The ornamental design for a surface indicia, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a surface indicia, embodying our new design;

FIG. 2 is a front view of the surface indicia of FIG. 1.

FIG. 3 is a back elevational view of the surface indicia of FIG. 1;

FIG. 4 is a first side elevational view of the surface indicia of FIG. 1;

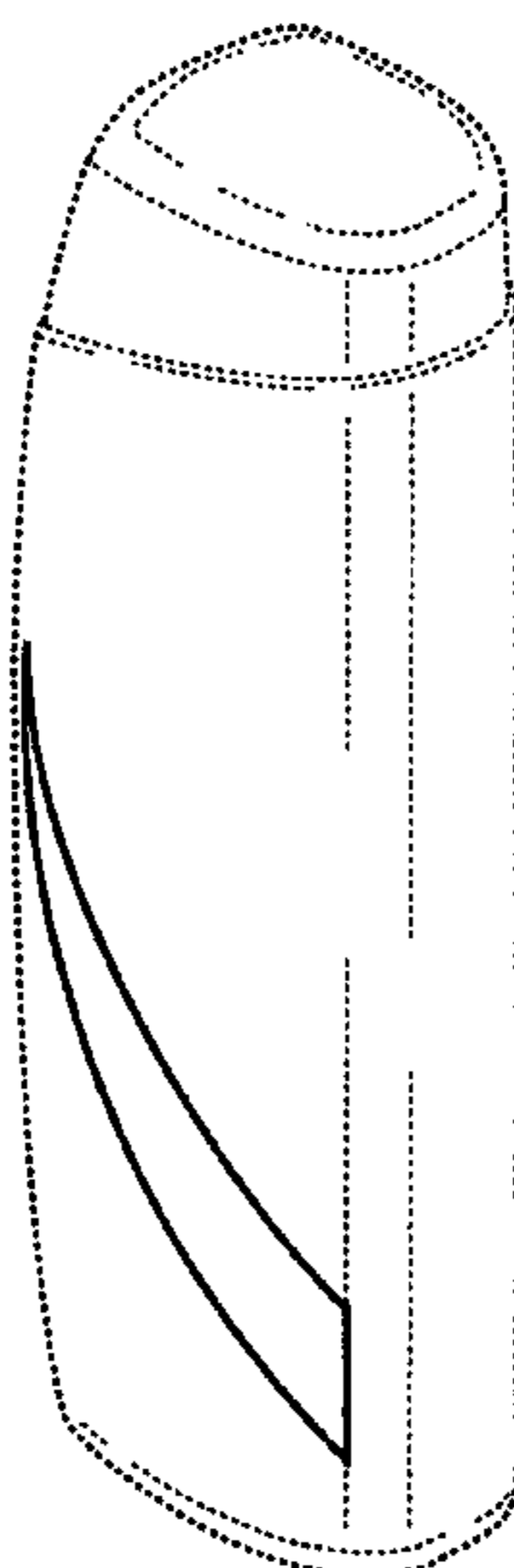
FIG. 5 is a second side elevational view of the surface indicia of FIG. 1;

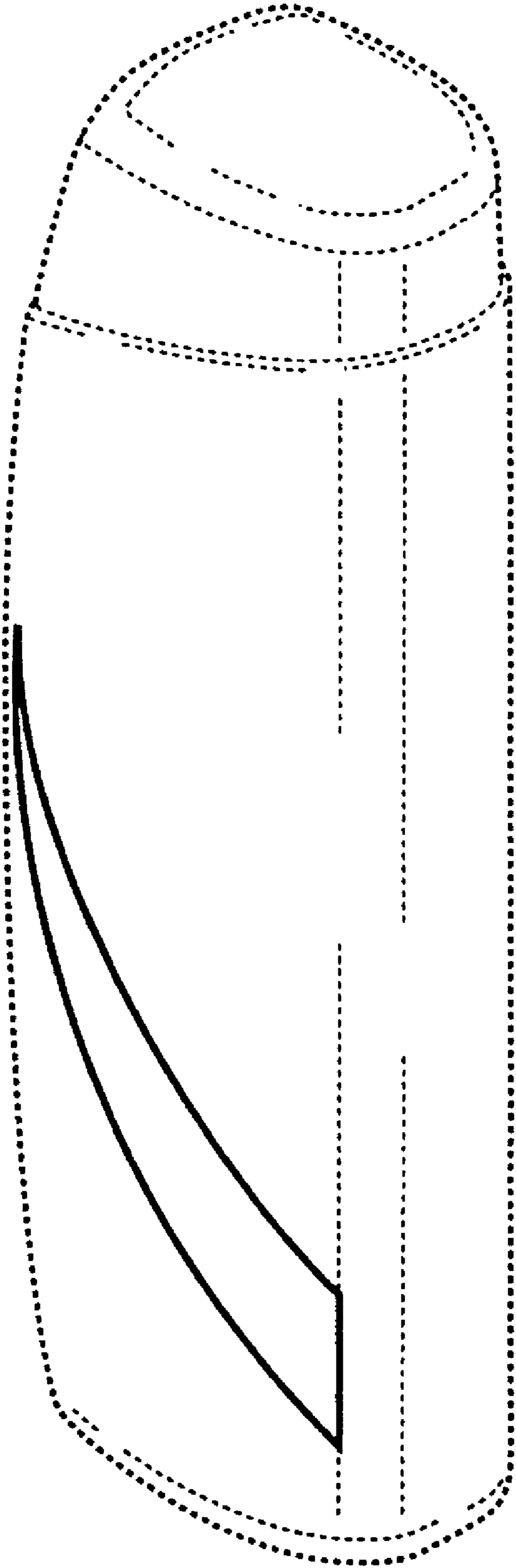

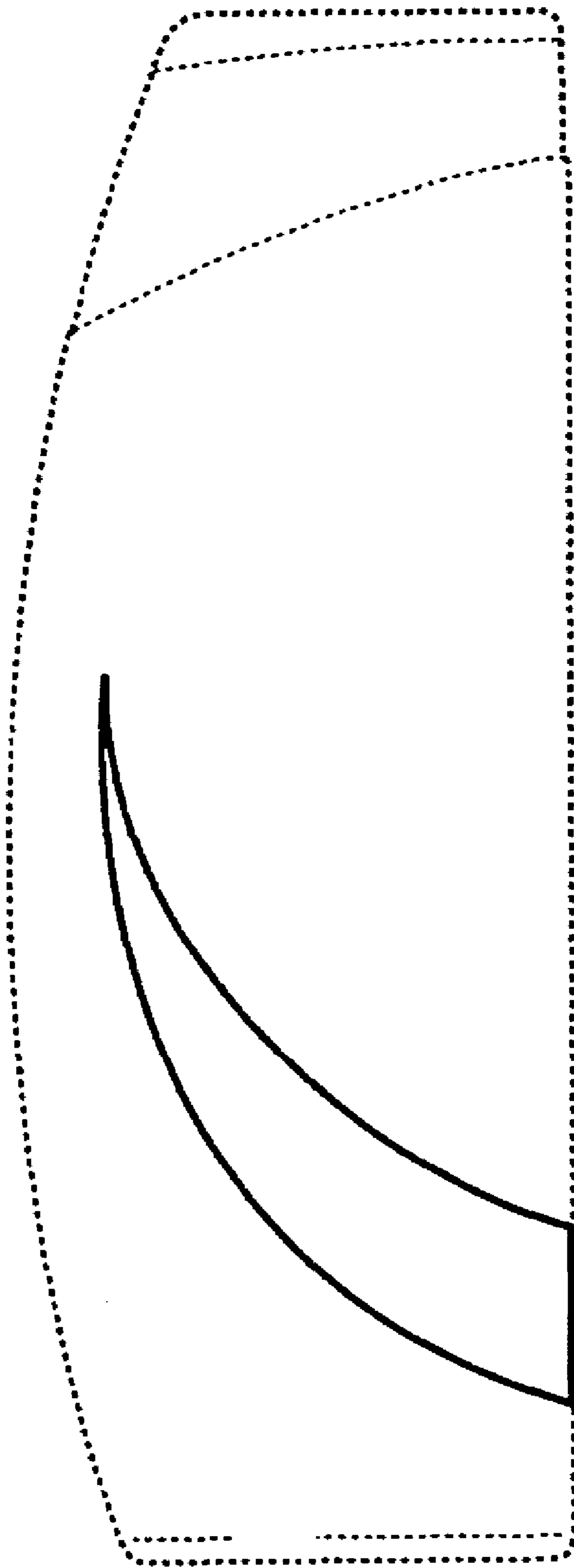

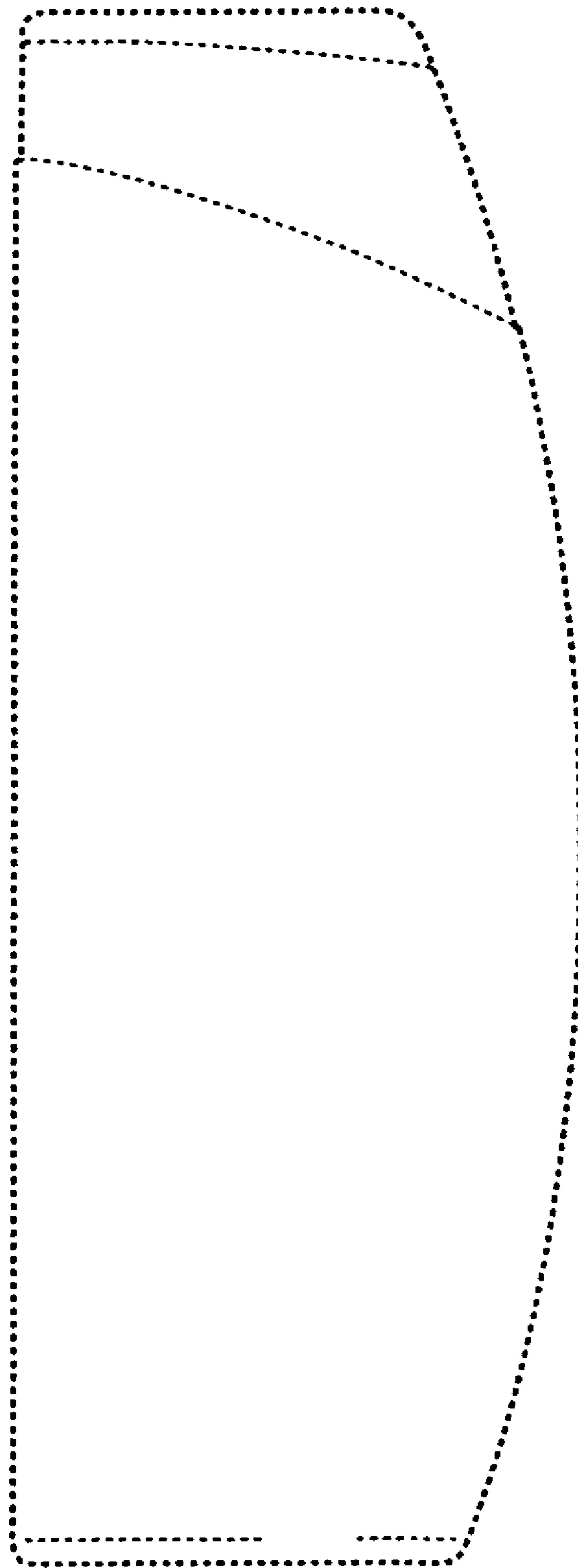

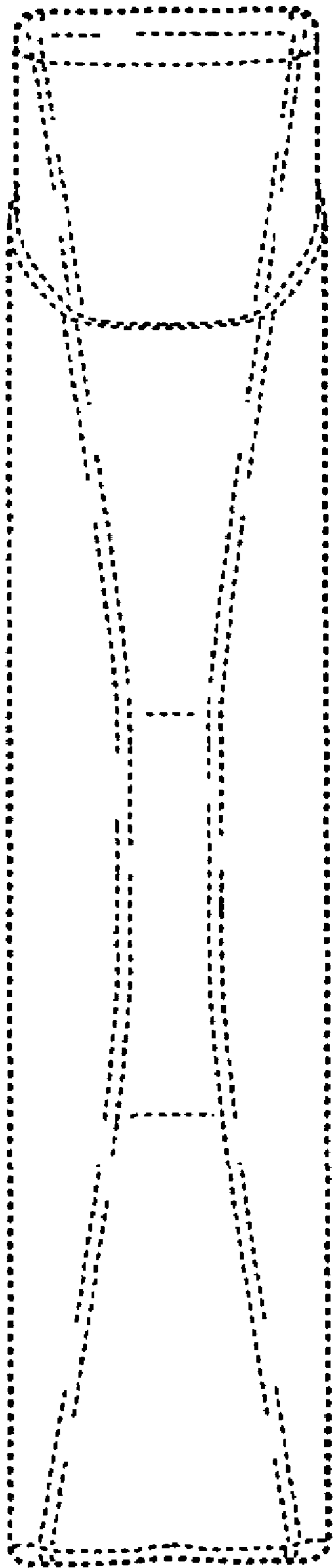

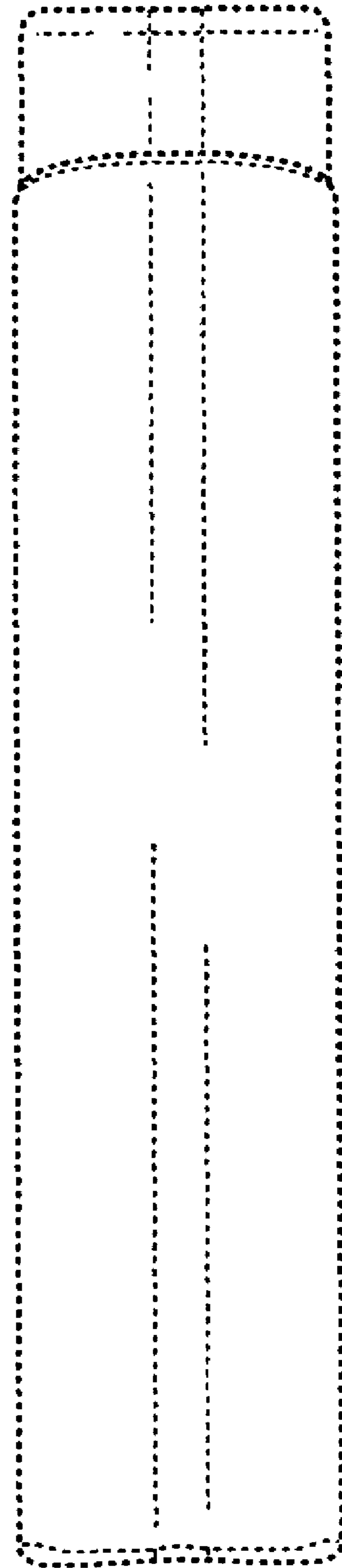

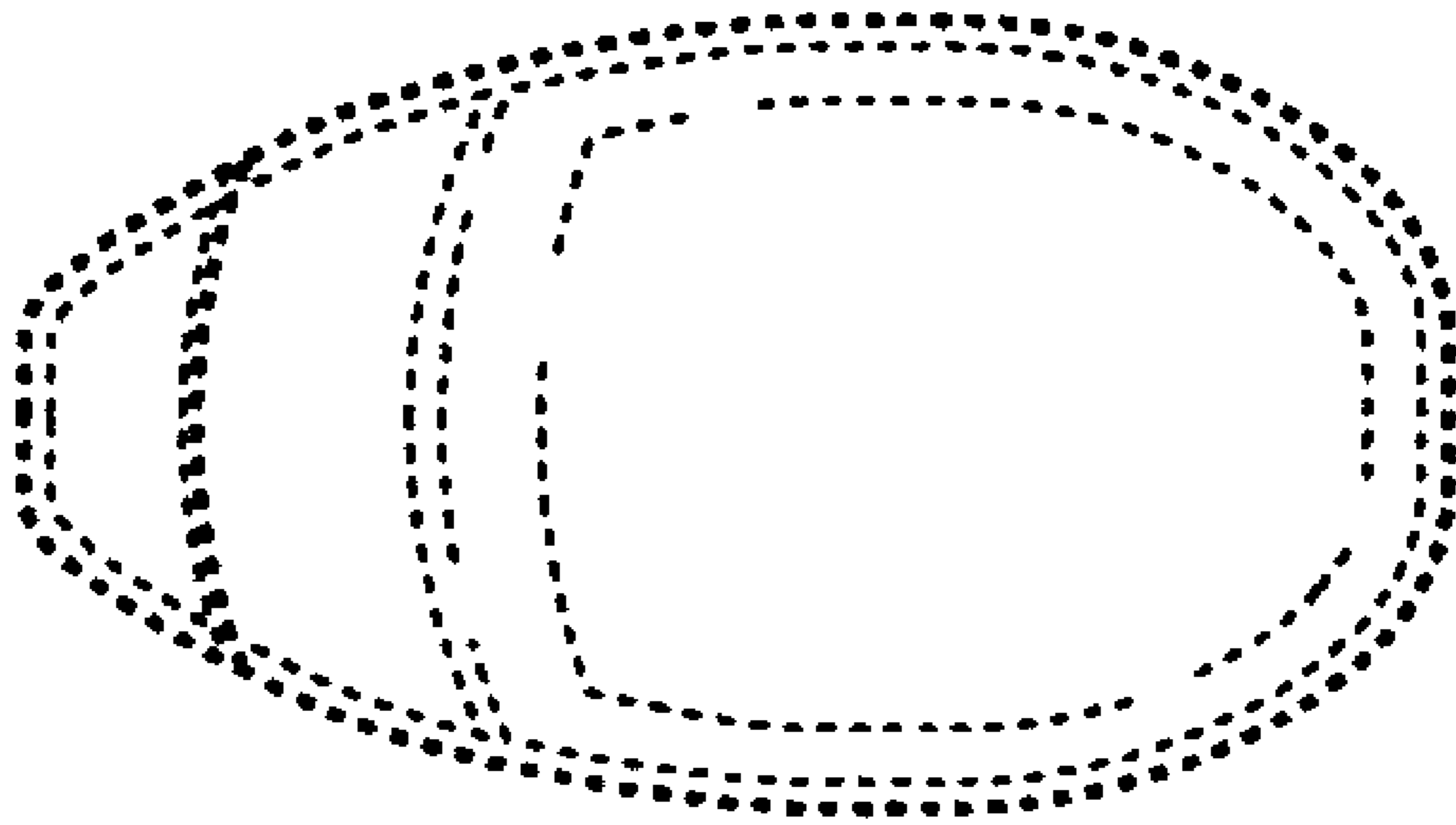

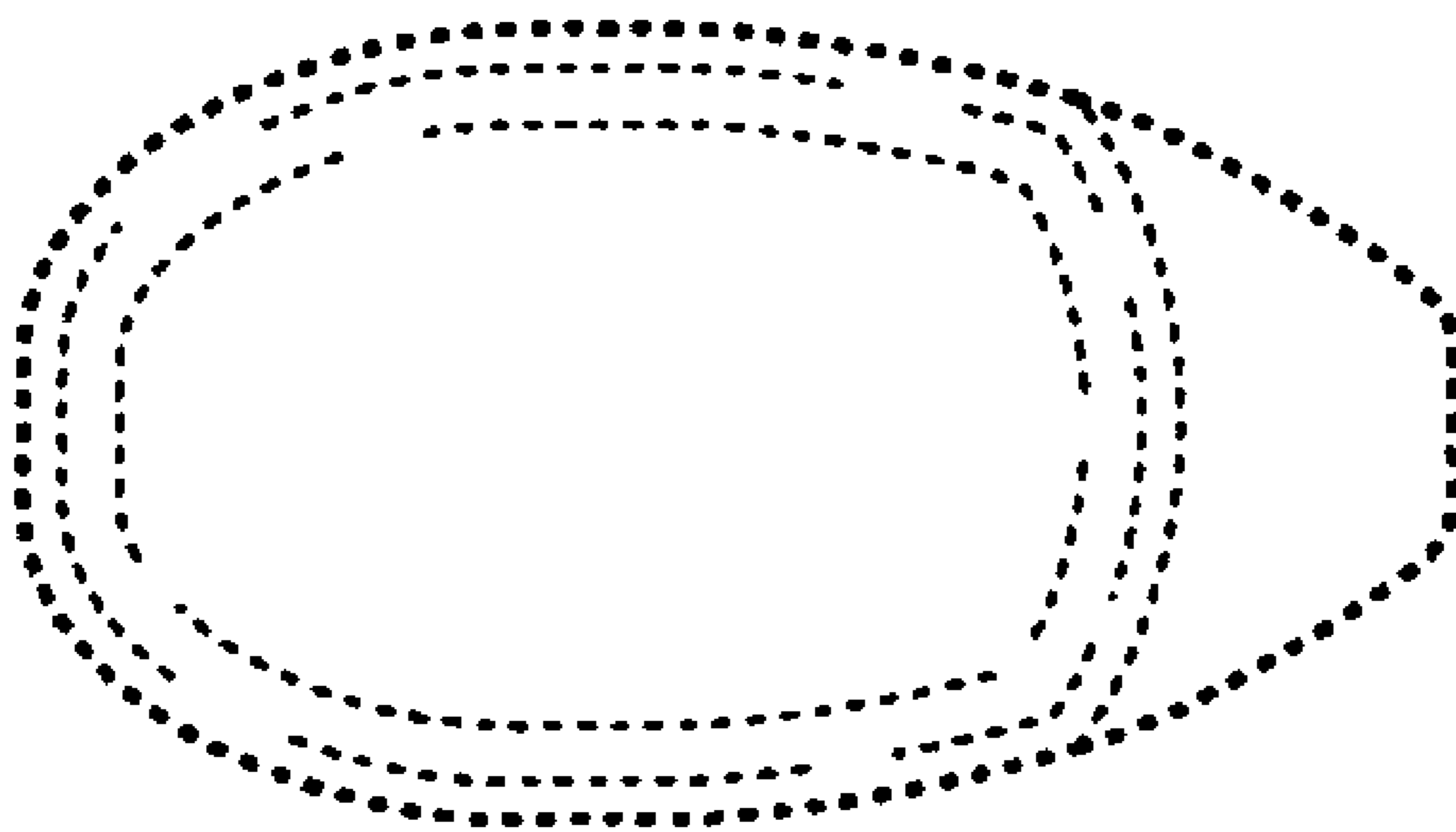
