**DESCRIPTION**

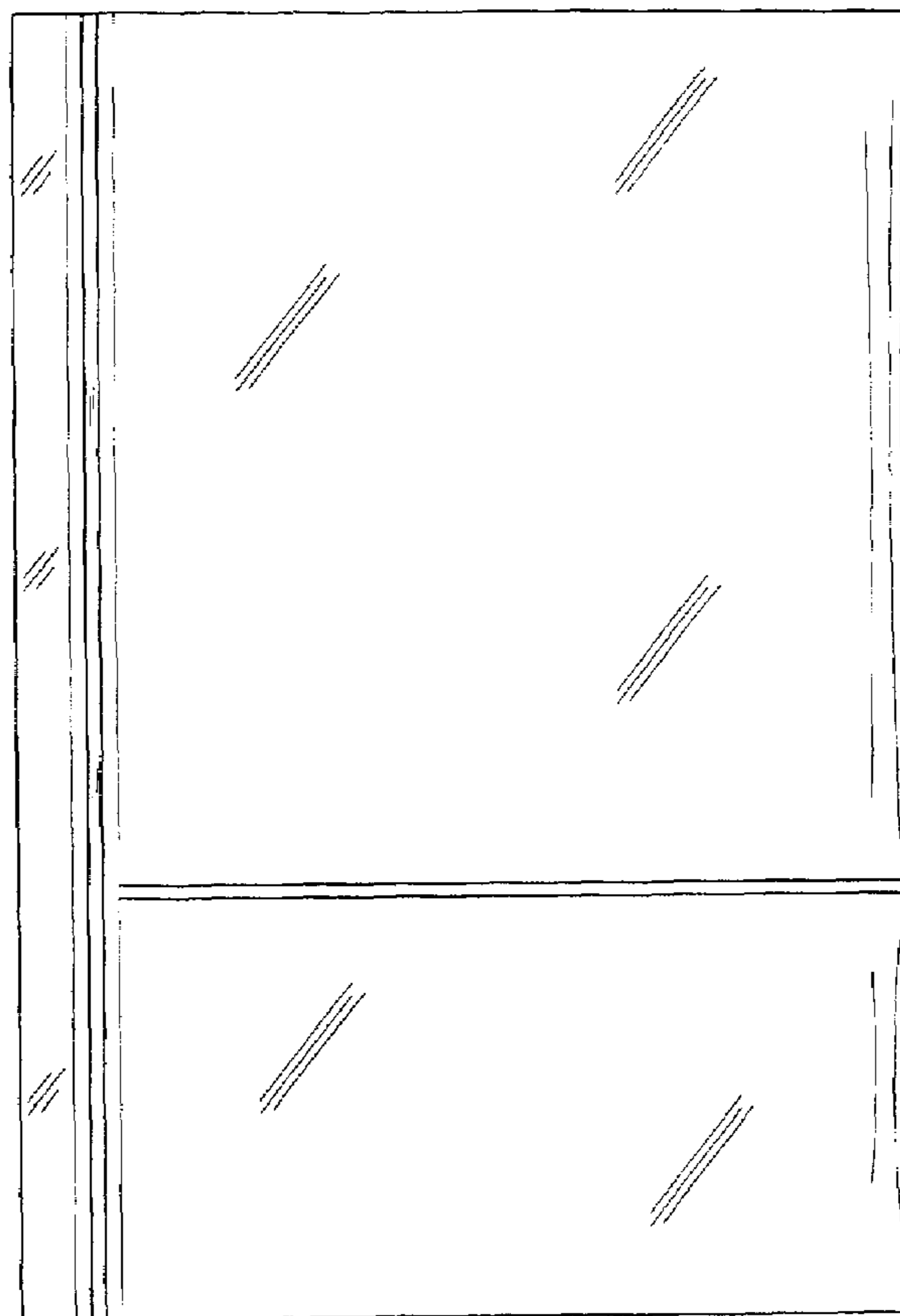
FIG. 1 is a front elevational view of the dual-compartment sandwich bag showing my new design;

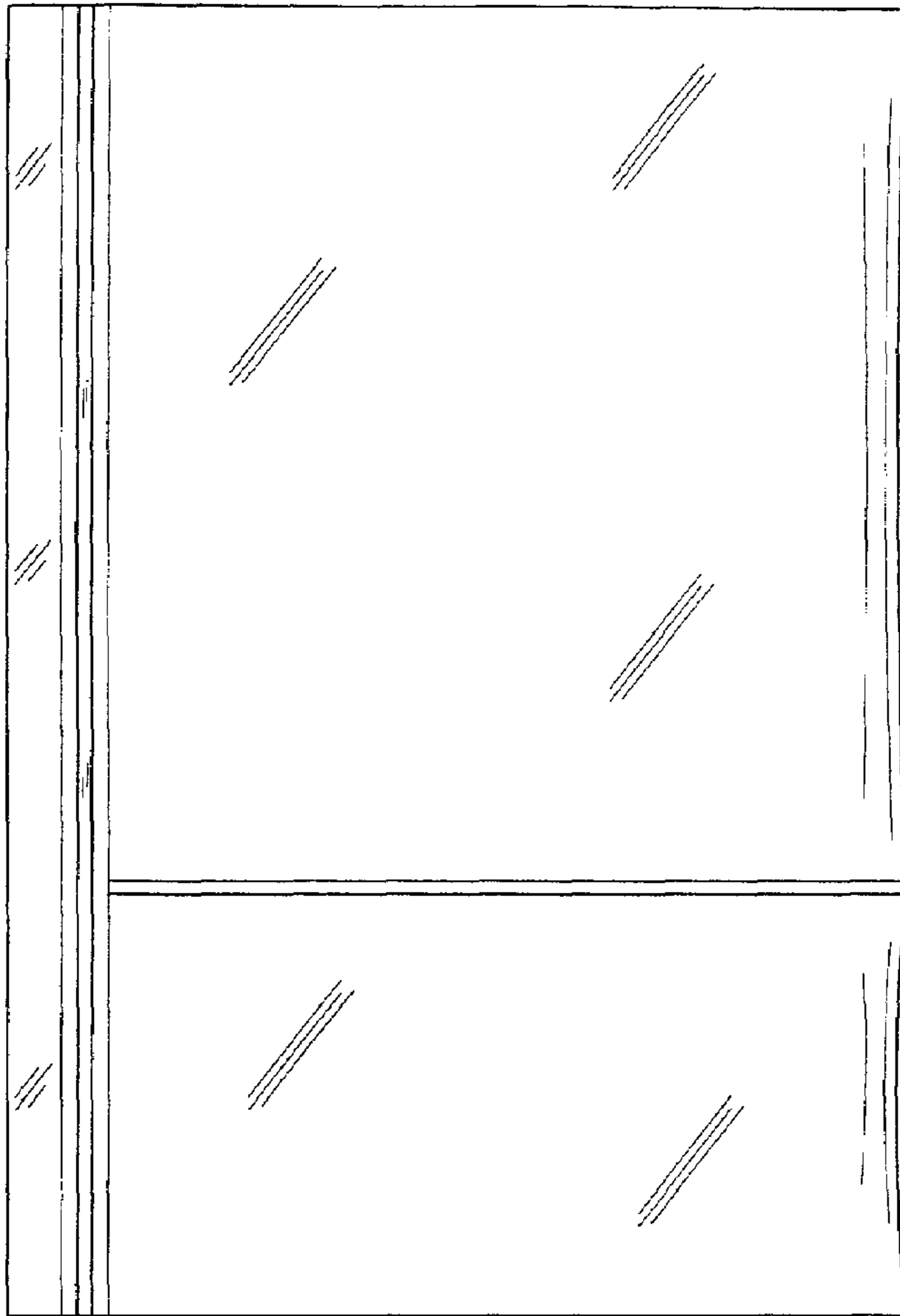

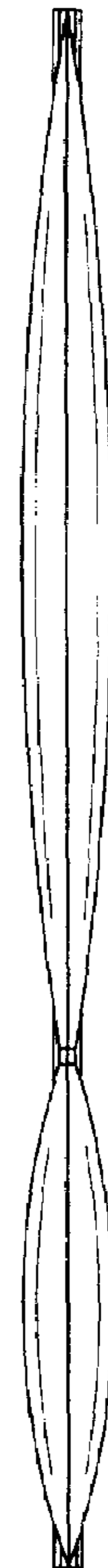

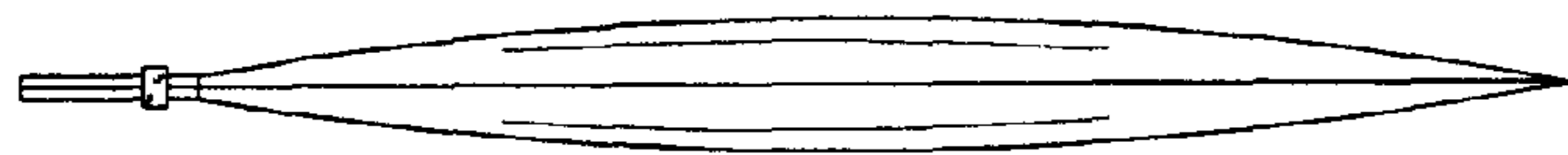
