The ornamental design for a geometric hanging basket, substantially, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a geometric hanging basket showing my new design;

FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

FIG. 3 is a rear elevational view thereof;

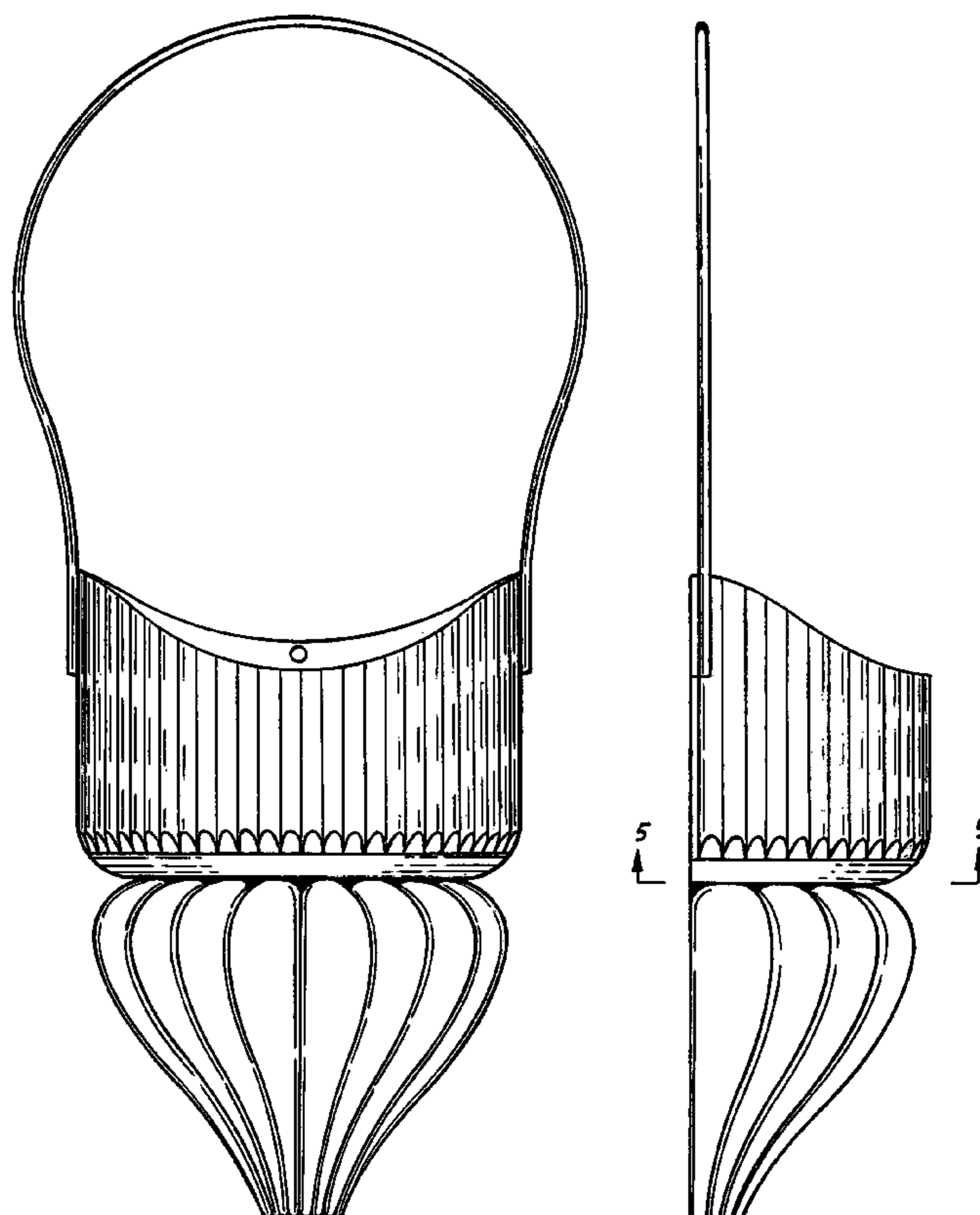
FIG. 4 is a top plan view thereof;

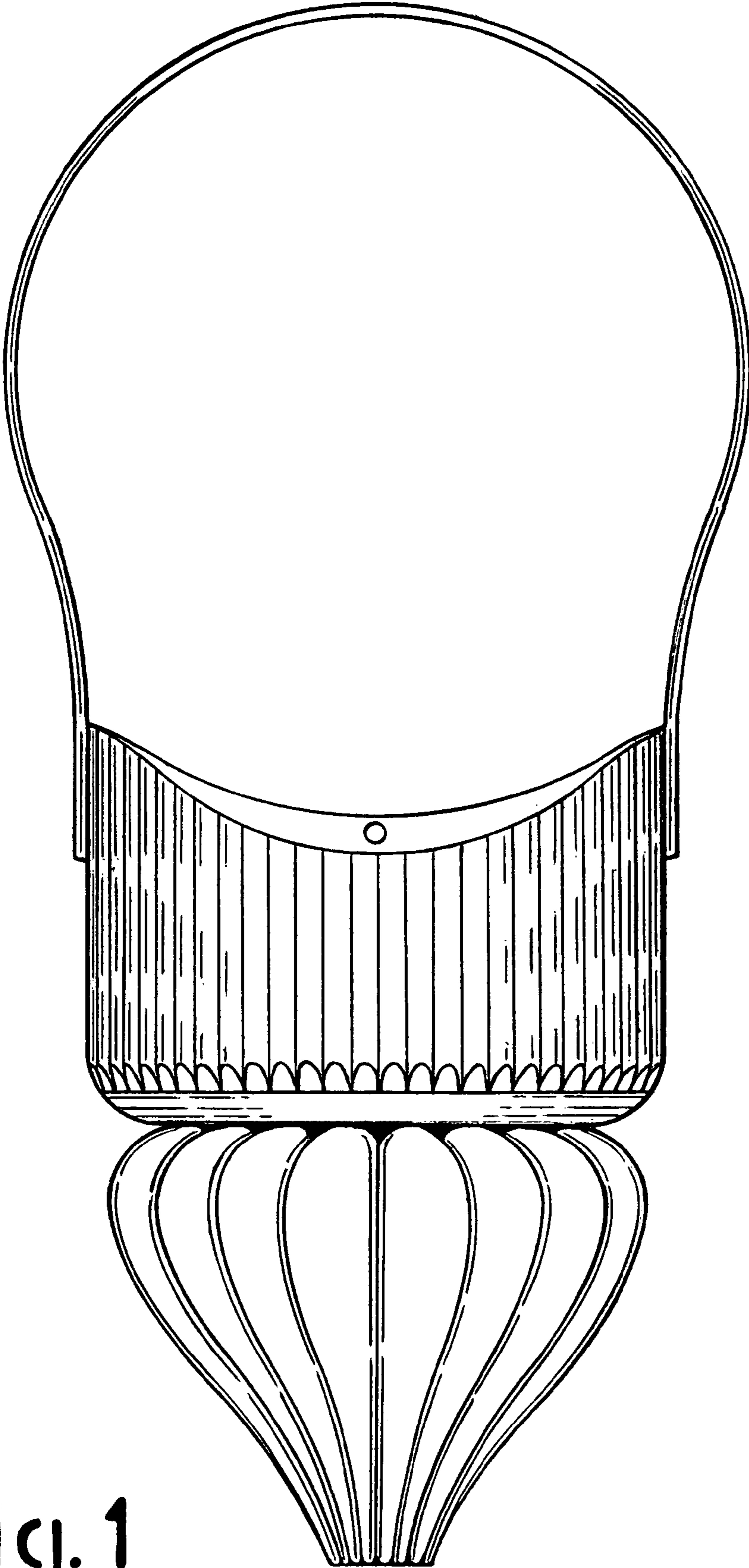

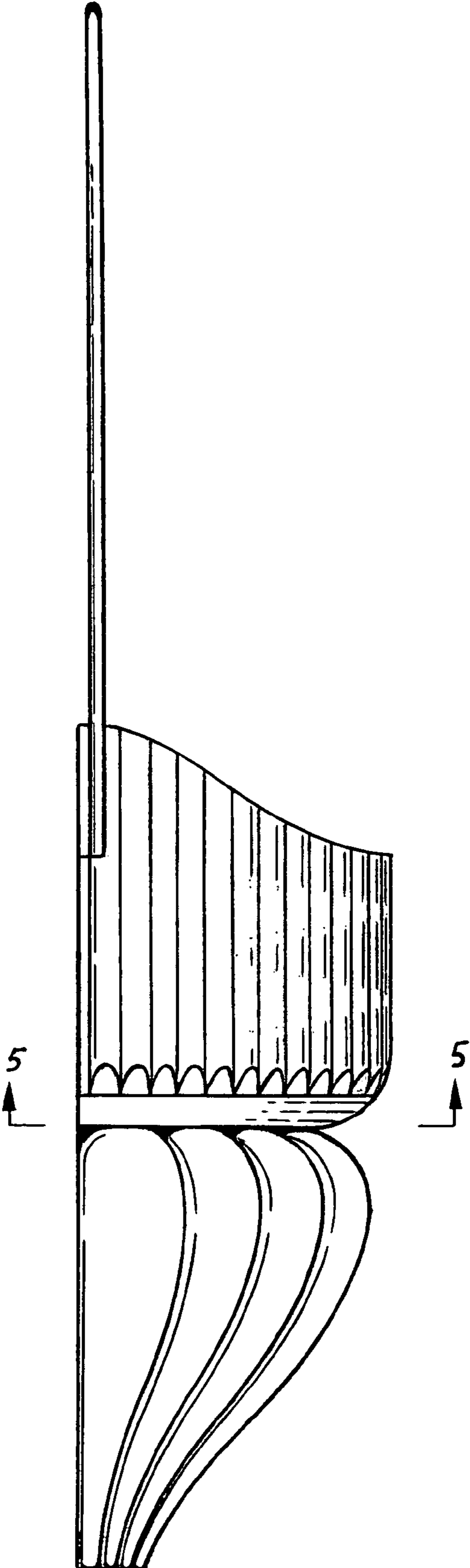

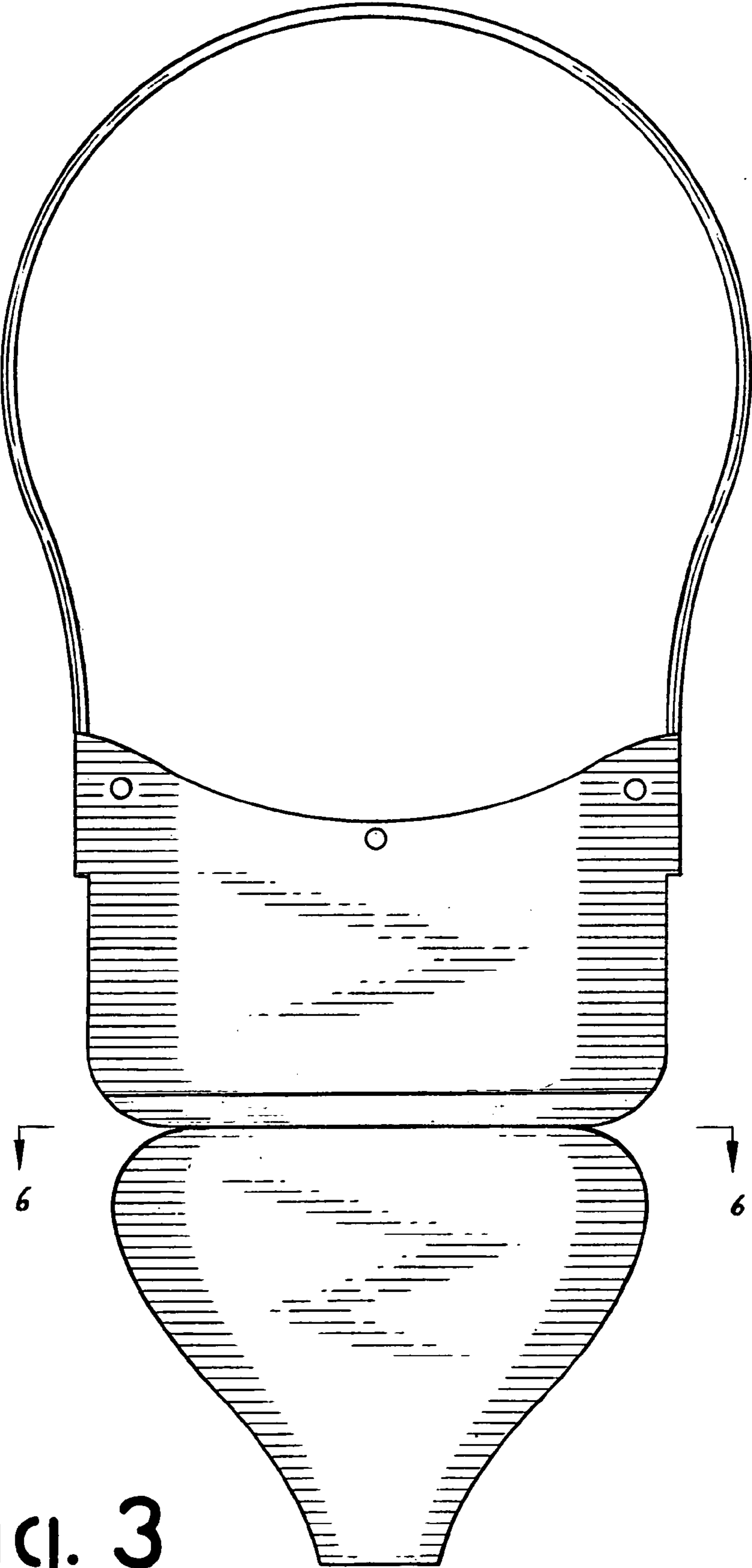

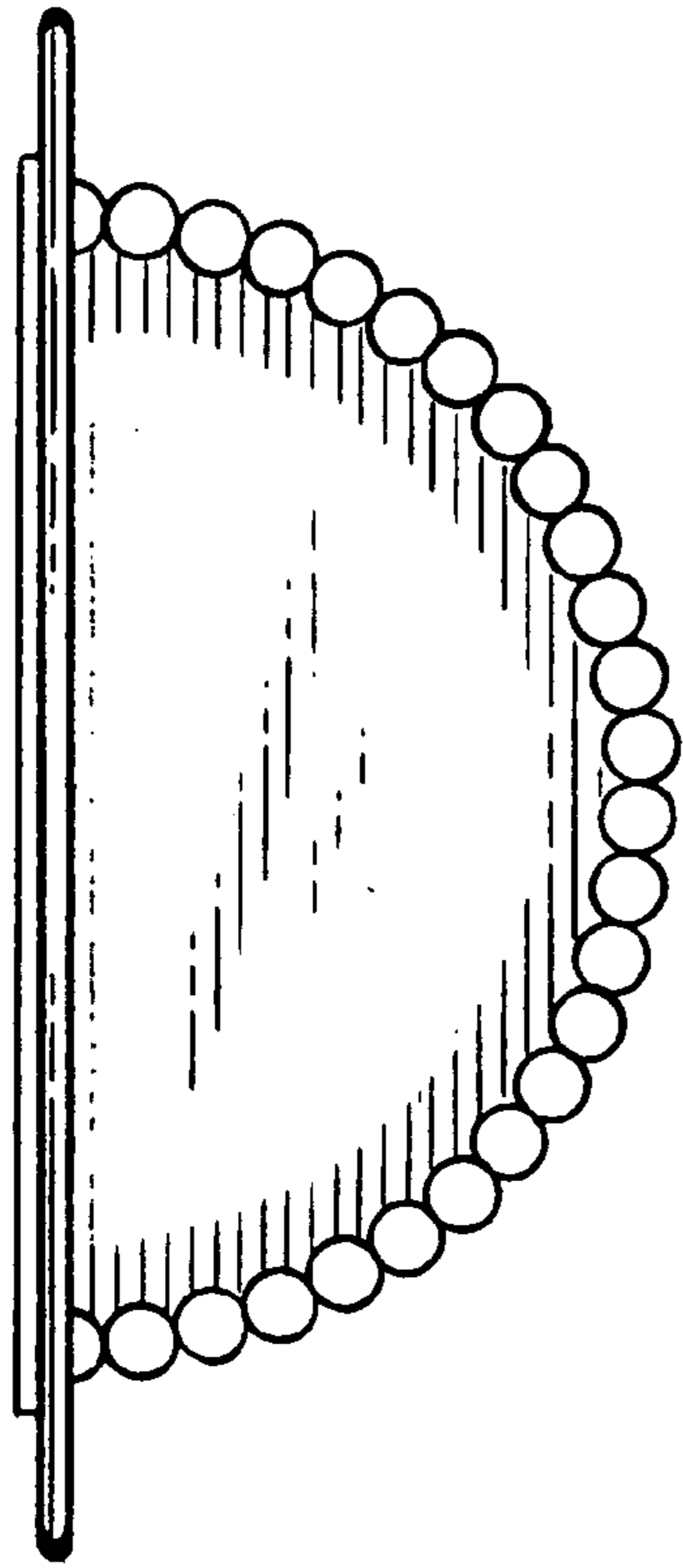

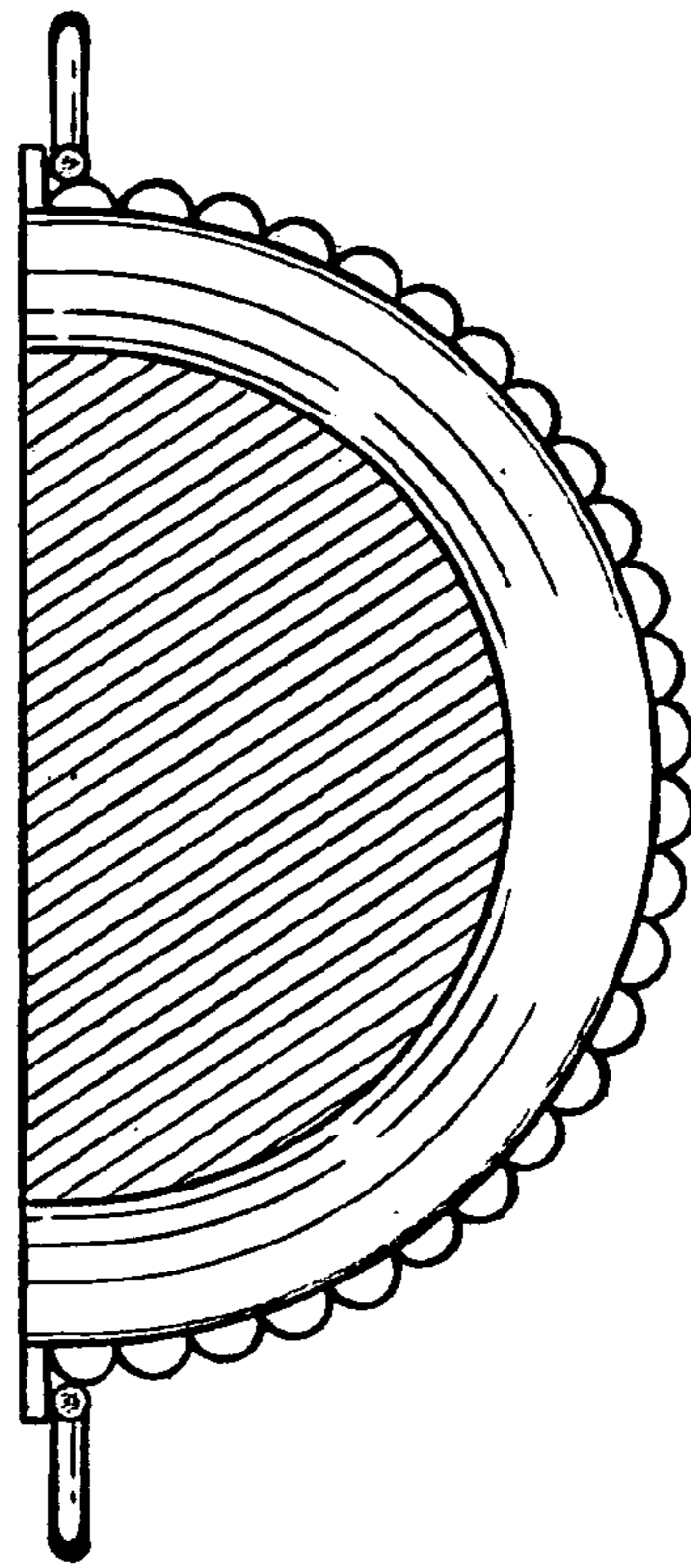

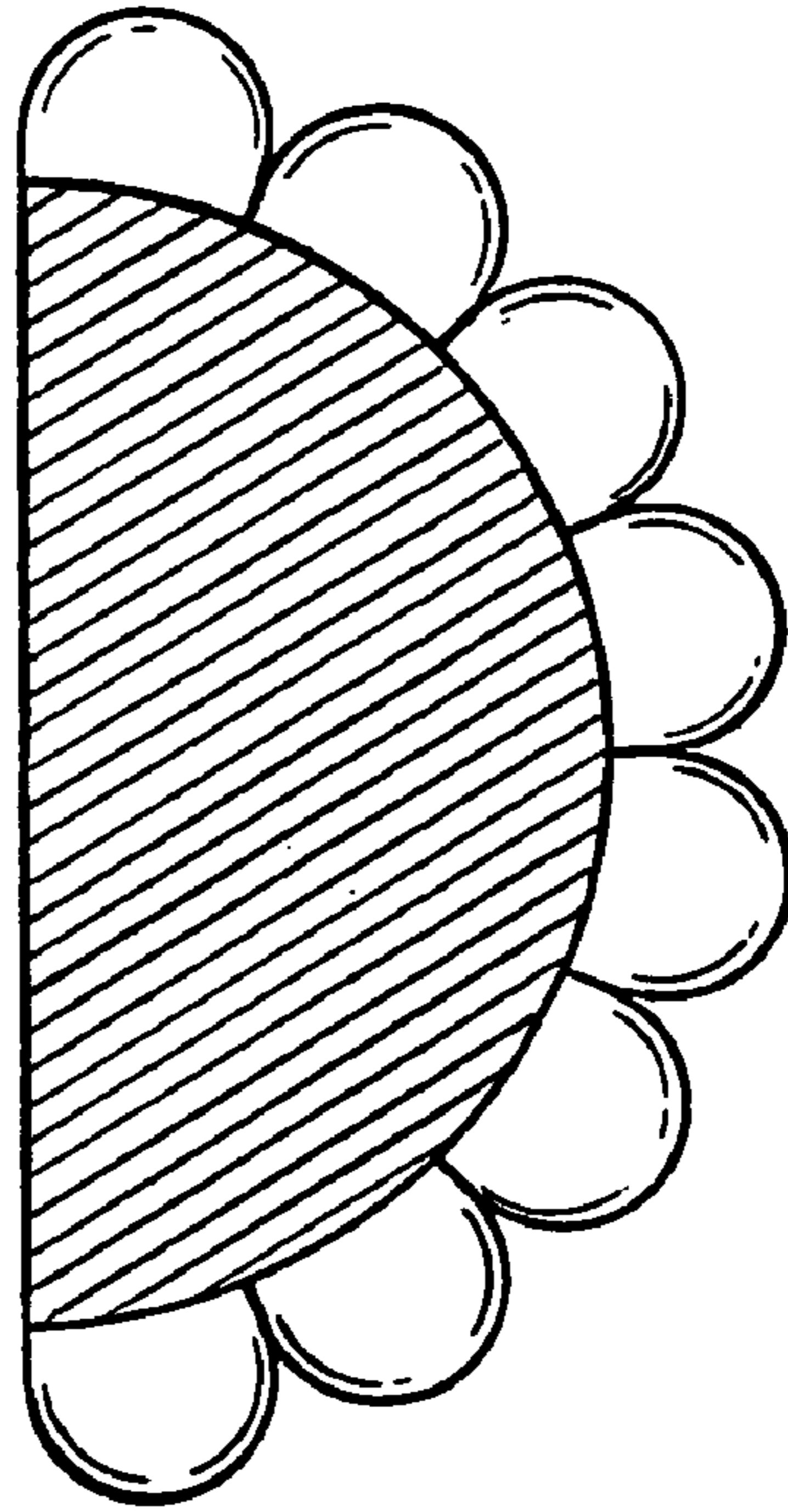
