The ornamental design for a boom microphone, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a boom microphone showing our new design, the cord is drawn broken away to illustrate indeterminate length;

FIG. 3 is a rear view thereof;

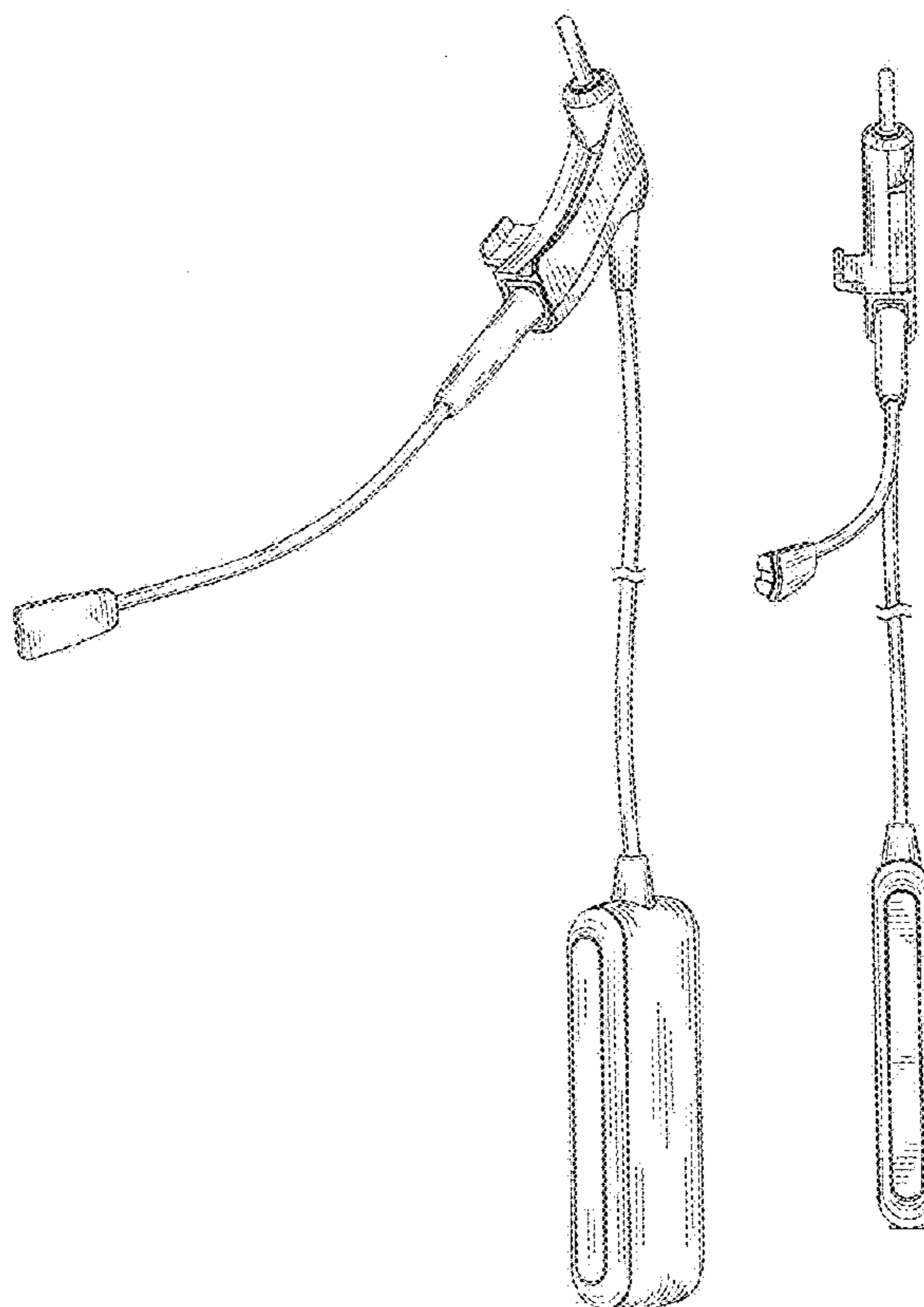
FIG. 4 is a right side view thereof;

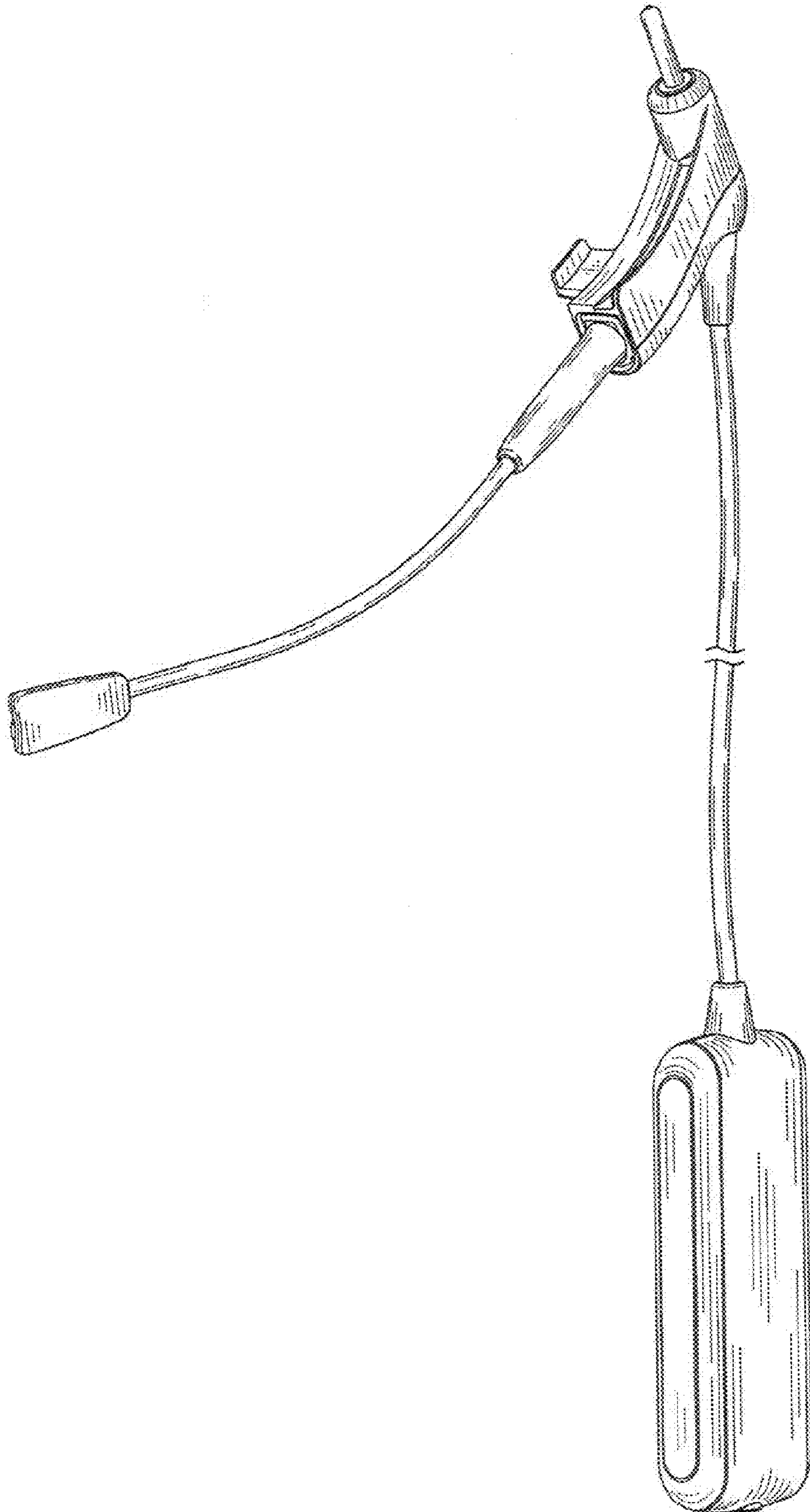

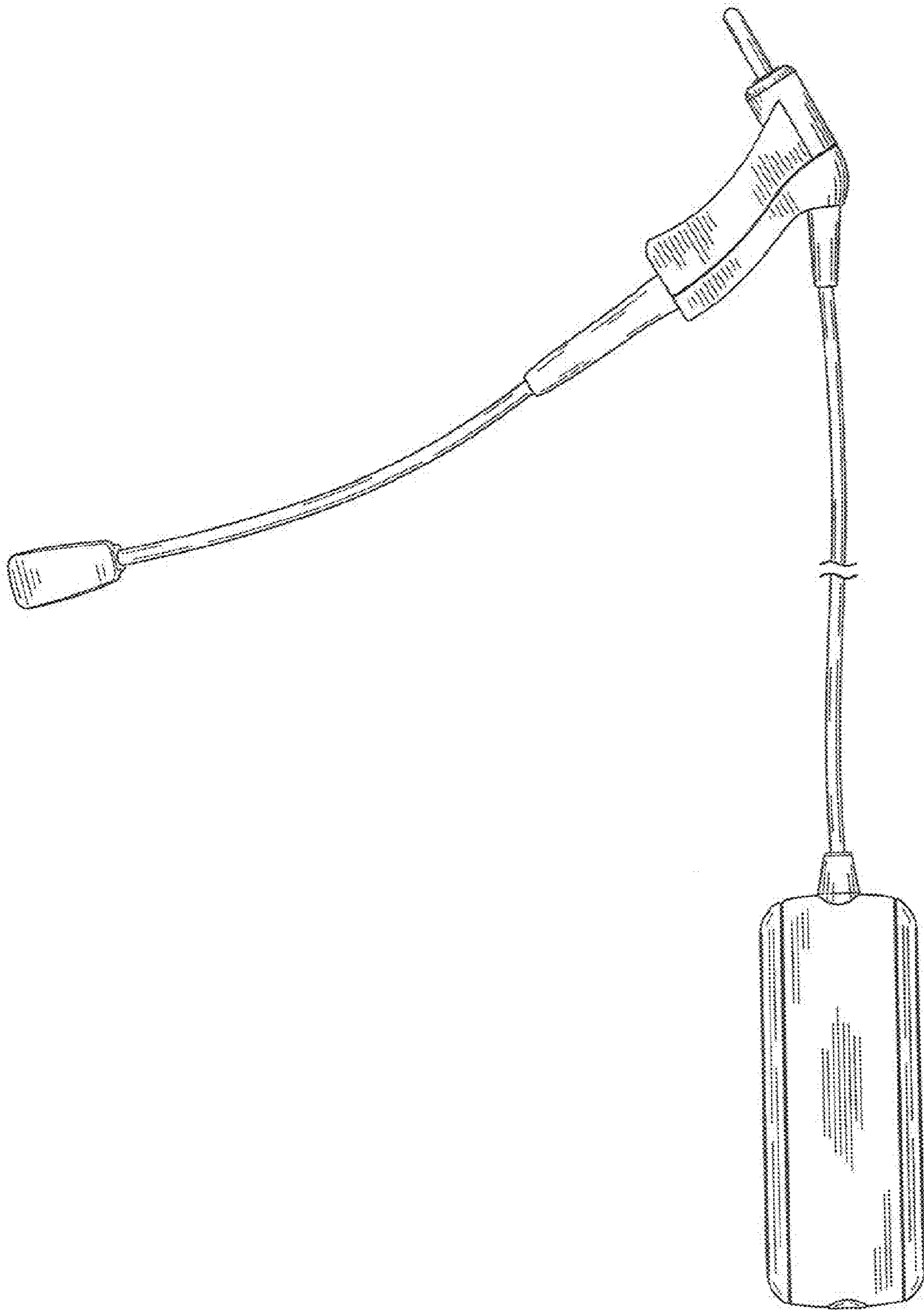

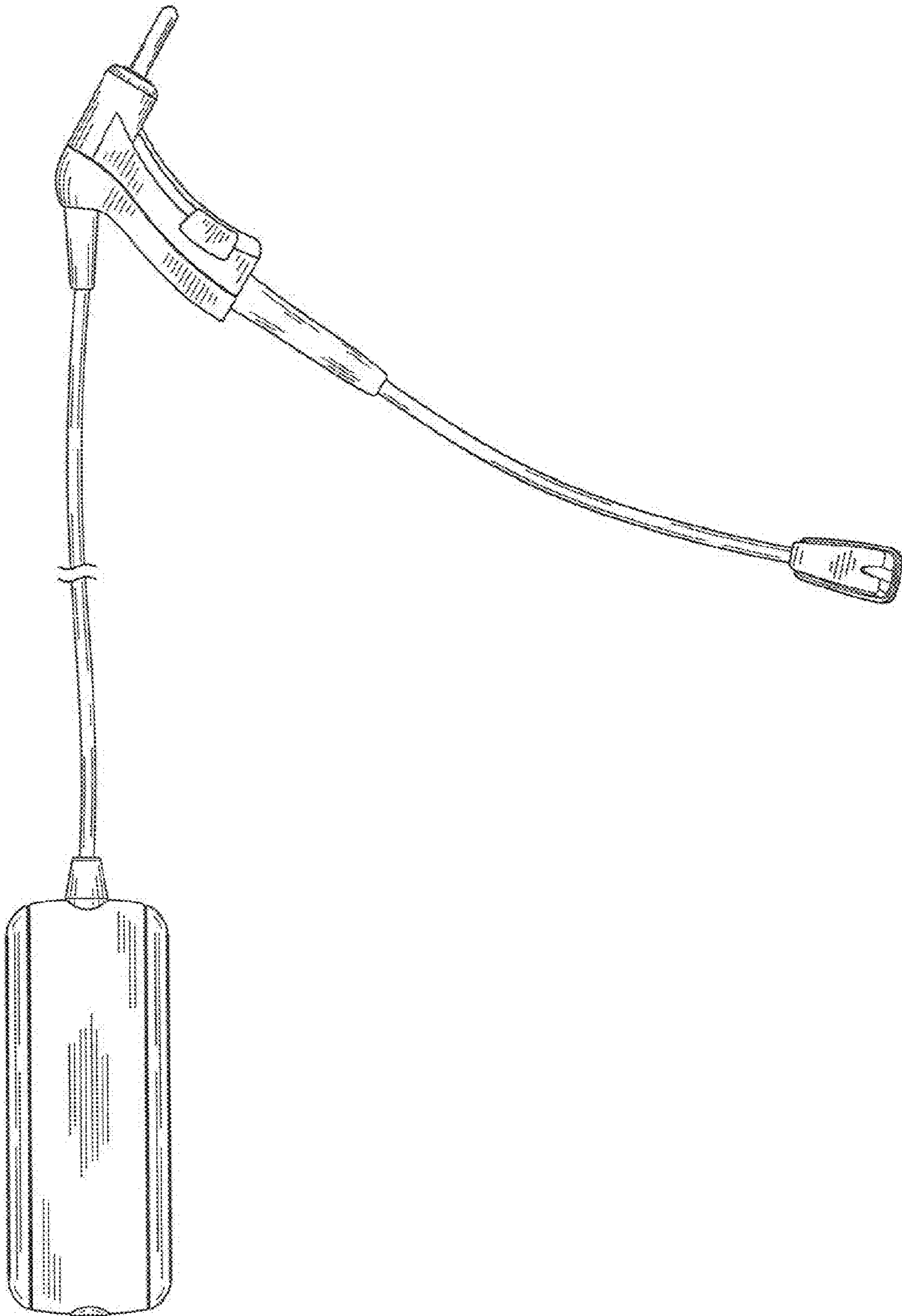

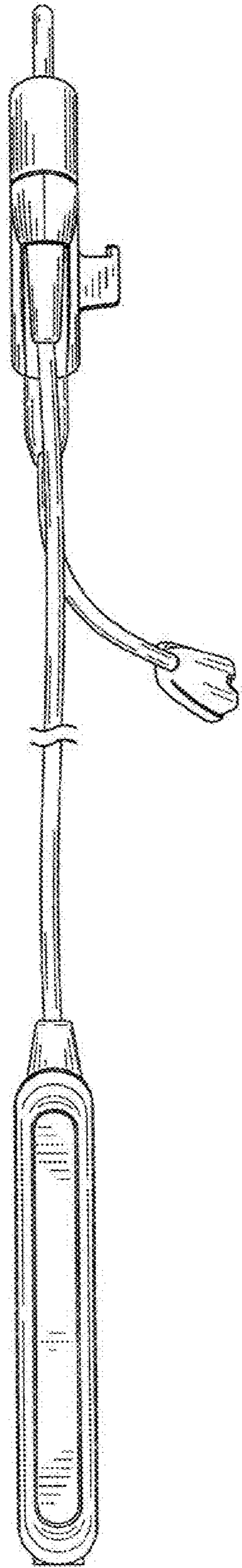

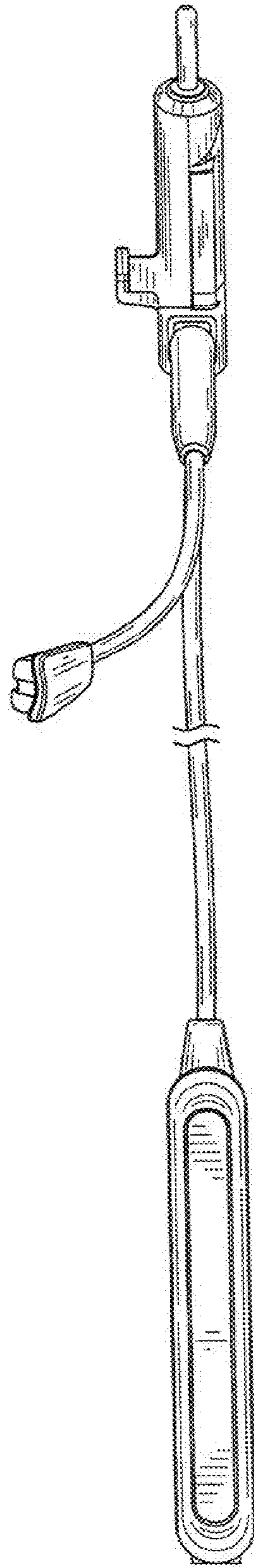

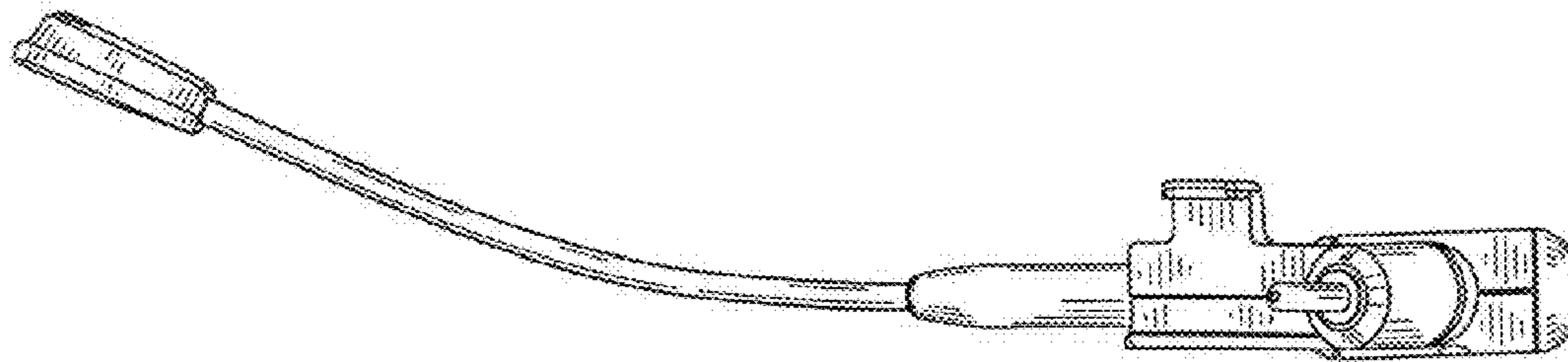

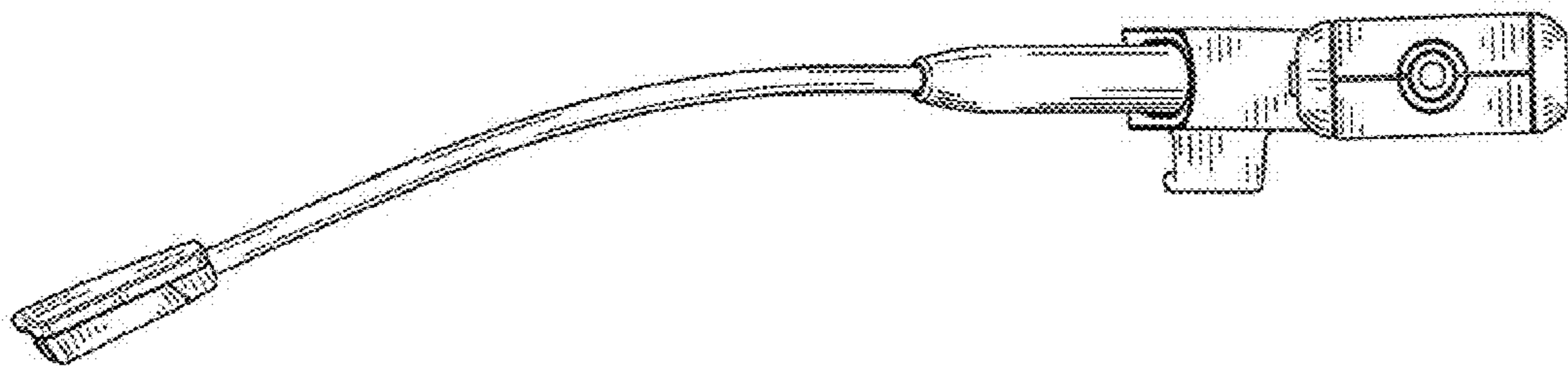
