(57) **CLAIM**

I claim the ornamental design for tilt mounting bracket for flat panel display, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a tilt mounting bracket for flat panel display.

FIG. 2 is a front elevation view of the tilt mounting bracket for flat panel display of FIG. 1;

FIG. 3 is a rear elevation view of the tilt mounting bracket for flat panel display of FIG. 1;

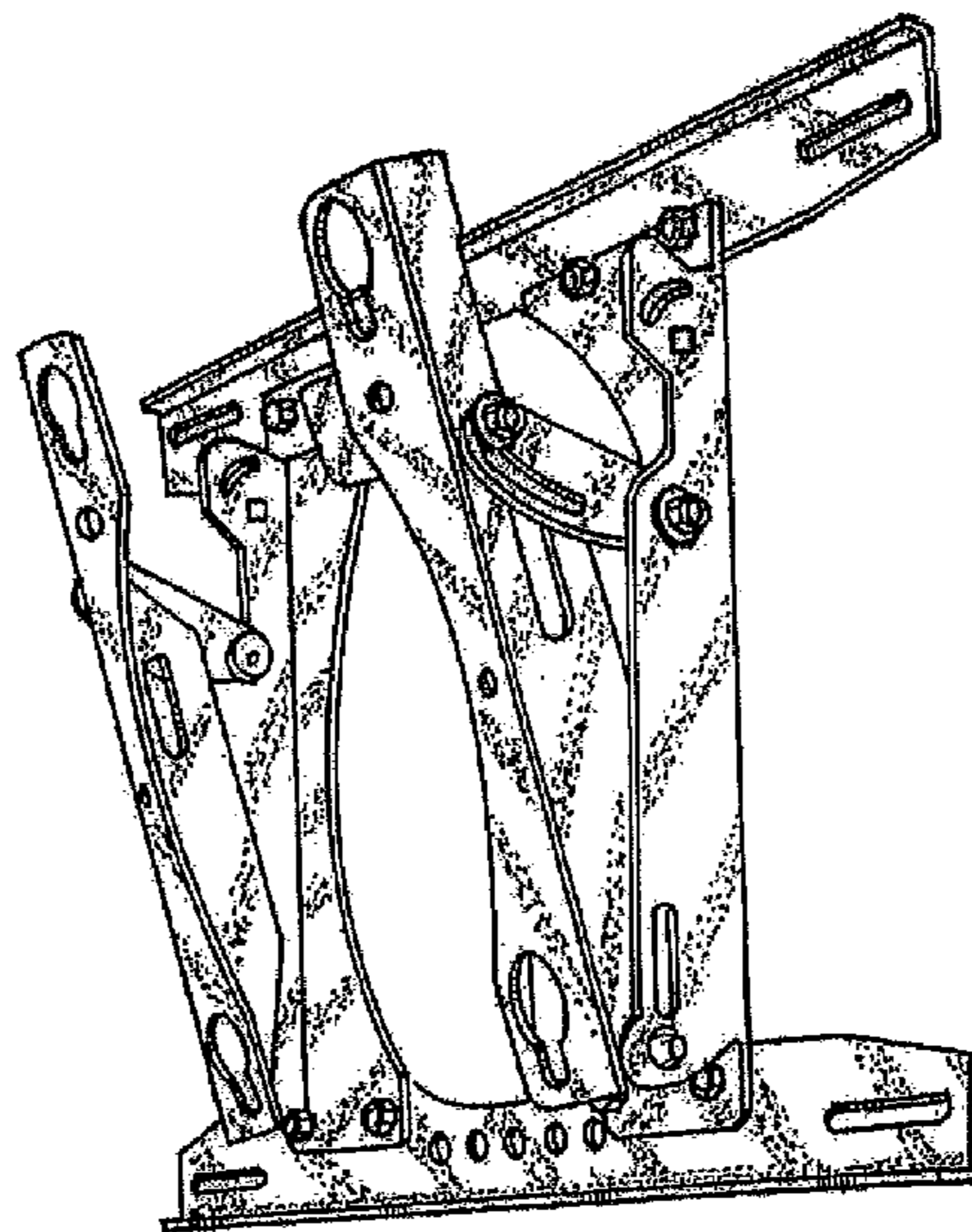
FIG. 4 is a bottom plan view of the tilt mounting bracket for flat panel display of FIG. 1;

FIG. 5 is a top plan view of the tilt mounting bracket for flat panel display of FIG. 1; and,

FIG. 6 is a side elevation view of the tilt mounting bracket for flat panel display of FIG. 1.

The opposing side elevation view not depicted is a mirror image of the view of FIG. 6.

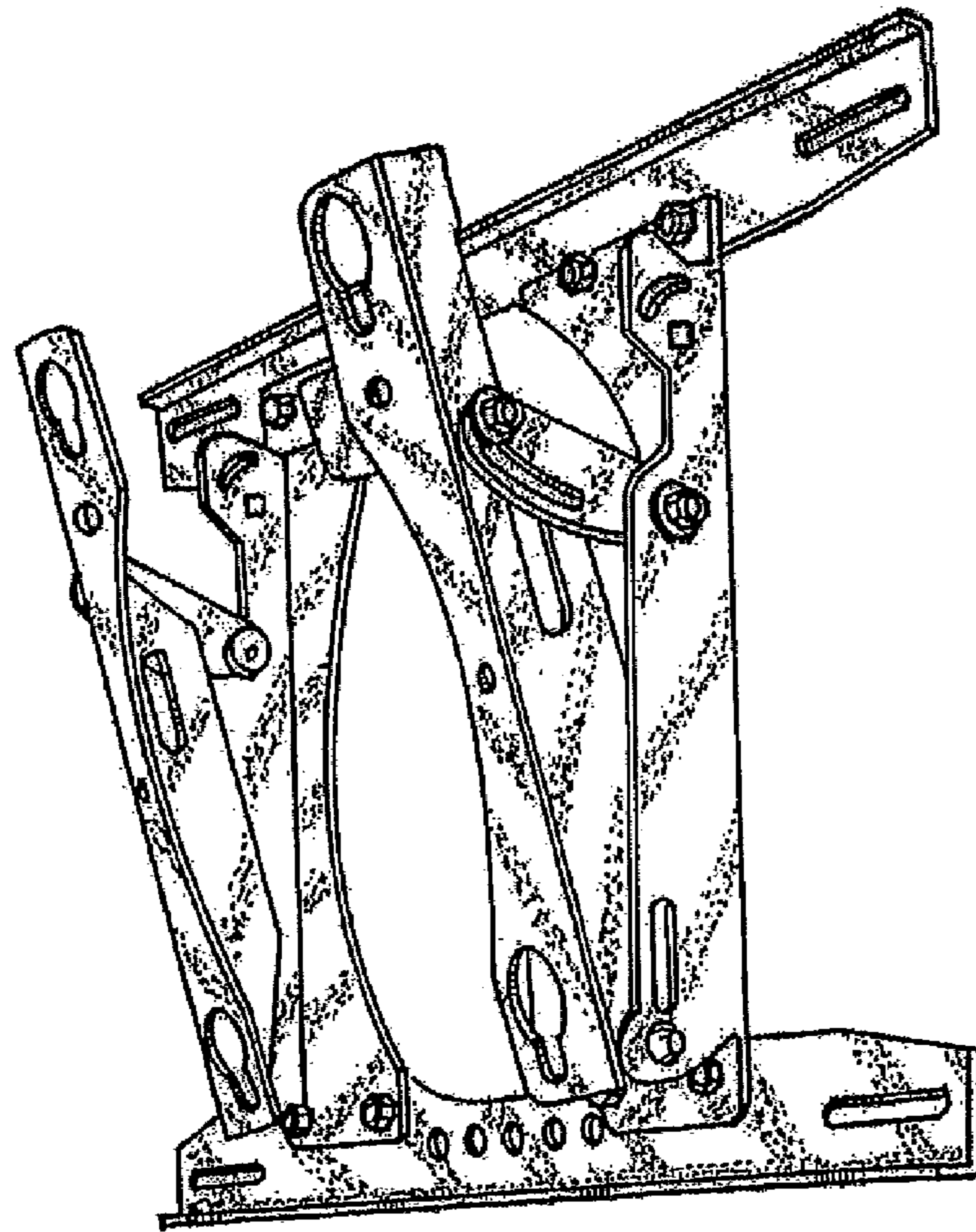

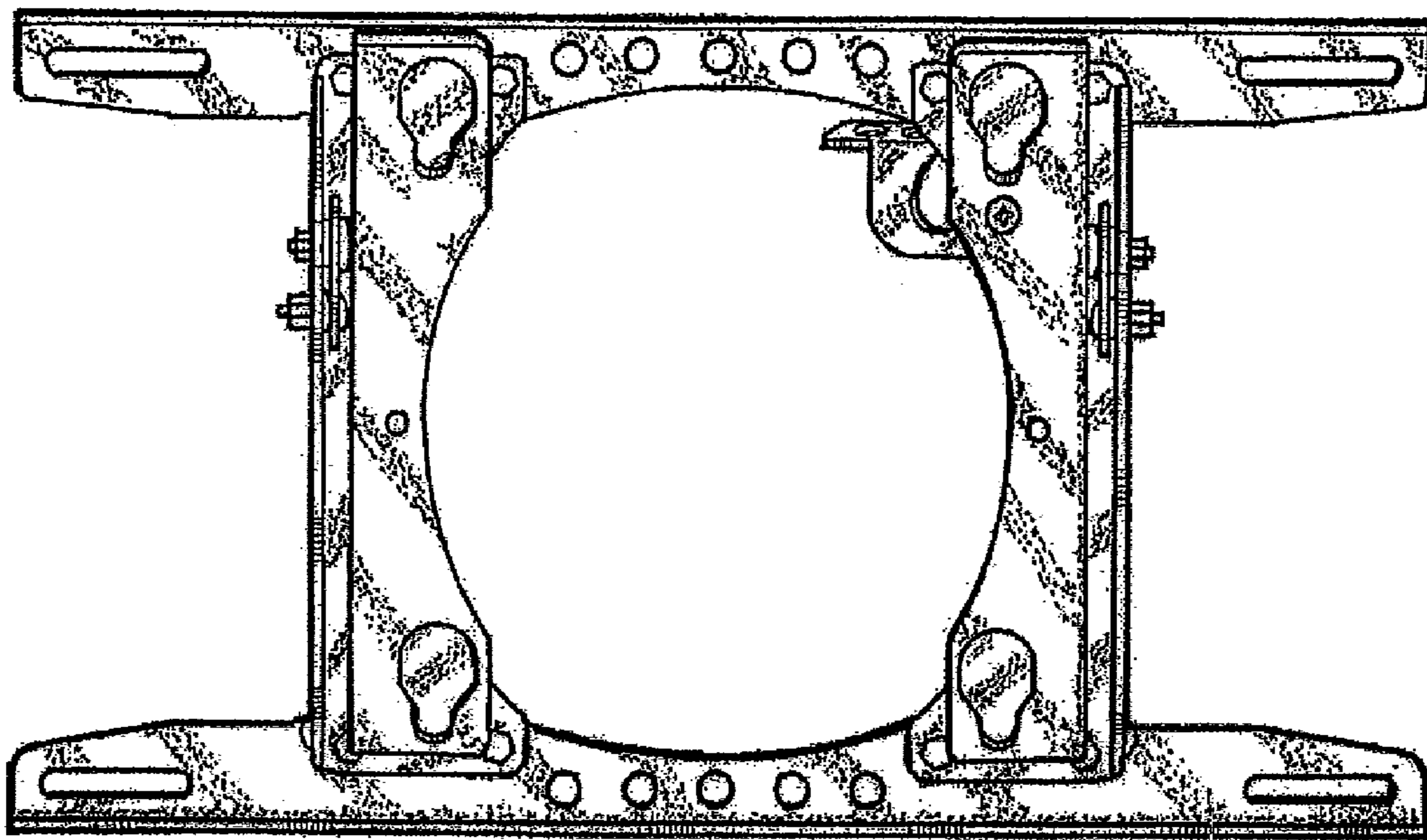

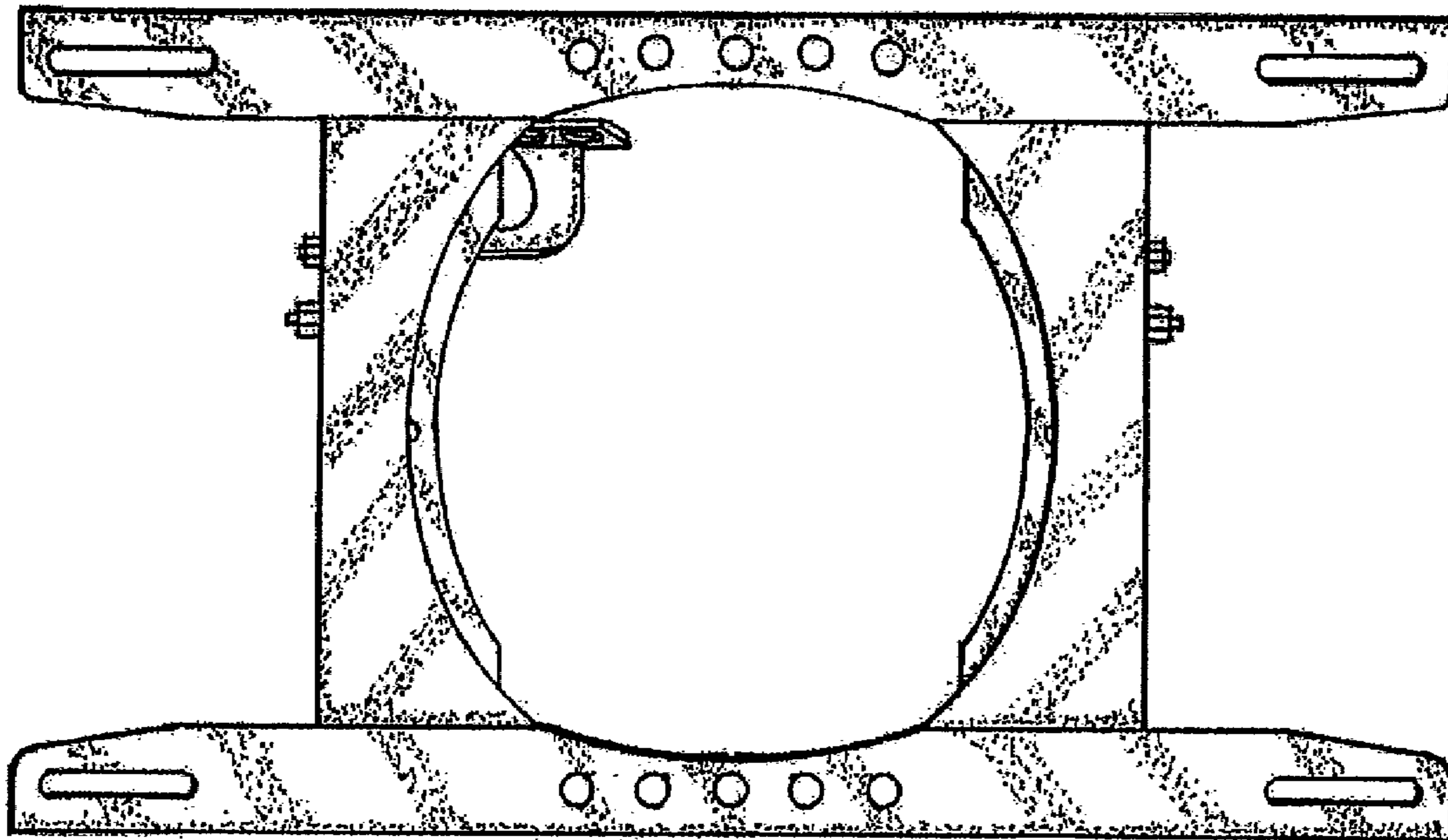

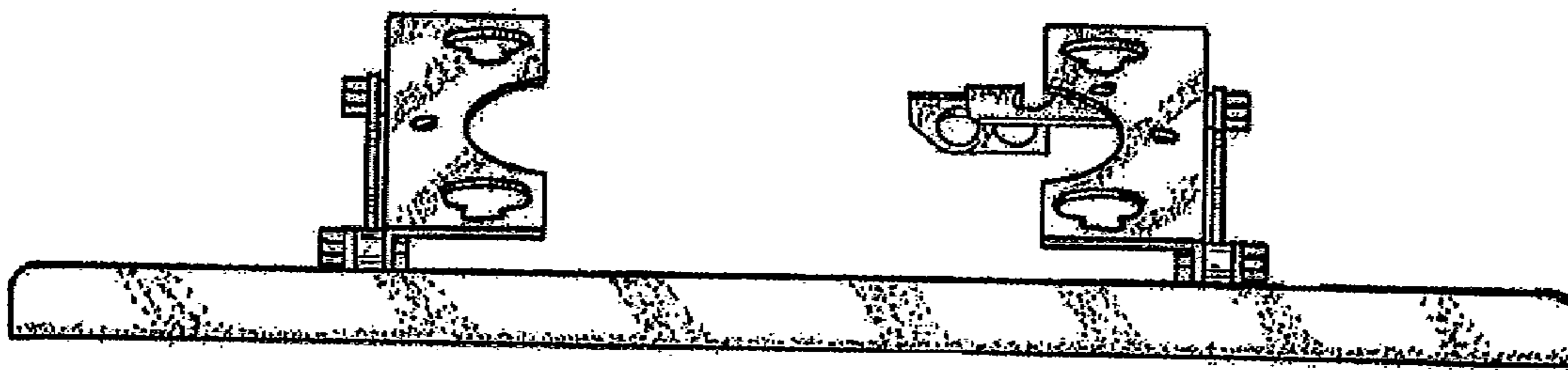

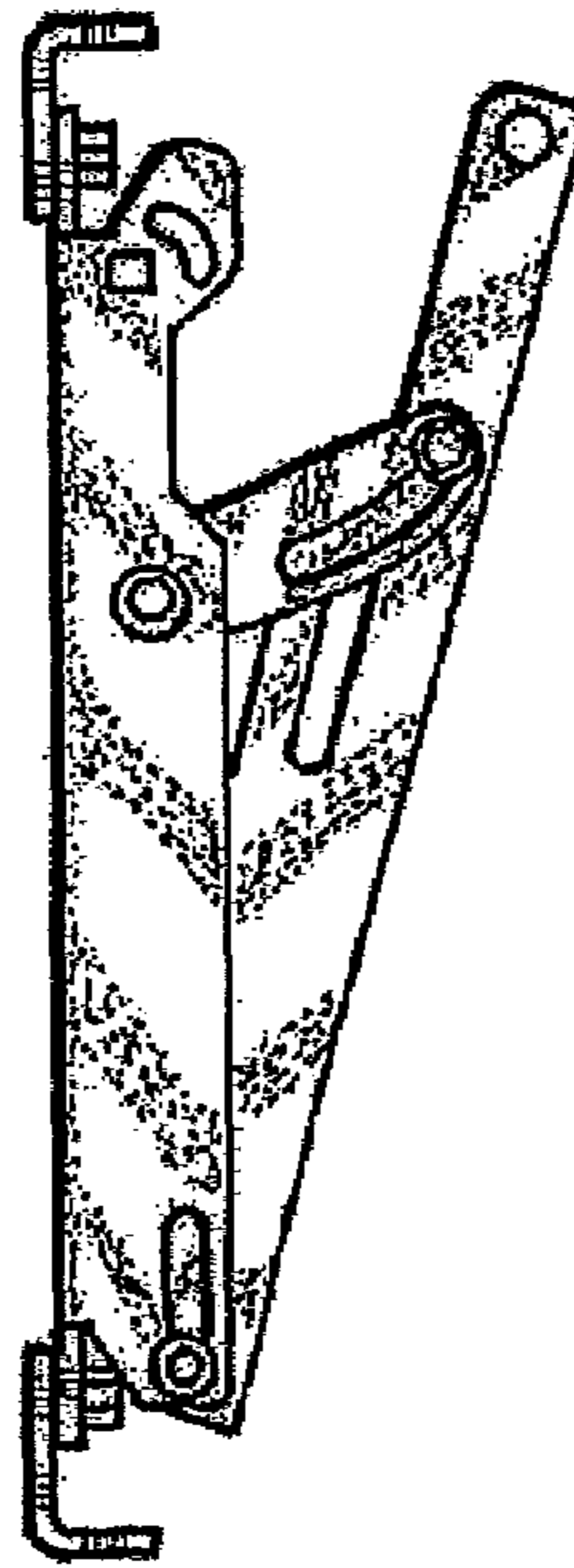
