DESCRIPTION

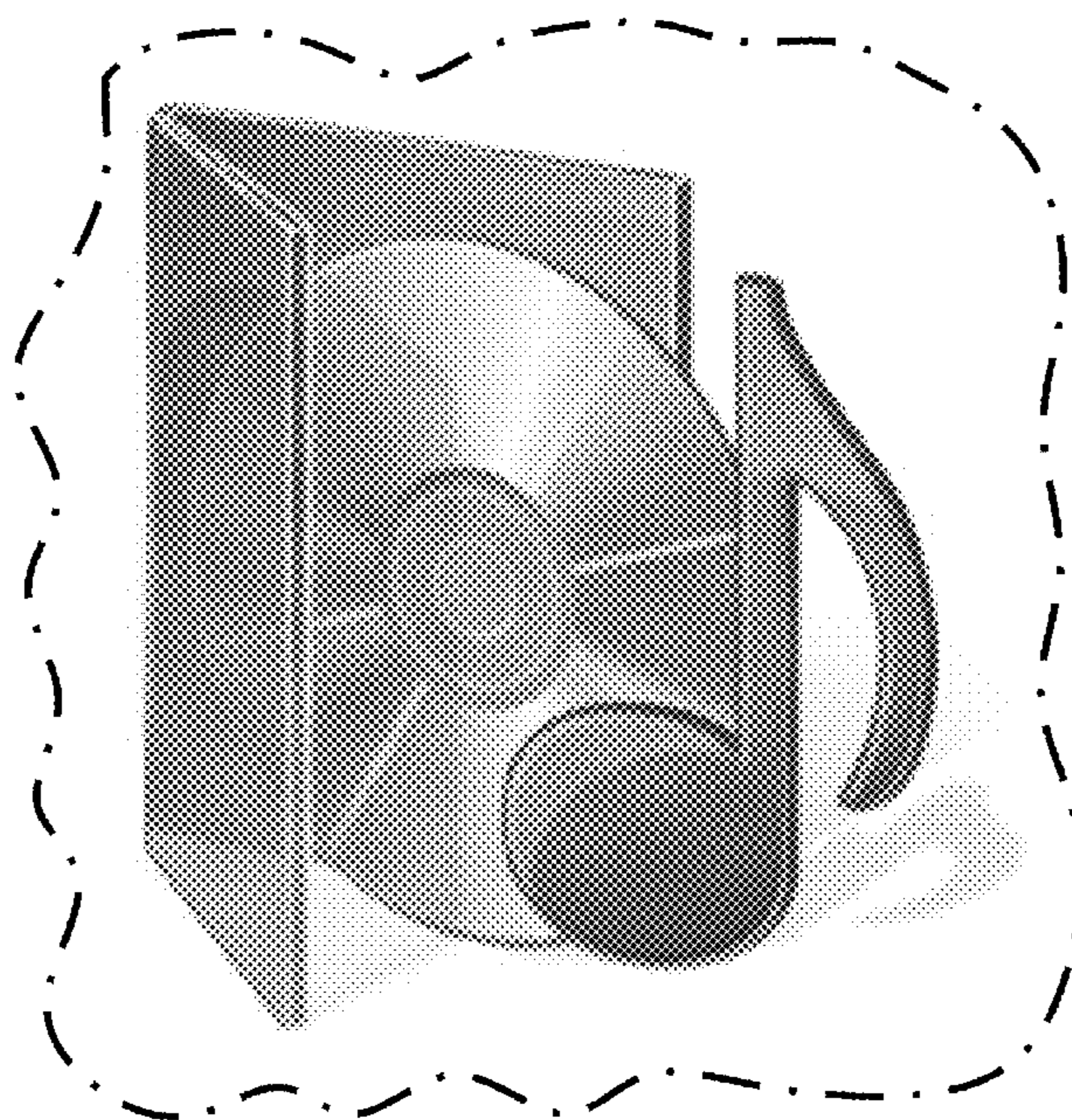
The FIGURE is a front view of an icon for a portion of a display screen showing our new design.
