FIG. 15 is a top plan view thereof.

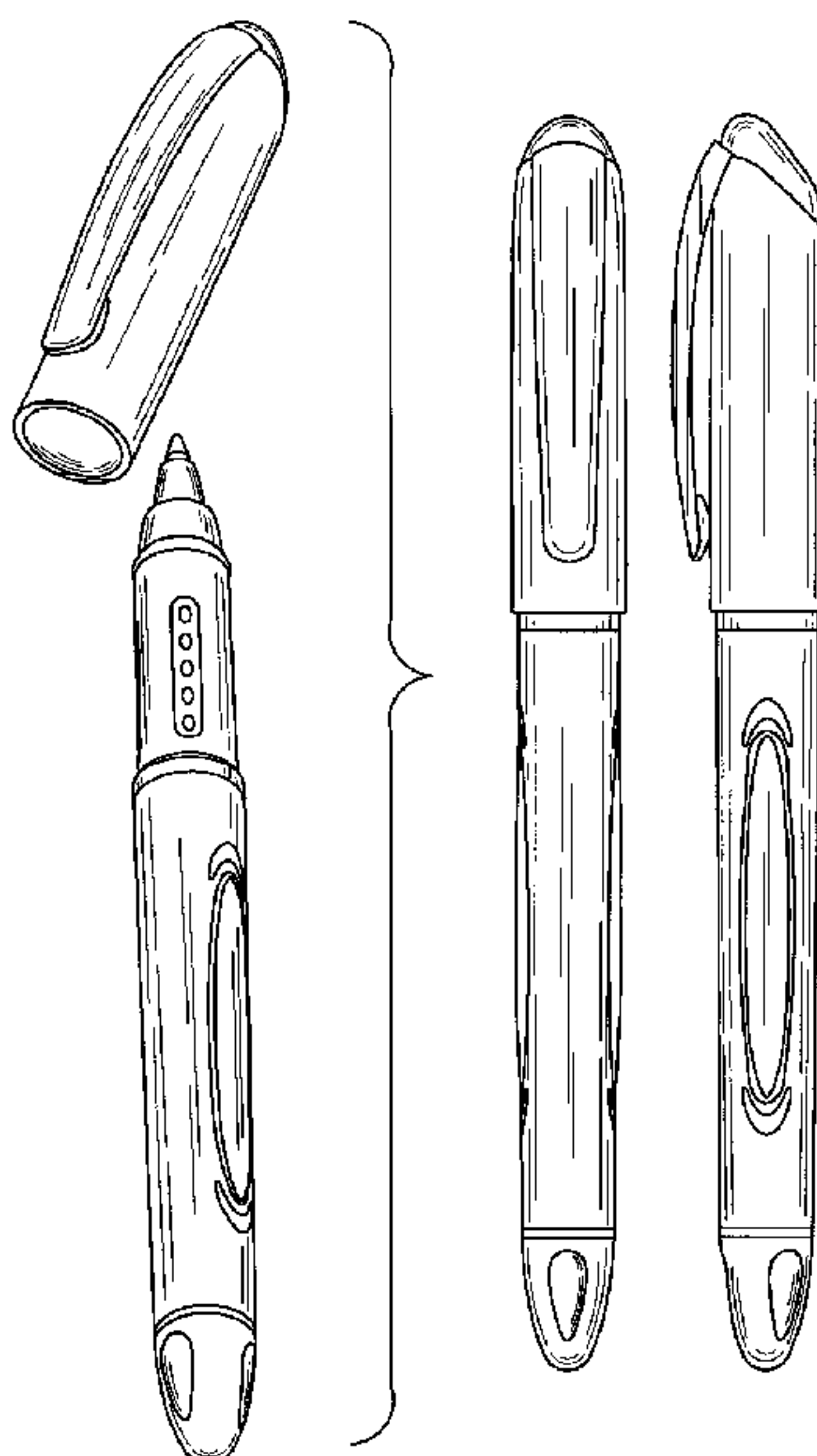

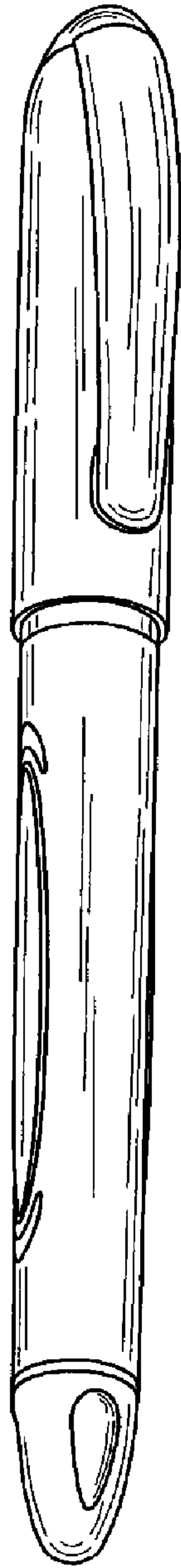

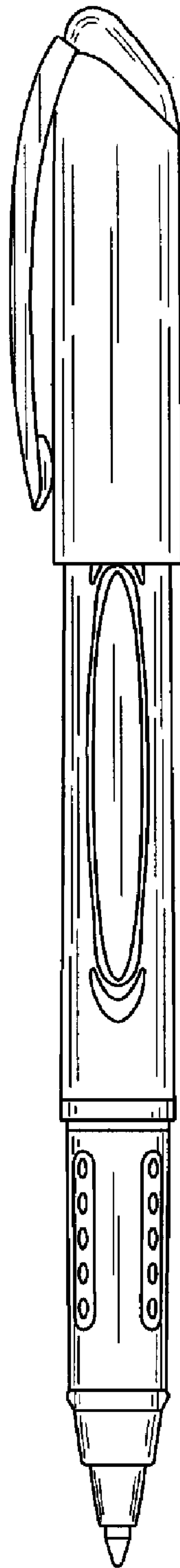

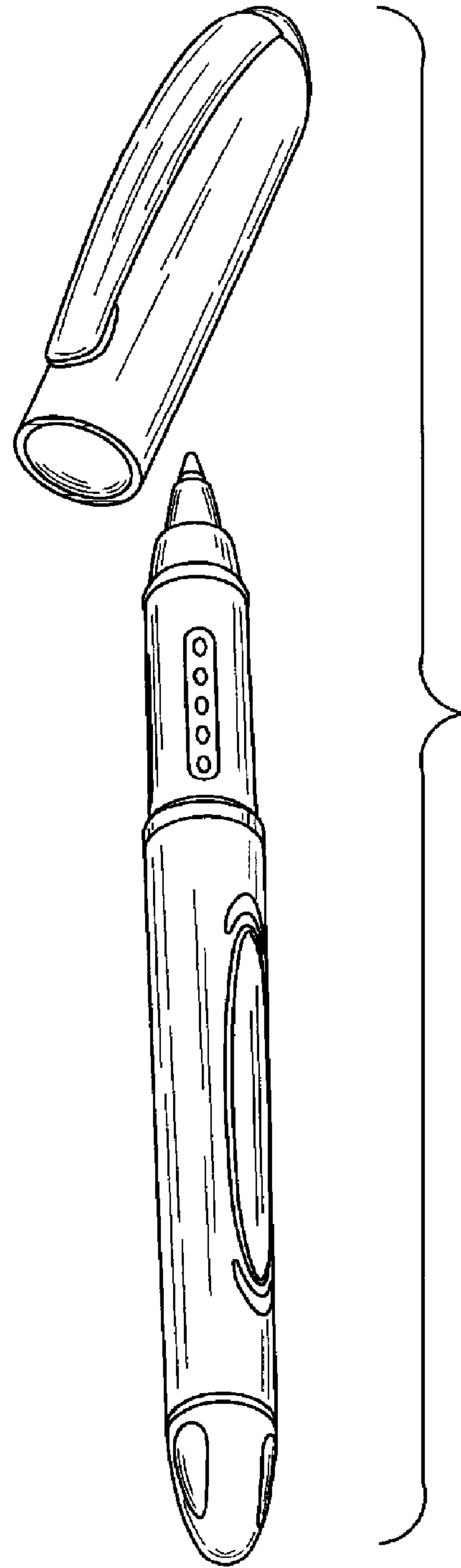

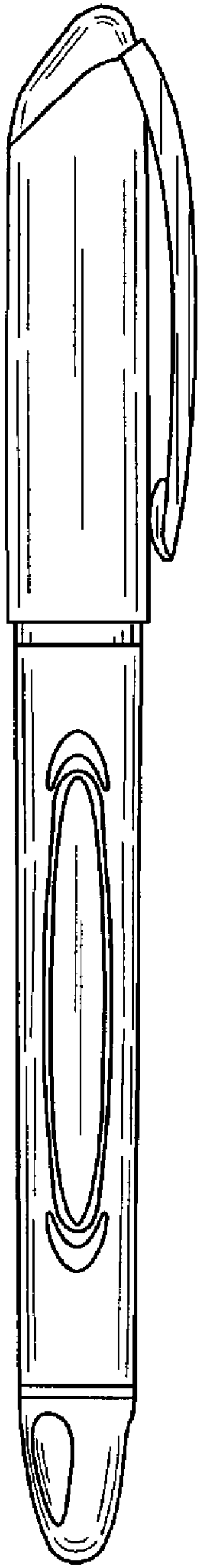

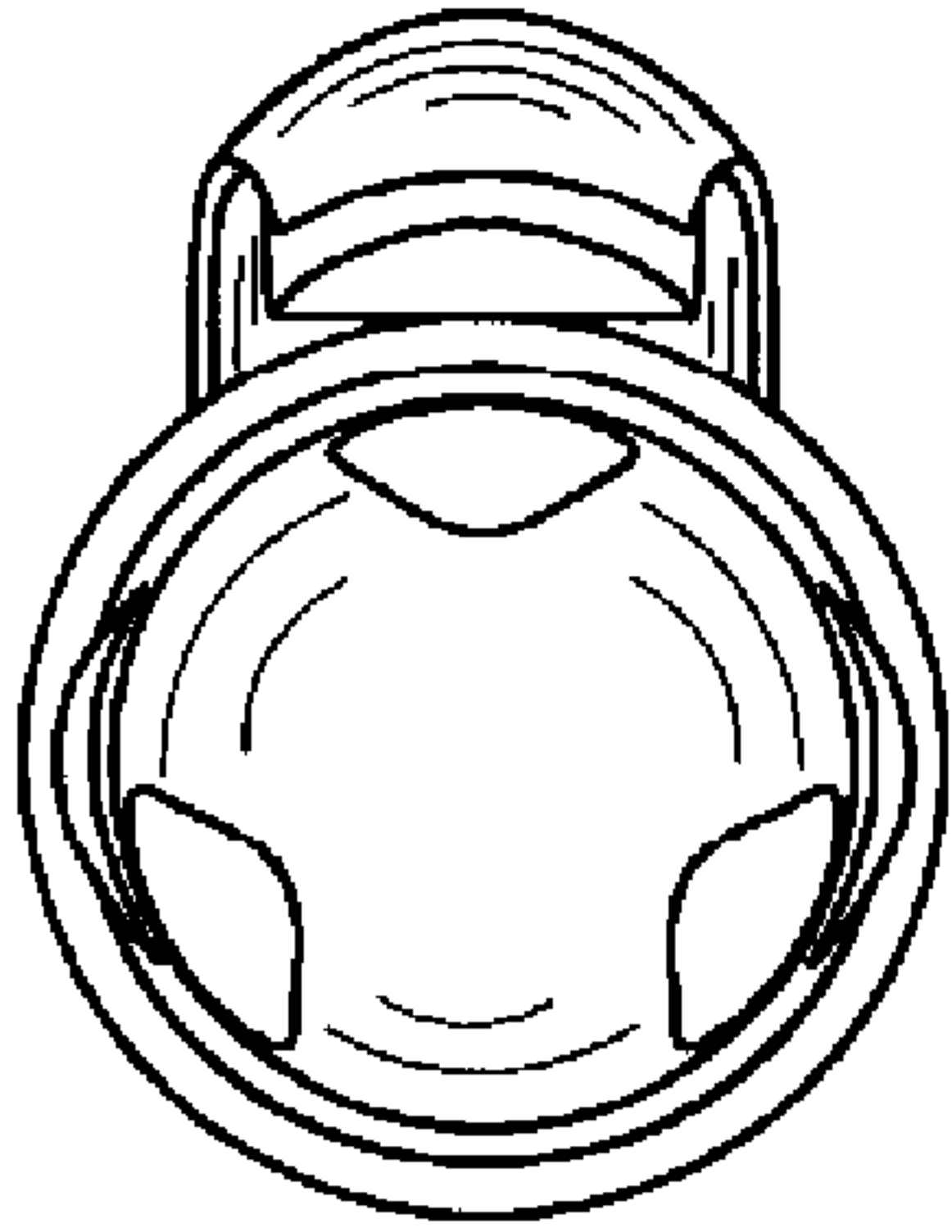

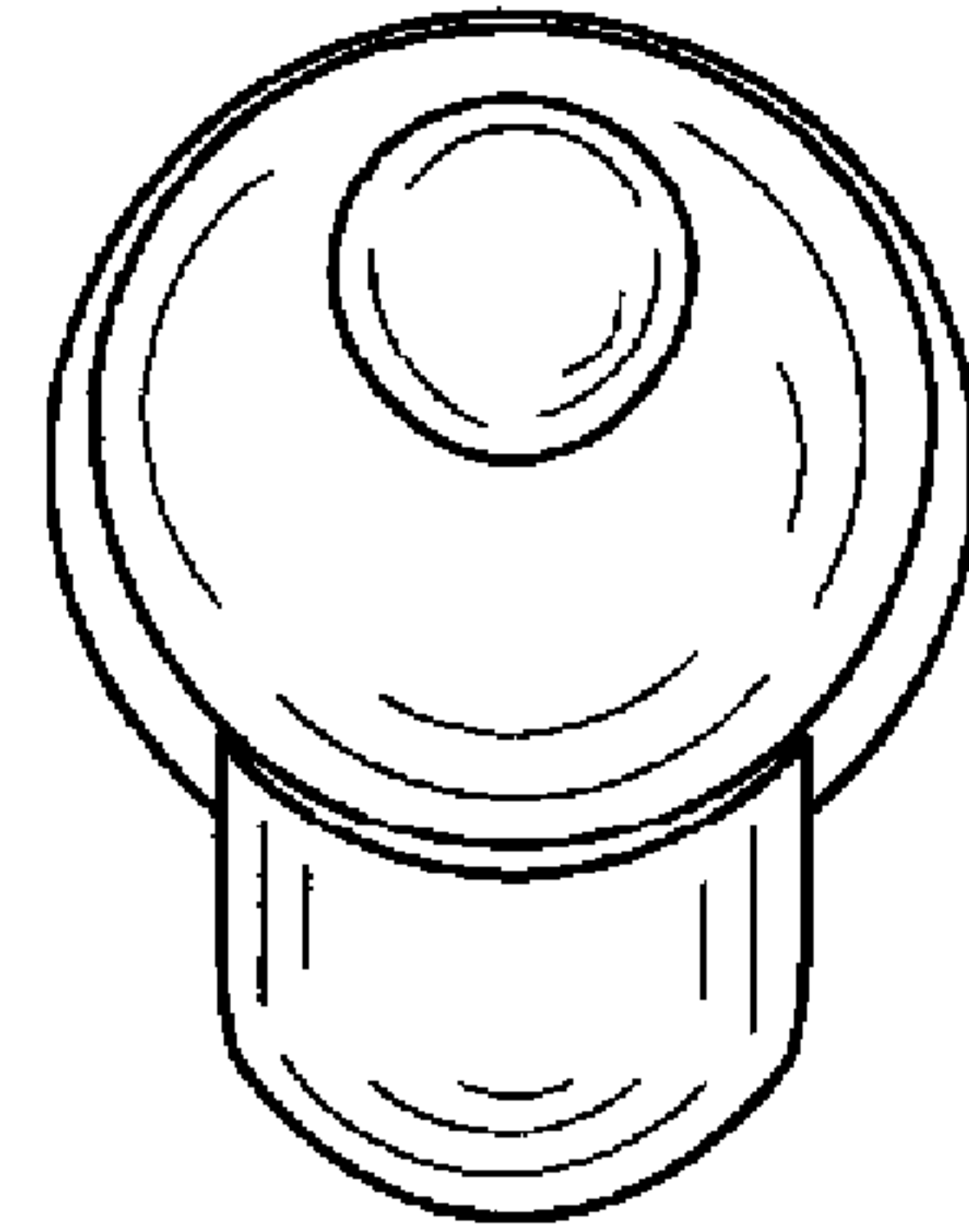

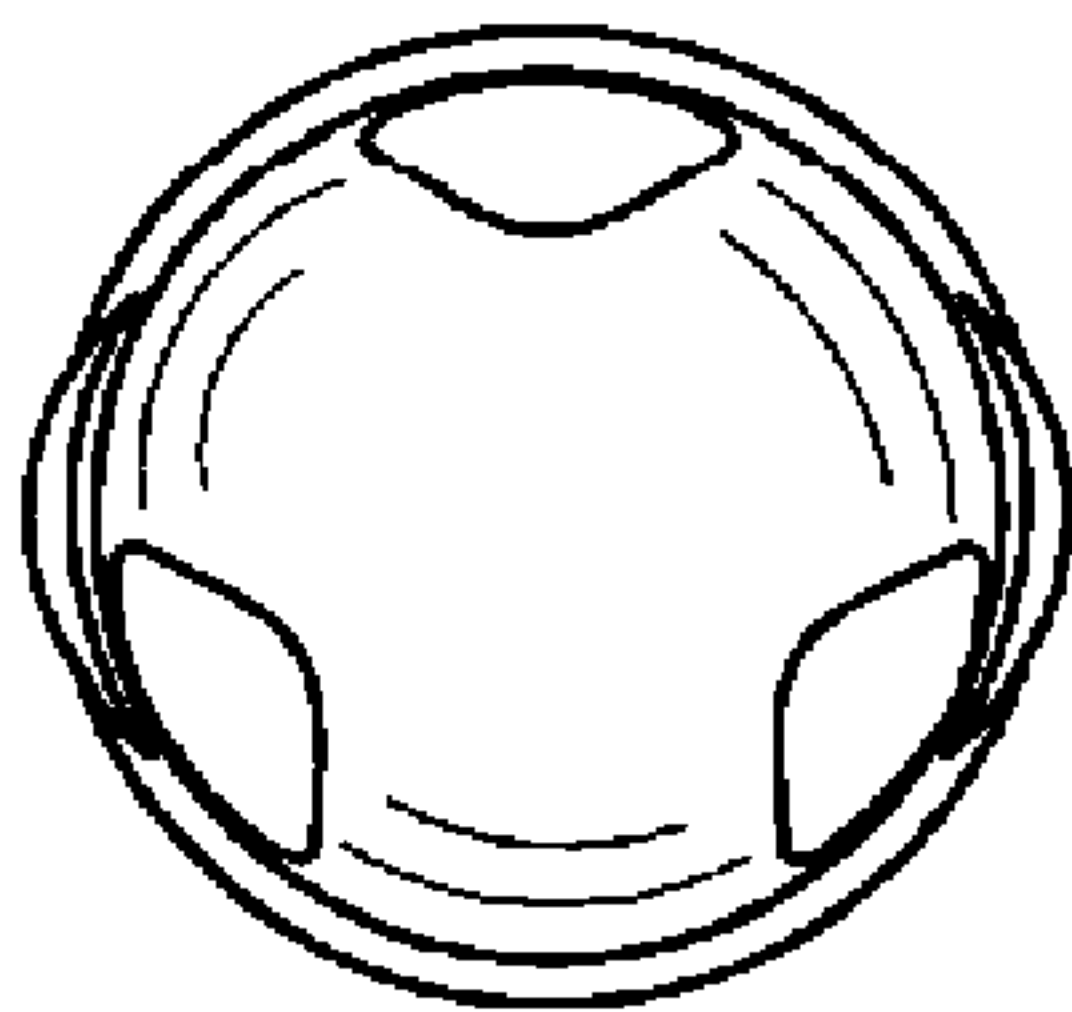

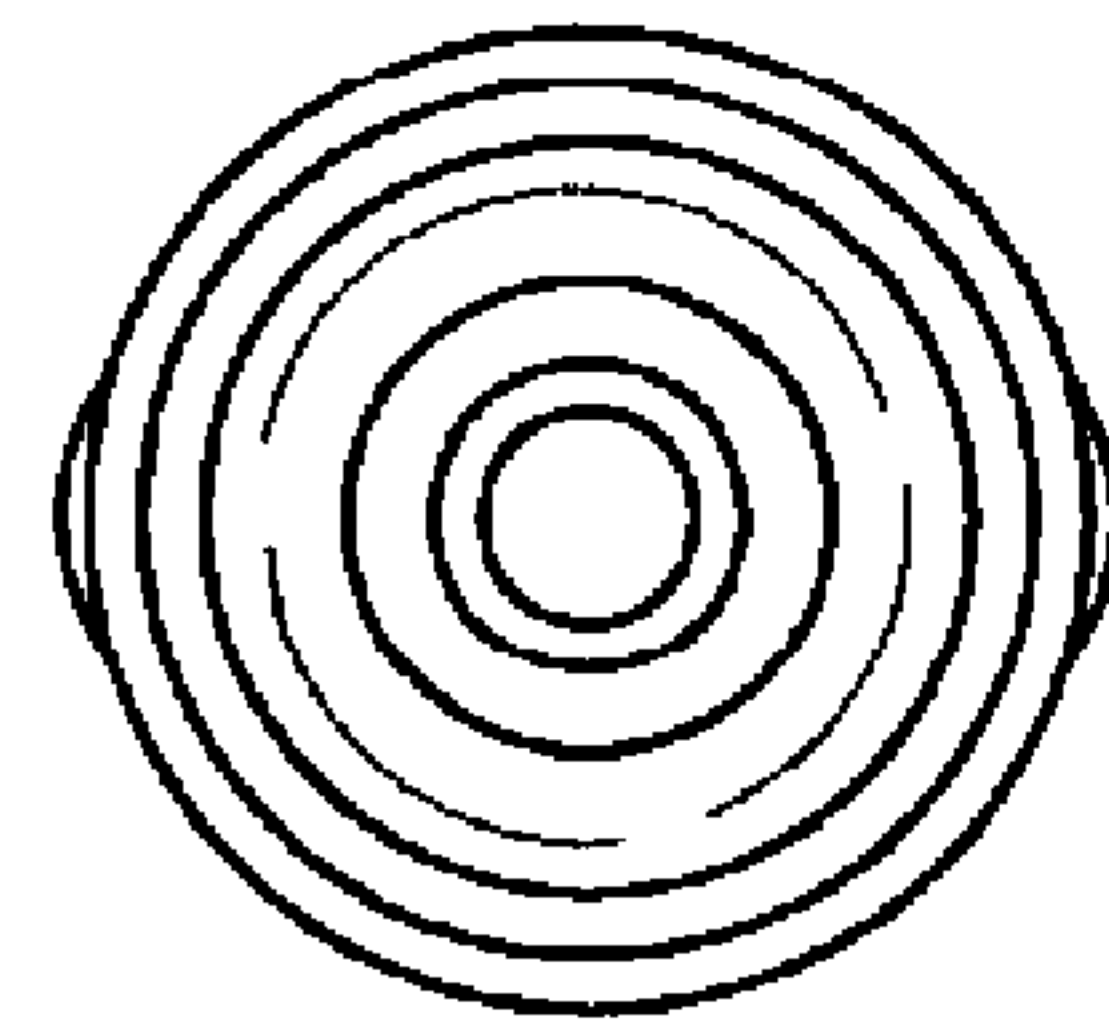

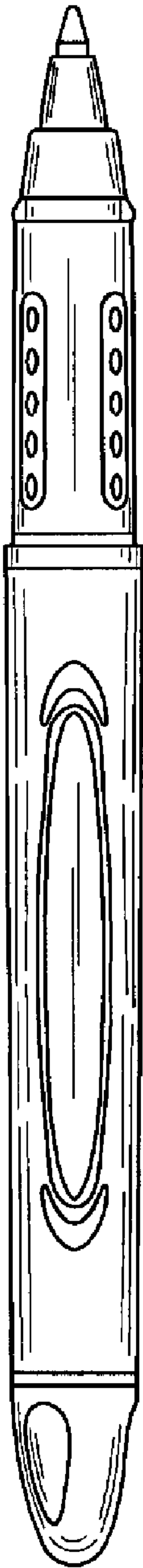

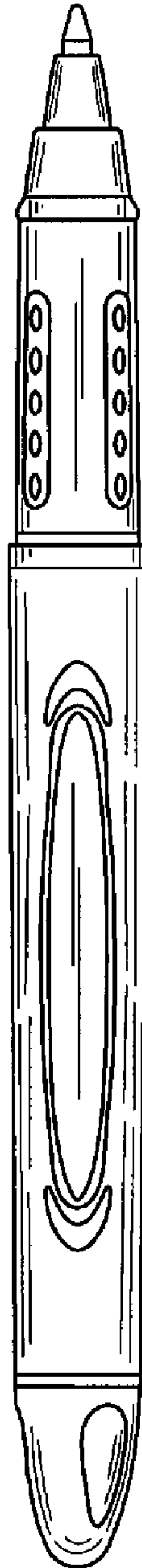
