(57) **CLAIM**

The ornamental design for a lavatory, as shown and described.

**DESCRIPTION**

In a preferred embodiment, the nature of this product is as a plumbing fixture in the form of a lavatory which is primarily useful for washing the body parts of humans.

FIG. 25 is a right side elevational view thereof;

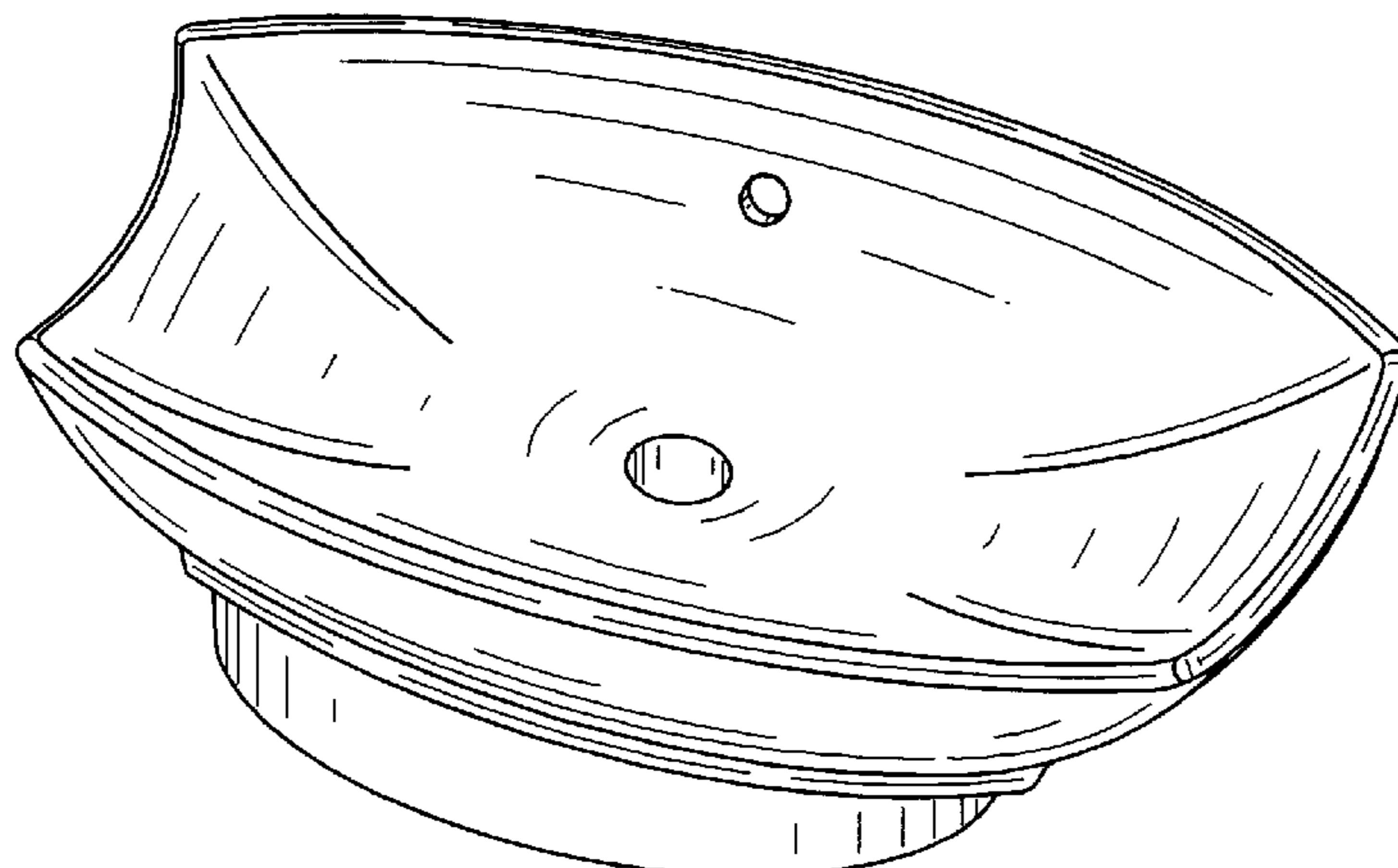
FIG. 26 is a left side elevational view thereof;

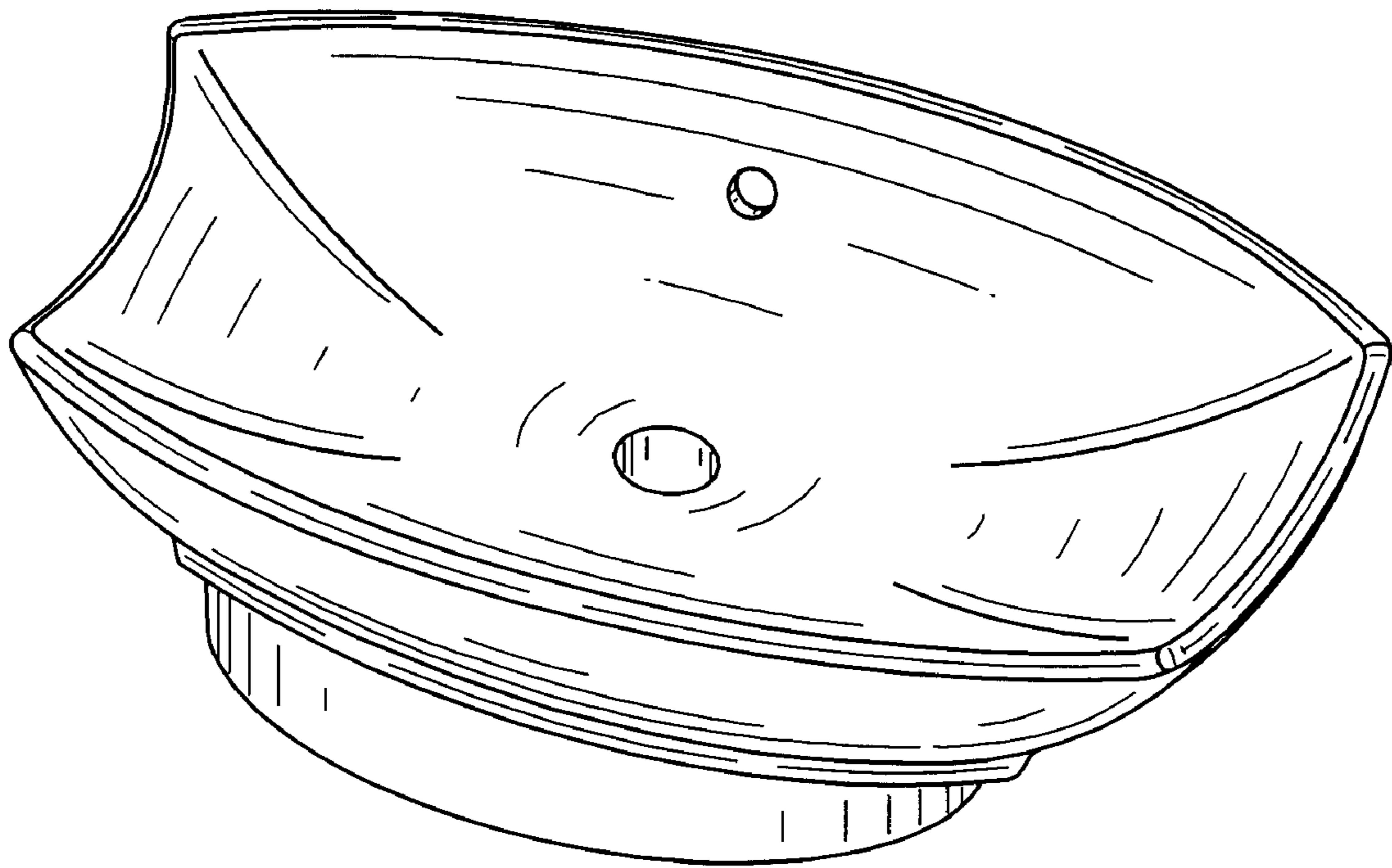

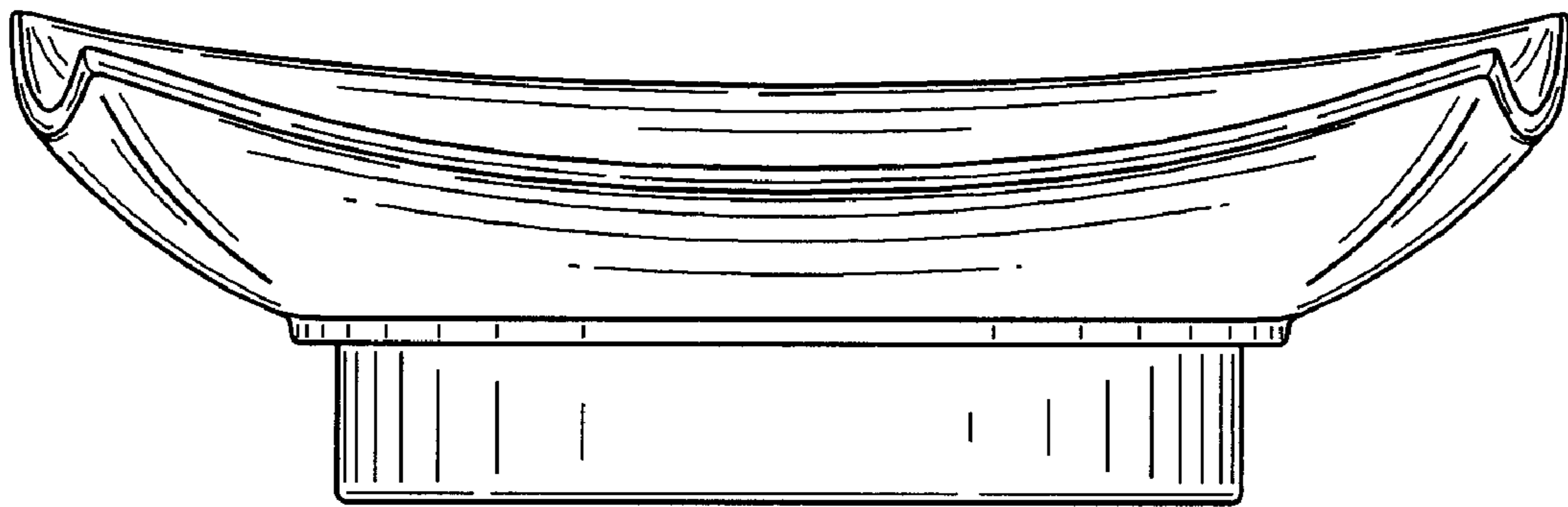

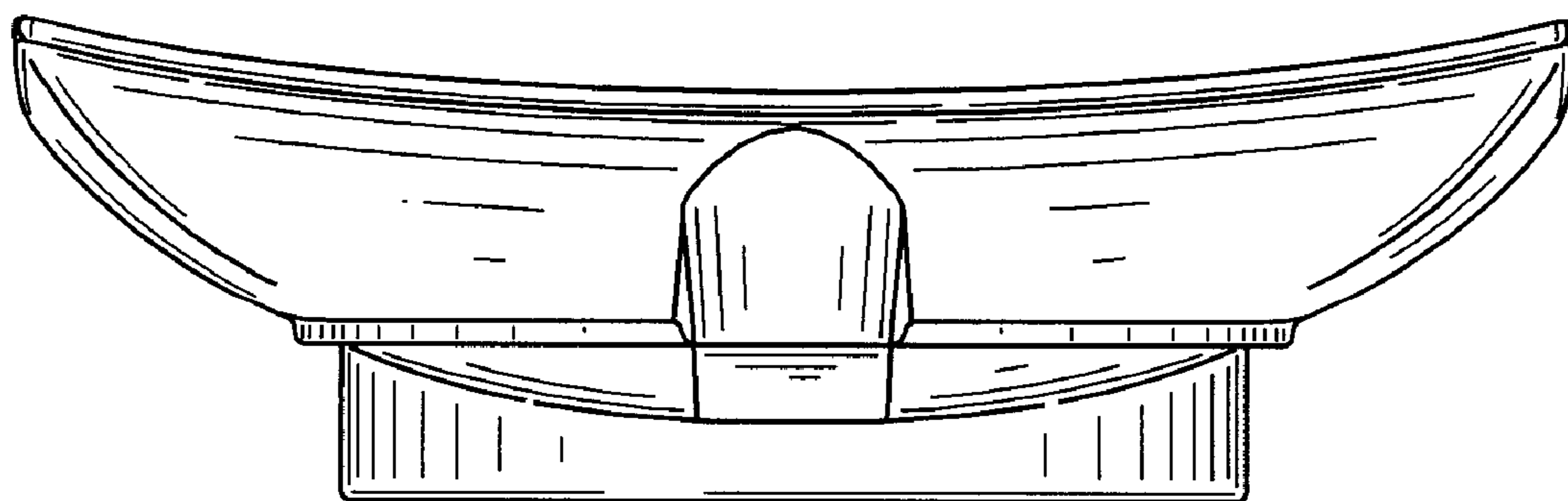

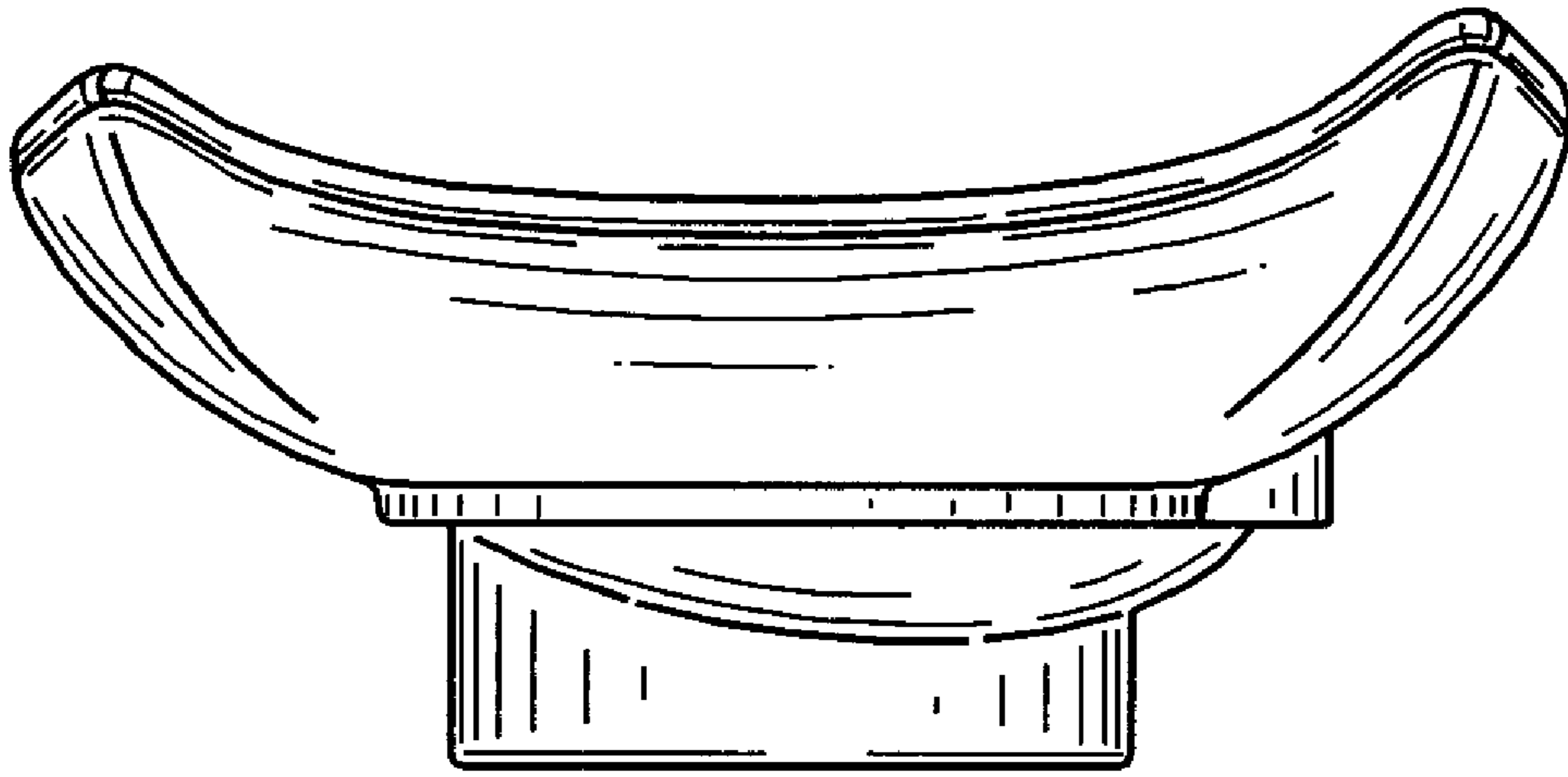

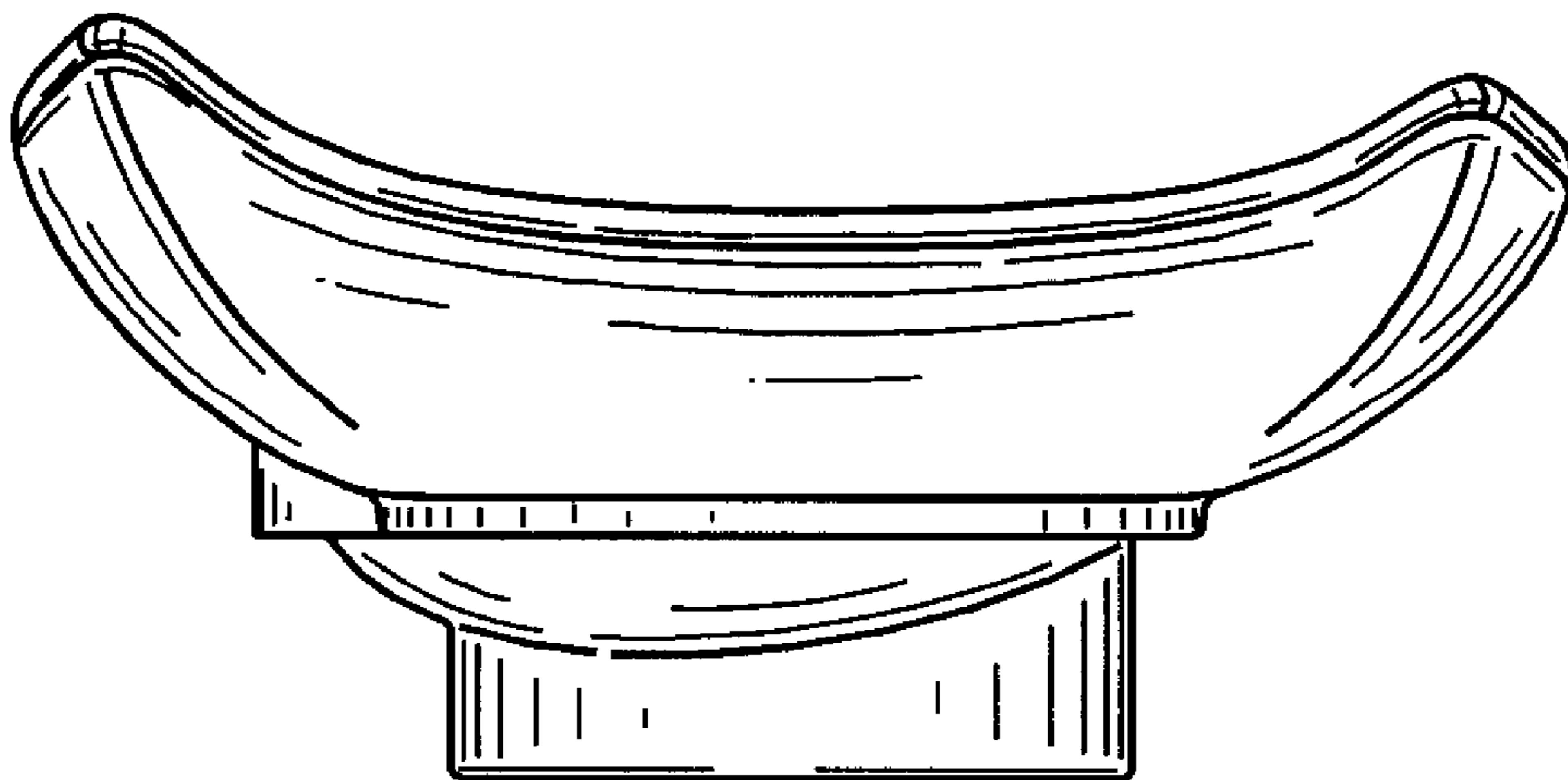

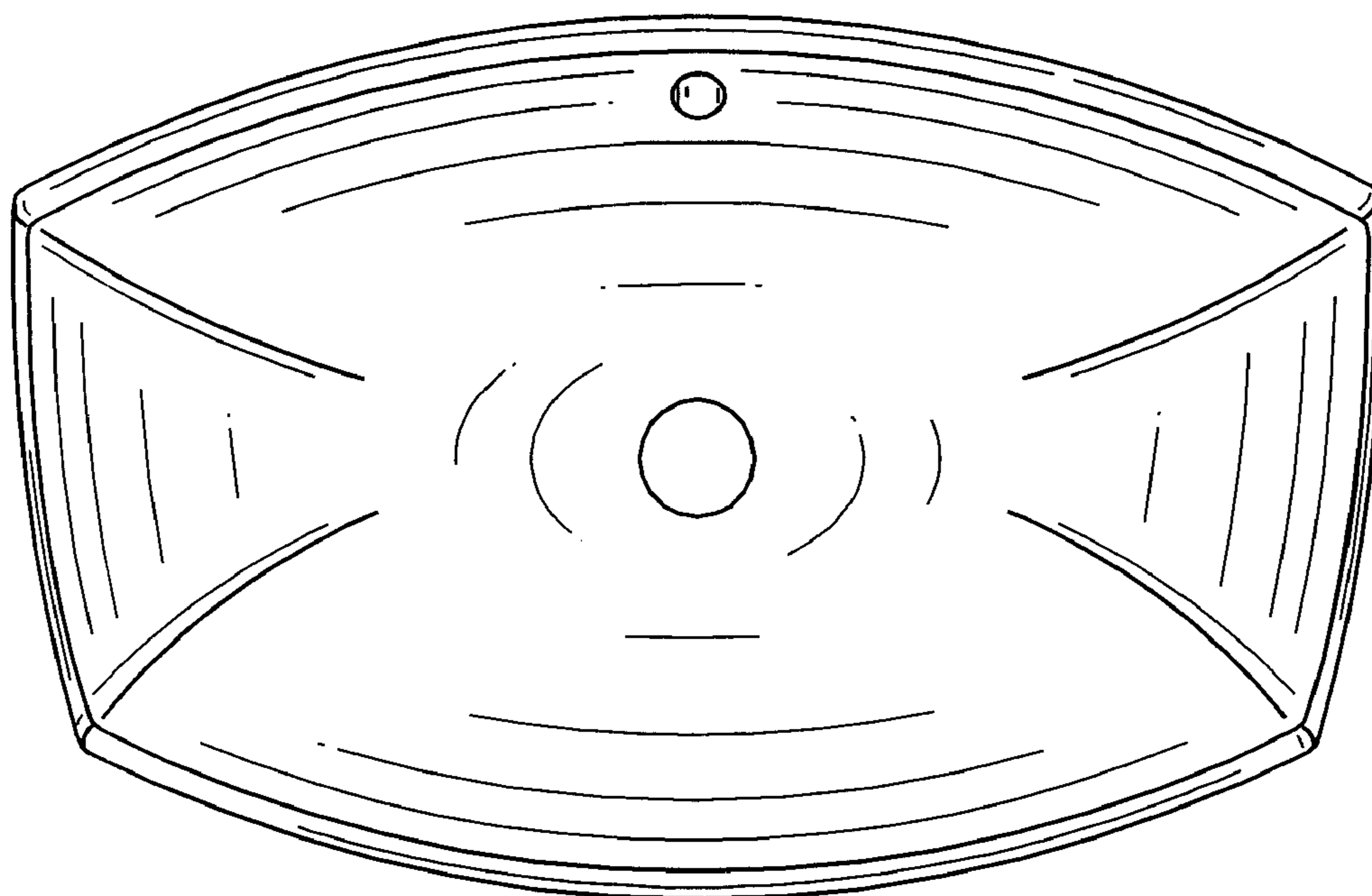

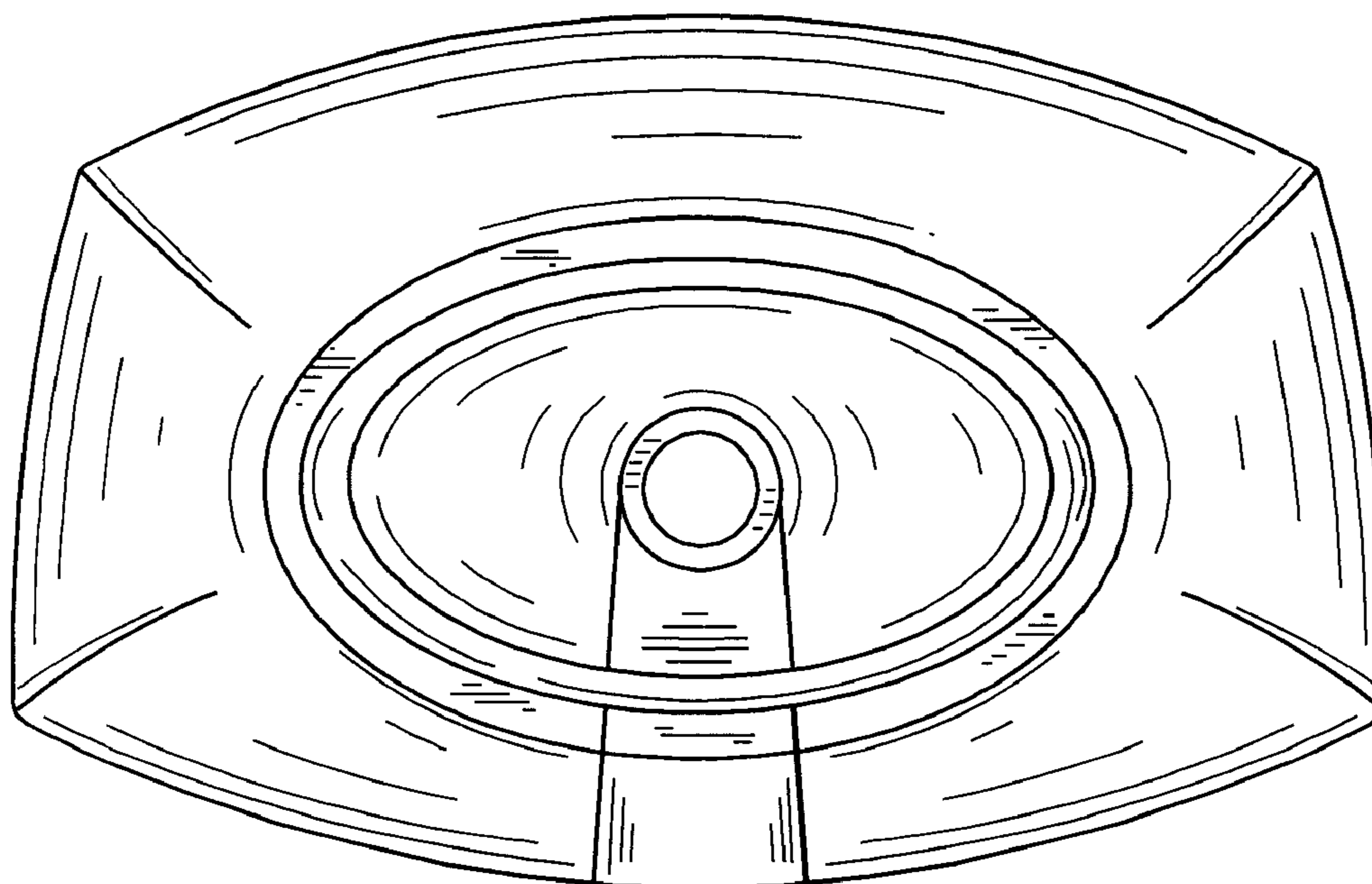

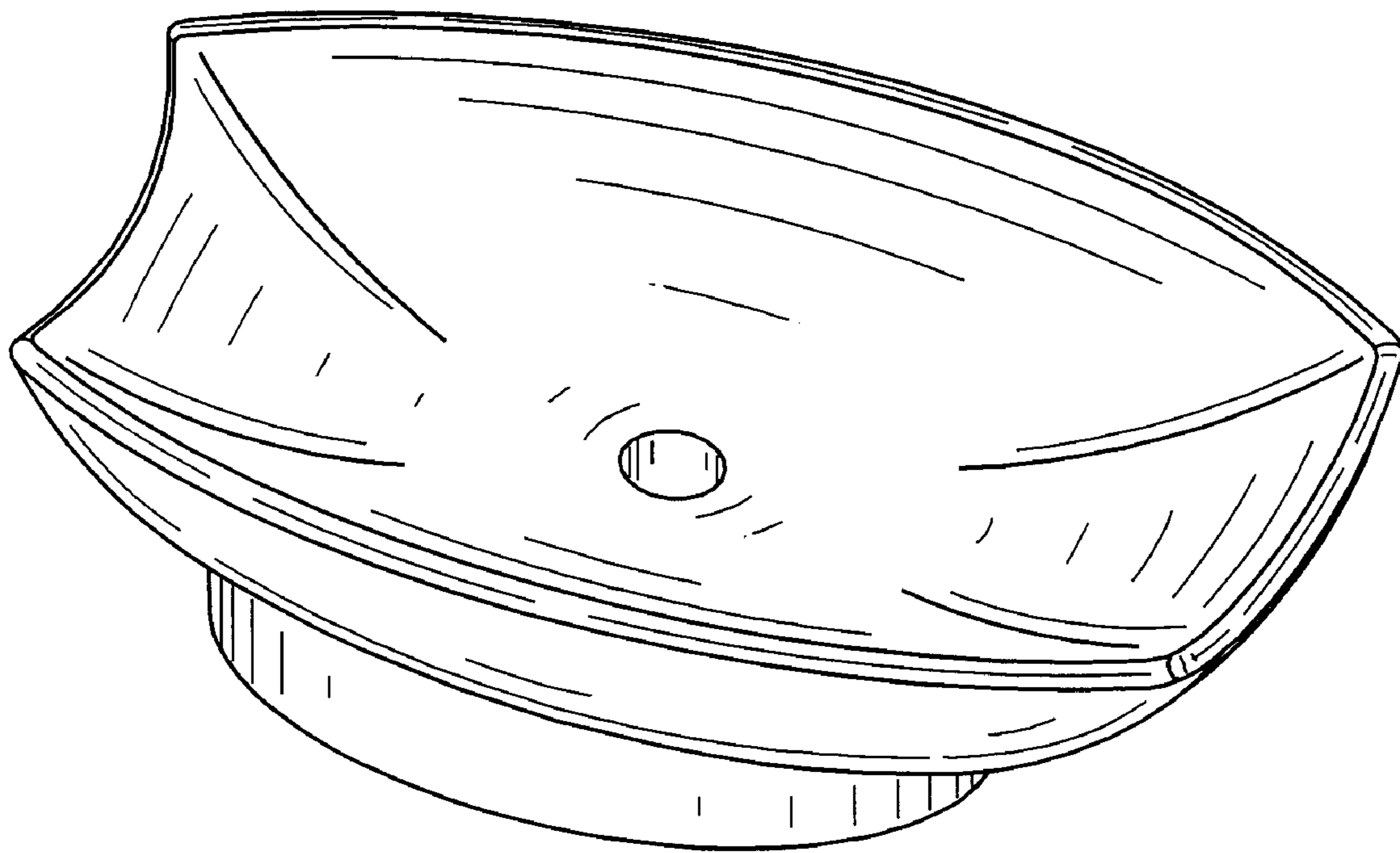

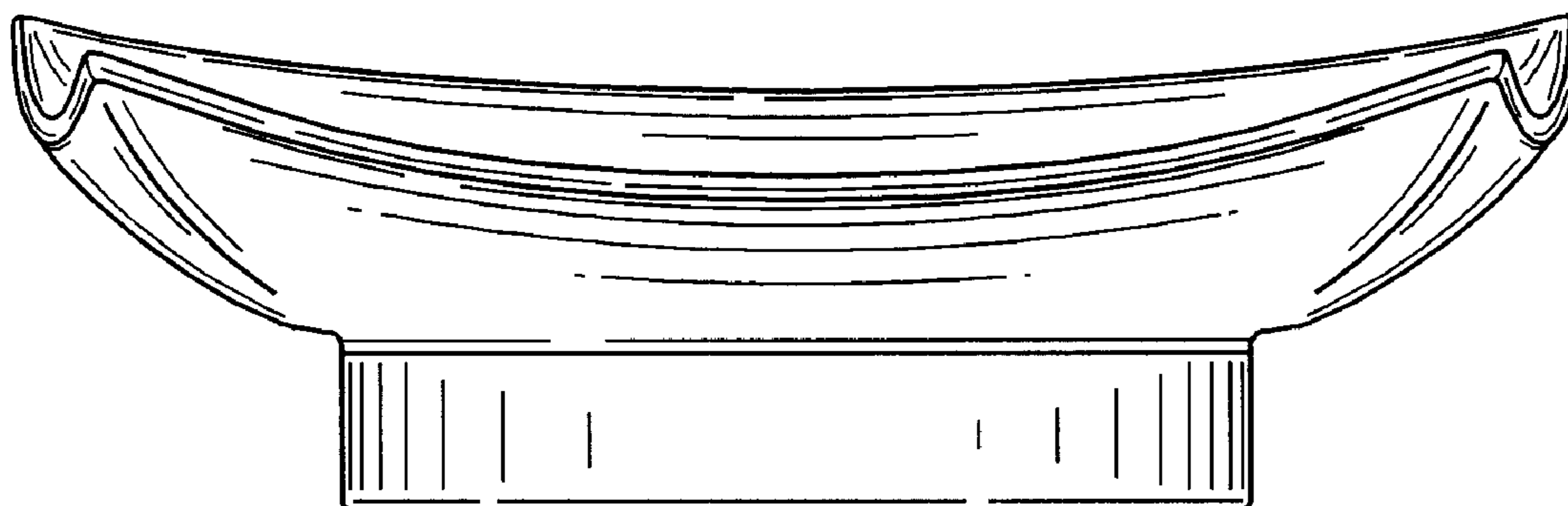

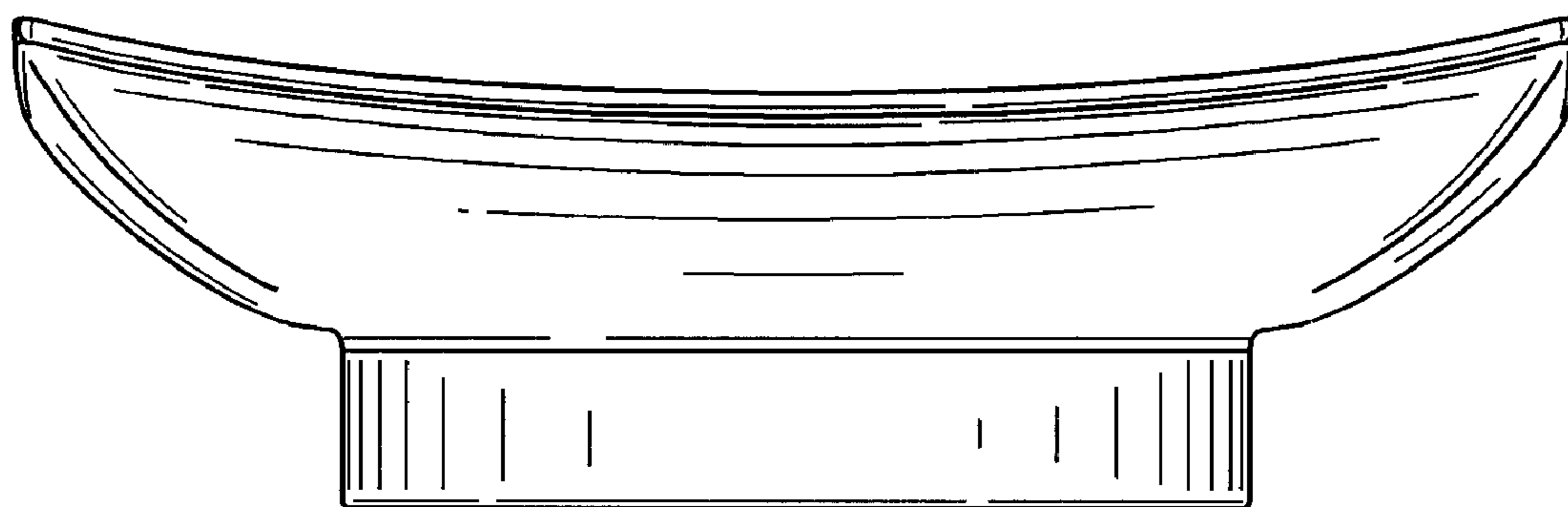

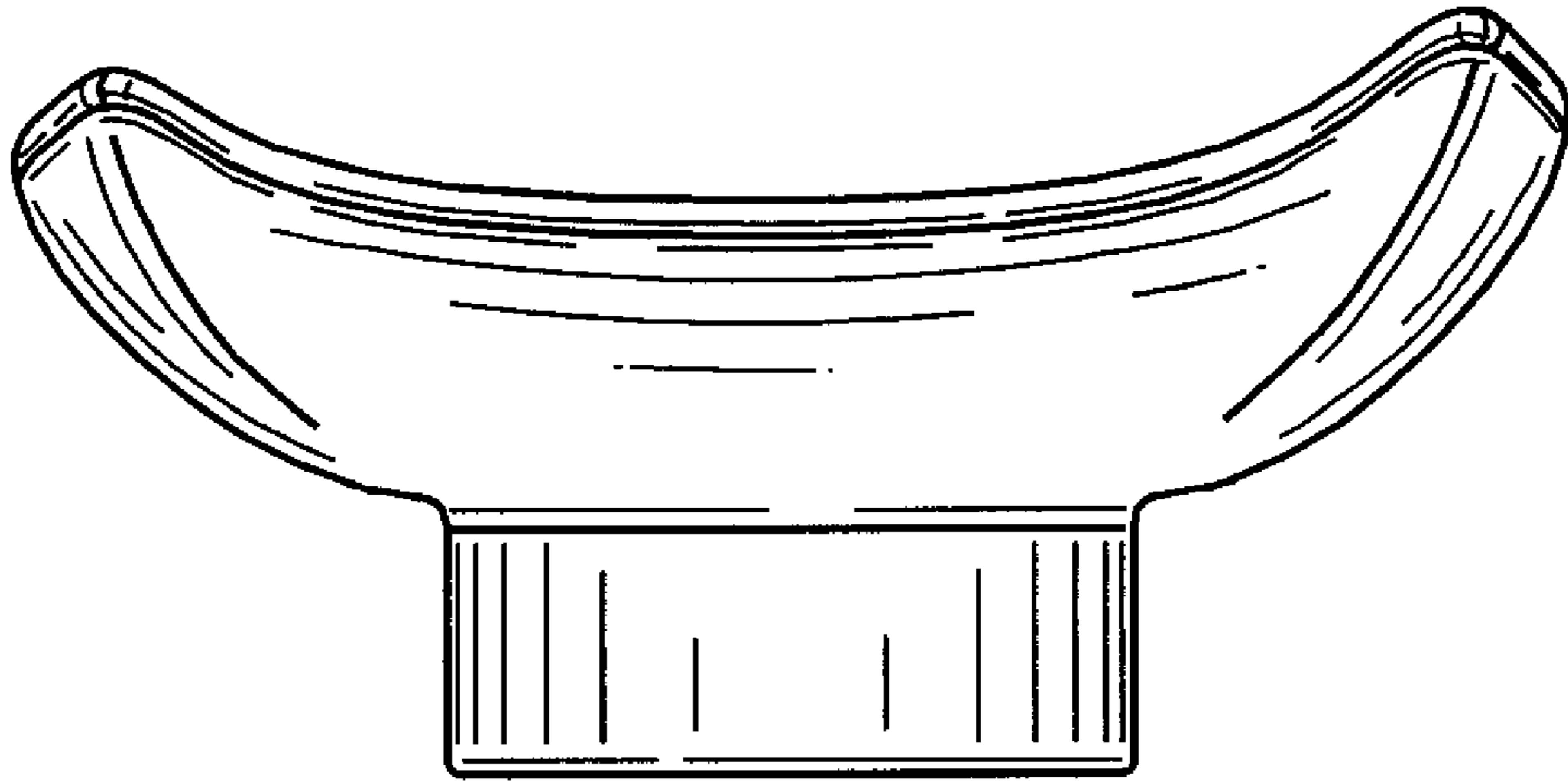

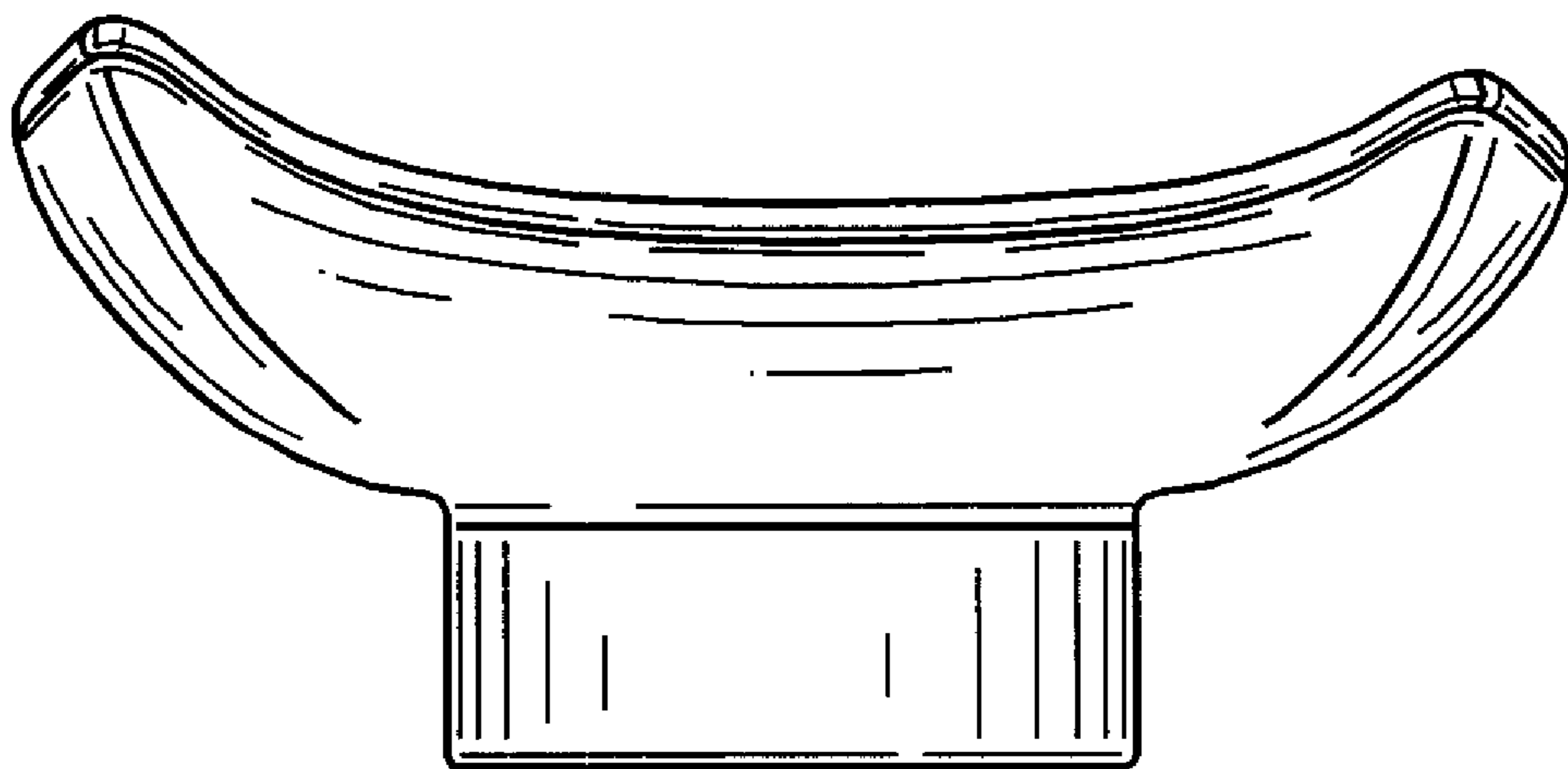

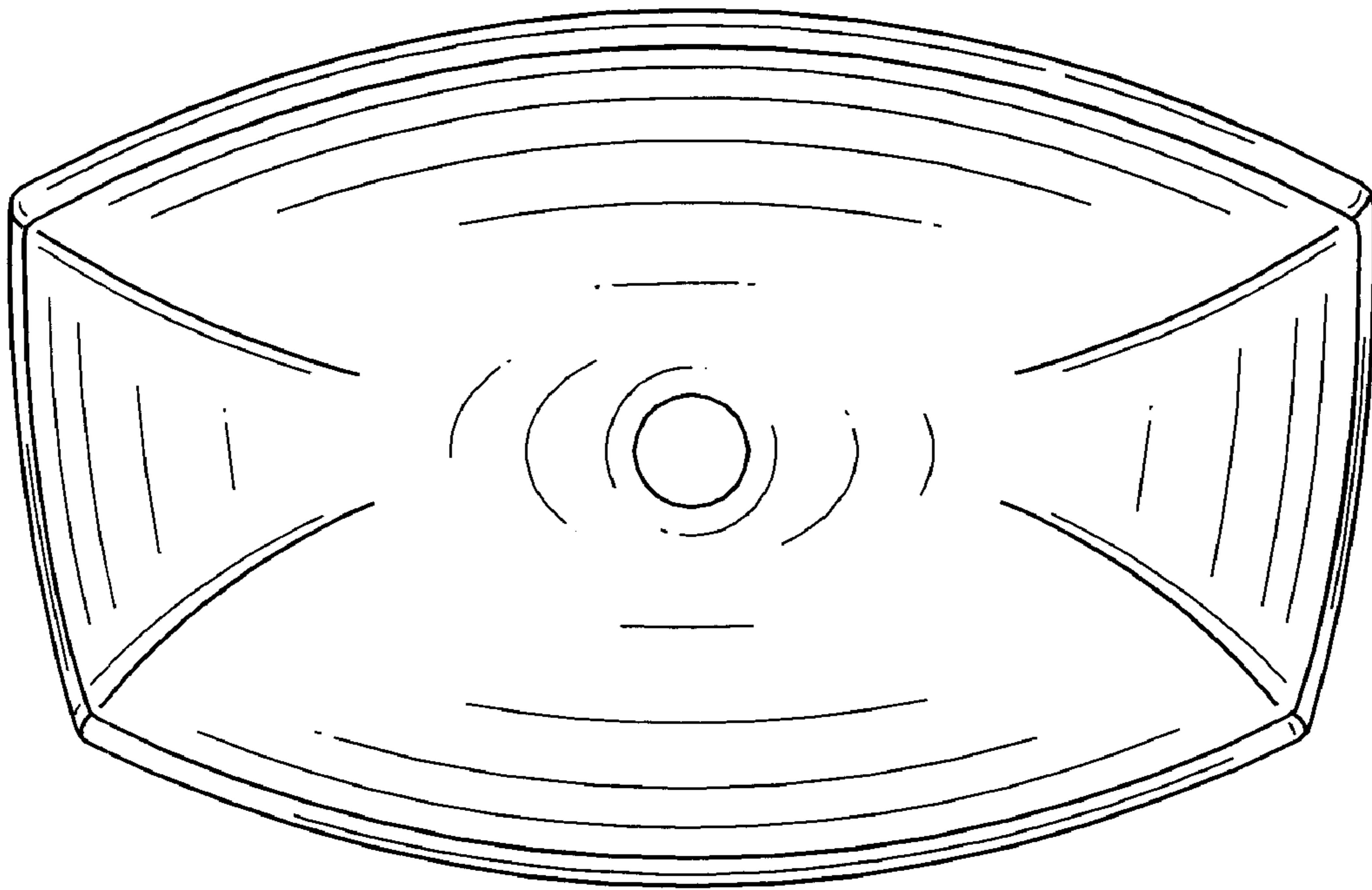

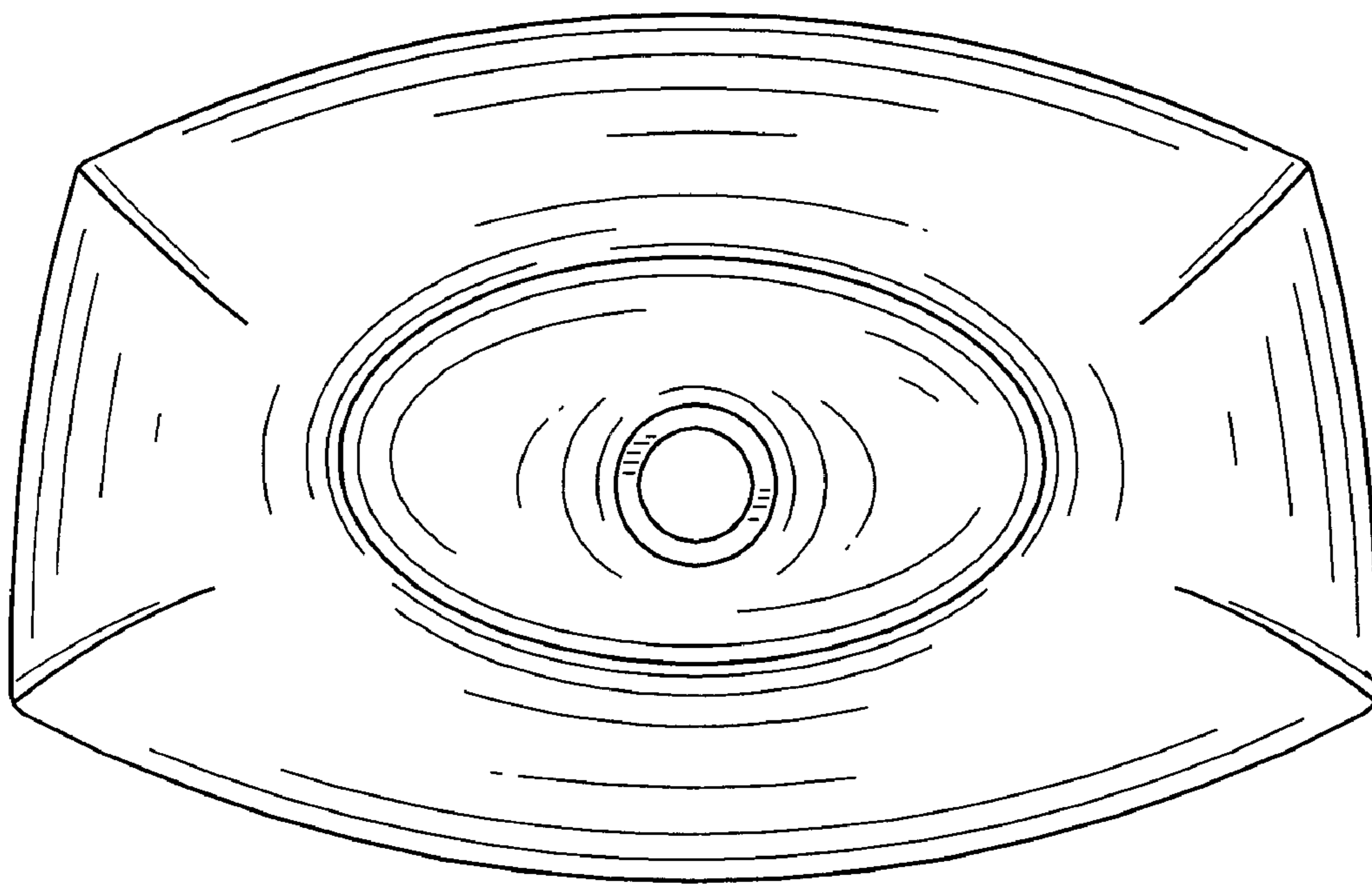

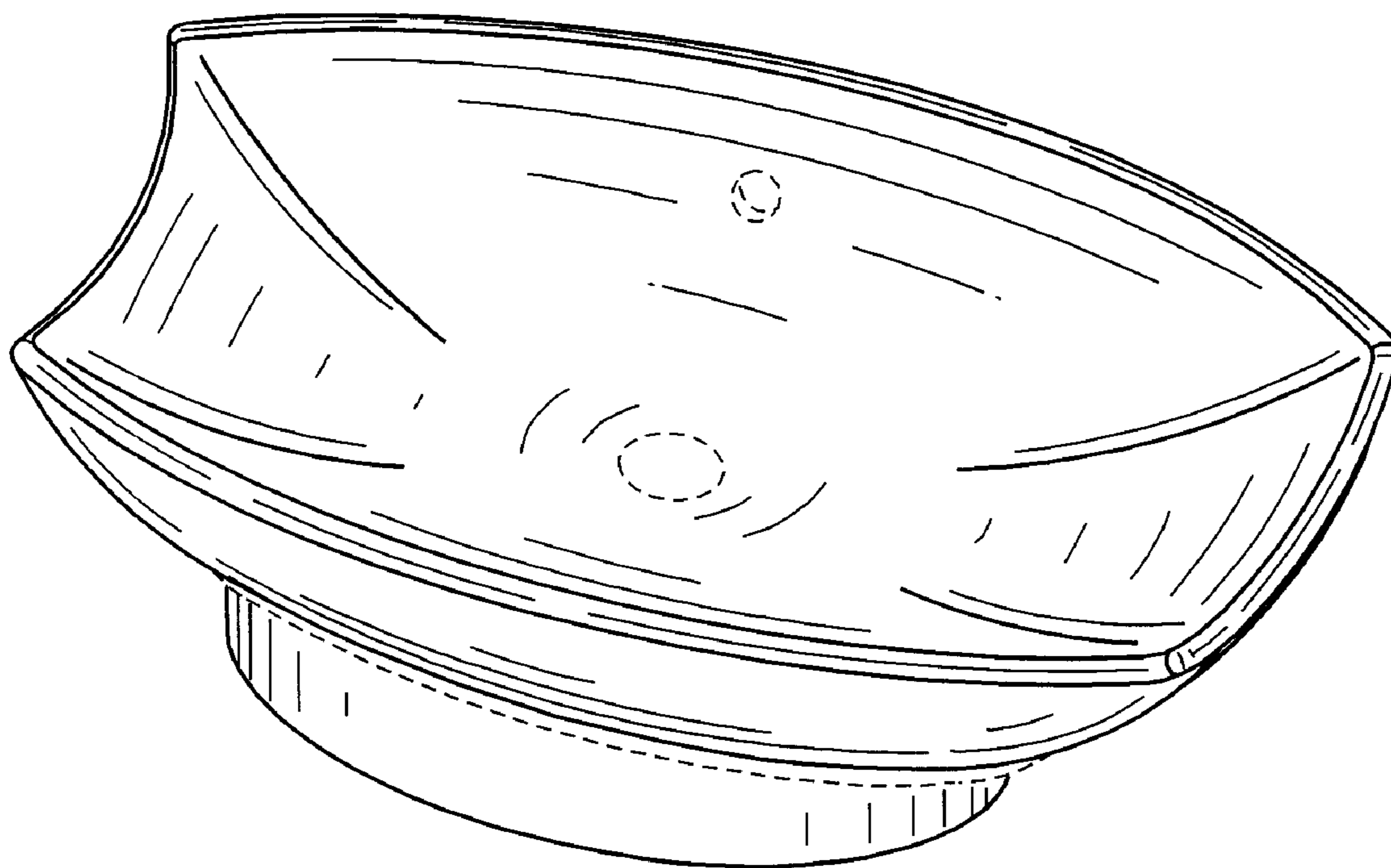

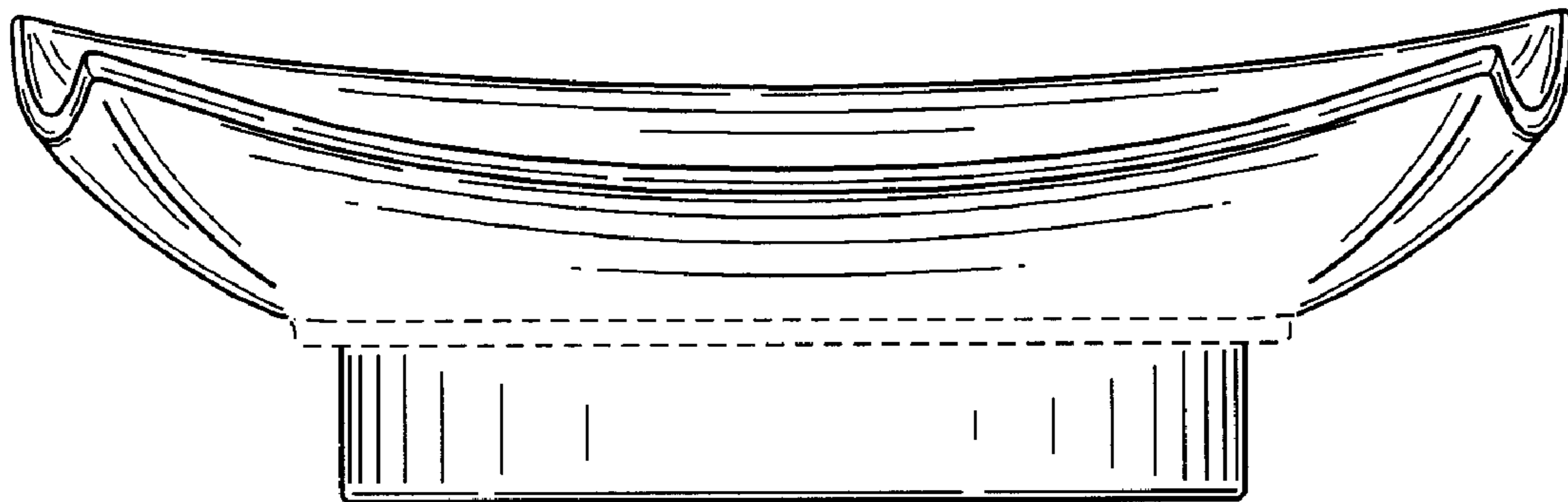

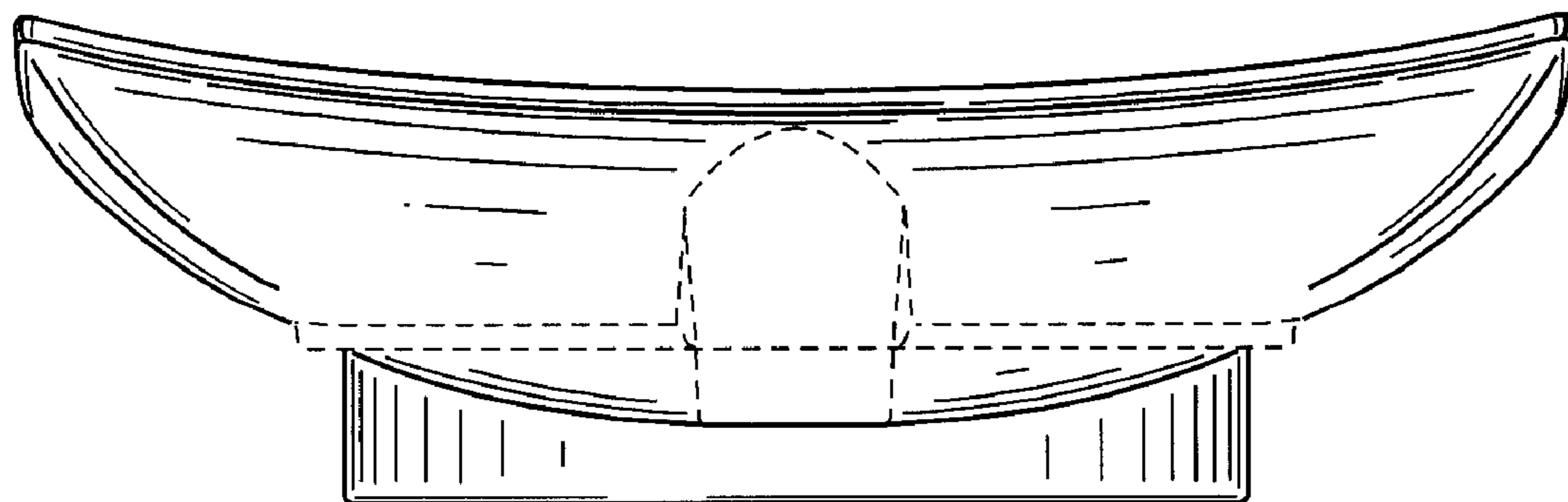

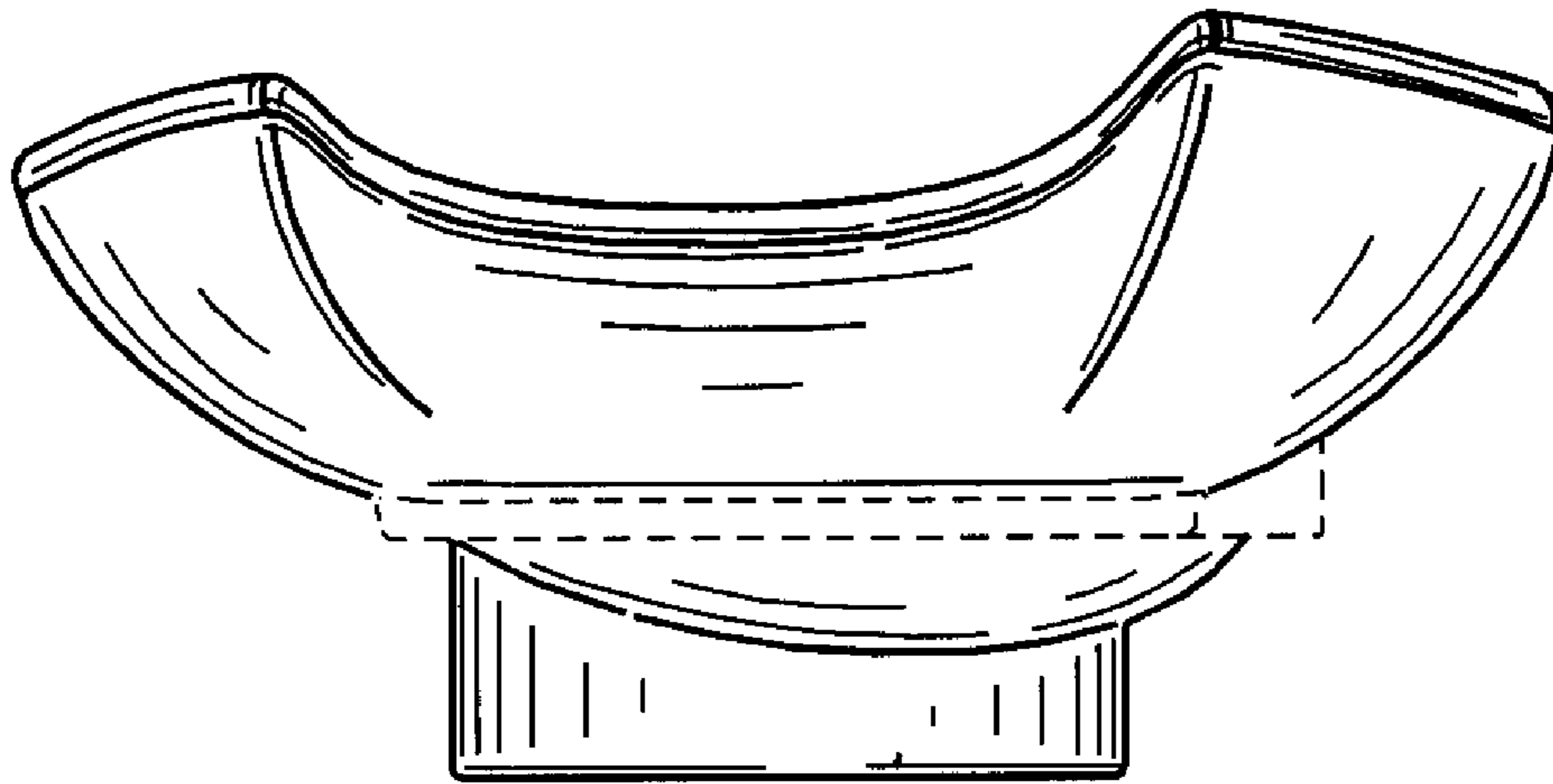

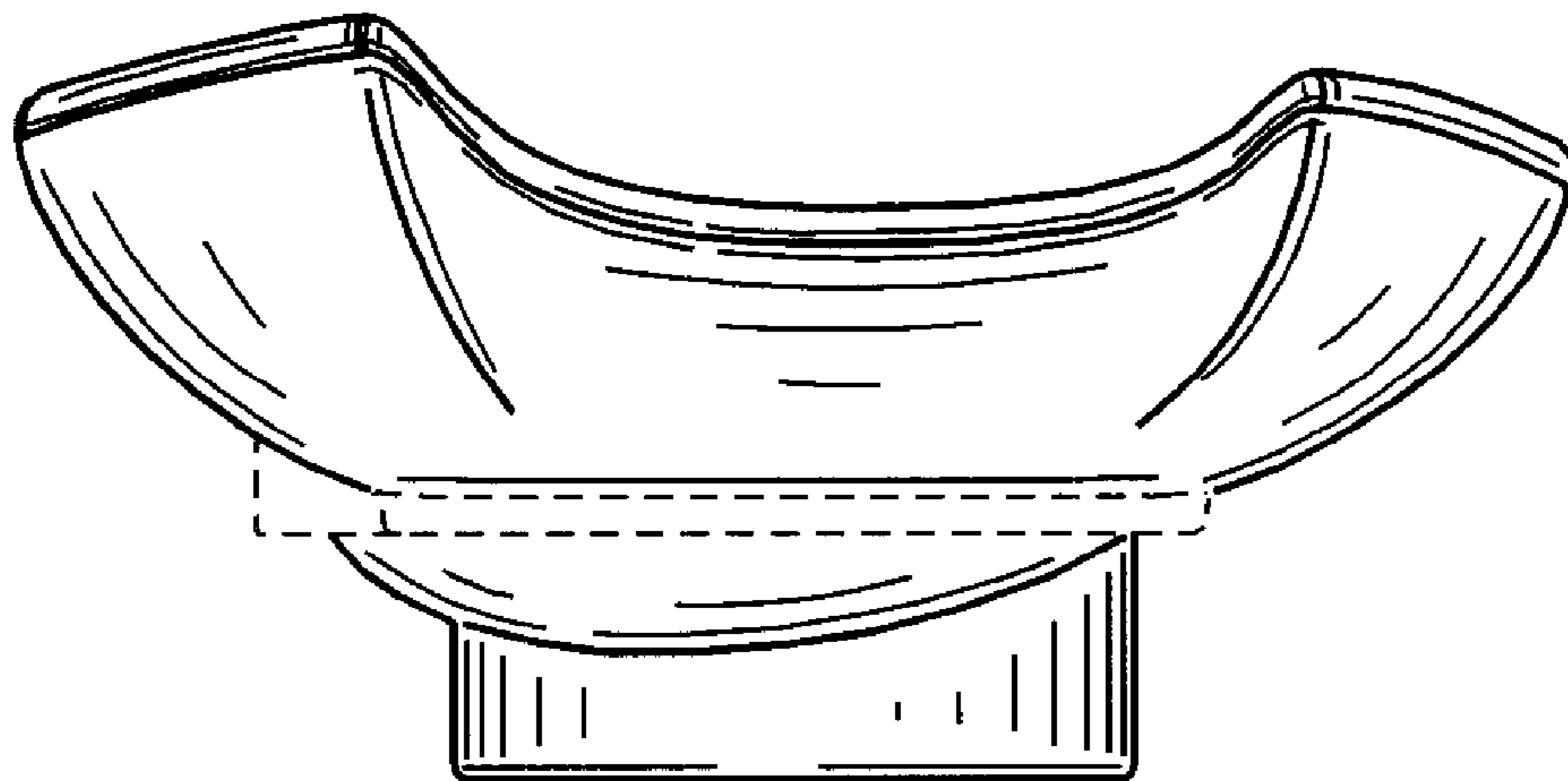

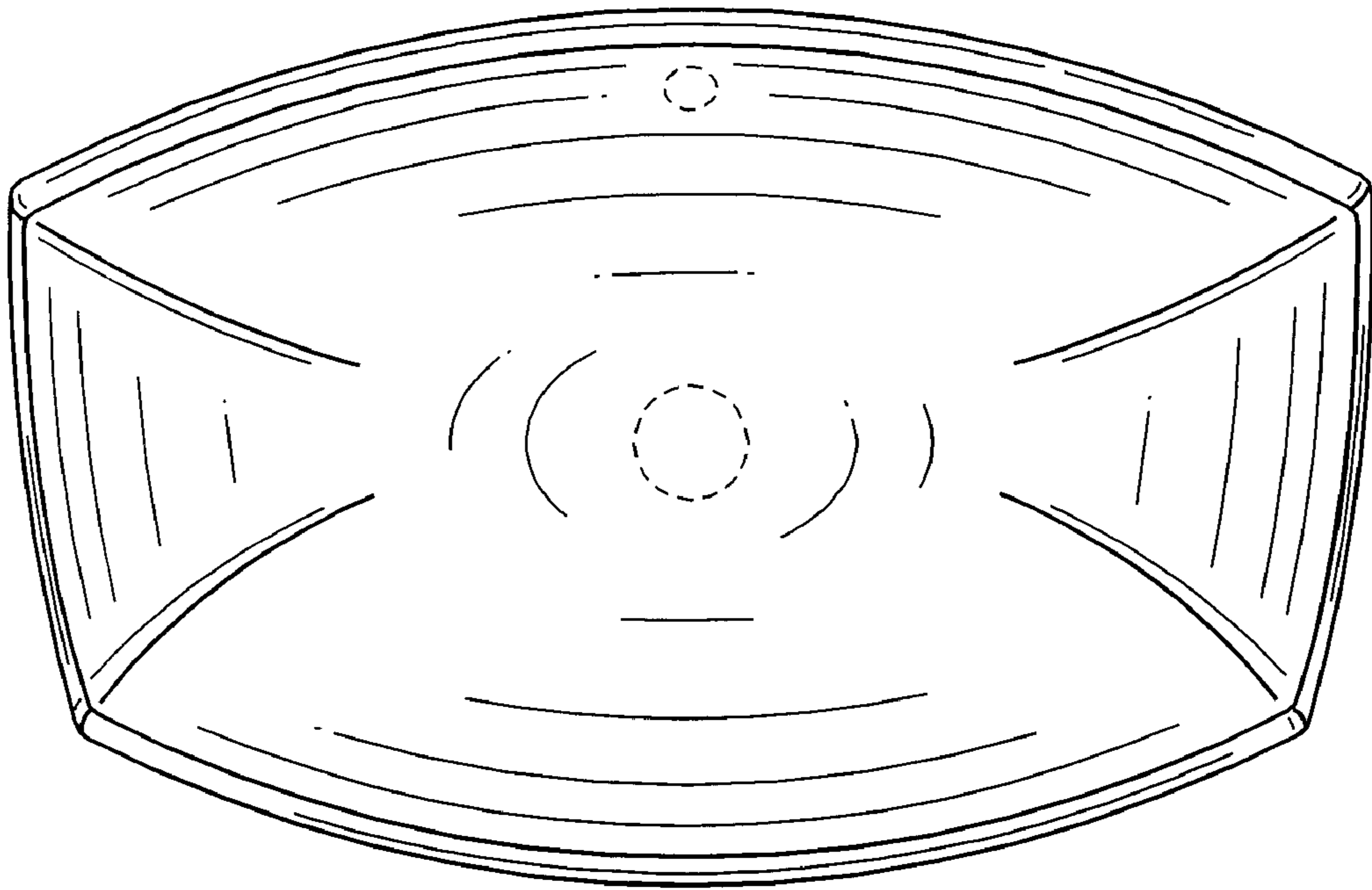

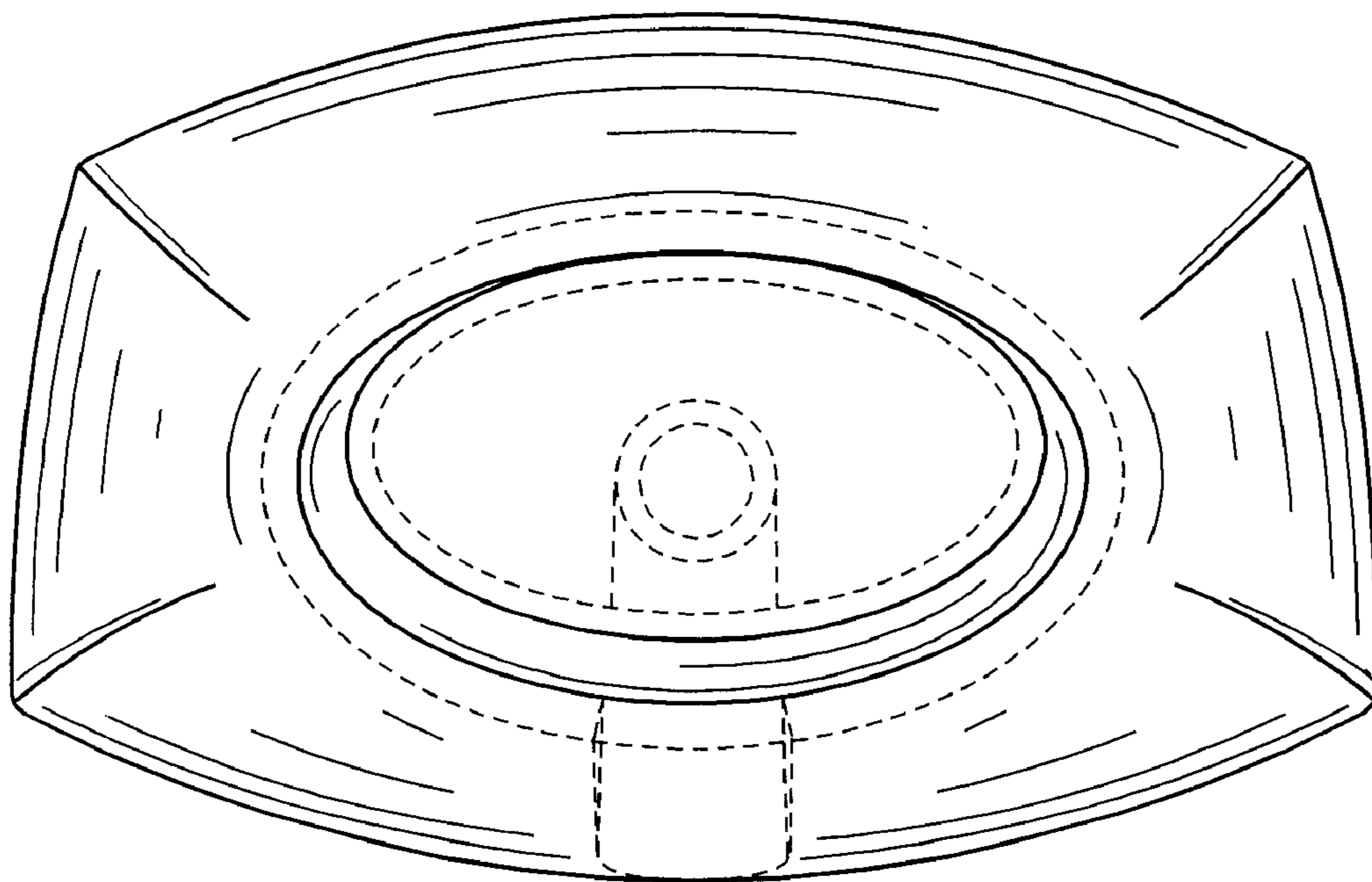

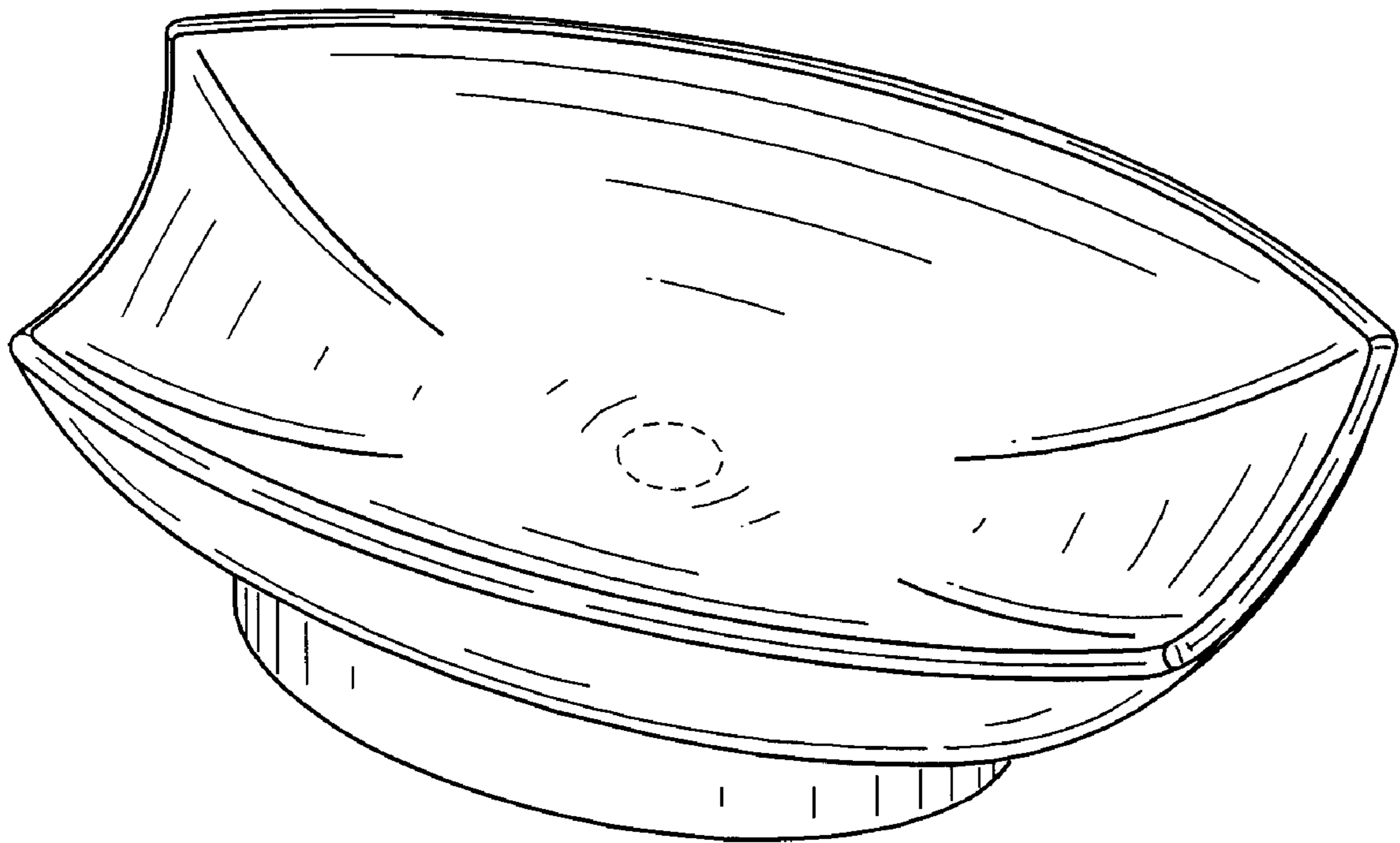

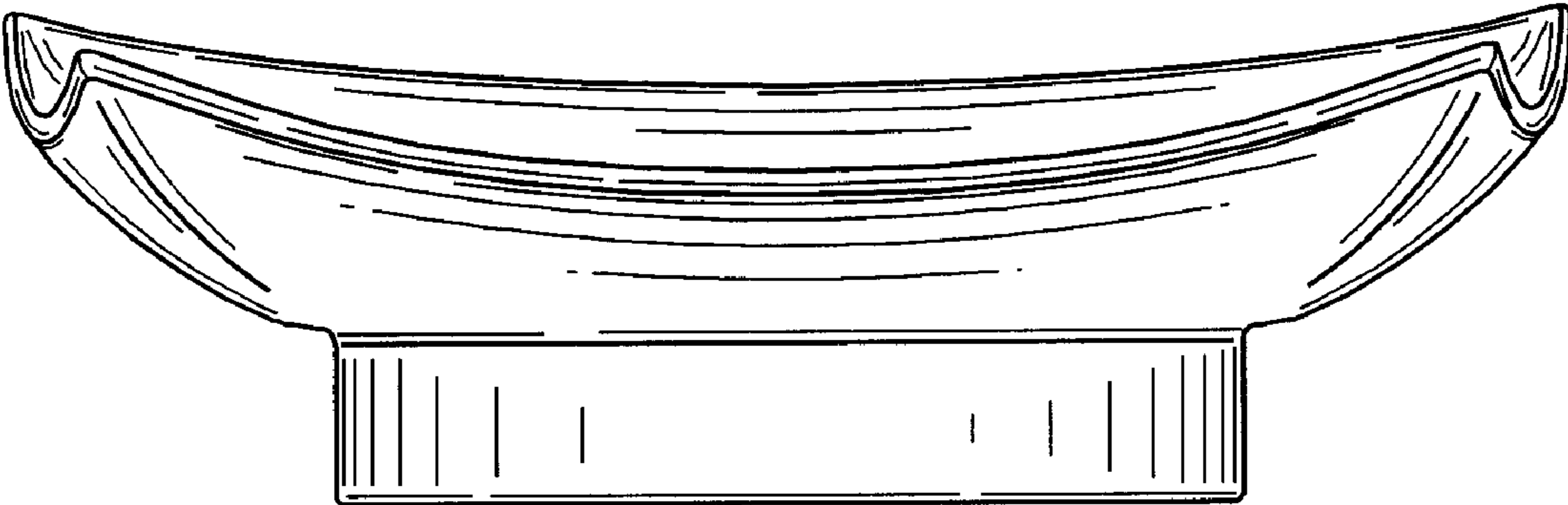

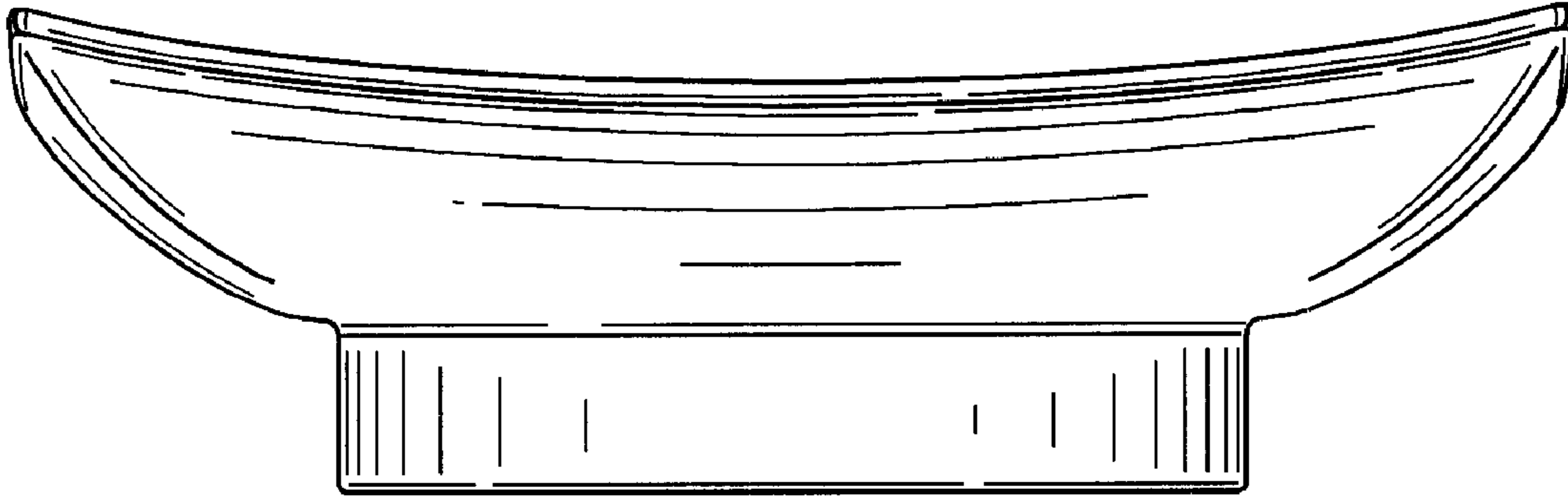

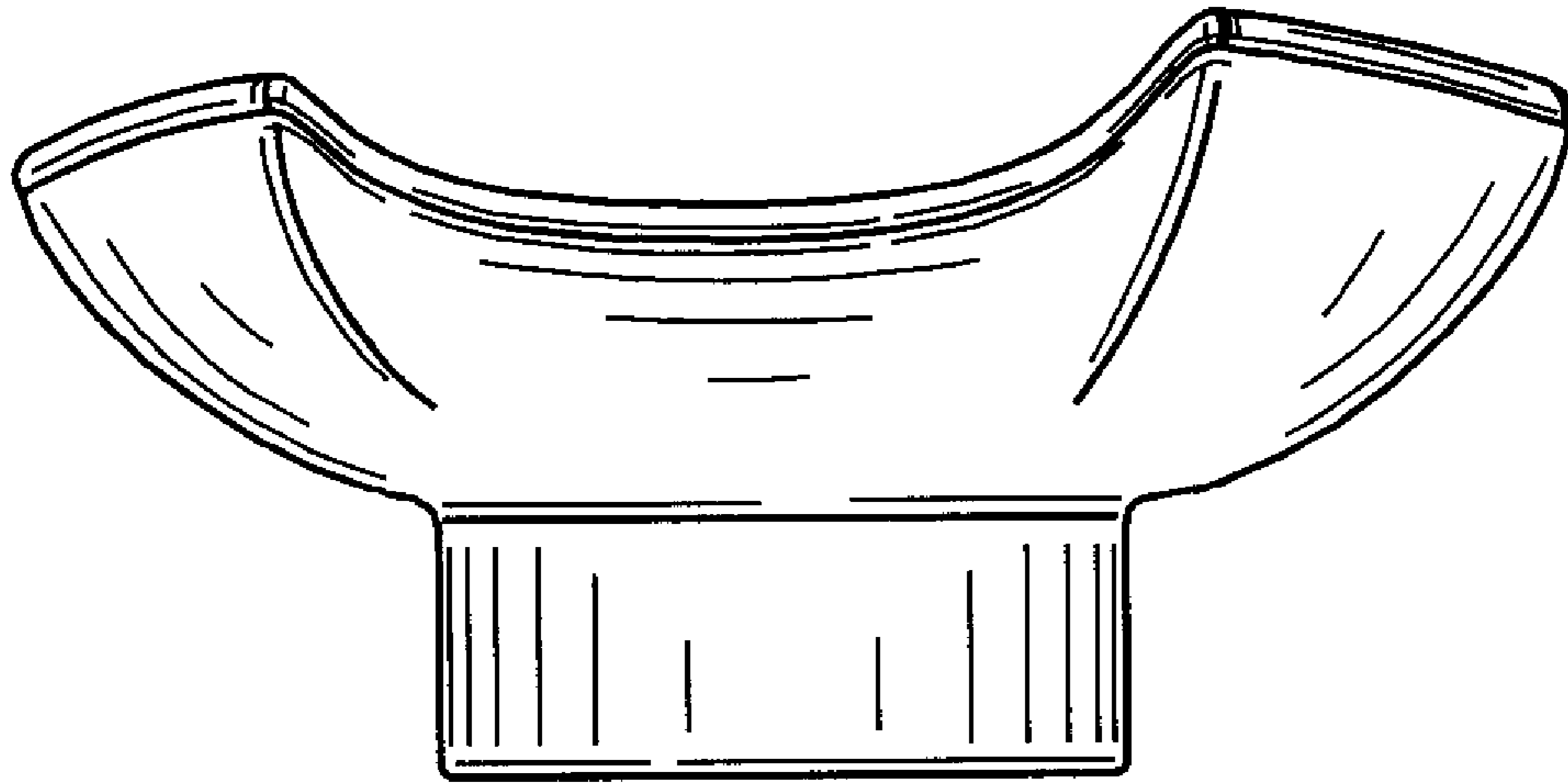

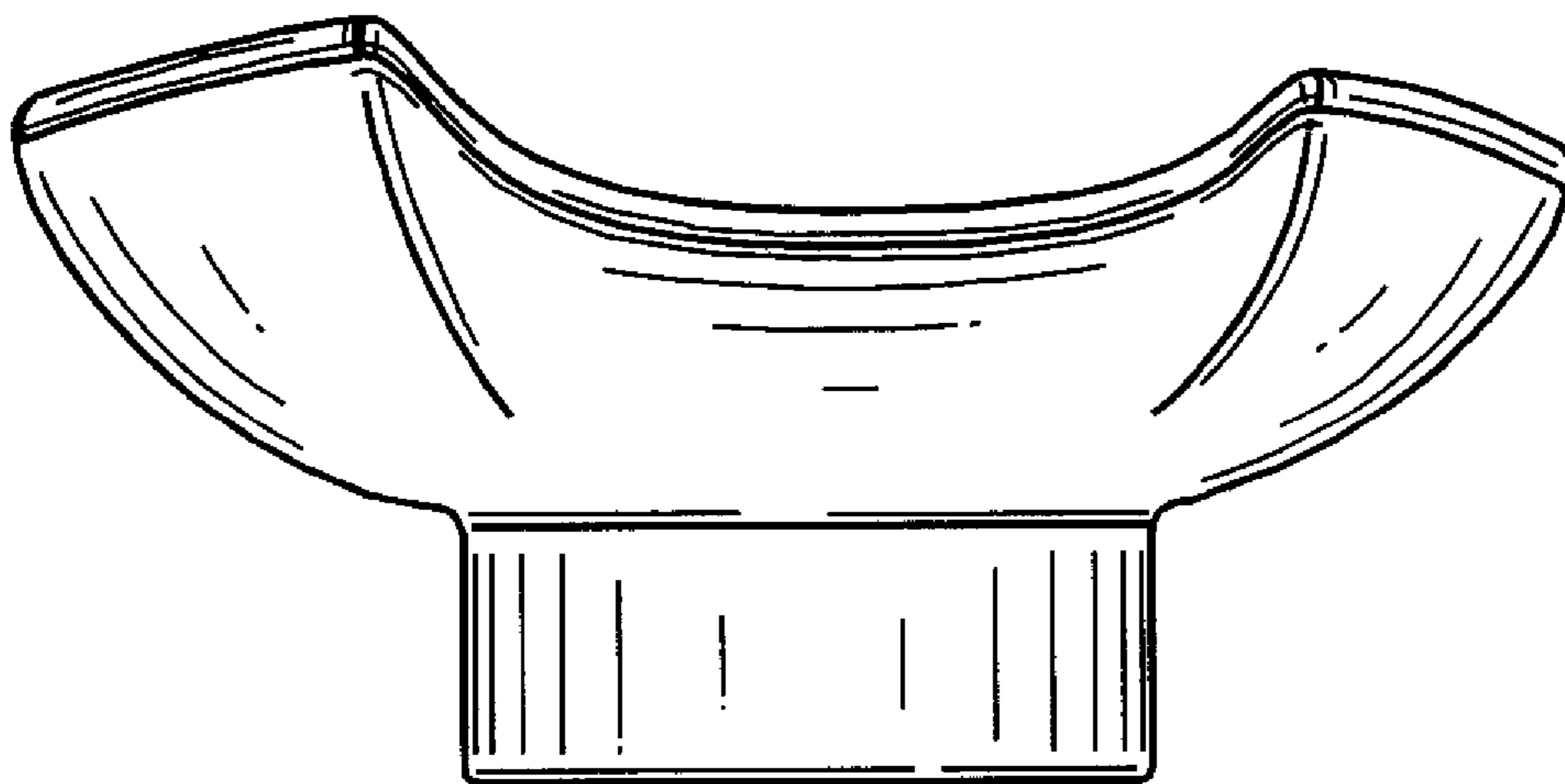

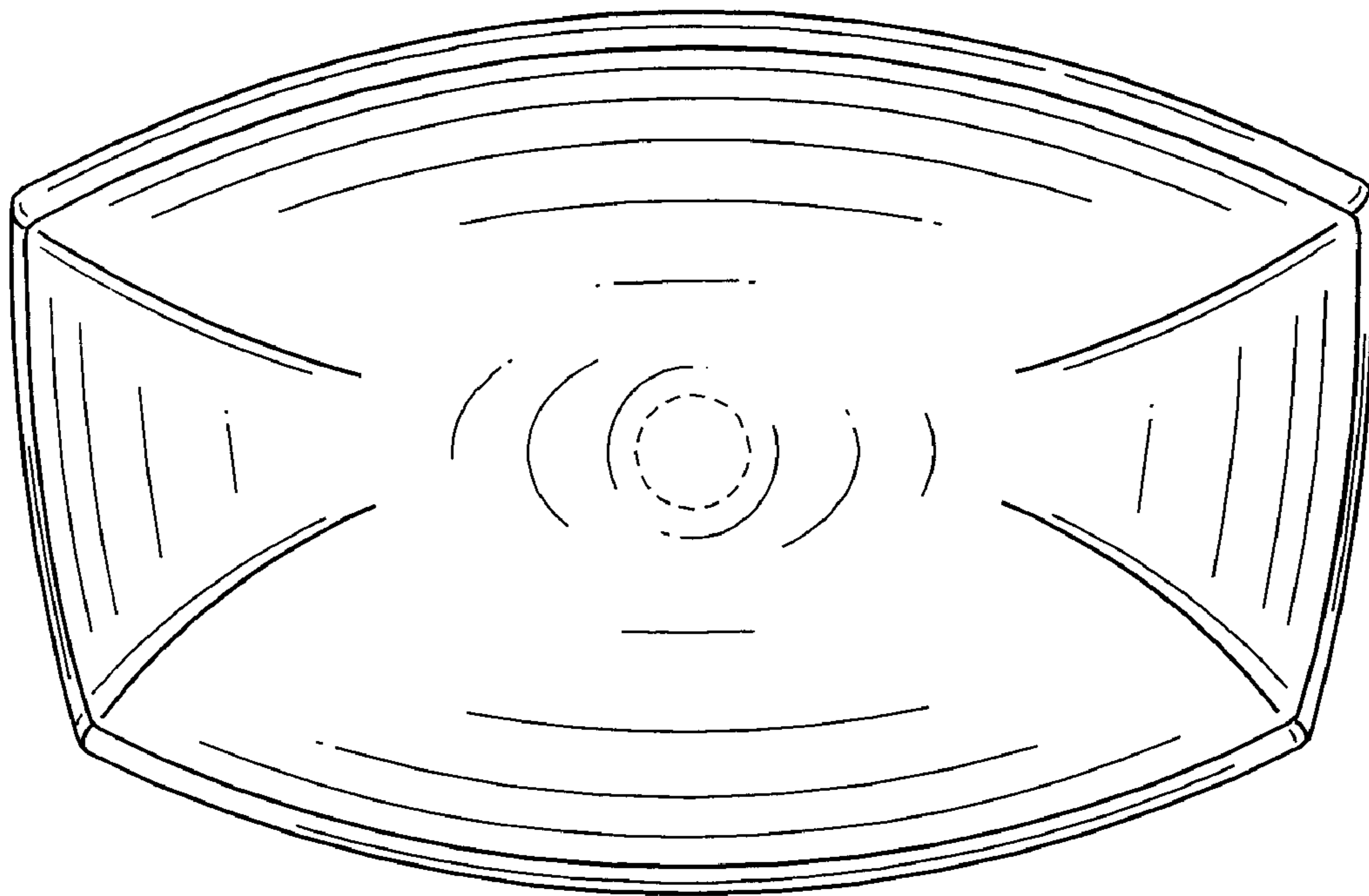

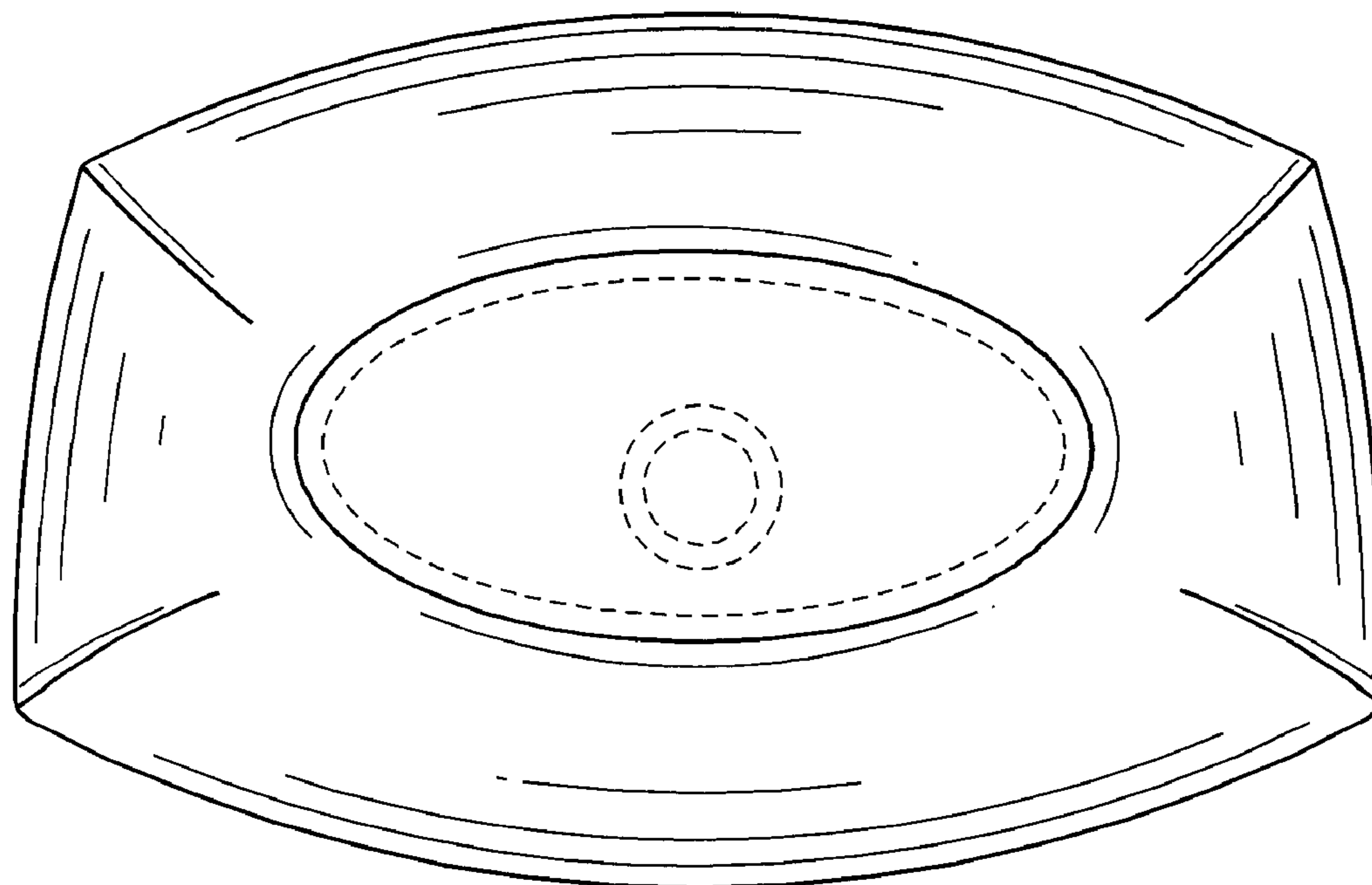
