(57) **CLAIM**

The ornamental design for a kitchen hood, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of a kitchen hood constructed
in accordance with an embodiment of the present invention;

FIG. 2 is a left side view of the kitchen hood shown in FIG.
1;

FIG. 3 is a front plan view of the kitchen hood shown in
FIGS. 1 and 2;

FIG. 4 is a bottom view of the kitchen hood shown in FIGS.
1–3;

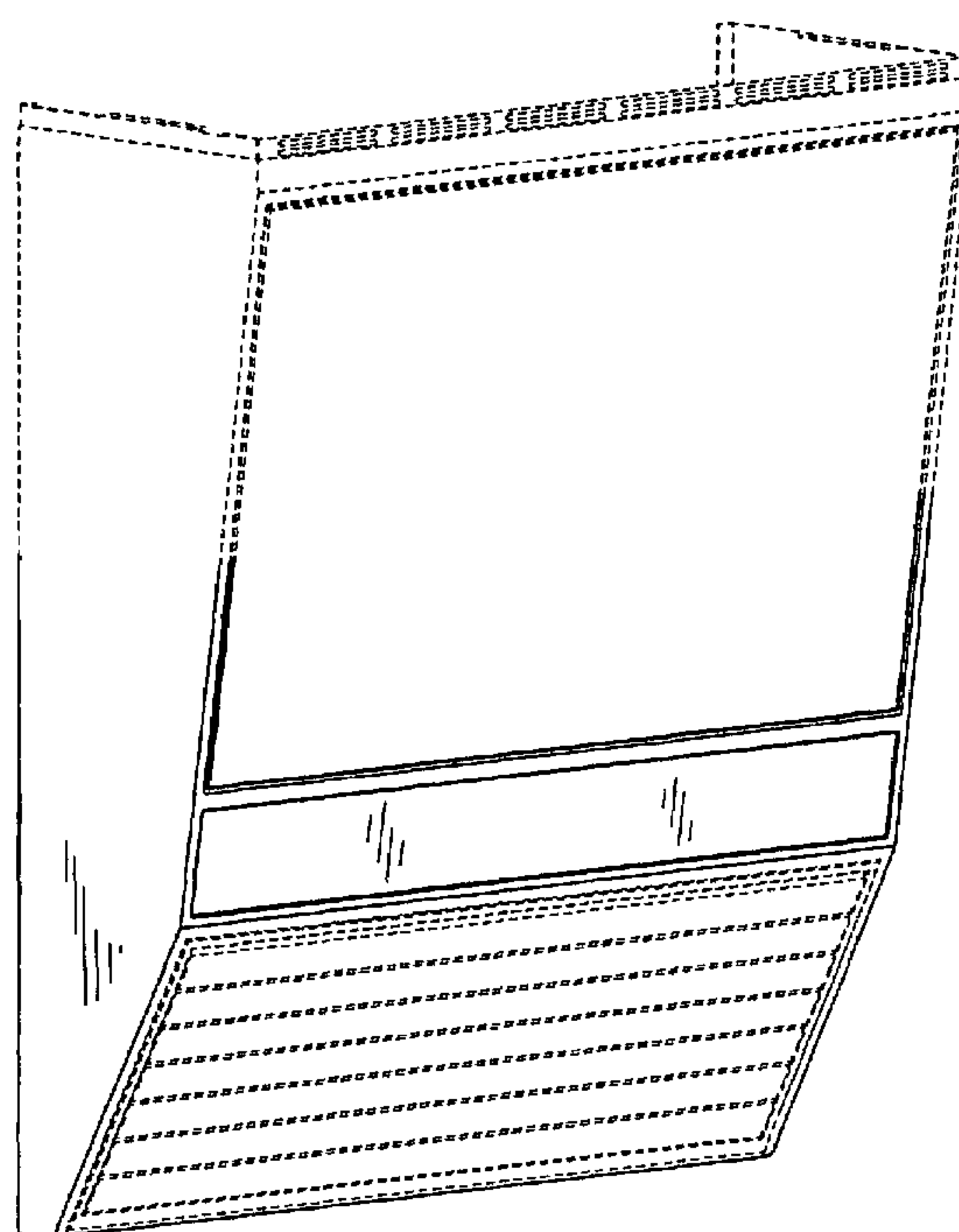
FIG. 5 is a bottom view of the kitchen hood shown in FIGS.
1–4;

FIG. 6 is a right side view of the kitchen hood shown in
FIGS. 1–5; and,

FIG. 7 is a perspective view with the lower assembly open

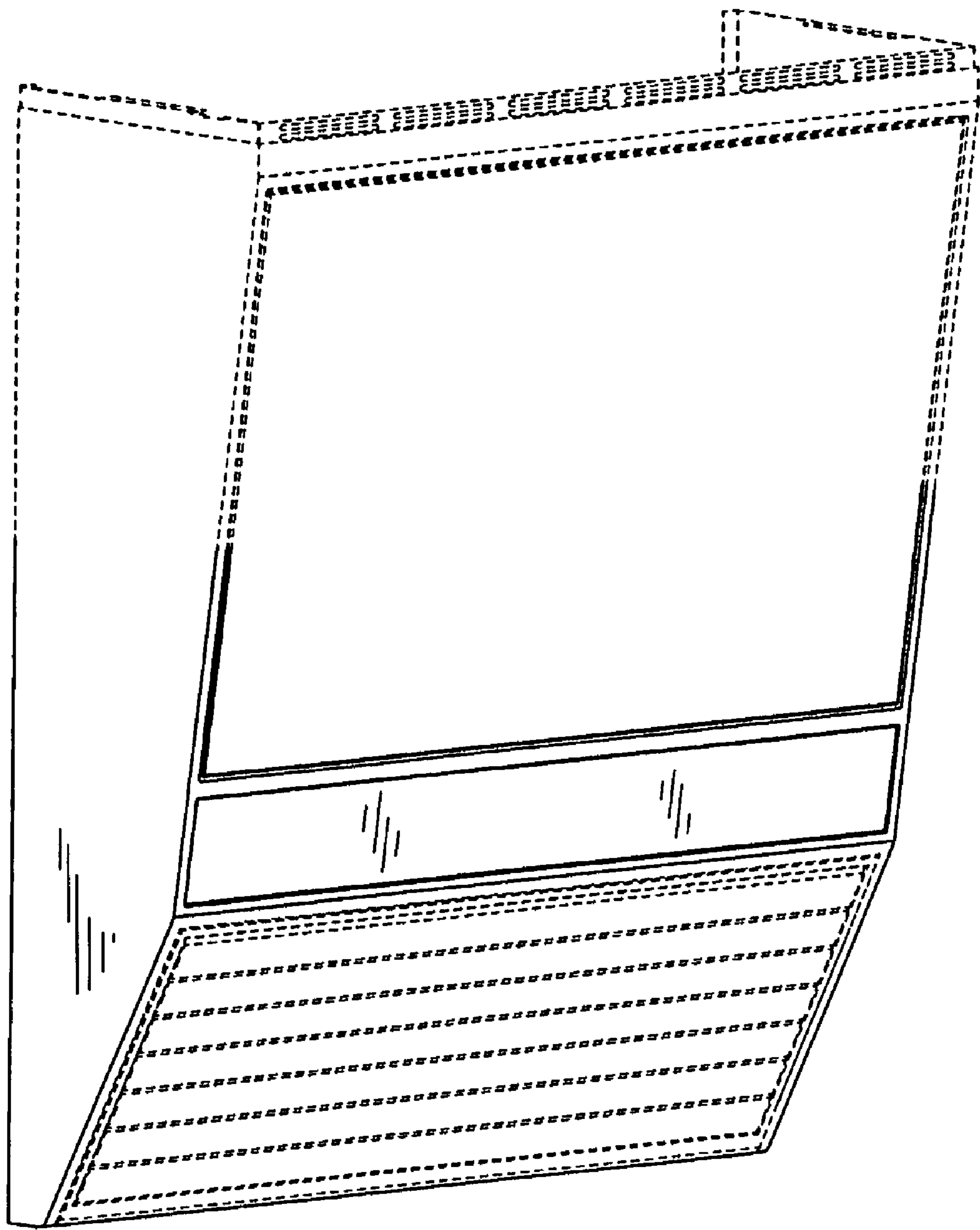

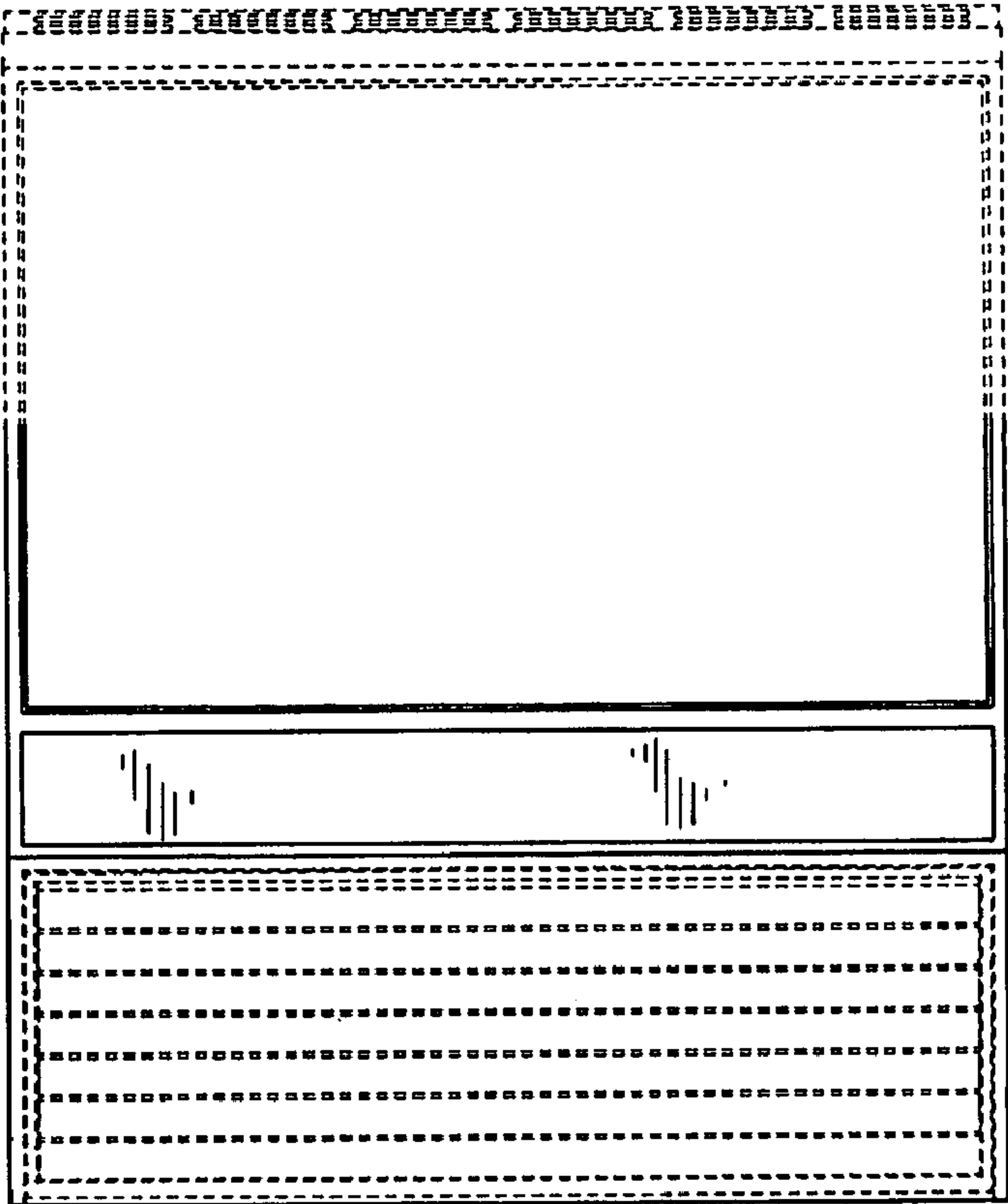

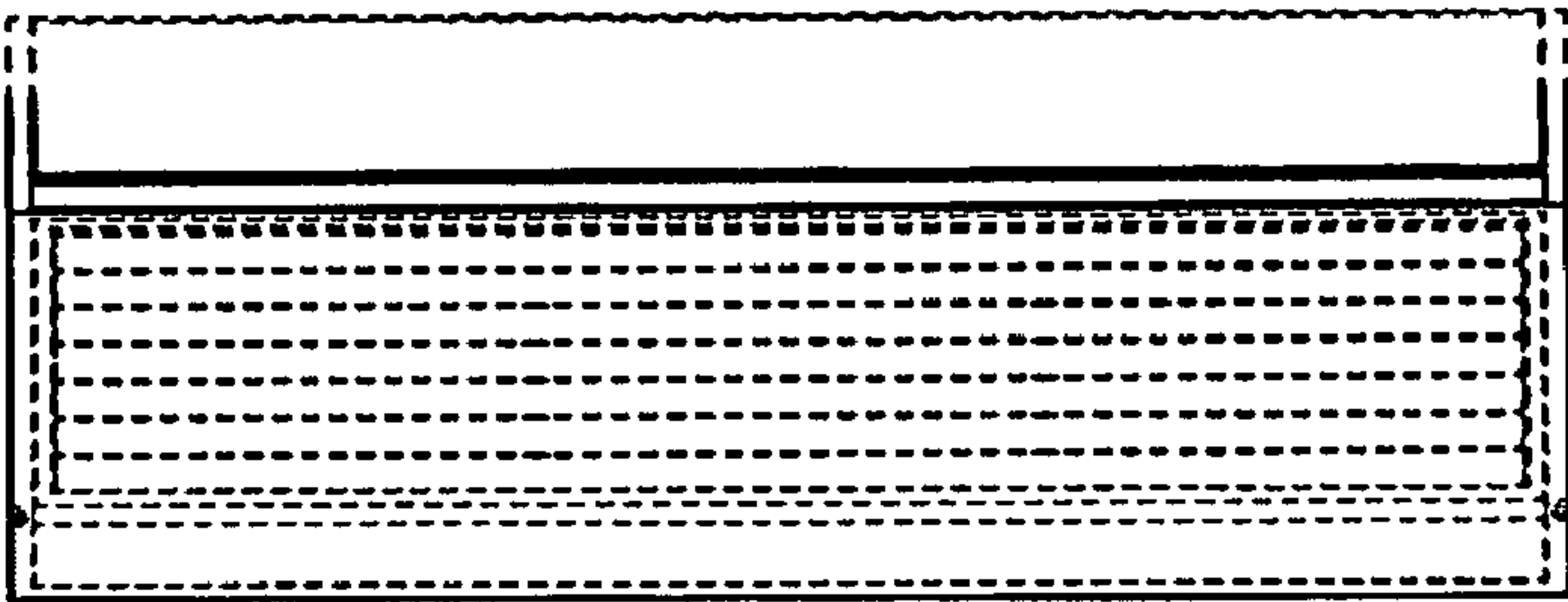

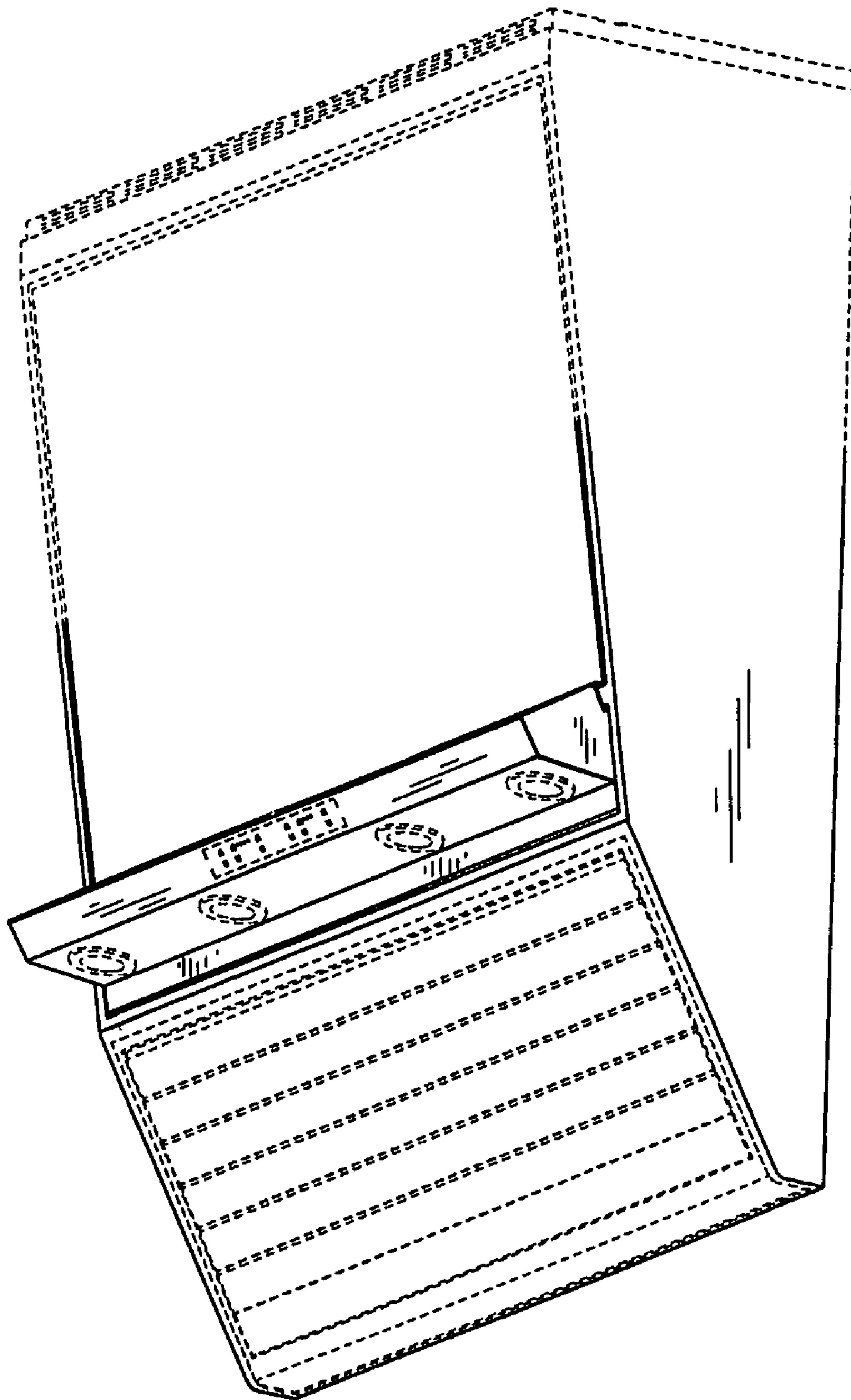

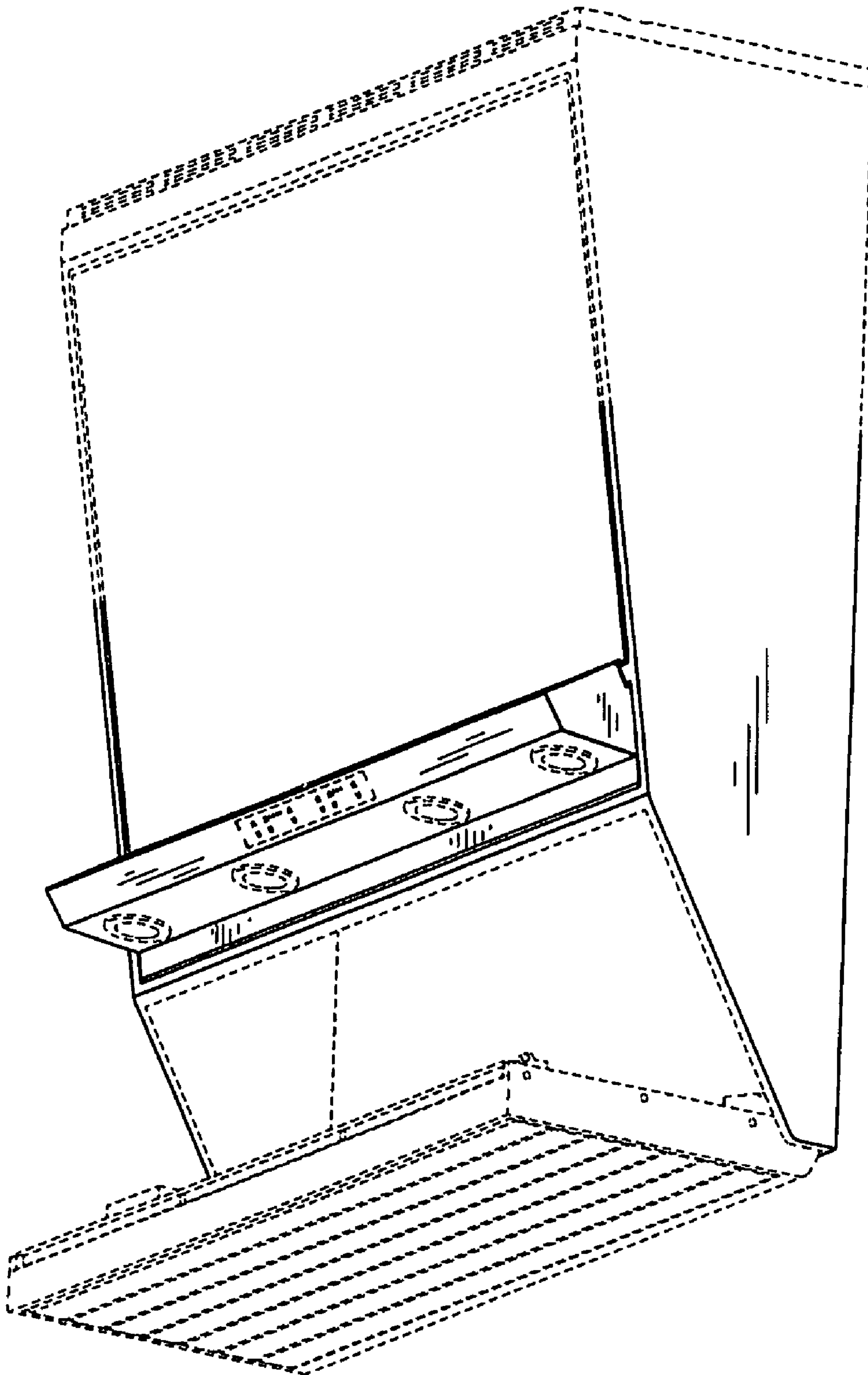
