The ornamental design for a lamp for a sewing machine, as shown and described.

**DESCRIPTION**

FIG. 5 is a right view thereof;

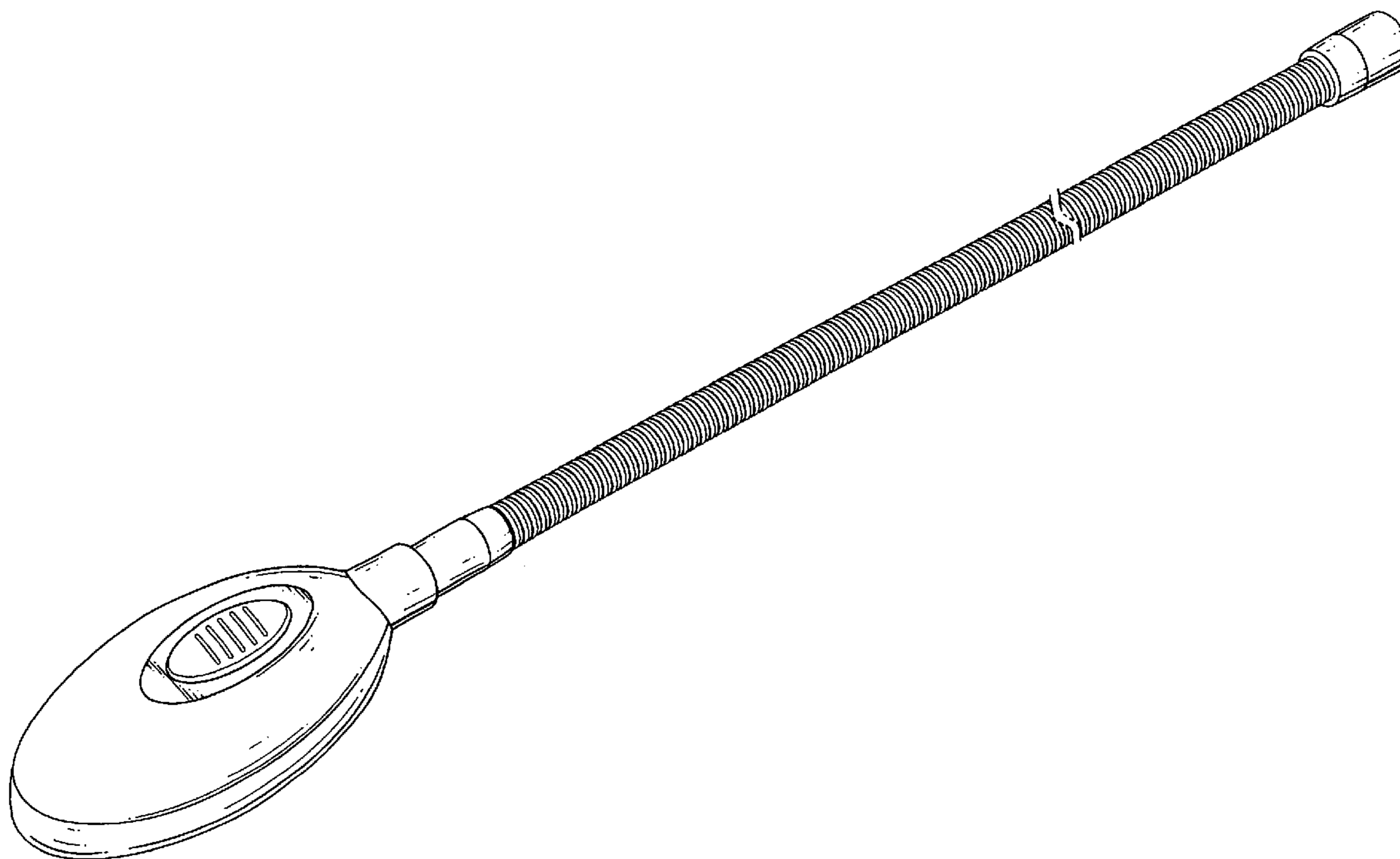
FIG. 6 is a top view thereof;

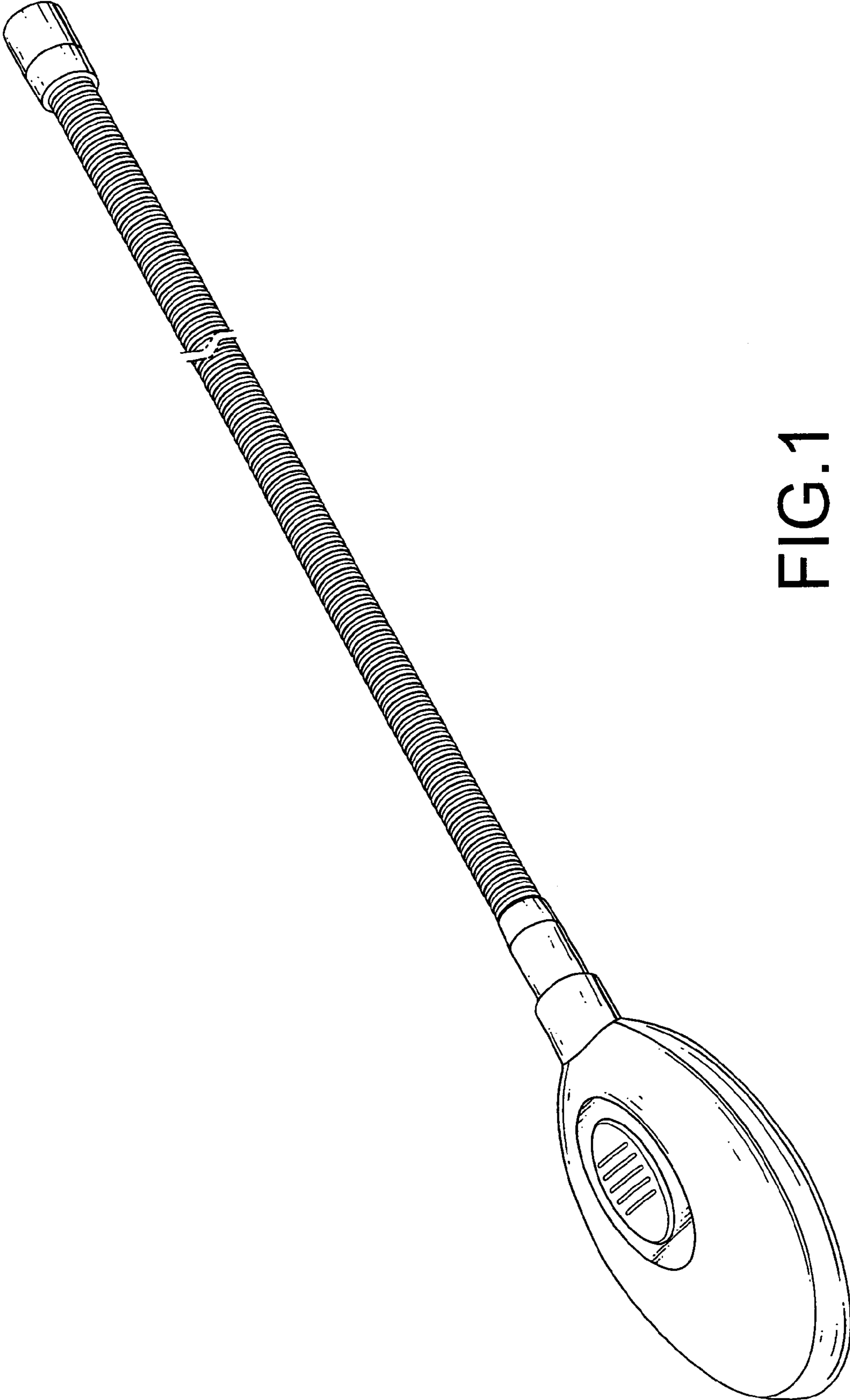

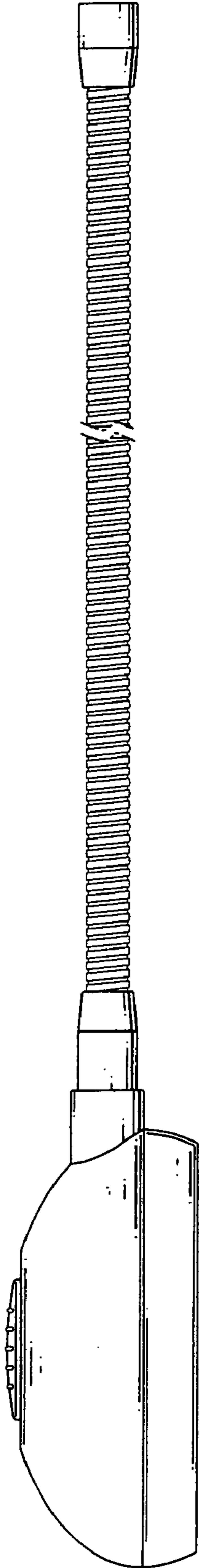

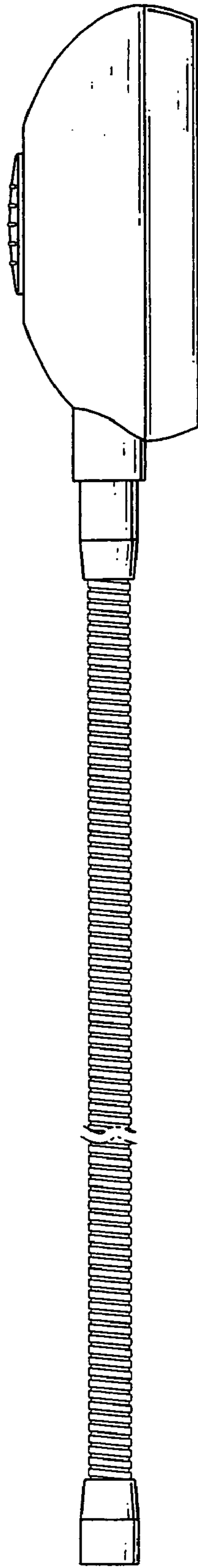

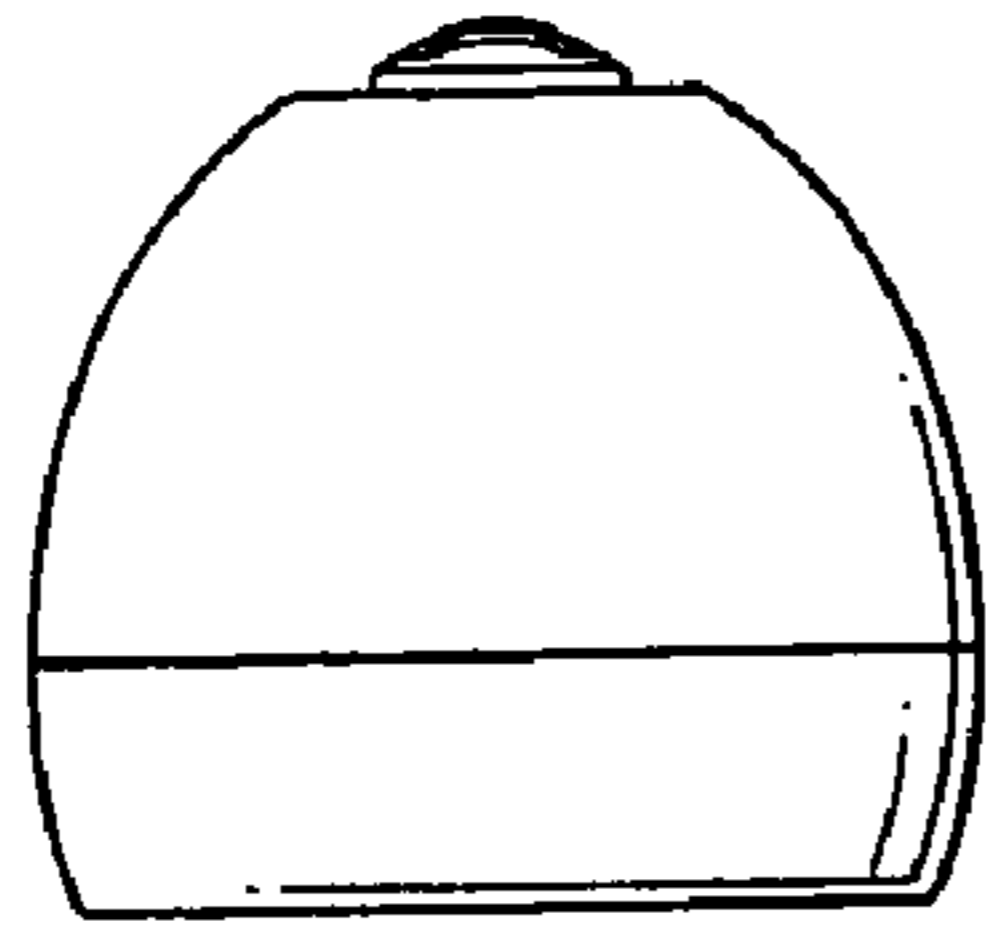

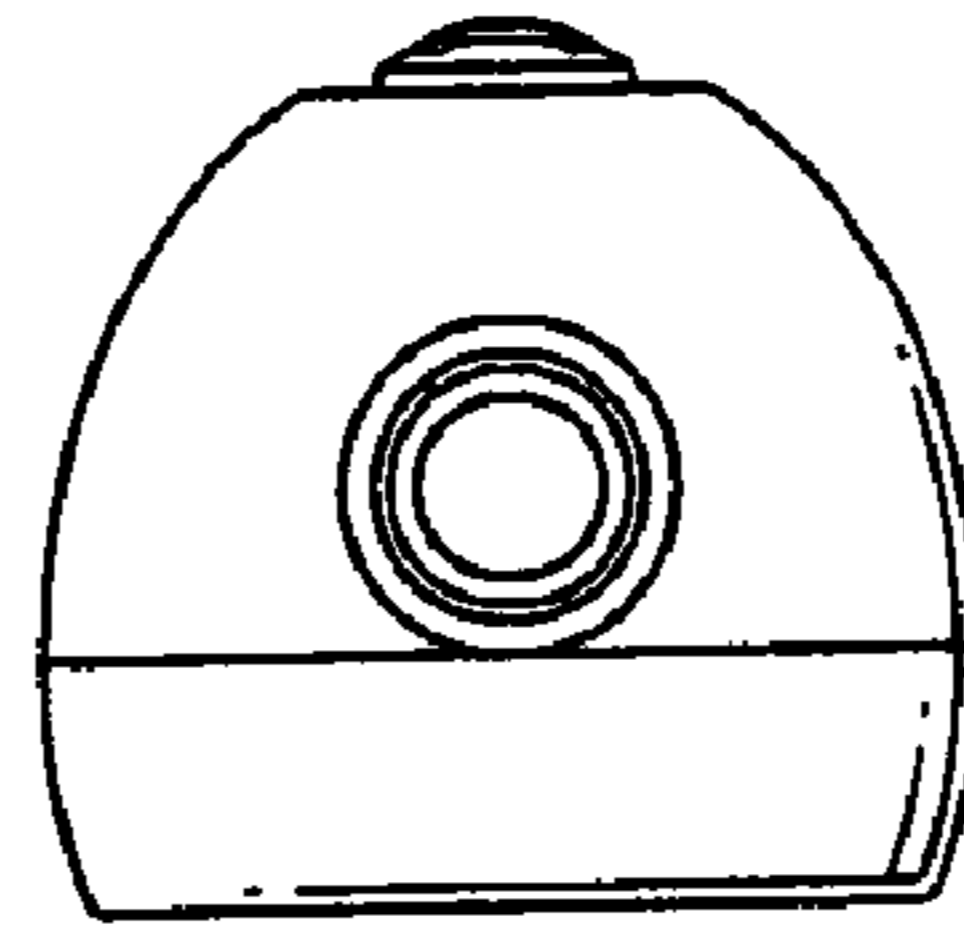

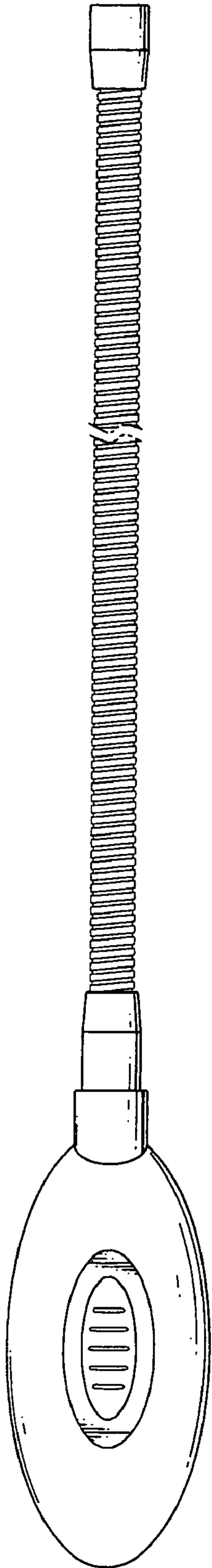

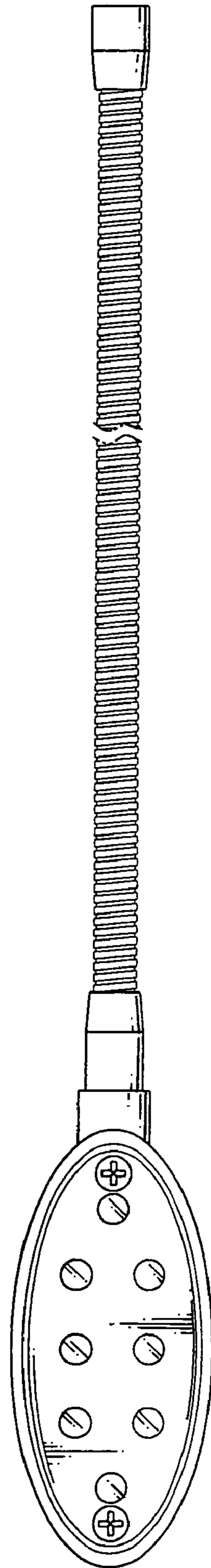

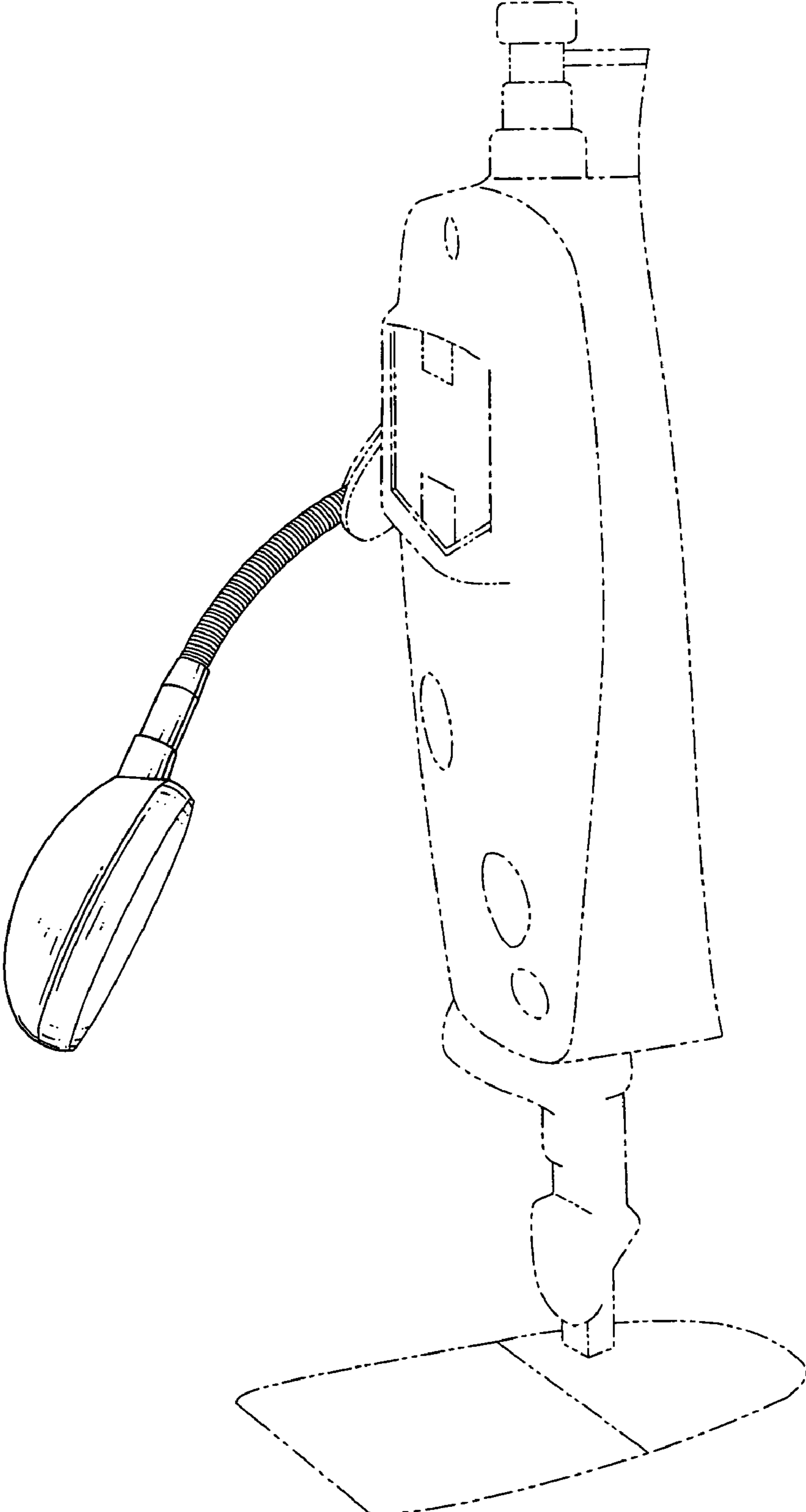
