DESCRIPTION

FIG. 1 is a perspective view of a lamp-type projector showing my new design;

FIG. 5 is a top plan view thereof;

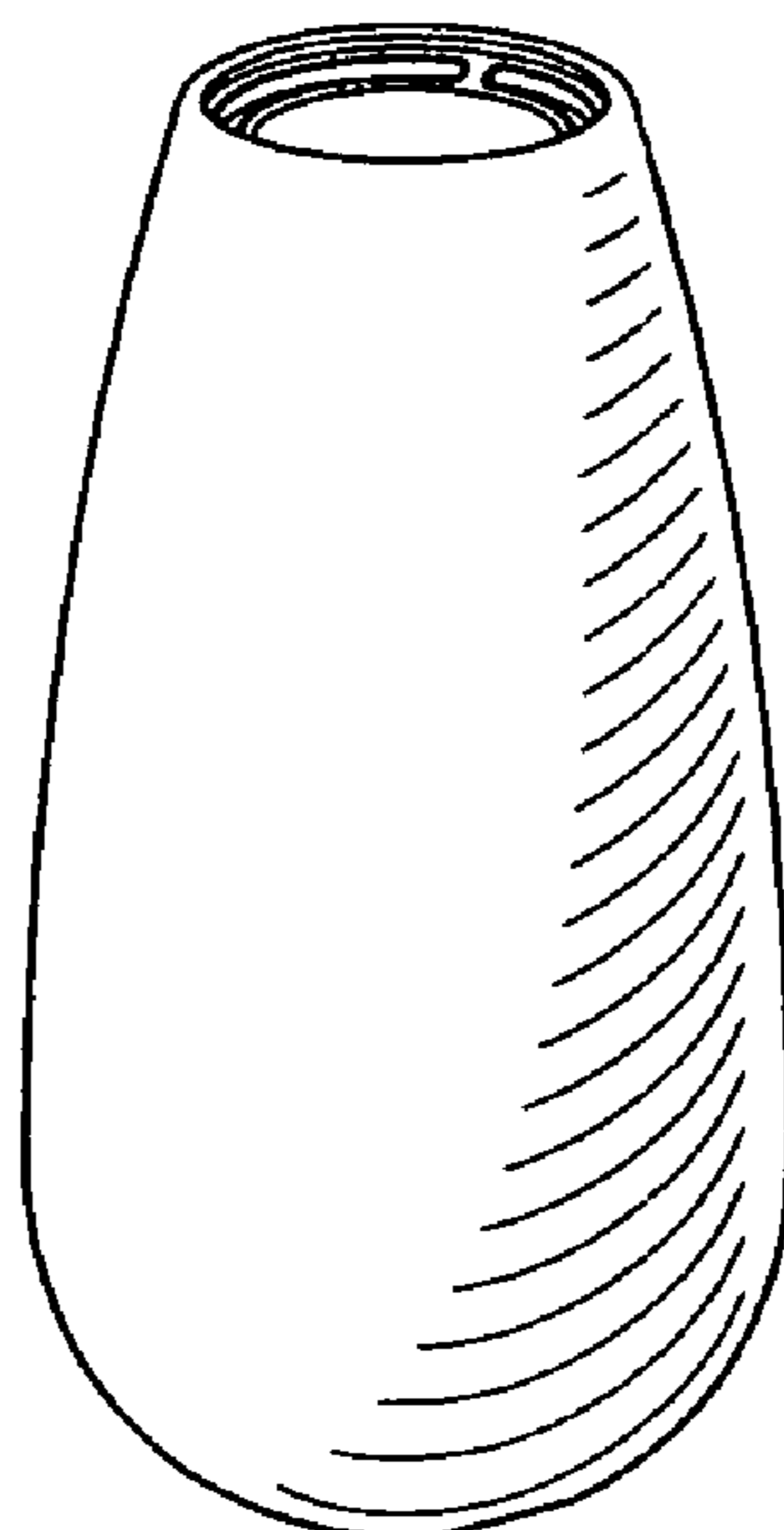
FIG. 6 is a bottom plan view thereof;

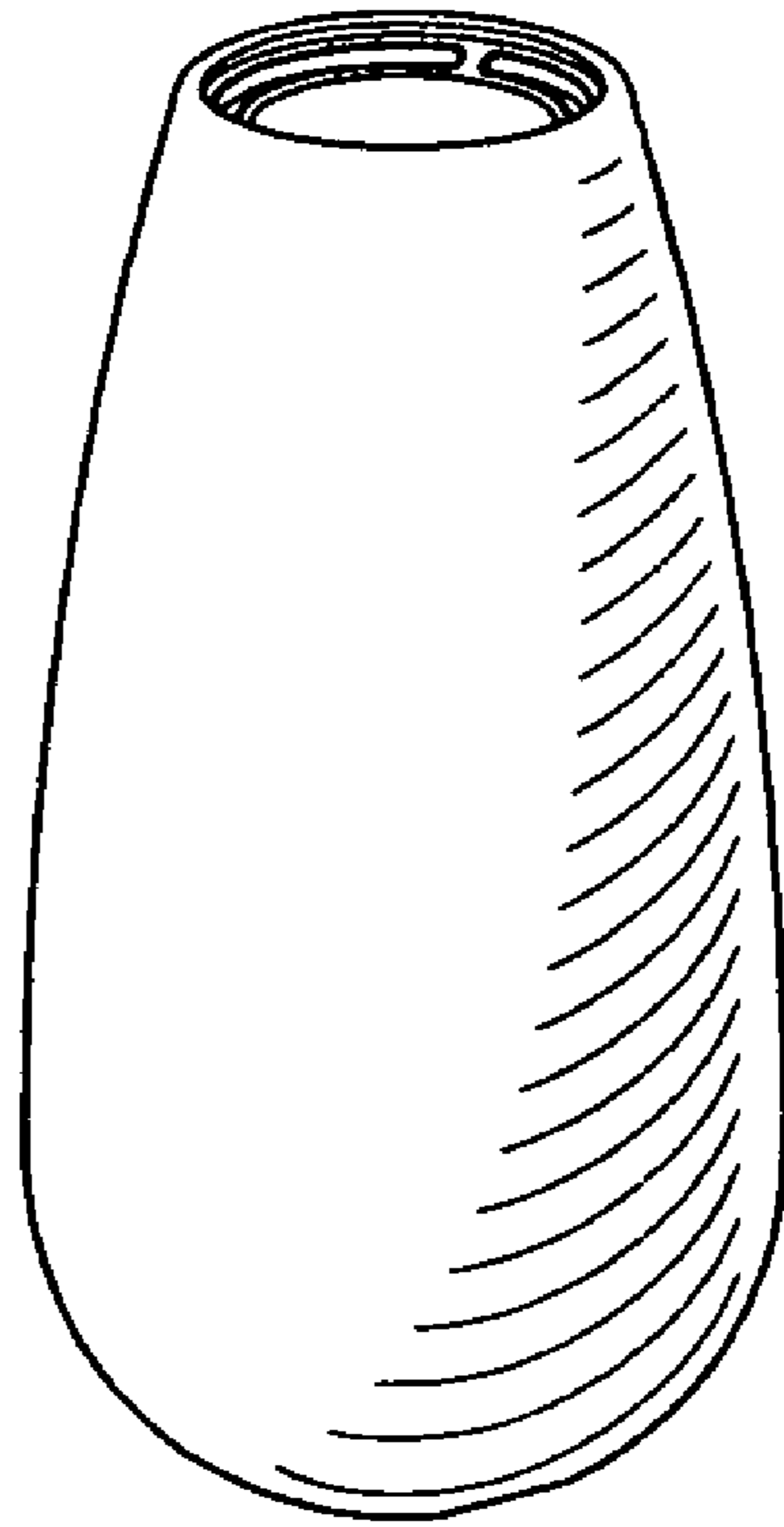

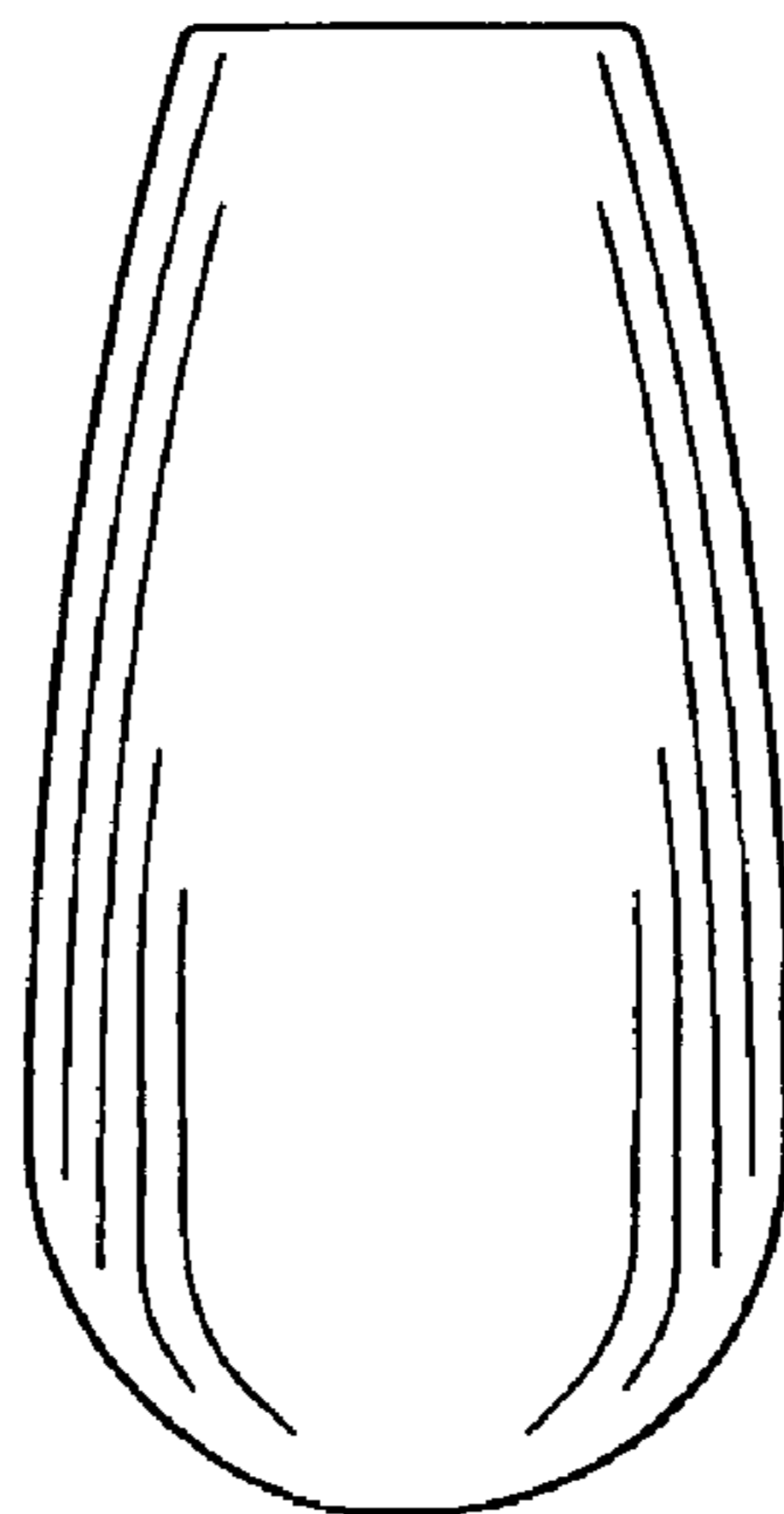

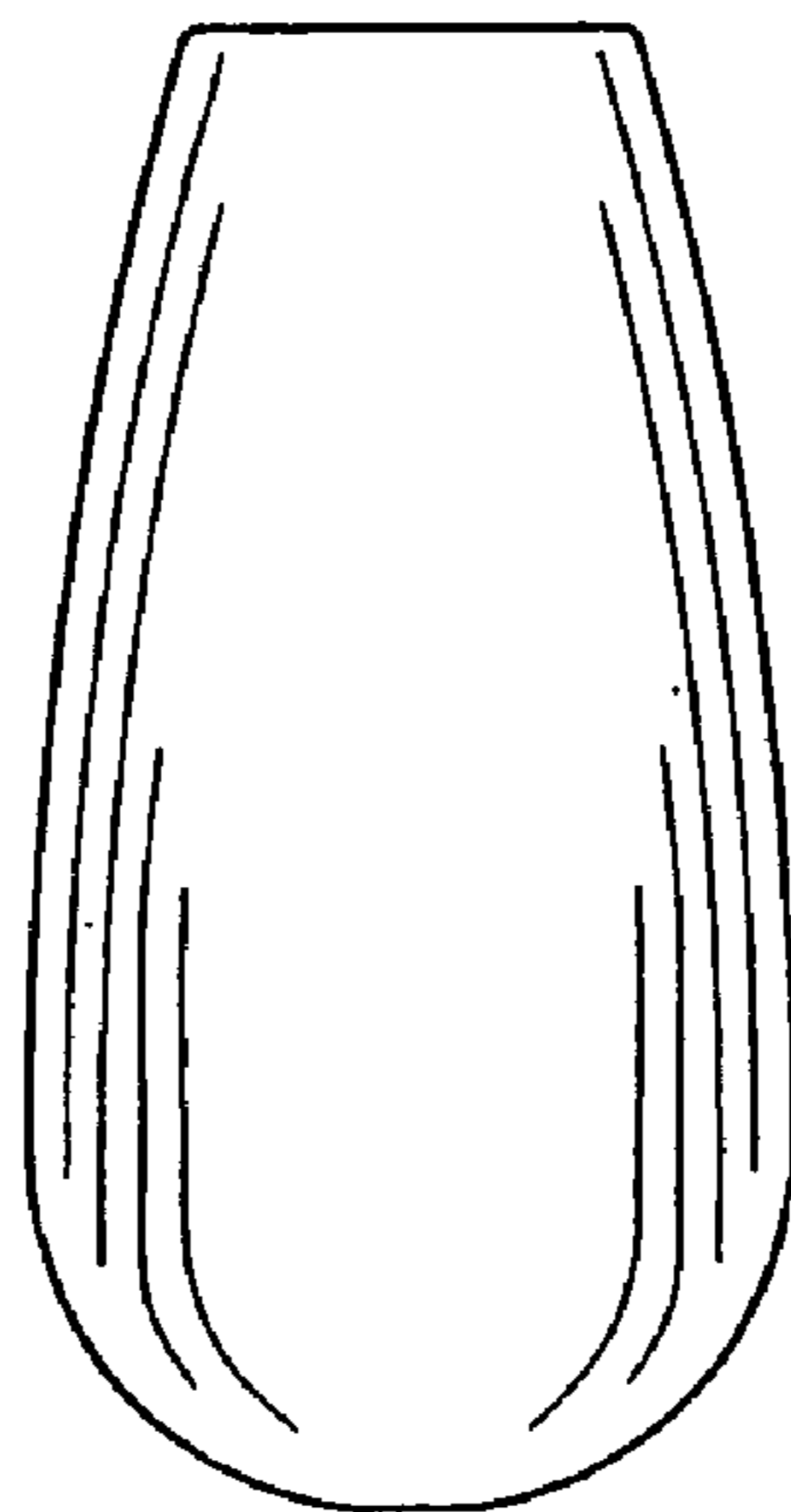

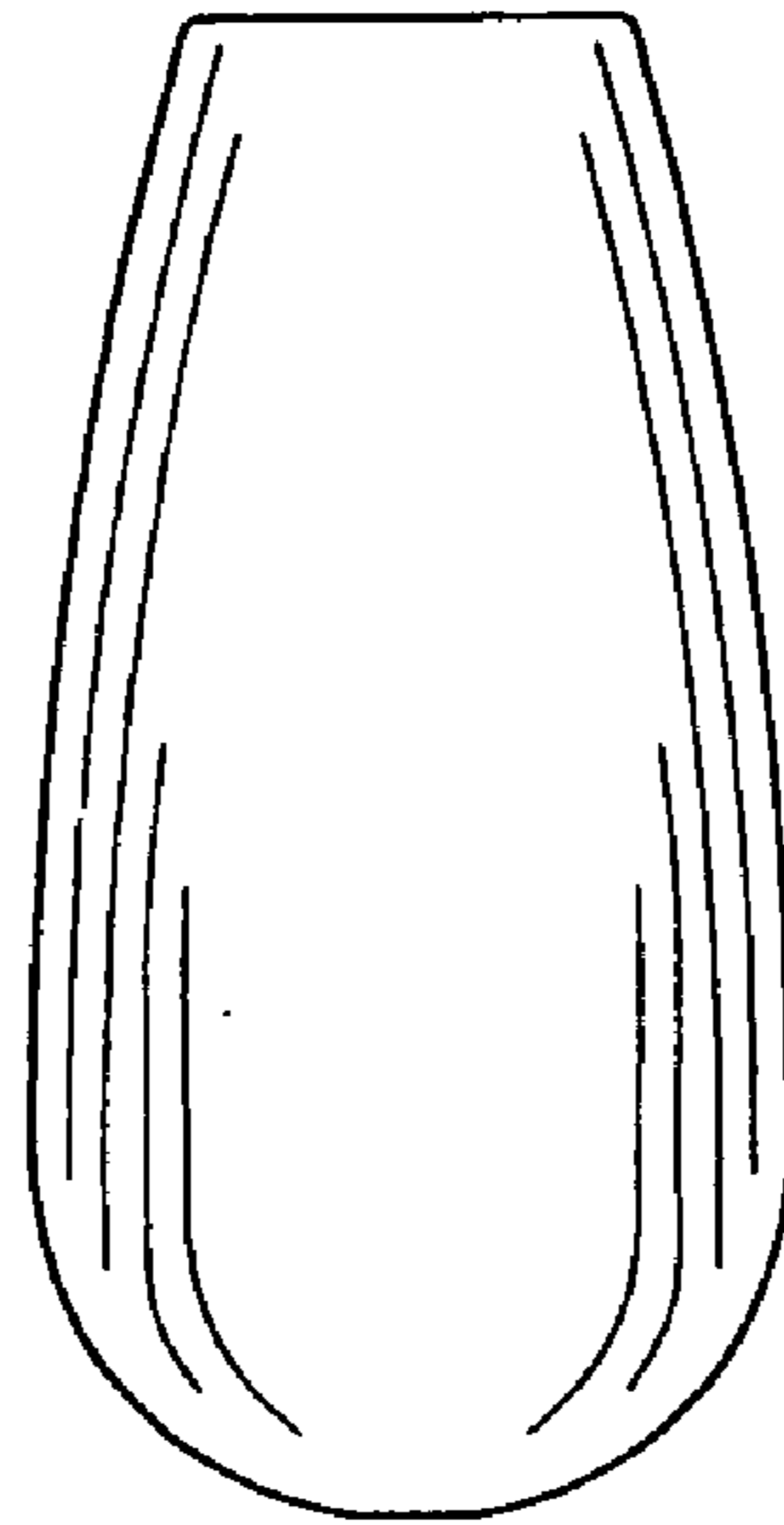

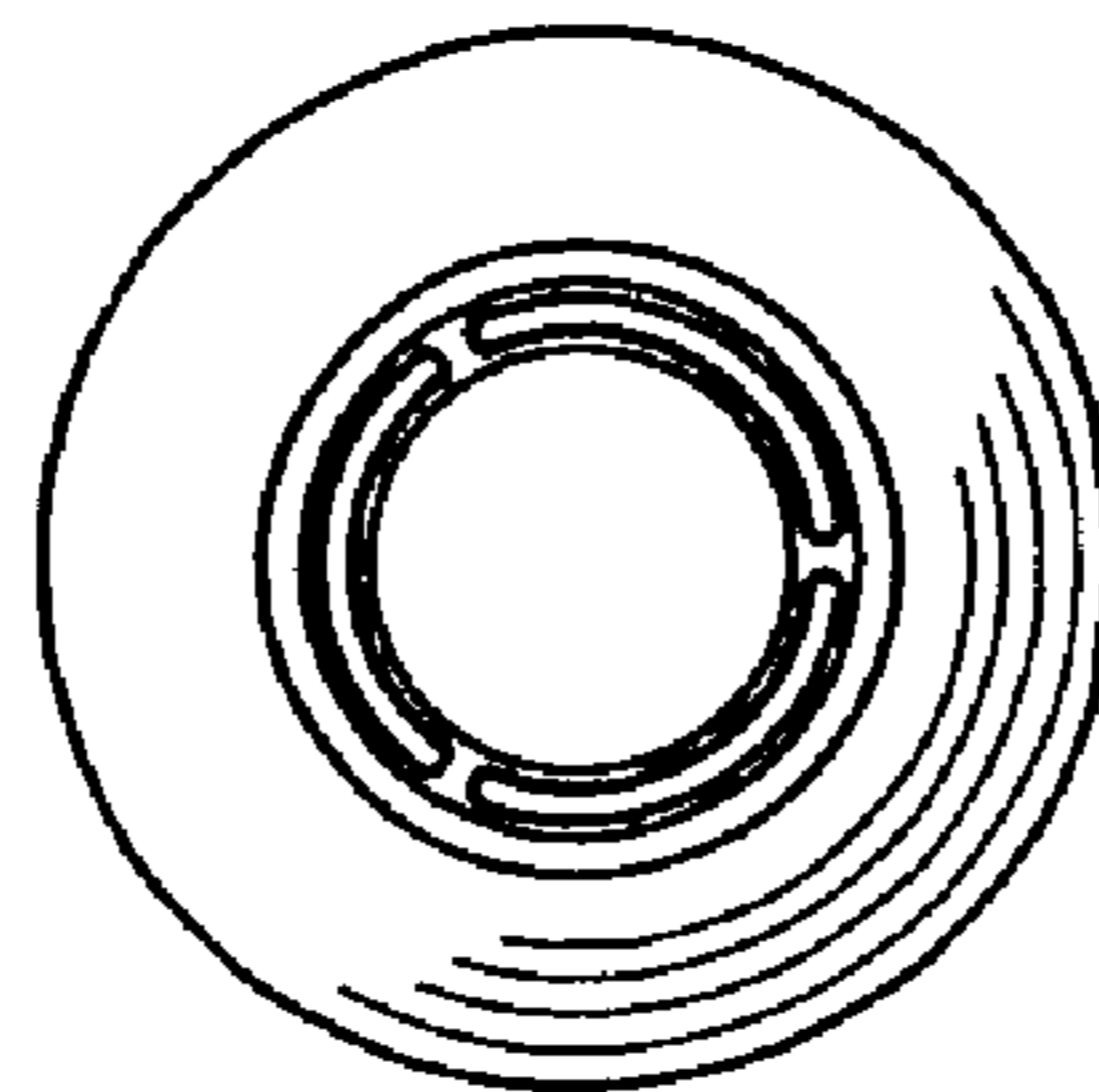

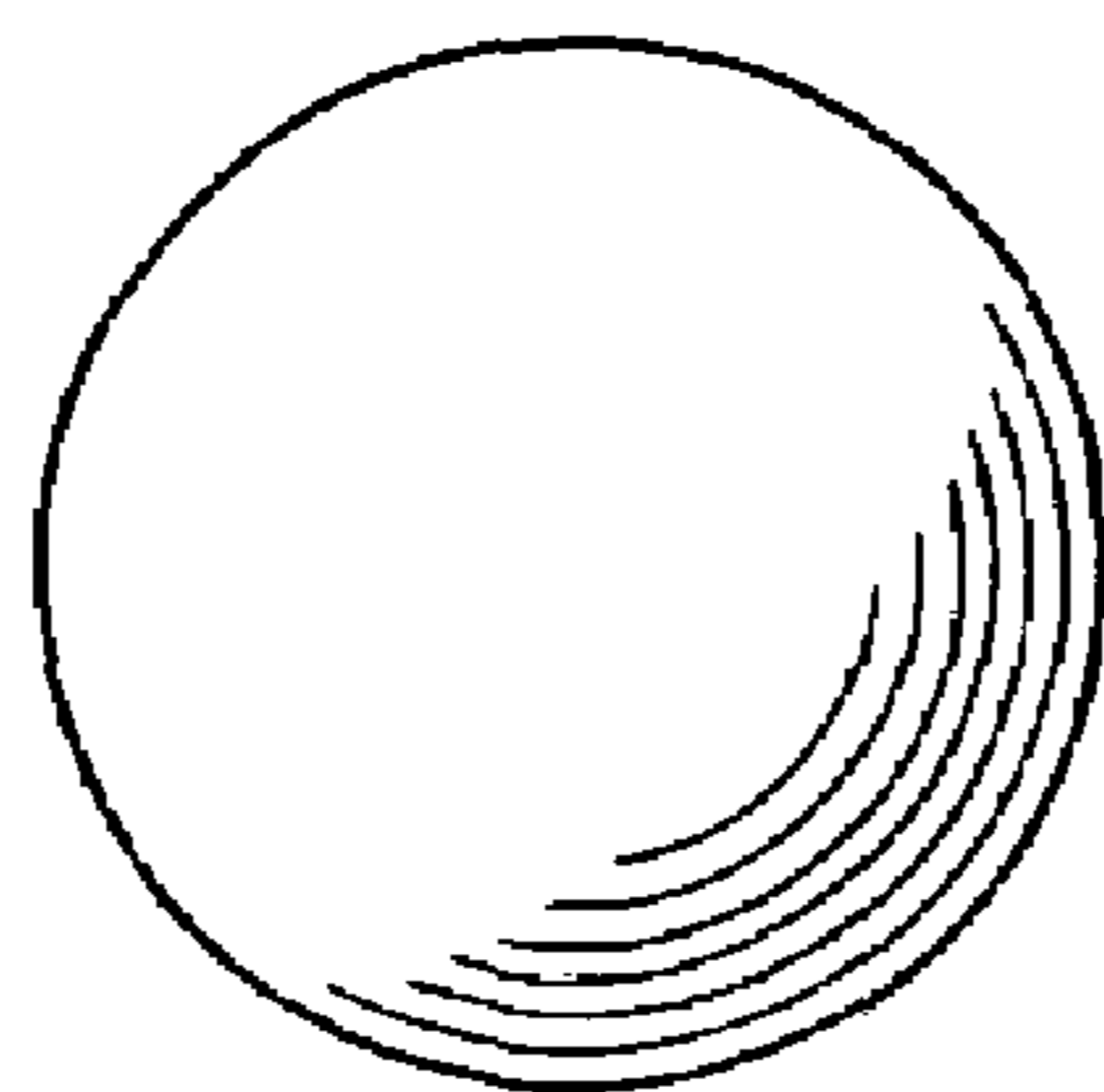

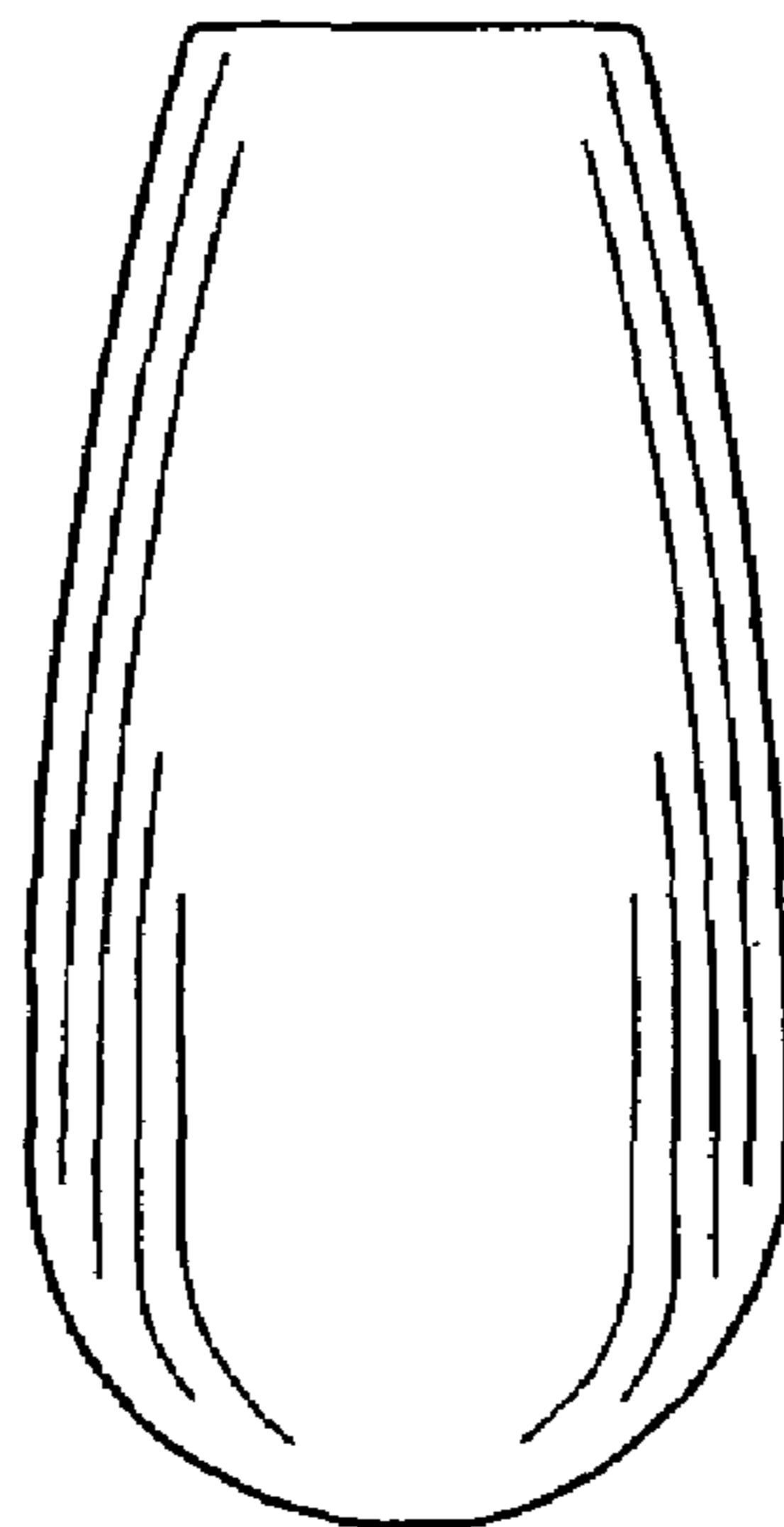

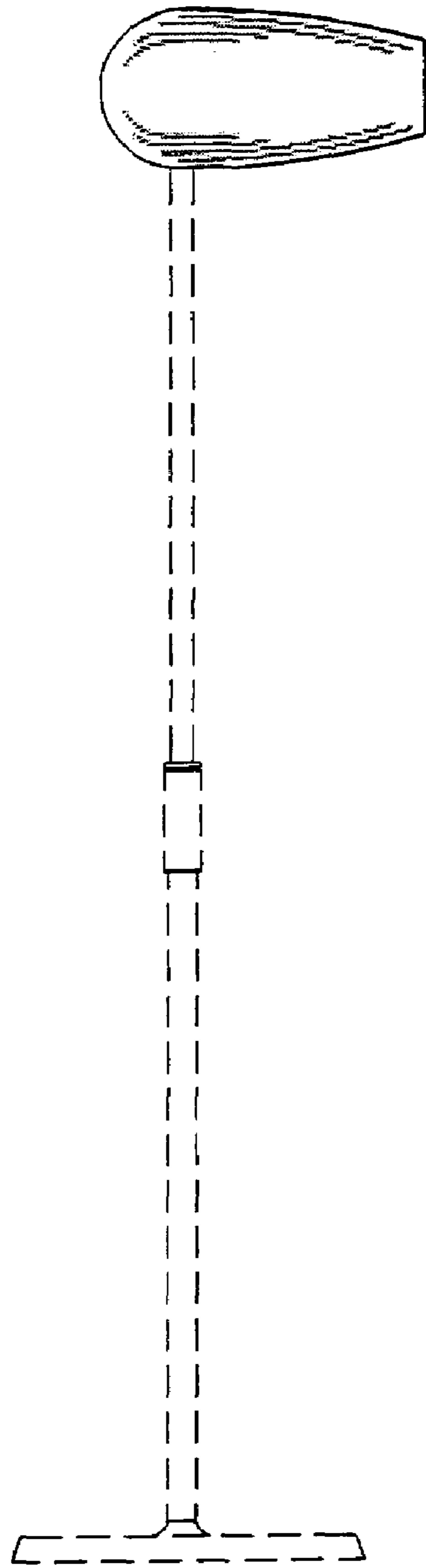
