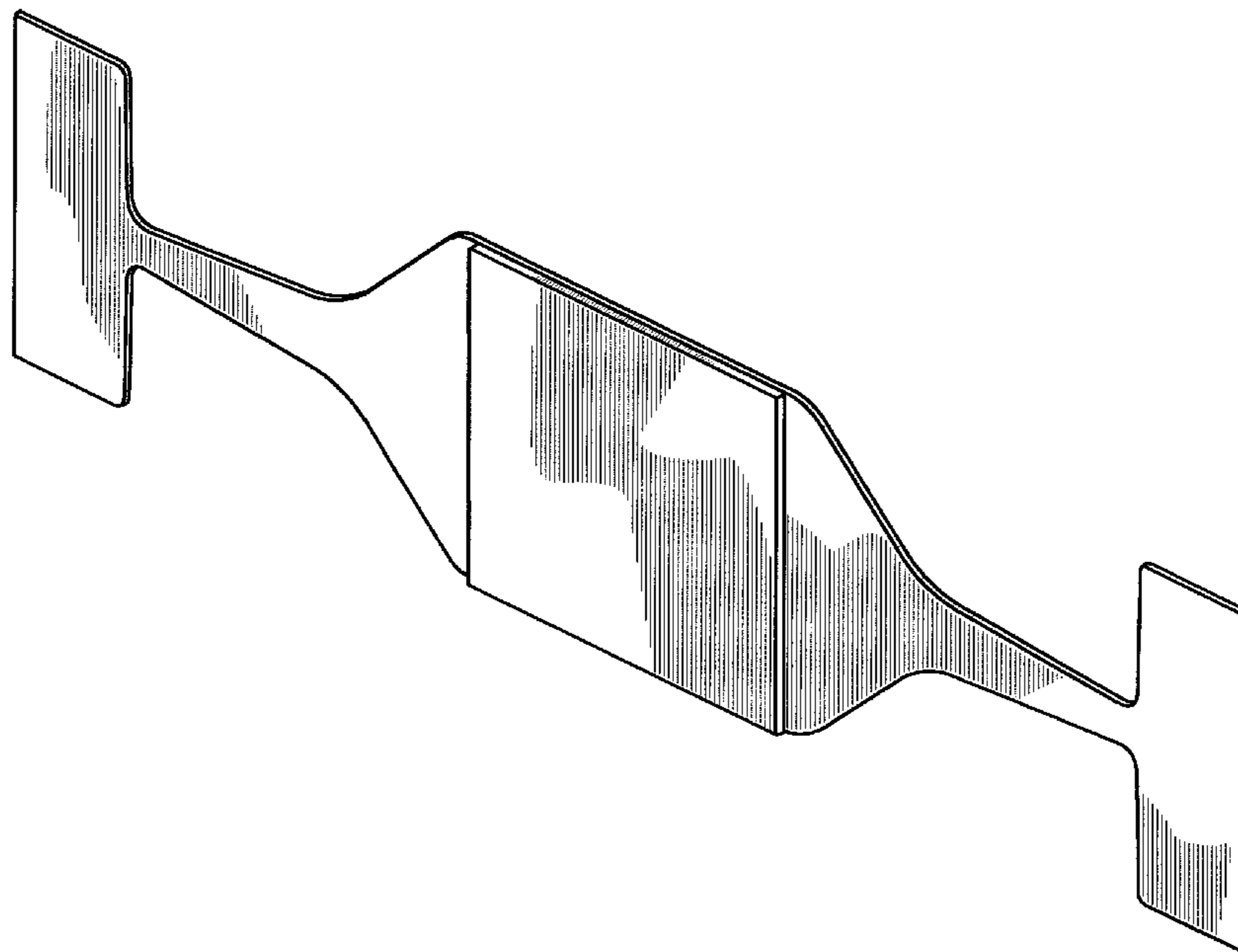
(57) **CLAIM**

DESCRIPTION

- FIG. 1 is a perspective view of a personnel marker according to the new design.
- FIG. 2 is a top view of the personnel marker illustrated in FIG. 1.
- FIG. 3 is a bottom view of the personnel marker illustrated in FIG. 1.
- FIG. 4 is a left side view of the personnel marker illustrated in FIG. 1.
- FIG. 5 is a right side view of the personnel marker illustrated in FIG. 1.
- FIG. 6 is a front view of the personnel marker illustrated in FIG. 1; and,

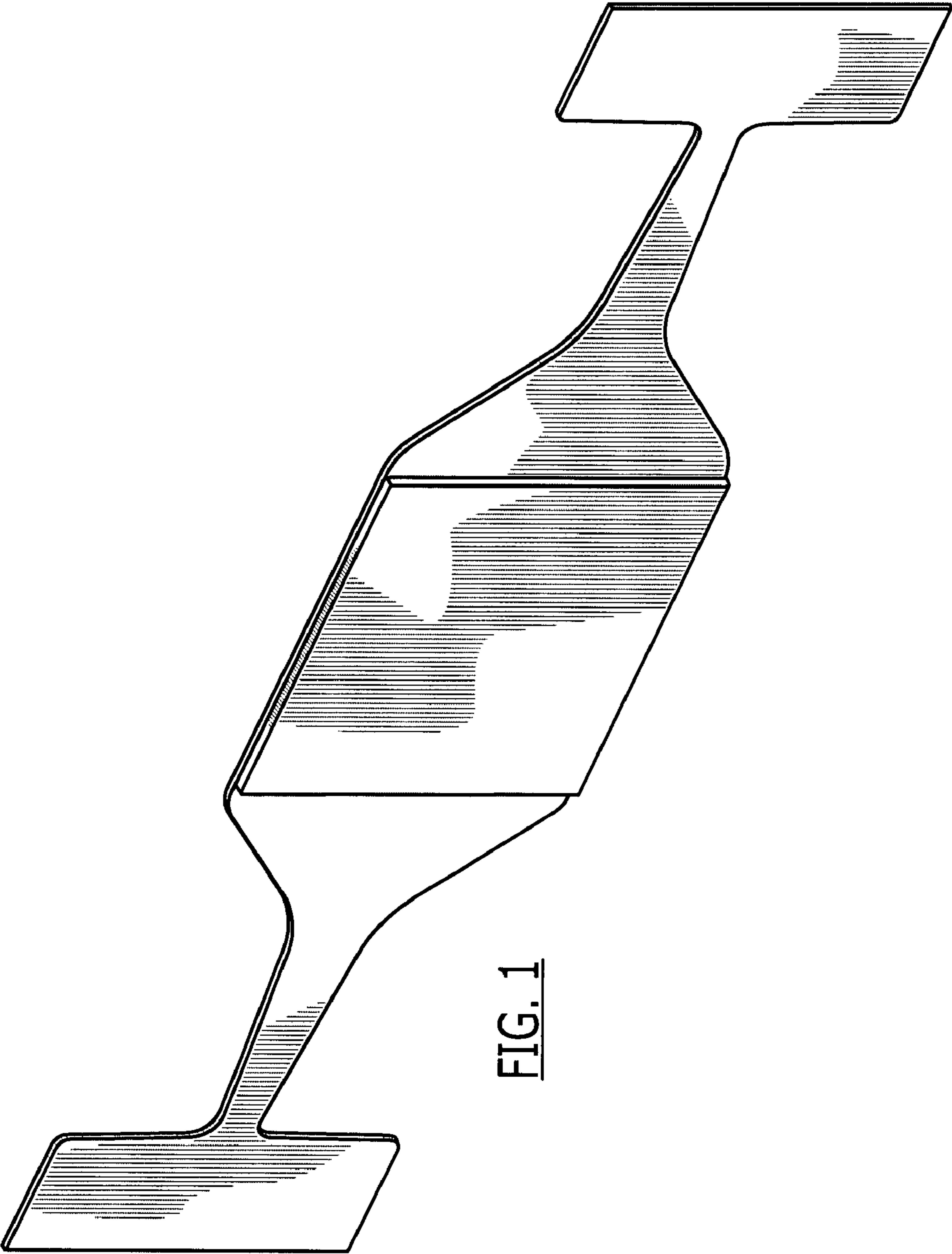

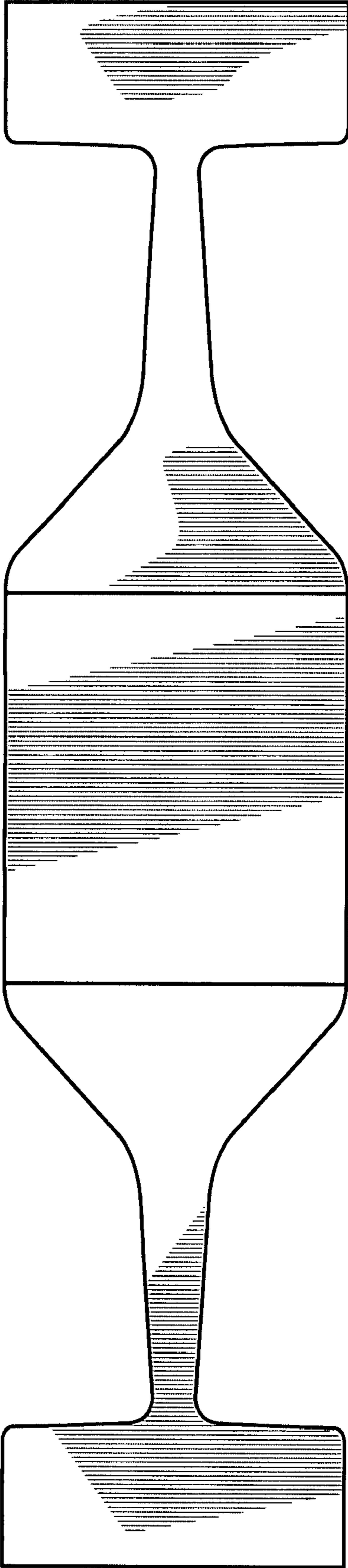

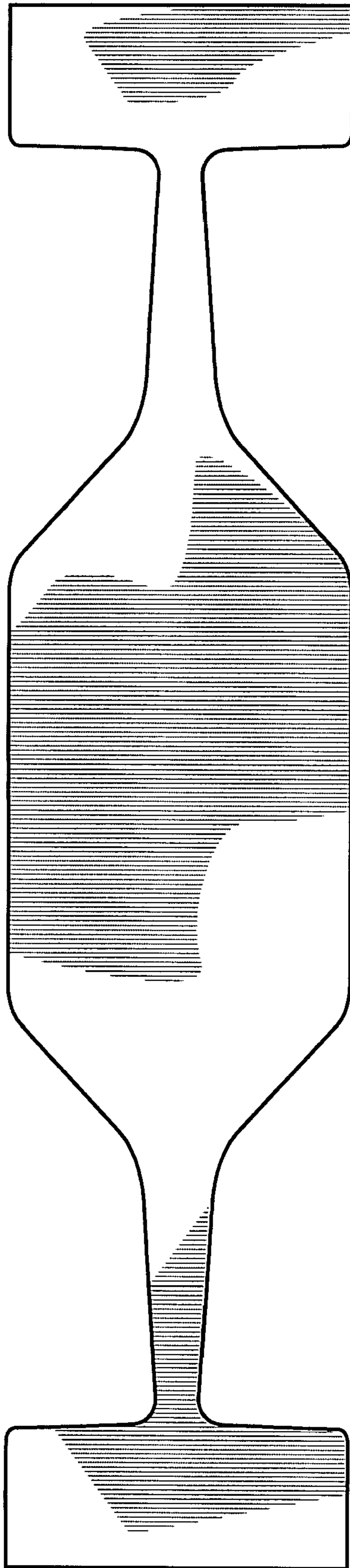
