FIG. 6 is a rear view thereof.

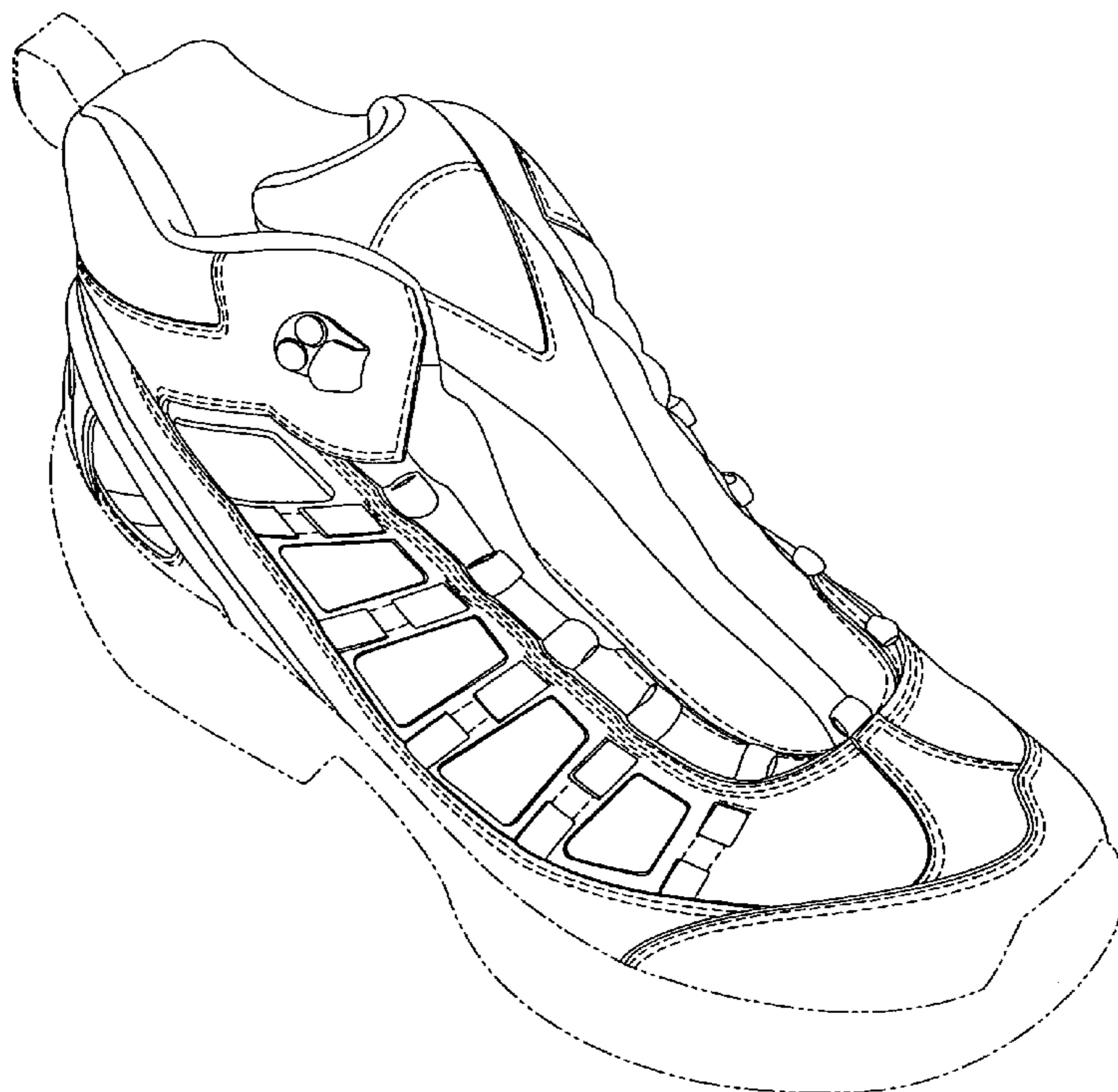
FIGS. 1–6 show features of an article of footwear in

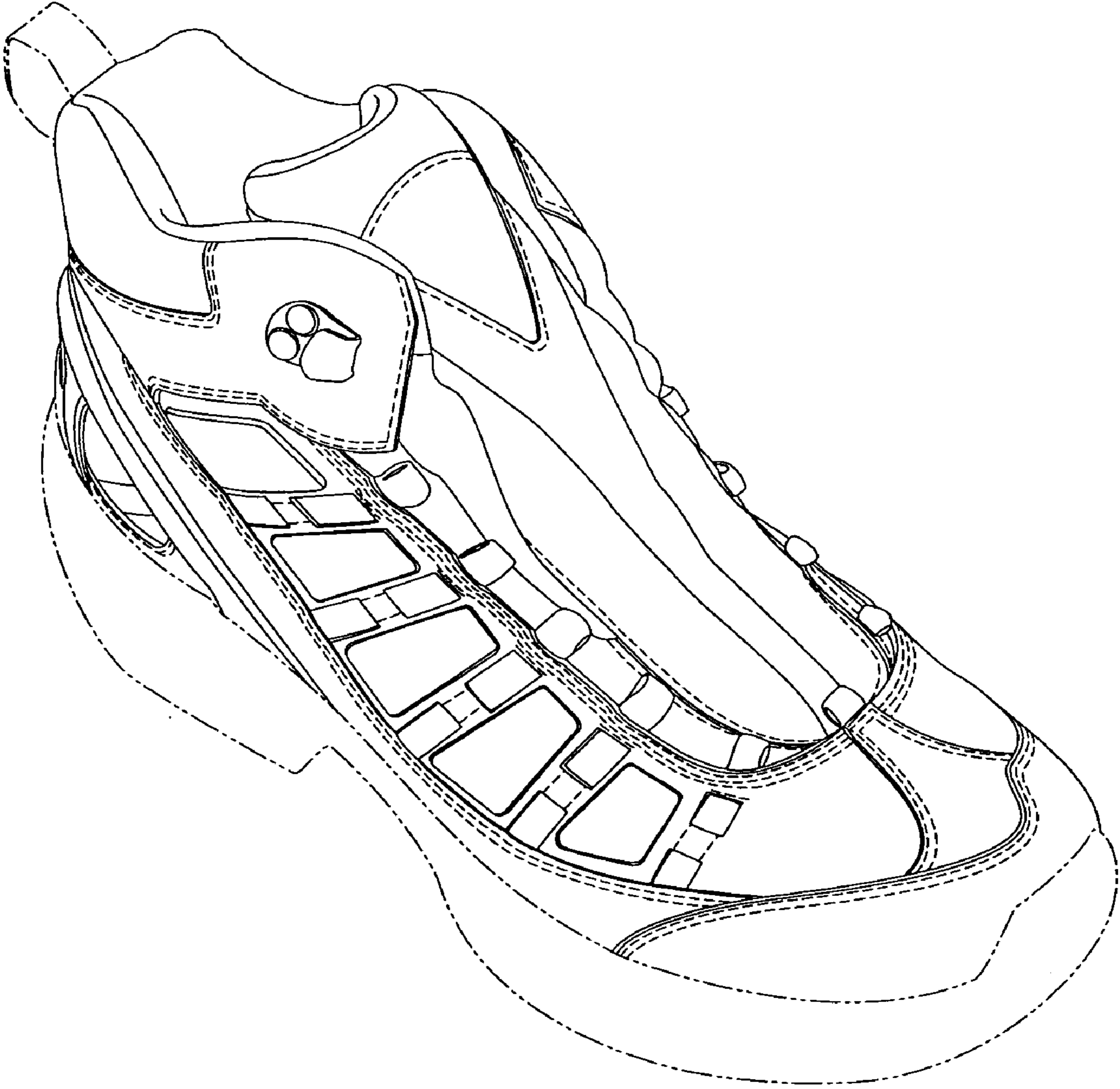

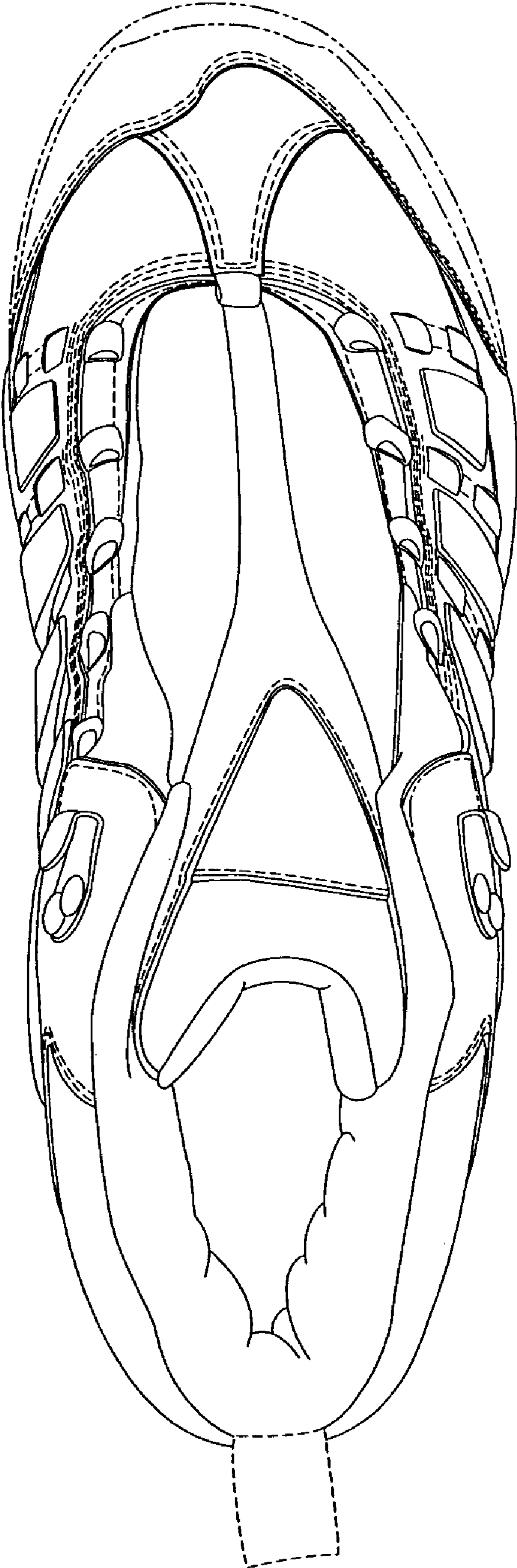

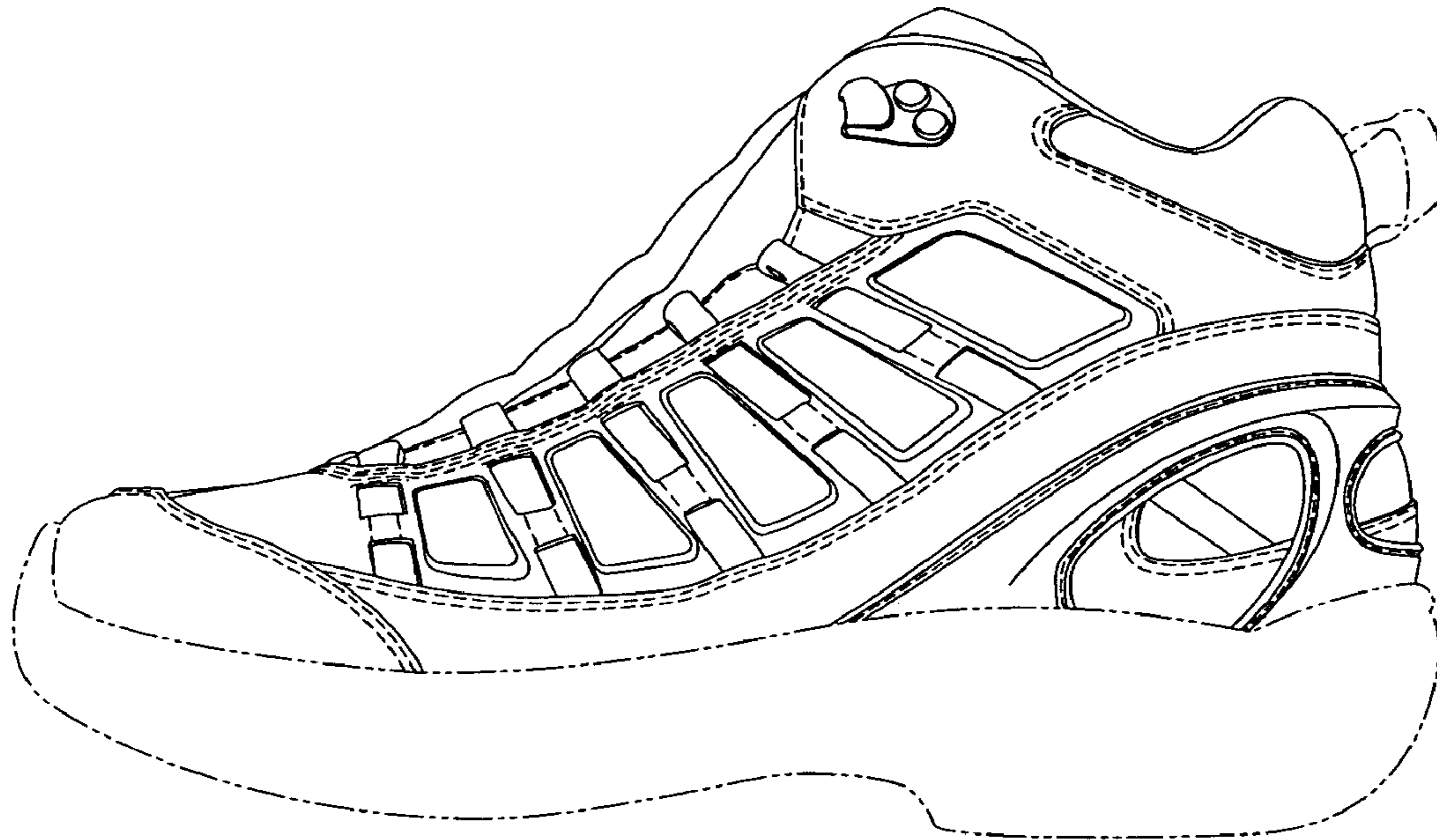

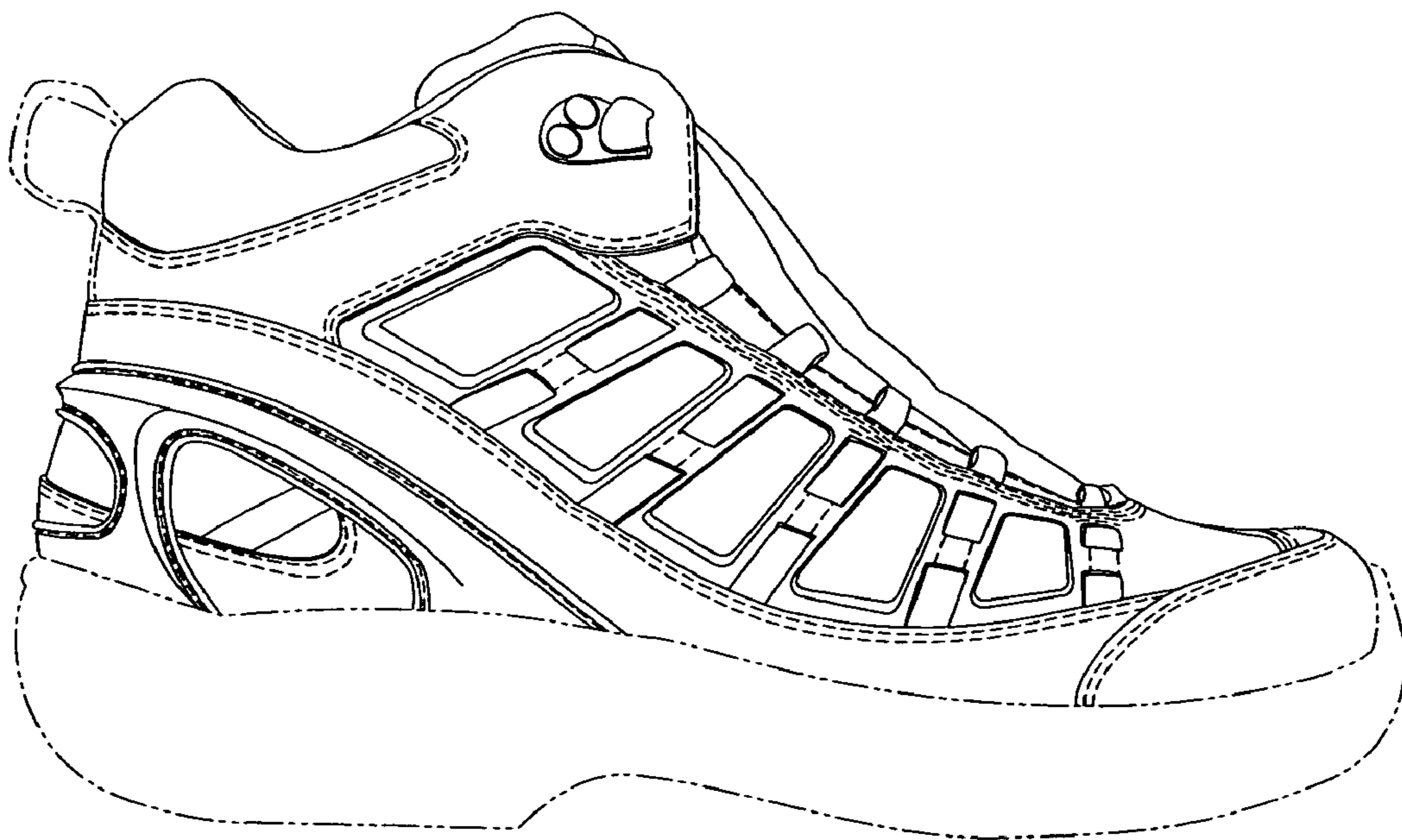

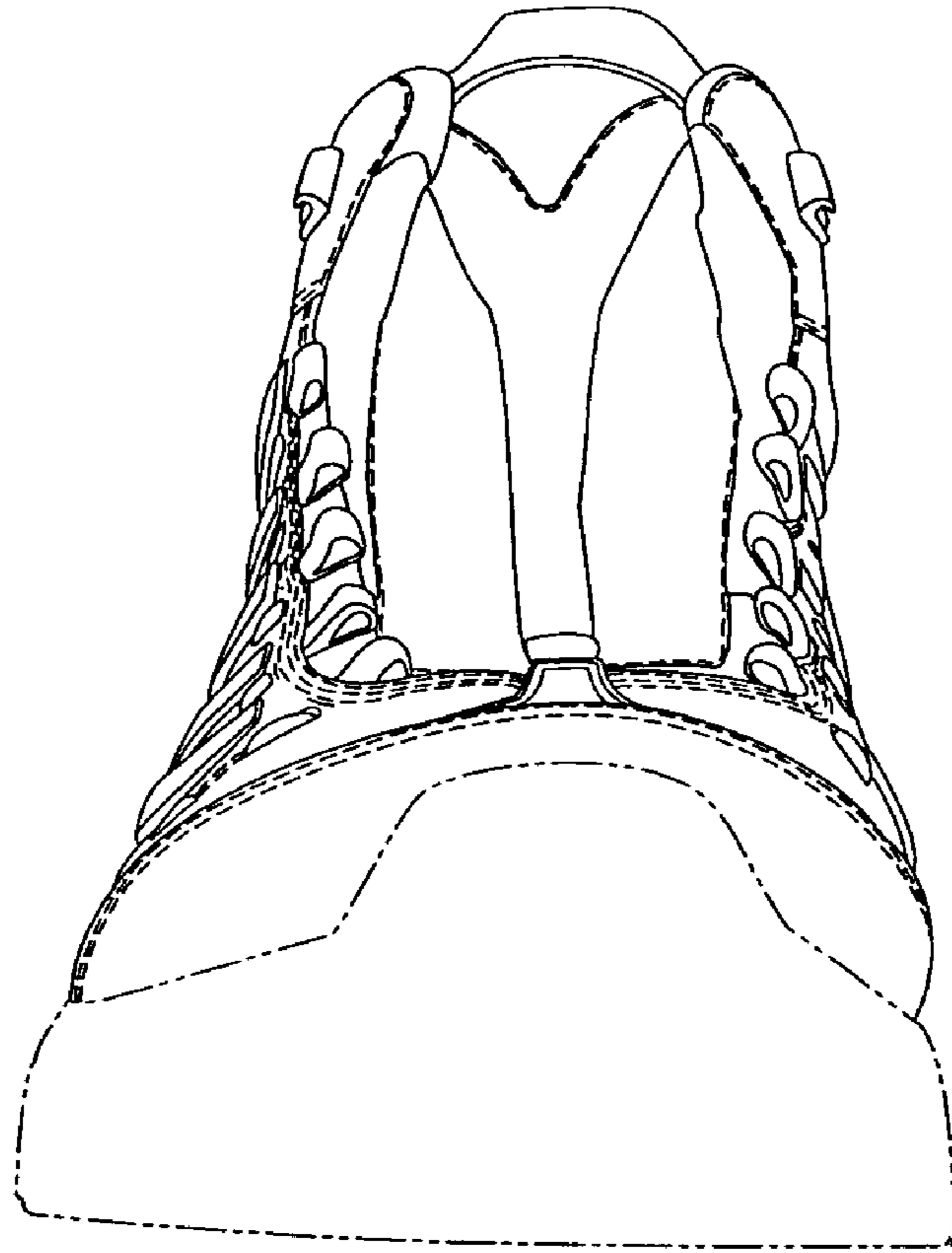

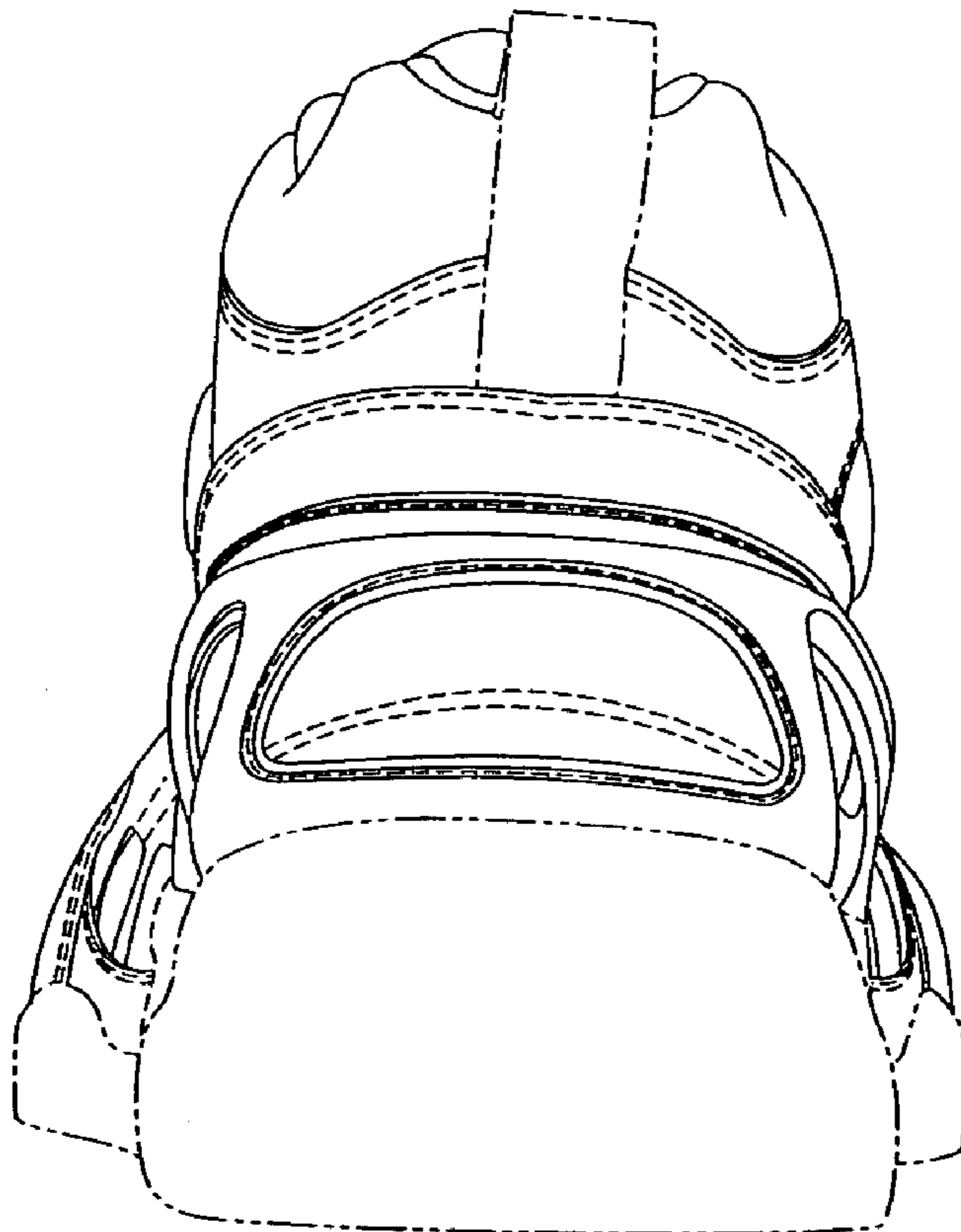
