FIG. 3 is a top view of the drawer organizer as shown in FIG. 1;

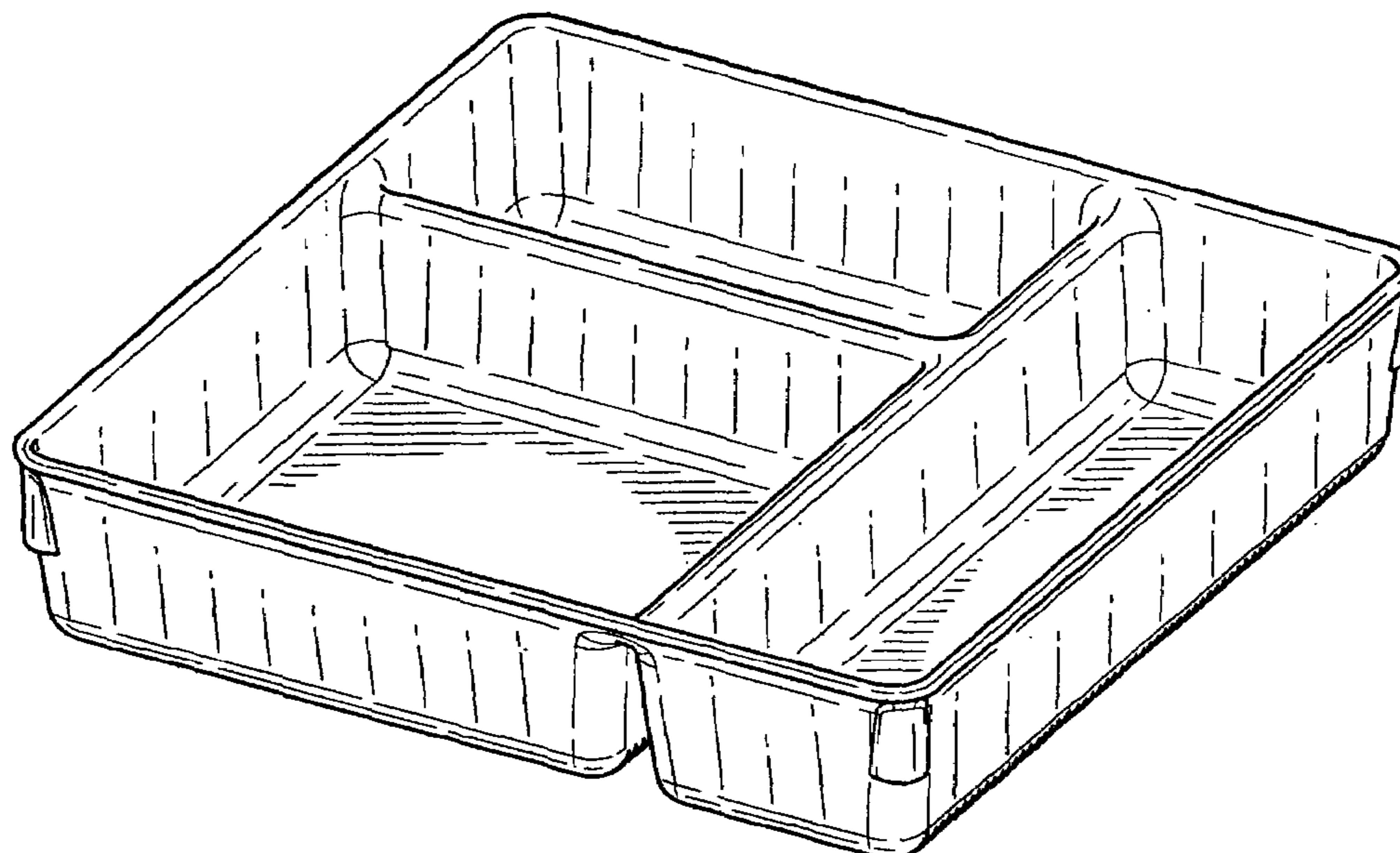
FIG. 4 is a side view of the drawer organizer as shown in FIG. 1;

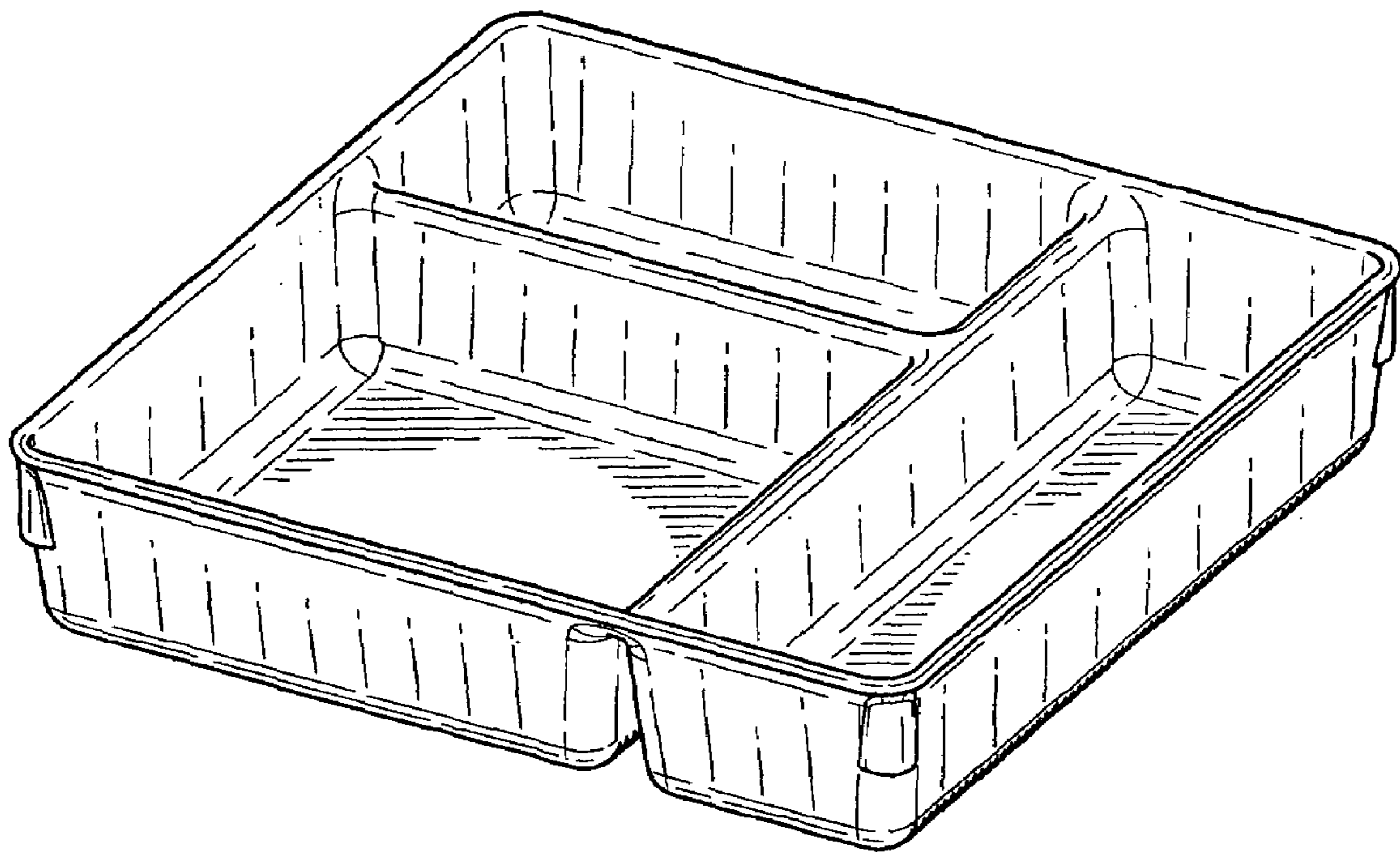

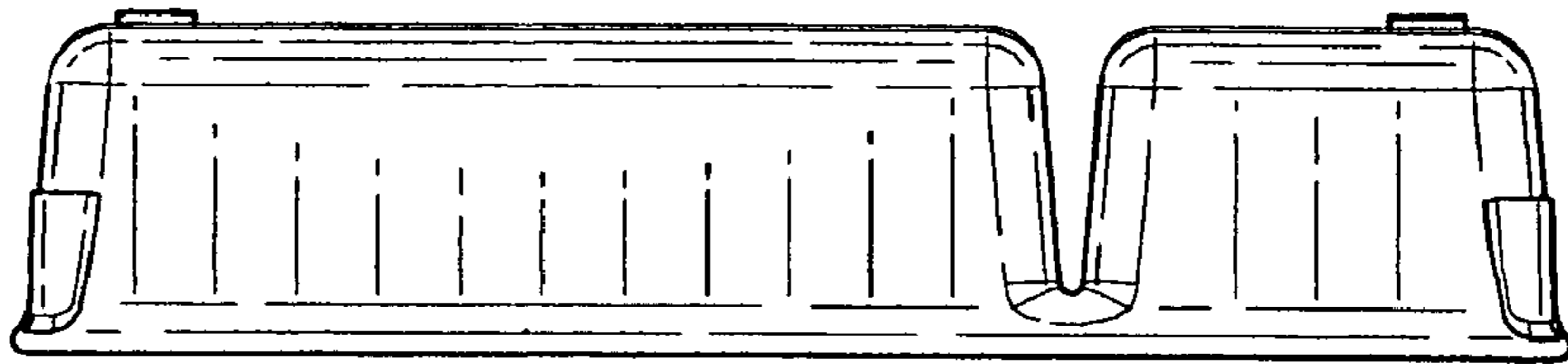

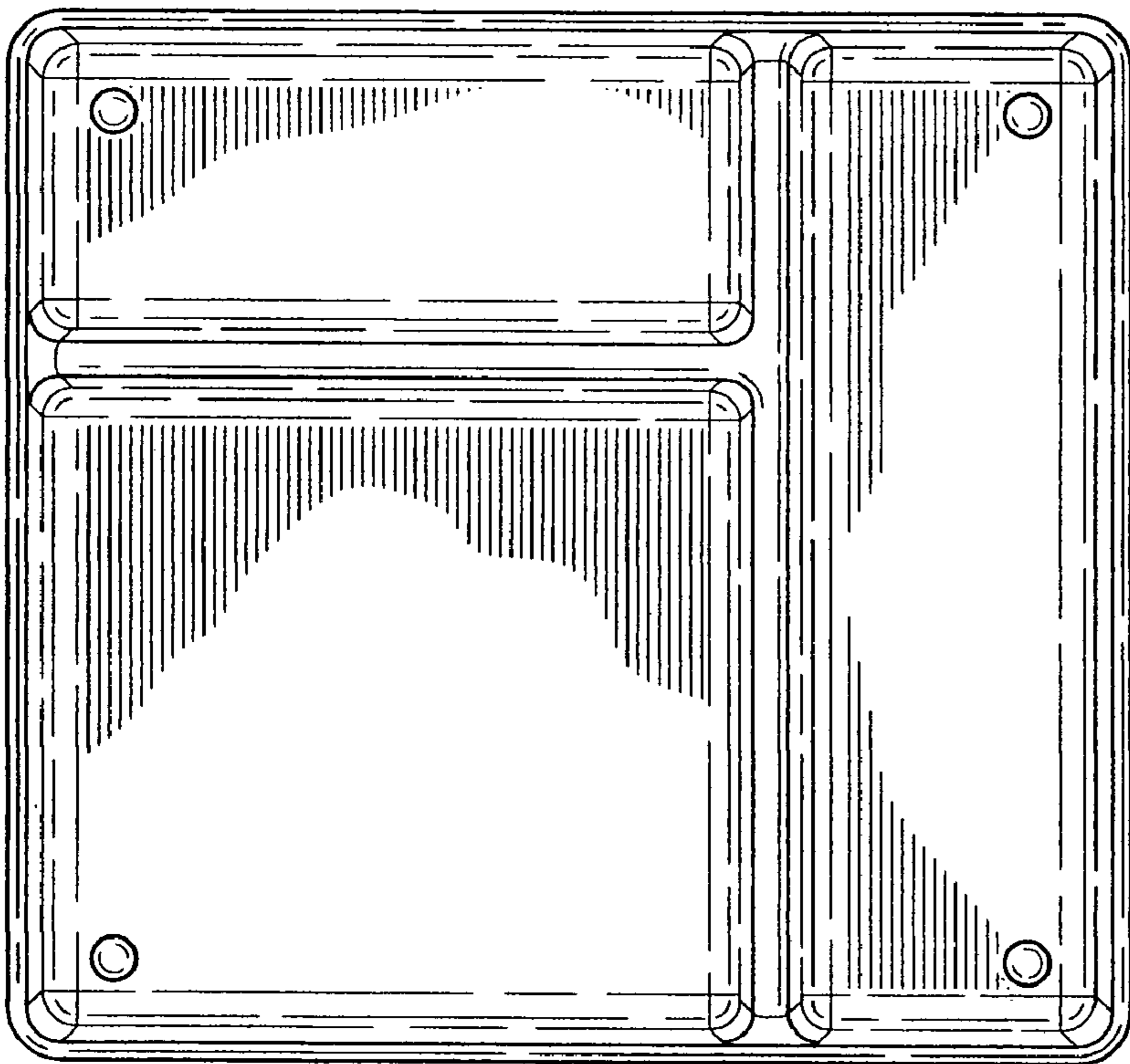

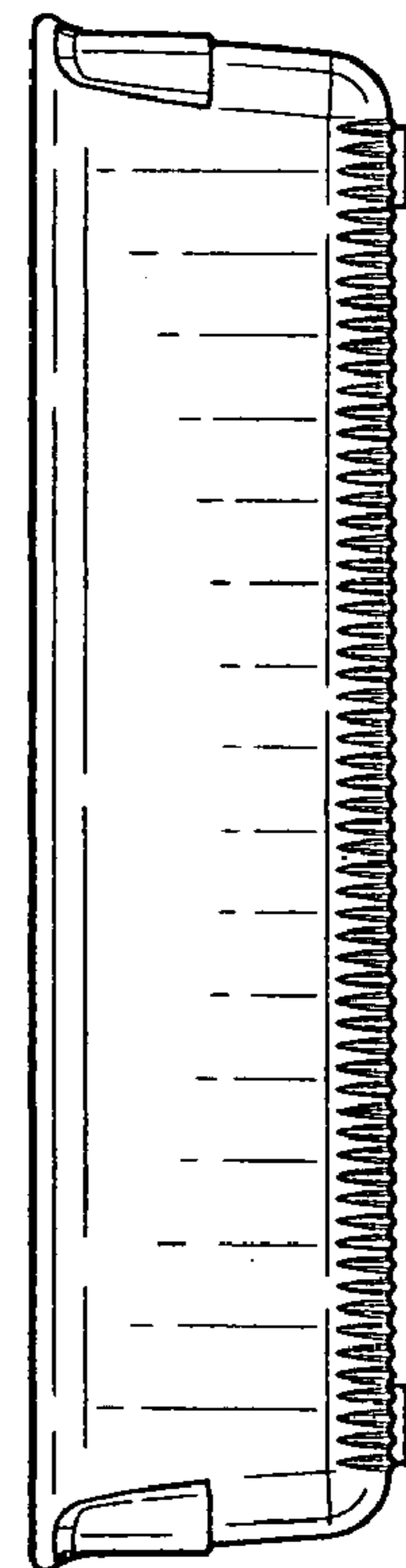

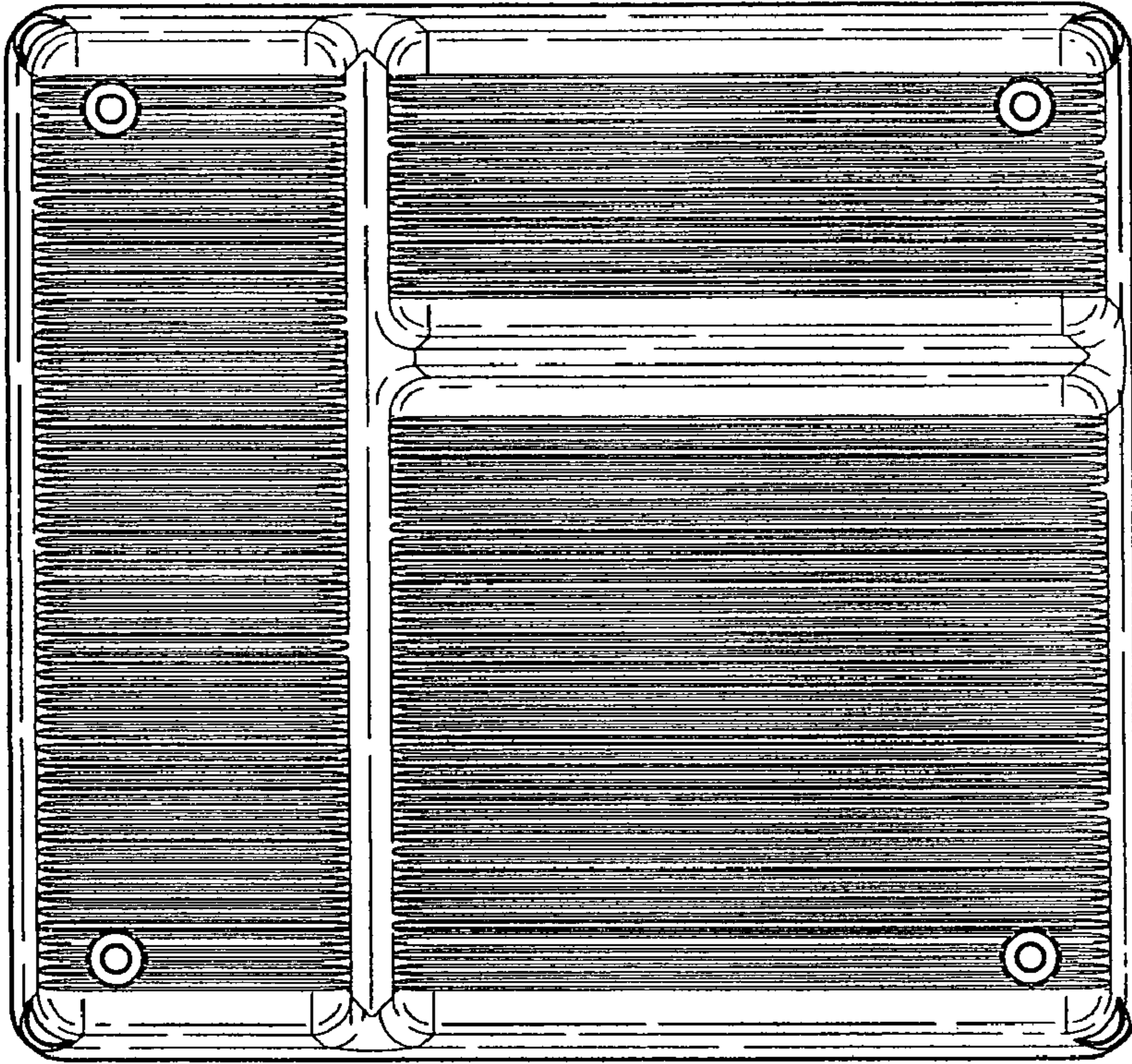

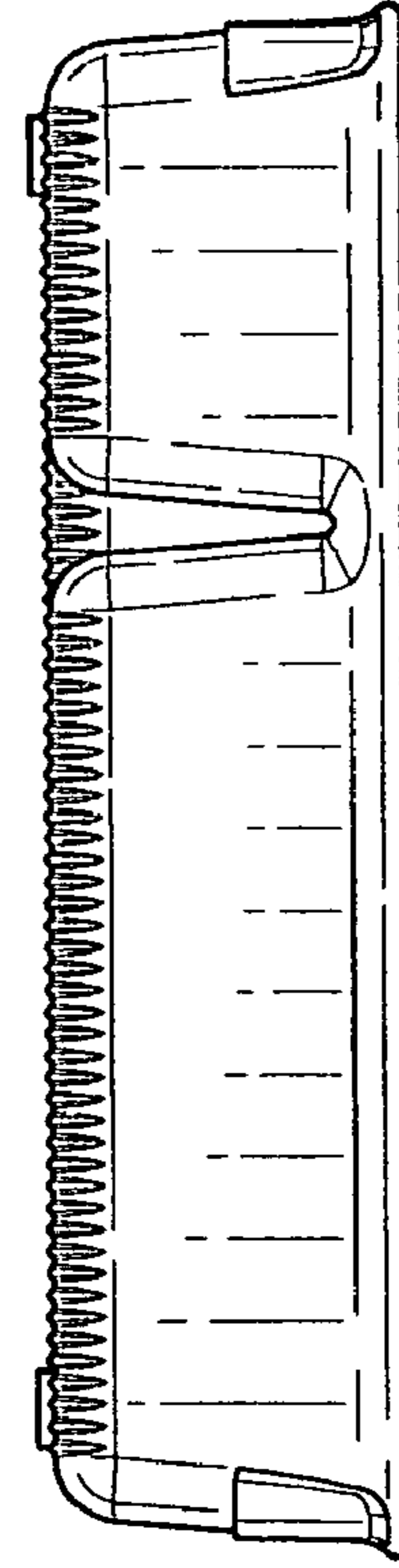

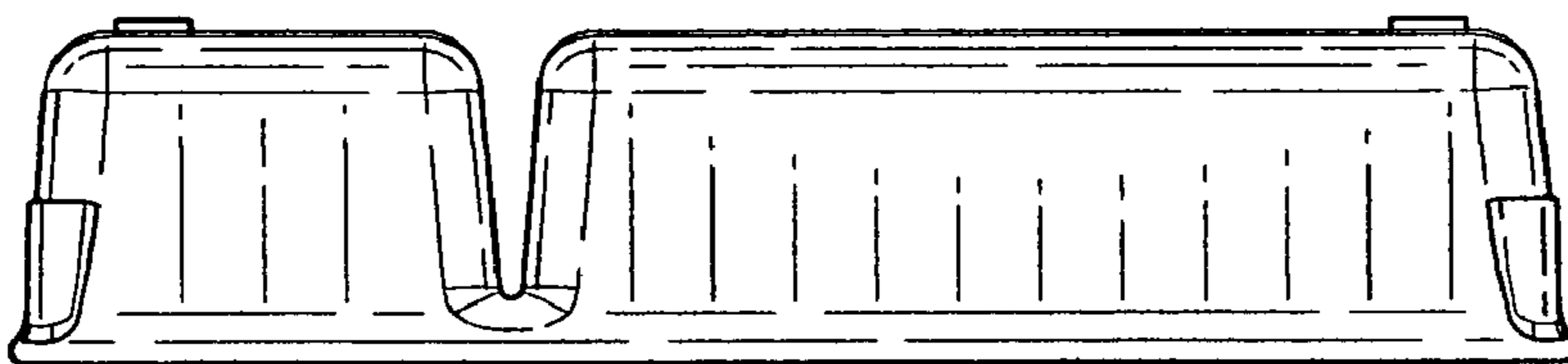
