DESCRIPTION

FIG. 10 is a side elevation view thereof;

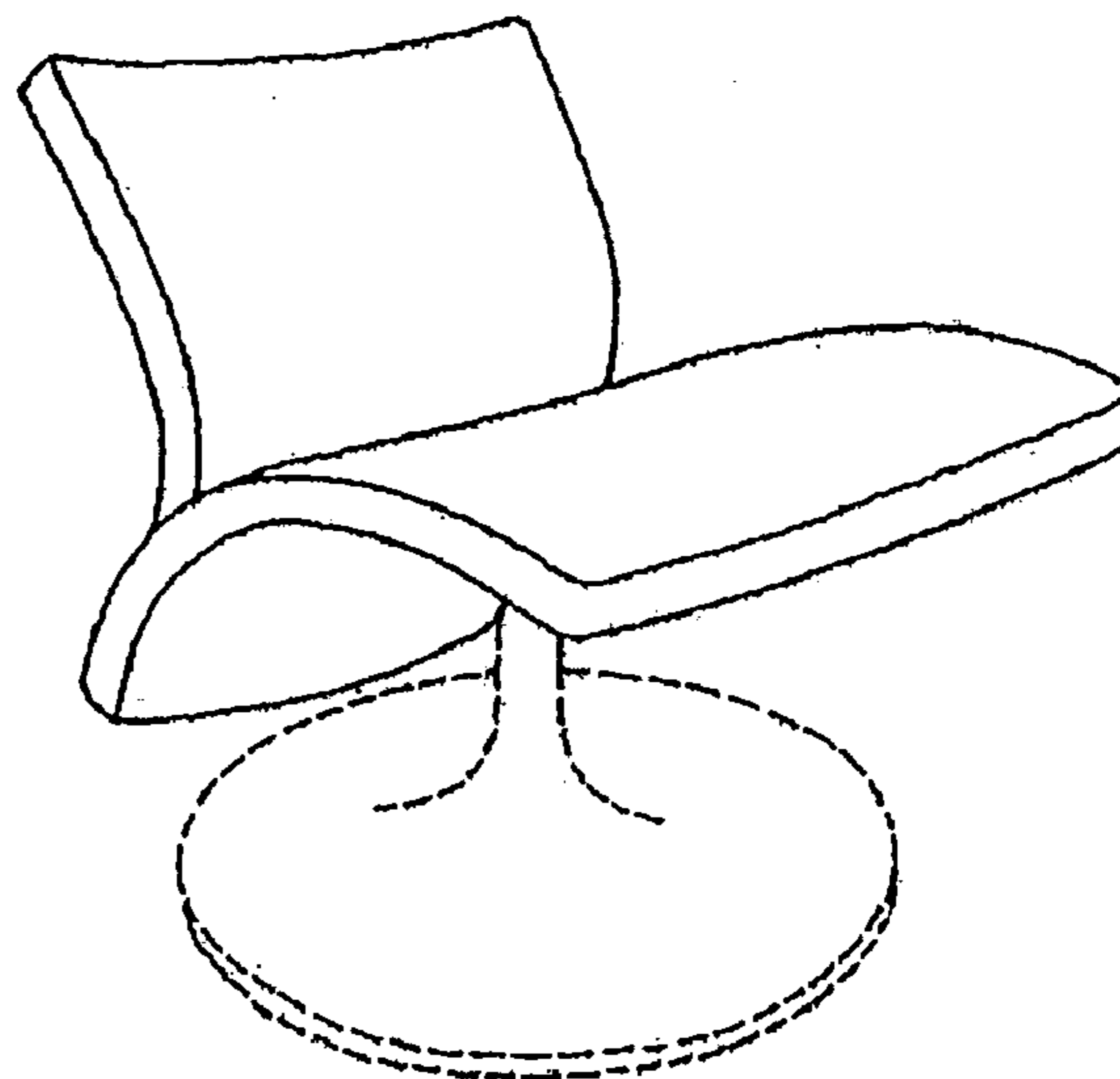
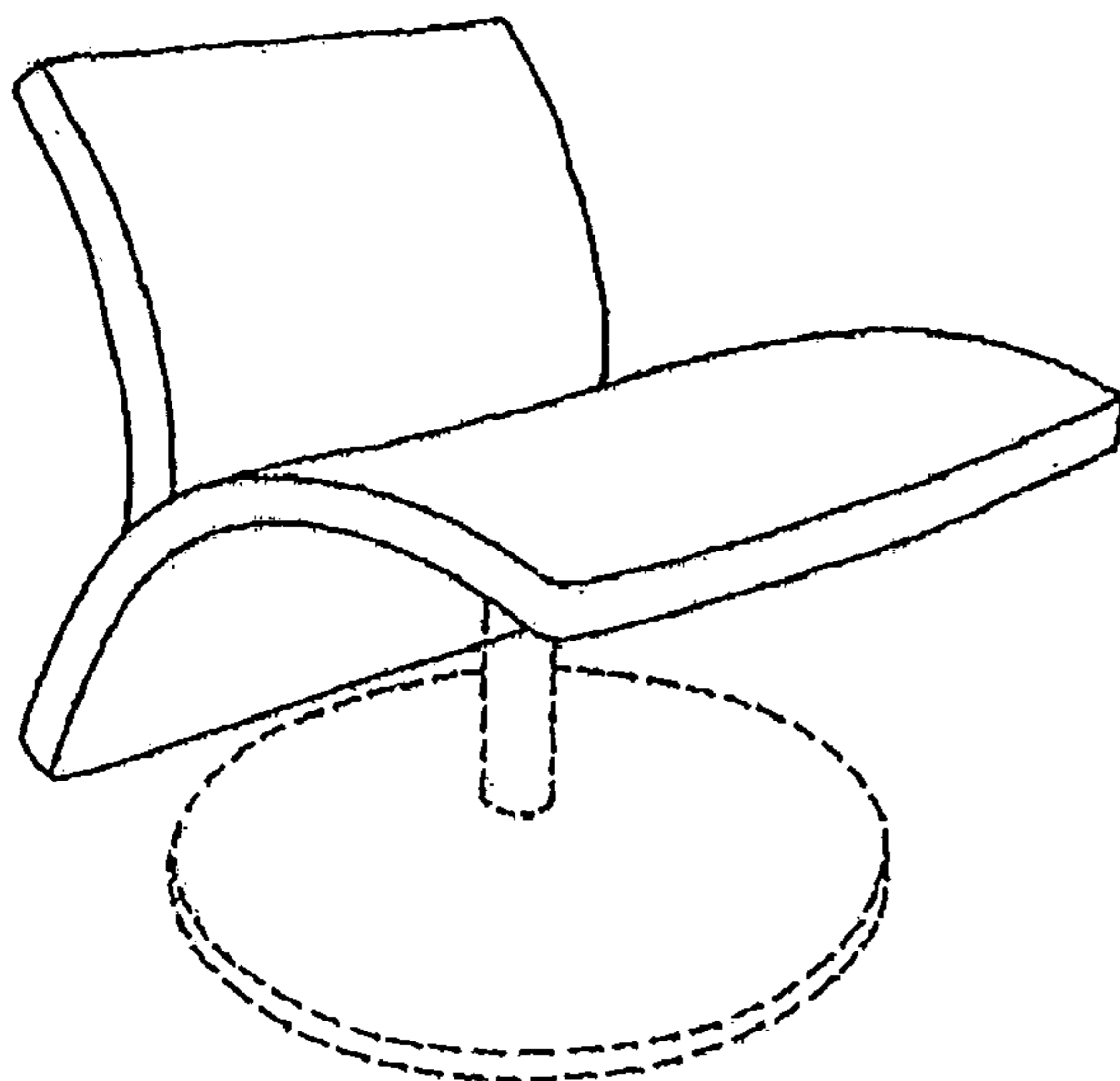
FIG. 11 is a rear elevation view thereof;

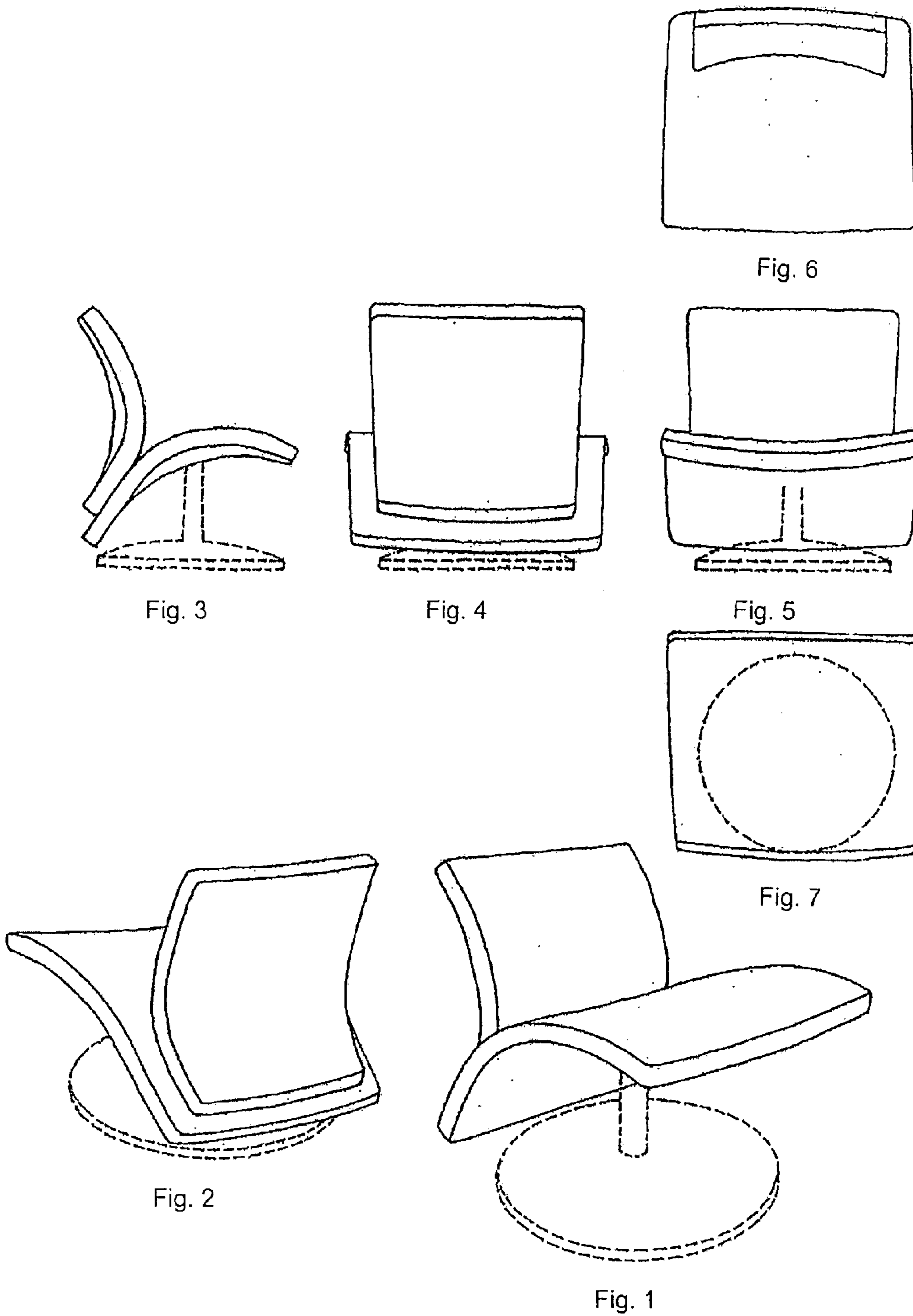
FIG. 12 is a front elevation view thereof;

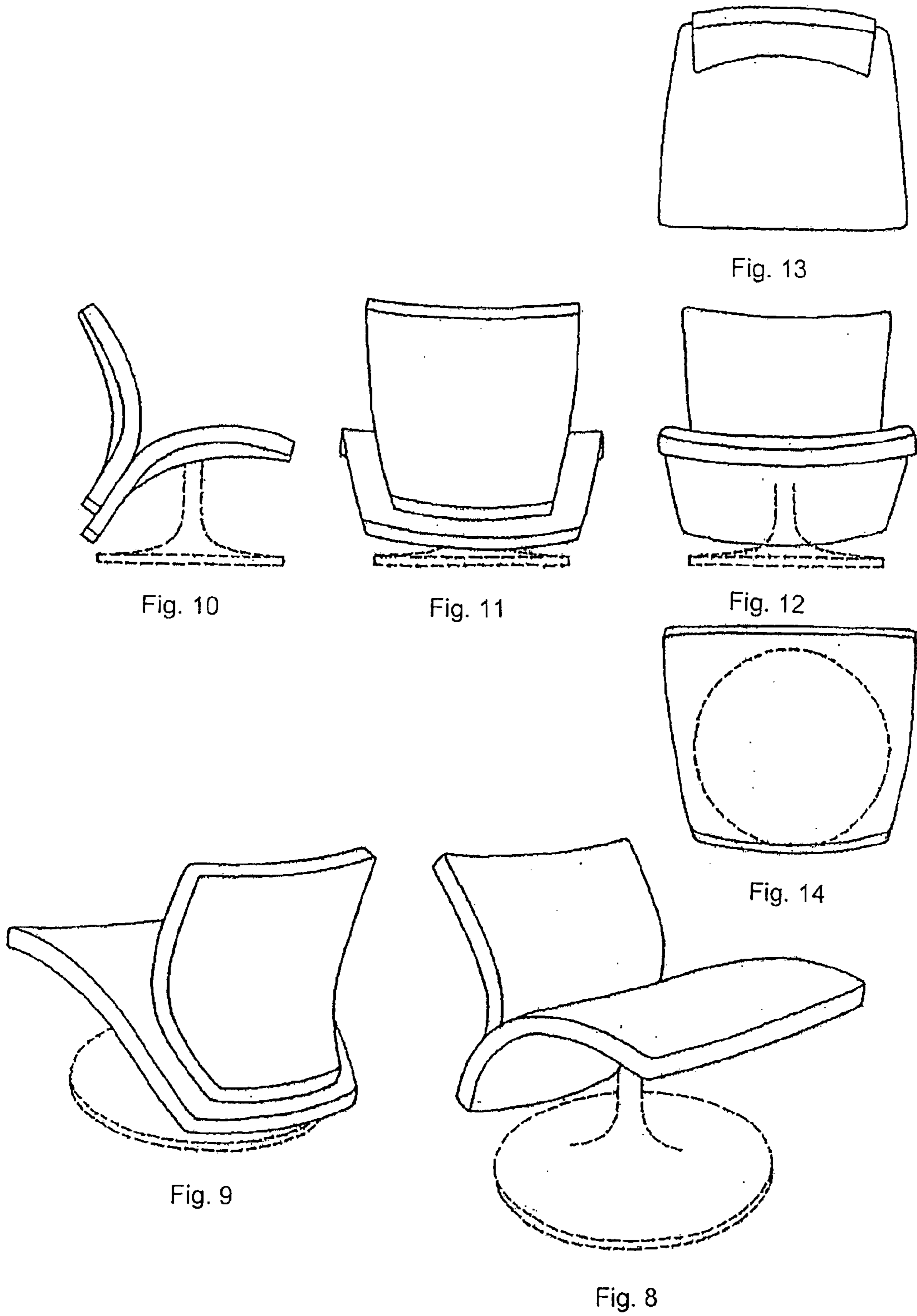
