elevational view being a mirror imaged.

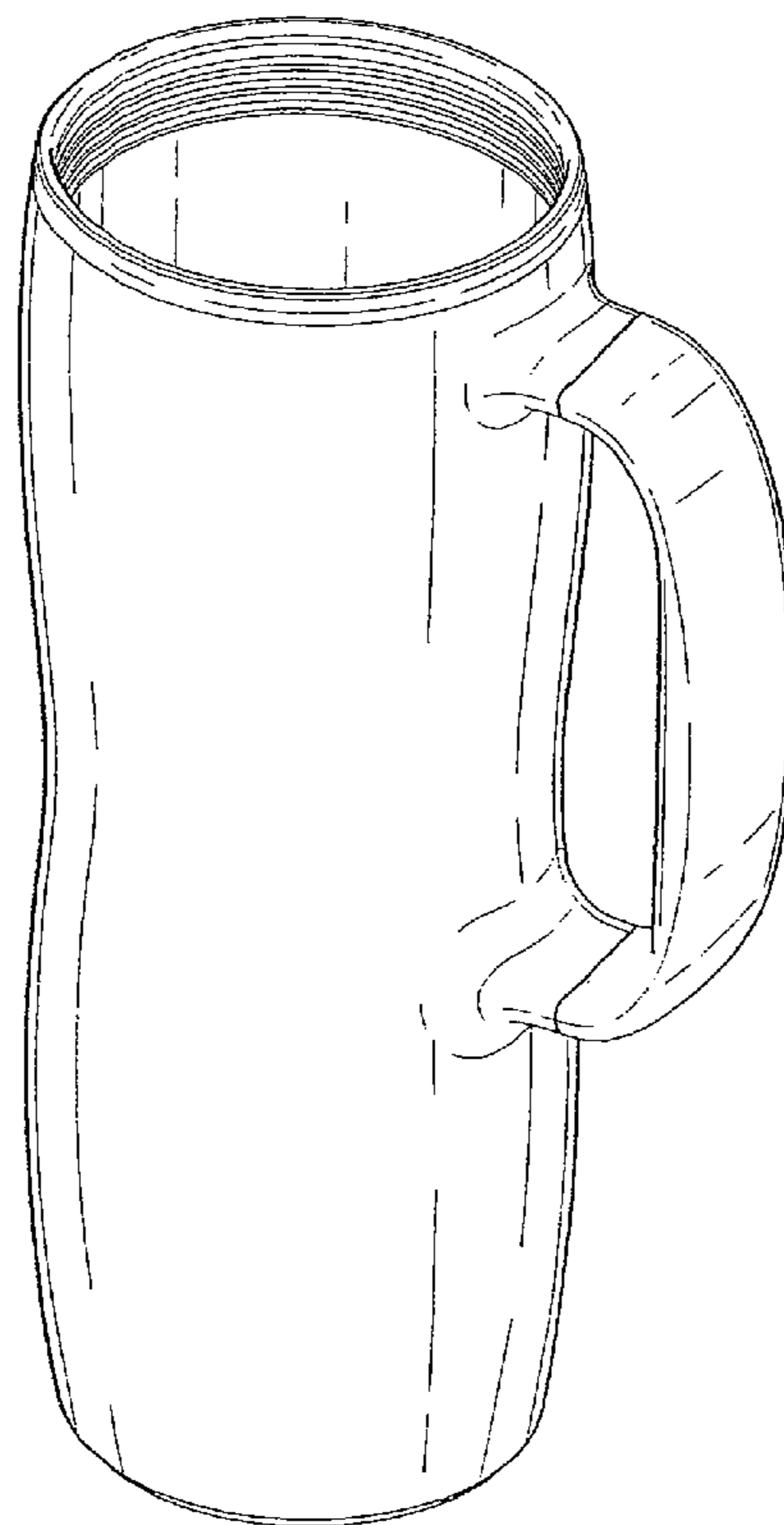
FIG. 3 is a right side elevational view thereof.

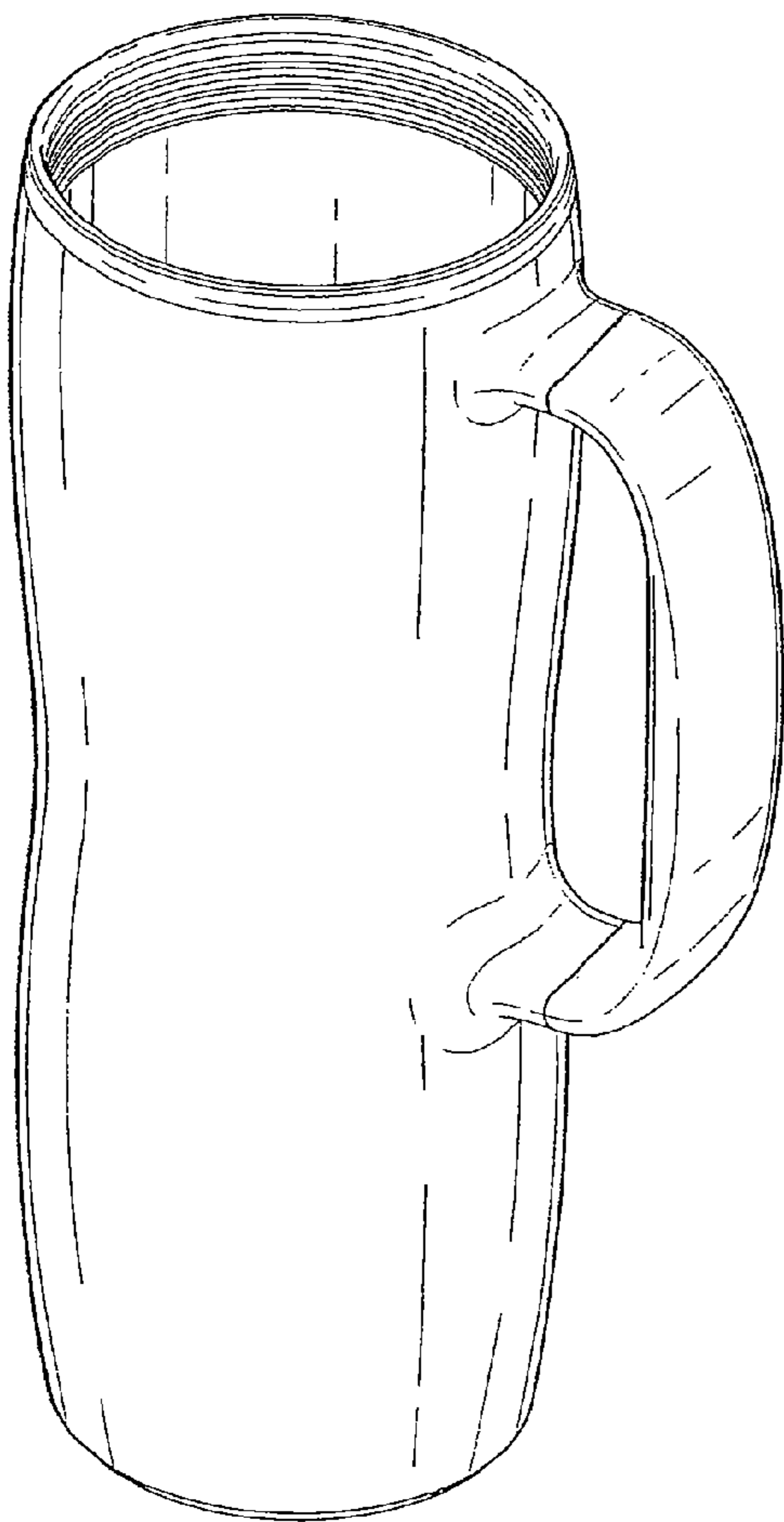

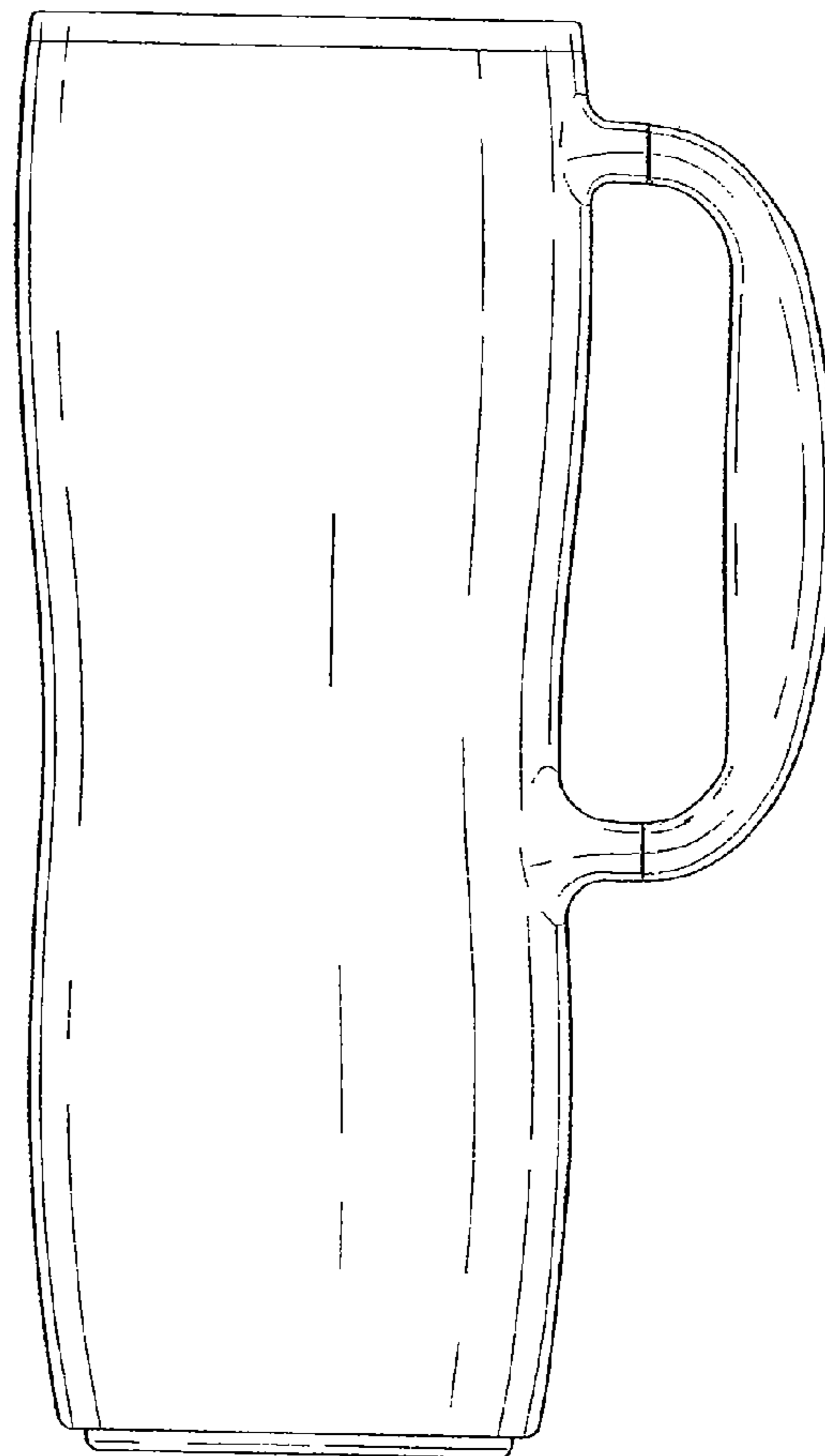

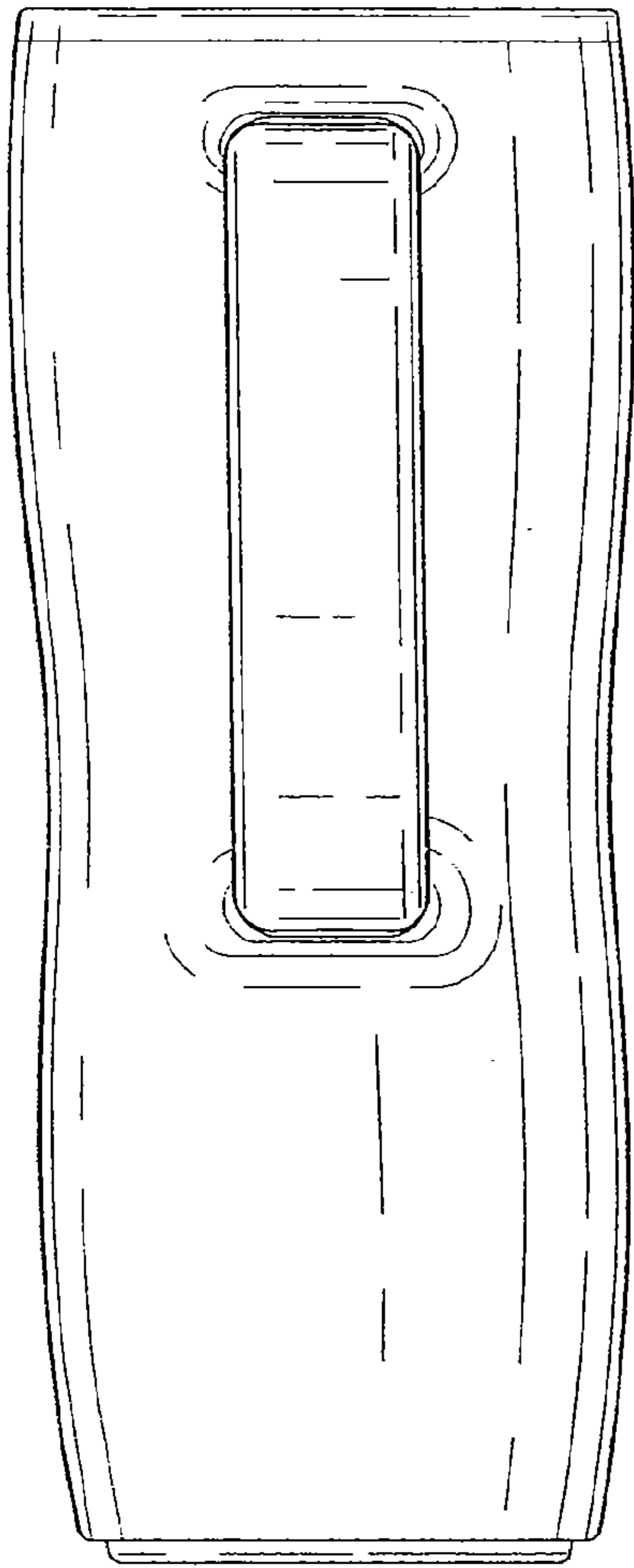

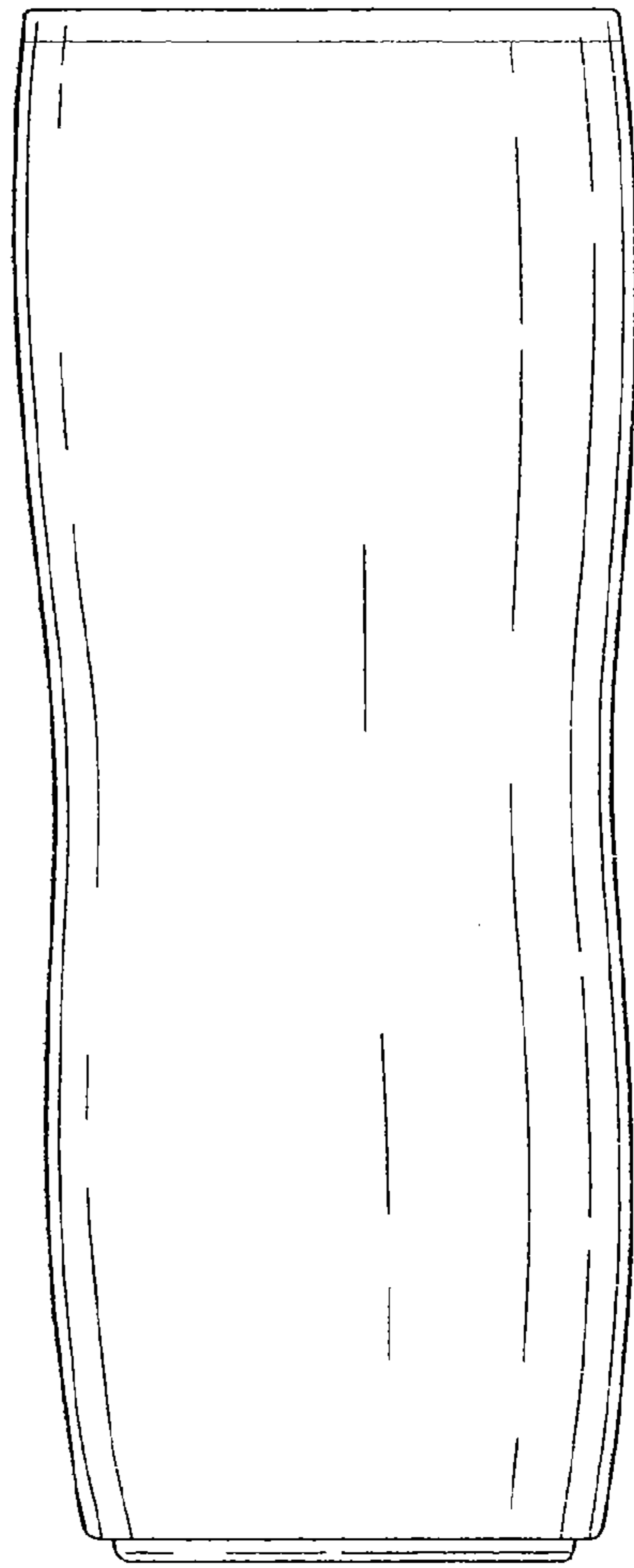

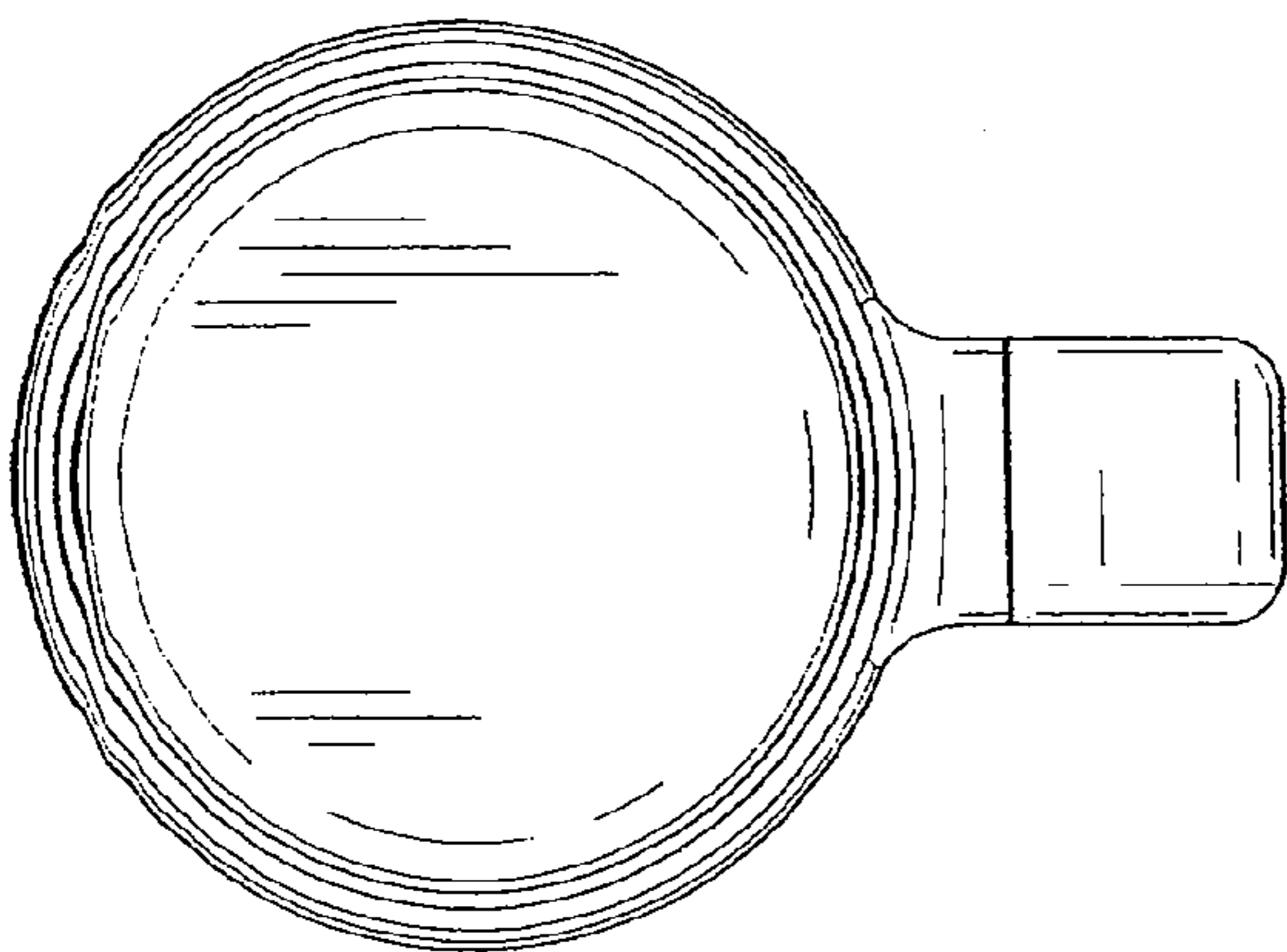

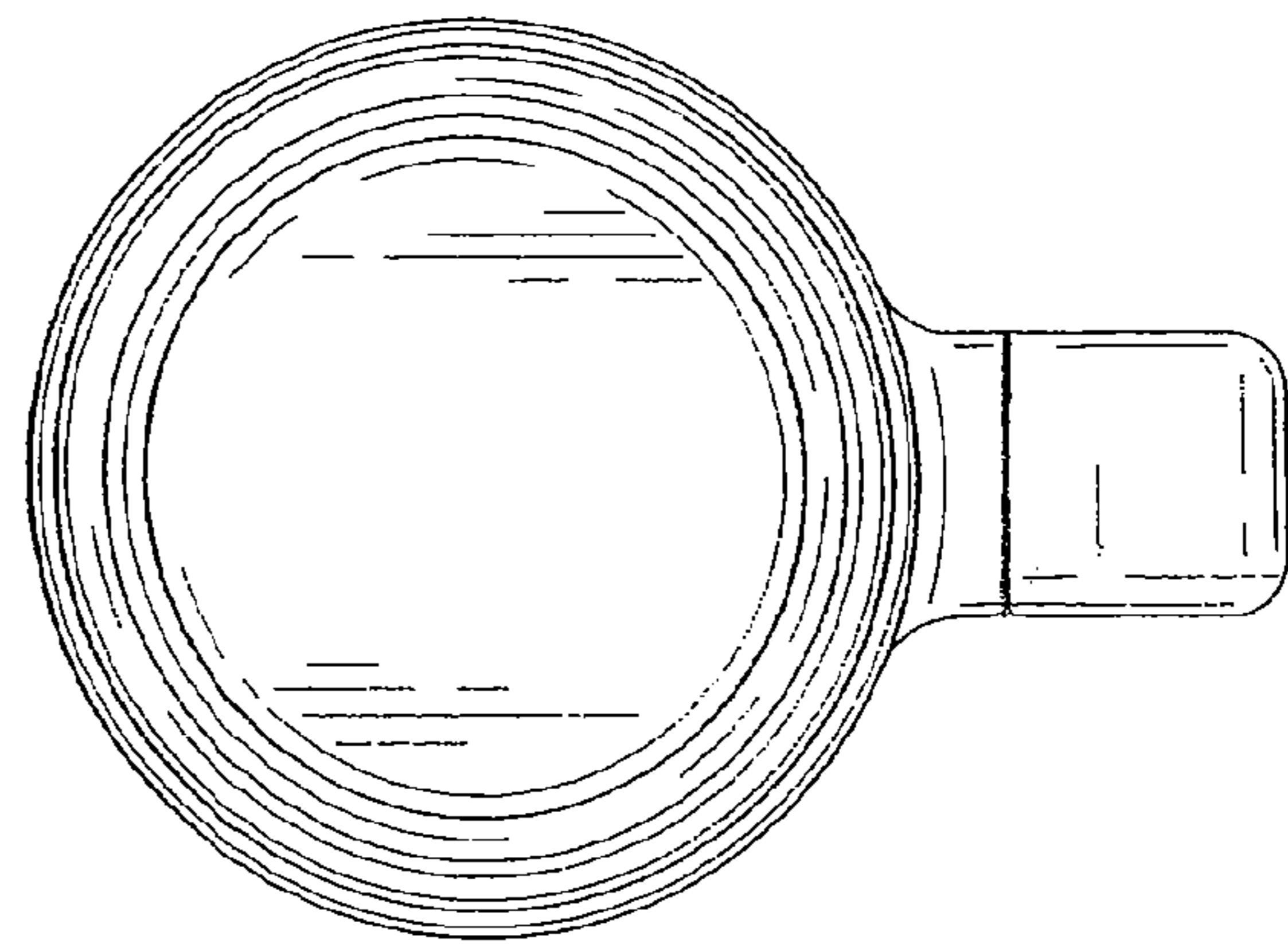
