DESCRIPTION

FIG. 6 is a bottom plan view thereof;

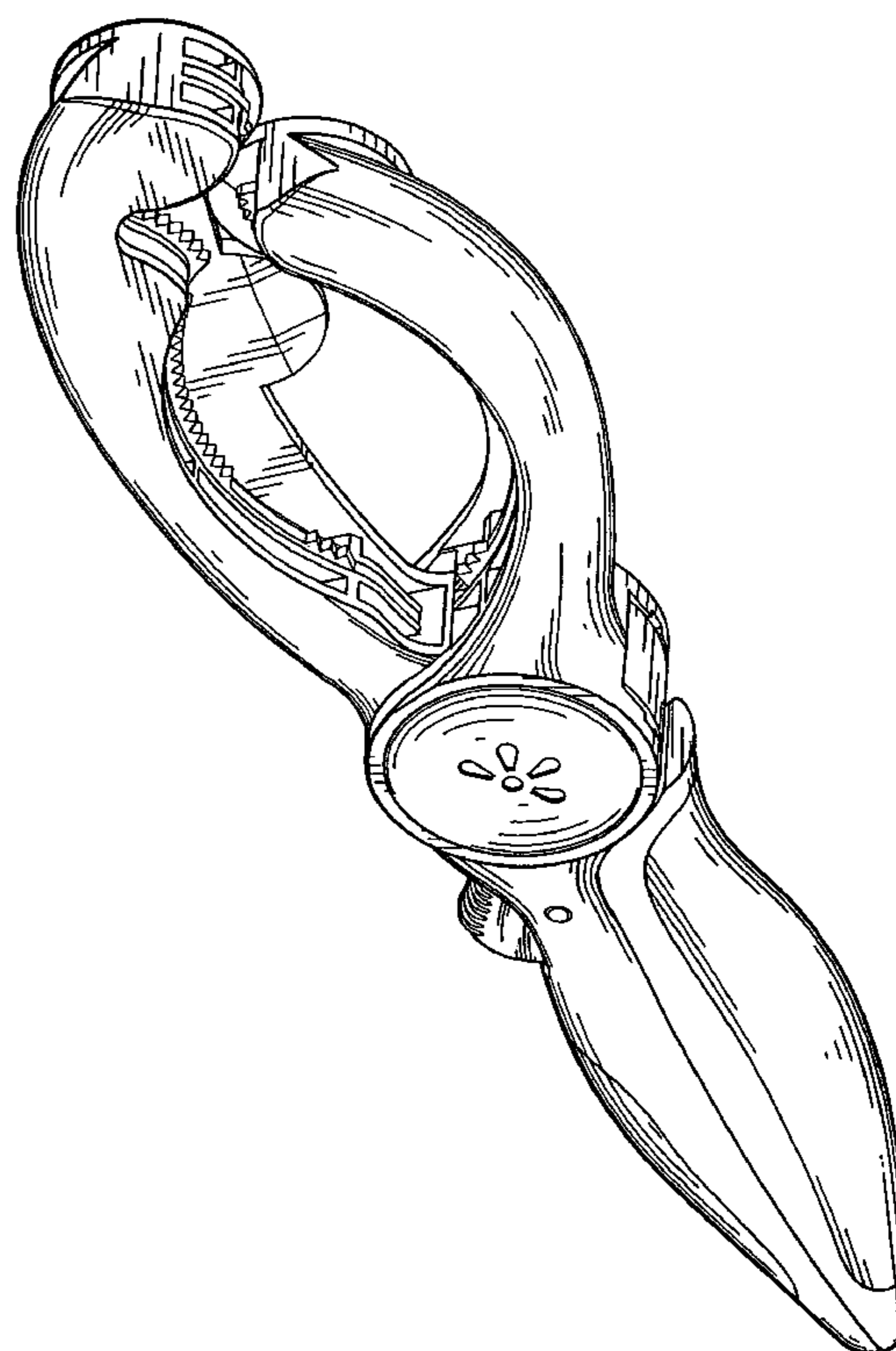
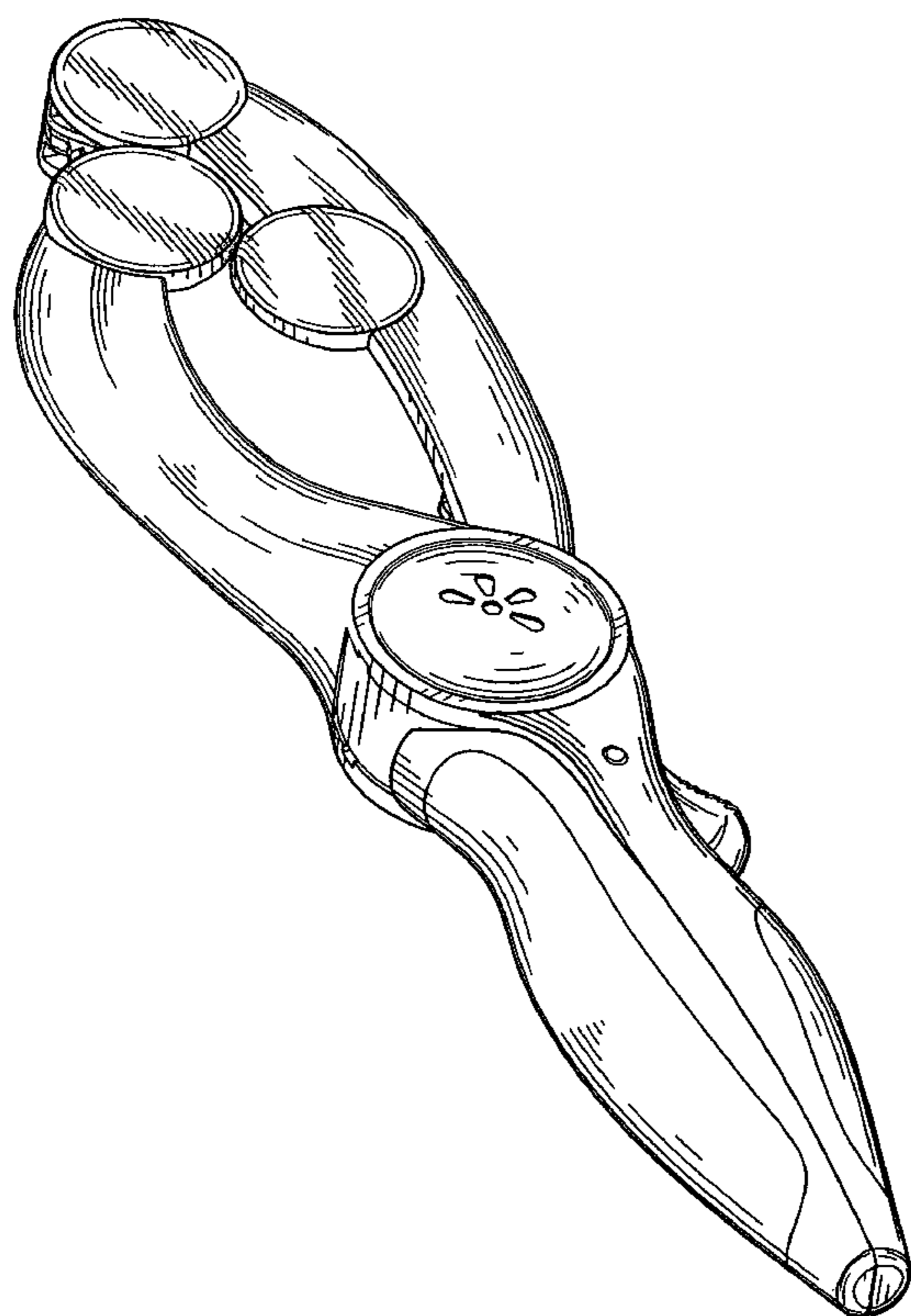
FIG. 7 is a front end elevational view thereof;

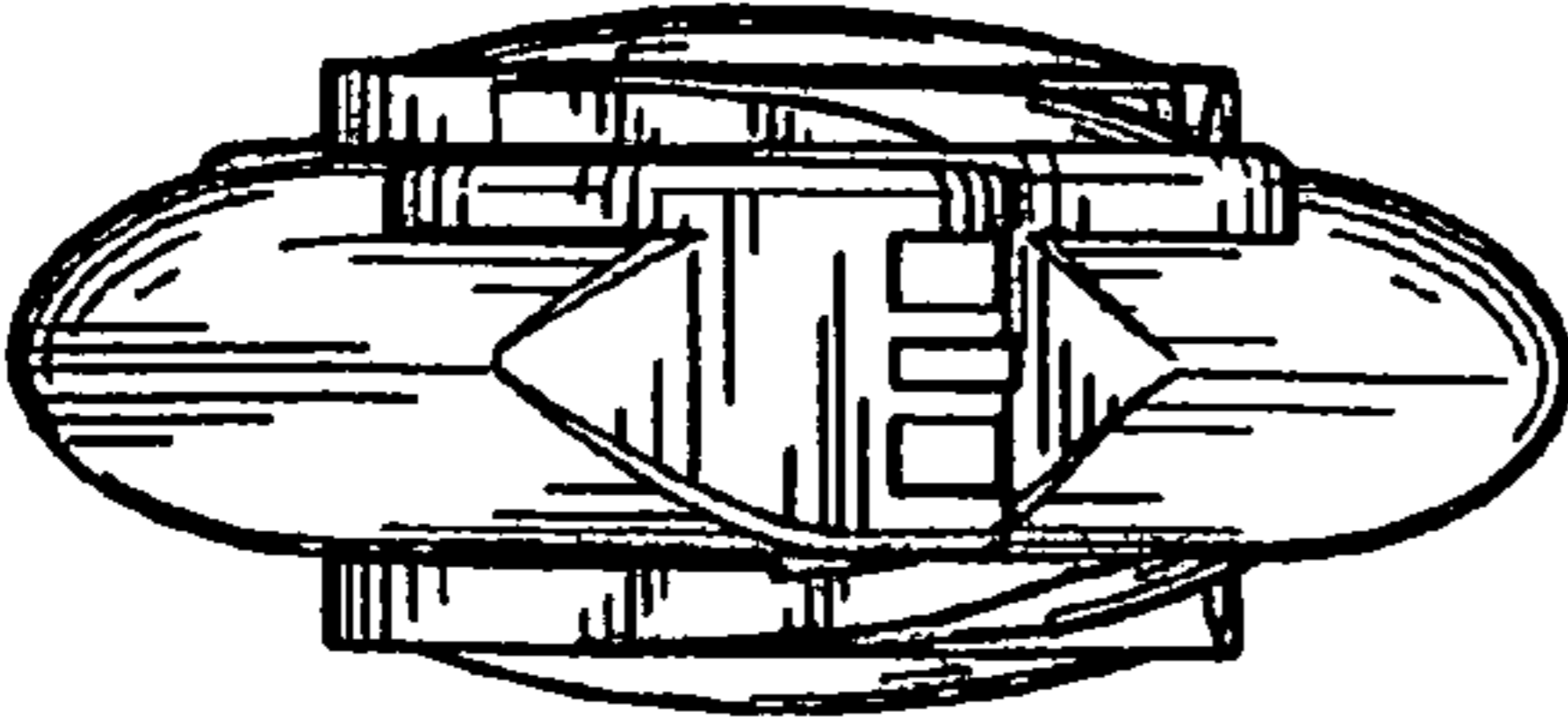

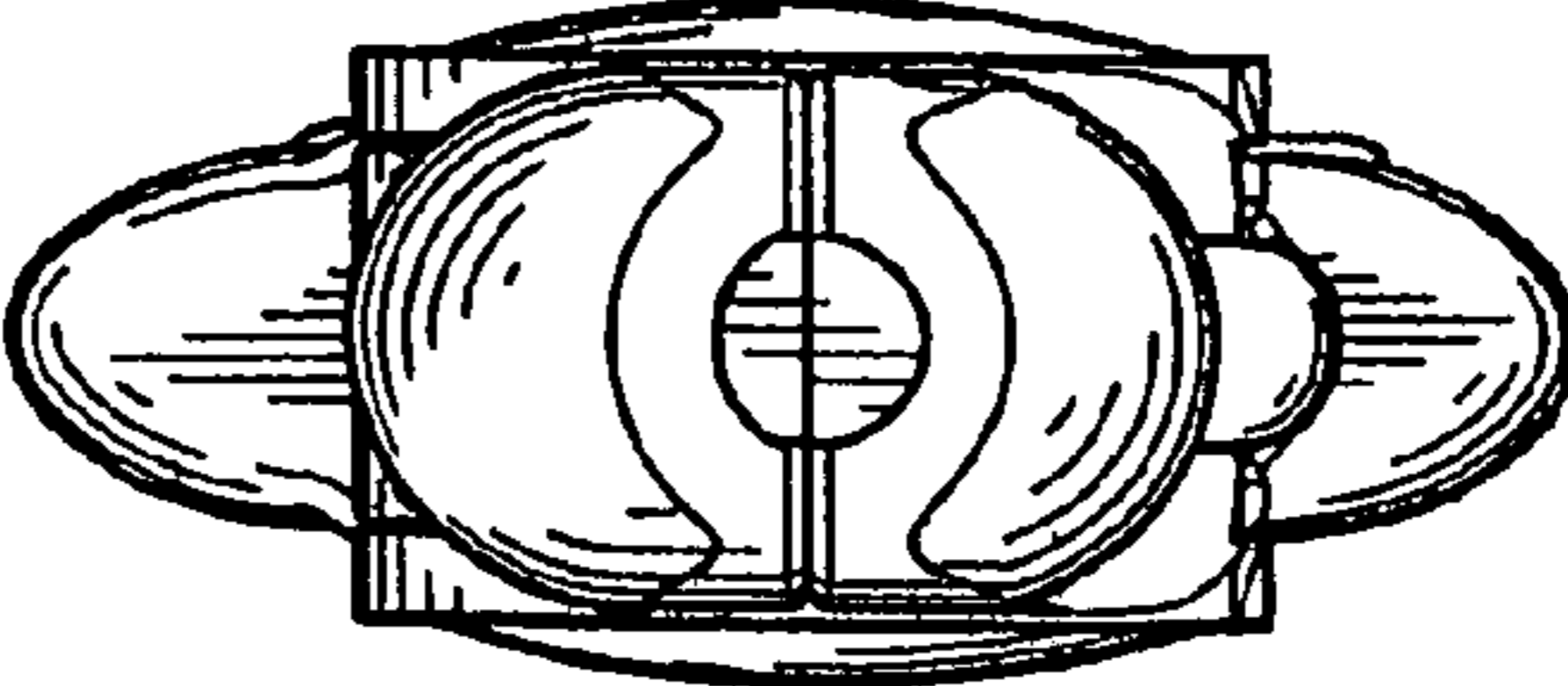

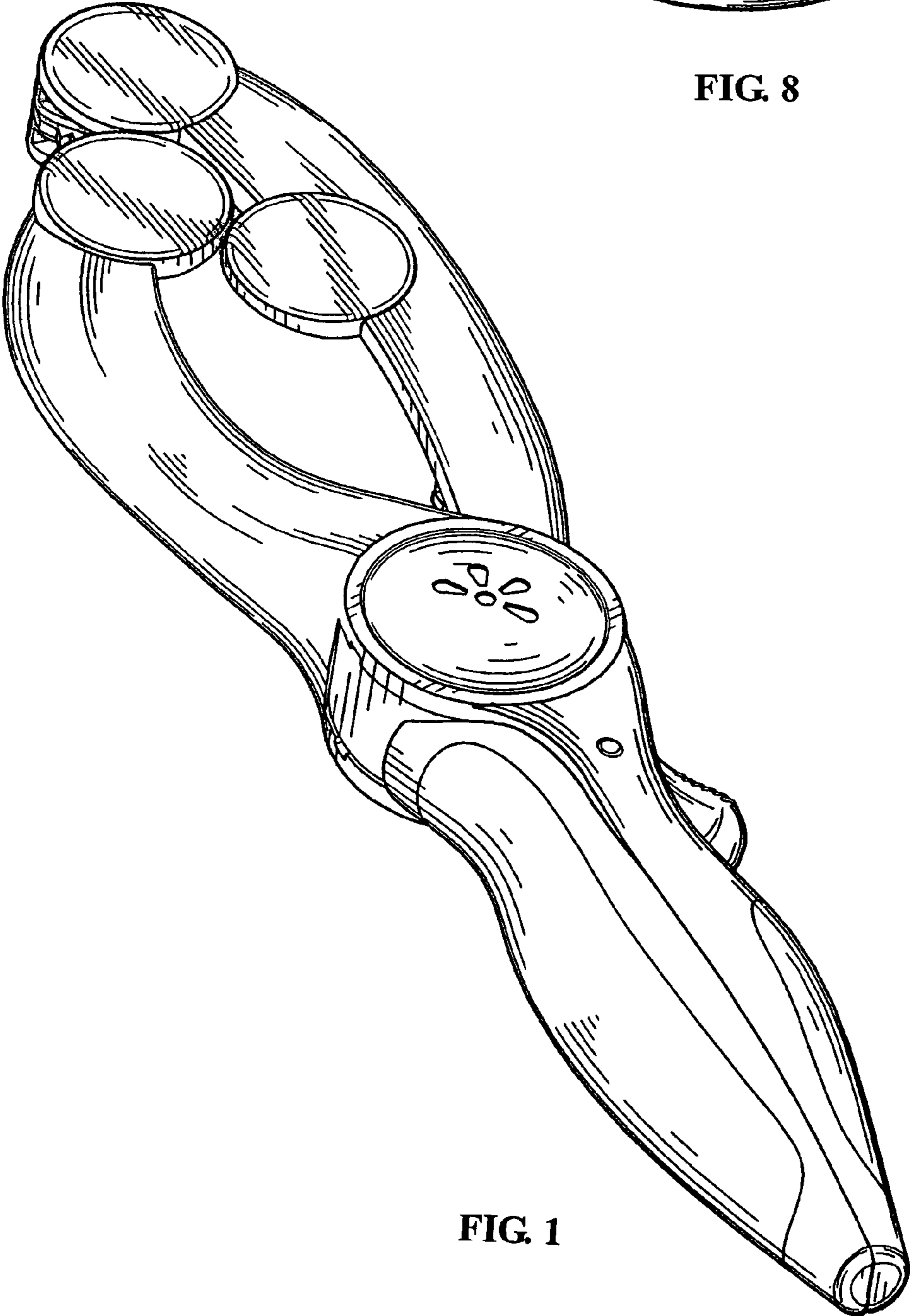

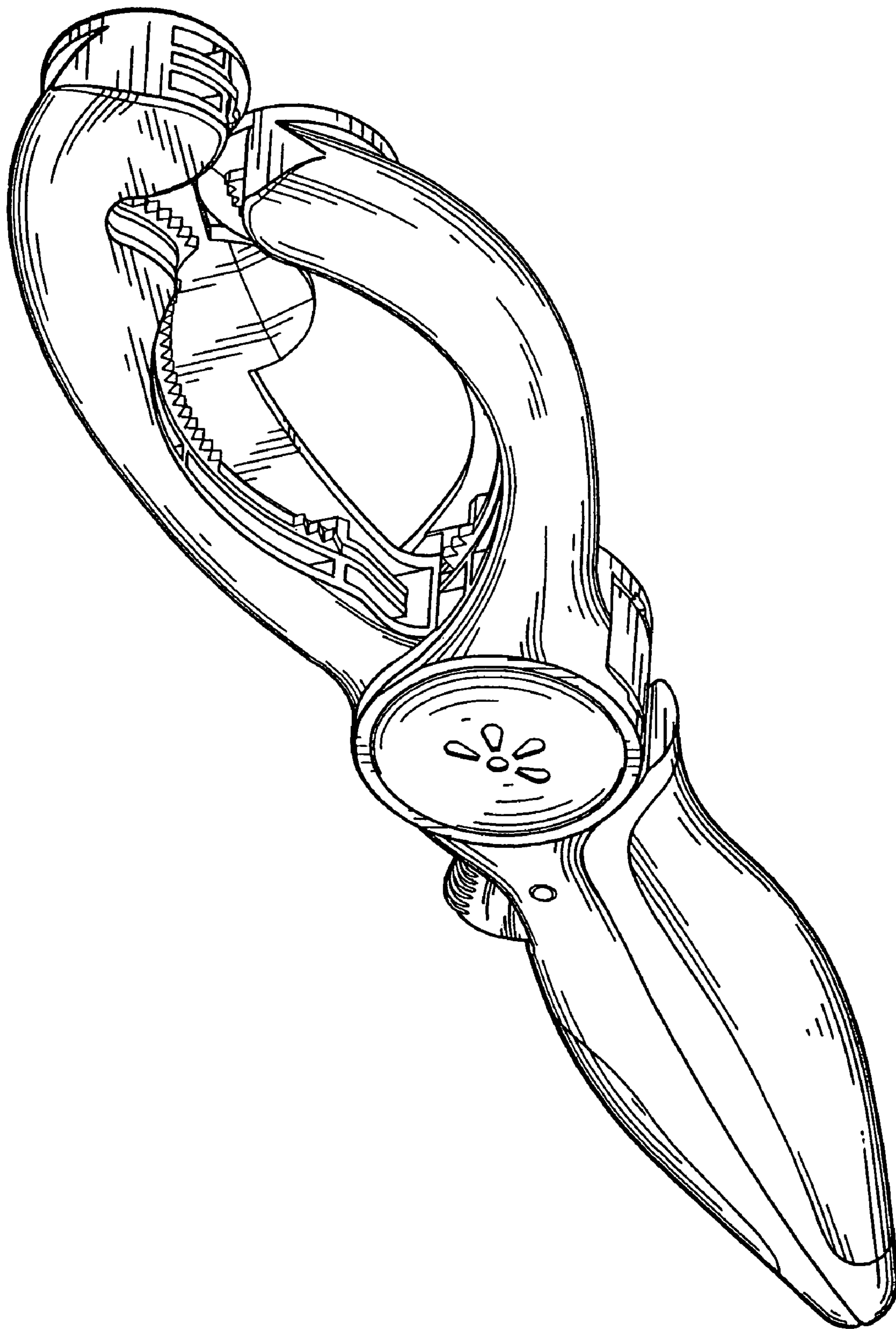

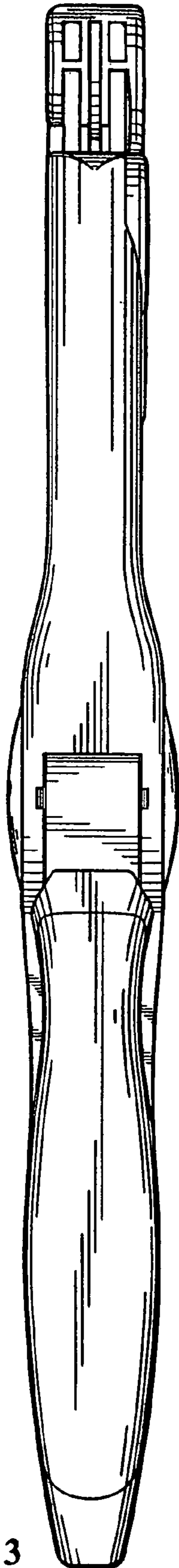

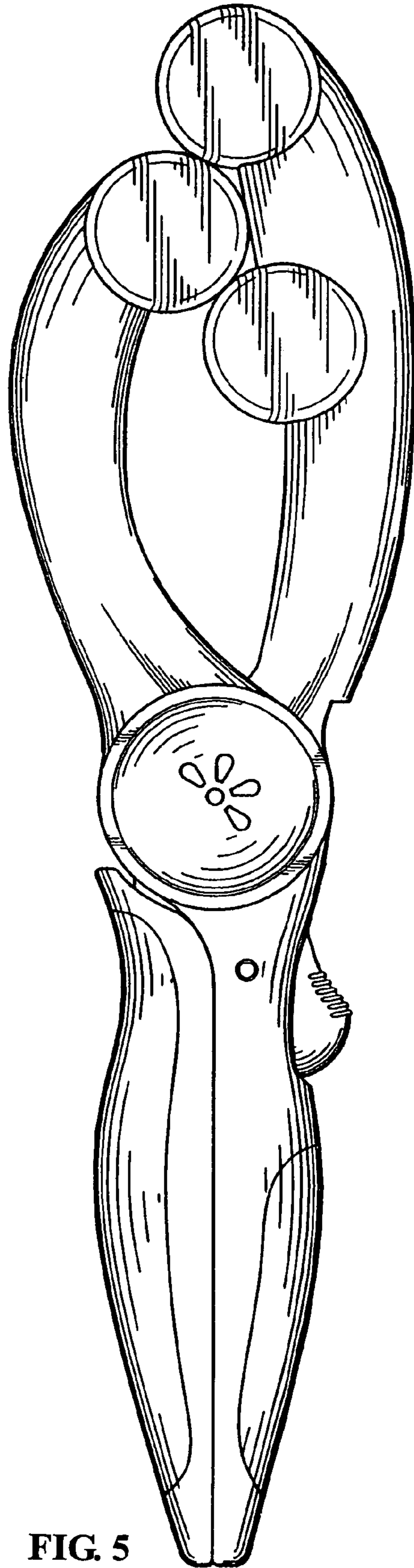

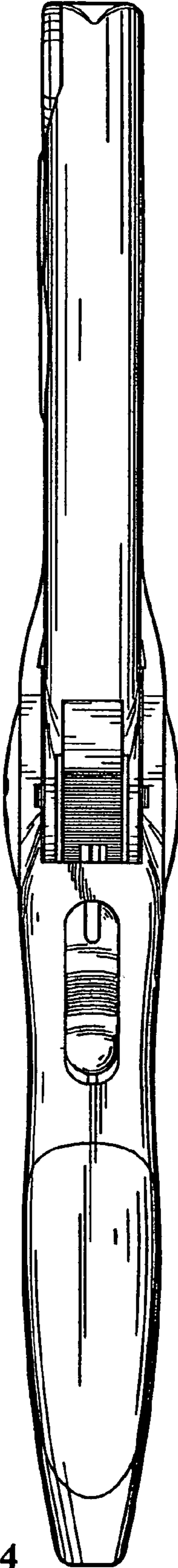

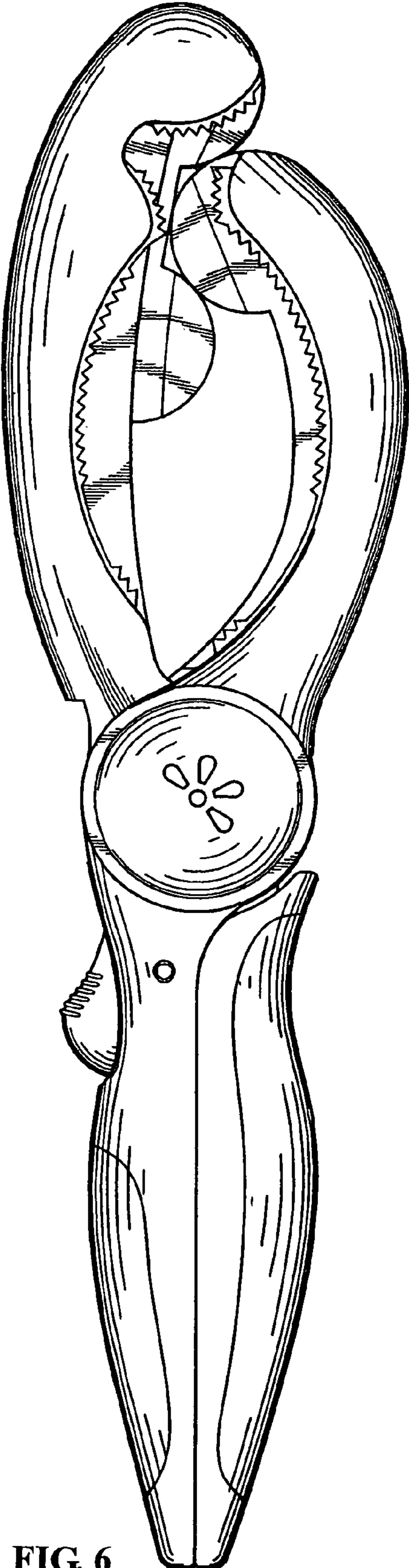

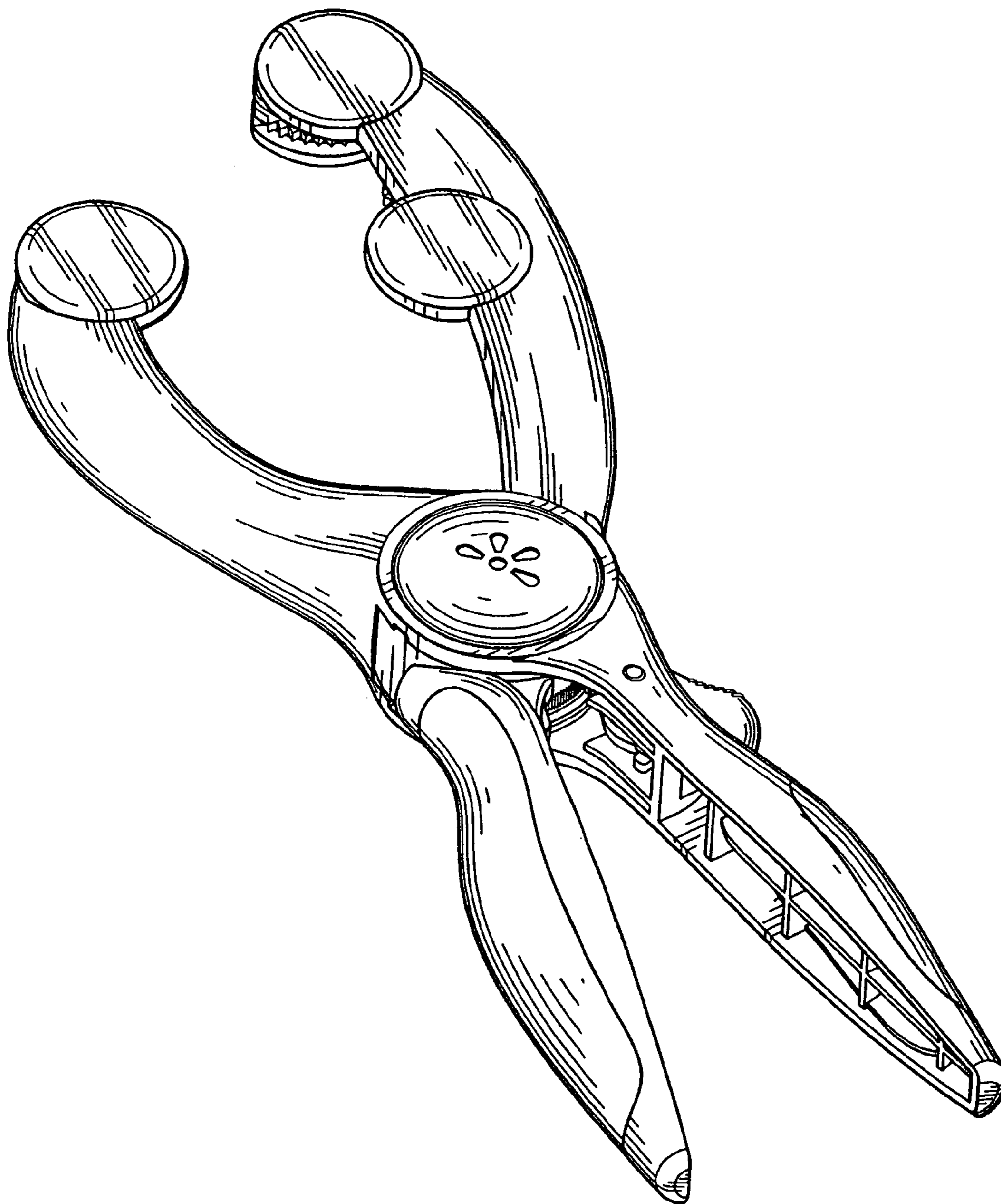

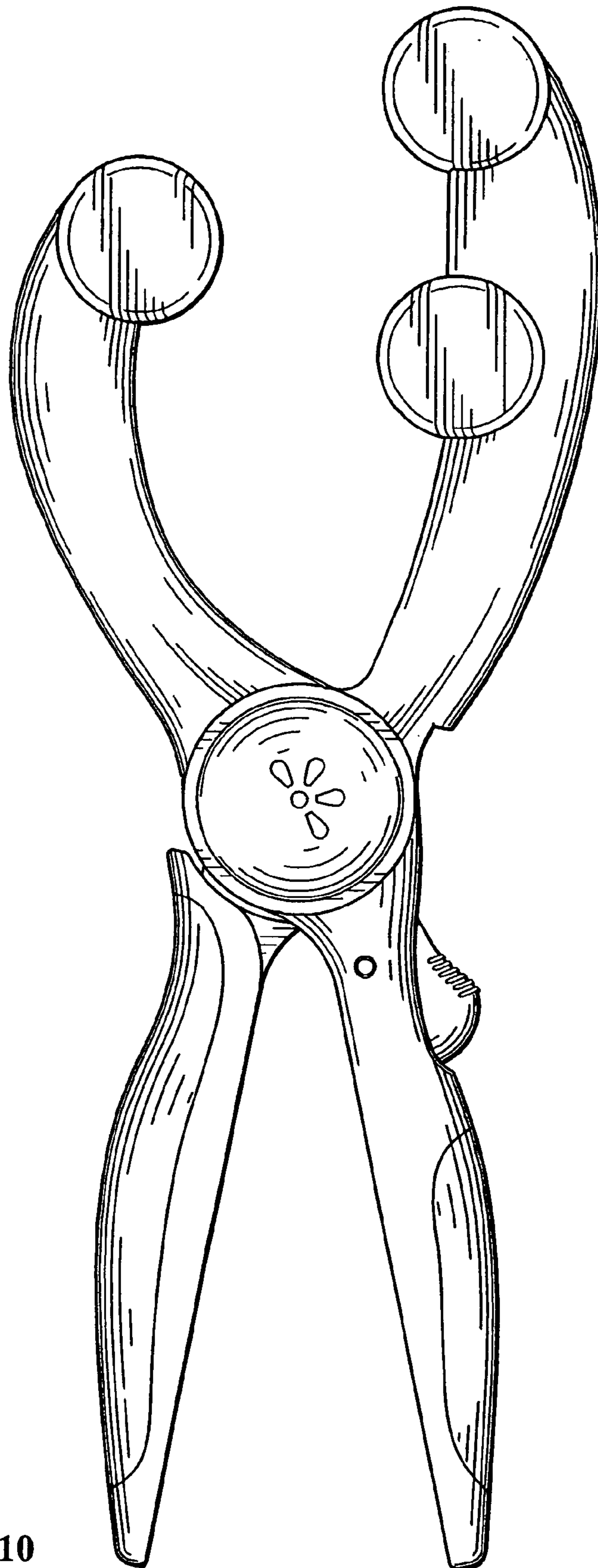
