The ornamental design for a cap for a cosmetic article, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cap of the invention;

FIG. 2 is a front view of the cap of the invention;

FIG. 3 is a back view of the cap of the invention;

FIG. 4 is a side view of the cap of the invention, wherein the opposite side view is a mirror image;

FIG. 5 is a top view of the cap of the invention; and,

FIG. 6 is a perspective view of the cap of the invention shown on a balm applicator body.

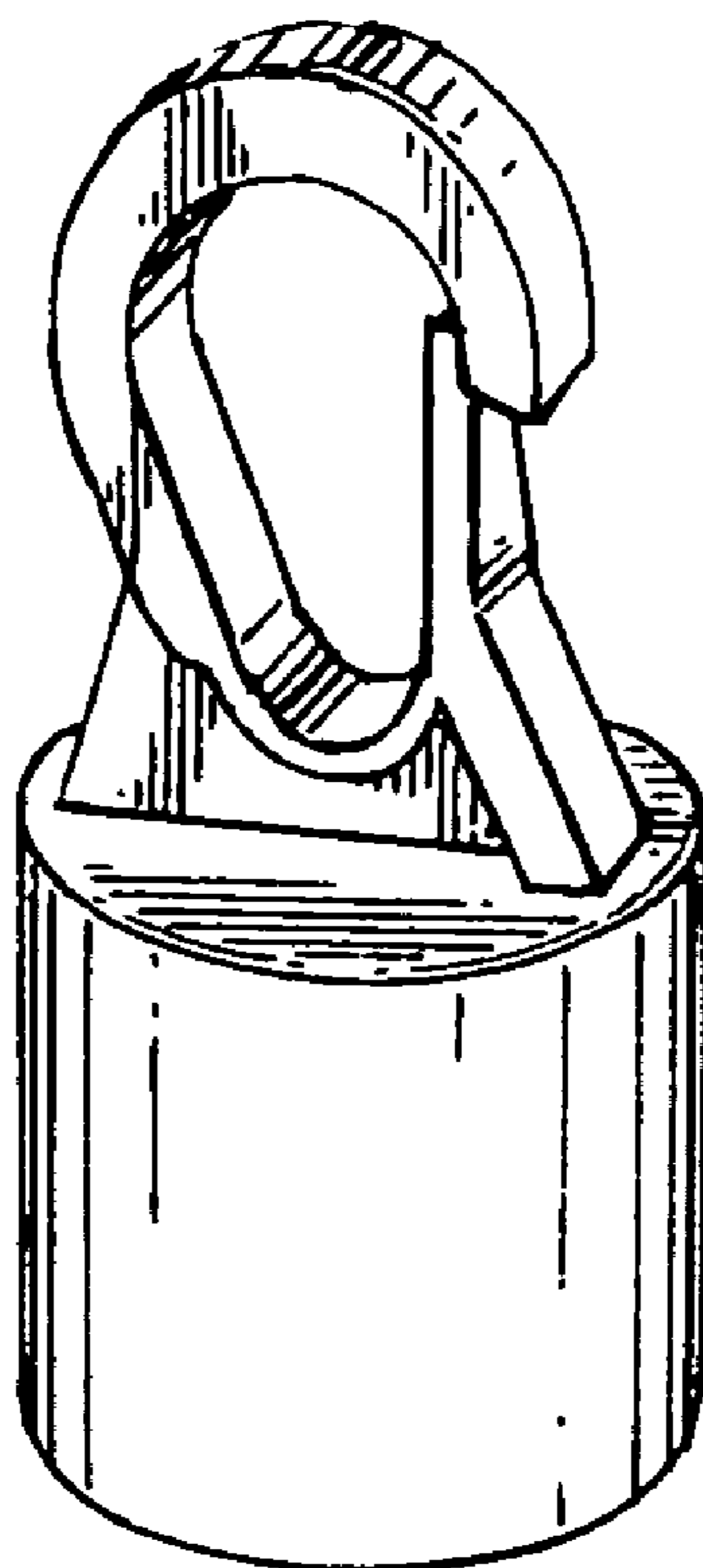

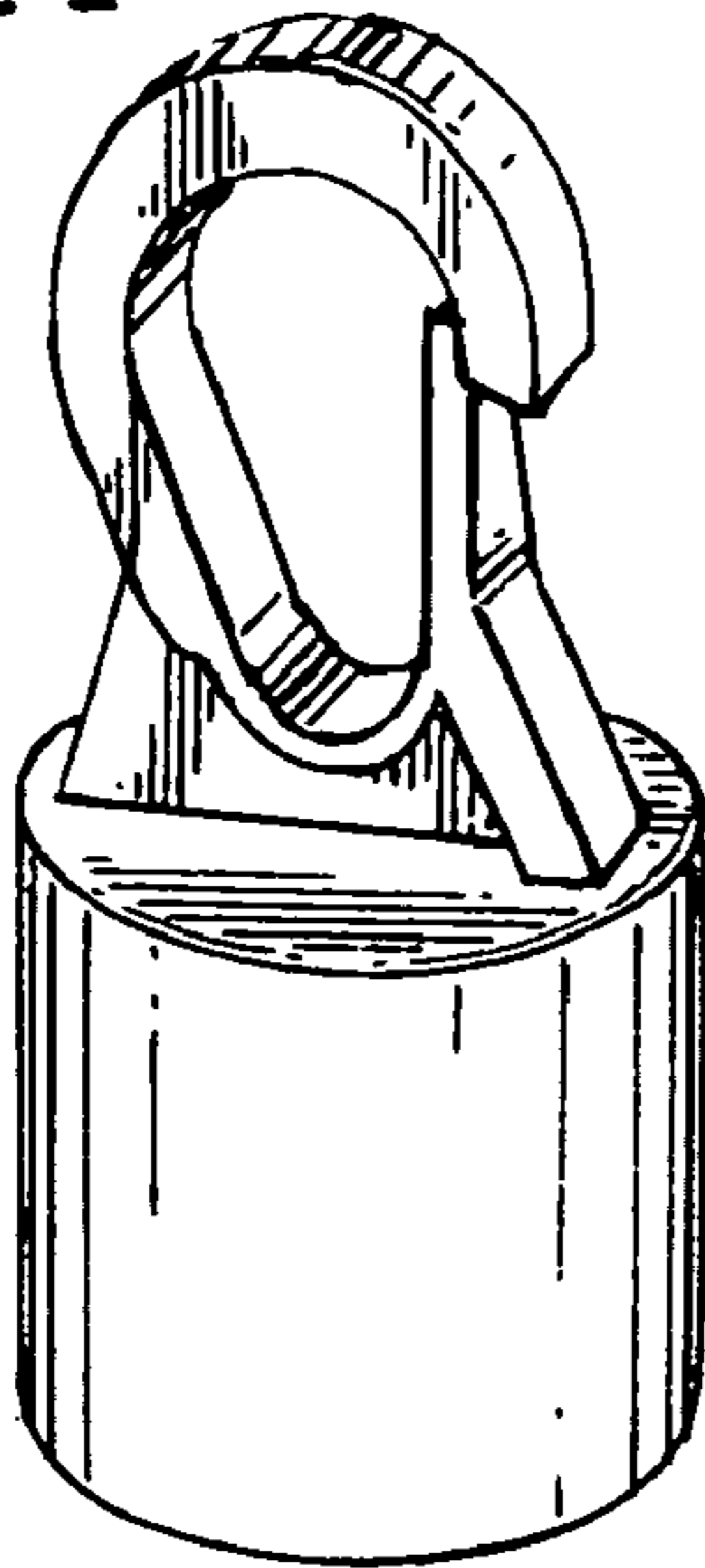

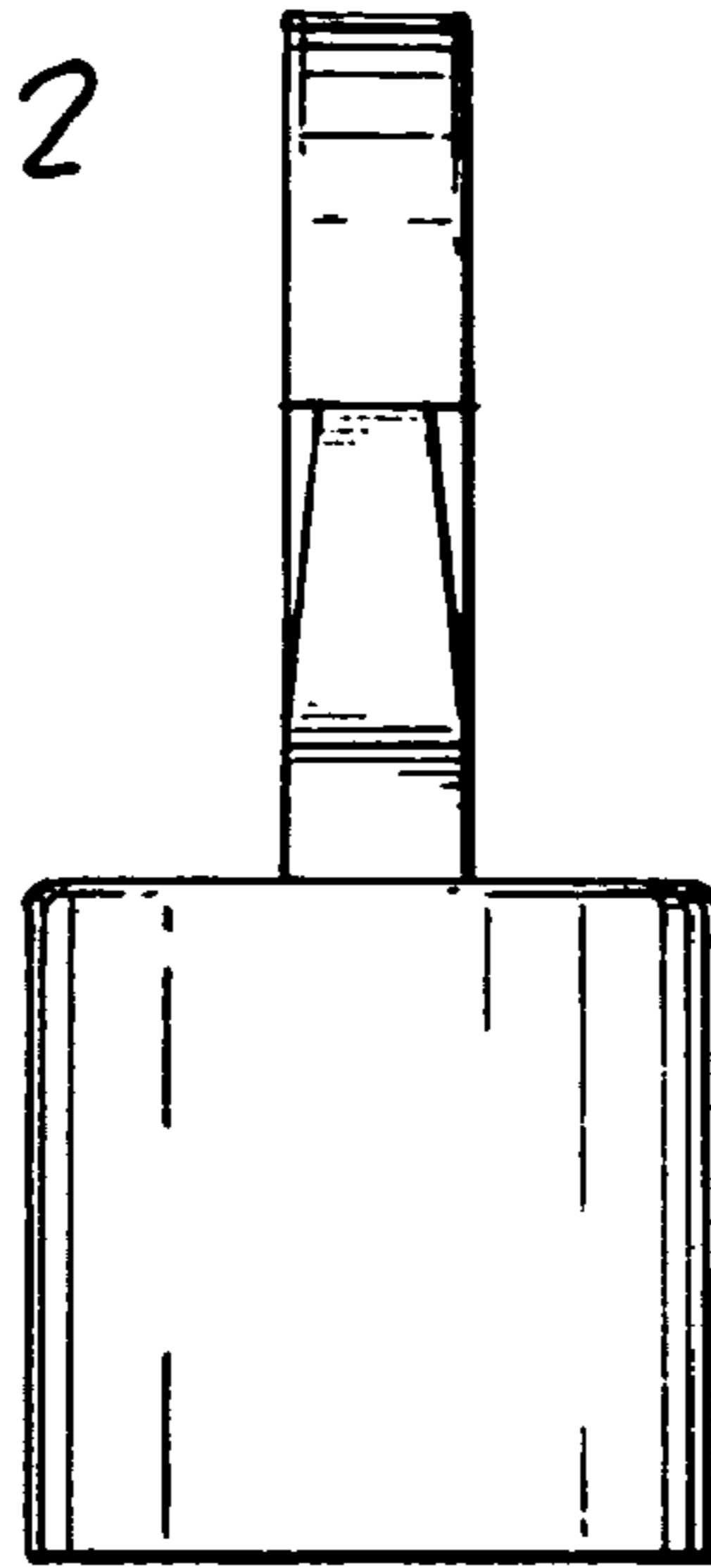

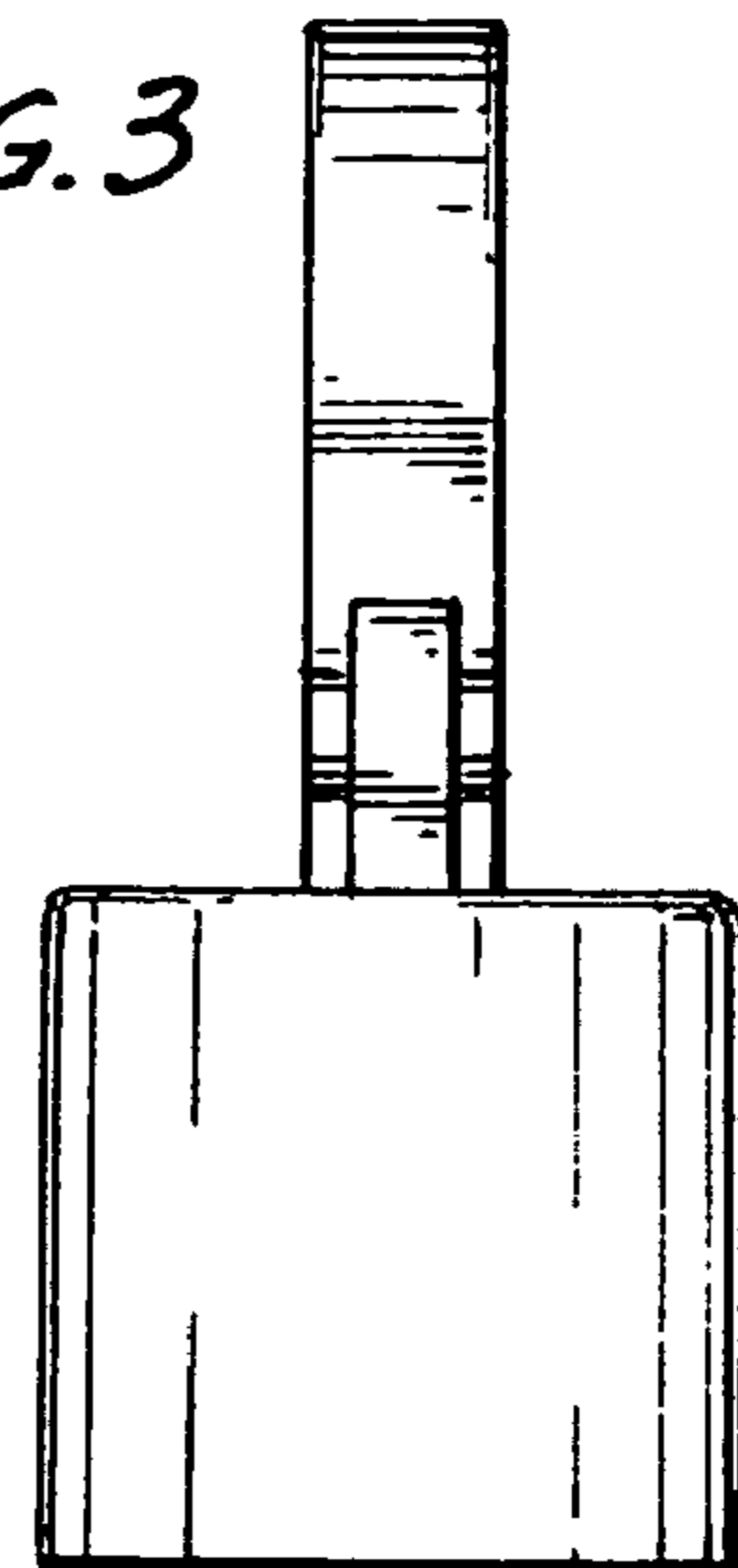

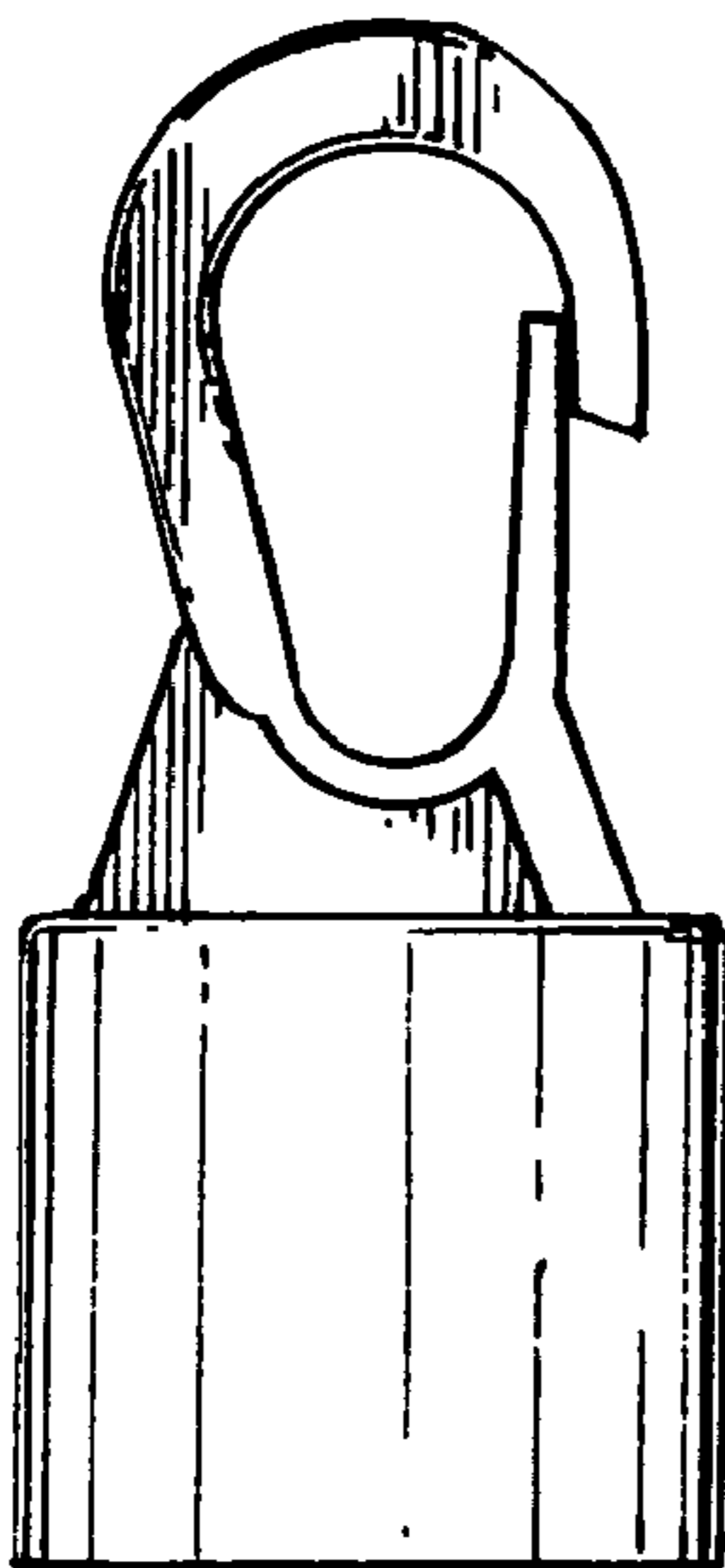

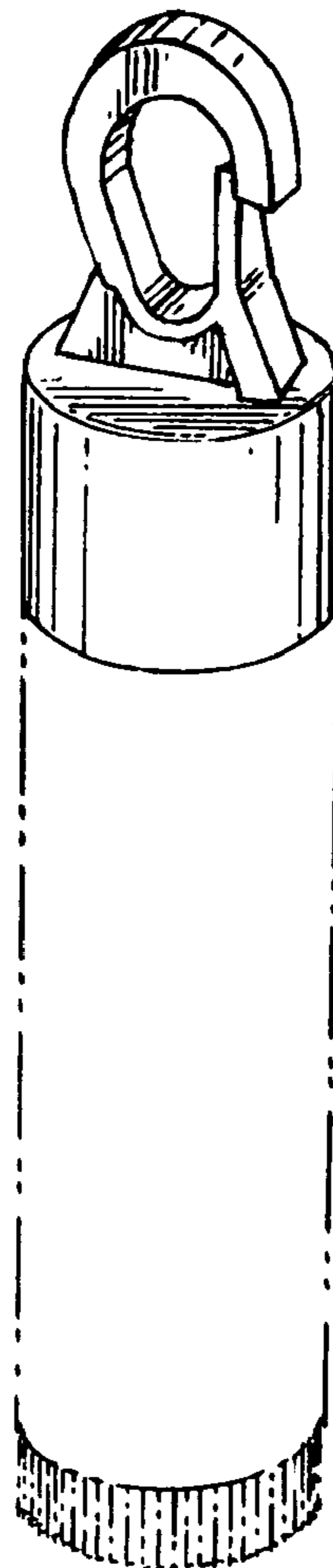
