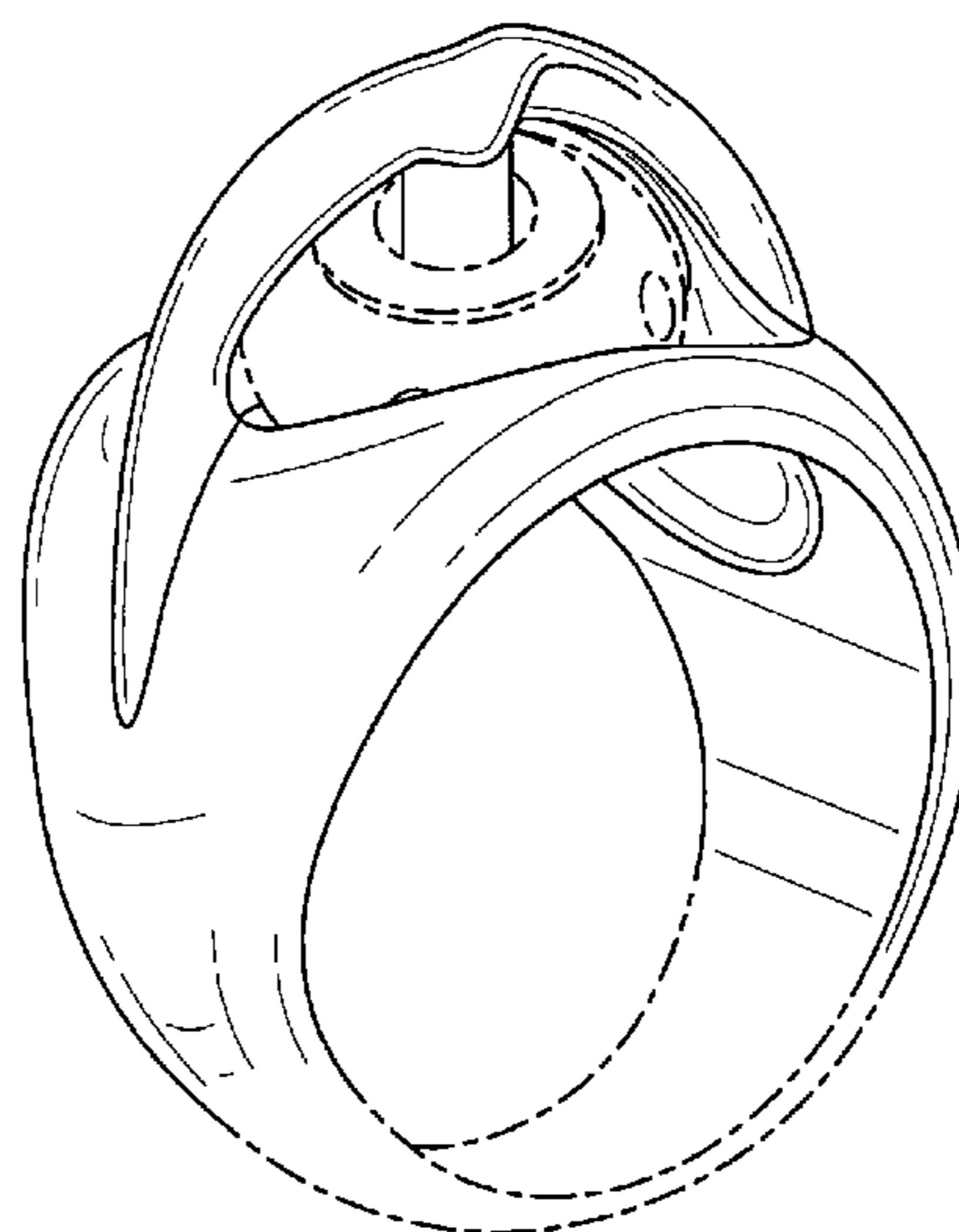
The ornamental design for an interchangeable ornament ring, as shown and described.

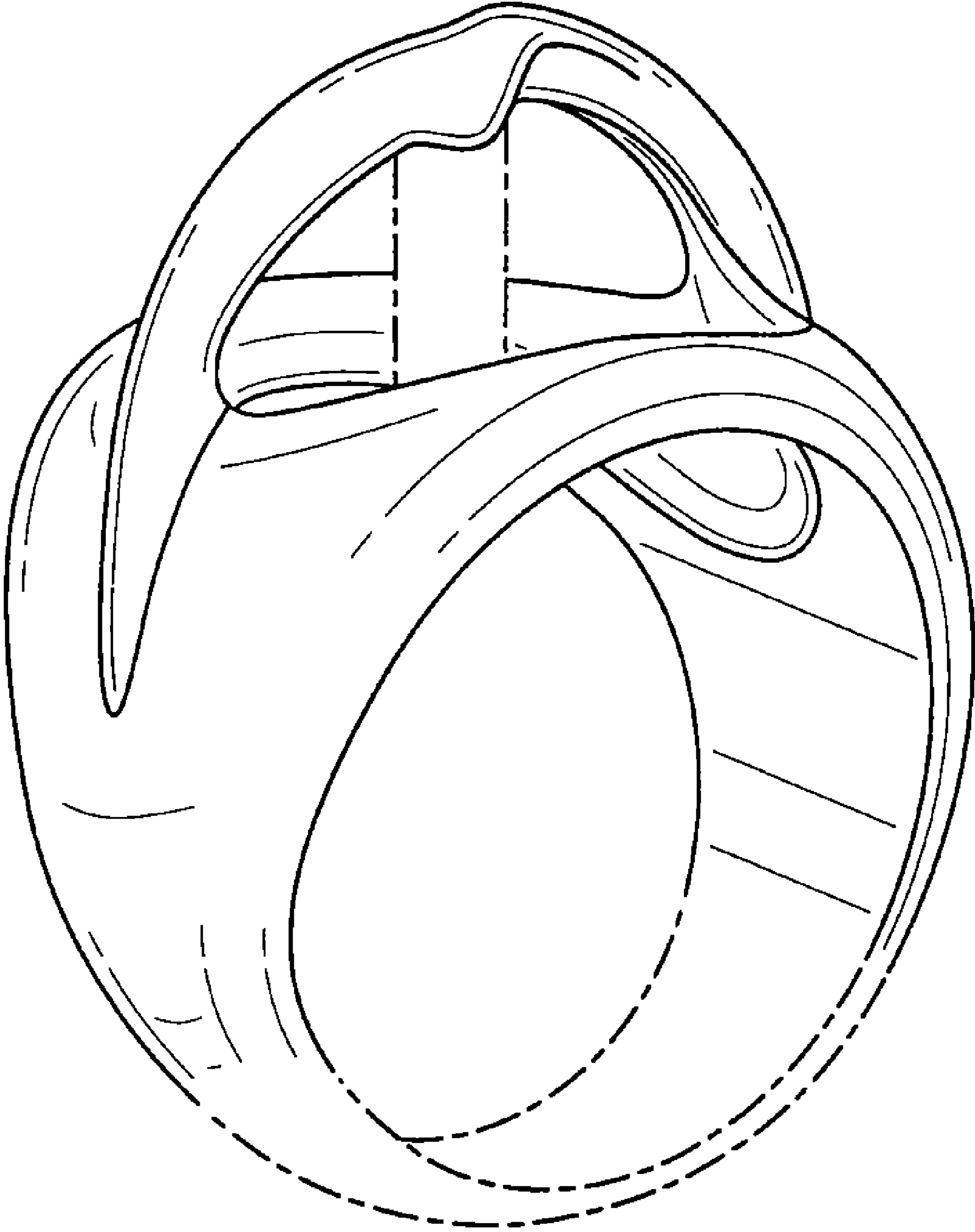

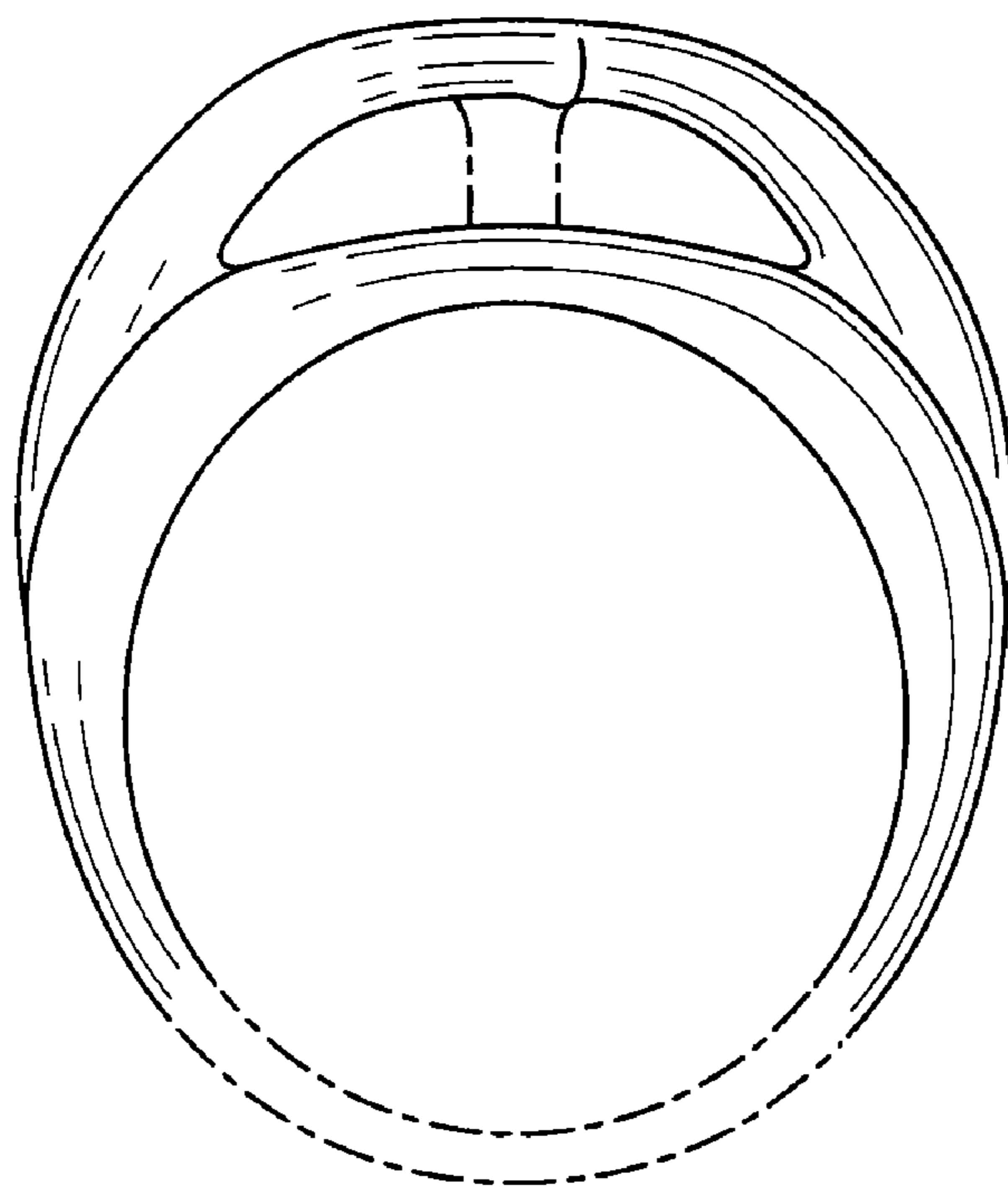

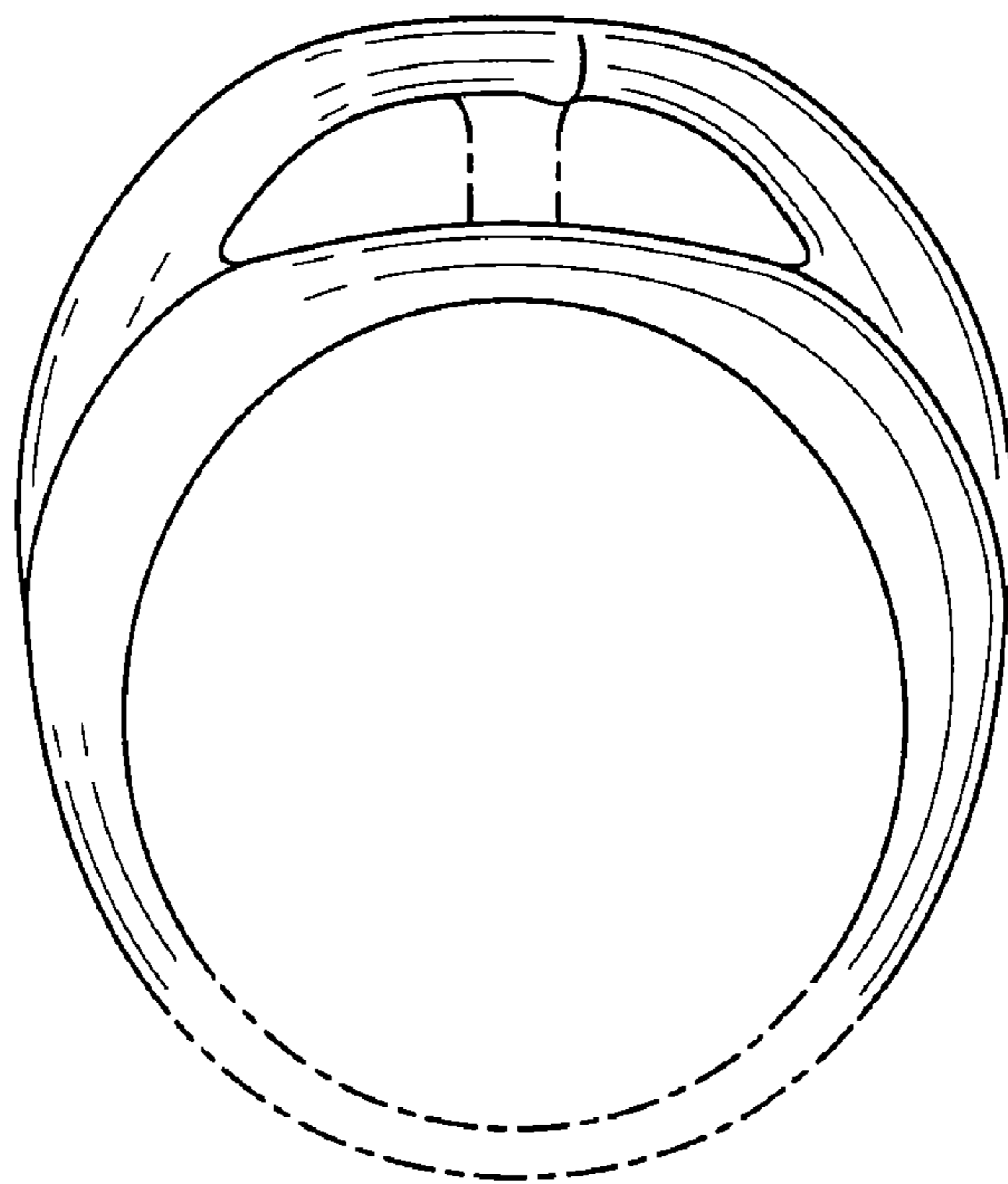

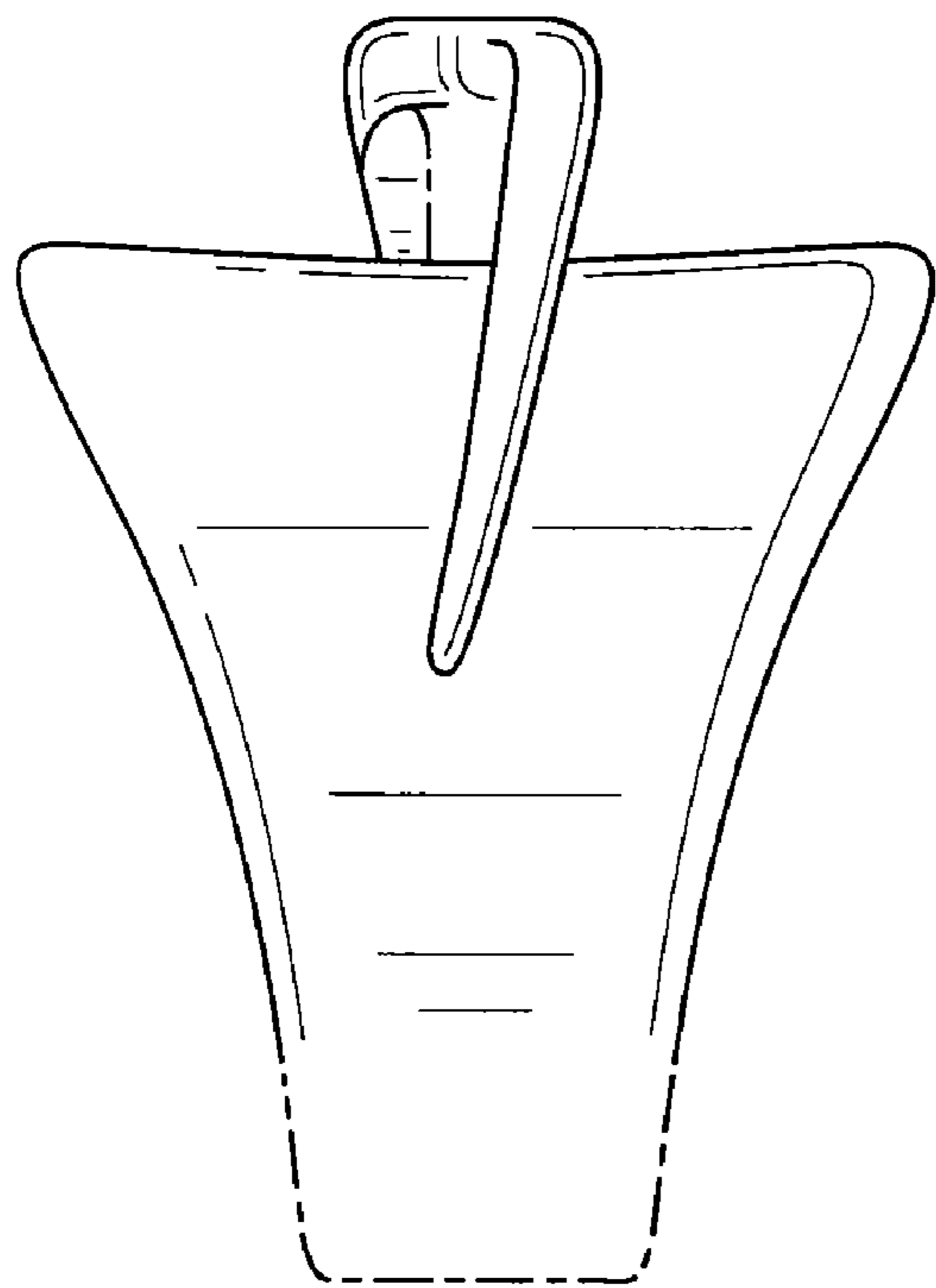

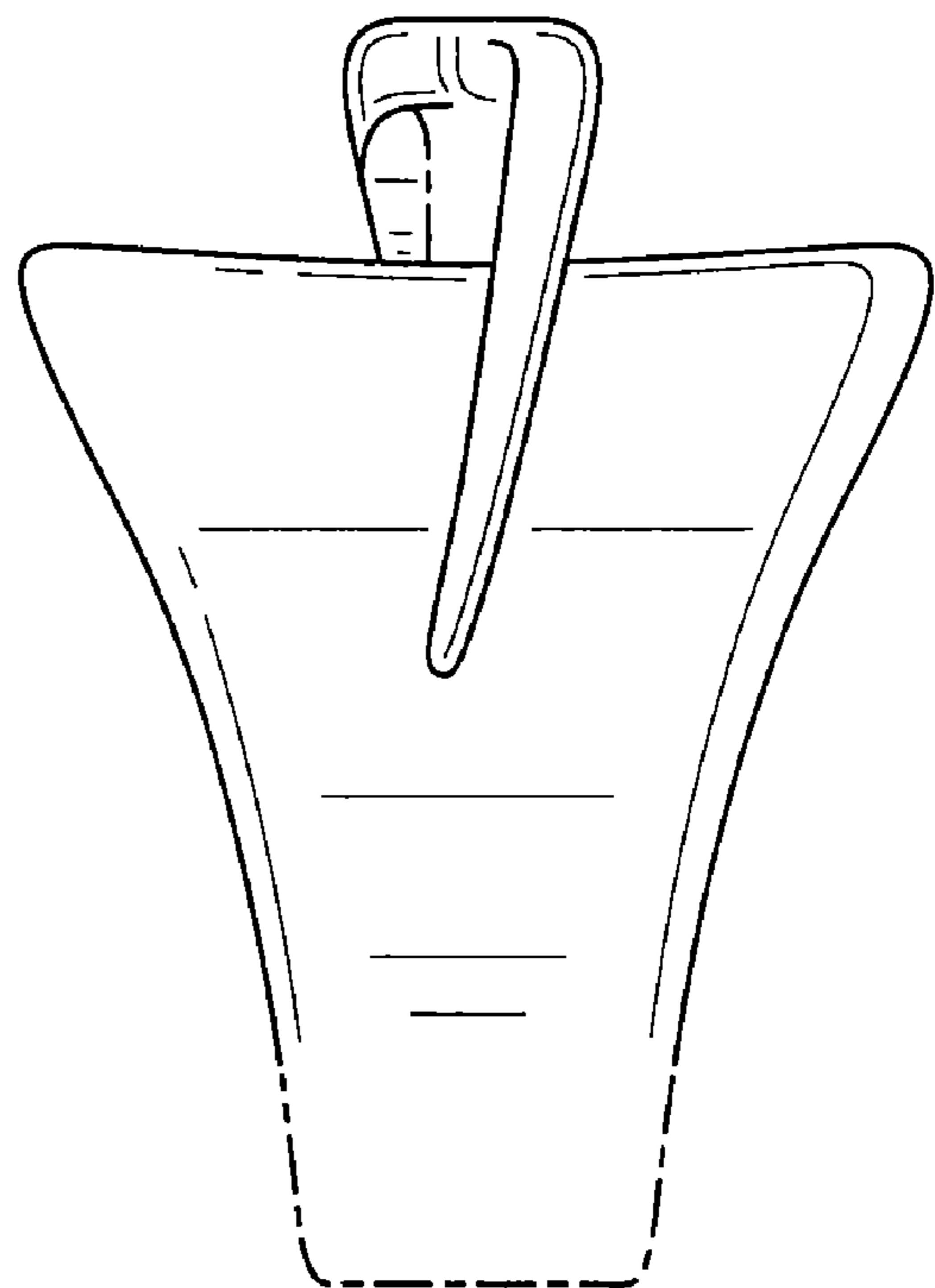

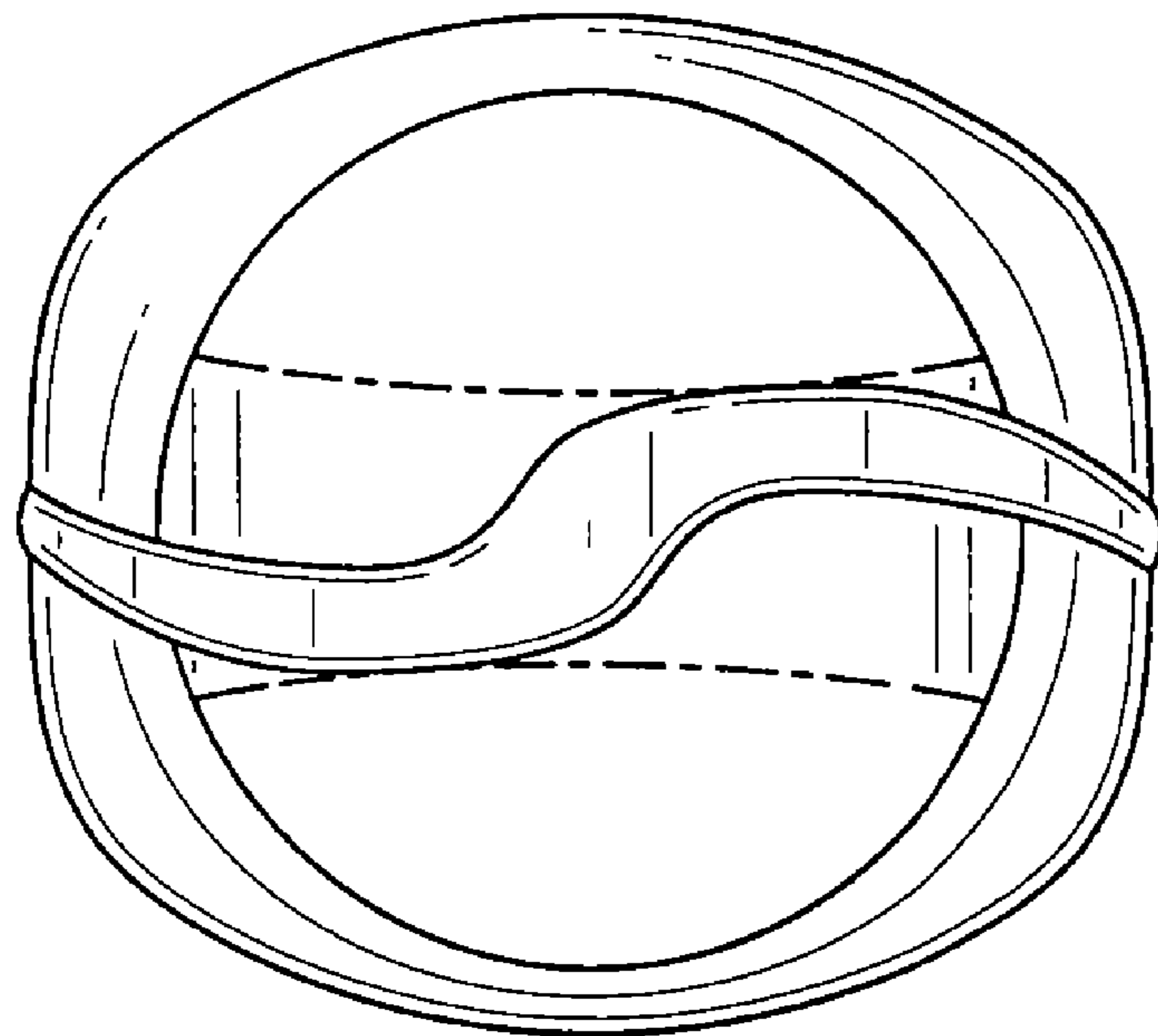

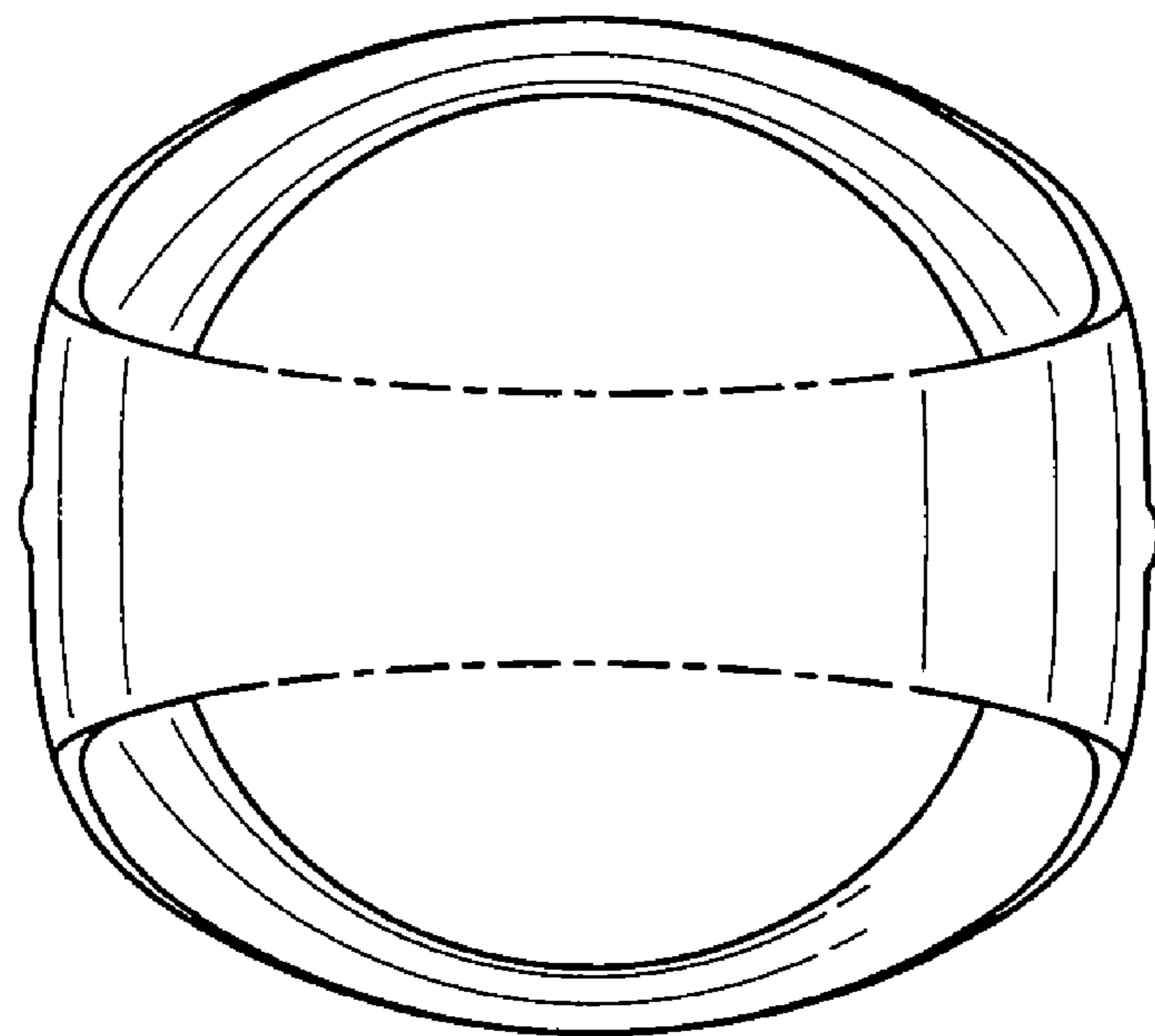

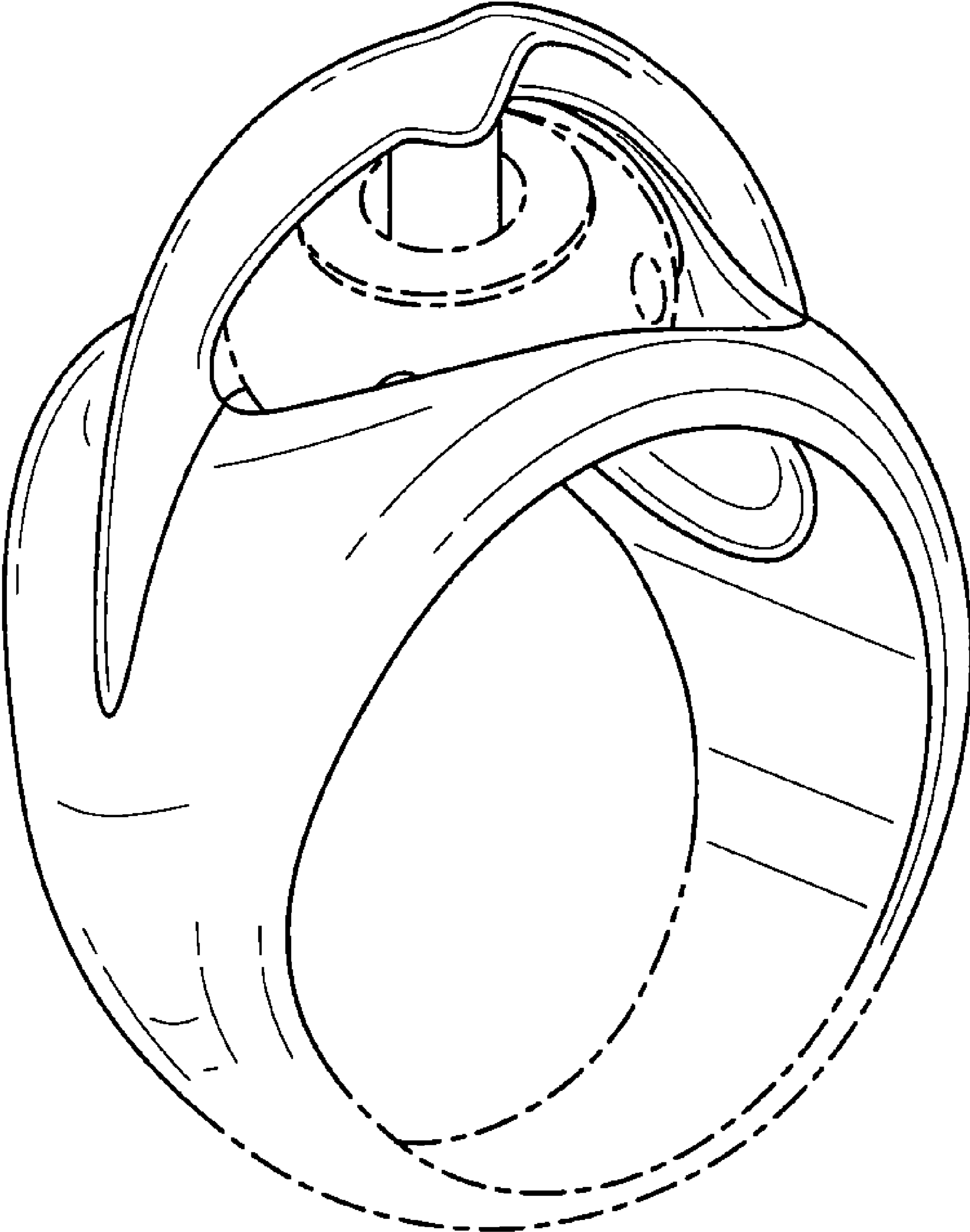
