(57) **CLAIM**

The ornamental design for an electronic component cooling apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an electronic component cooling apparatus showing our new design;

FIG. 2 is a rear elevation view of the cooling apparatus;

FIG. 3 is a right side elevation view of the cooling apparatus;

FIG. 4 is a left side elevation view of the cooling apparatus;

FIG. 5 is a top plan view of the cooling apparatus;

FIG. 6 is a bottom plan view of the cooling apparatus;

FIG. 7 is a top plan reference view of the cooling apparatus taken along line 8—8 in FIG. 7;

FIG. 8 is a longitudinal cross sectional view of the cooling apparatus; and,

FIG. 9 is a perspective view of the cooling apparatus.

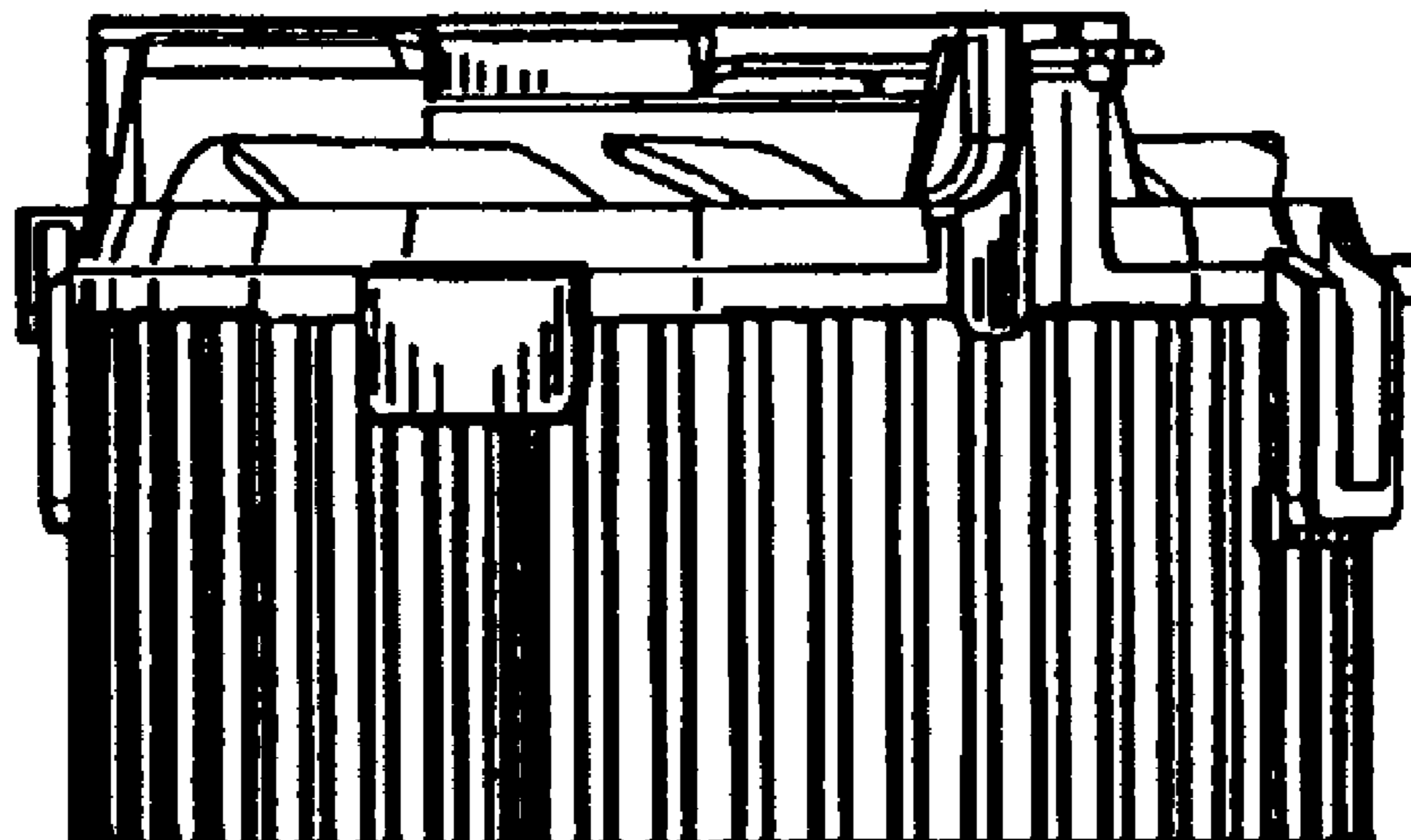

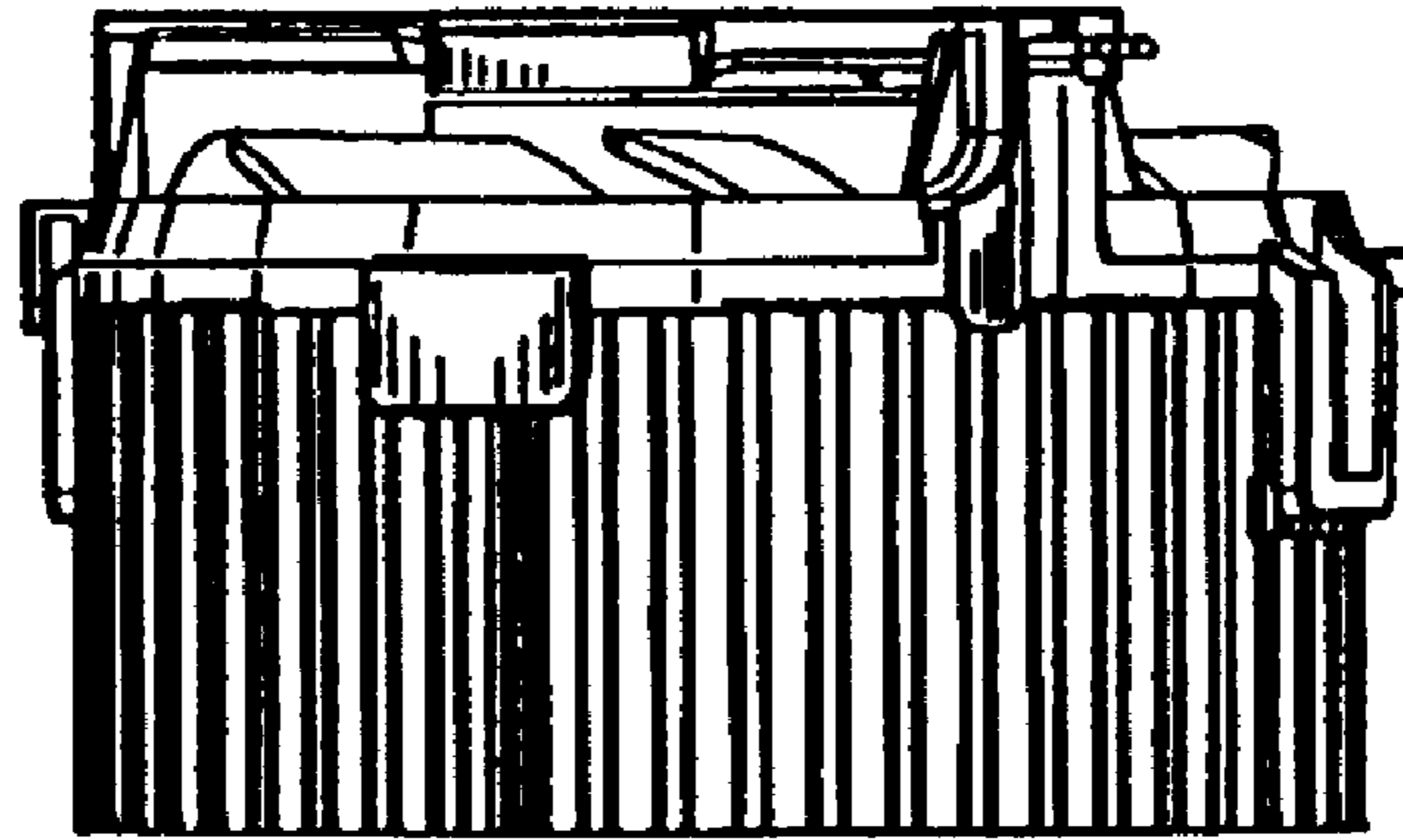

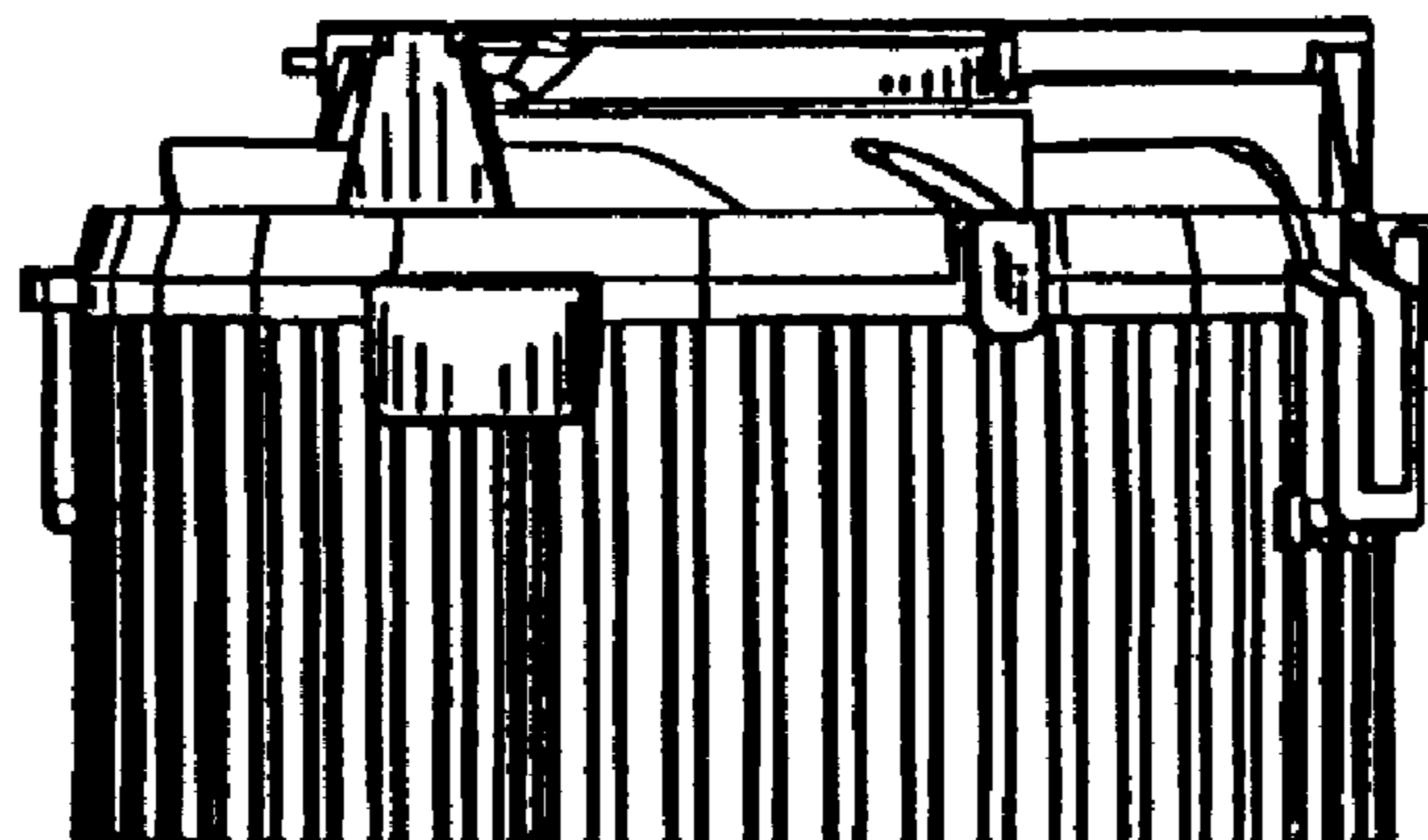

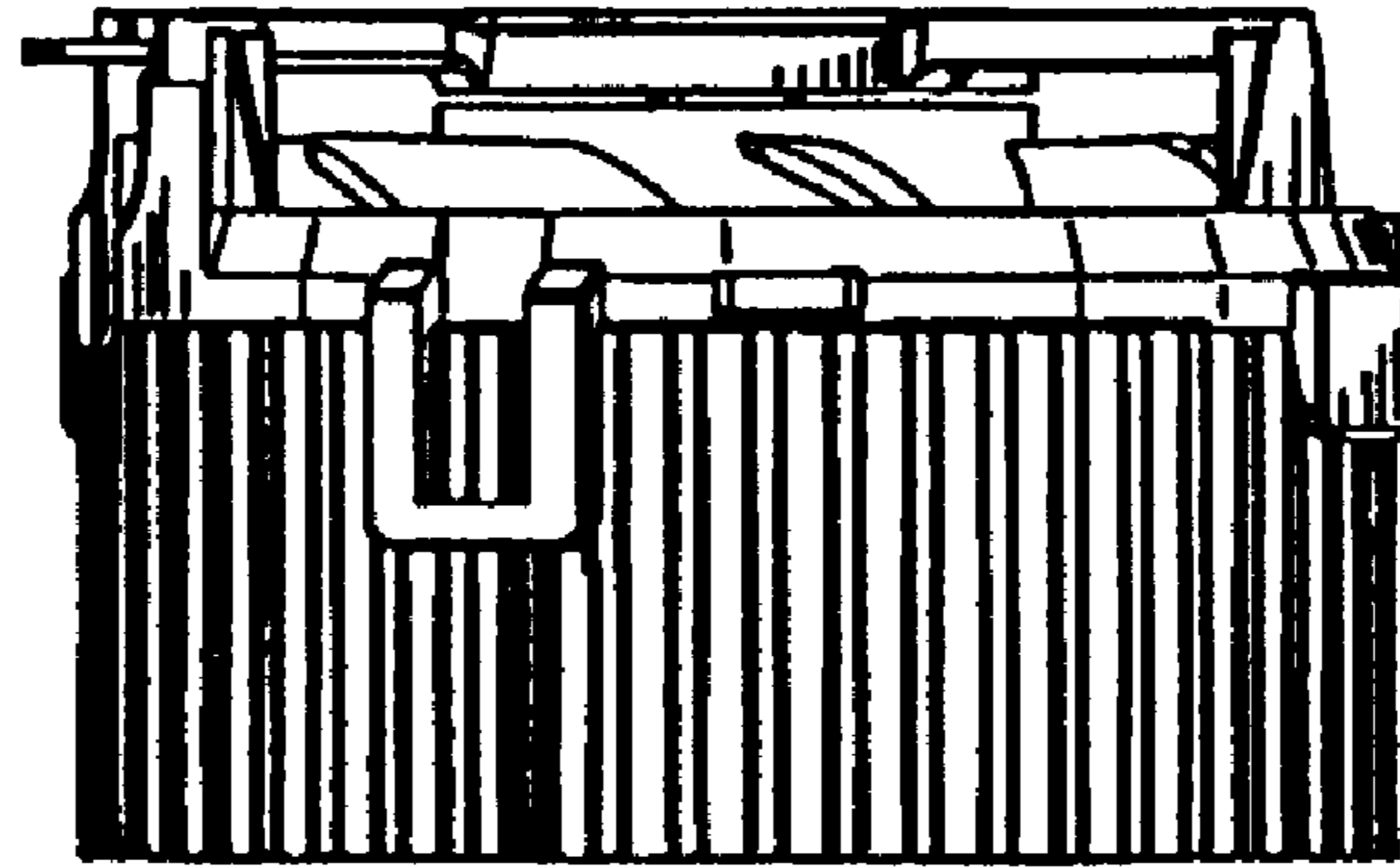

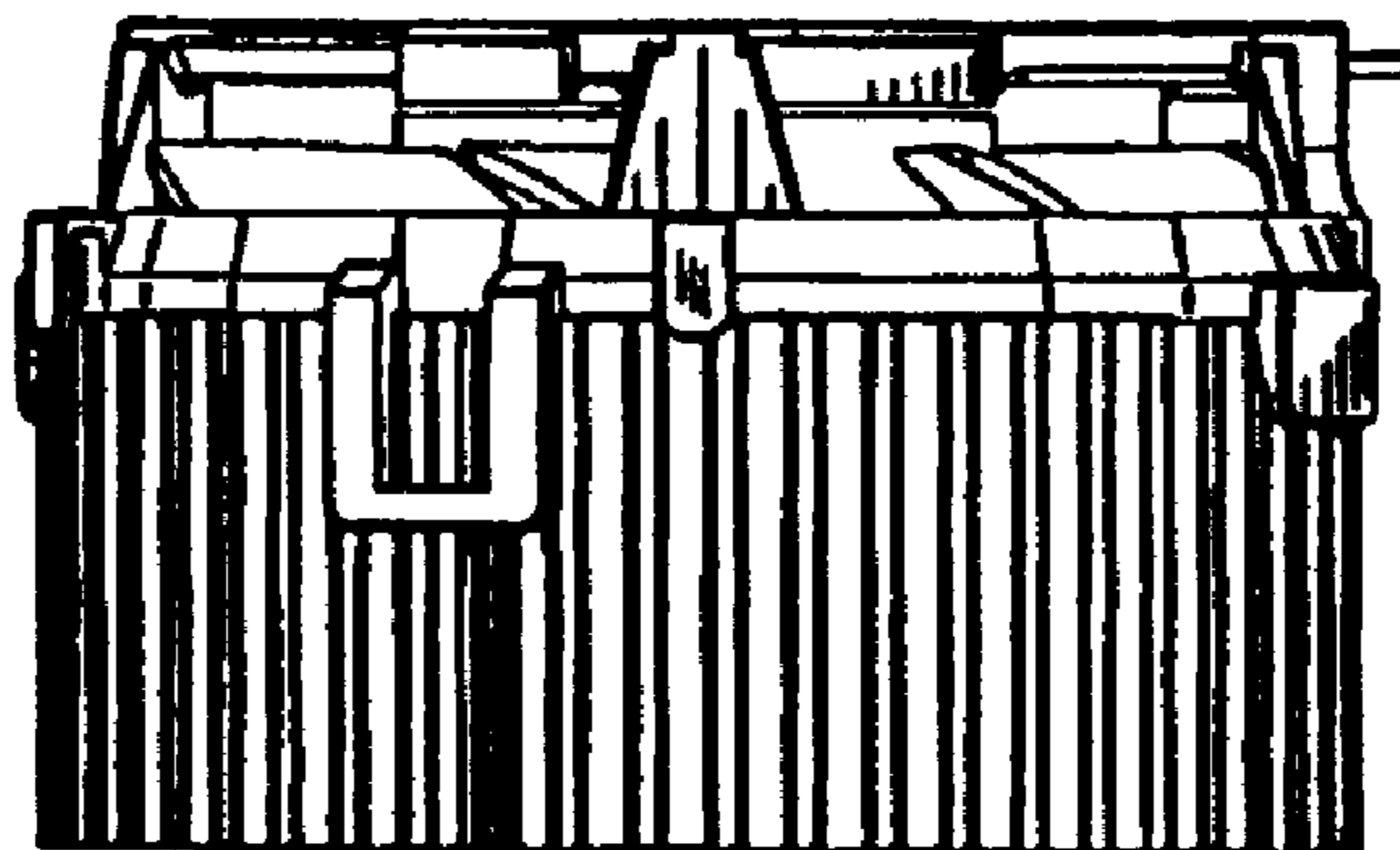

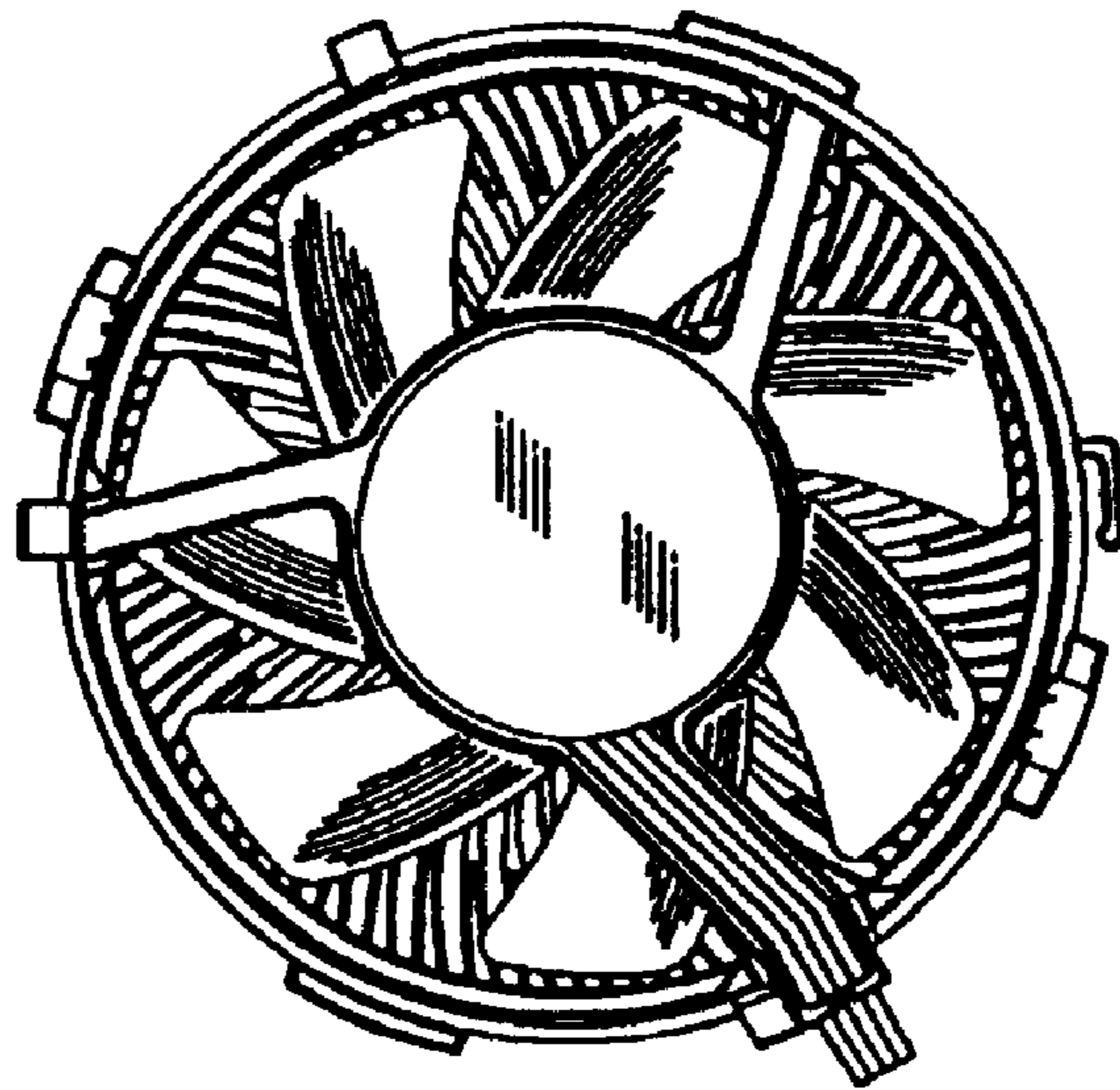

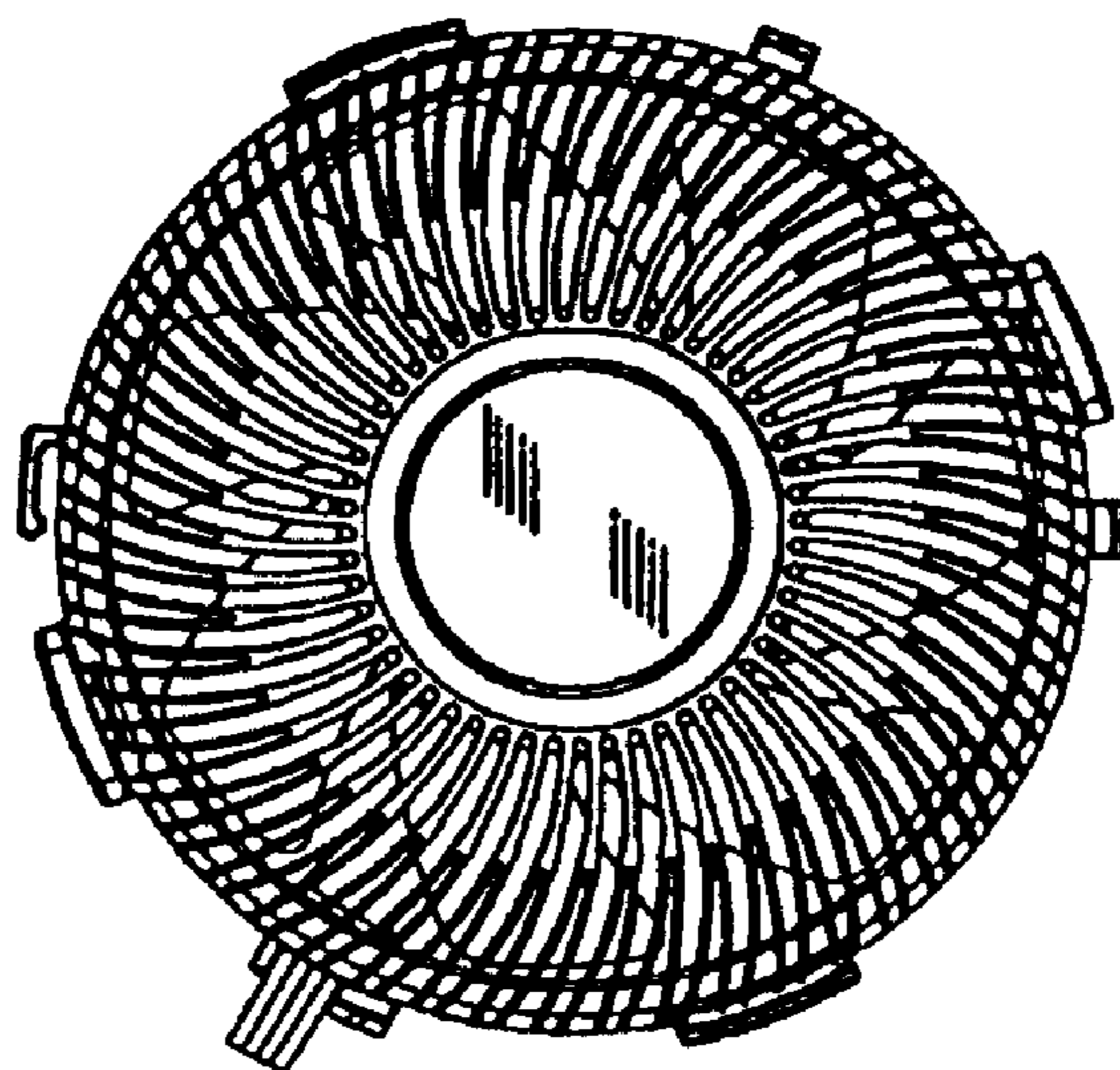

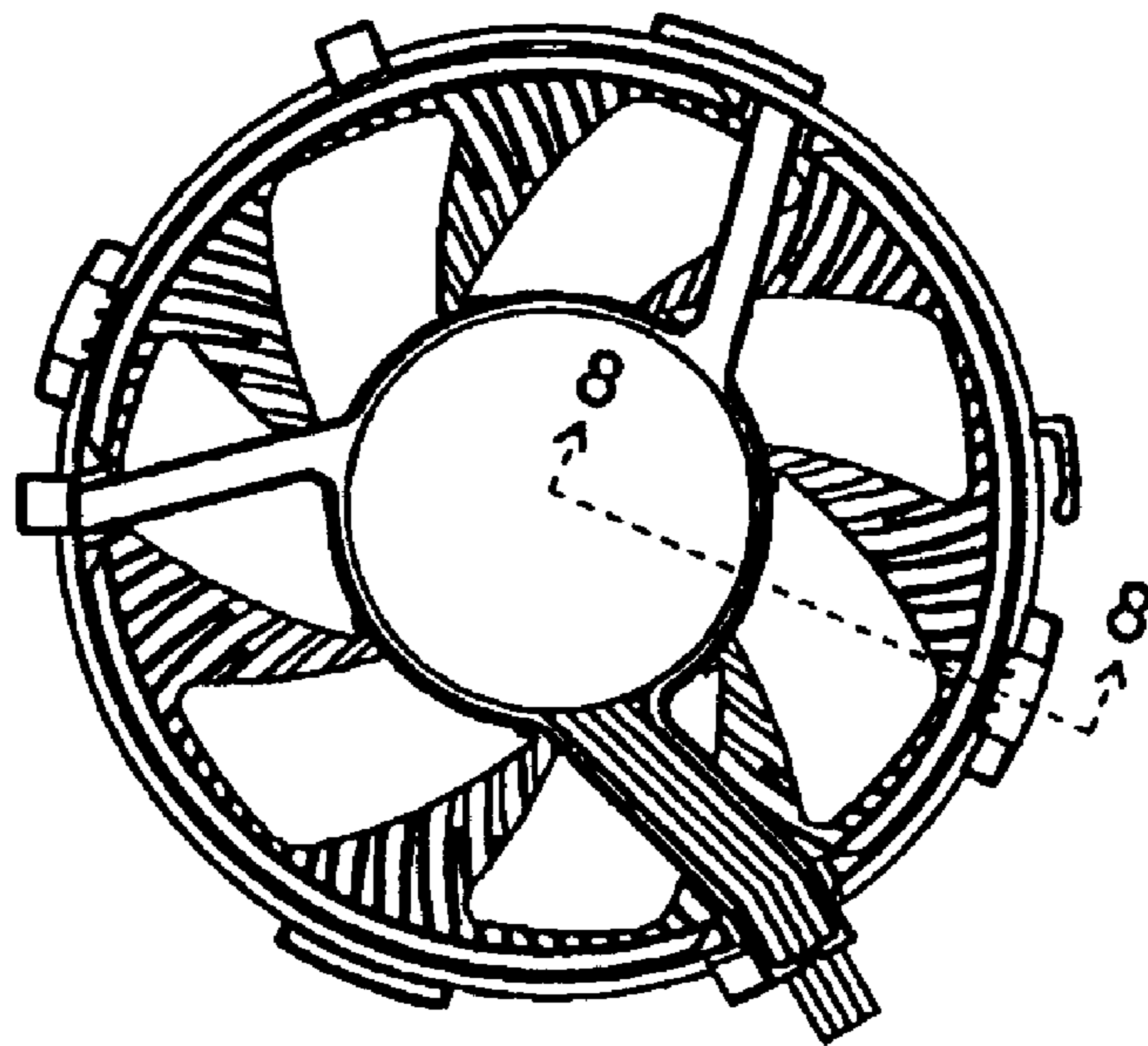

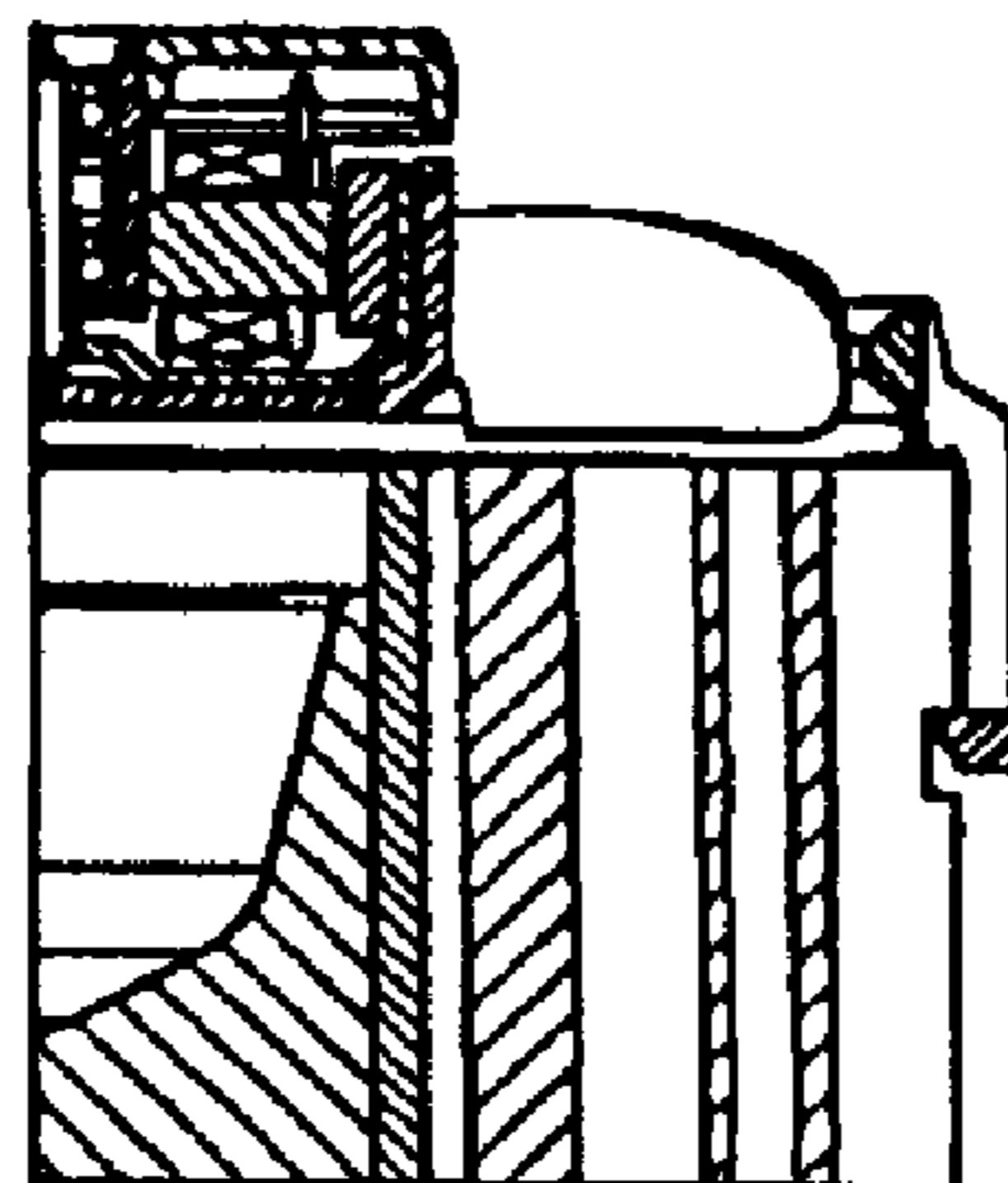
