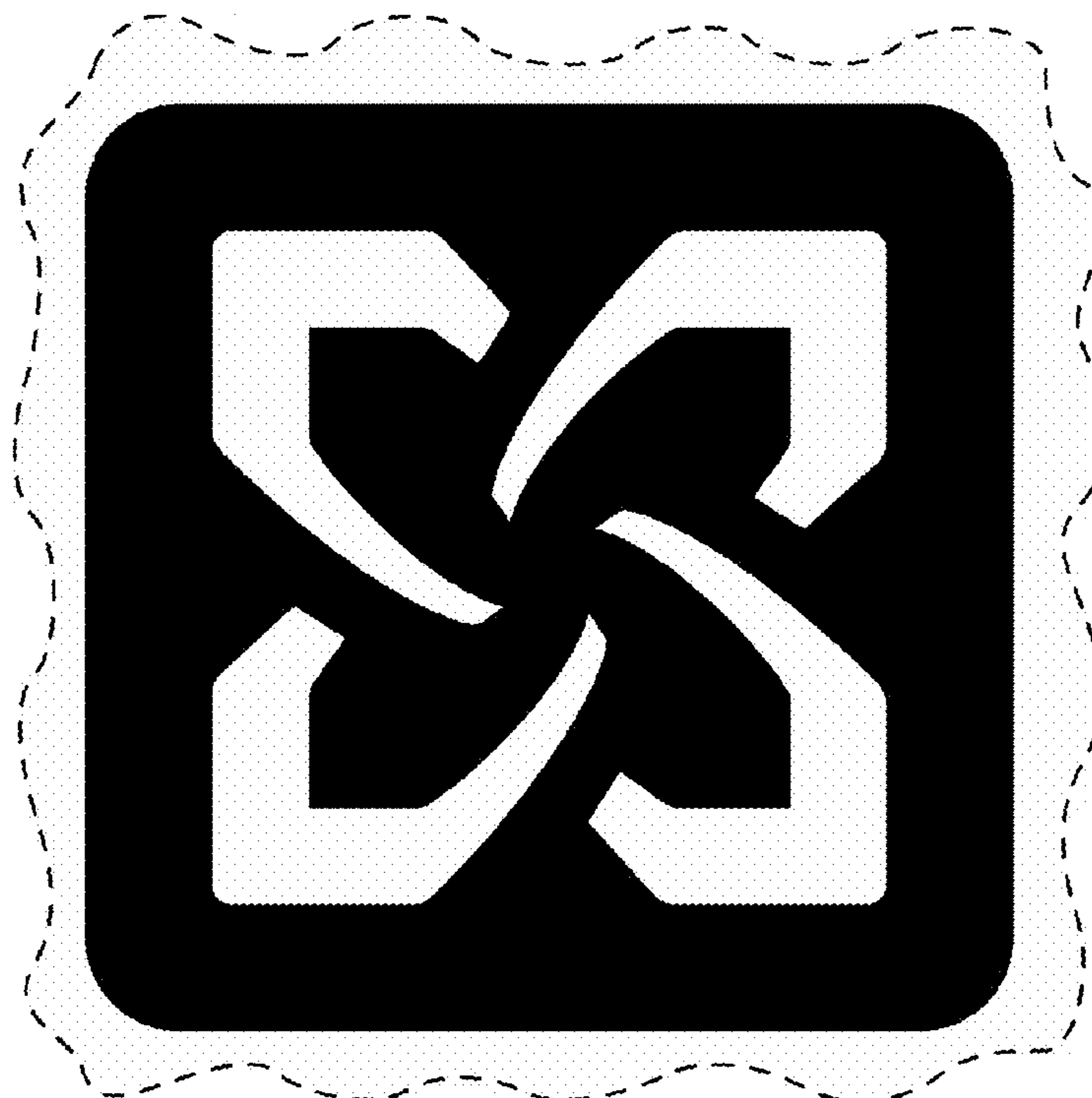
The ornamental design for an icon for a display screen or packaging, as shown and described.

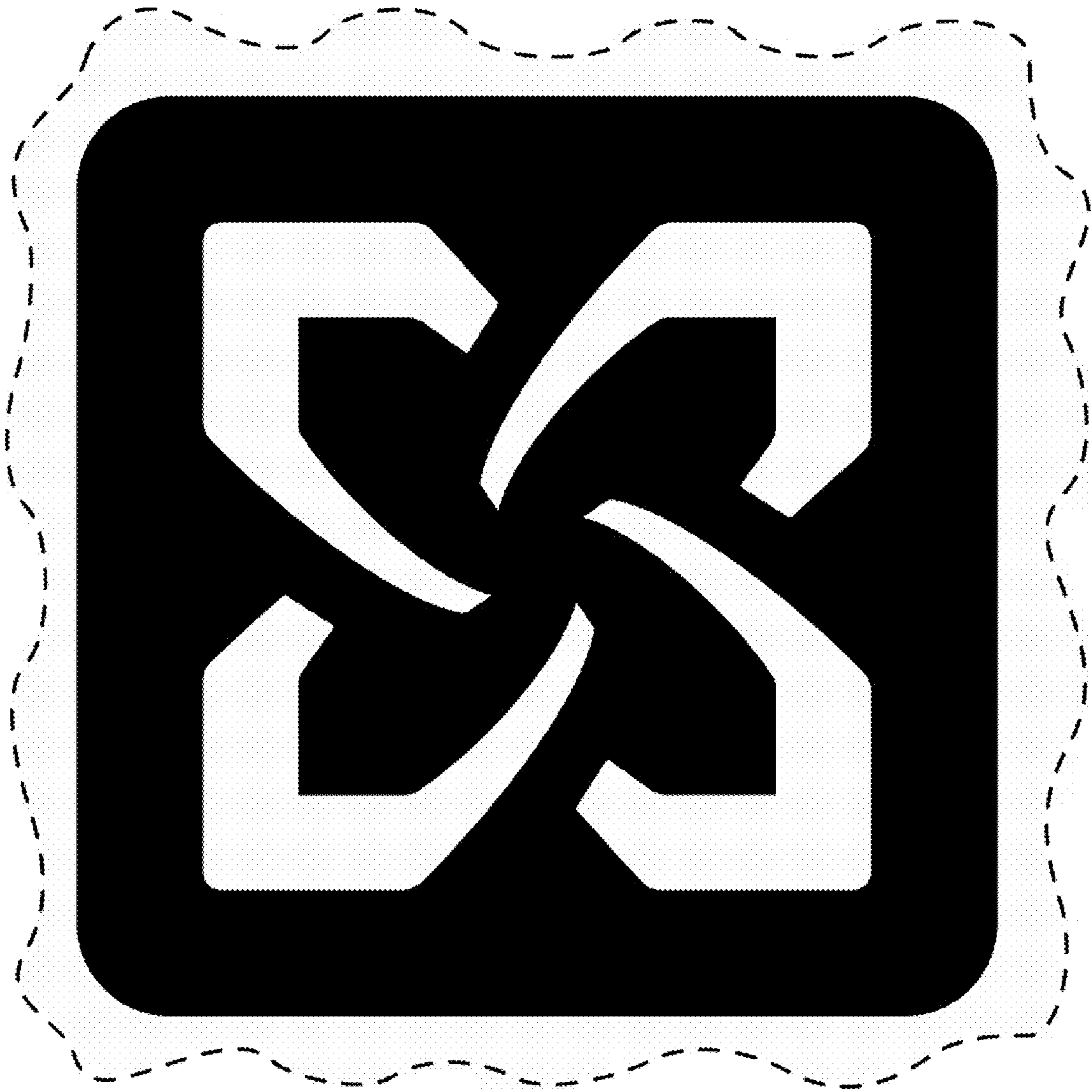
DESCRIPTION
