The ornamental design for a computer generated image for a display panel or screen, as shown and described.

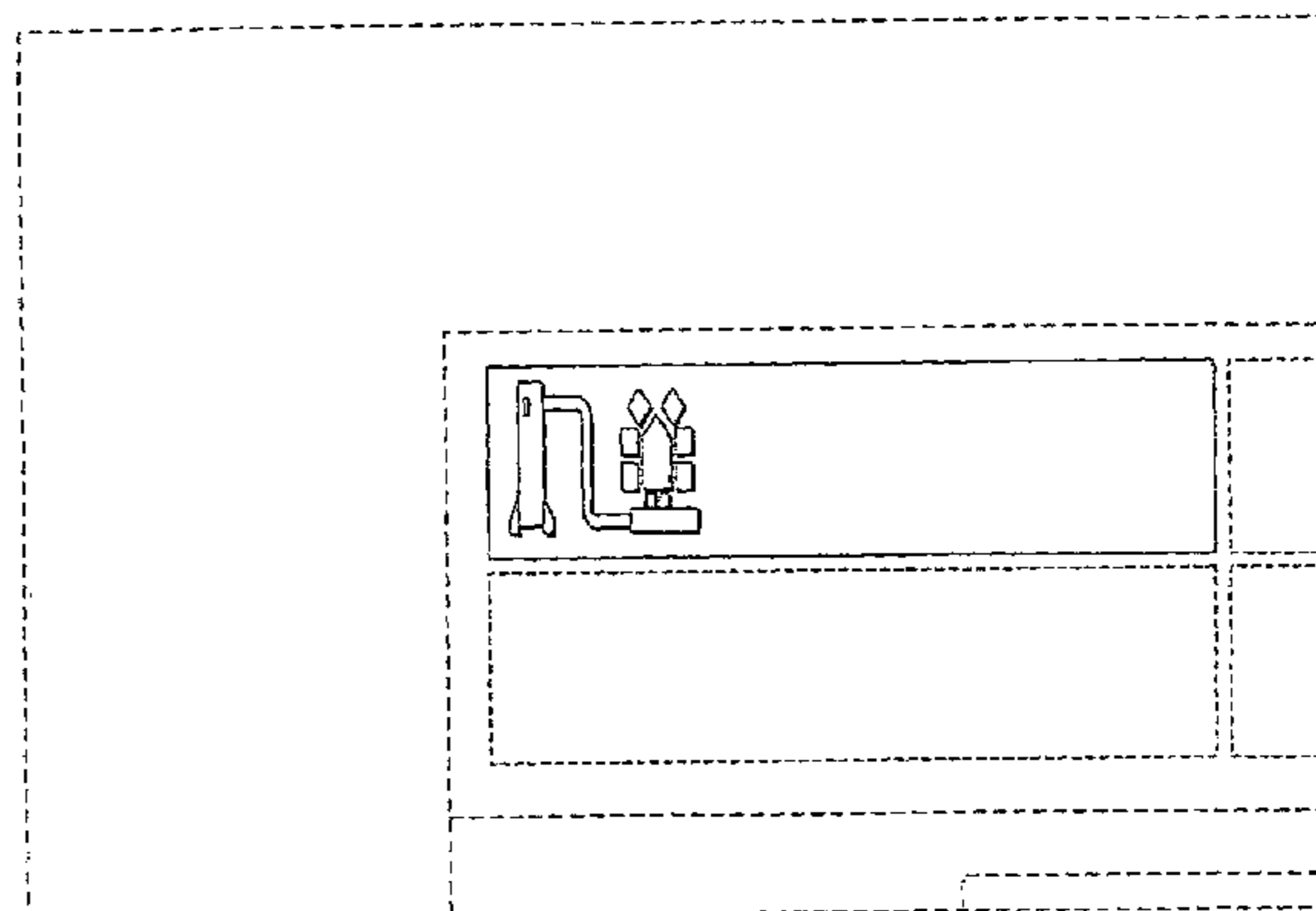
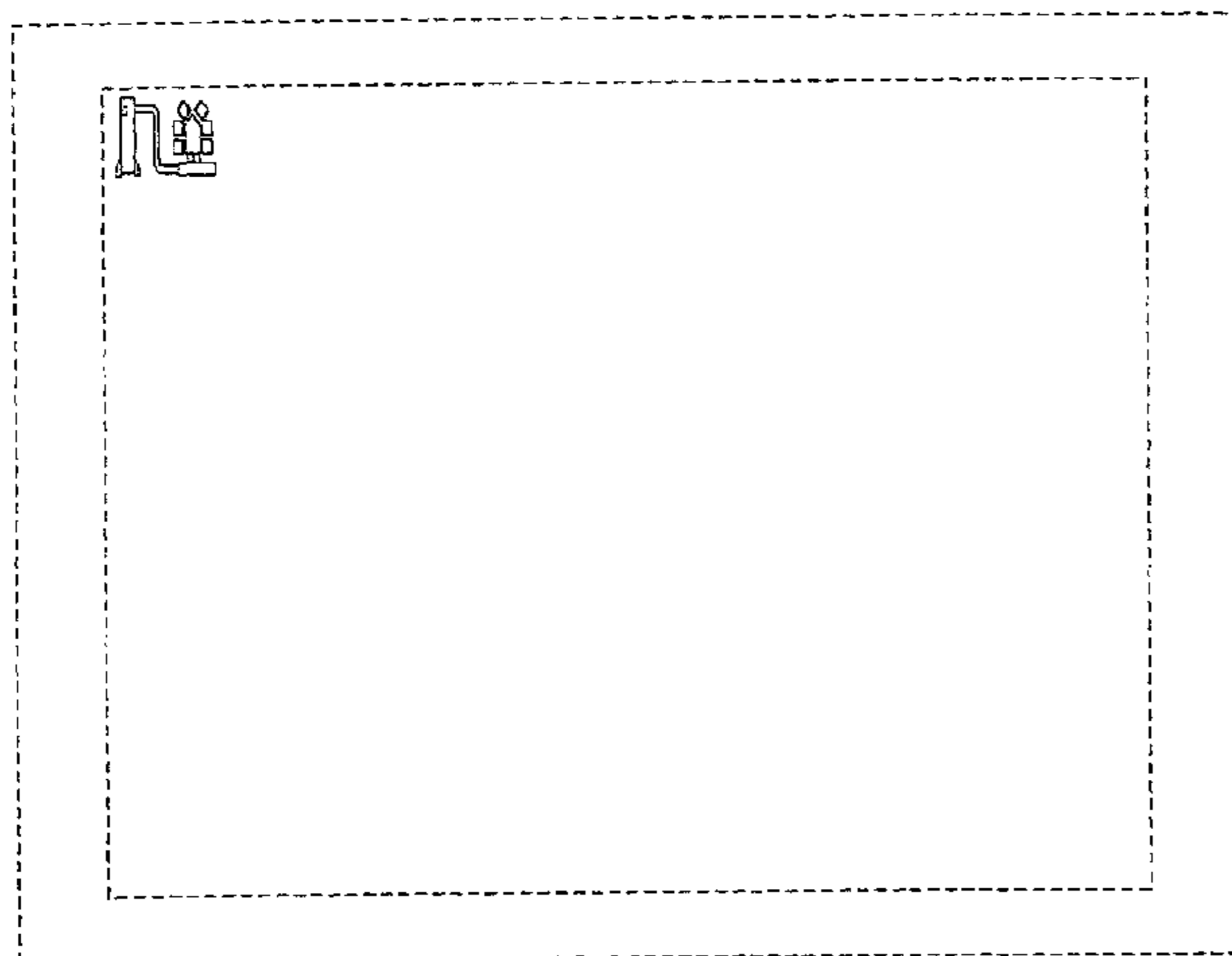
**DESCRIPTION**

FIG. 1 is a front elevational view of a computer generated image for a display panel or screen showing our new design; FIG. 2 is a front elevational view of another embodiment of a computer generated image for a display panel or screen showing our new design; and,

FIG. 3 is an enlarged front elevational view thereof, taken along the lines 3—3 of FIG. 2.

The broken lines illustrate portions of the computer generated image that form no part of the claimed design.

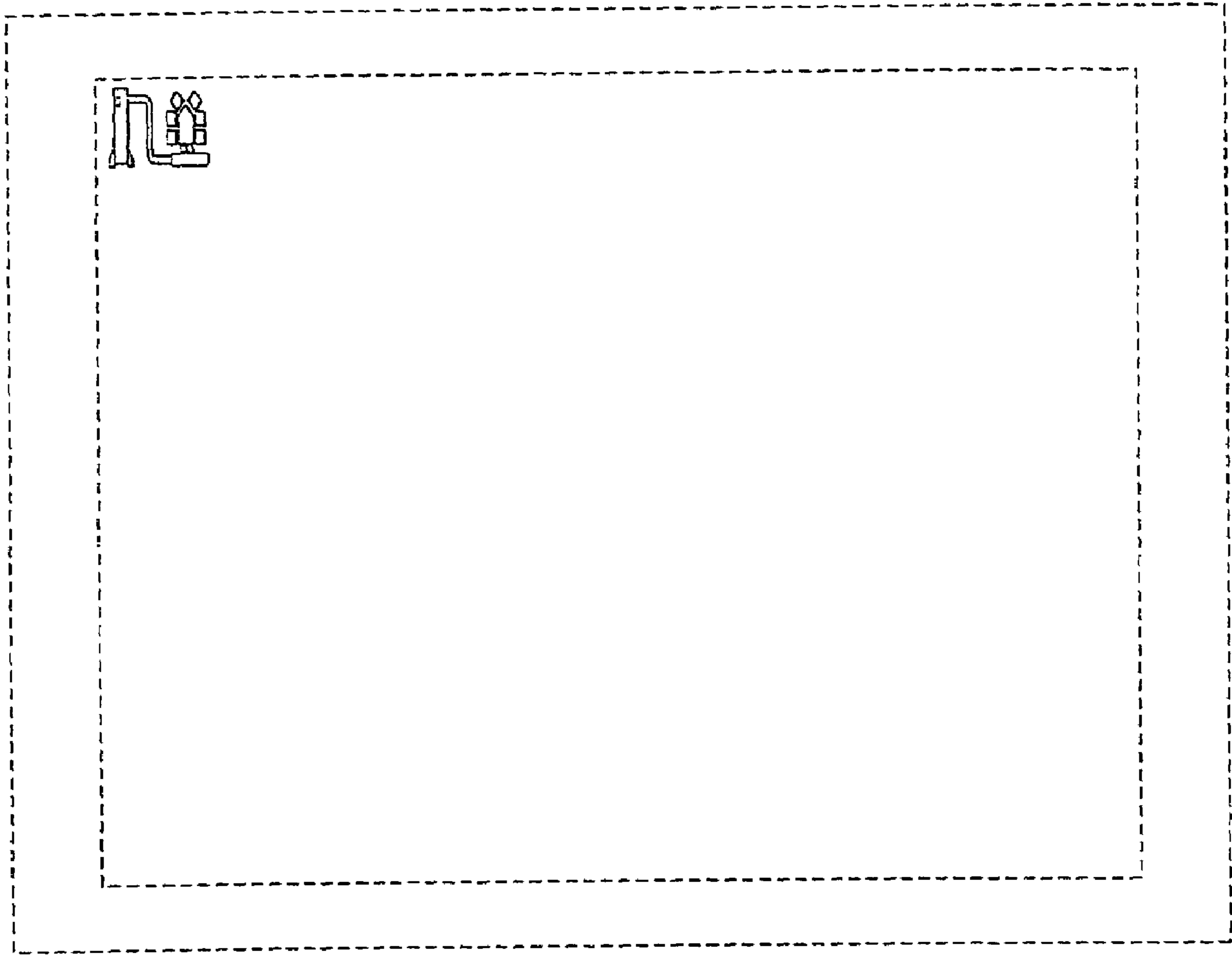

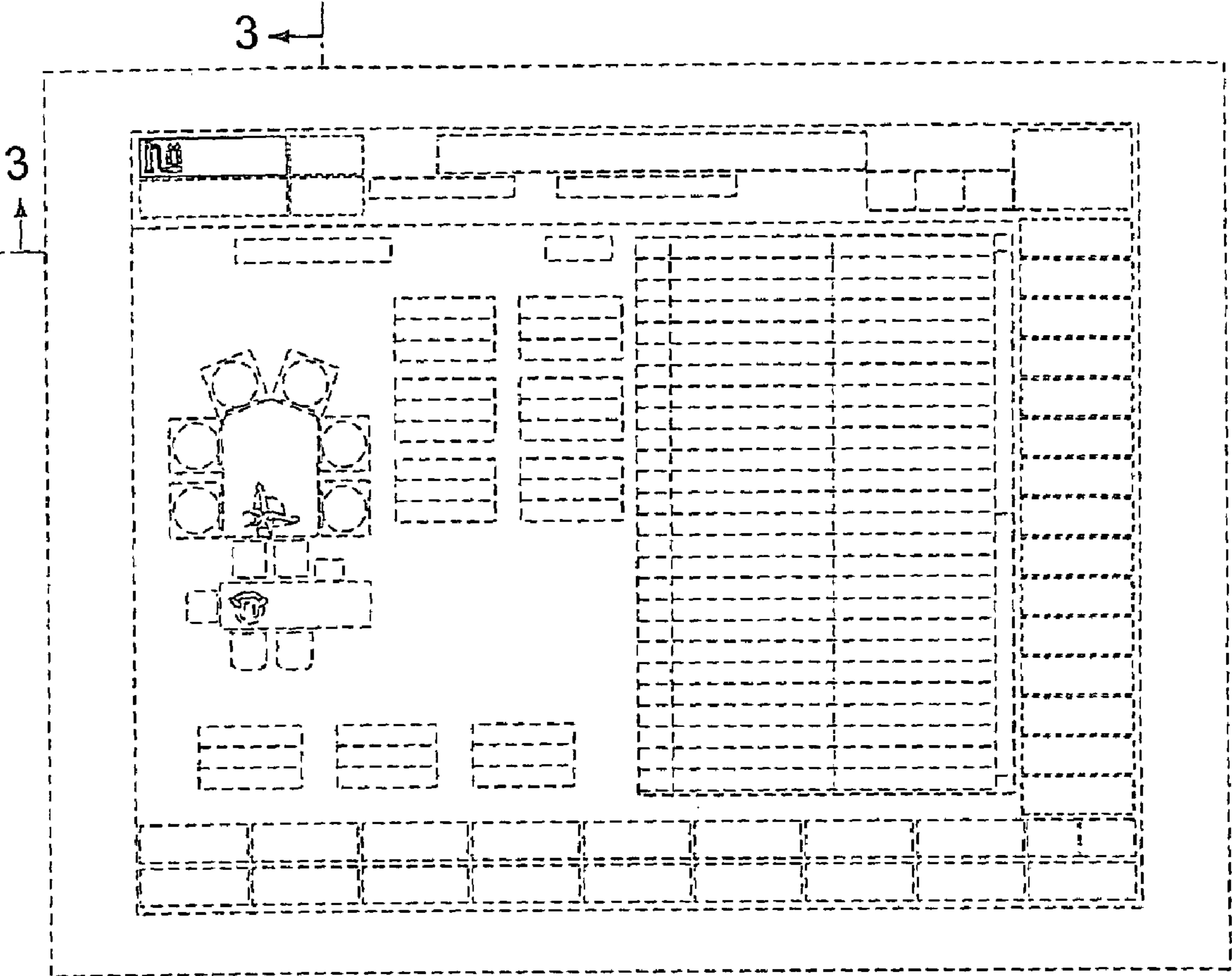

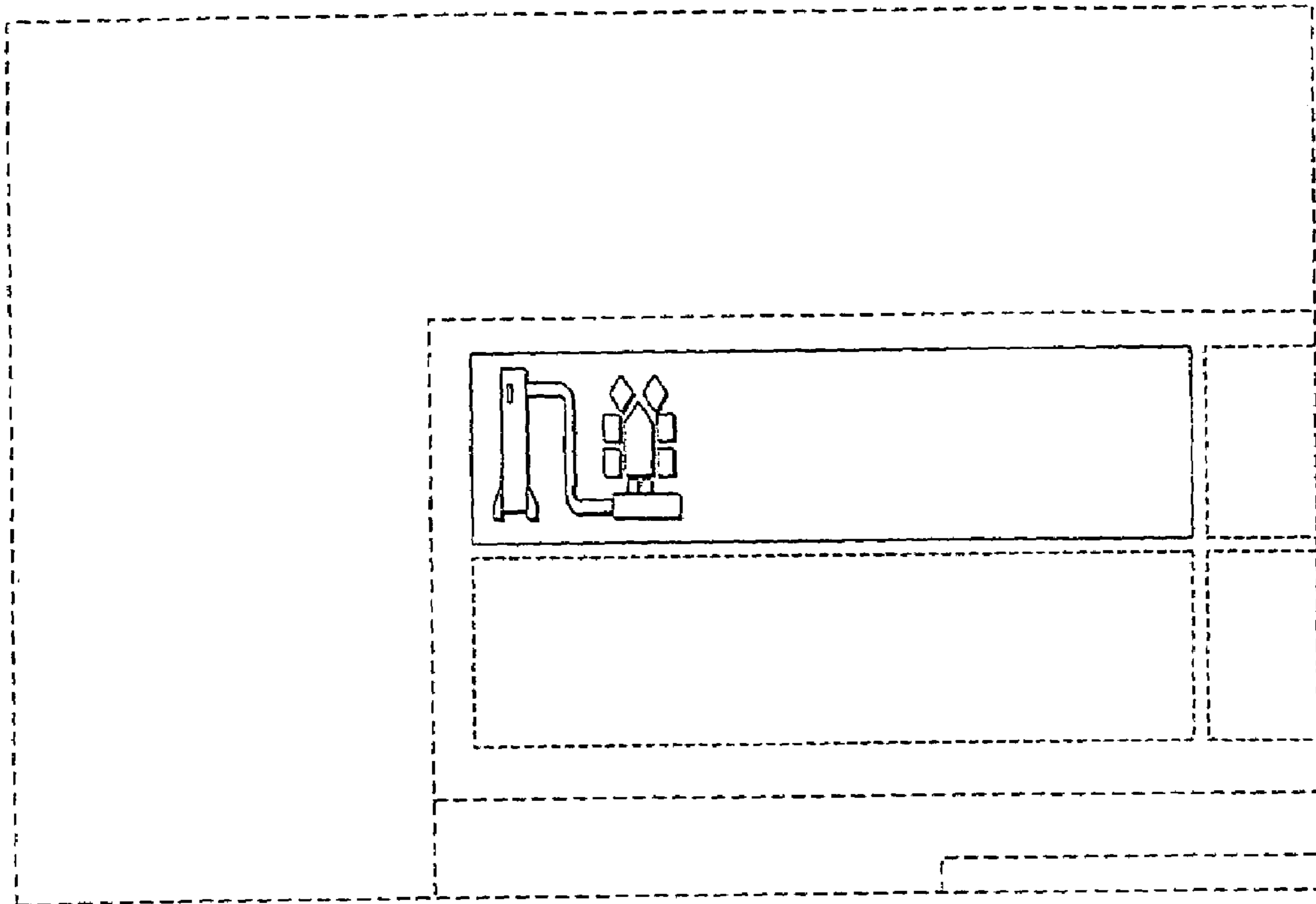
