(57) **CLAIM**

The ornamental design for a computer generated image for a display panel or screen, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of a computer generated image for a display panel or screen showing our new design;

FIG. 2 is a front elevational view of a second embodiment of a computer generated image for a display panel or screen;

FIG. 3 is a front elevational view of a second image of FIG. 1;

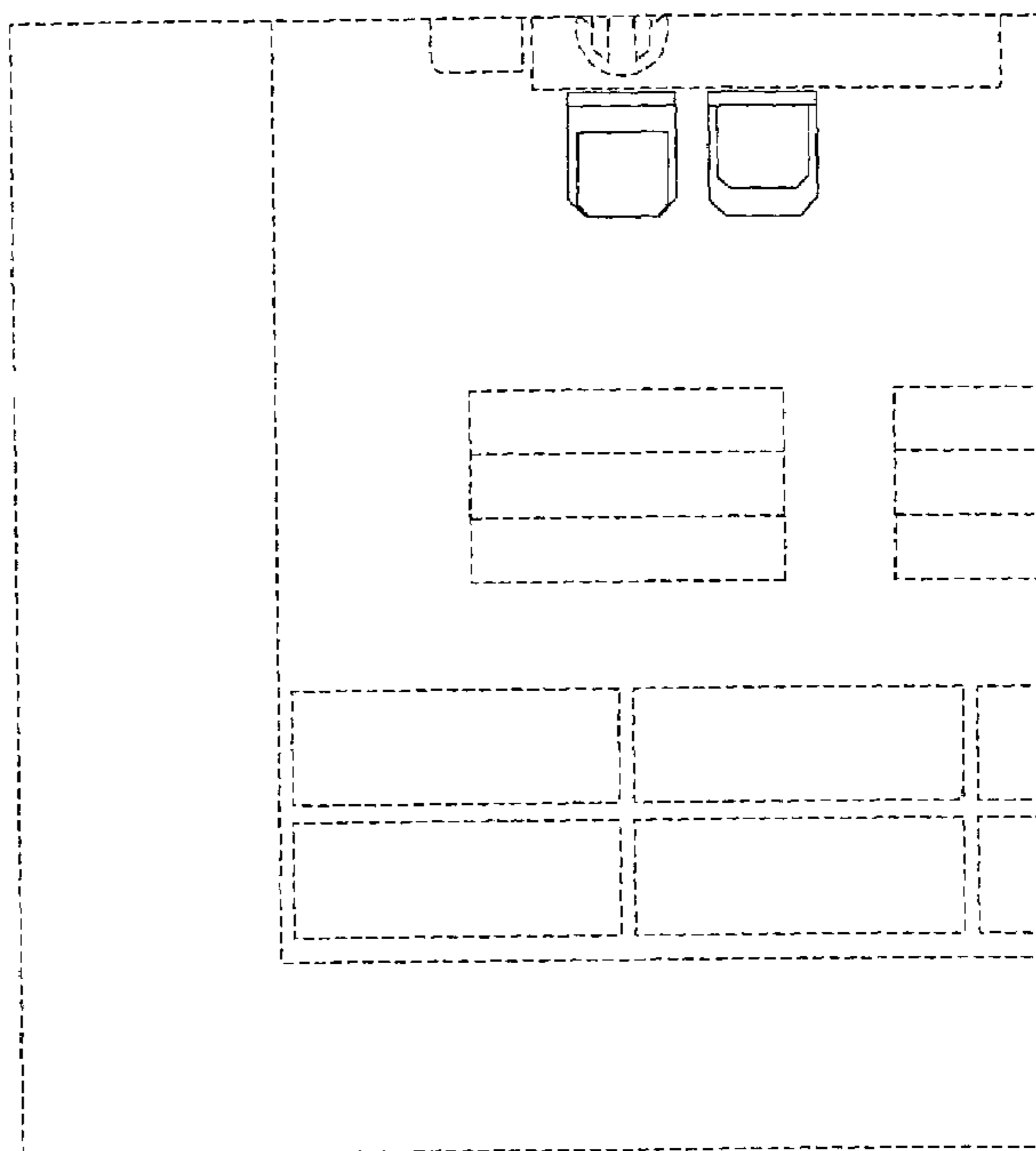
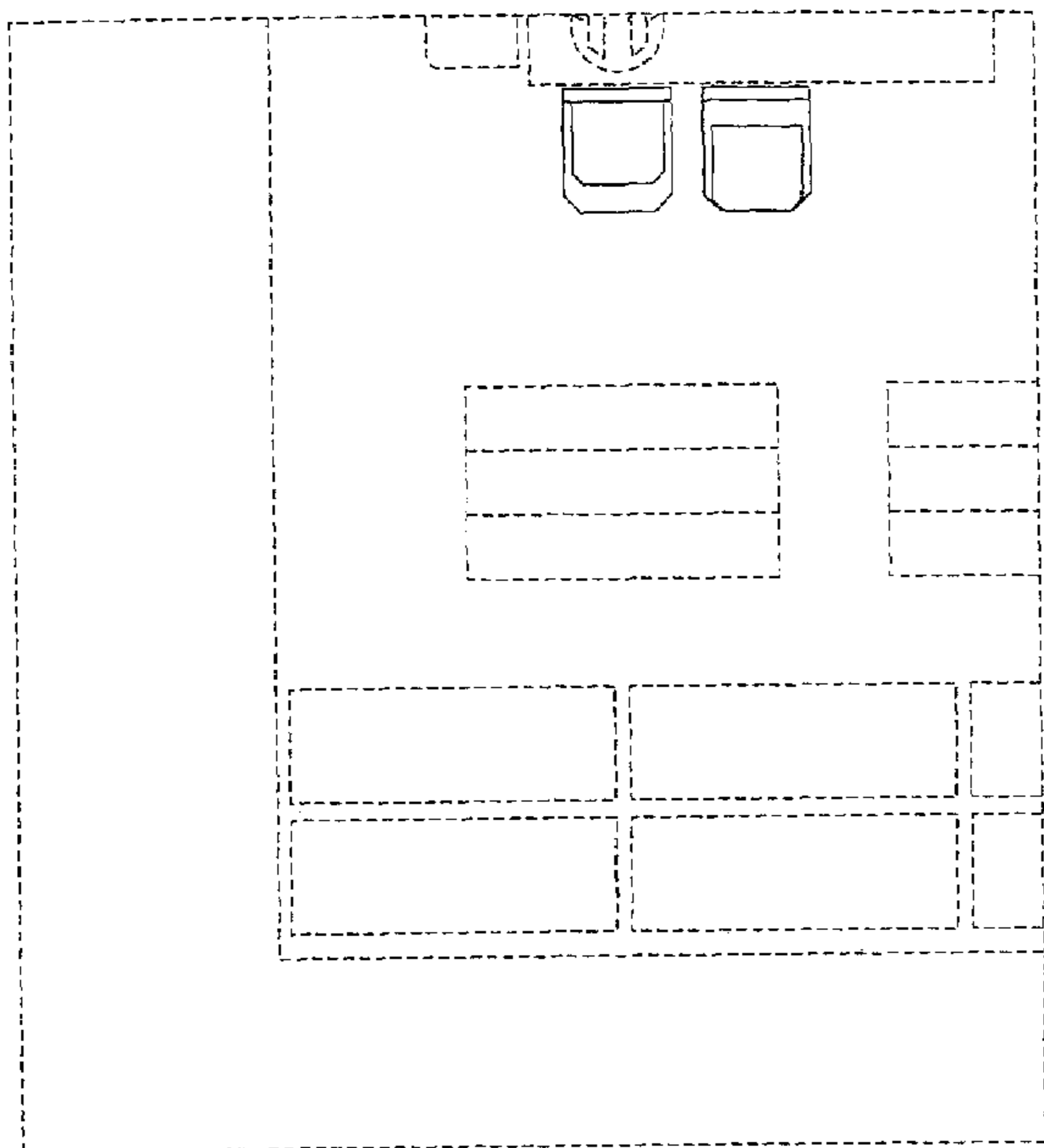
FIG. 4 is an enlarged front elevational view taken along the lines 4—4 of FIG. 3;

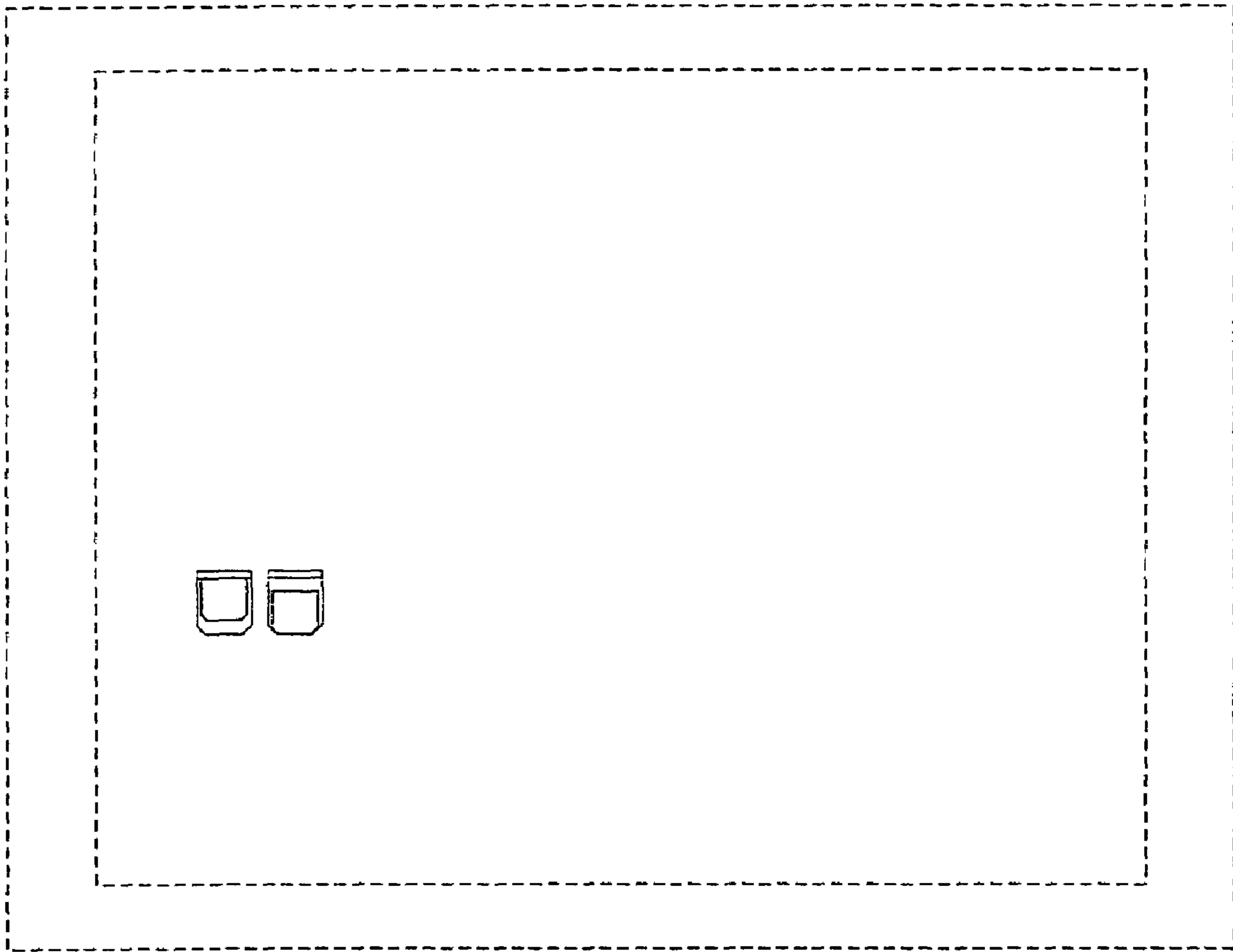

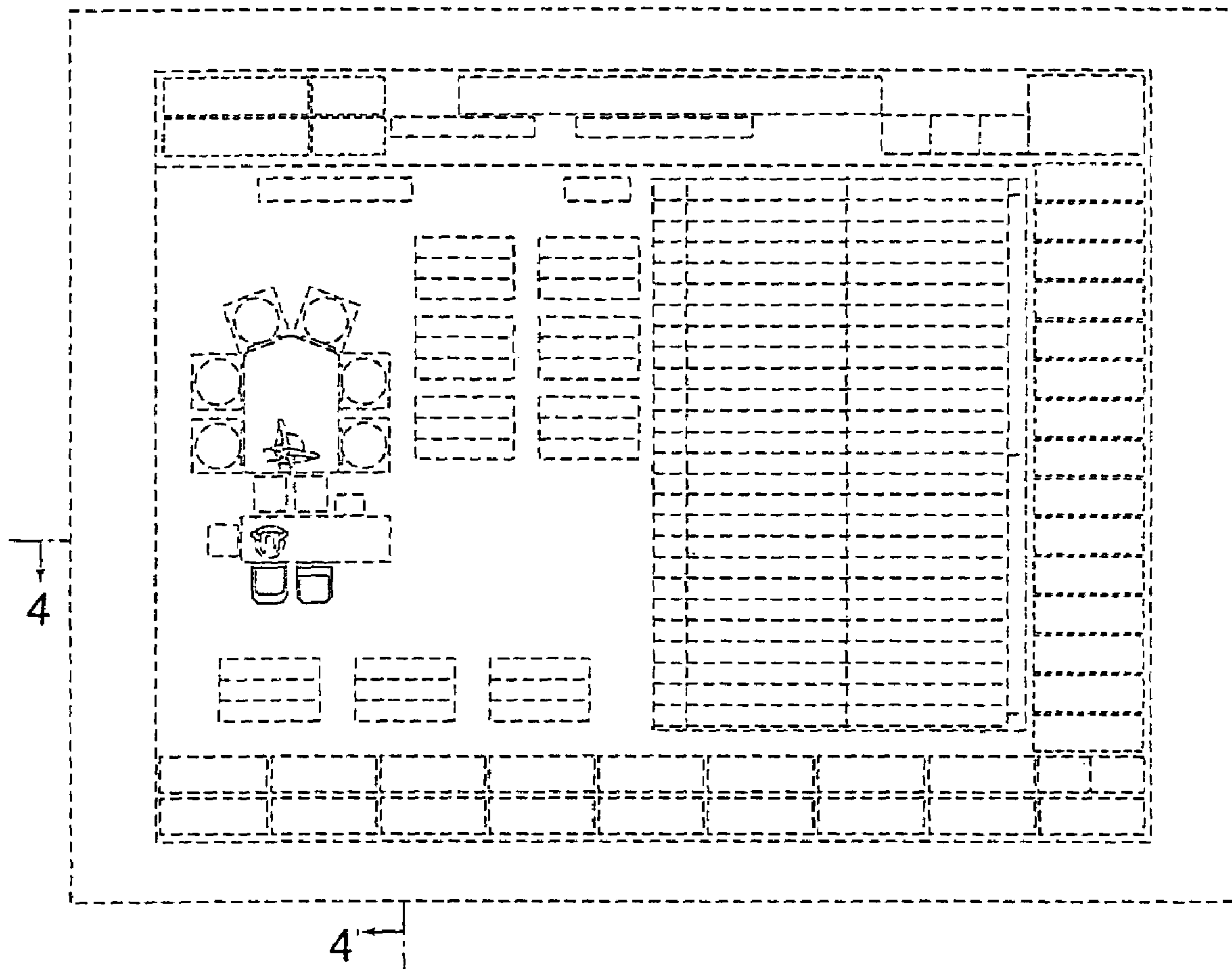

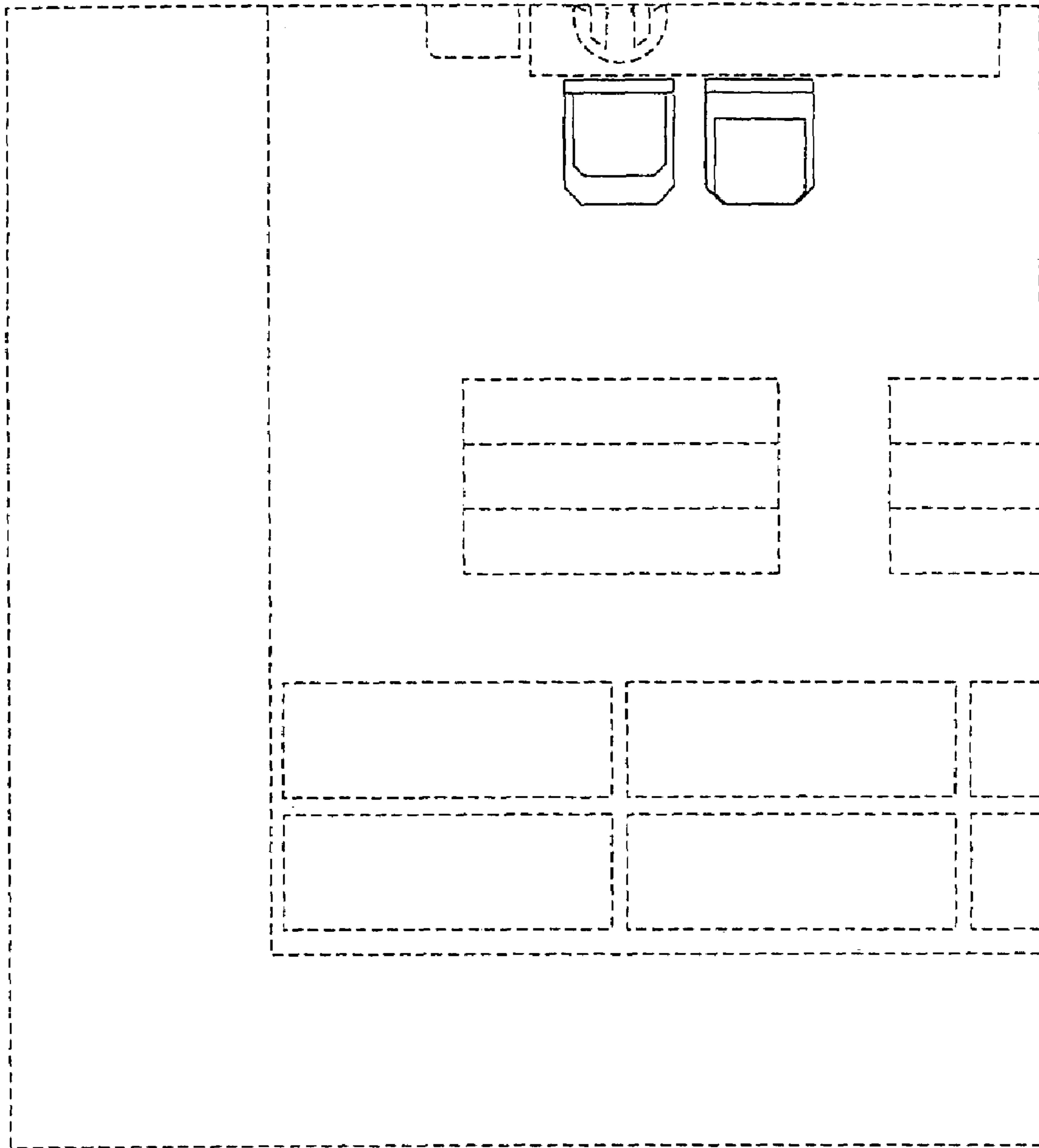

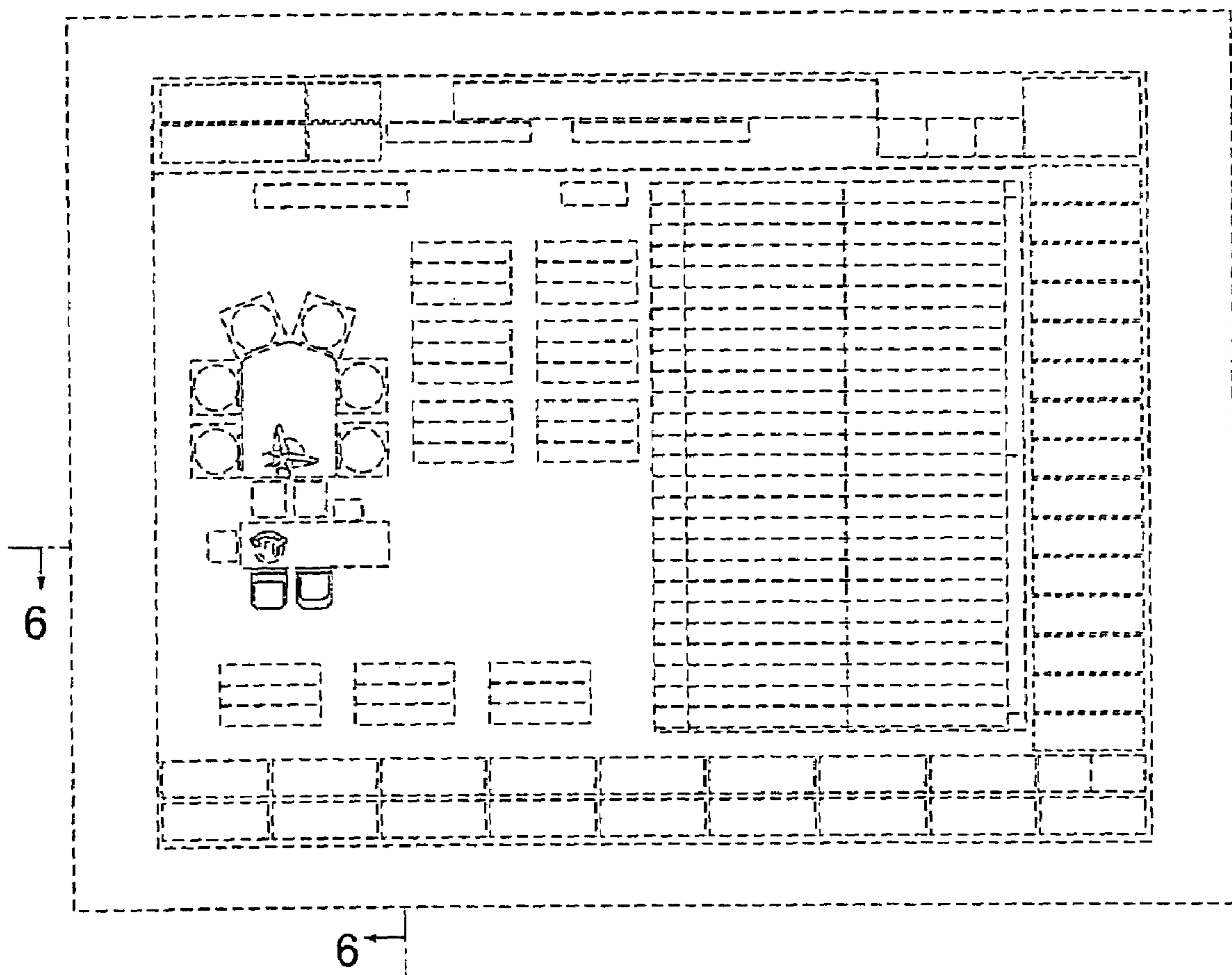

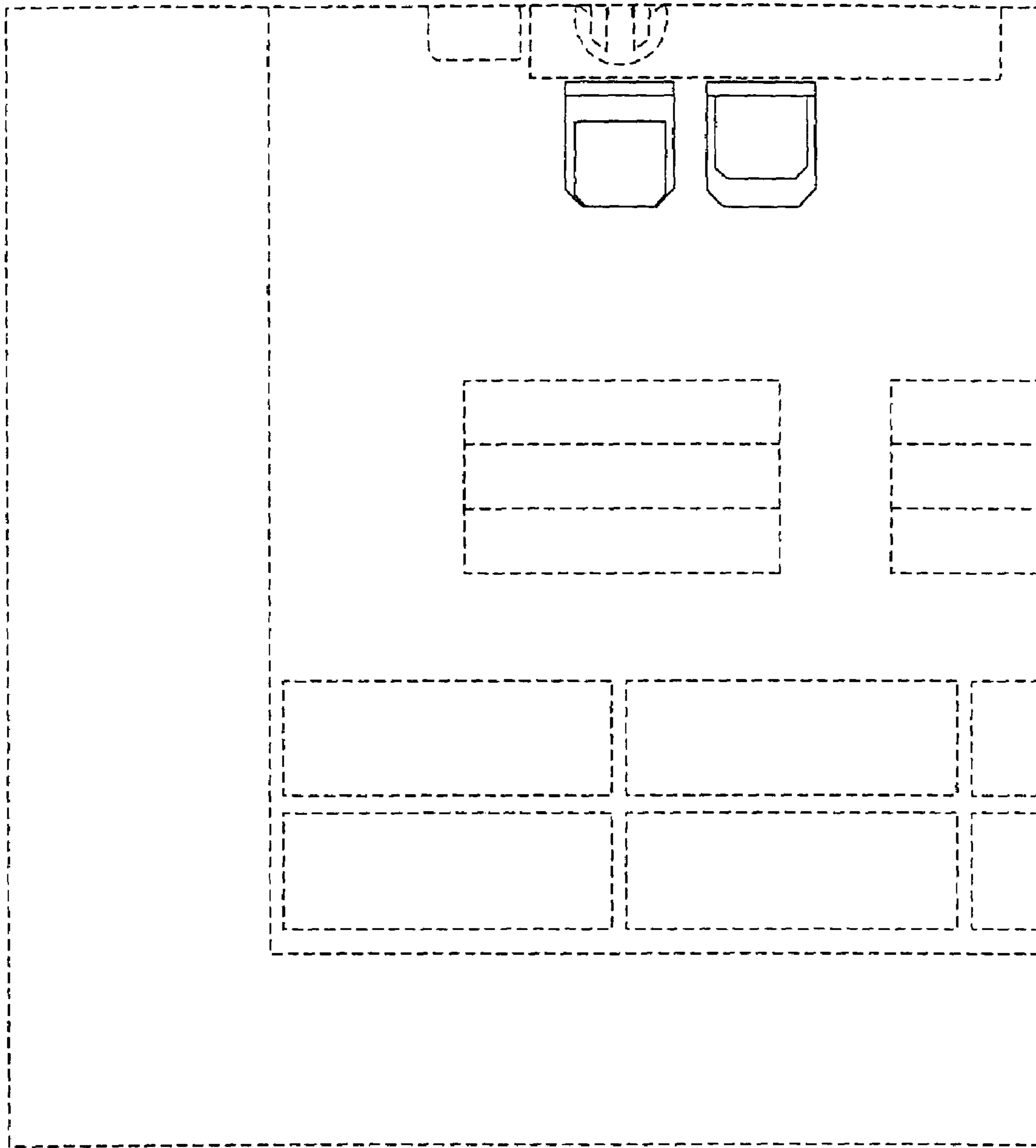
