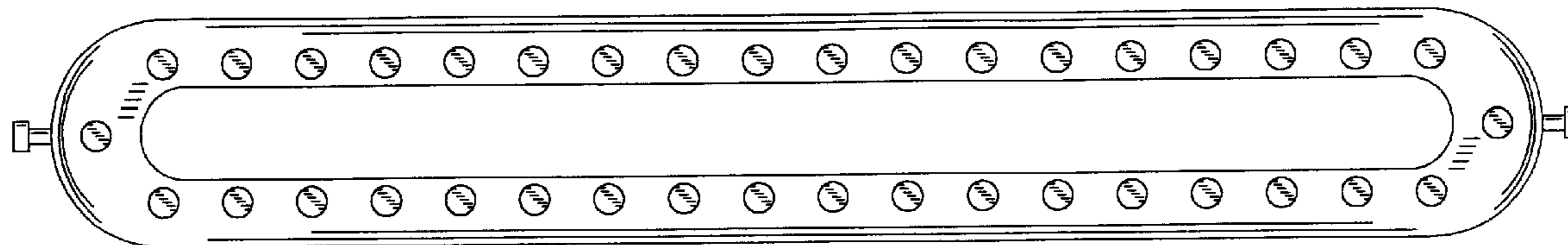
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top side view of the long knitting loom;
FIG. 2 is a bottom side view of the long knitting loom;
FIG. 3 is a front side view of the long knitting loom;
FIG. 4 is a back side view of the long knitting loom;
FIG. 5 is a left side view of the long knitting loom; and,
FIG. 6 is a right side view of the long knitting loom.

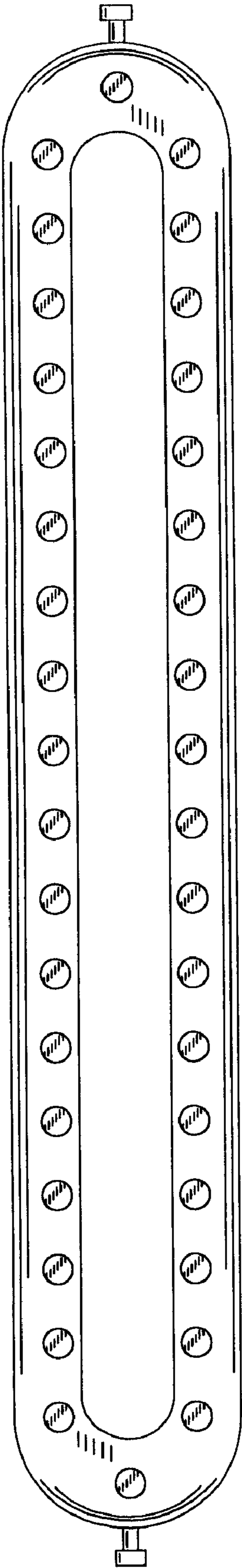

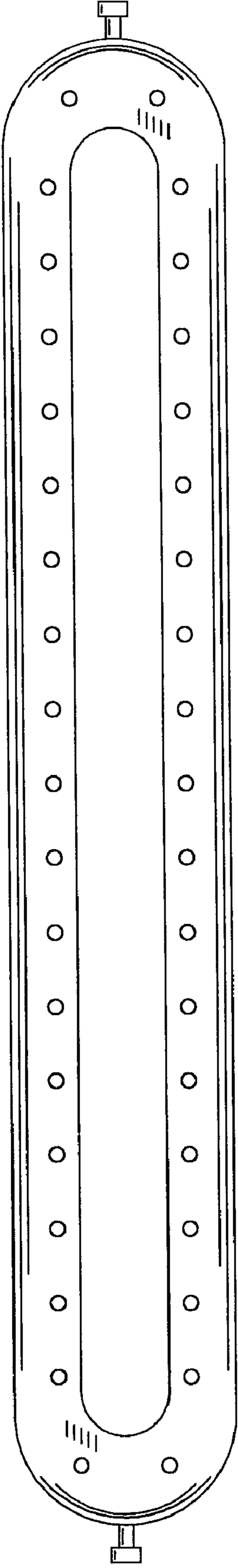

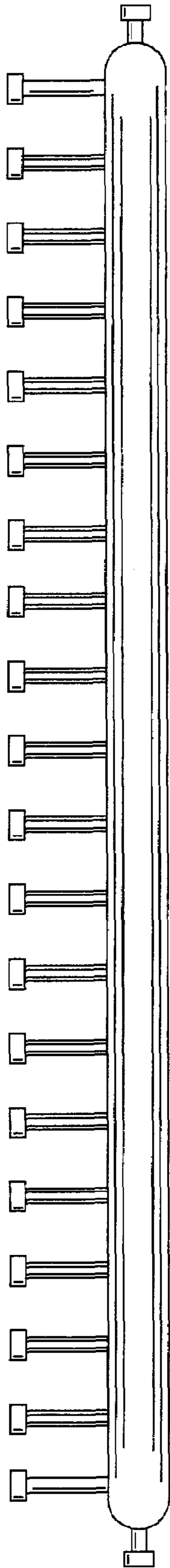

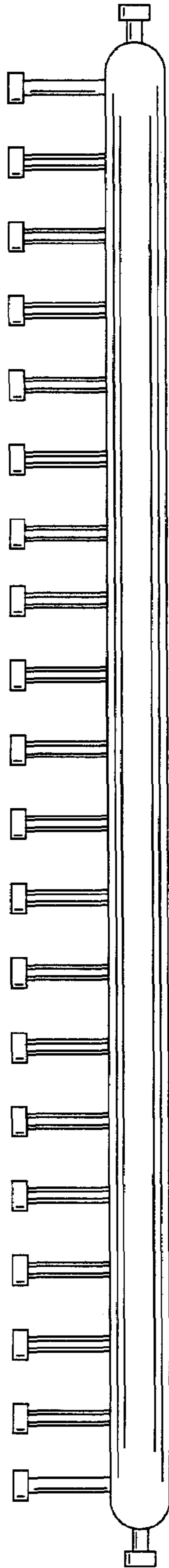

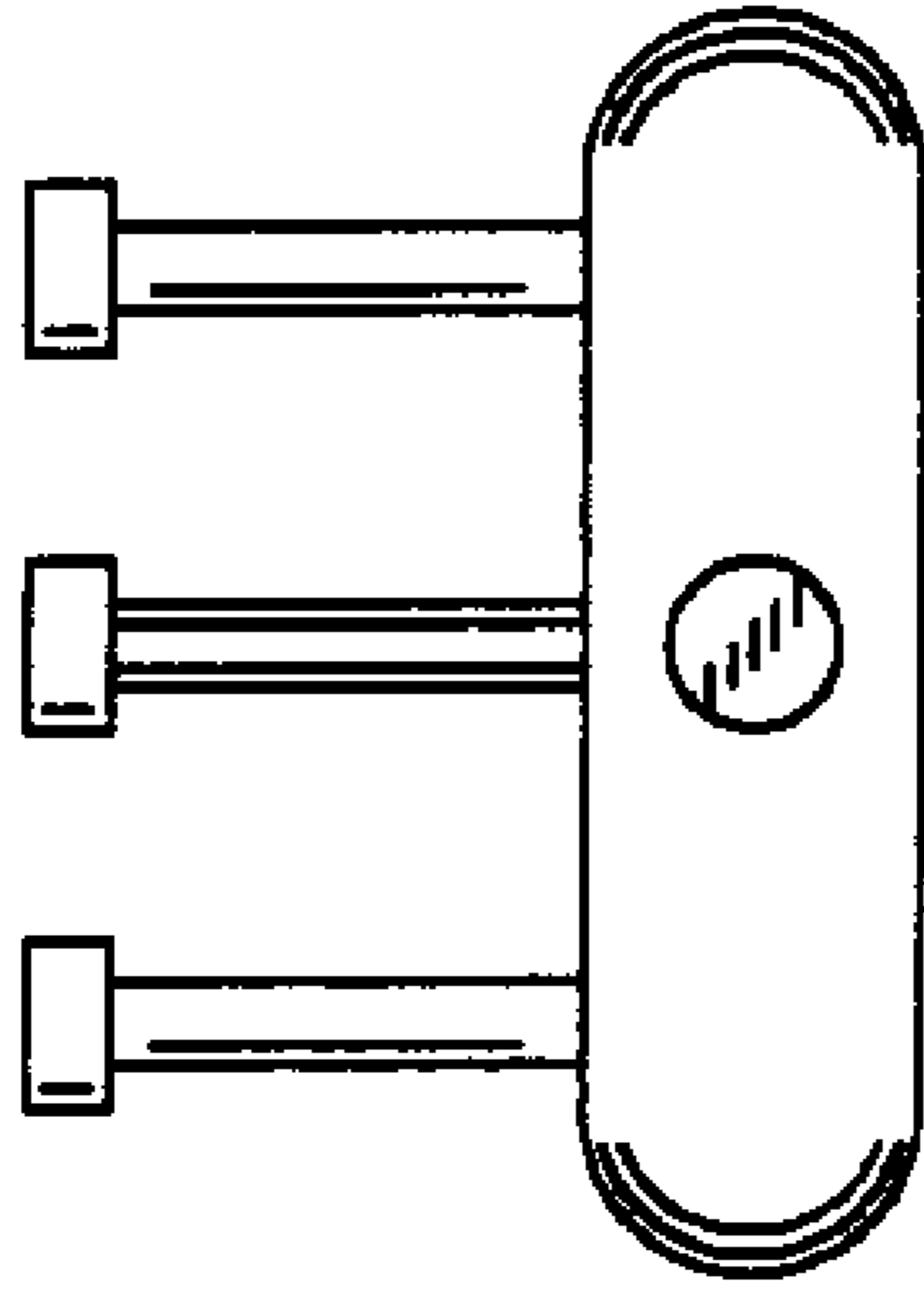

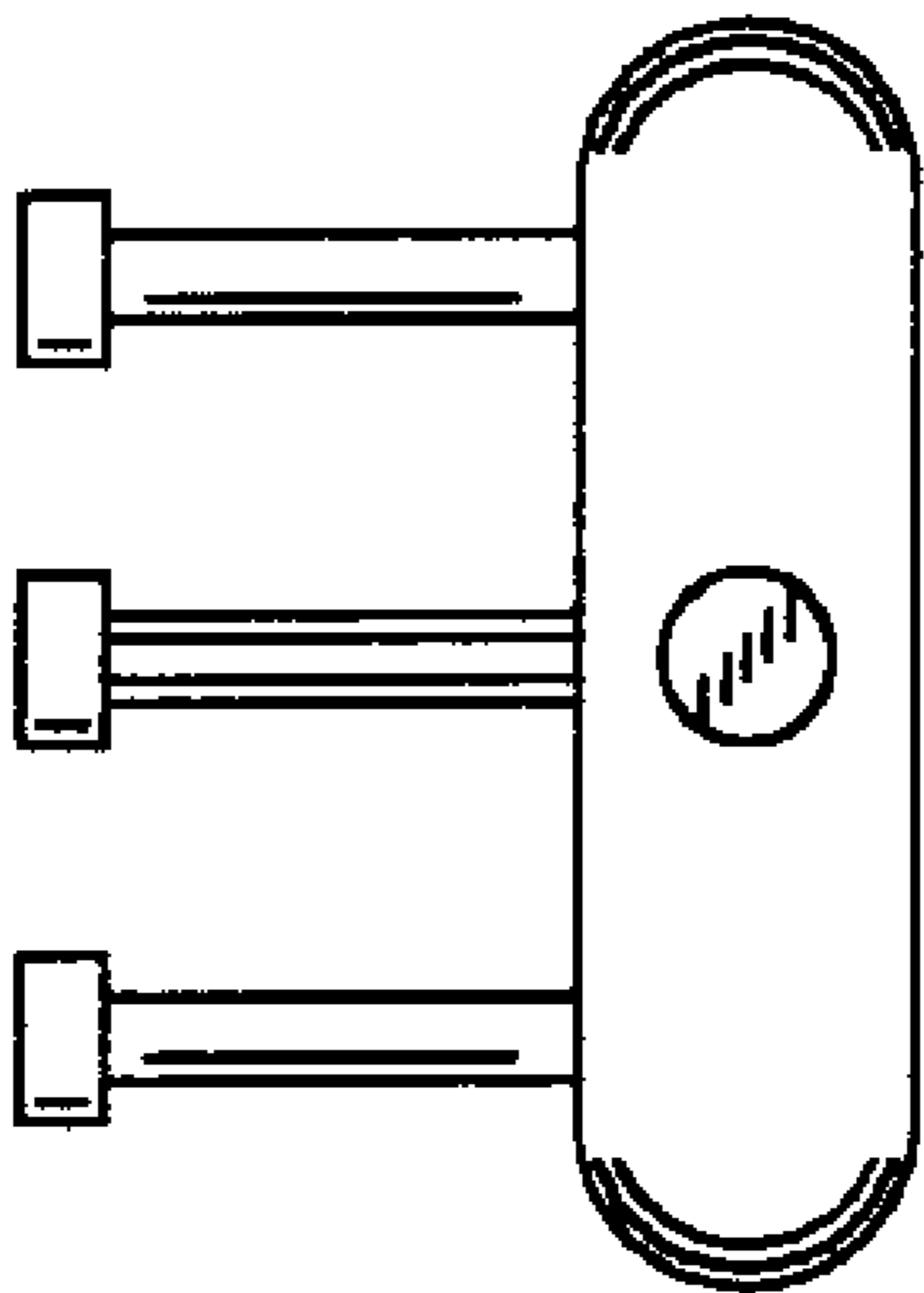
