**DESCRIPTION**

FIG. 4 is a rear view of the notepad and clip holder of FIG. 1;

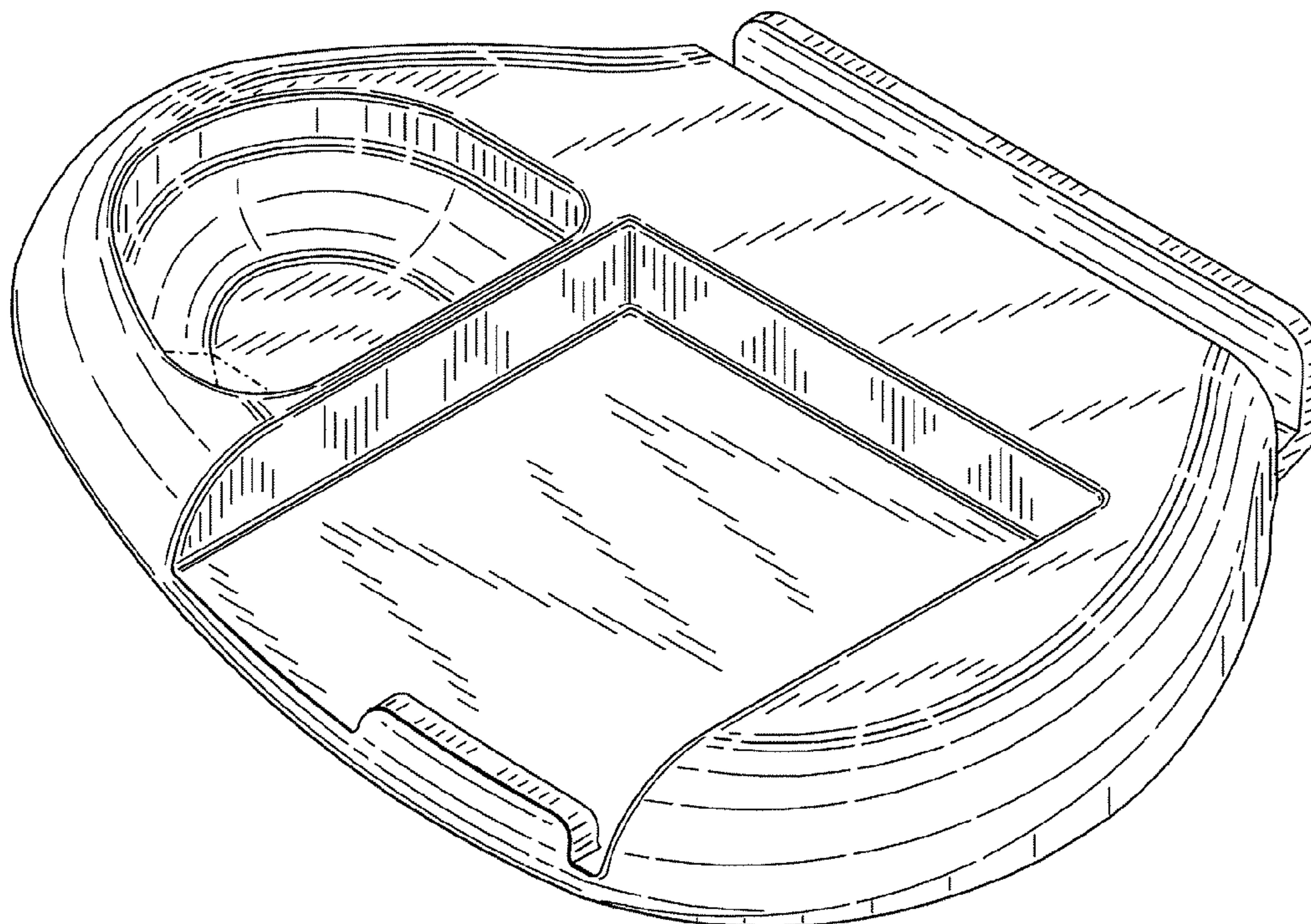
FIG. 5 is a bottom view of the notepad and clip holder of FIG. 1;

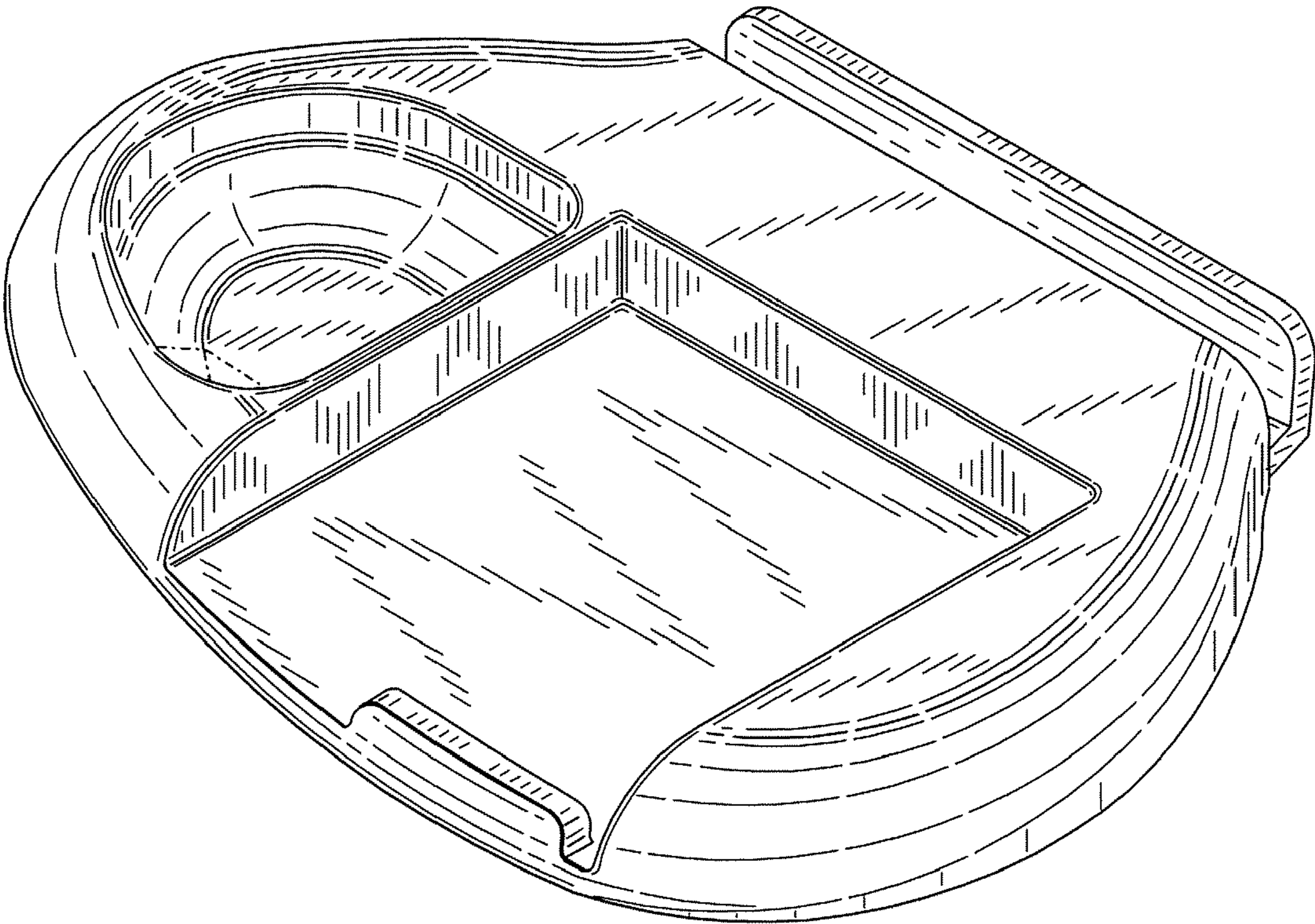

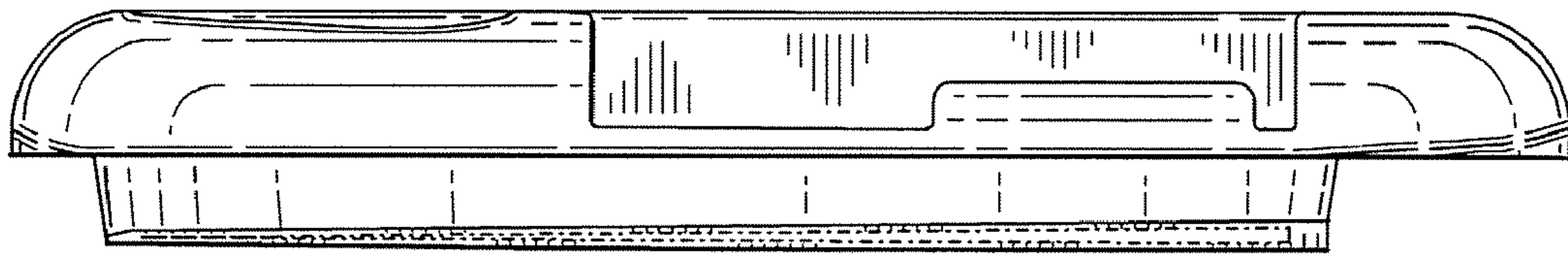

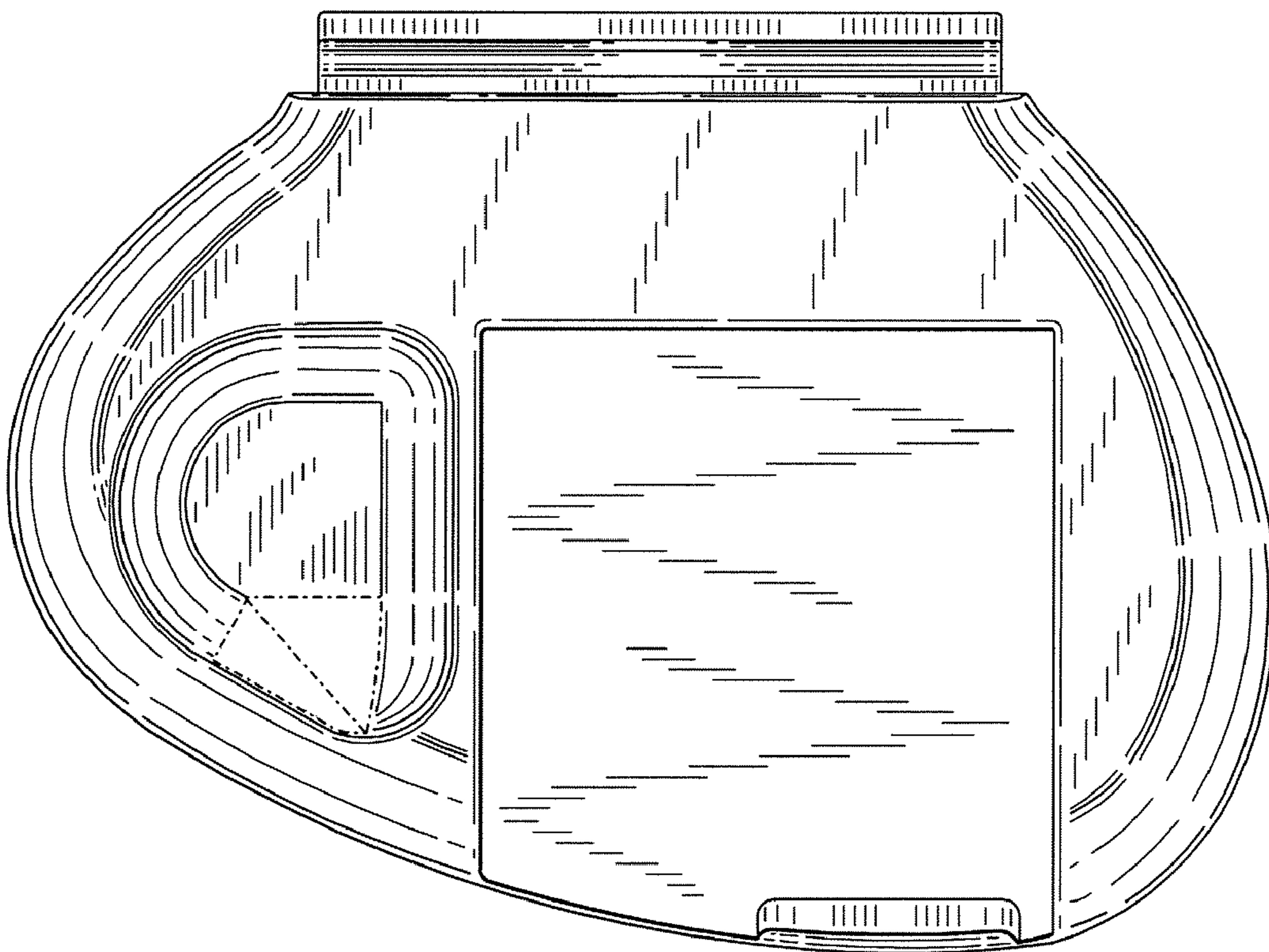

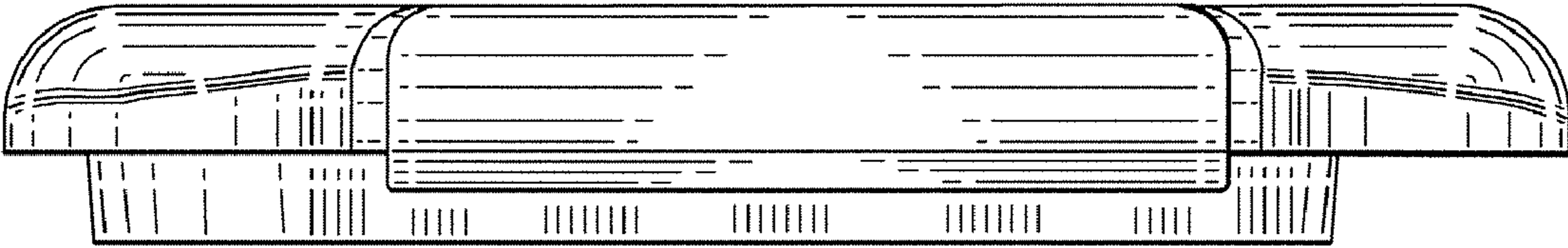

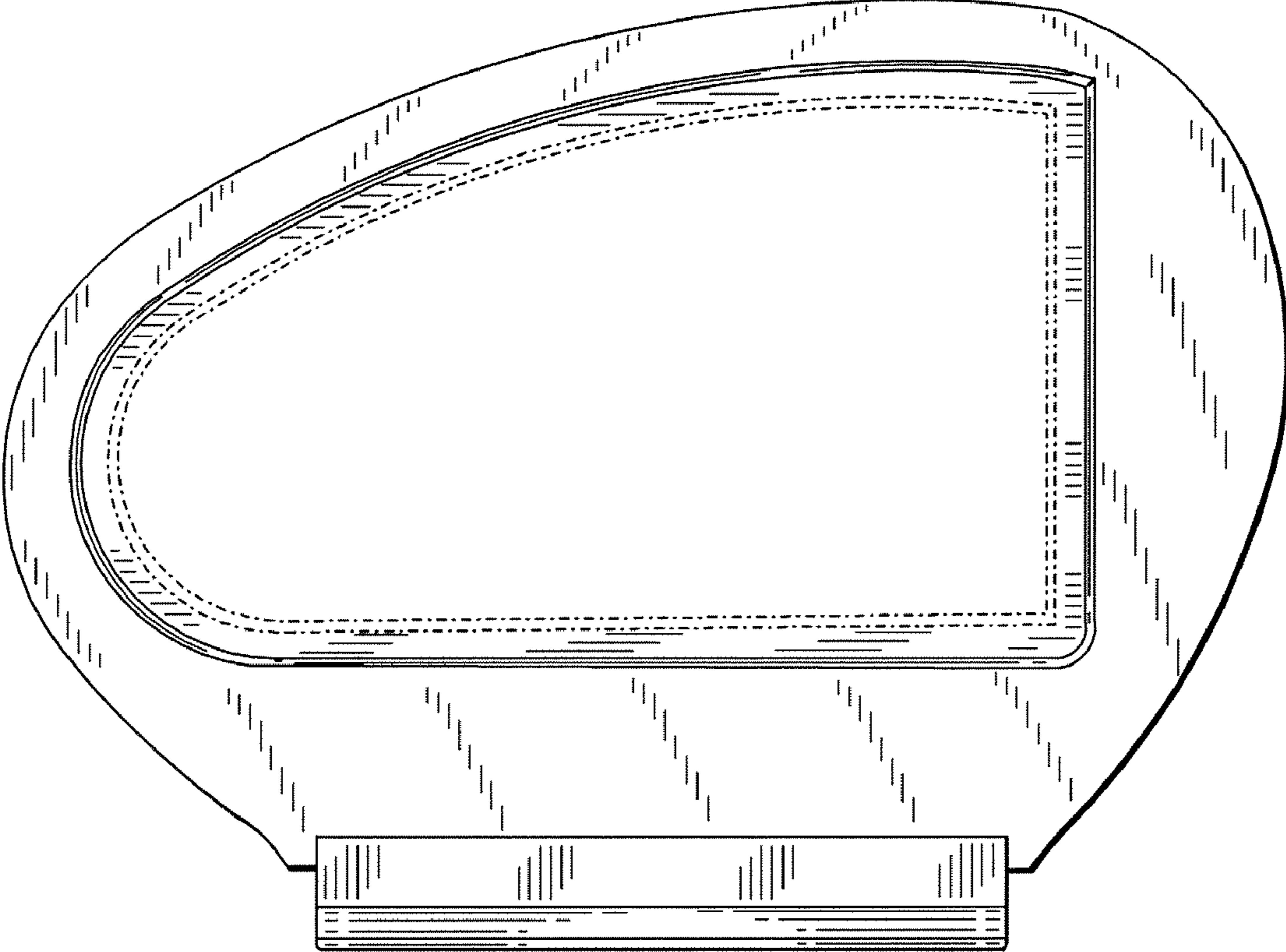

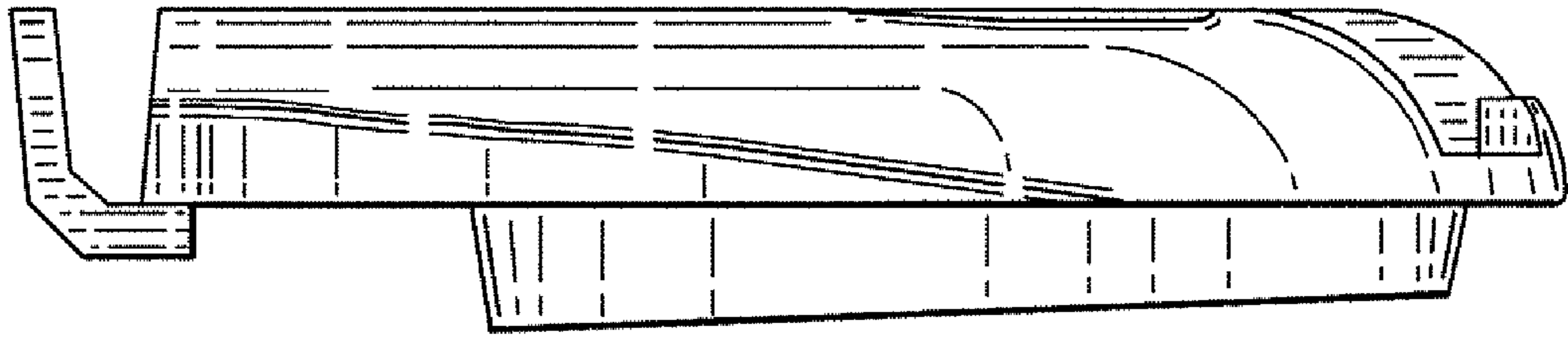

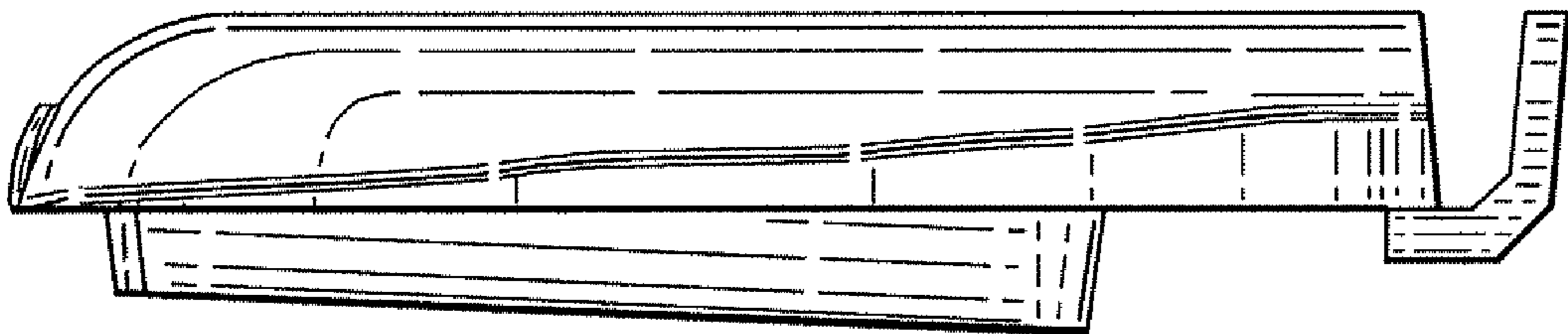
