(57) **CLAIM**

The ornamental design for a tablet, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a tablet according to the invention;

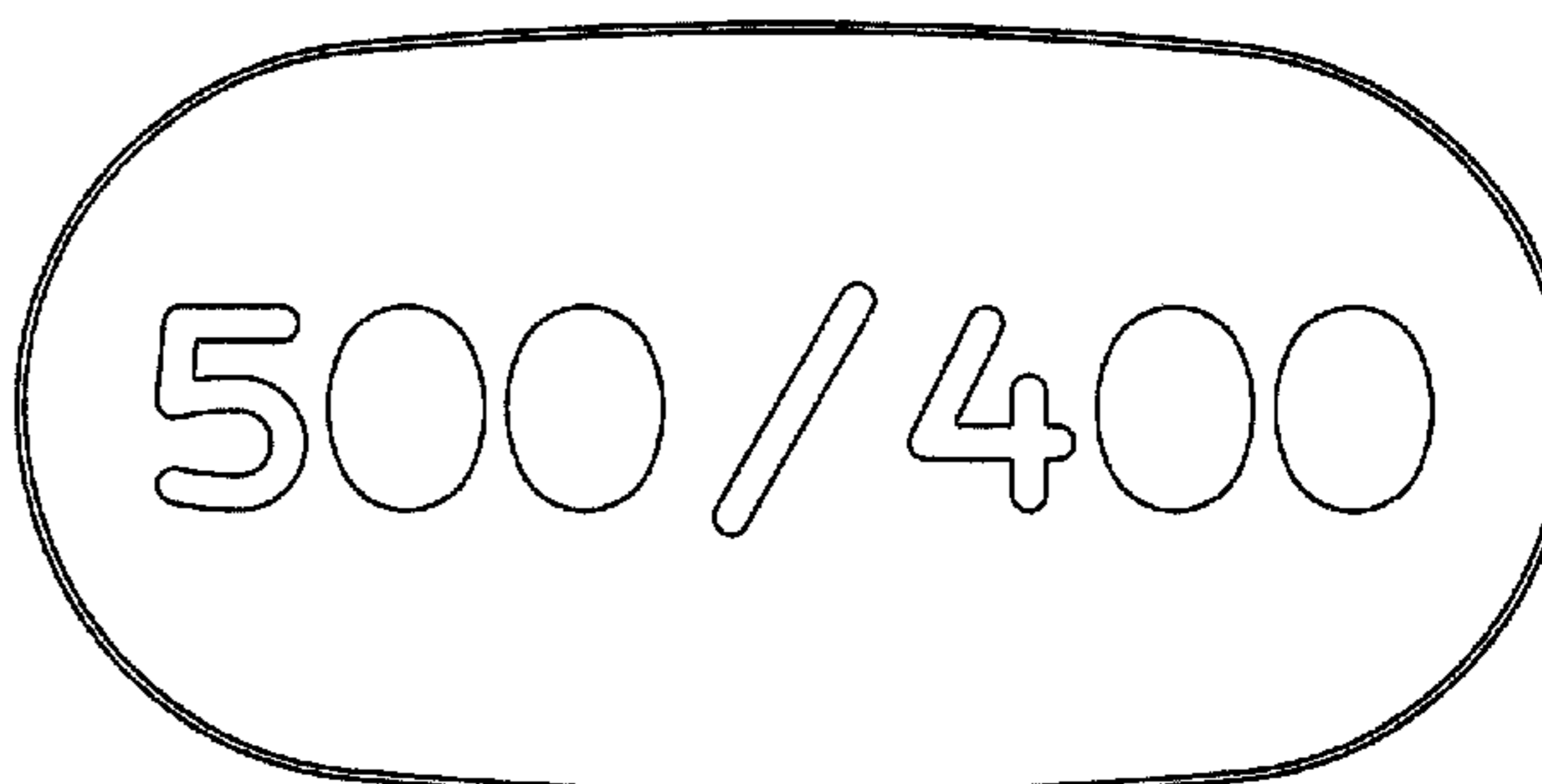
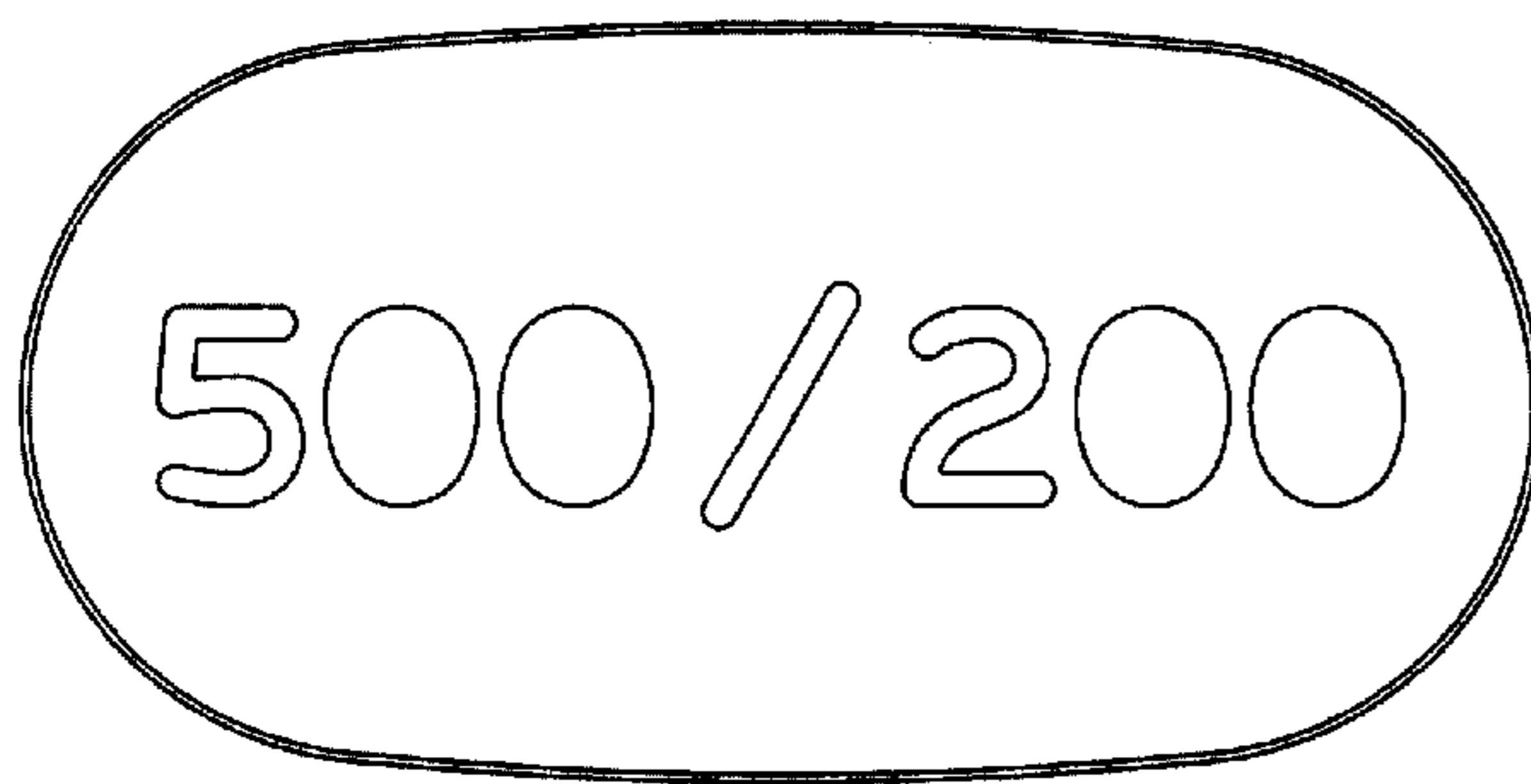
FIG. 2 is a top view of a first embodiment of the tablet shown in FIG. 1;

FIG. 3 is a front view of the tablet shown in FIG. 1;

FIG. 4 is a top view of a second embodiment of the tablet shown in FIG. 1, the only difference being the information engraved in the top surface of the tablet; and,

FIG. 5 is a top view of a third embodiment of the tablet shown in FIG. 1, the only difference being the lack of information engraved in the top surface of the tablet.

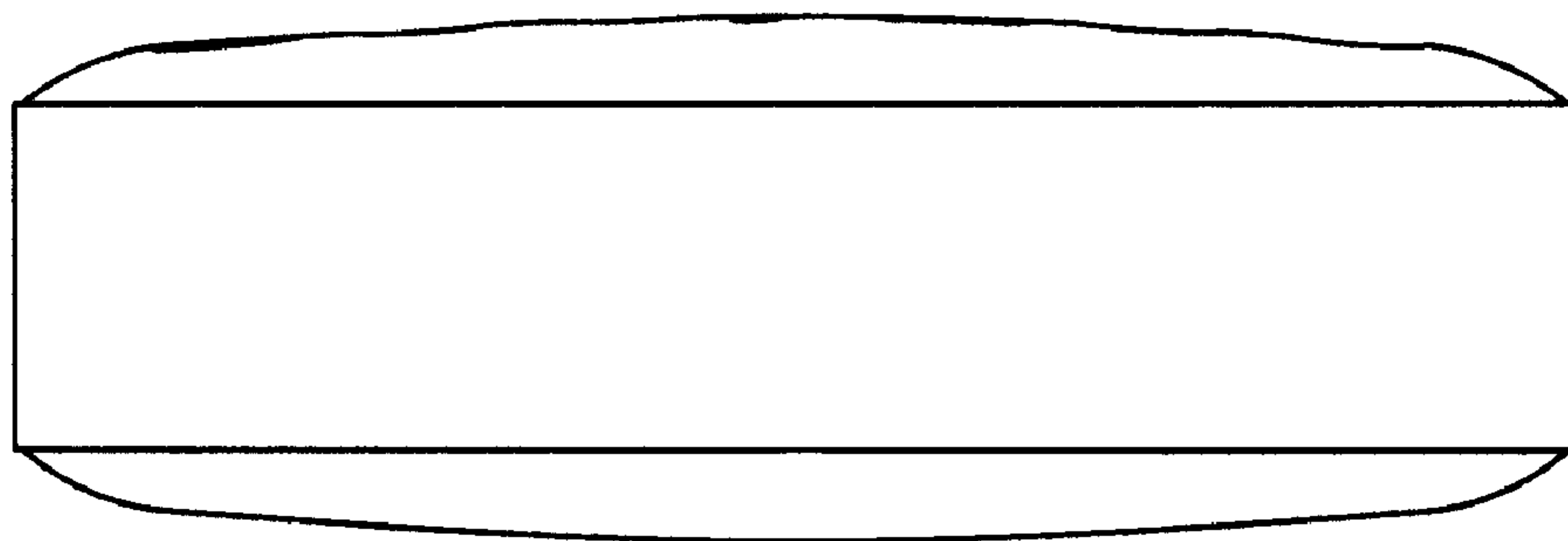

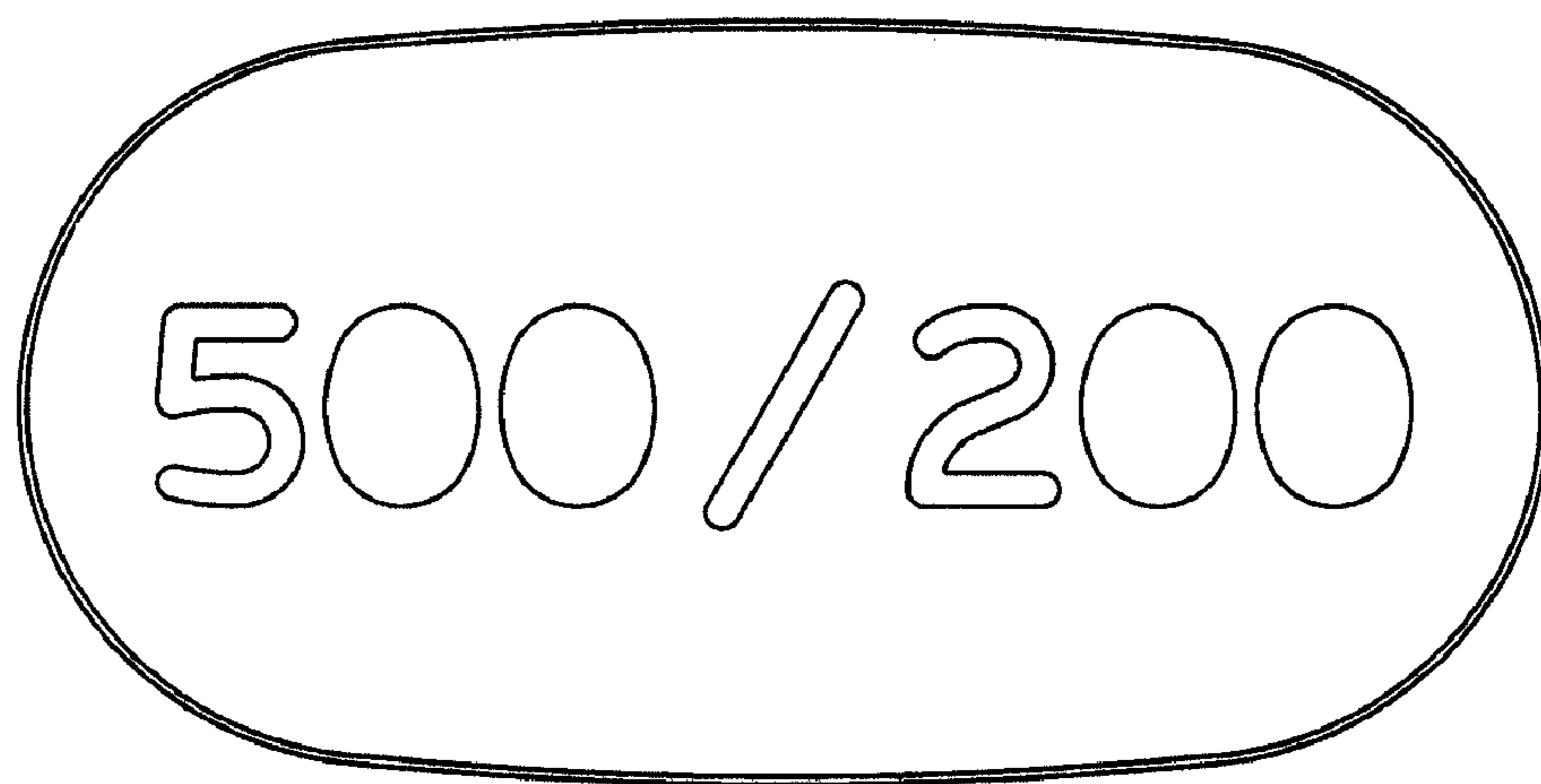

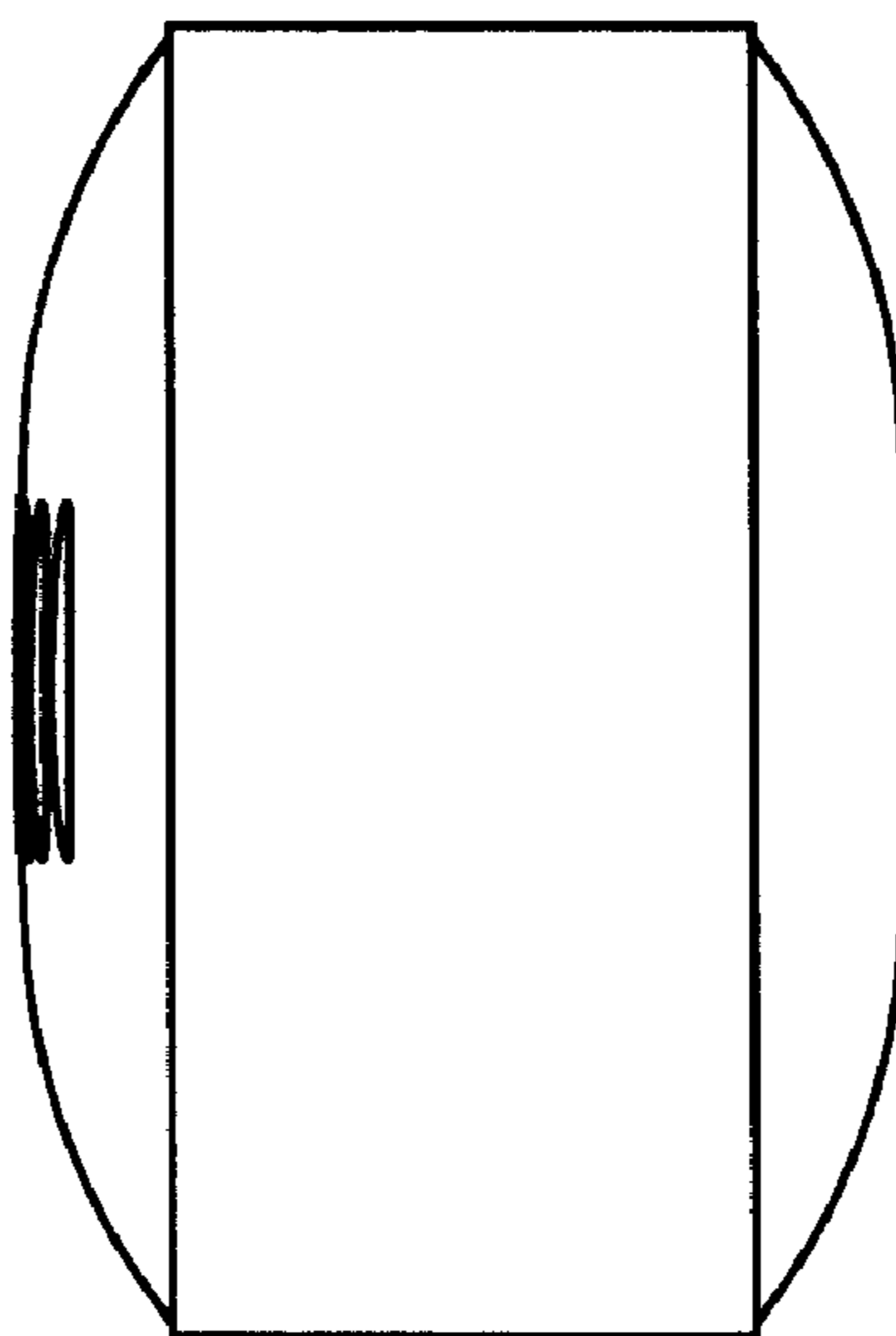

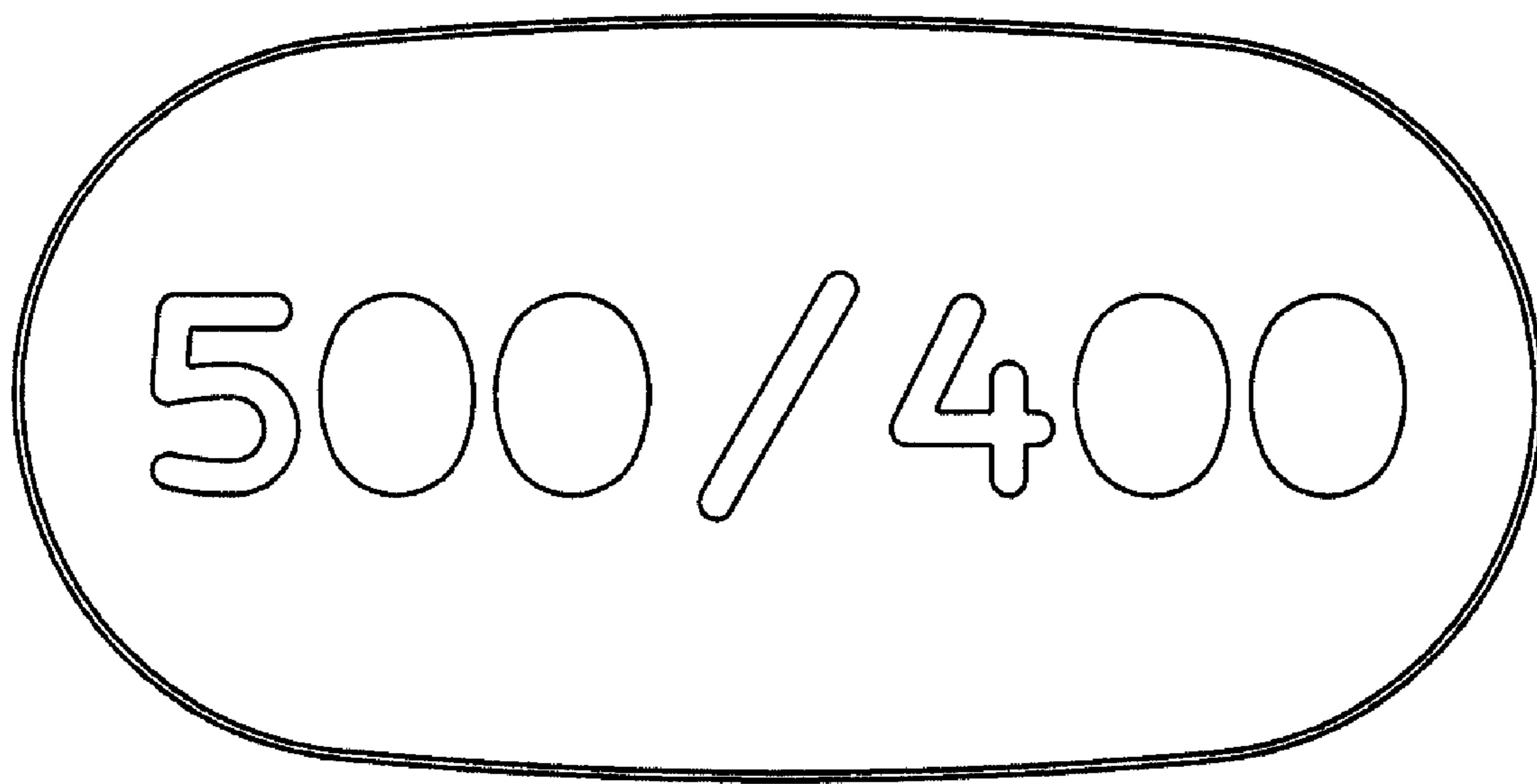

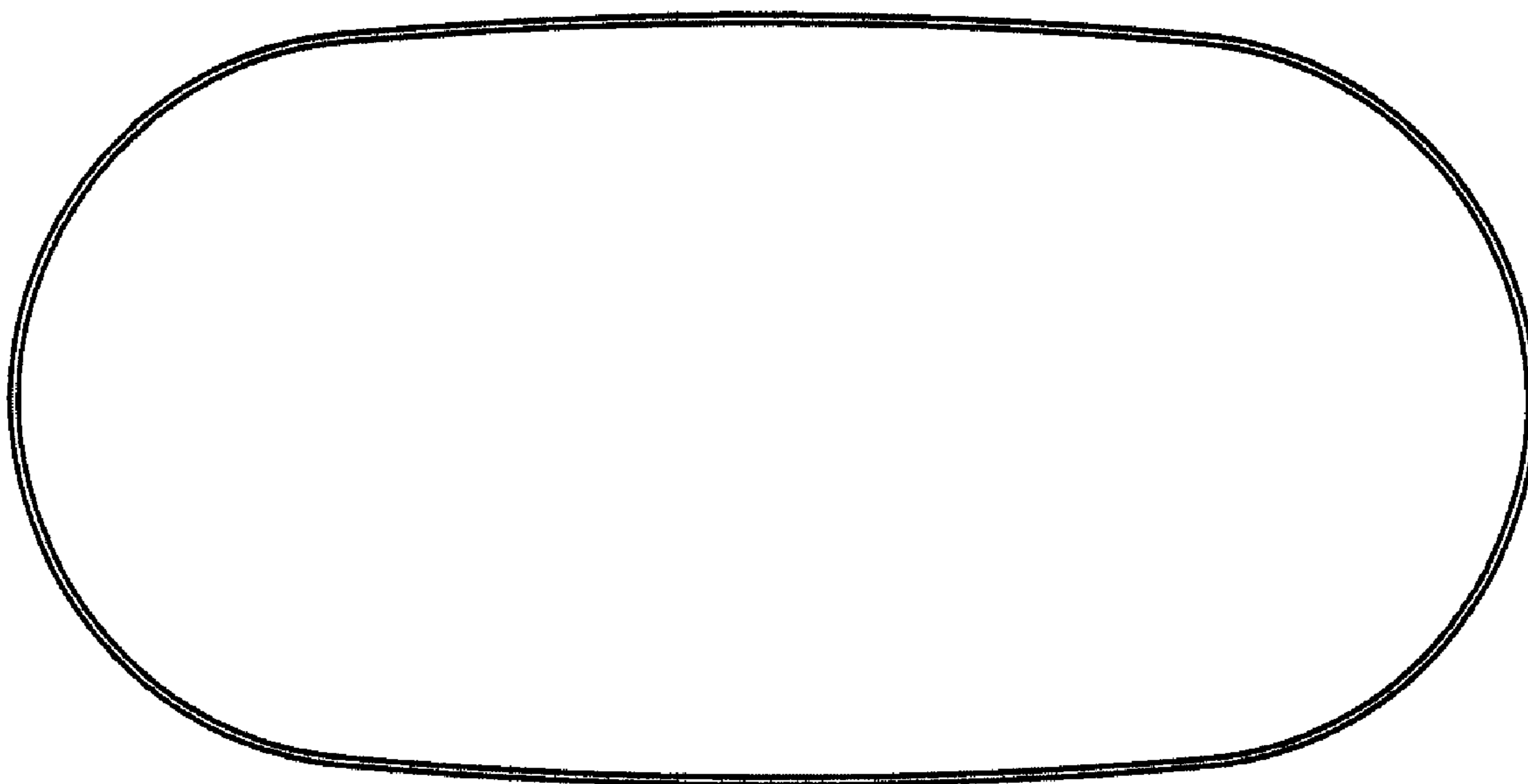
