FIG. 1 is a top plan view of the monkey design for food products of the present invention.

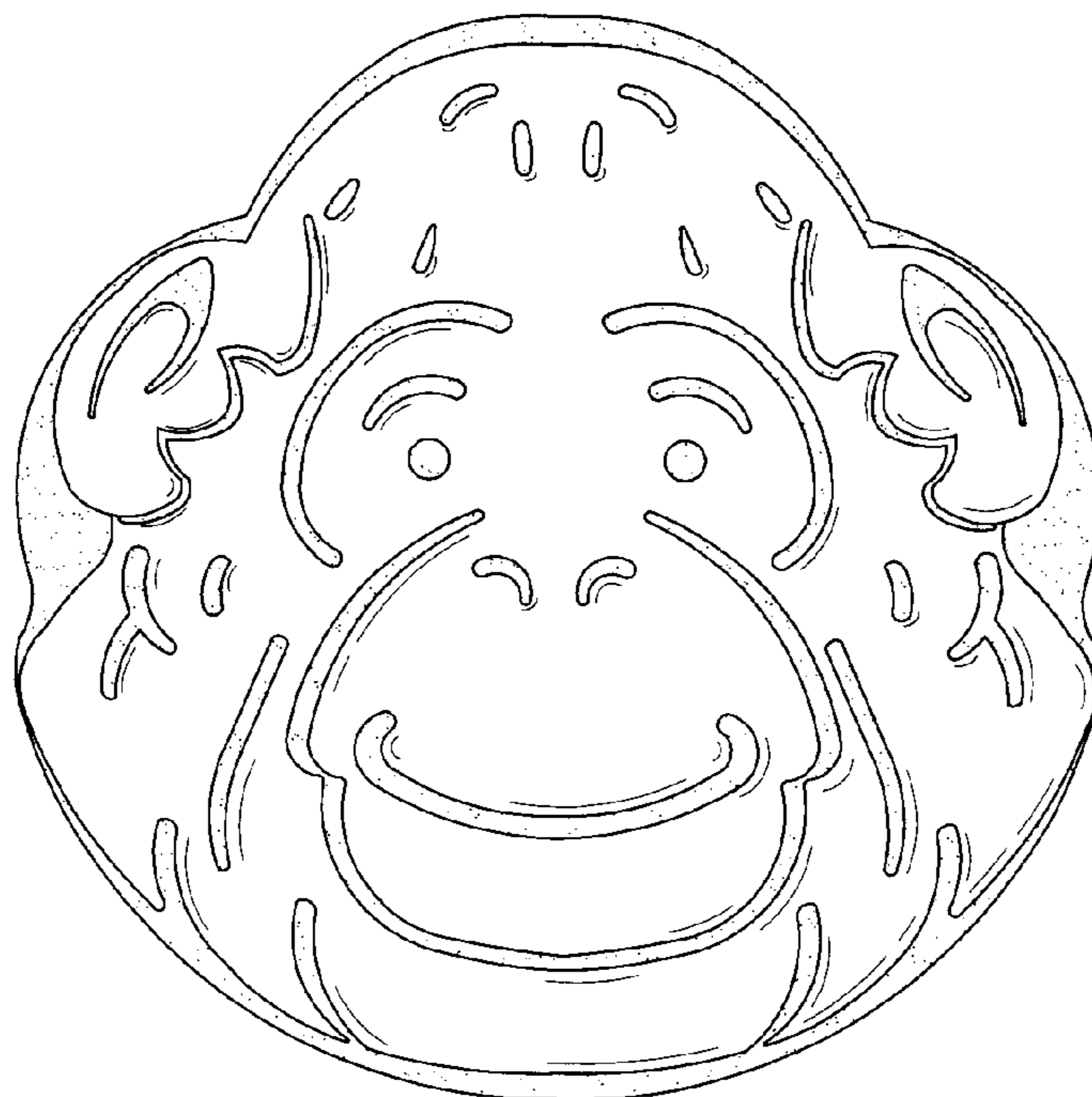
FIG. 2 is a rear elevation view of the monkey design for food products of the present invention.

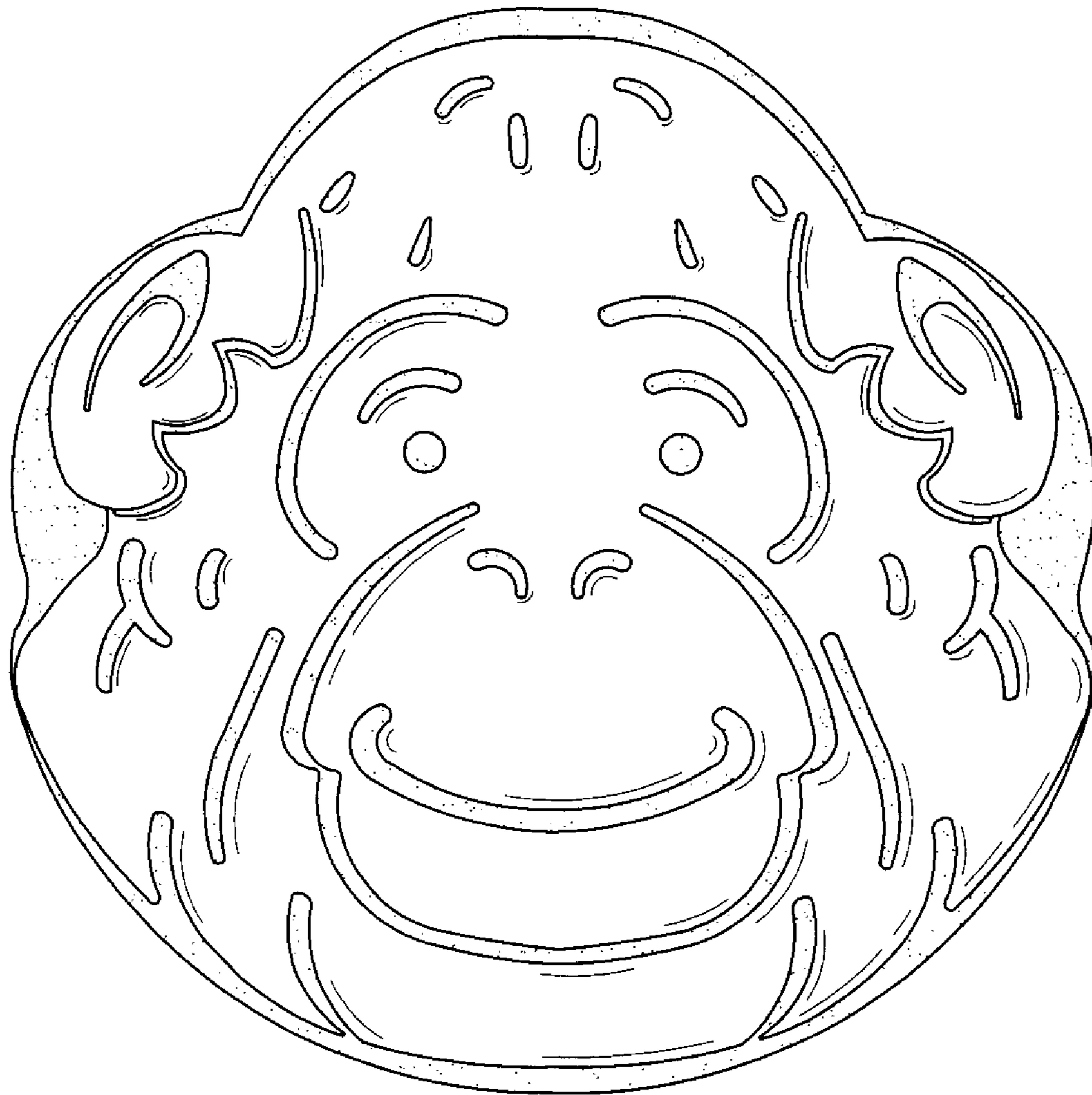

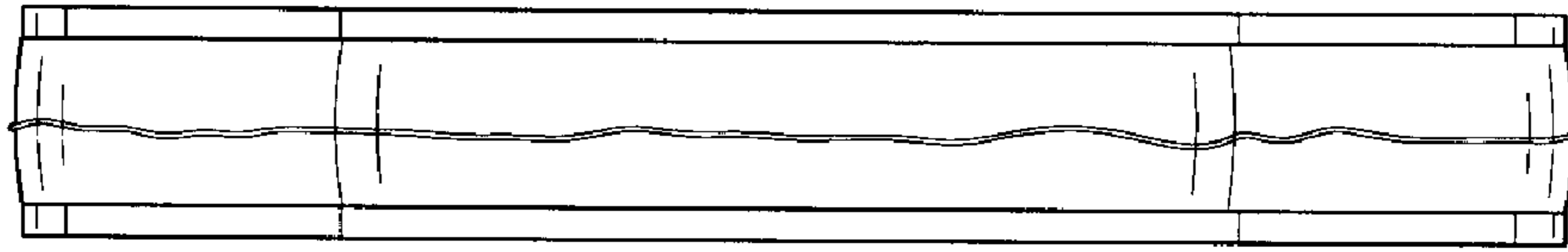

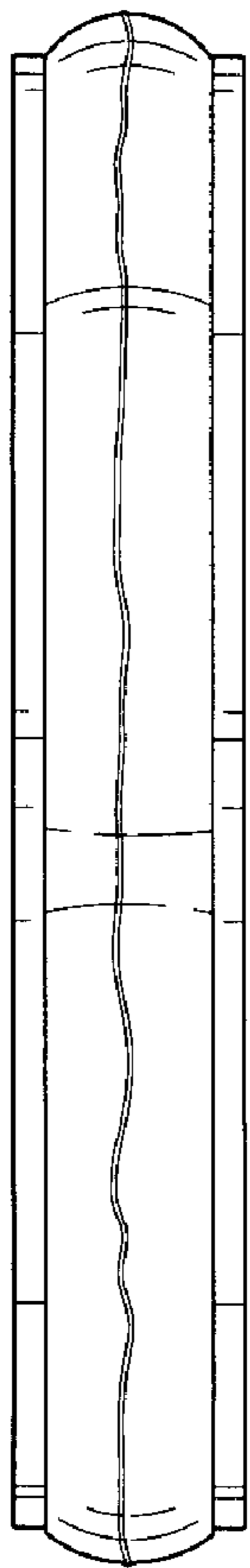

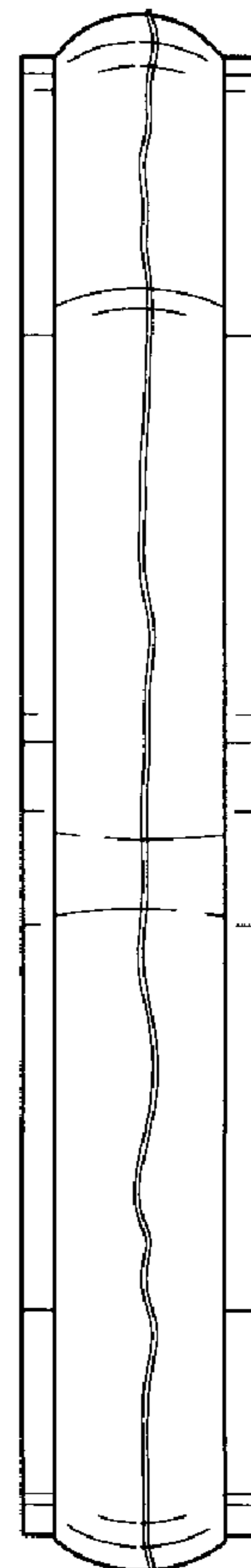

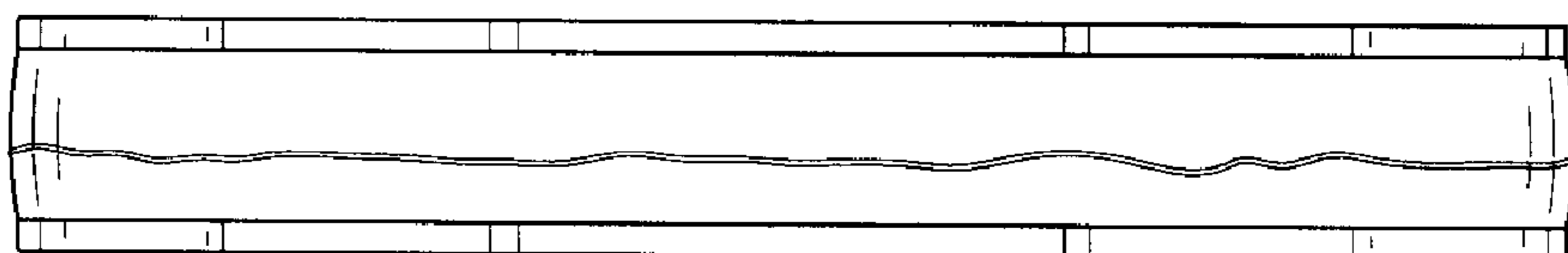
