(57) **CLAIM**

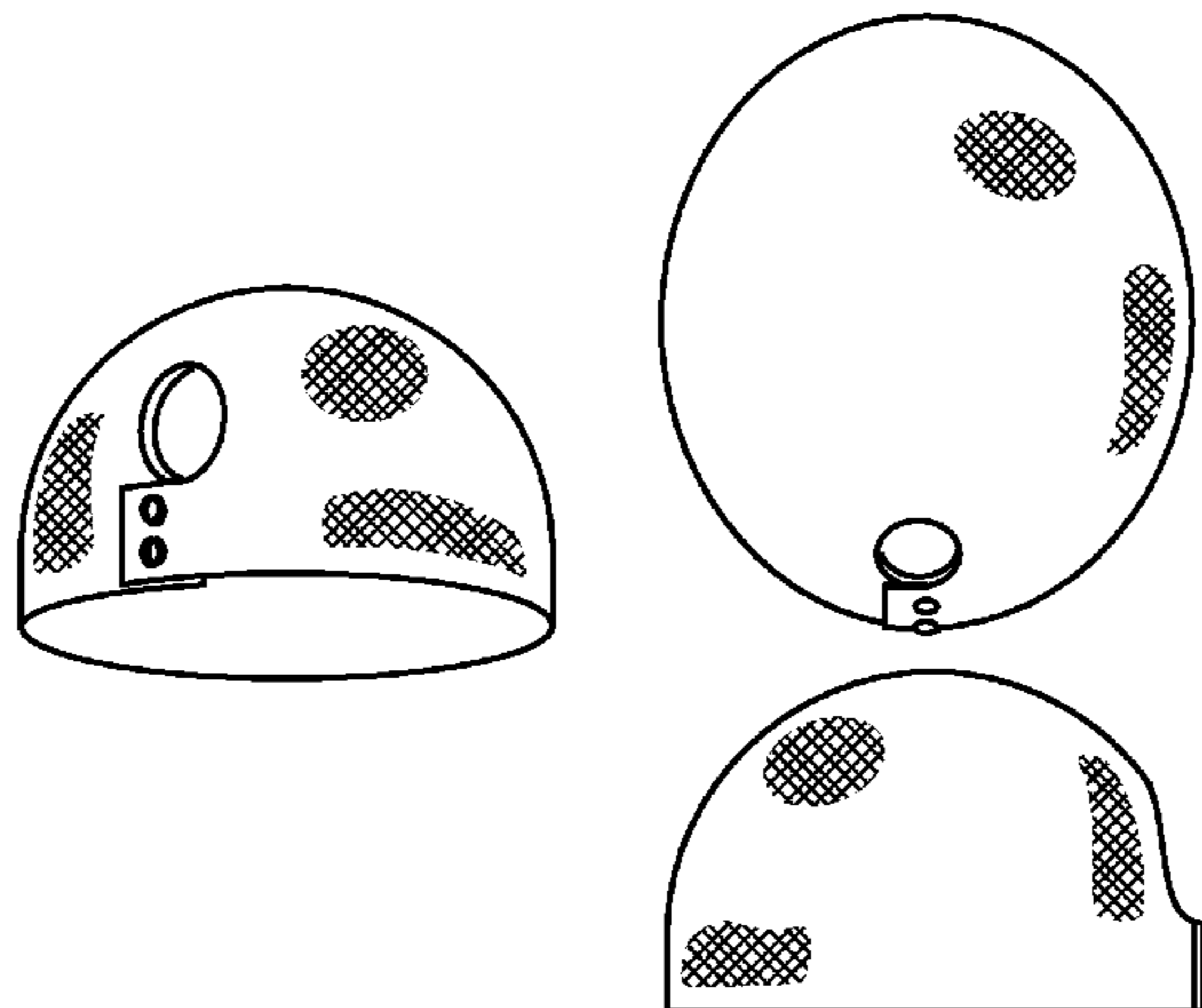
The ornamental design for a ponytail hat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ponytail hat showing our new design;
FIG. 2 is a back view of the ponytail hat shown in FIG. 1;
FIG. 3 is a front view of the side opposite FIG. 1;
FIG. 4 is the bottom view of the ponytail hat shown in FIG. 1;
FIG. 5 is the top view of the ponytail hat shown in FIG. 1;
FIG. 6 is a view of a side of the ponytail hat shown in FIG. 1; and,
FIG. 7 is a view of the side opposite FIG. 6.

The crosshatched pattern, although shown intermittently, is meant to represent fabric, and is understood to be distributed uniformly over the surface of the claimed design.

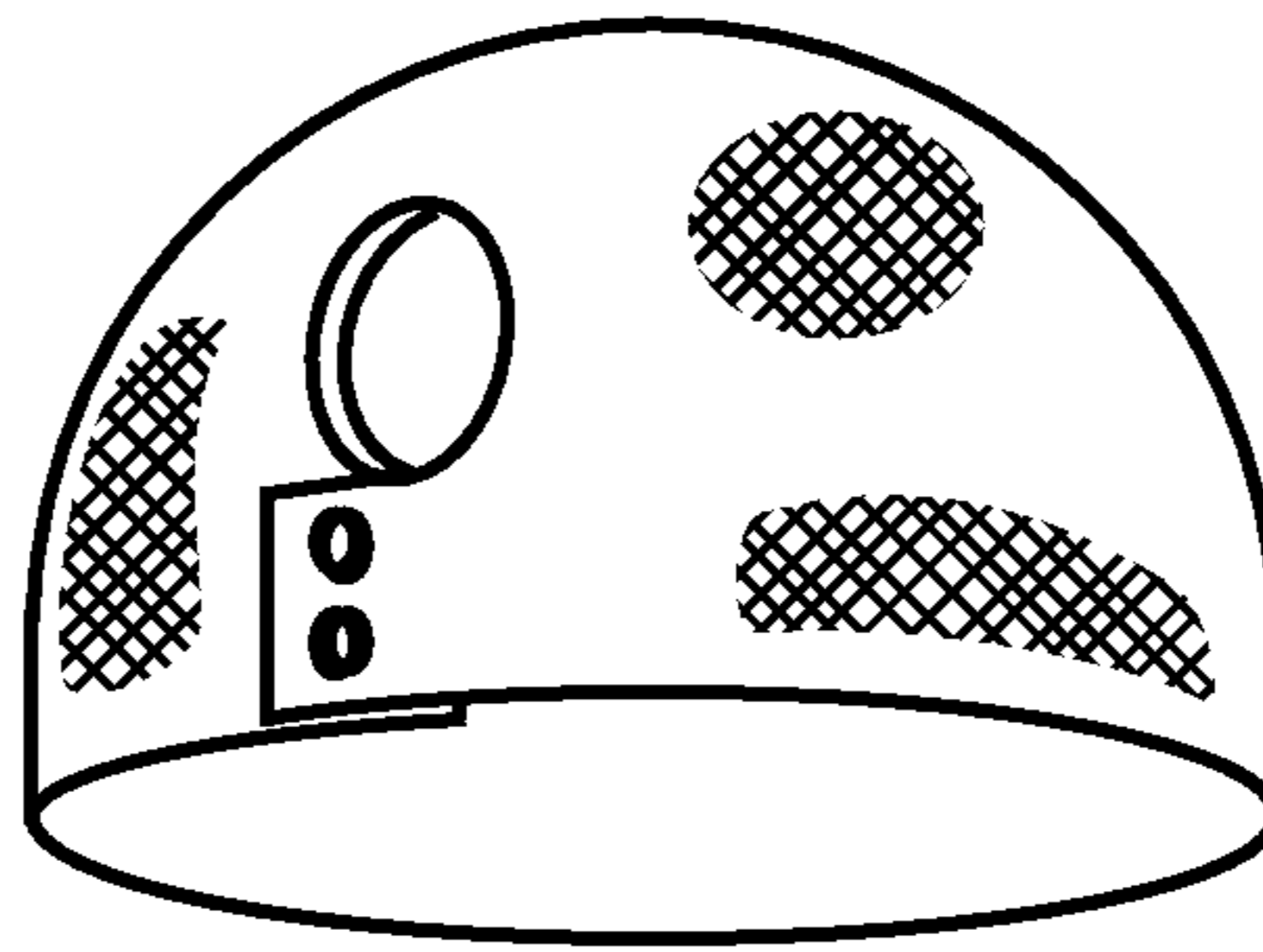

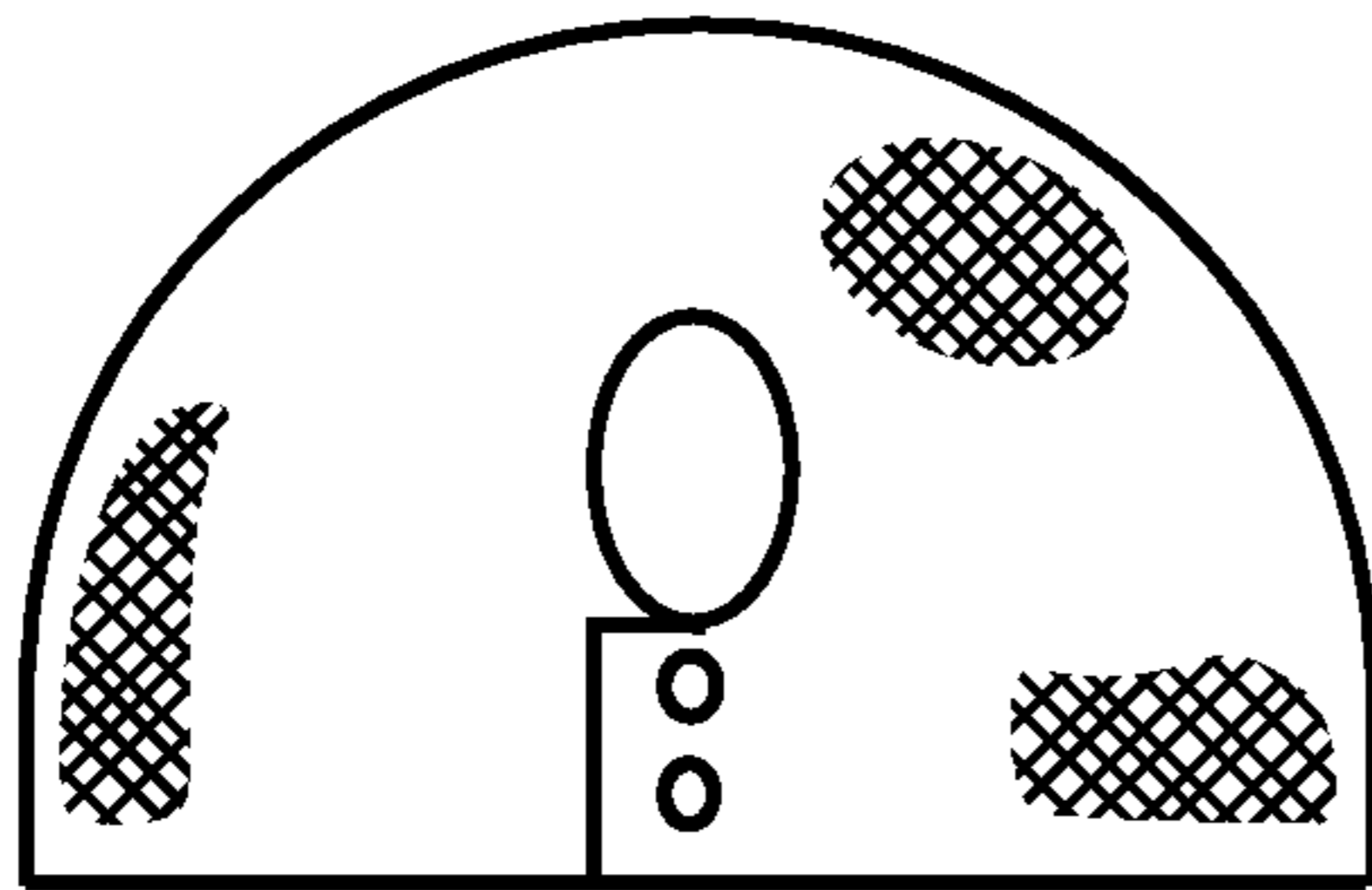

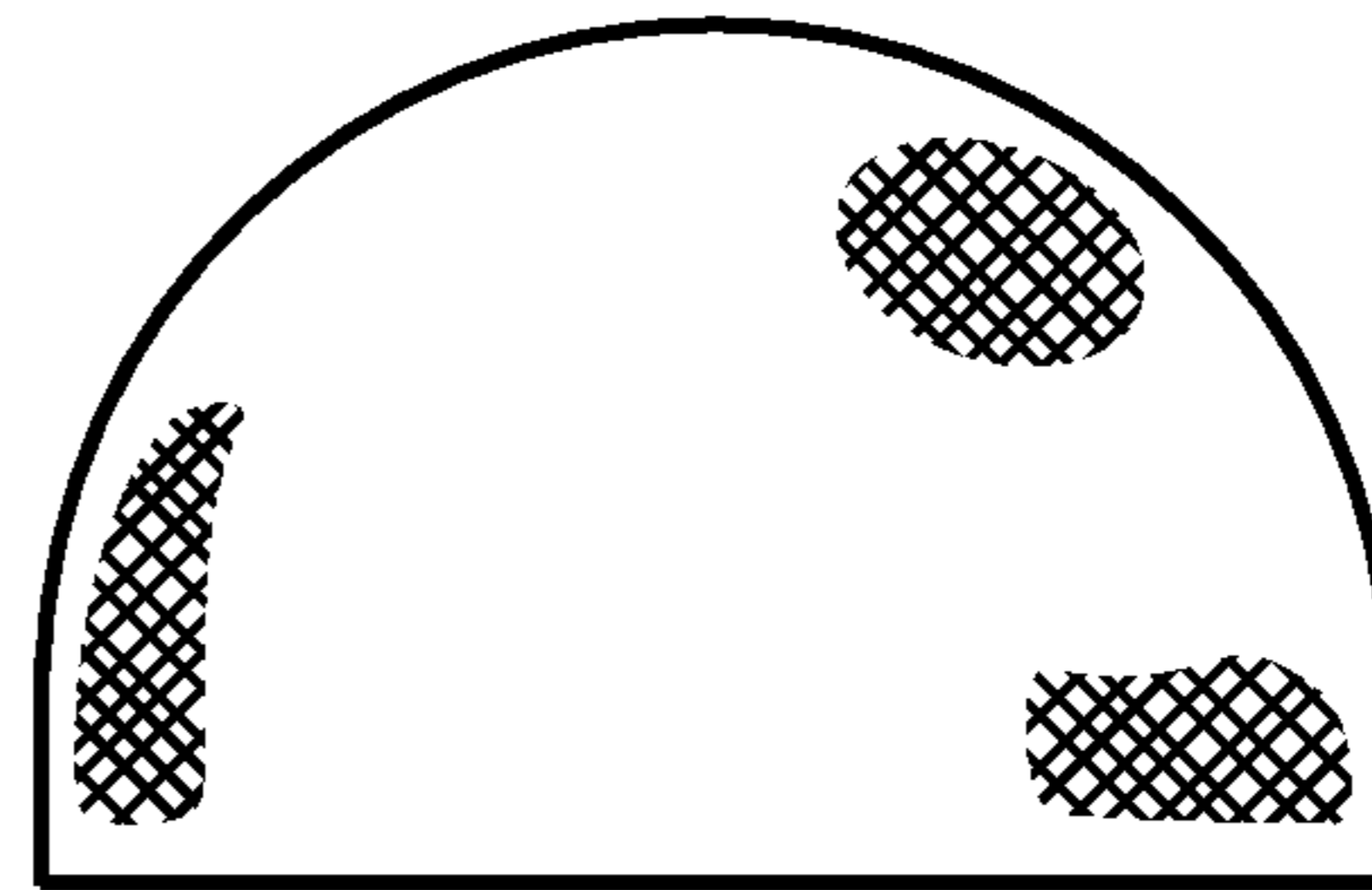

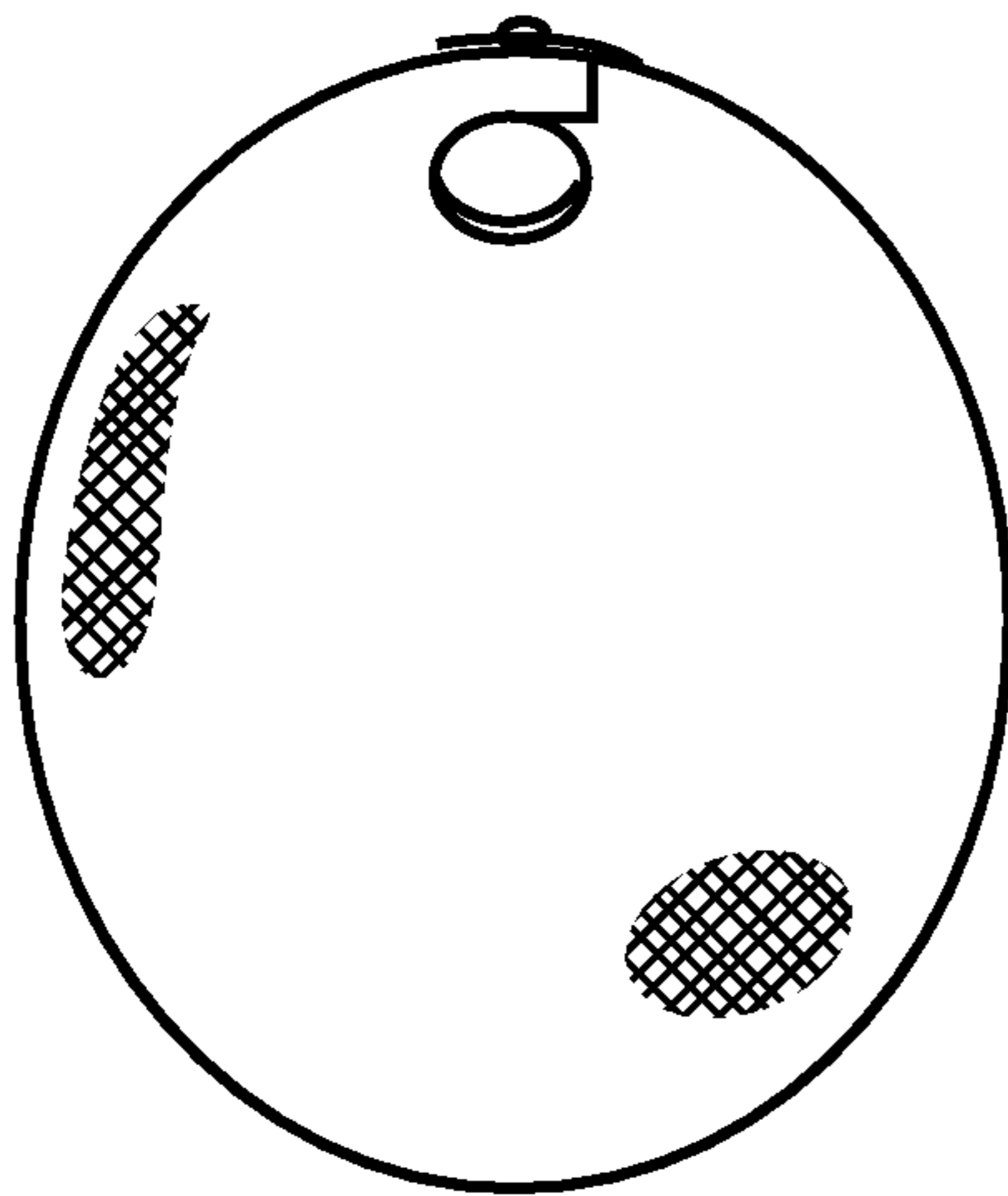

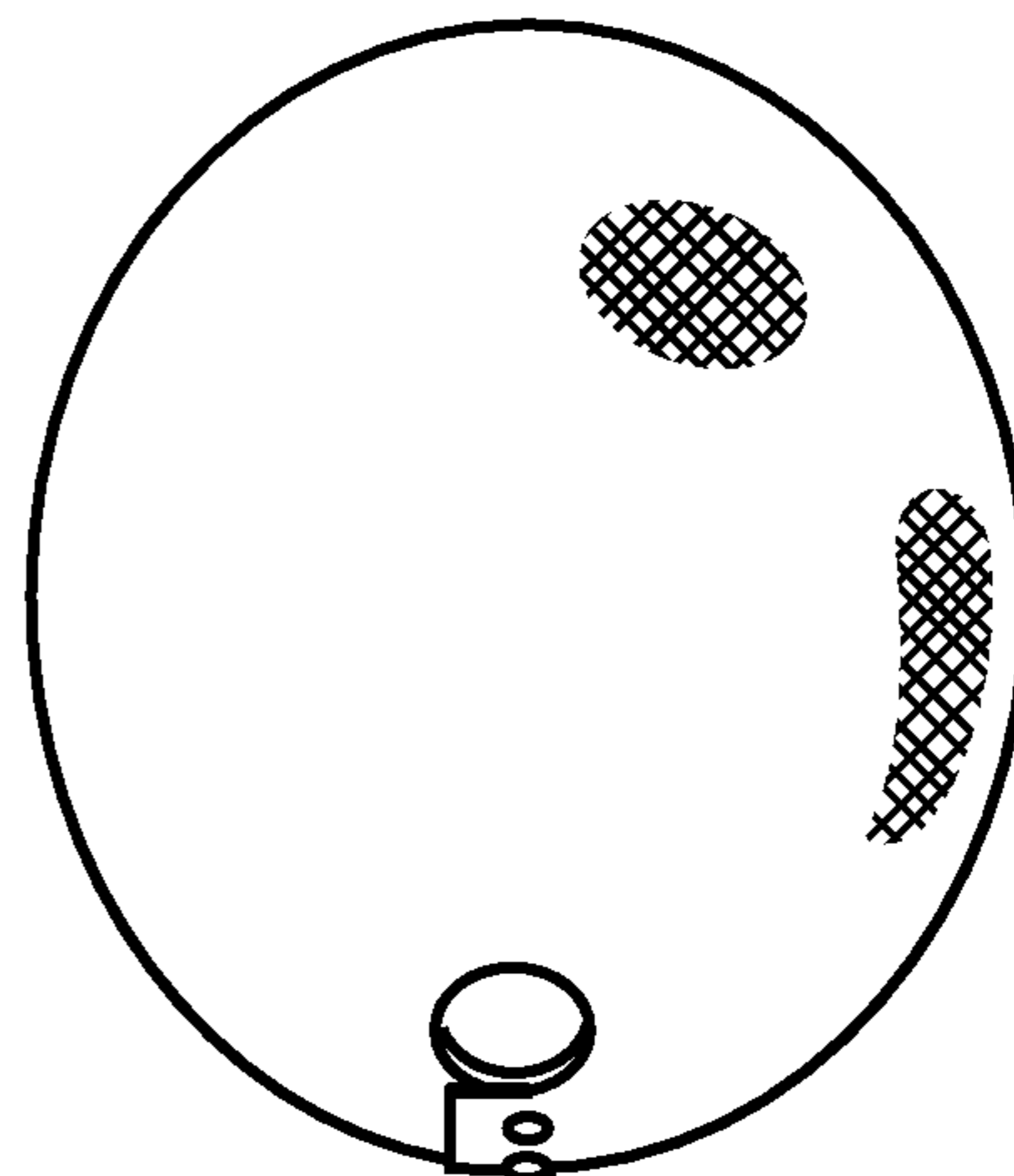

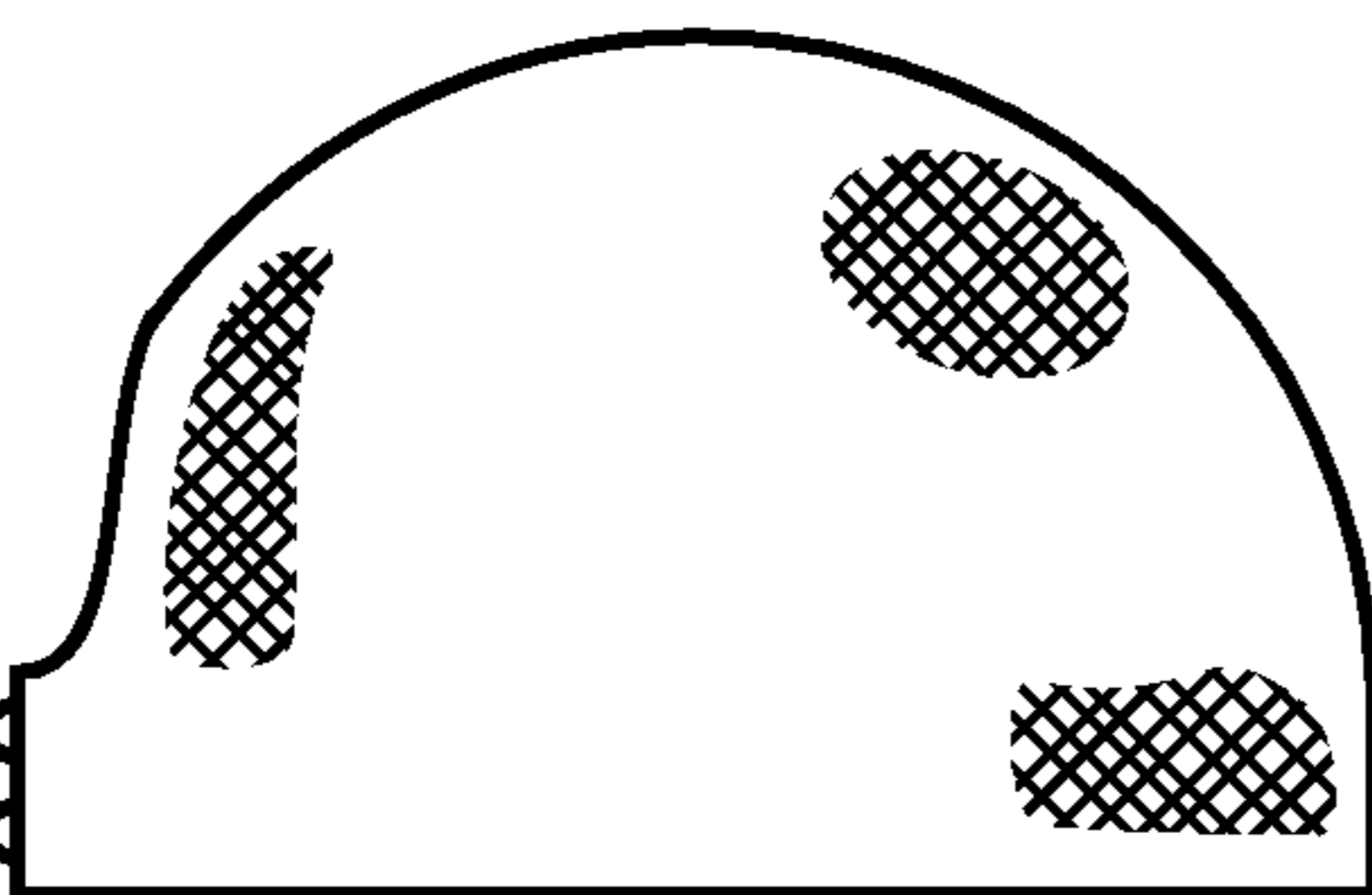
