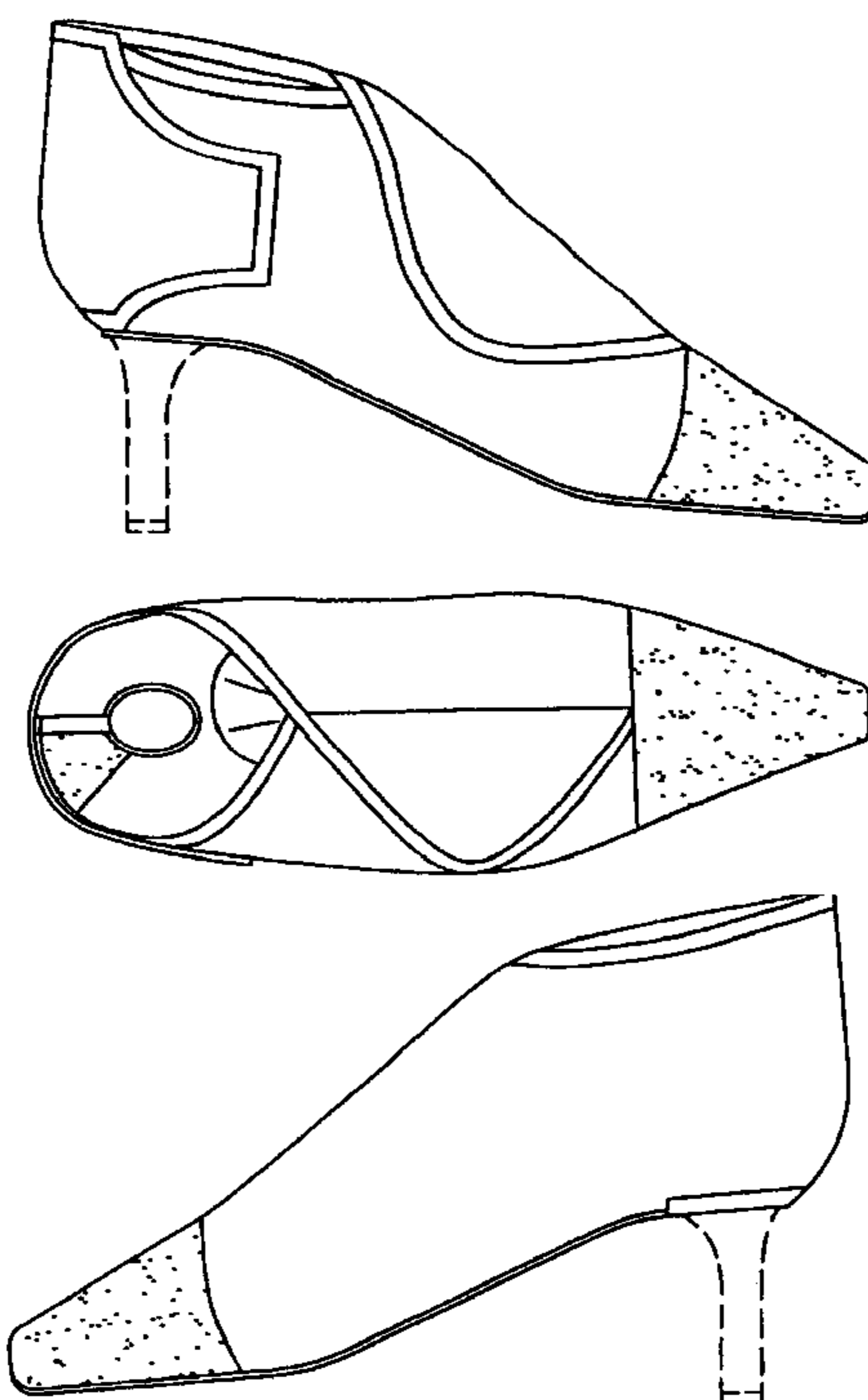
(57) **CLAIM**

The ornamental design for a shoe cover fashion accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side view of a shoe cover fashion accessory constructed in accordance with the present invention; FIG. 2 is a top view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a perspective view of the shoe cover fashion accessory; FIG. 8 is a perspective view as shown in FIG. 7 with one flap open; and, FIG. 9 is a perspective view as shown in FIGS. 7 and 8 with two flaps open.

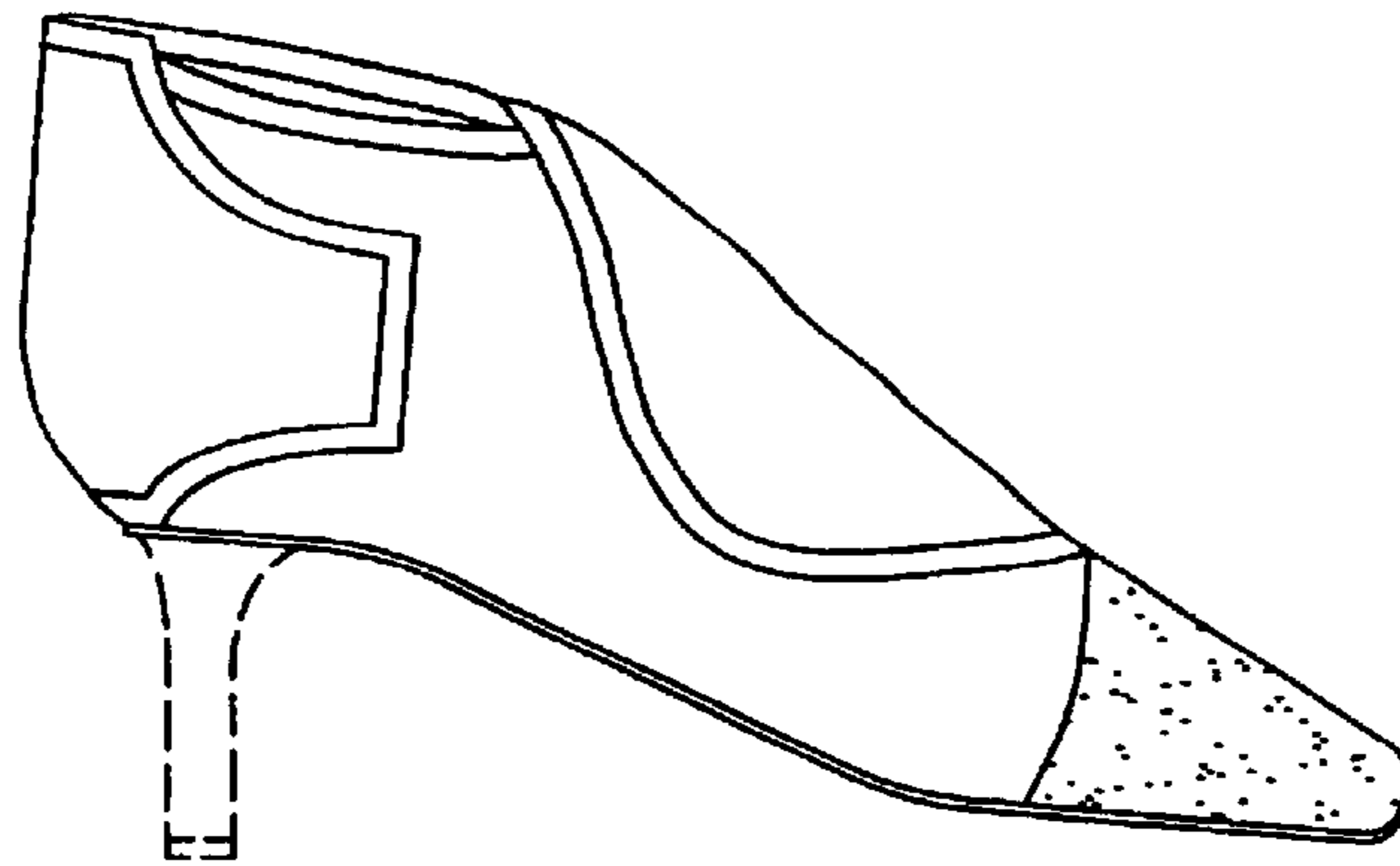

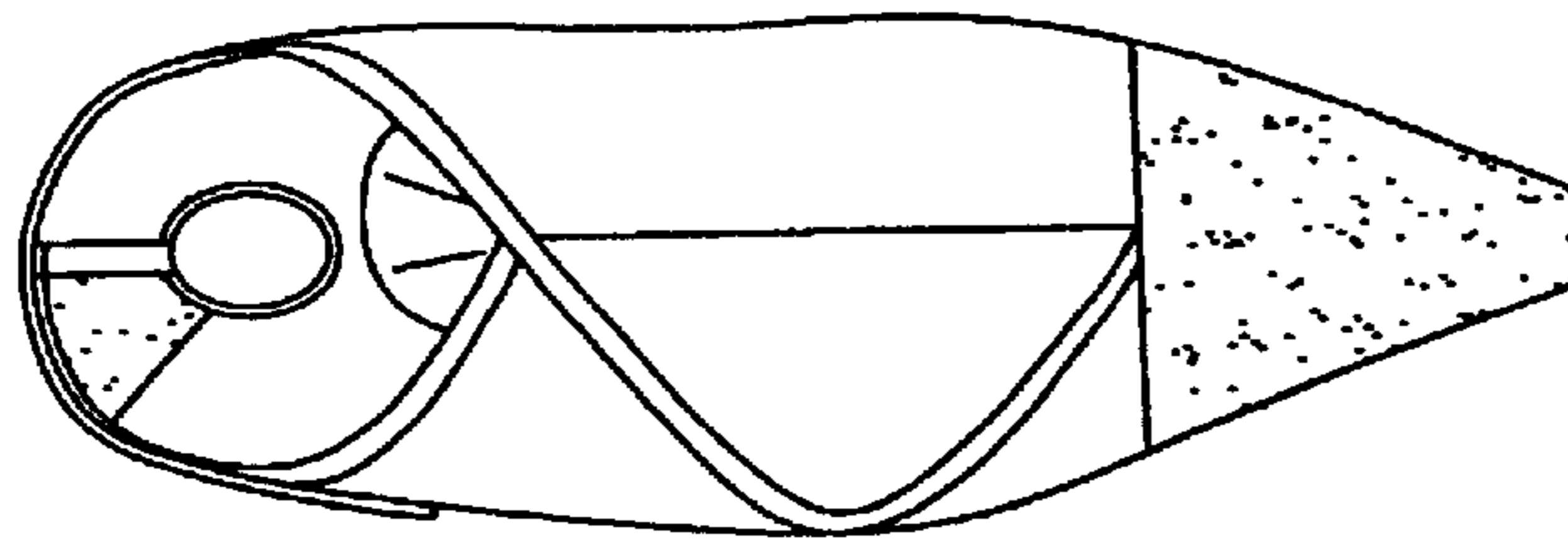

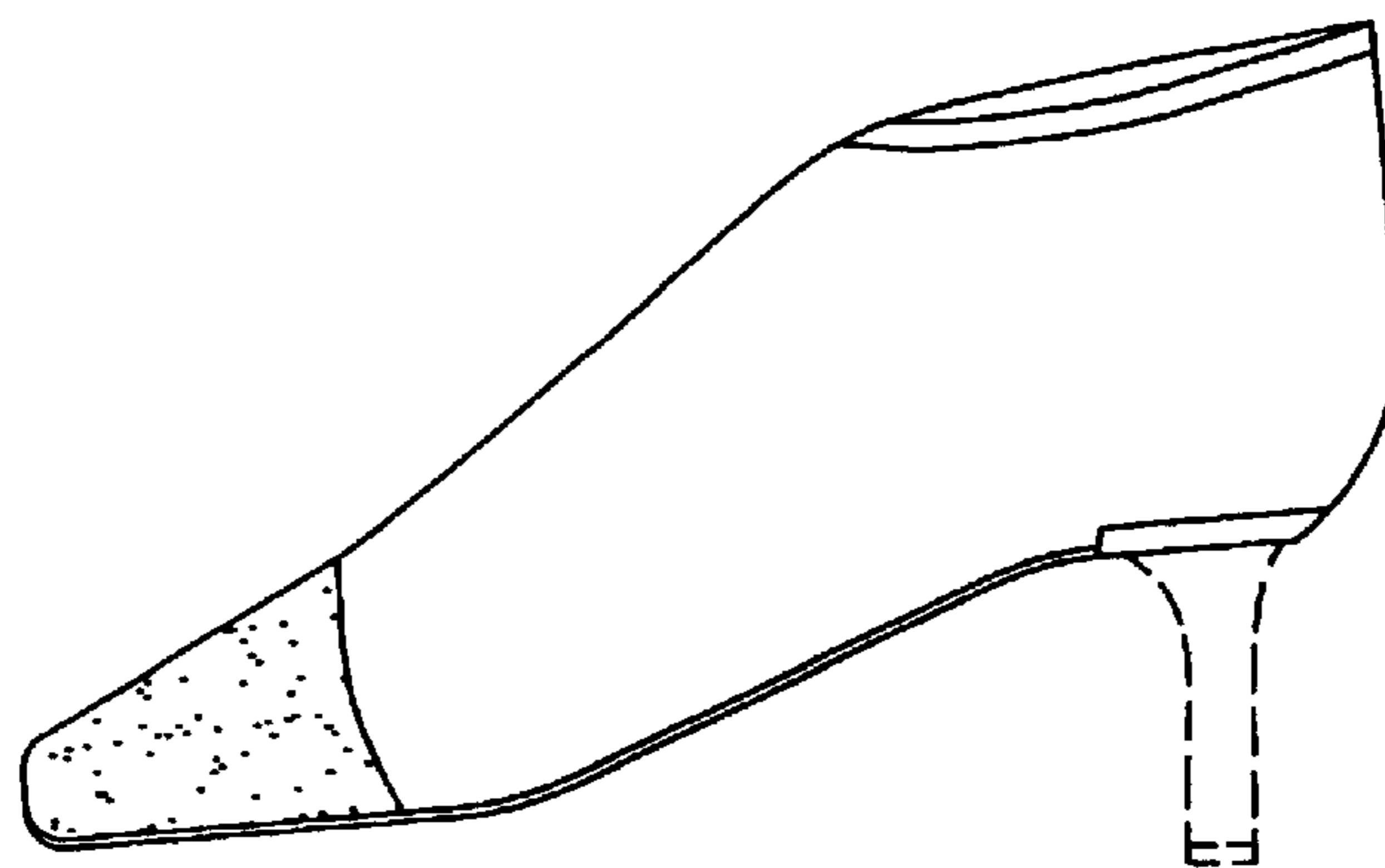

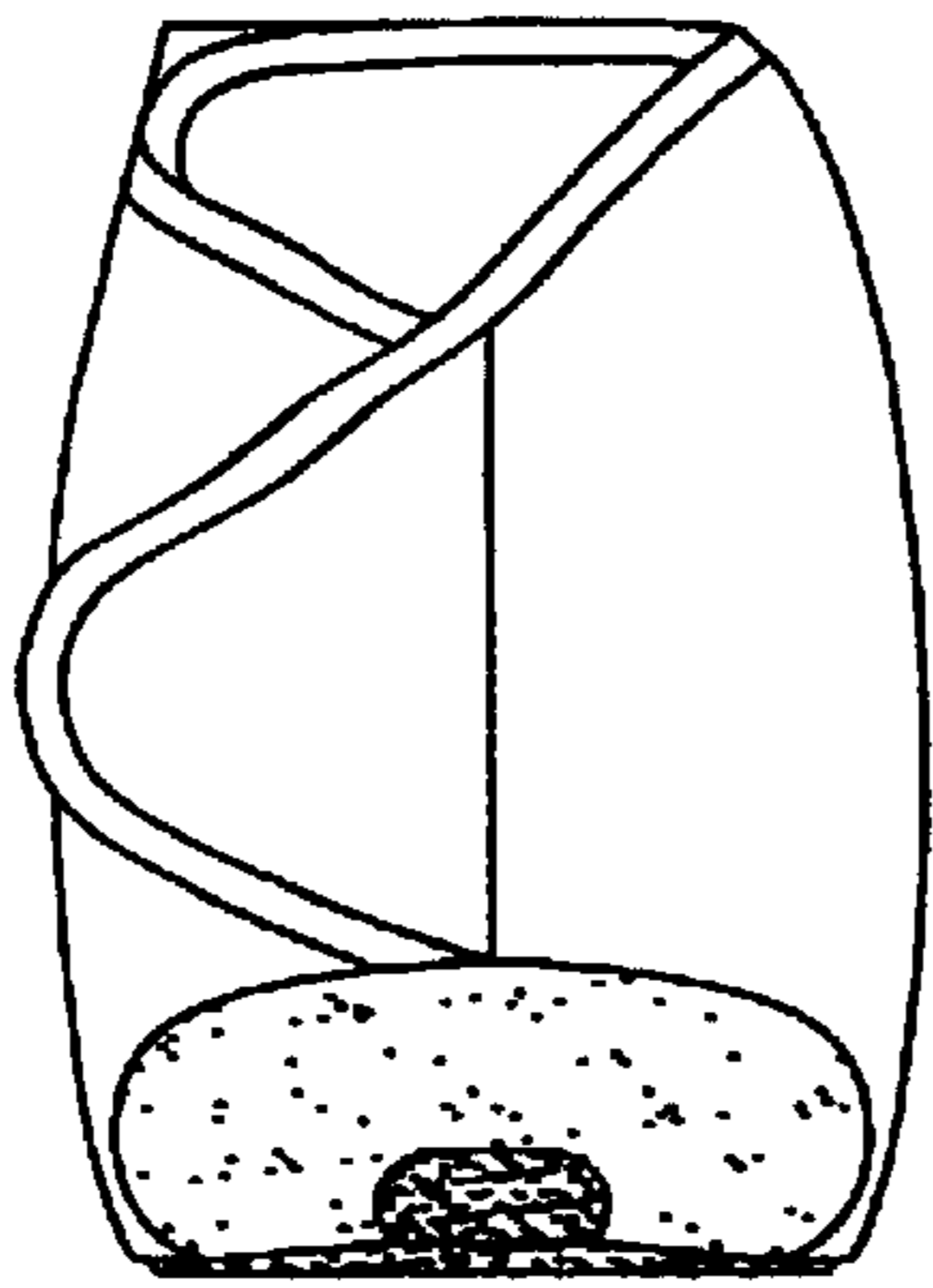

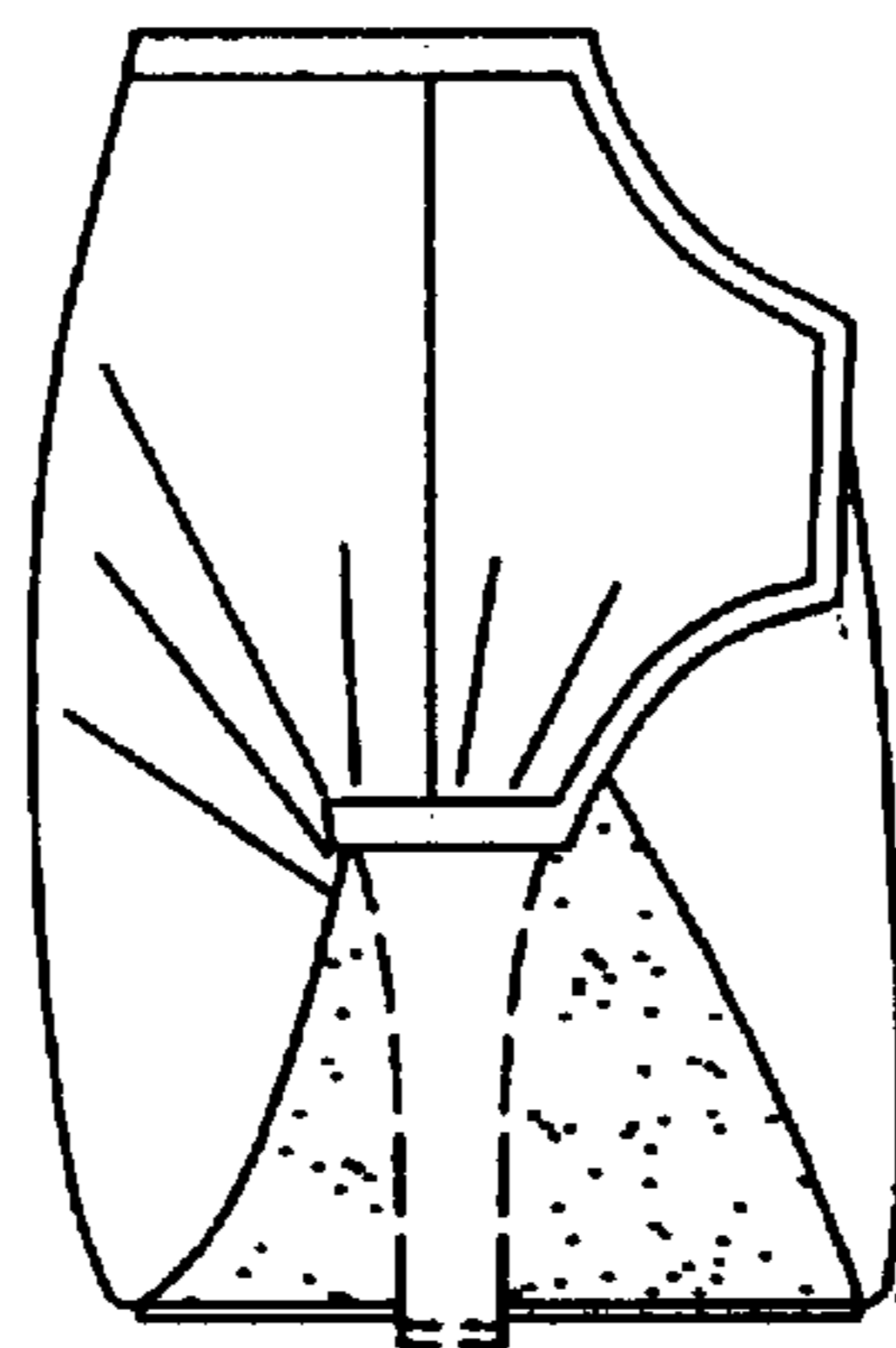

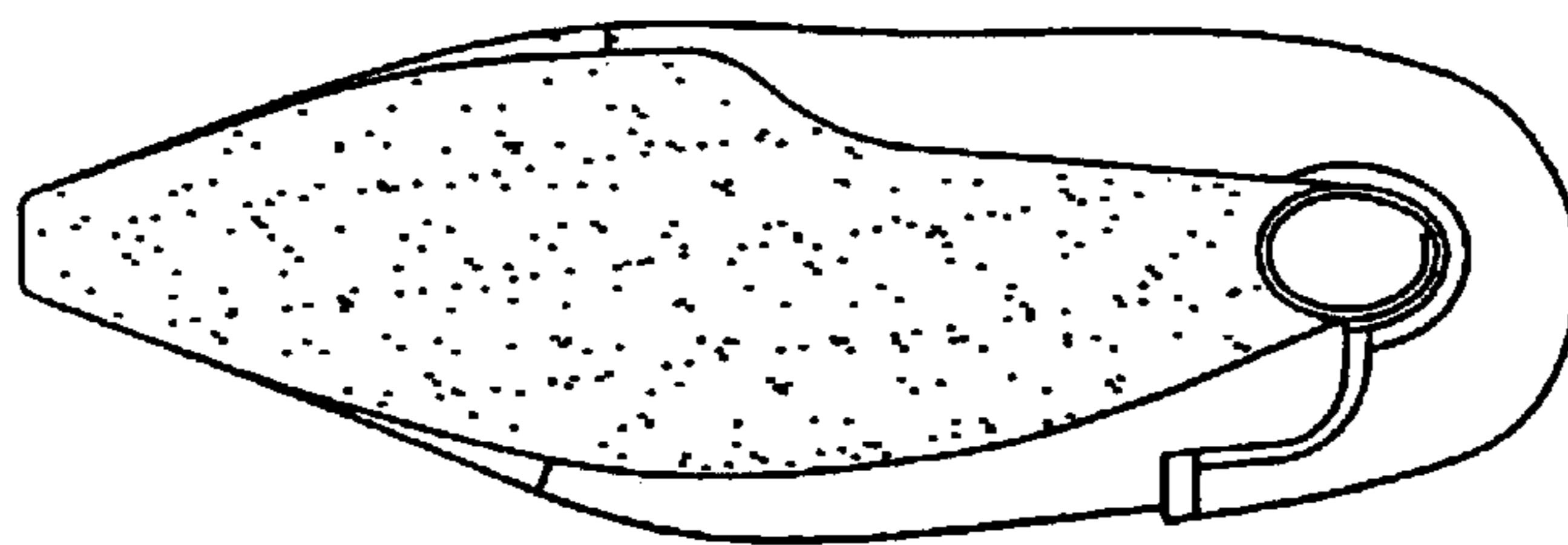

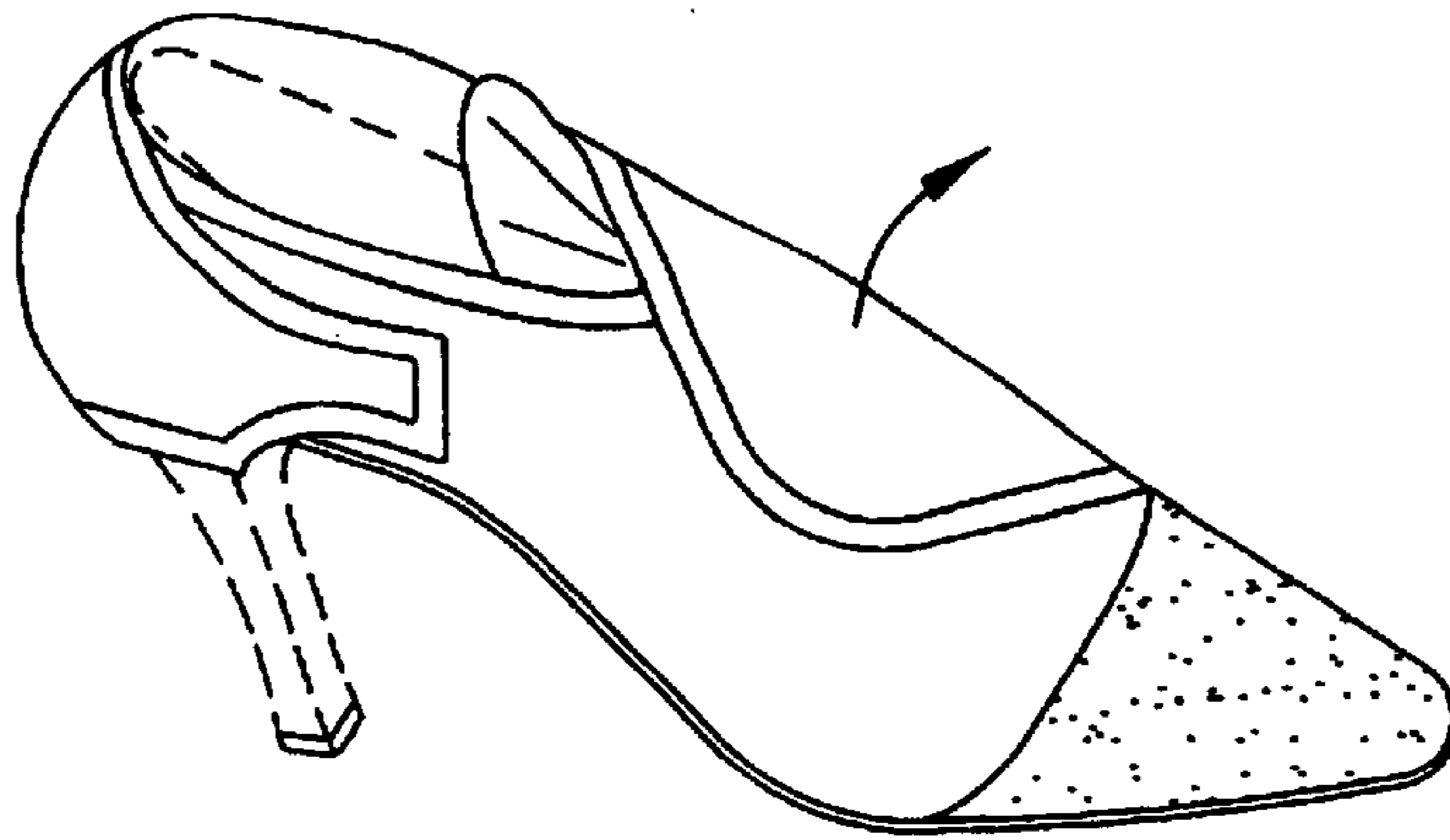

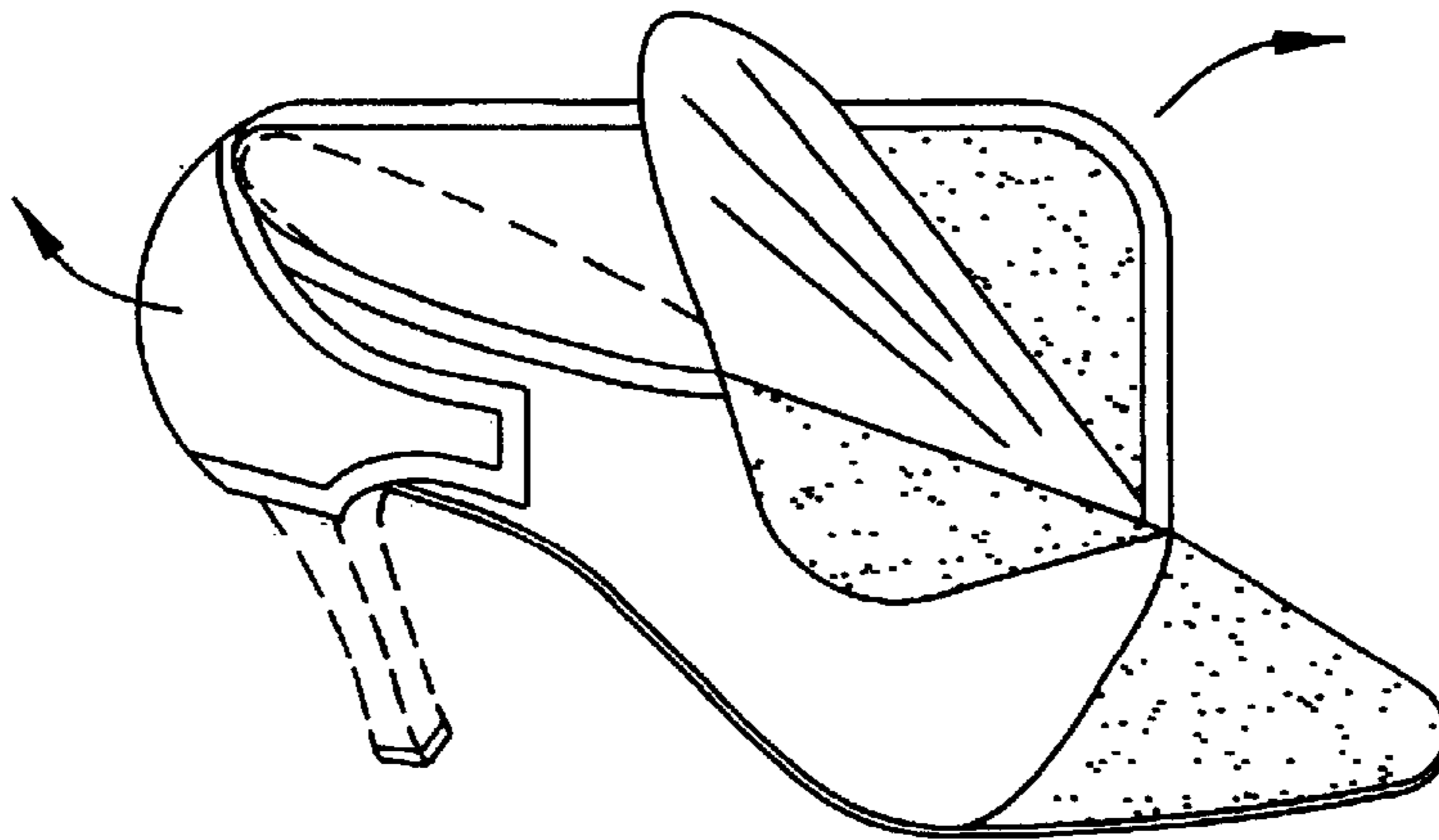

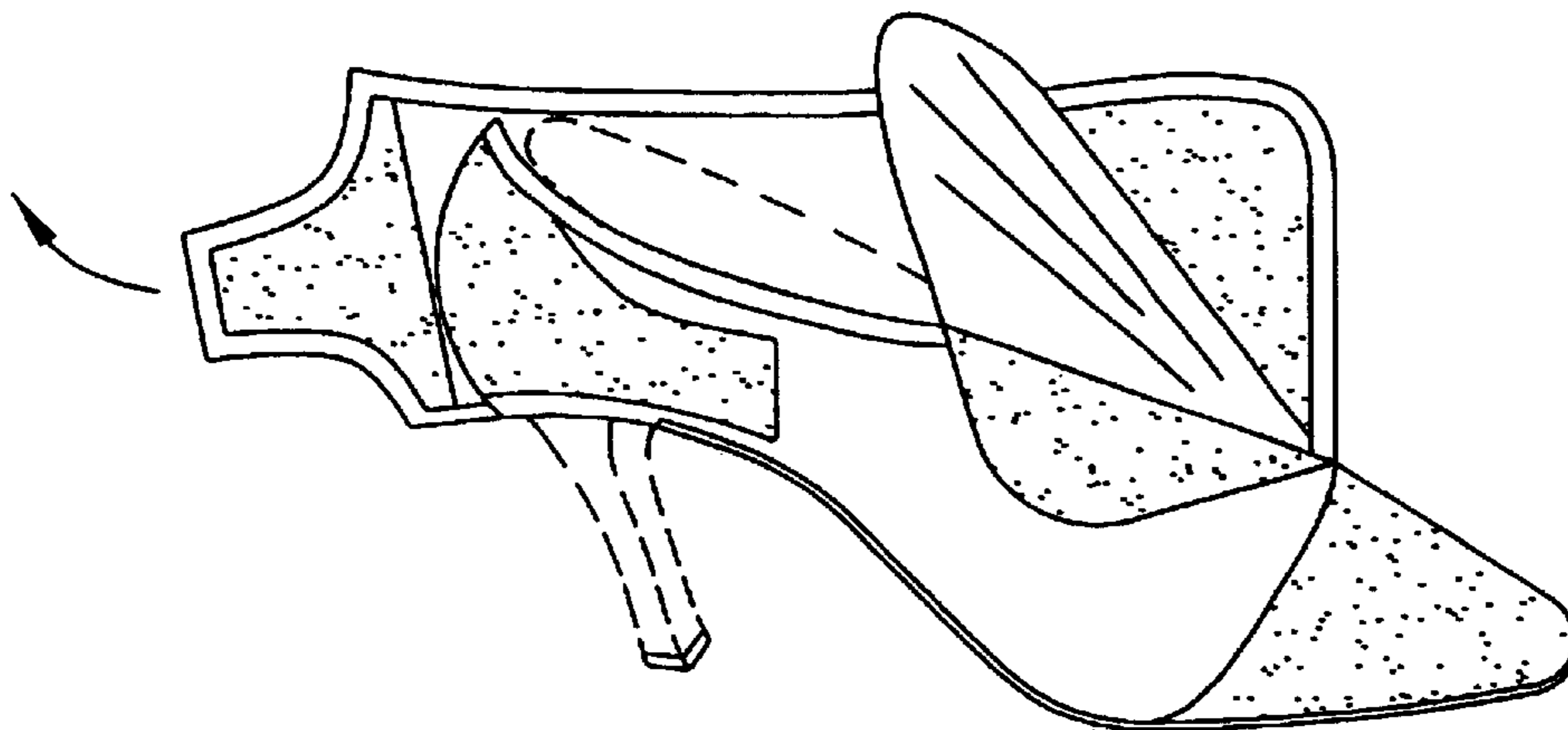
