DESCRIPTION

FIG. 1 is a bottom plan view of a shoe sole showing my new design;

FIG. 2 is a left side elevational view thereof, shown at a reduced scale;

FIG. 3 is a top plan view thereof;

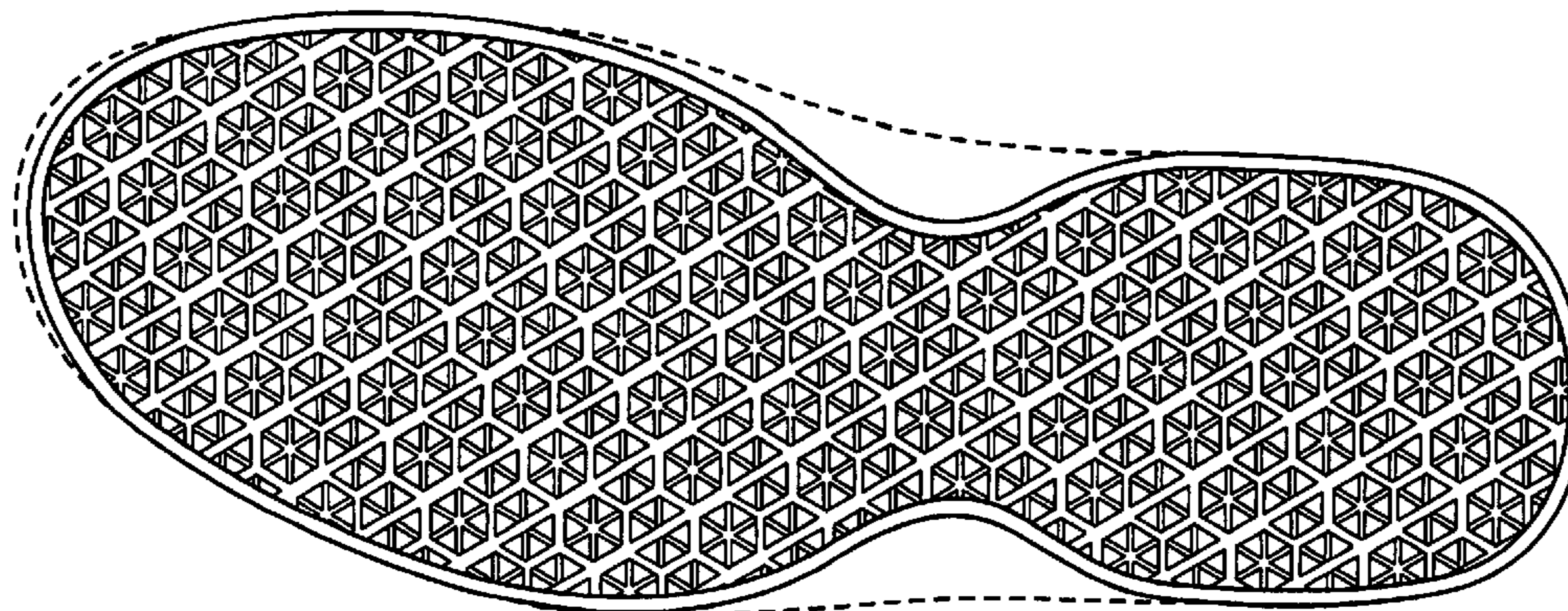
FIG. 4 is a right side elevational view thereof;

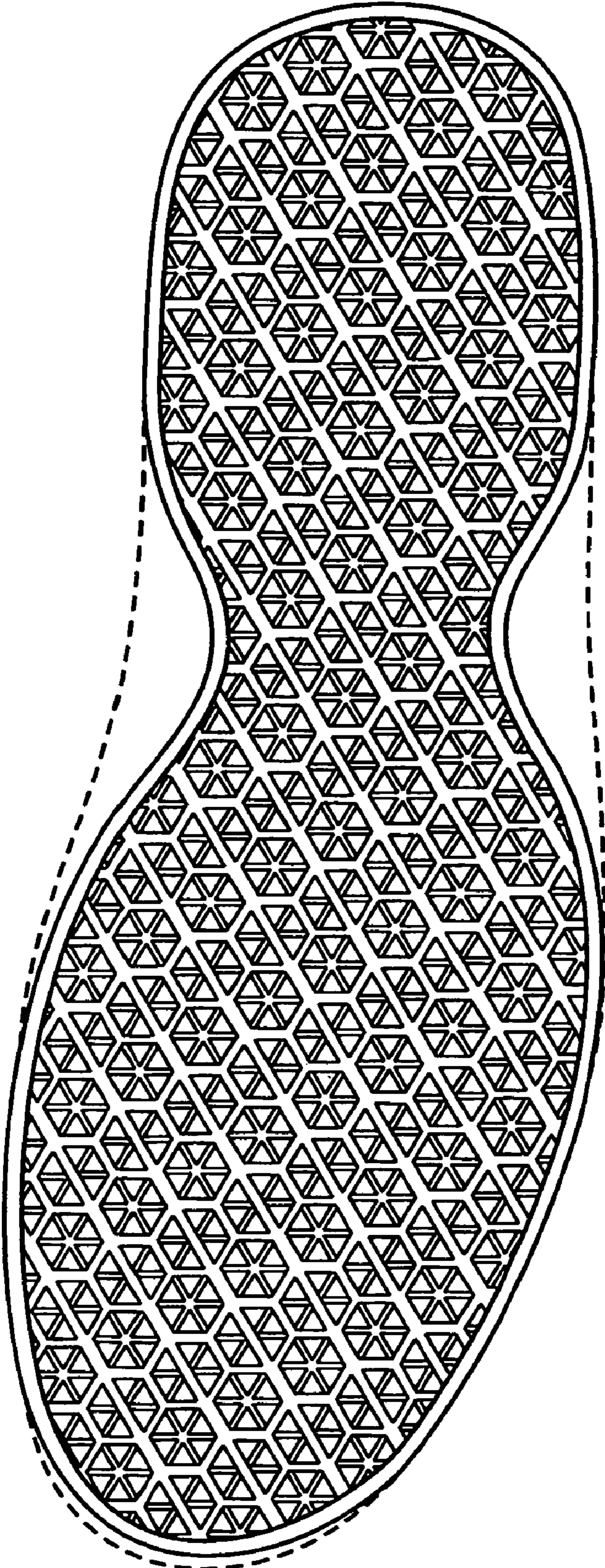

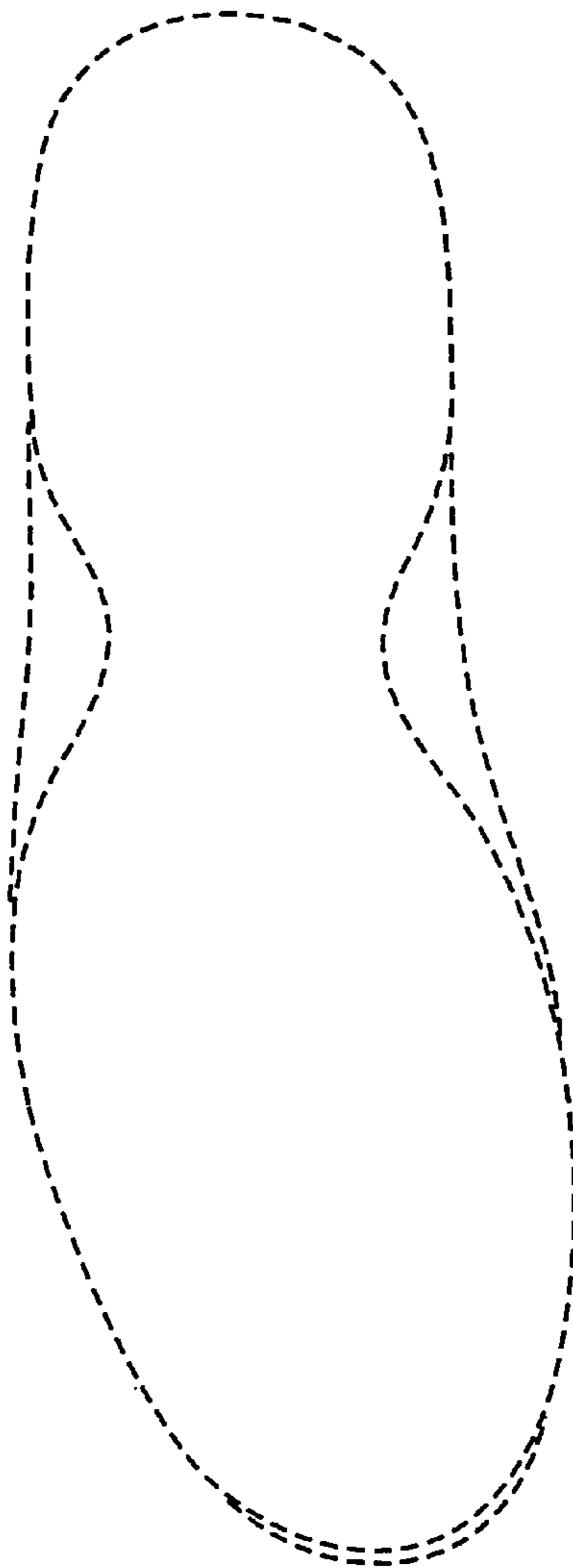
