FIG. 3 is a lateral view (right side) thereof

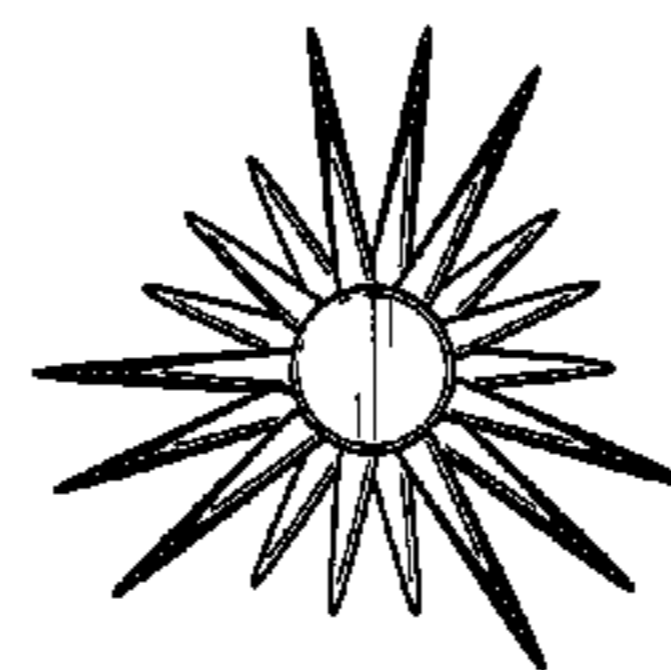
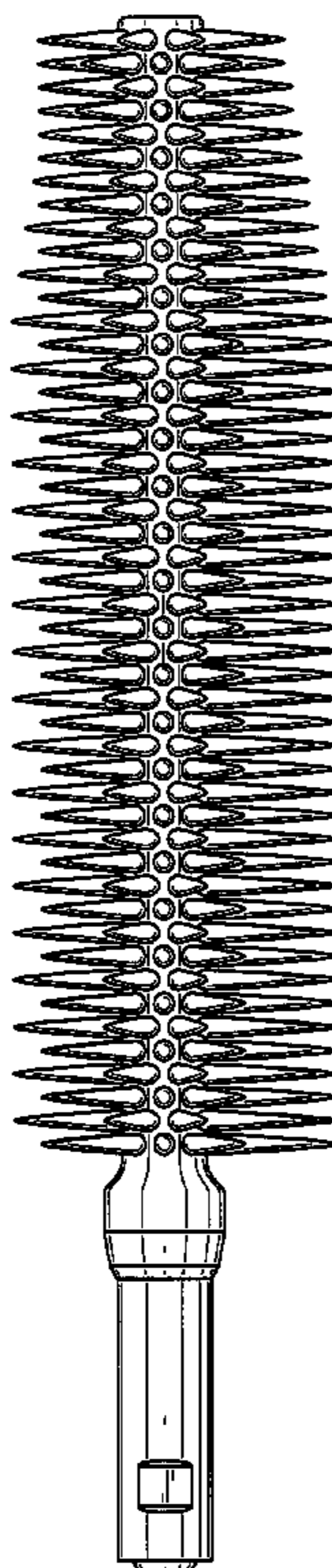
FIG. 4 is a rear view thereof;

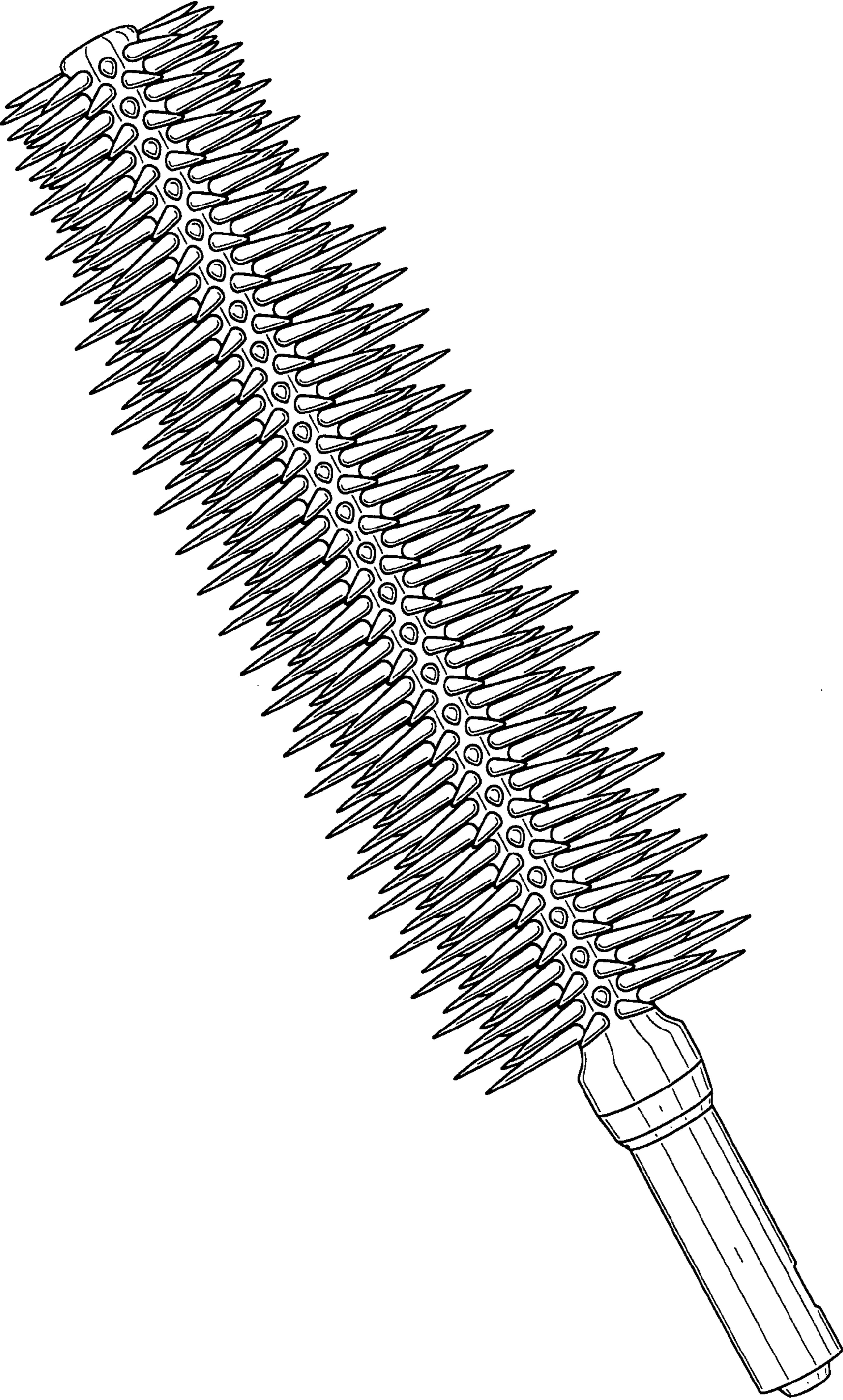

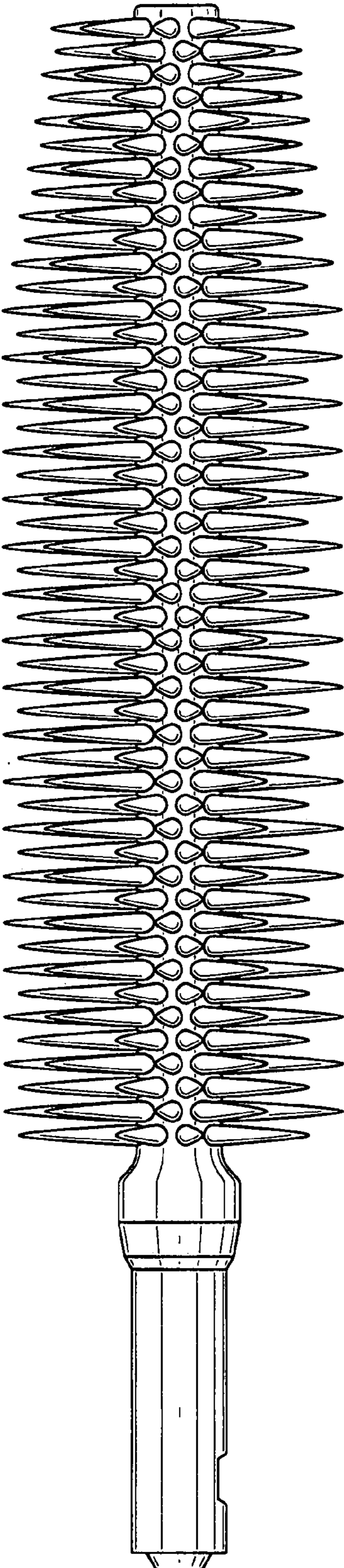

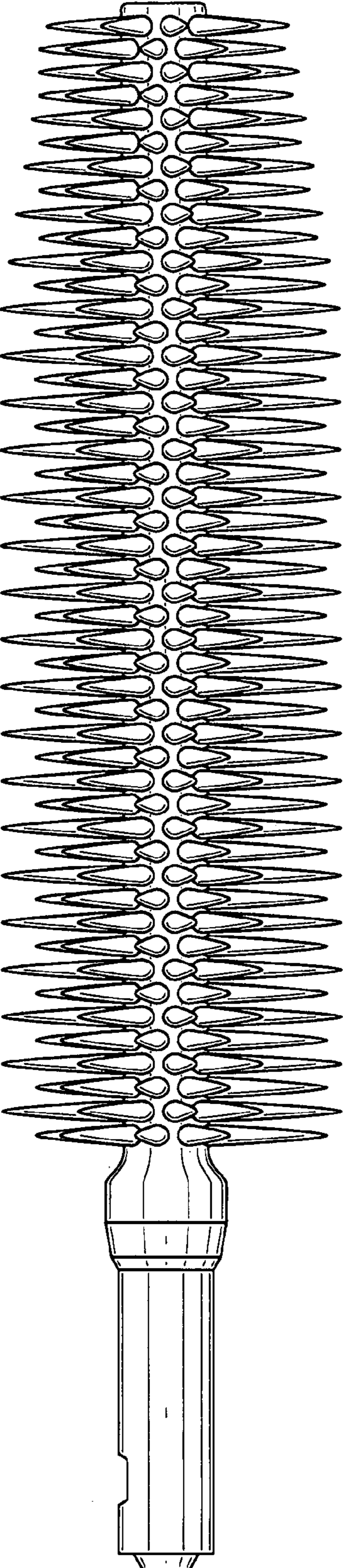

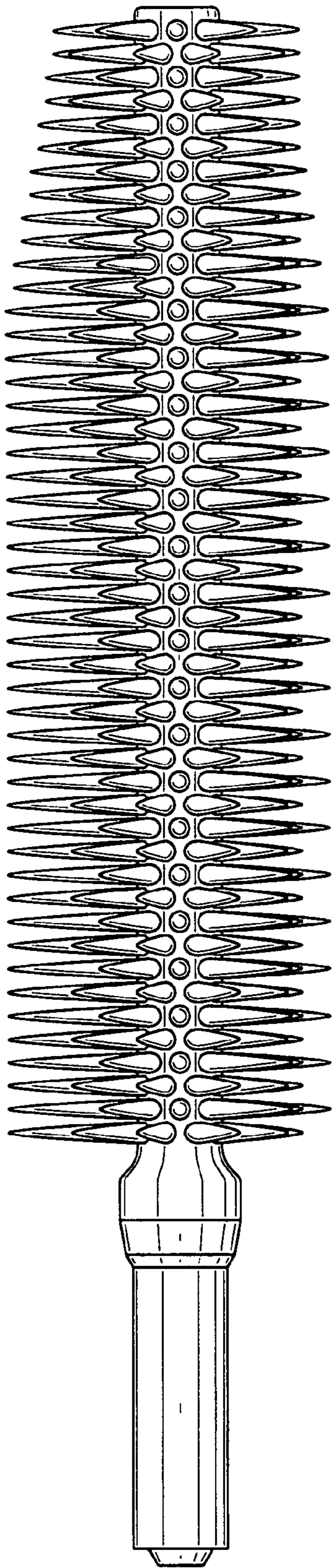

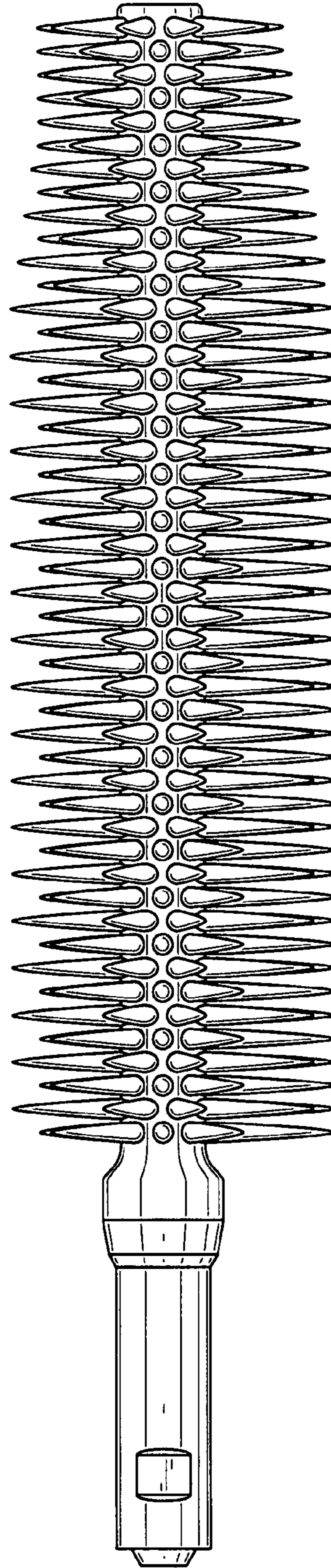

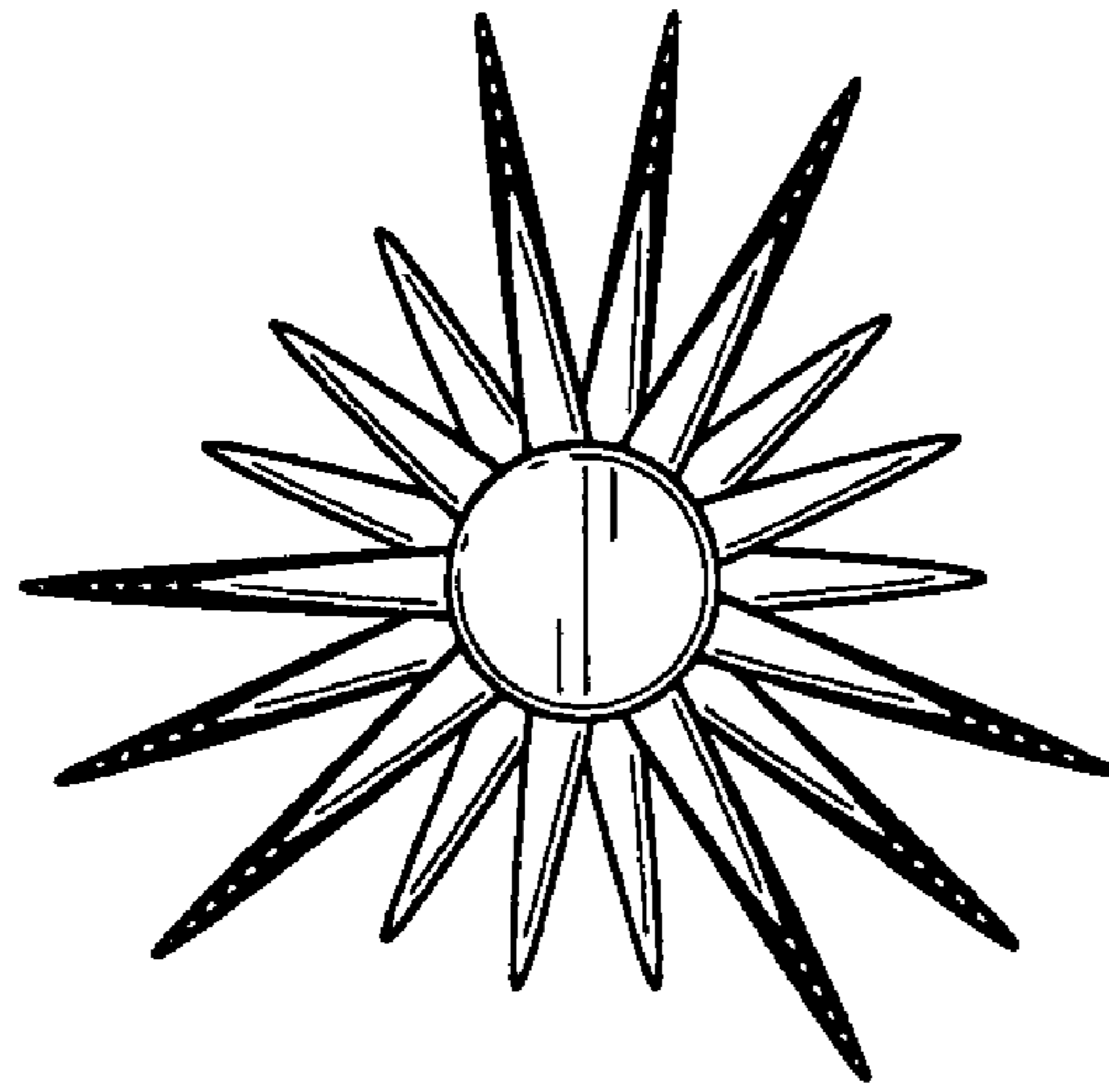

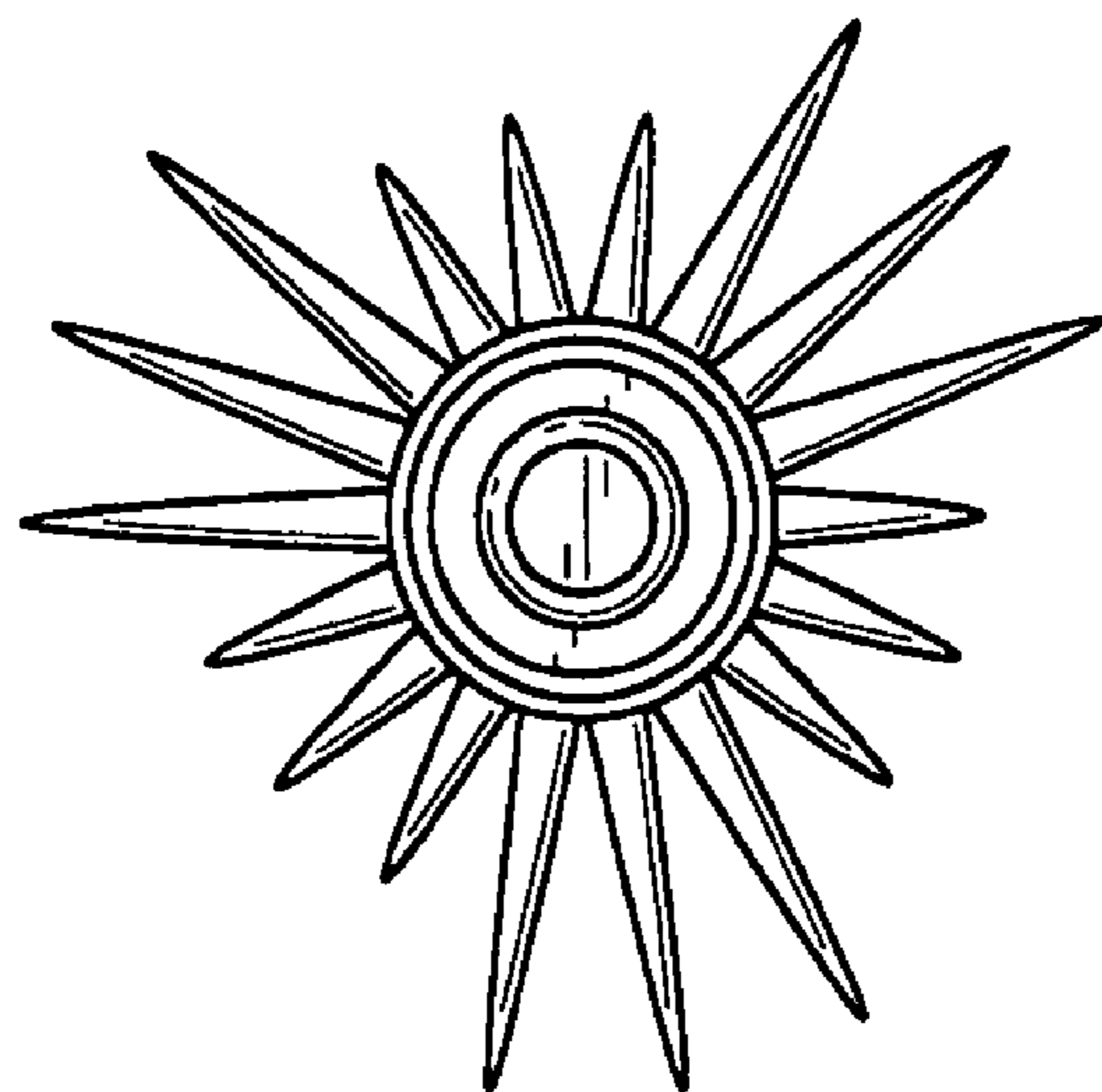
