(57) **CLAIM**

The ornamental design for paper tissue, as shown and described.

DESCRIPTION

The sole FIGURE is a top plan view of paper tissue that is shown cut away on each of its four sides to indicate that a specific length and width of paper tissue forms no part of the claimed design, it being understood that the surface pattern repeats uniformly throughout the length and width of the paper tissue.
