**DESCRIPTION**

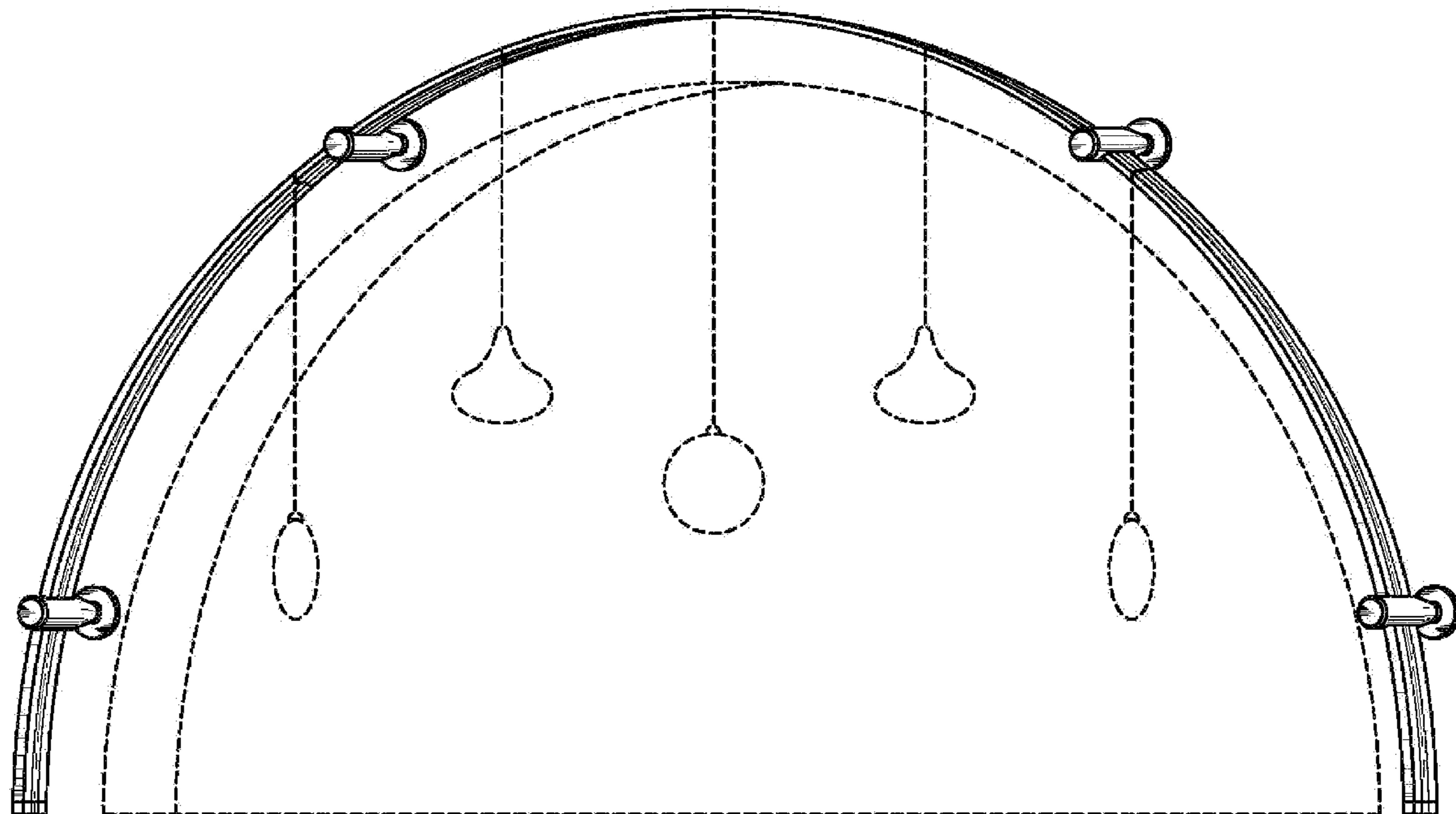
FIG. 1 is a perspective view of the arched window treatment for securing decorations.

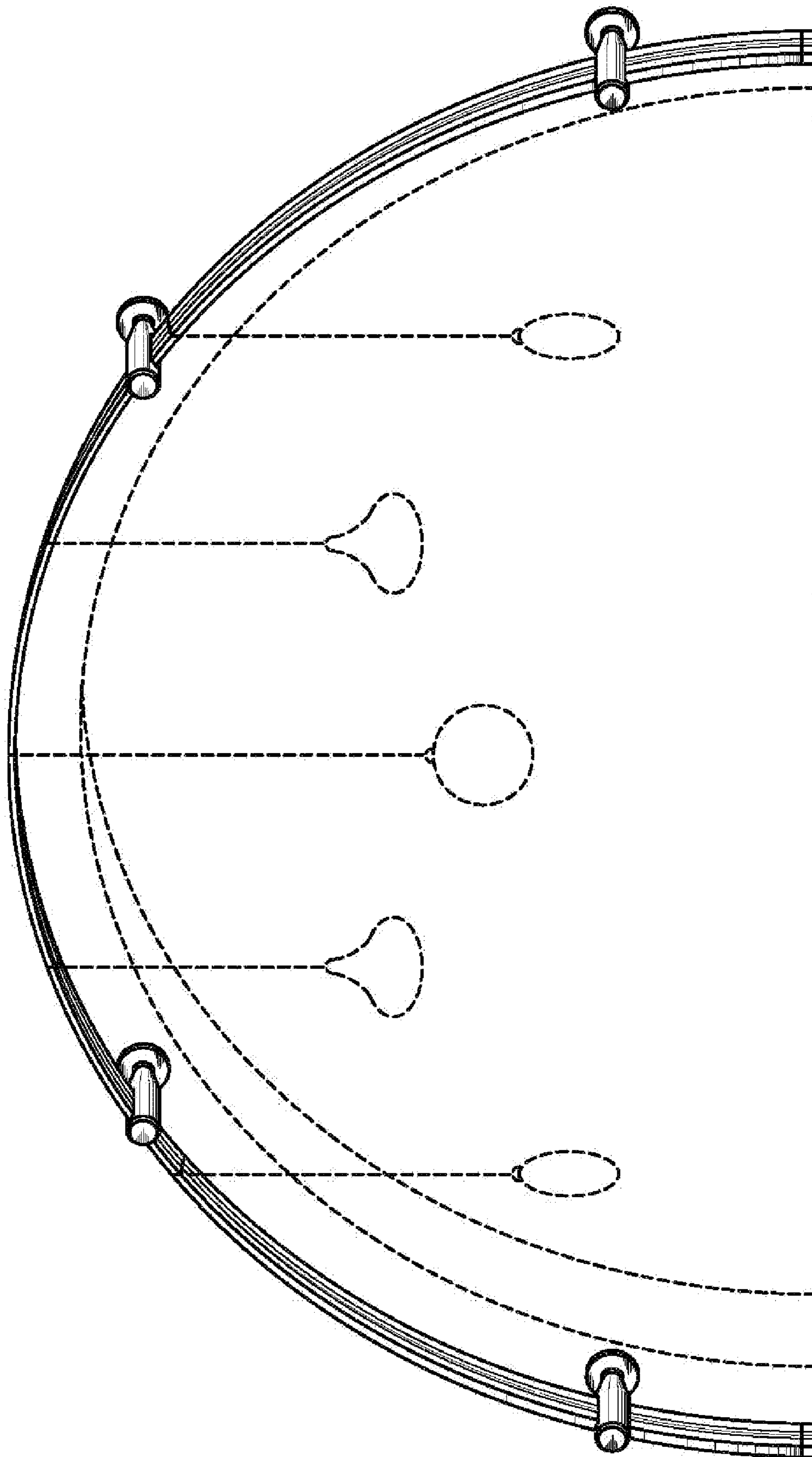

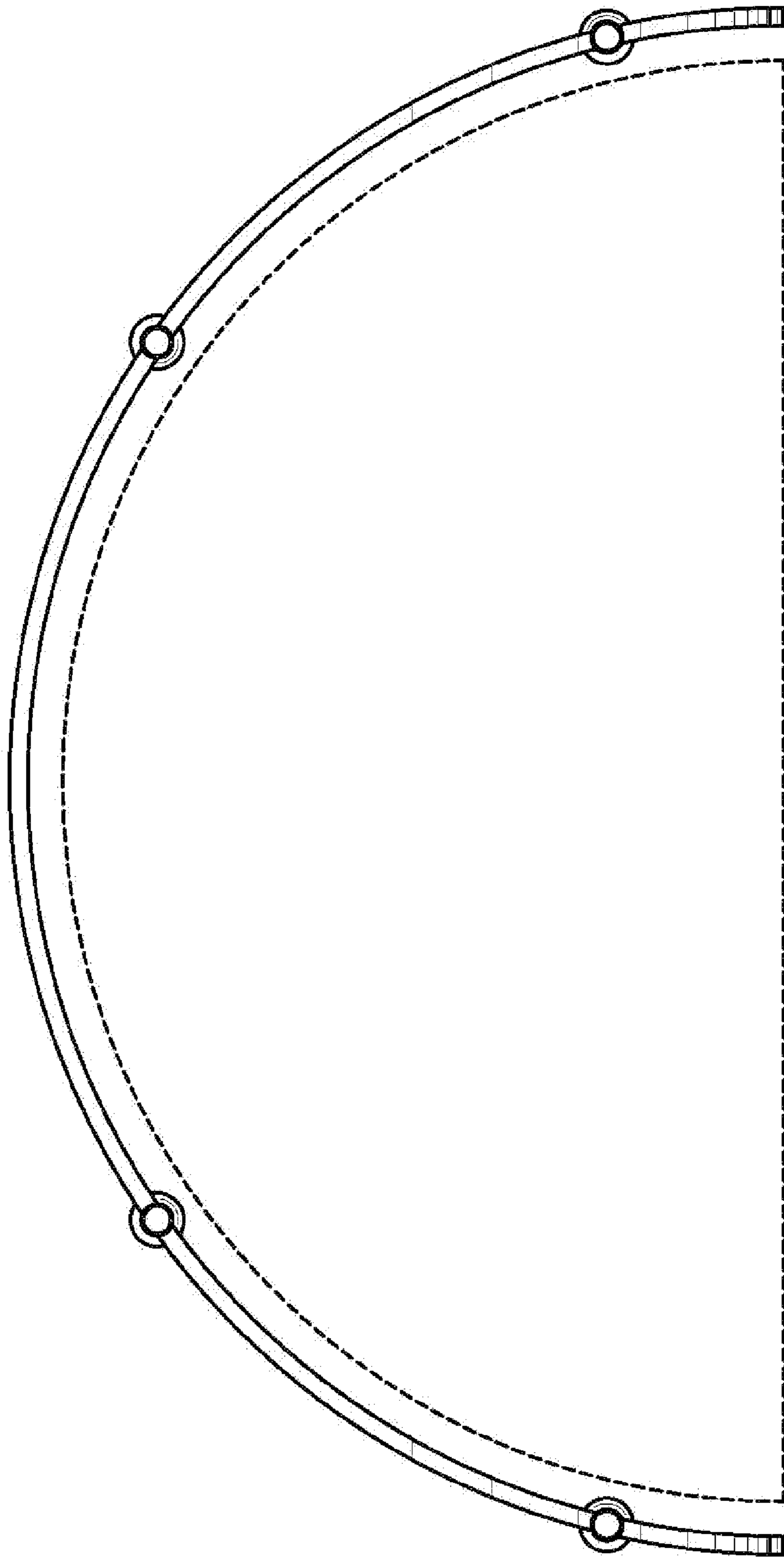

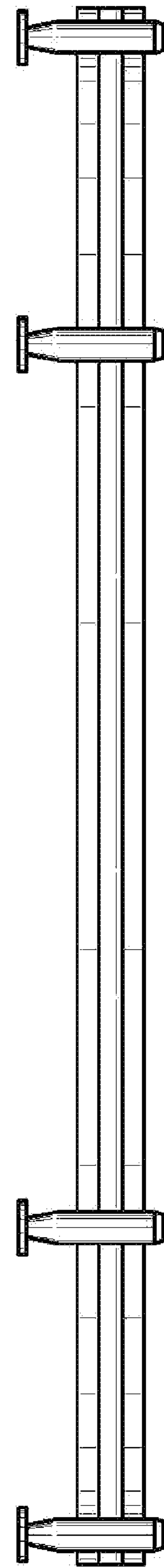
