FIG. 7 is a bottom plan view thereof; and,

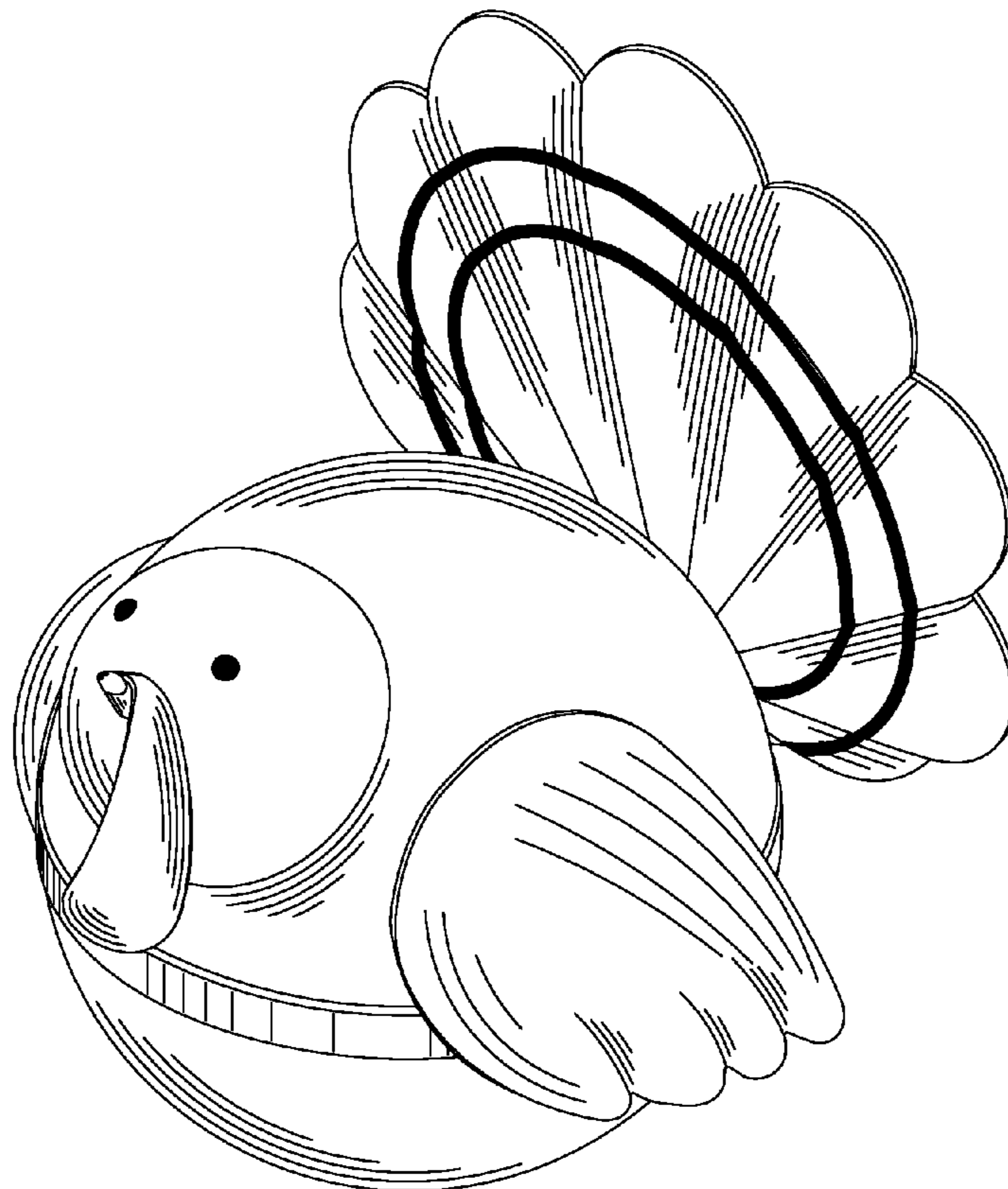
FIG. 8 is a perspective view thereof, with broken lines shown for illustrative purposes only, and forming no part of the claimed design.

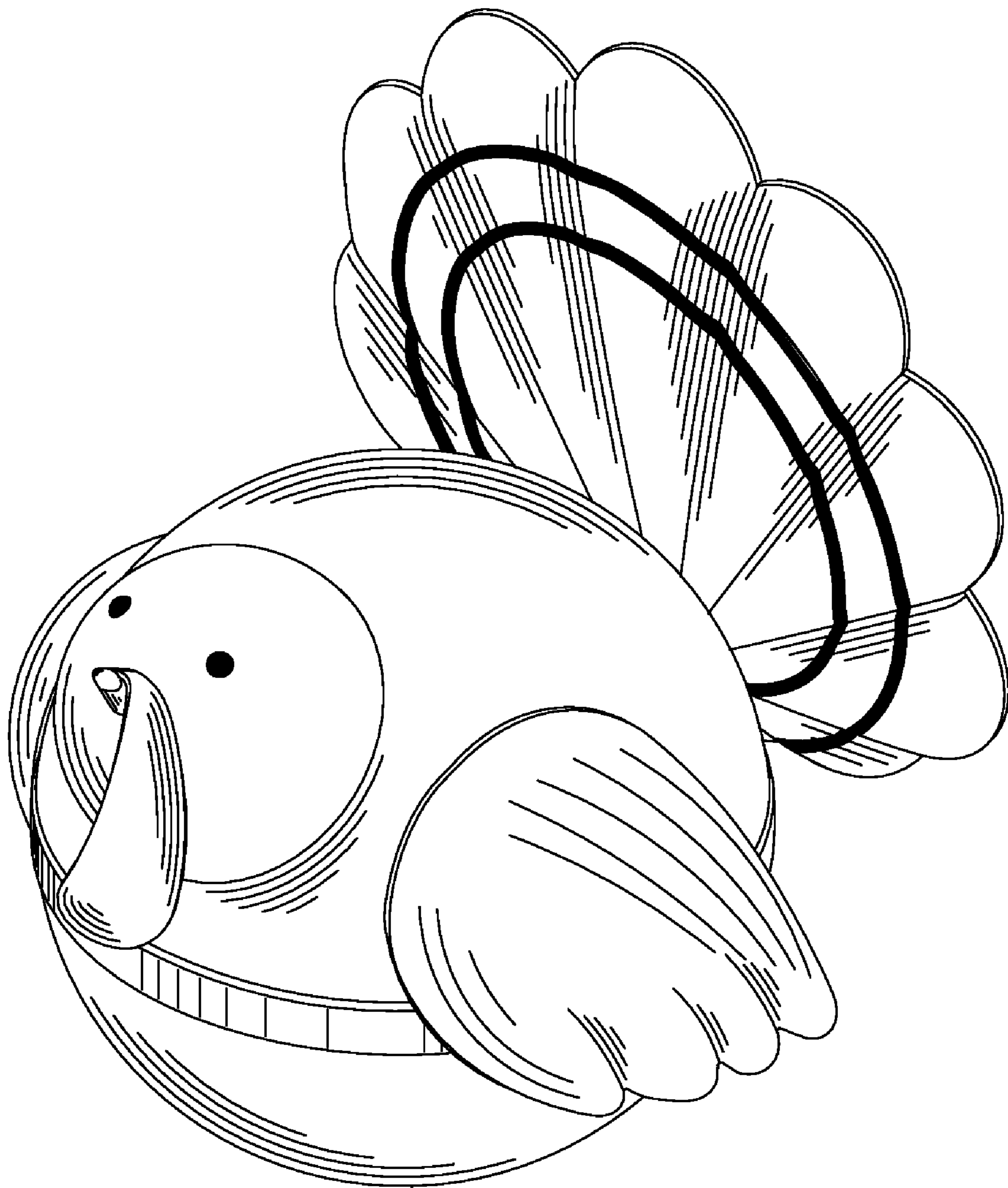

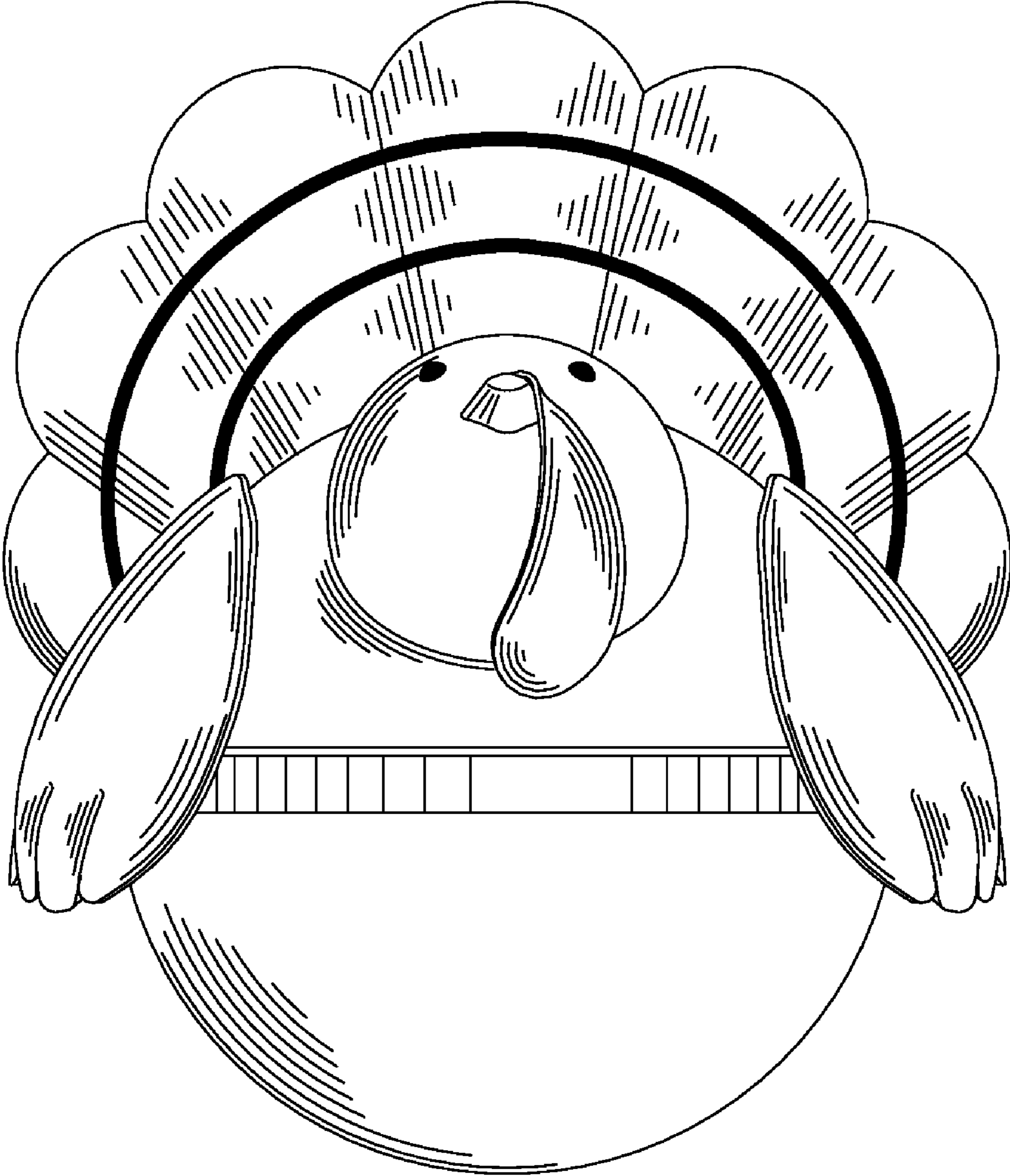

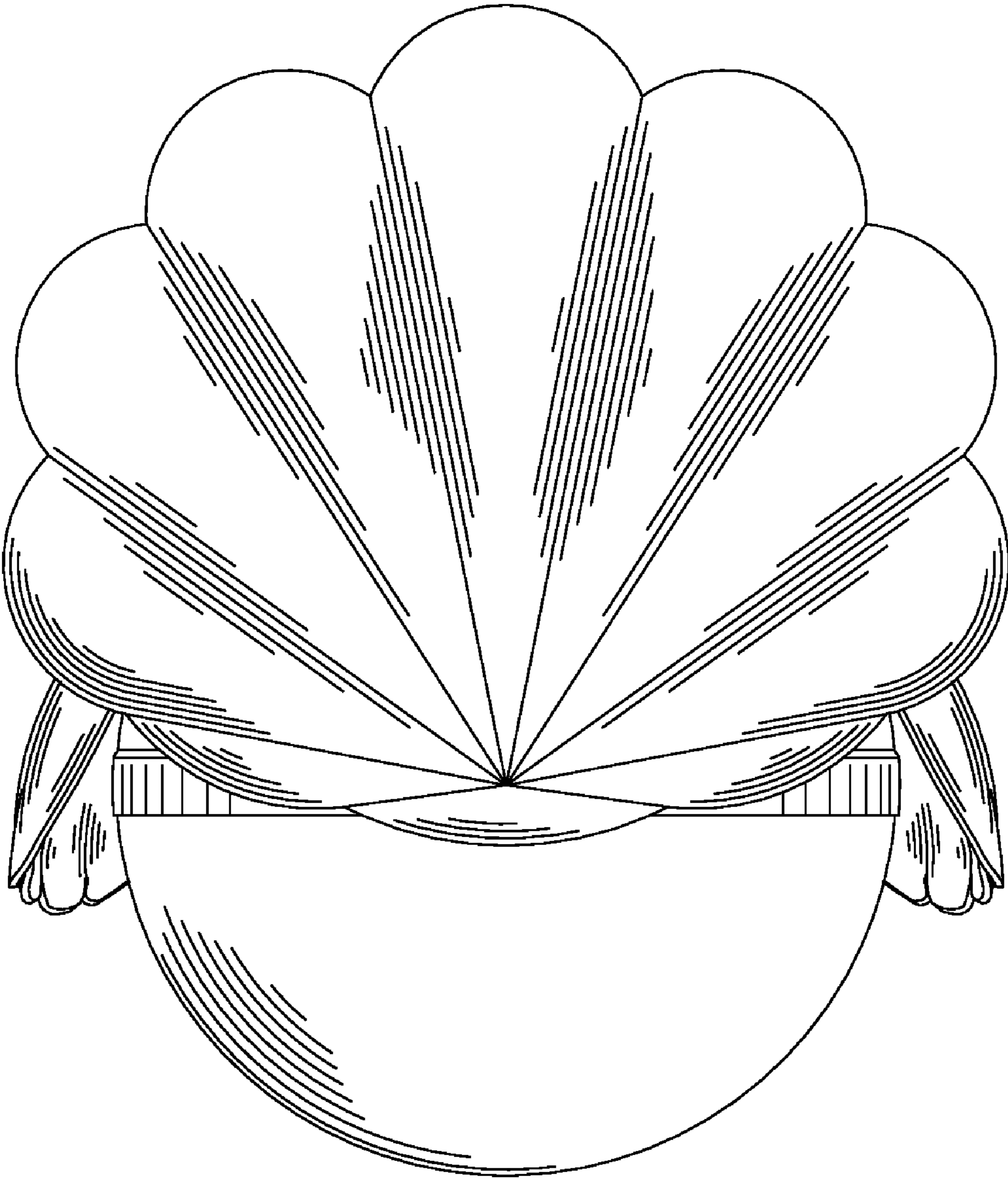

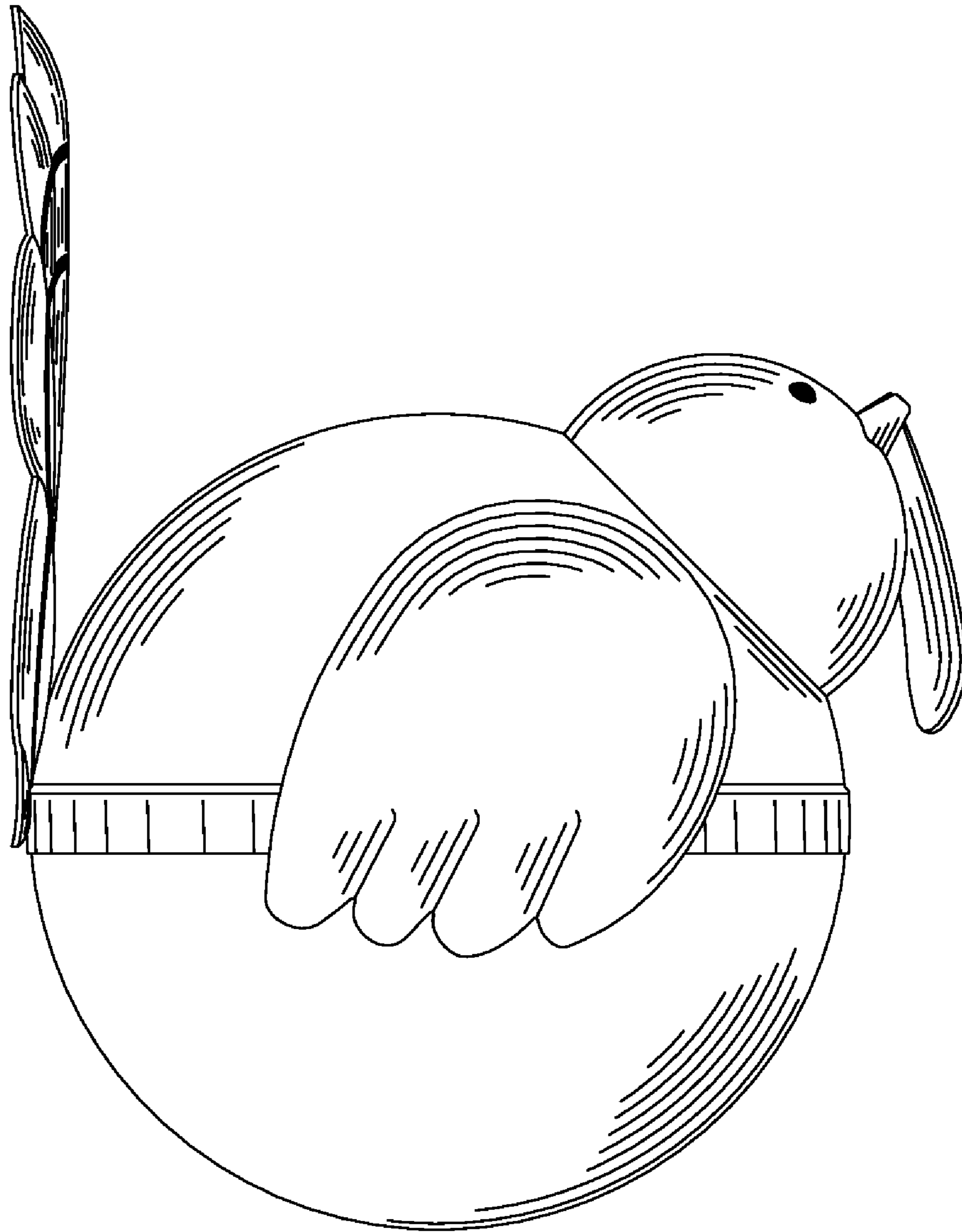

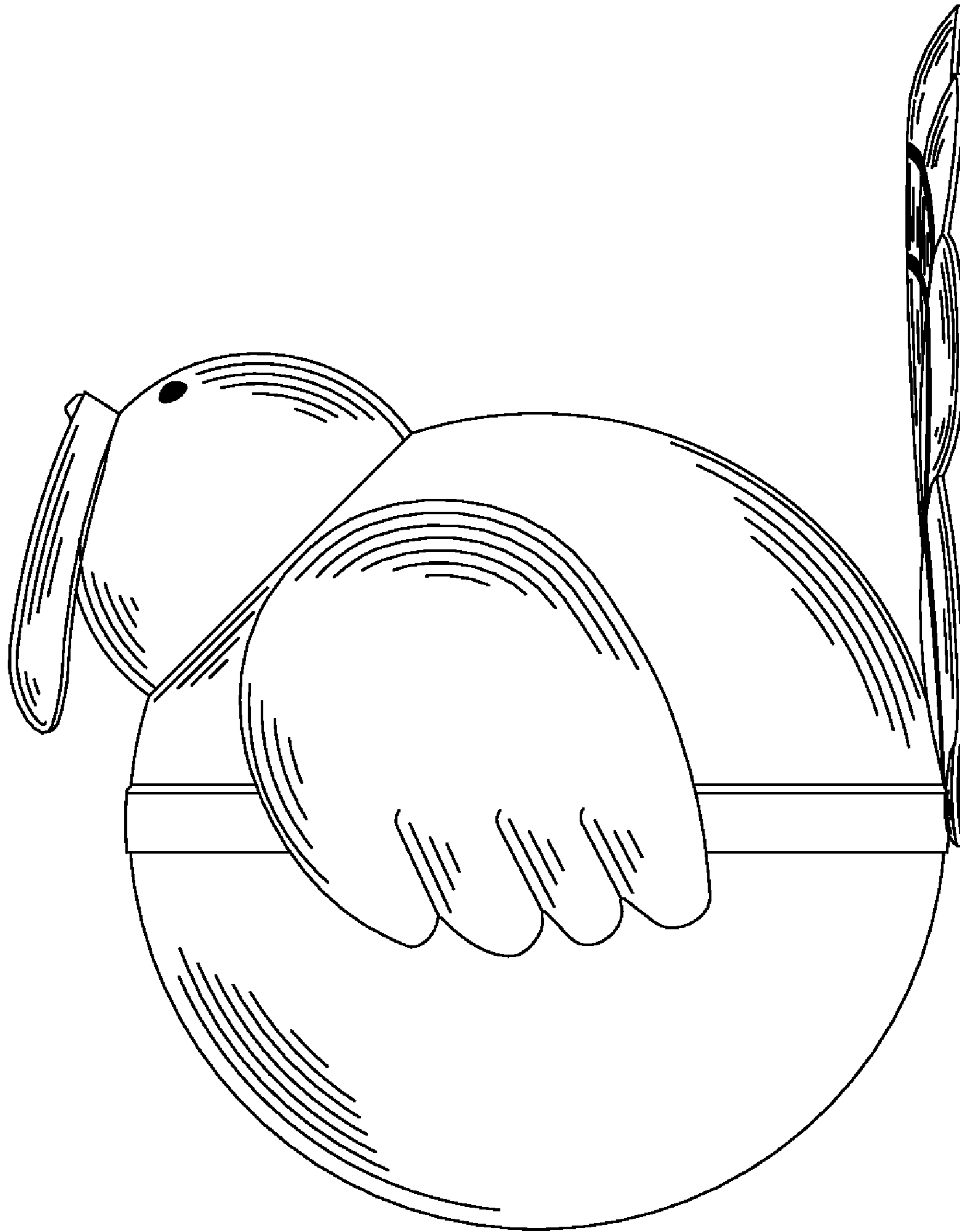

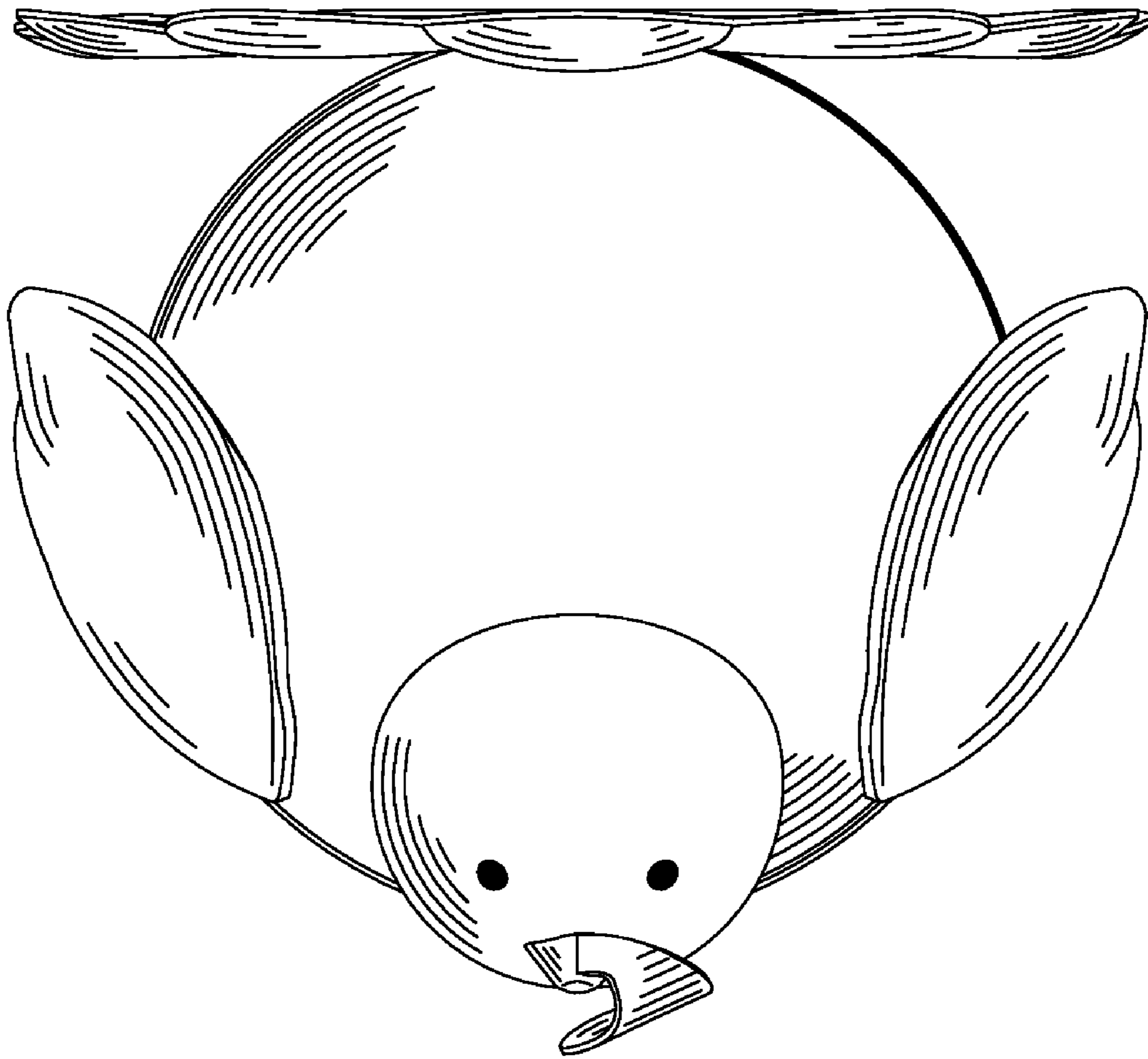

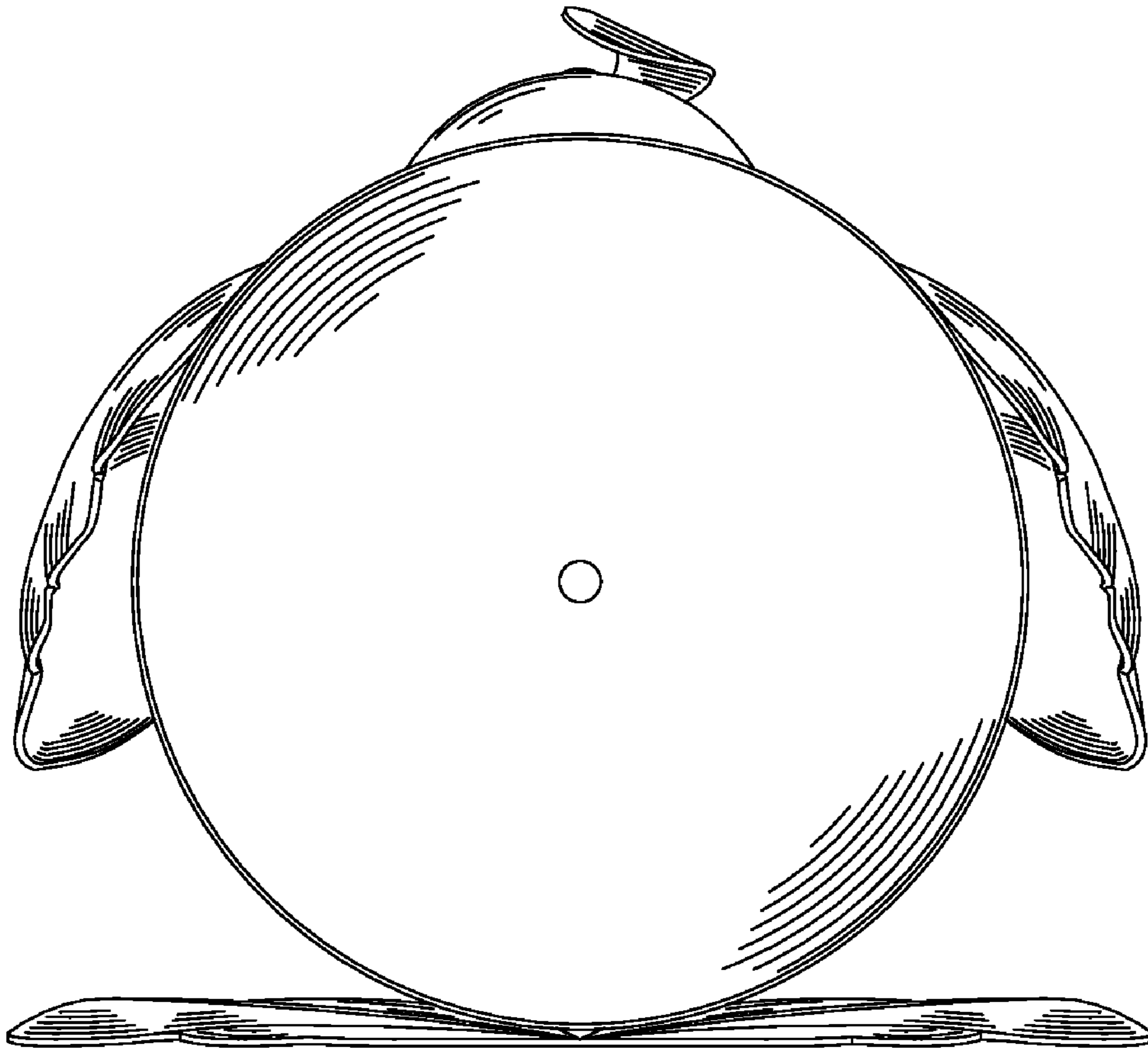

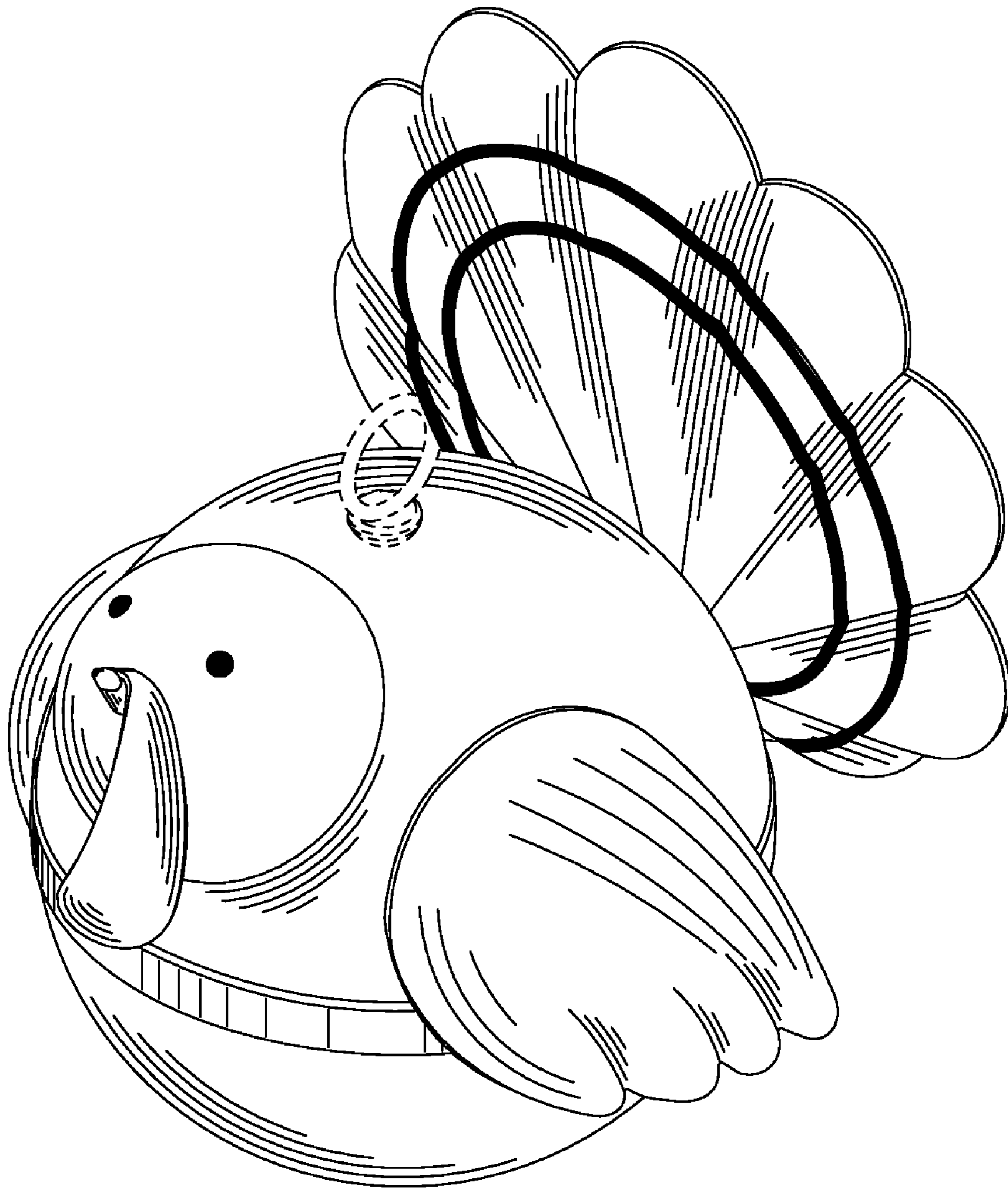
