The ornamental design for a side lighted storage box for trucks, as shown and described.

FIG. 3 is a front view thereof;

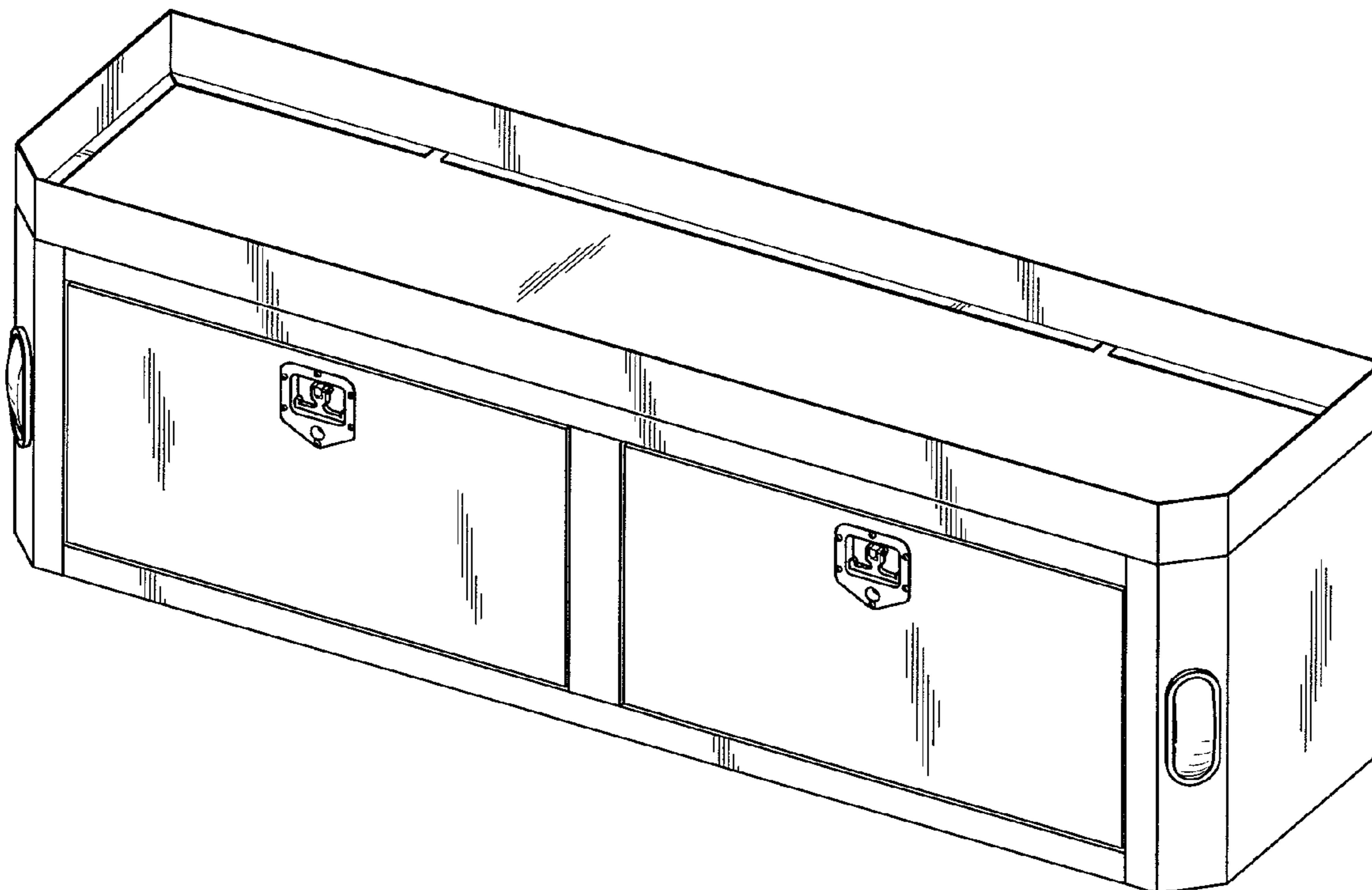
FIG. 4 is a first side view thereof;

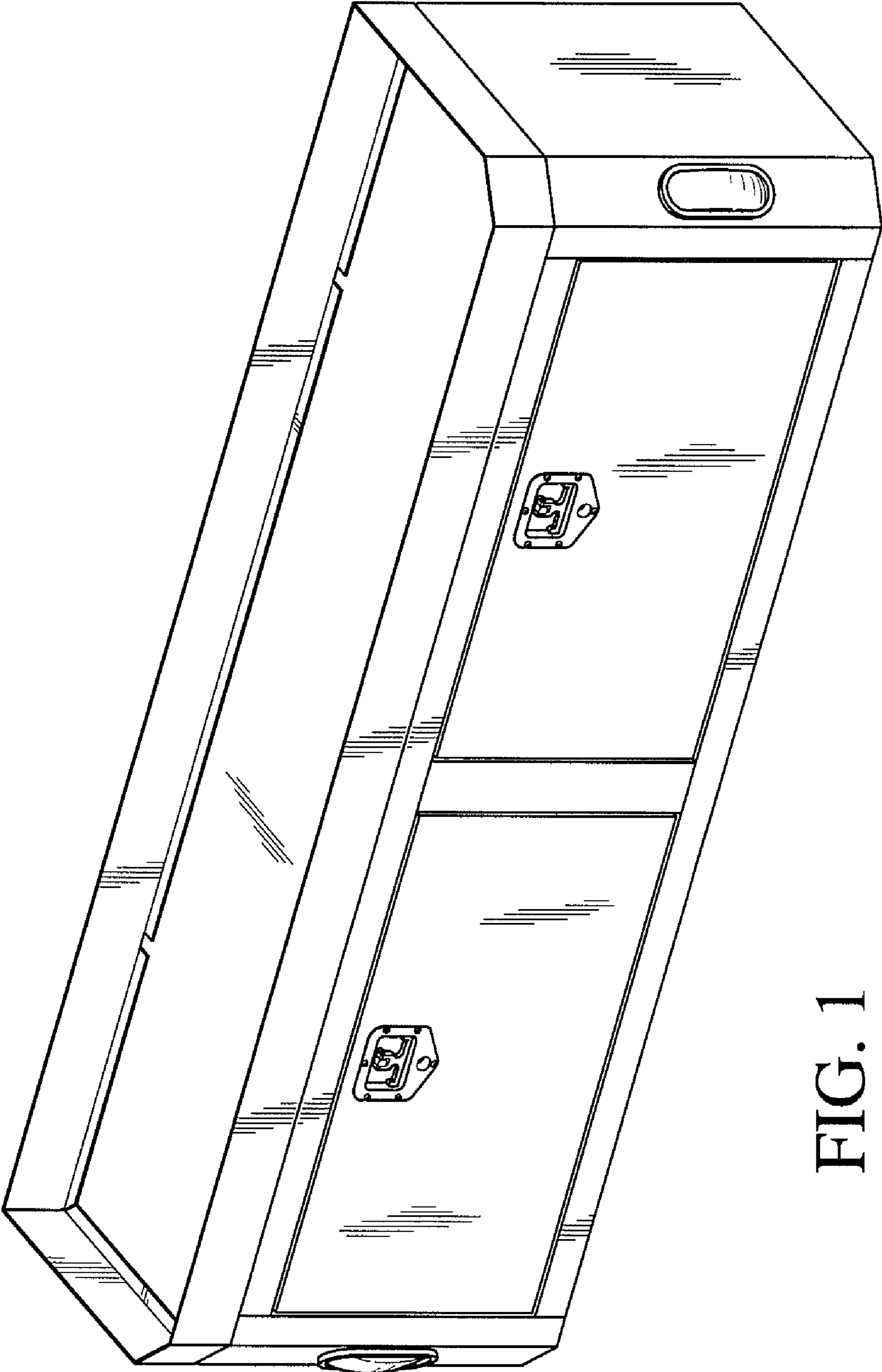

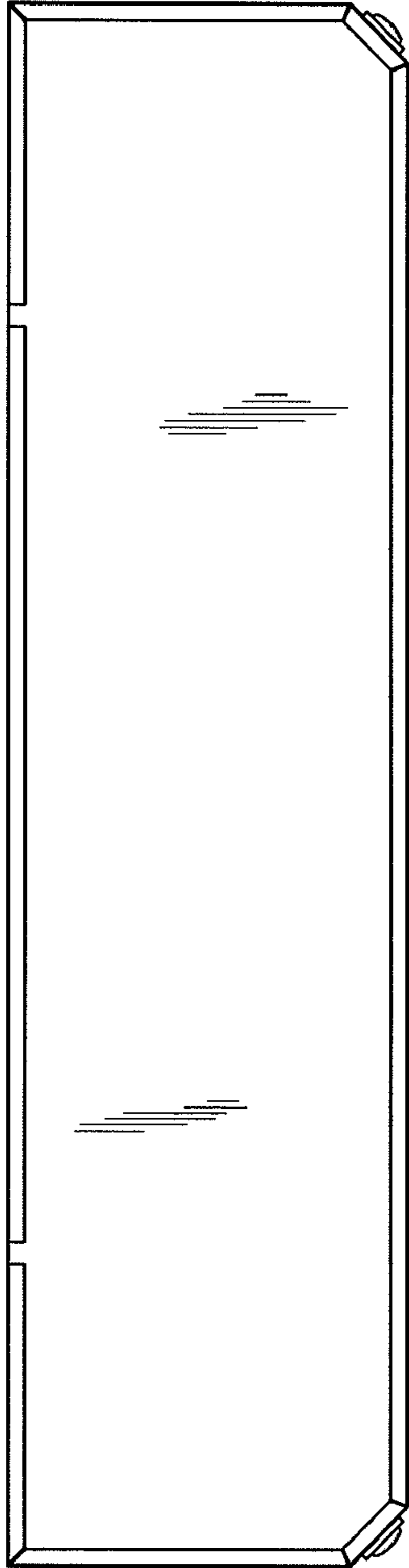

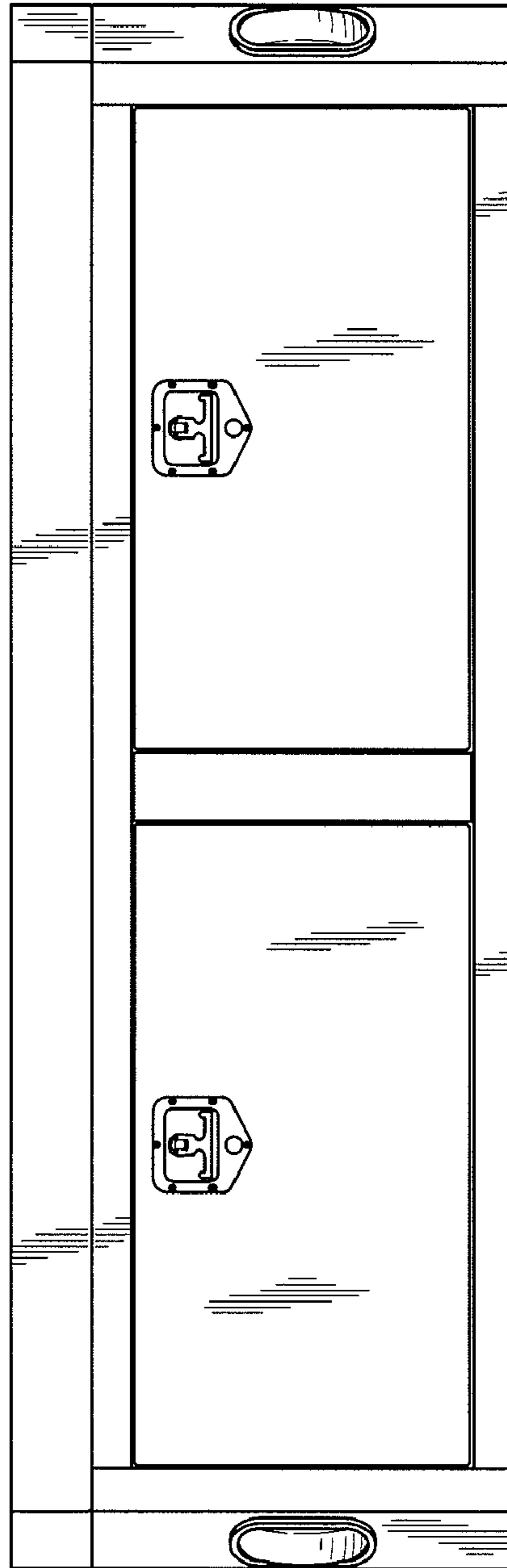

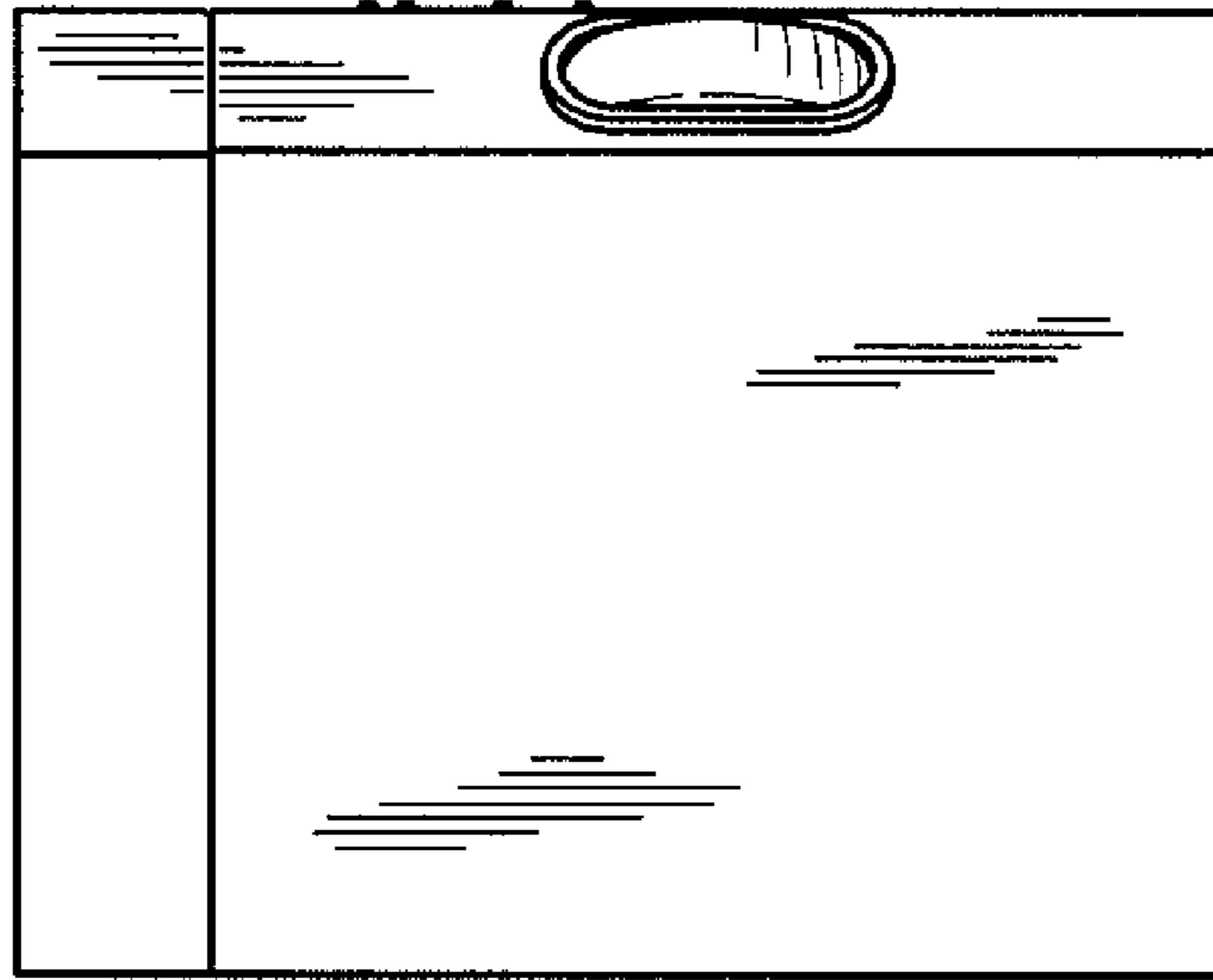

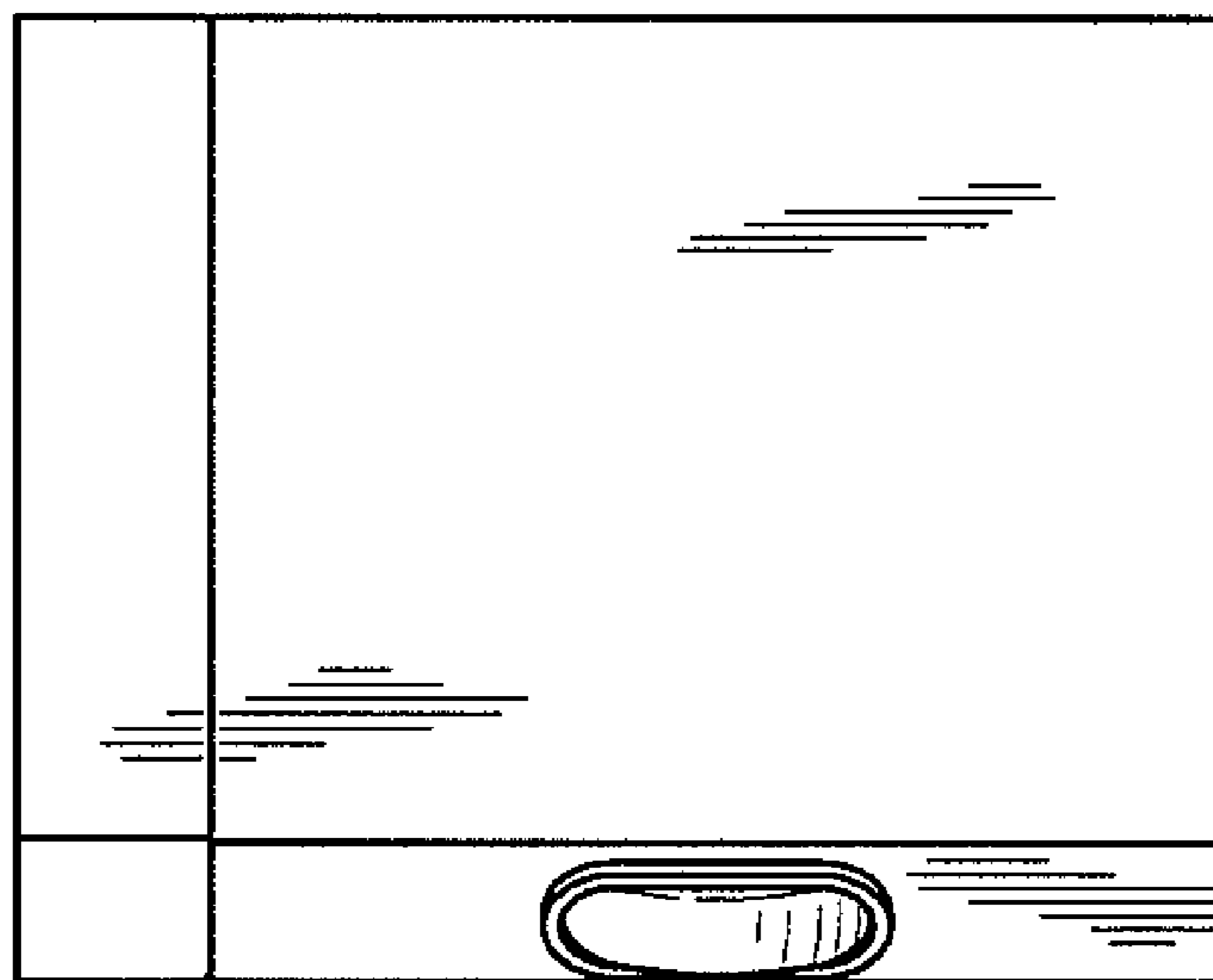

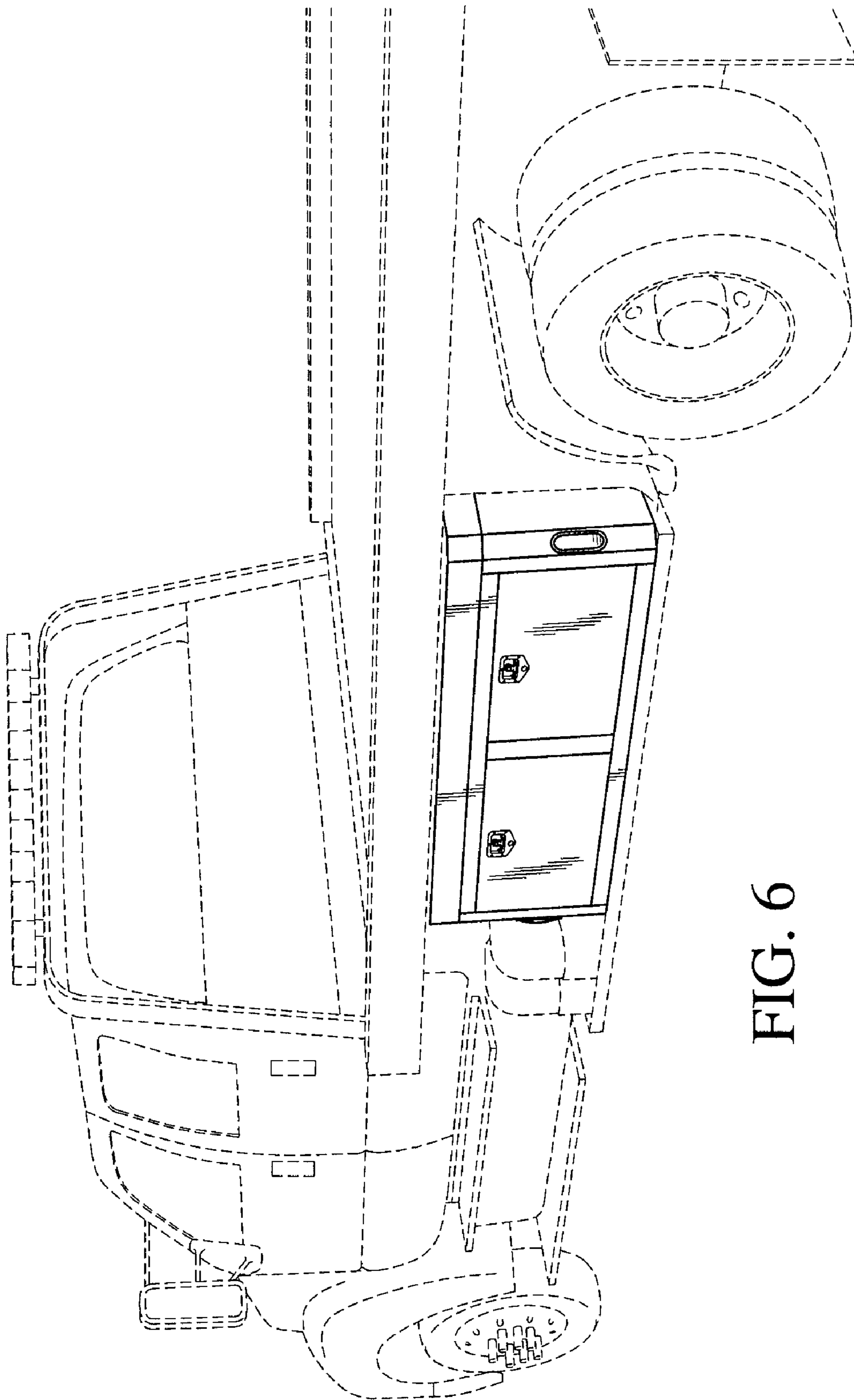
