(57) **CLAIM**

We claim the ornamental design for an irrigation controller, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an irrigation controller according to our new design;

FIG. 2 is a front view of the irrigation controller of FIG. 1;

FIG. 3 is a left side elevation view of the irrigation controller of FIG. 1;

FIG. 4 is a right side elevation view of the irrigation controller of FIG. 1;

FIG. 5 is a top side view of the irrigation controller of FIG. 1;

FIG. 6 is a bottom side view of the irrigation controller of FIG. 1;

FIG. 7 is a perspective view of a second embodiment of an irrigation controller according to our new design, in which a rotary switch is illustrated in broken lines for illustrative purposes and forms no part of the claimed design;

FIG. 8 is a front view of the irrigation controller of FIG. 7;

FIG. 9 is a left side elevation view of the irrigation controller of FIG. 7;

FIG. 10 is a right side elevation view of the irrigation controller of FIG. 7;

FIG. 11 is a top side view of the irrigation controller of FIG. 7;

FIG. 12 is a bottom side view of the irrigation controller of FIG. 7;

FIG. 13 is a perspective view of a third embodiment of an irrigation controller according to our new design, in which a rotary switch, a cover panel and back plate structures are illustrated in broken lines for illustrative purposes and form no part of the claimed design;

FIG. 14 is a front view of the irrigation controller of FIG. 13;

FIG. 15 is a left side elevation view of the irrigation controller of FIG. 13;

FIG. 16 is a right side elevation view of the irrigation controller of FIG. 13;

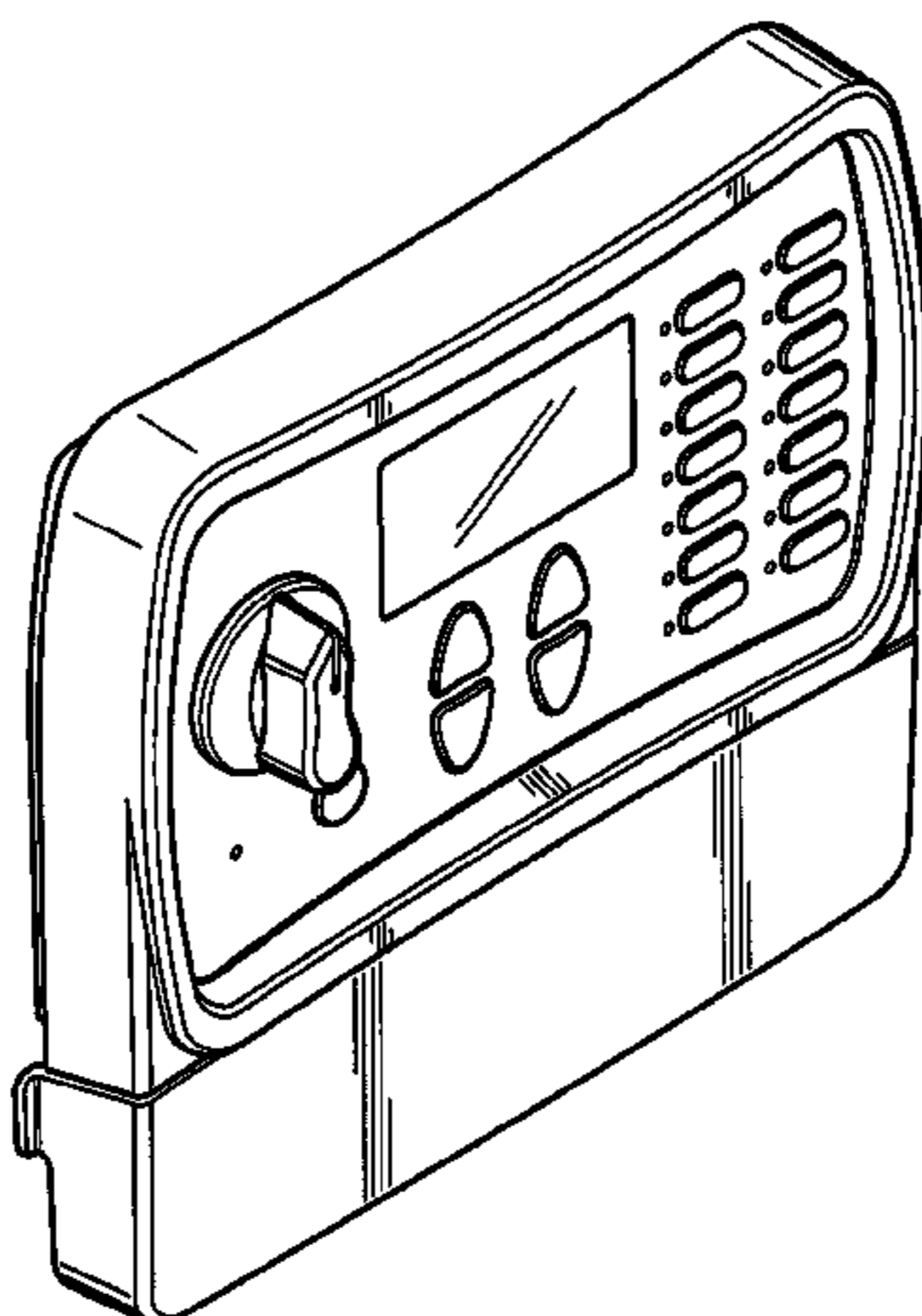
FIG. 17 is a top side view of the irrigation controller of FIG. 13;

FIG. 18 is a bottom side view of the irrigation controller of FIG. 13; and,

FIG. 19 is a front view of a fourth embodiment of an irrigation controller according to our new design.

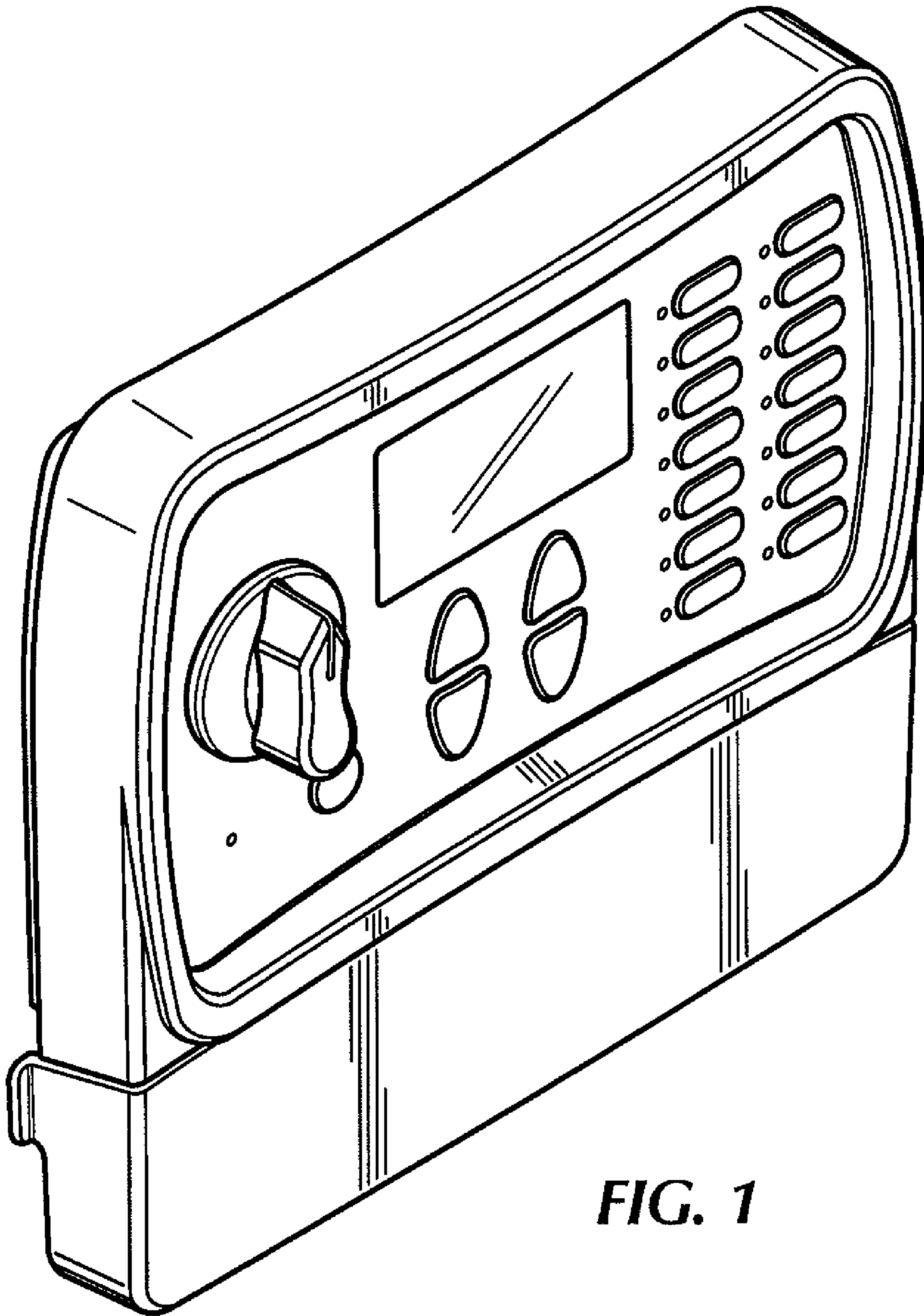

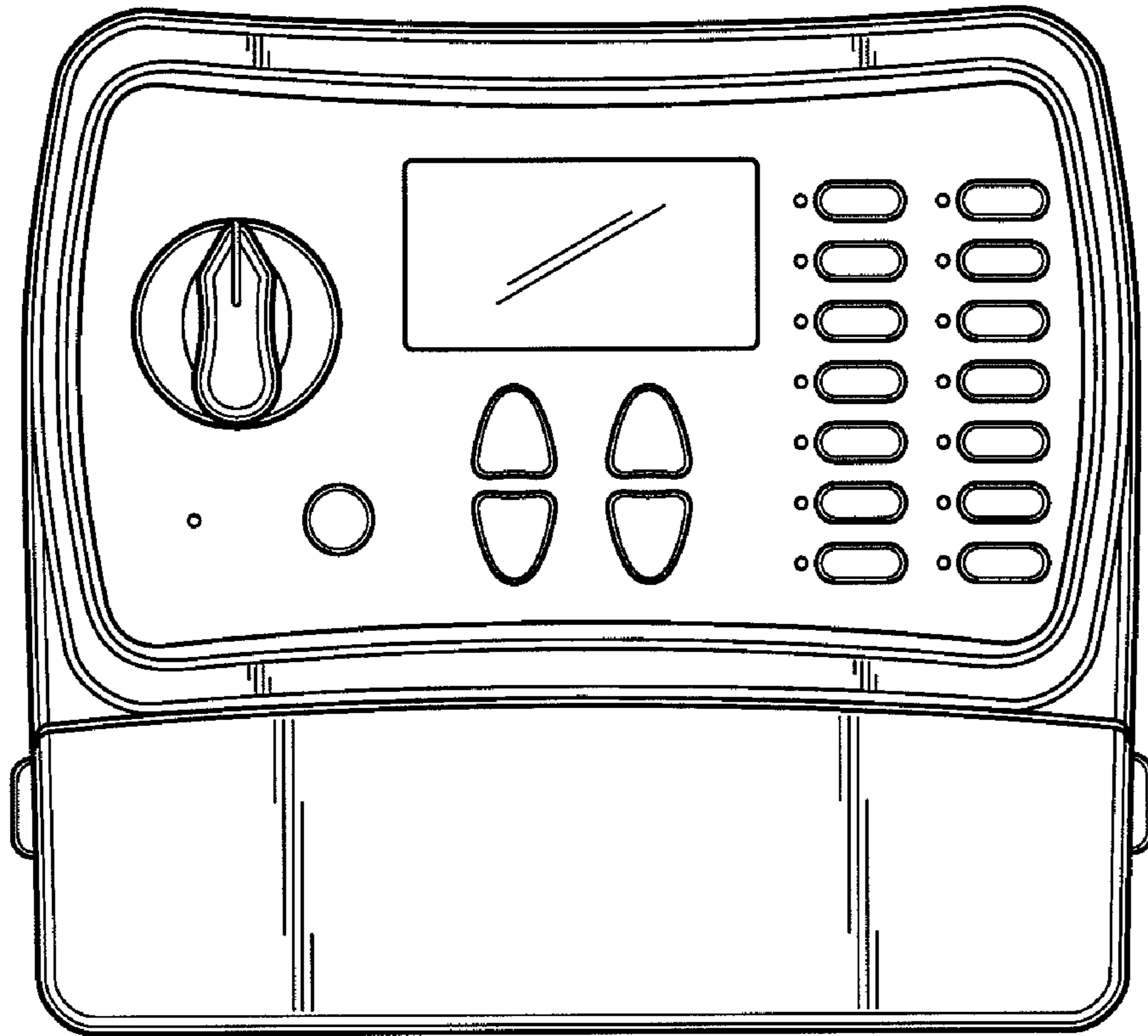

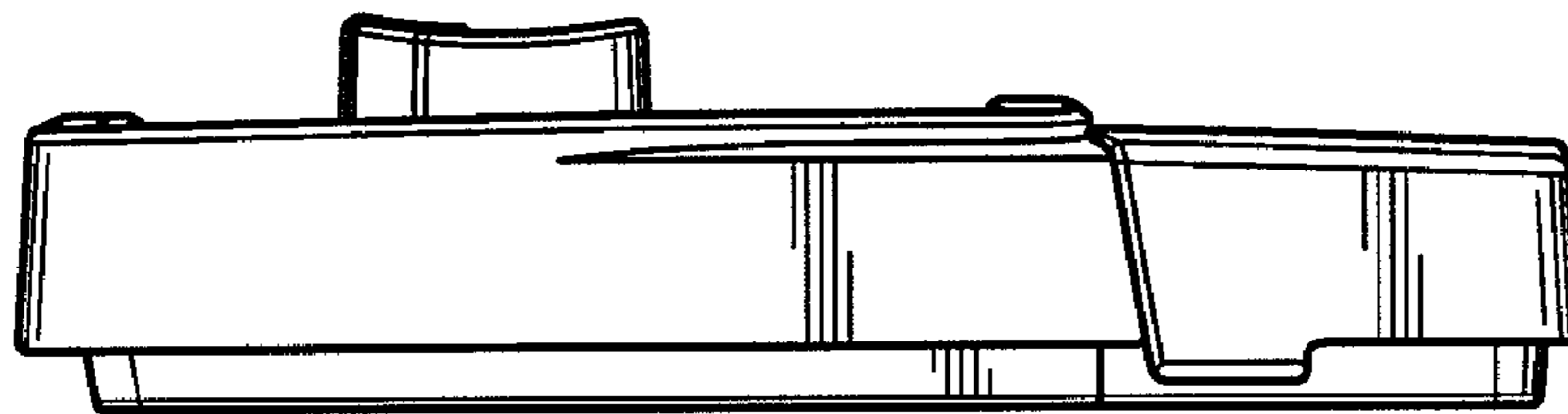

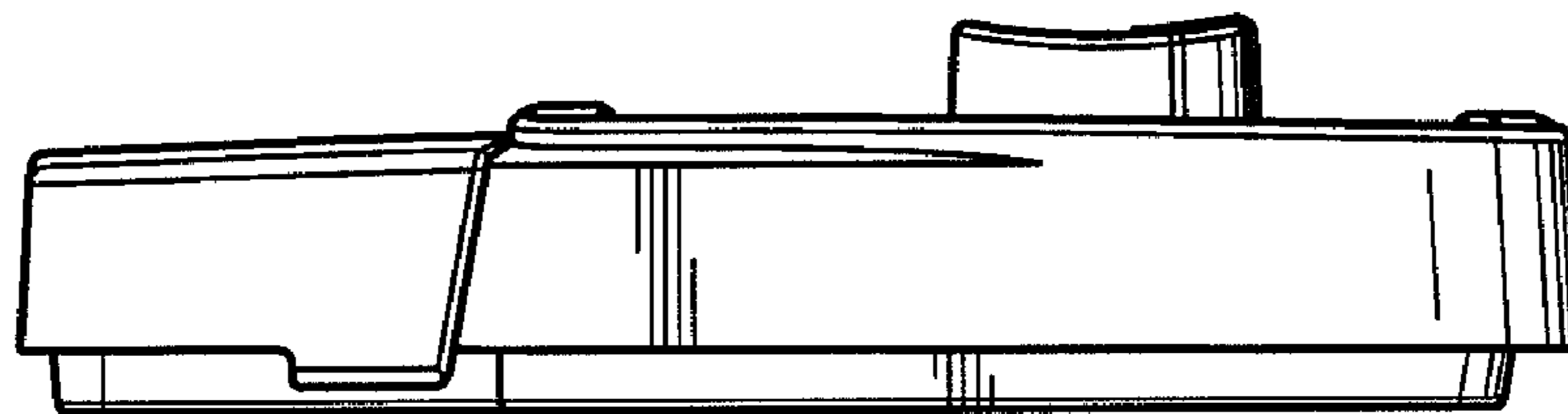

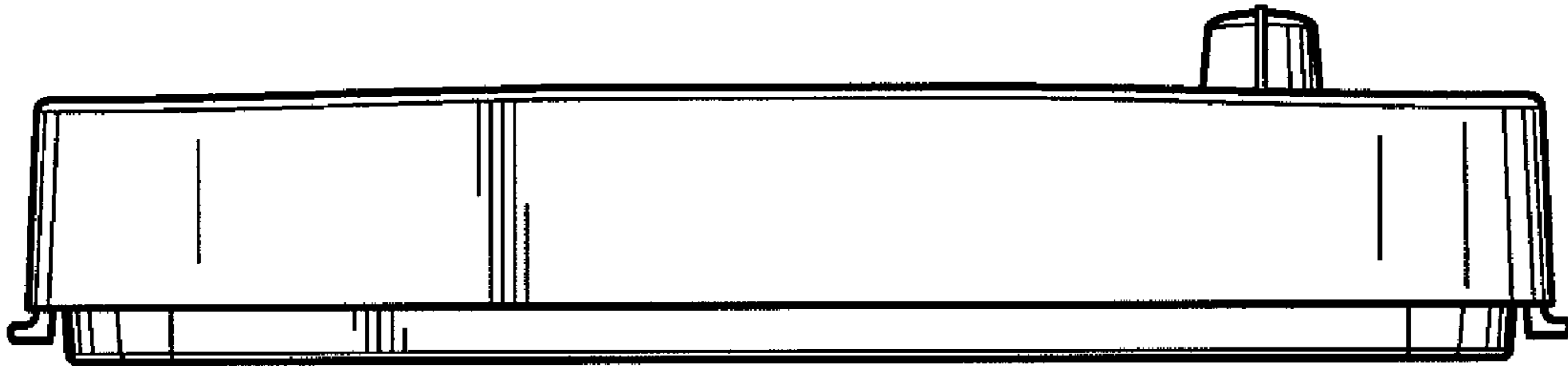

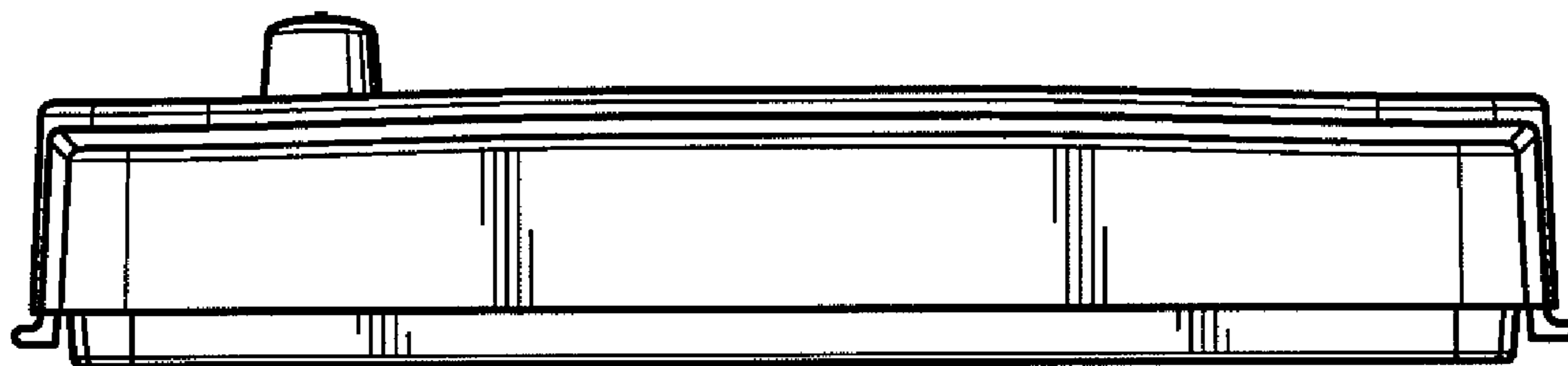

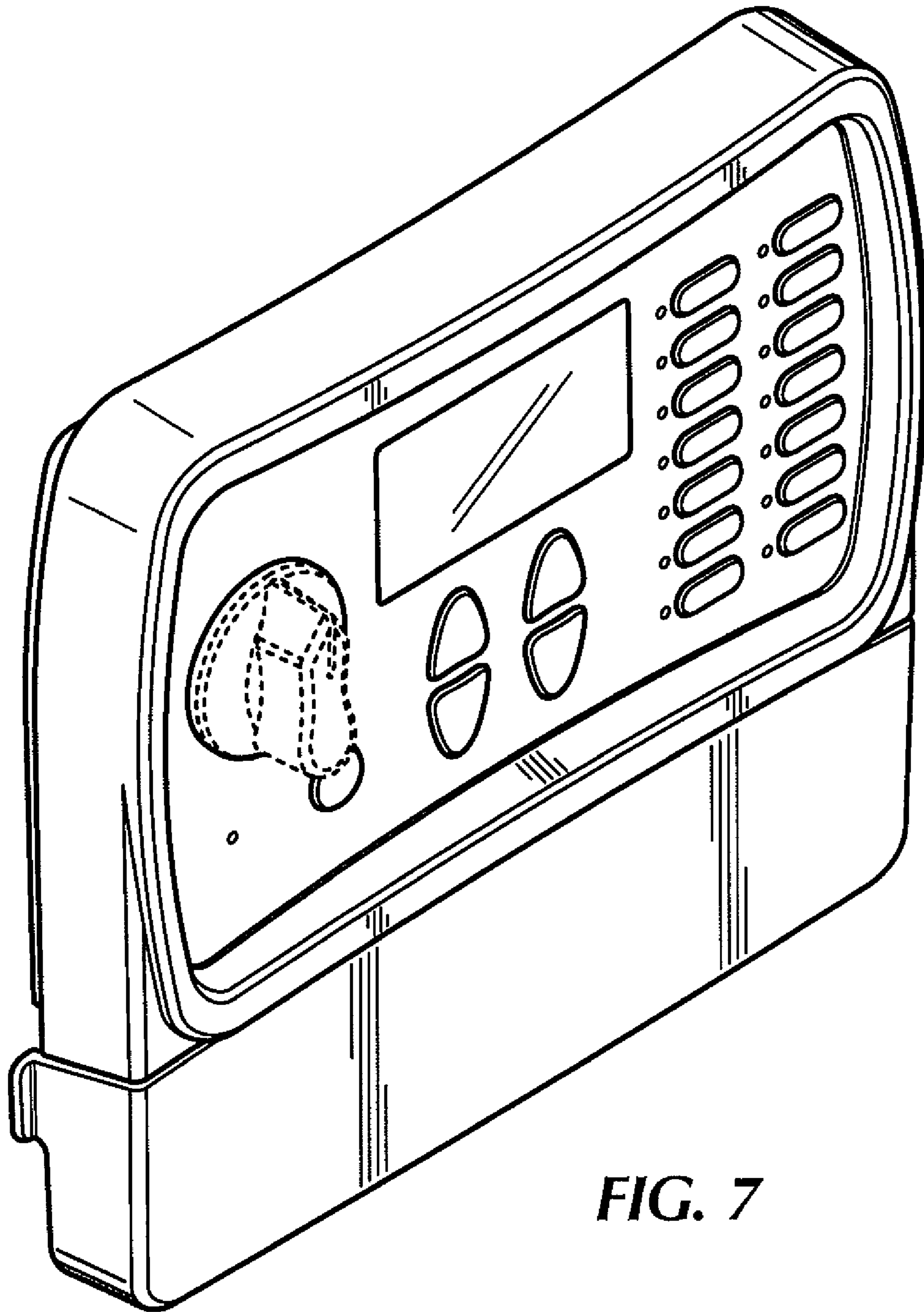

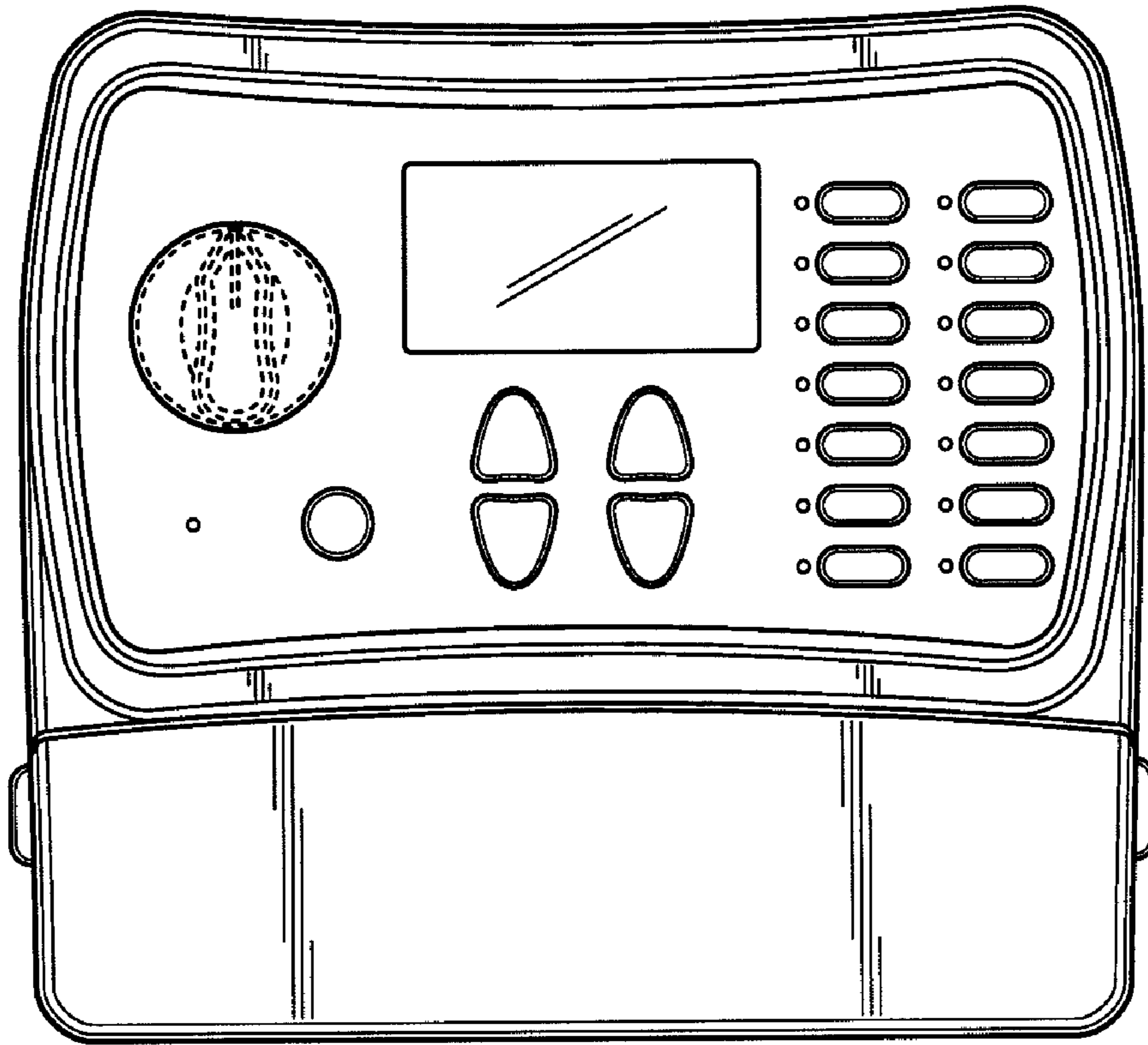

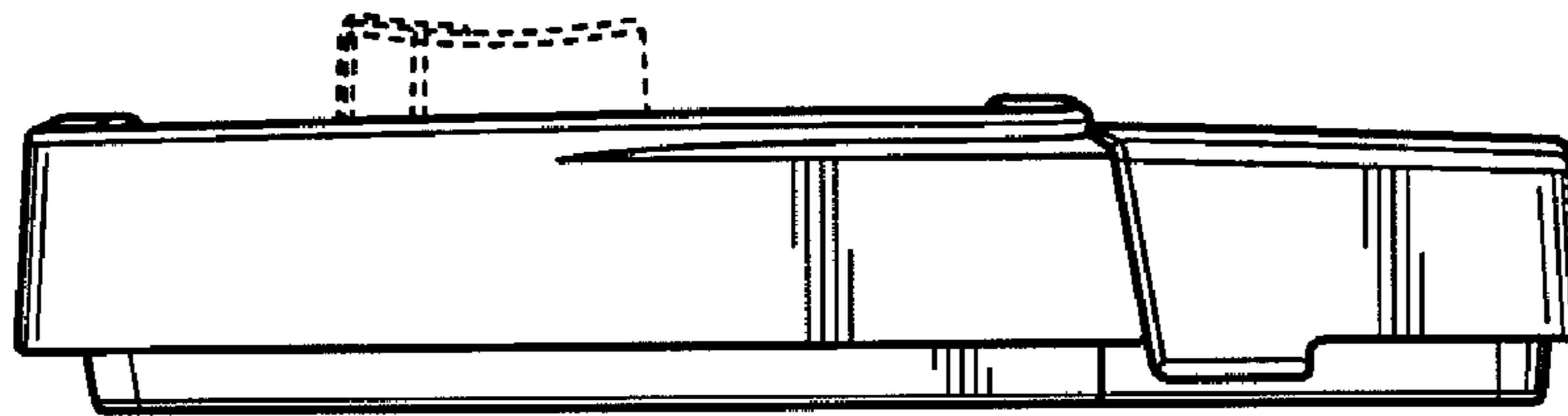

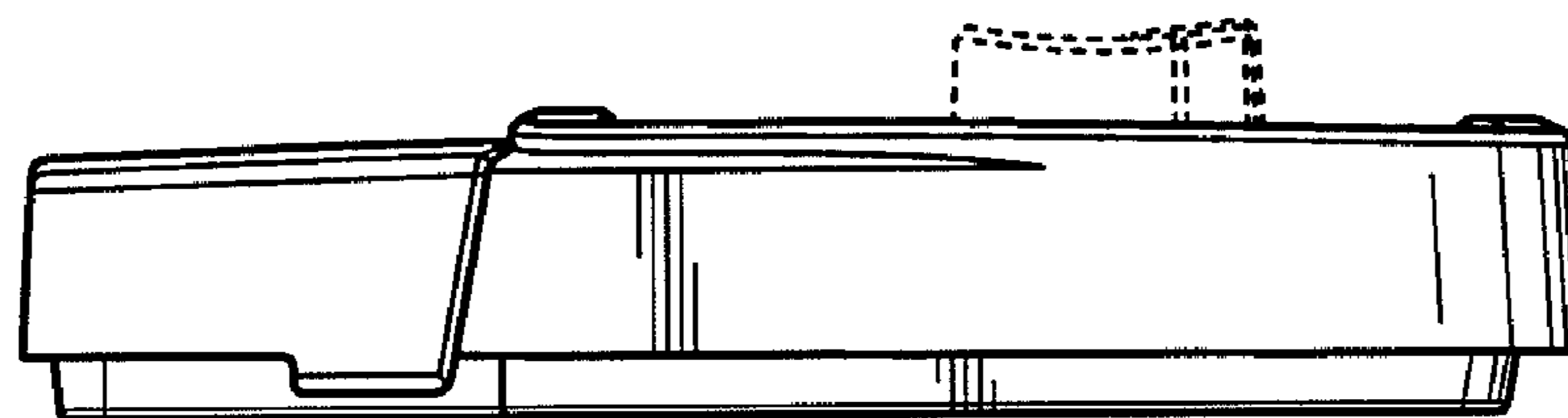

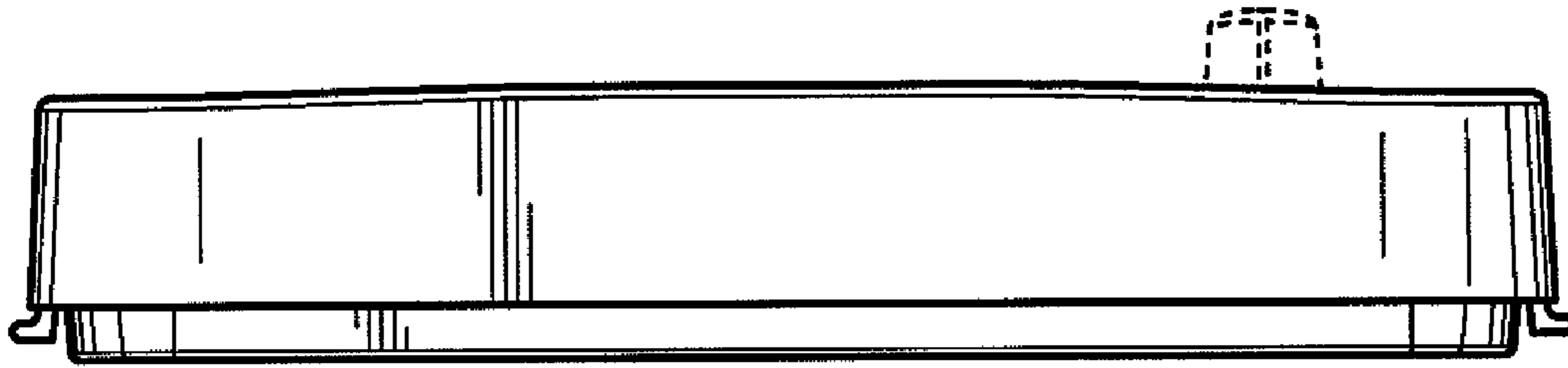

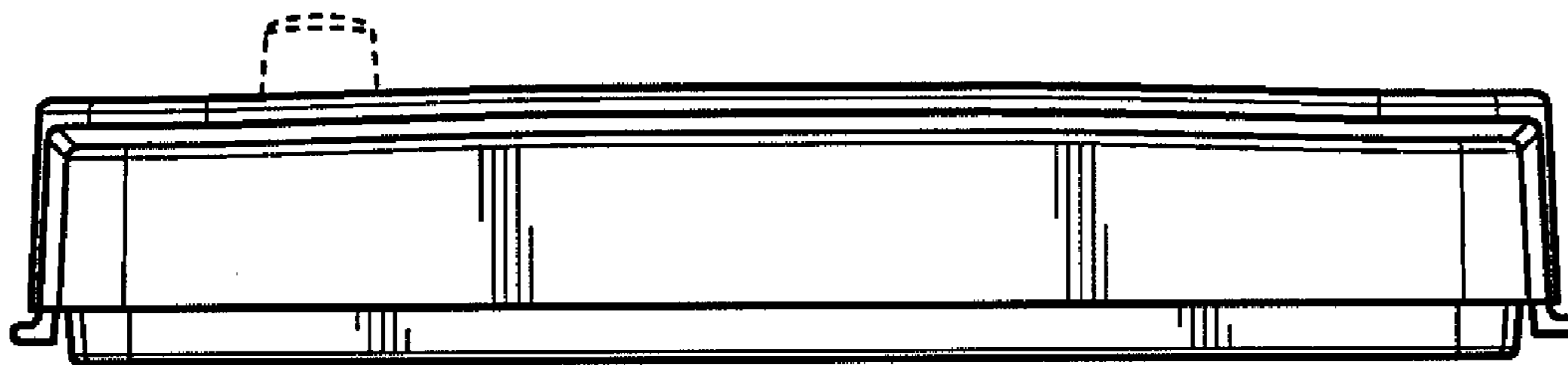

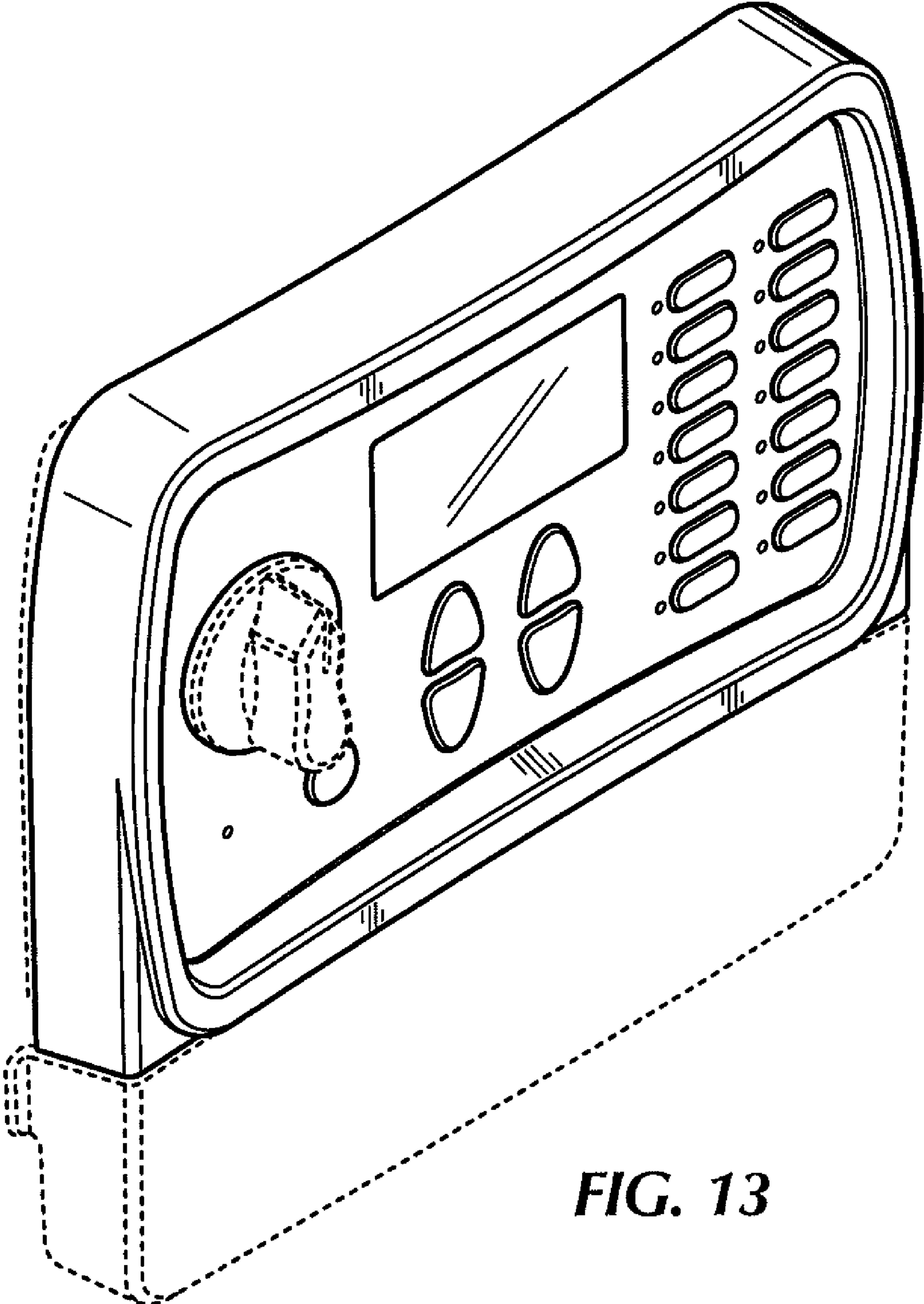

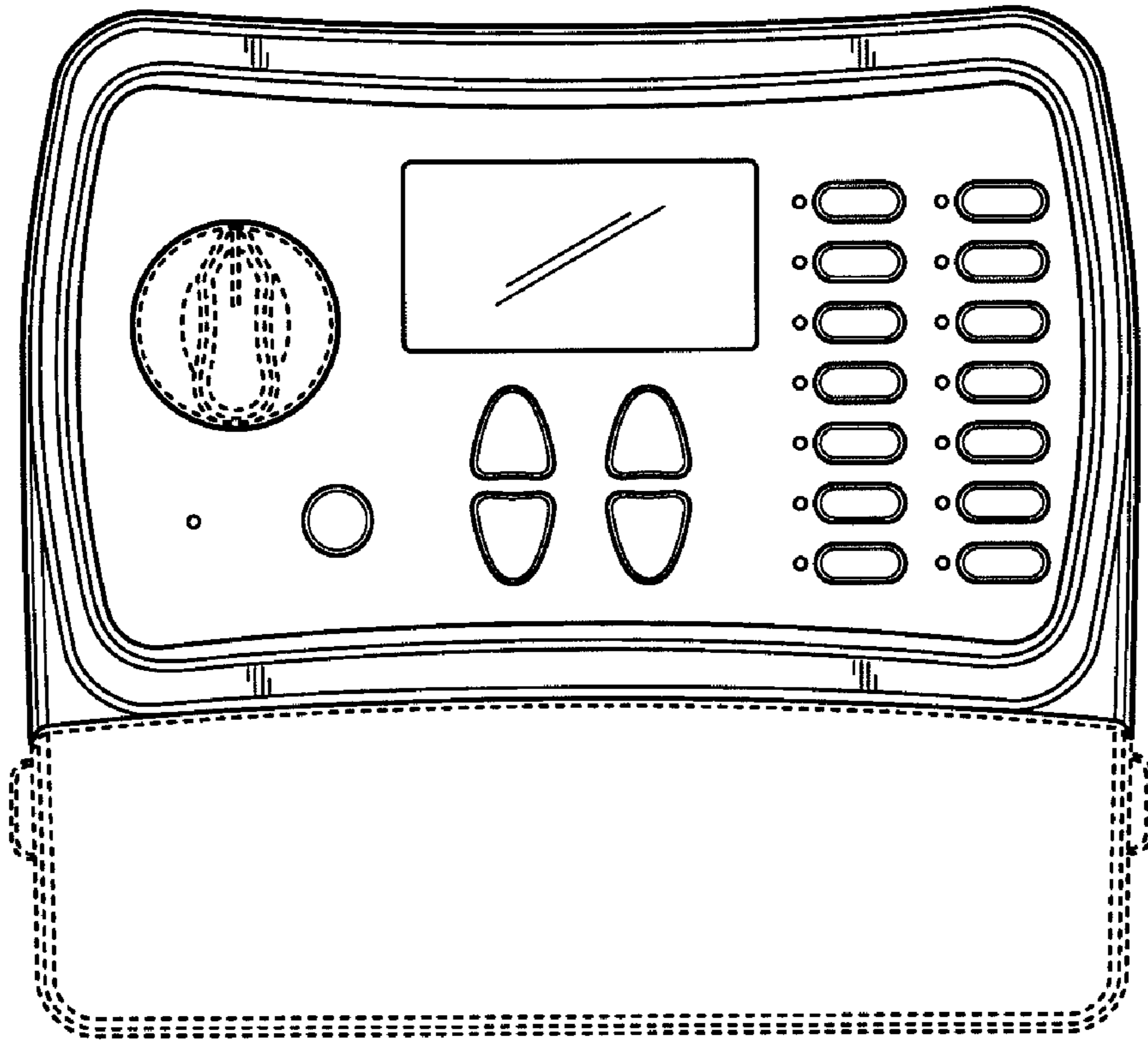

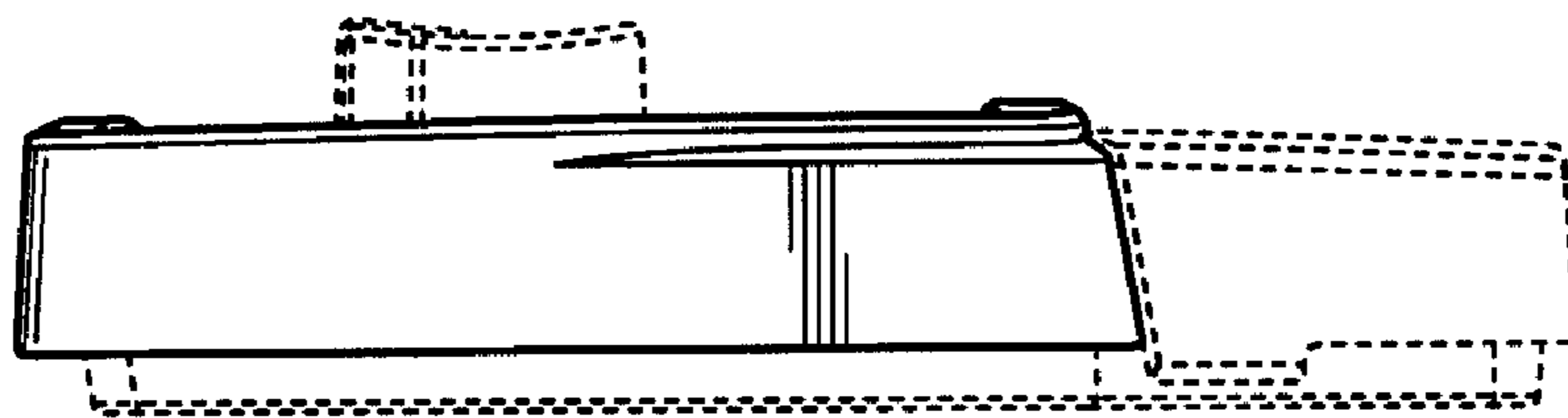

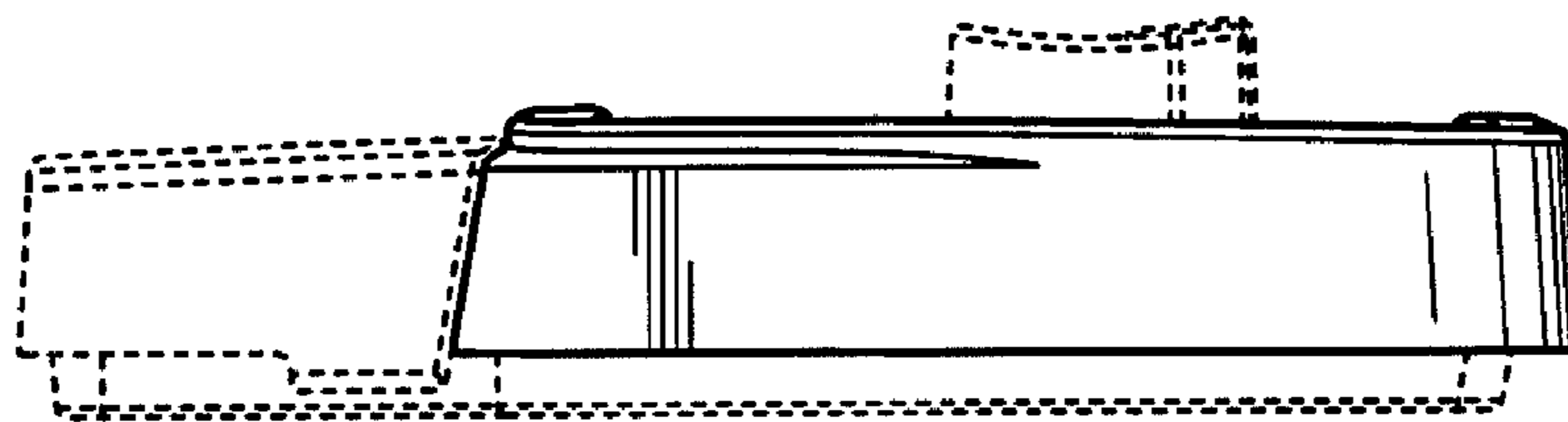

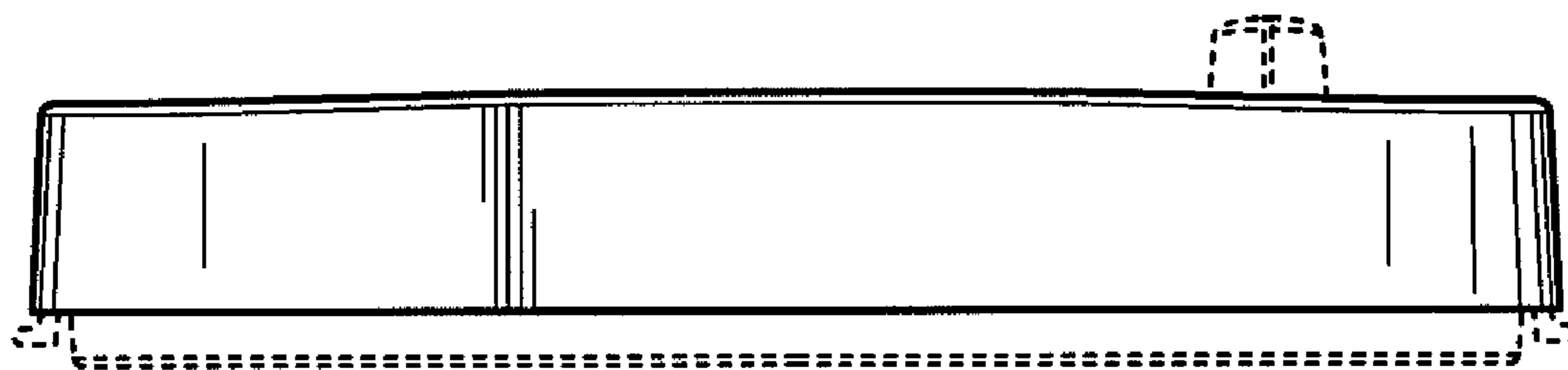

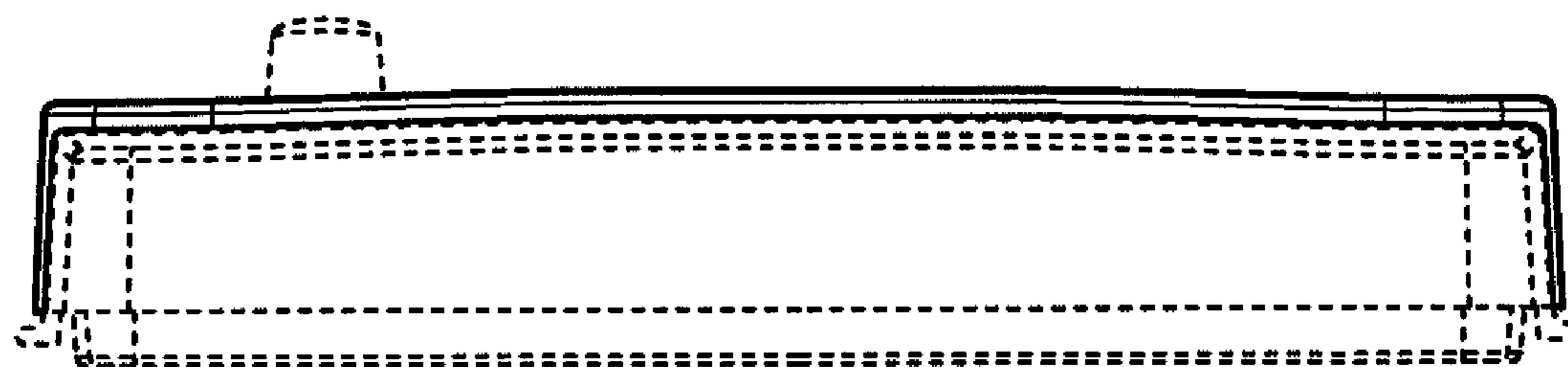

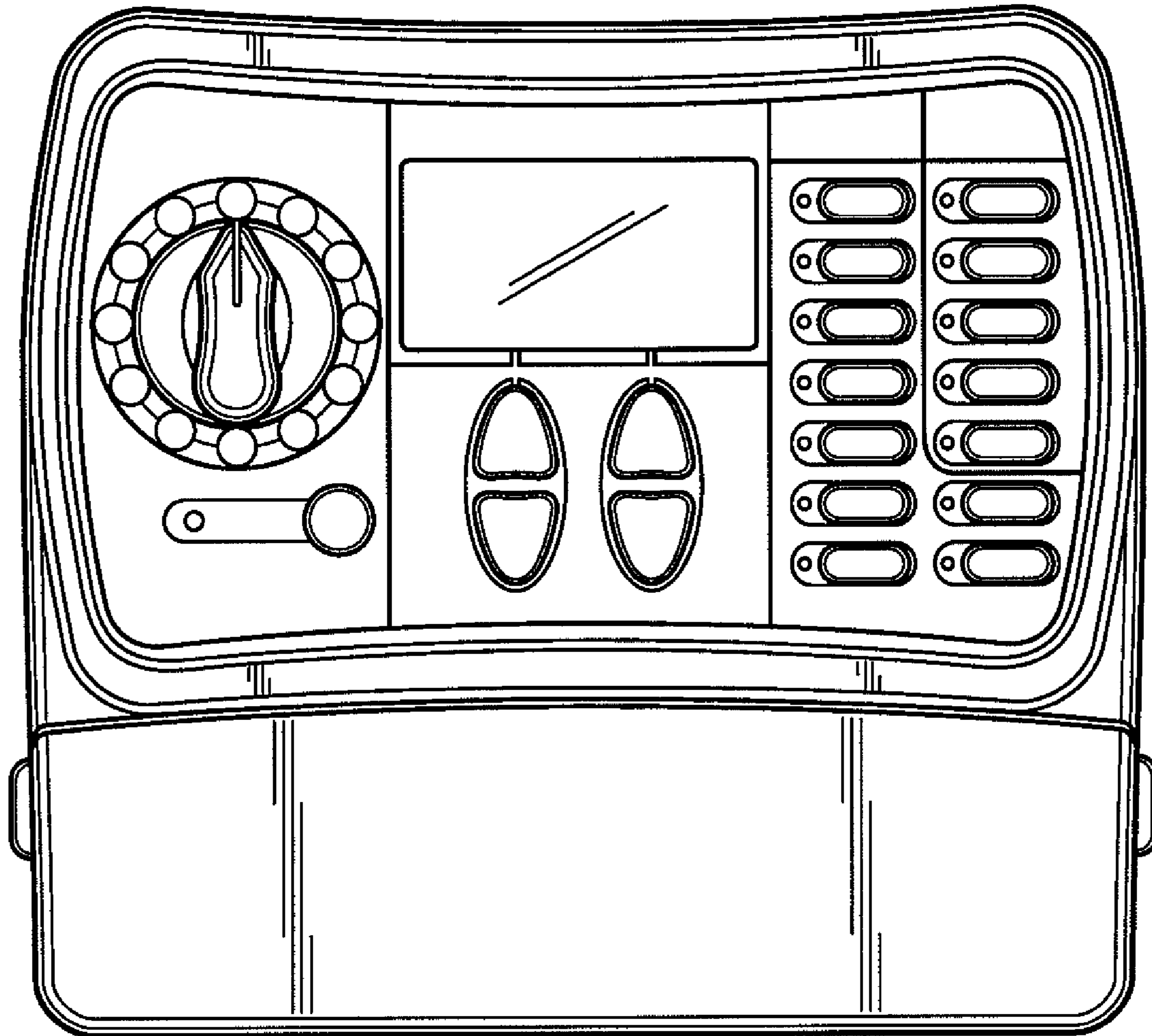
