FIG. 11 is a left side elevational view thereof in a closed position.

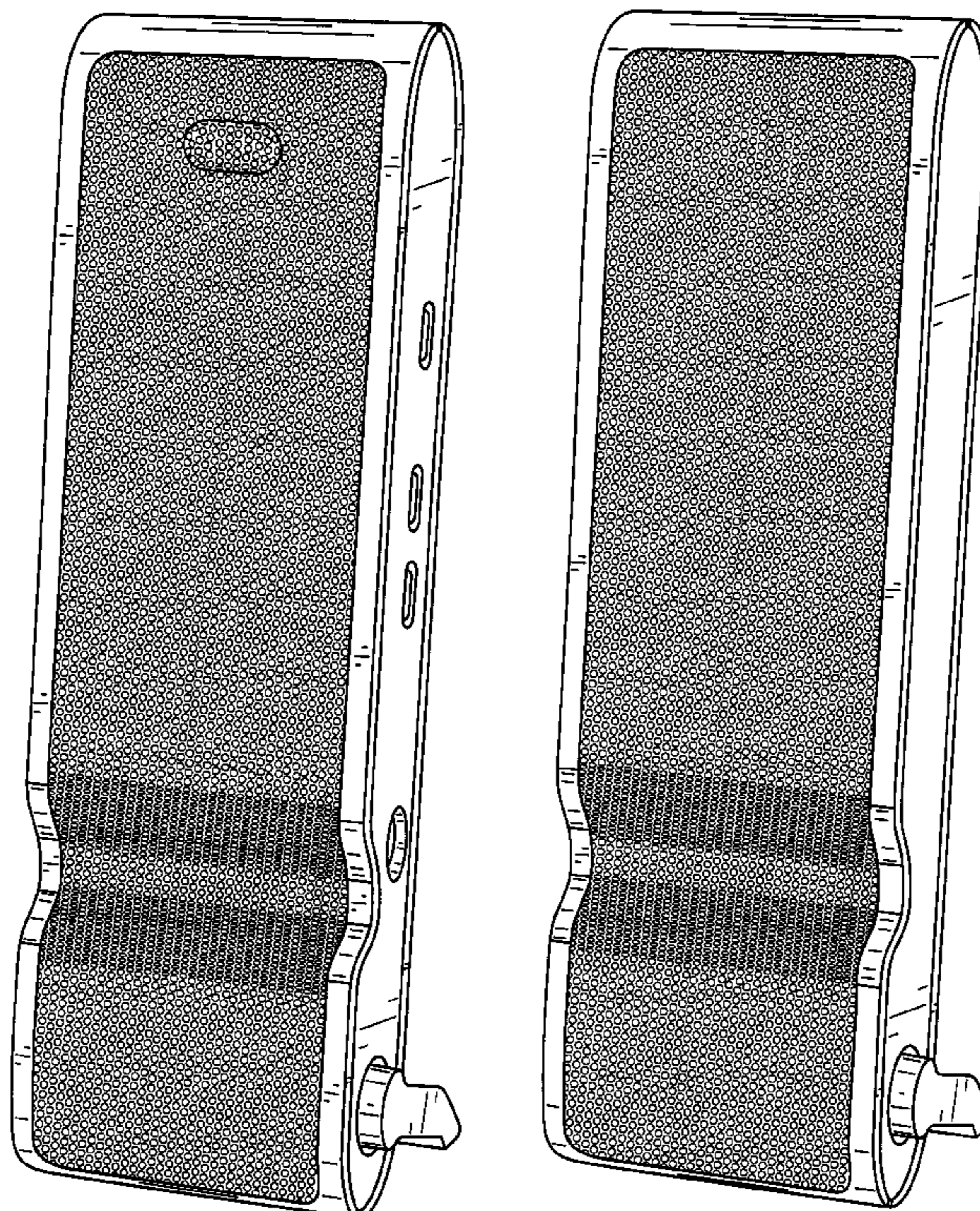

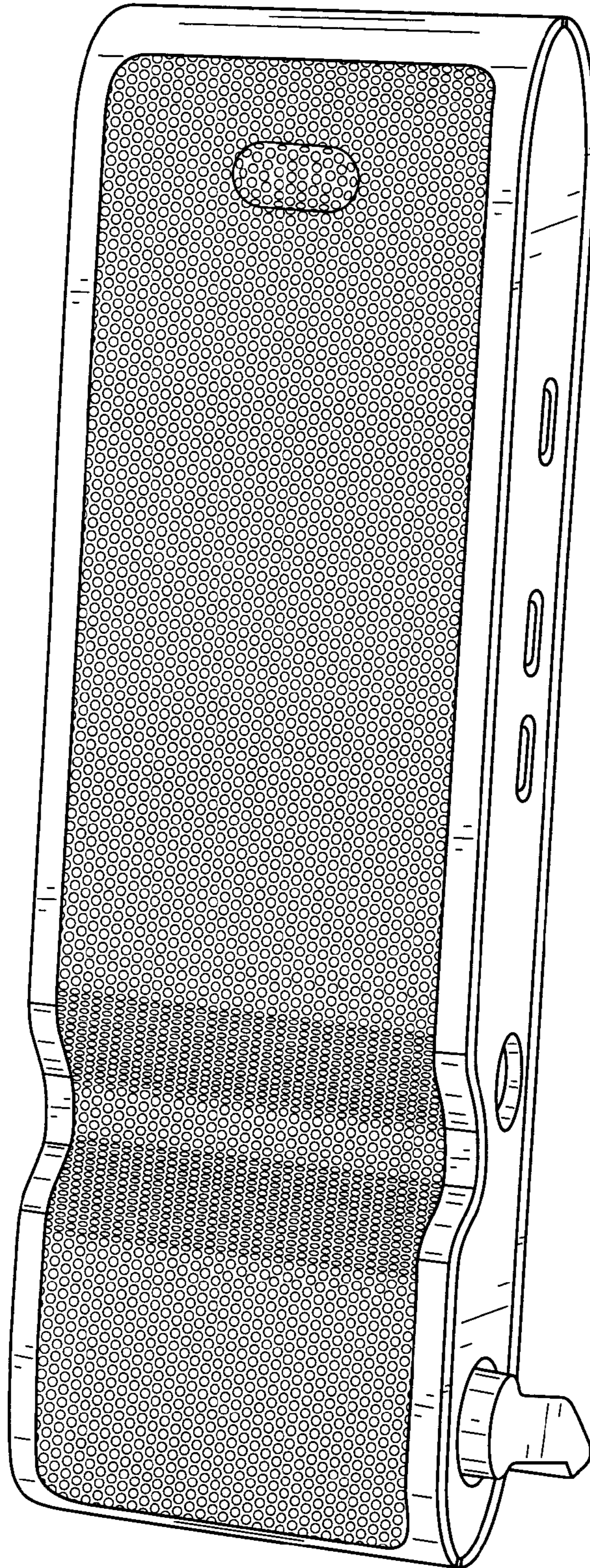

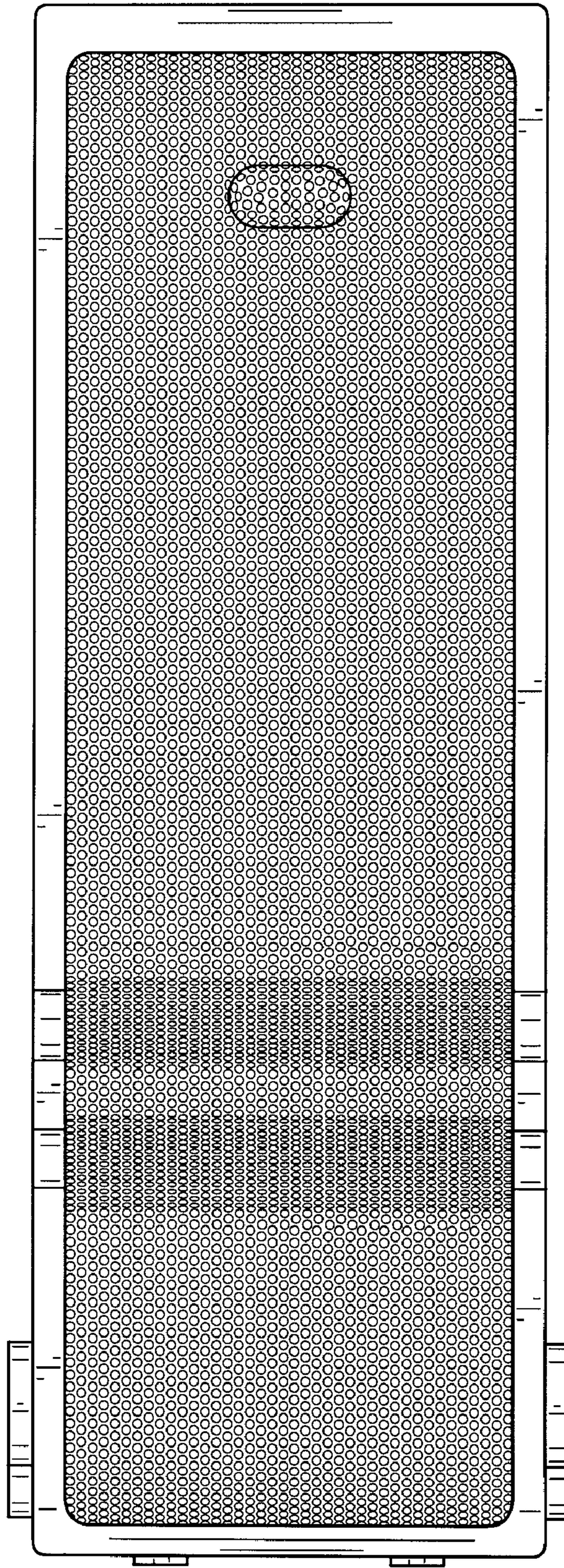

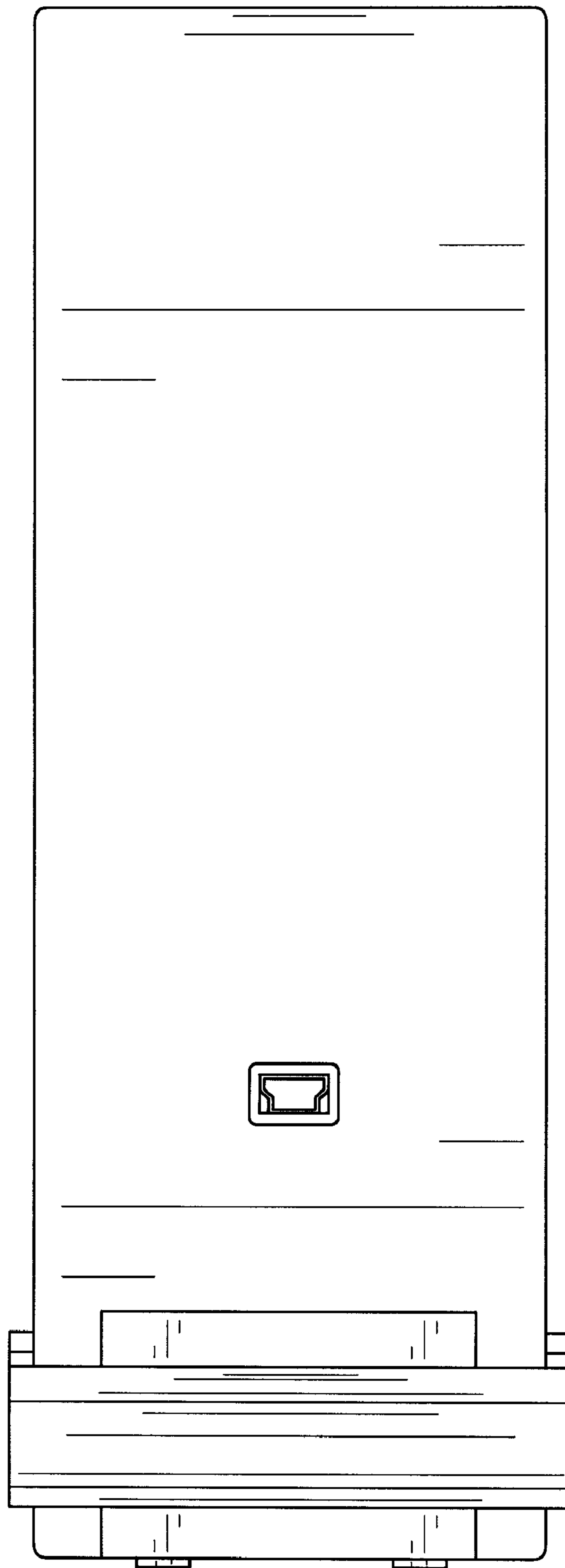

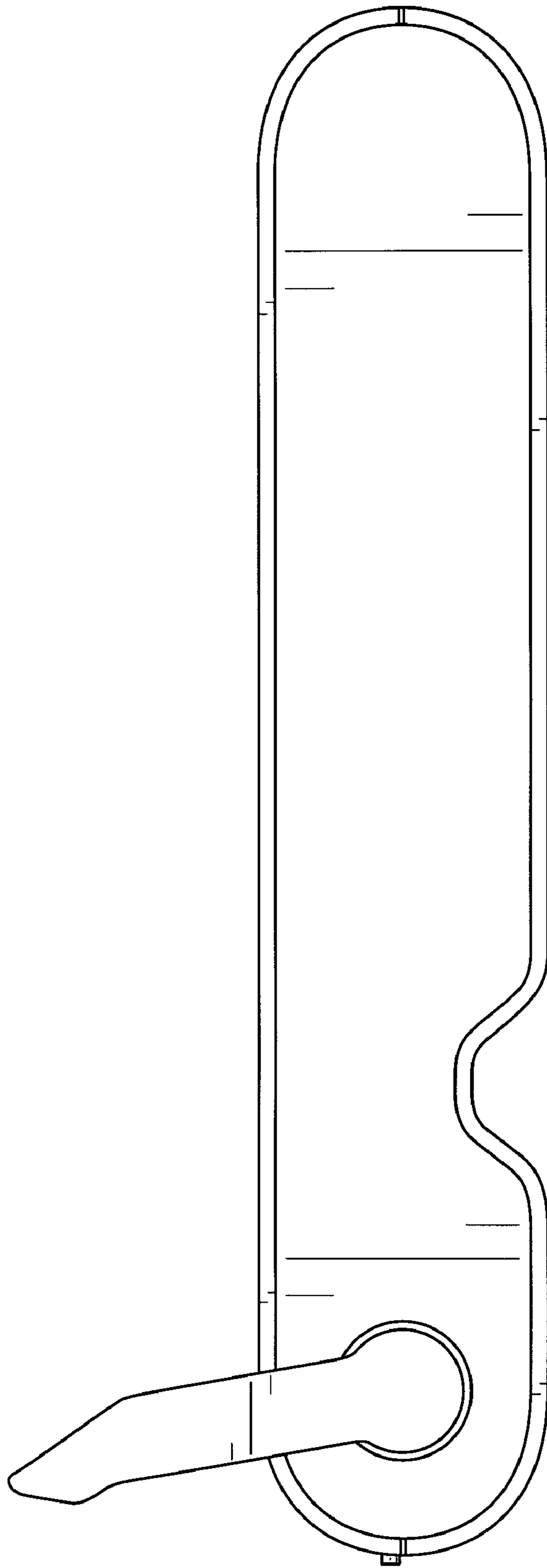

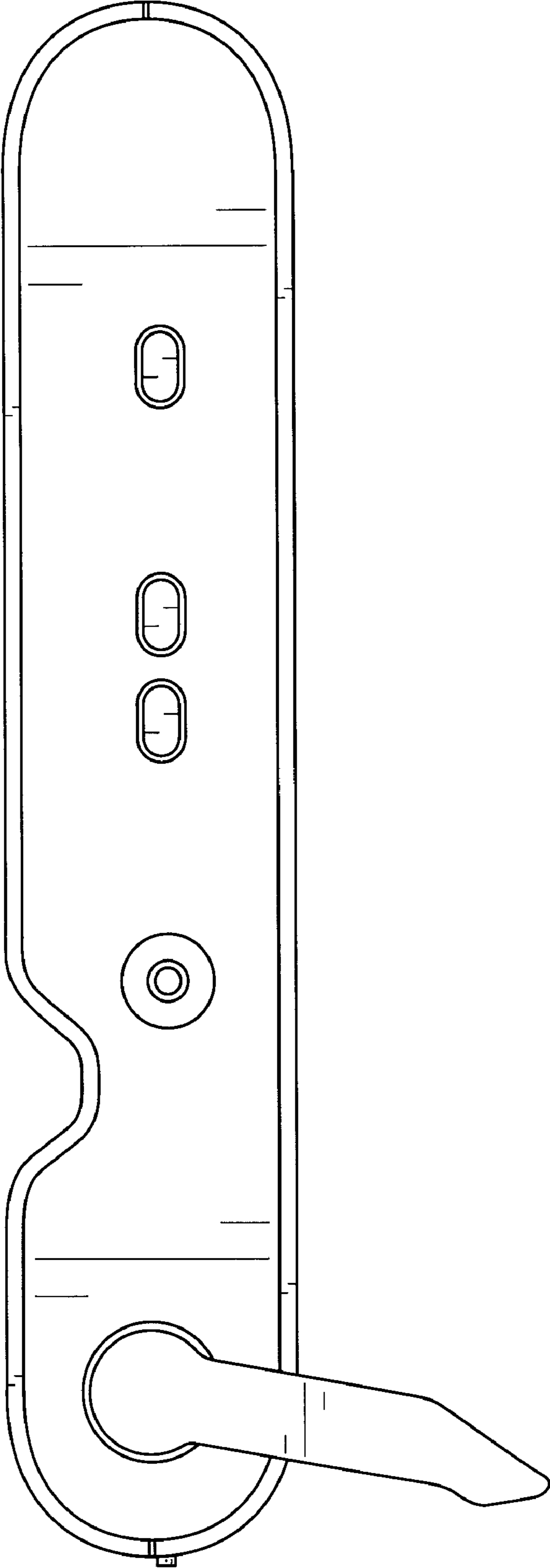

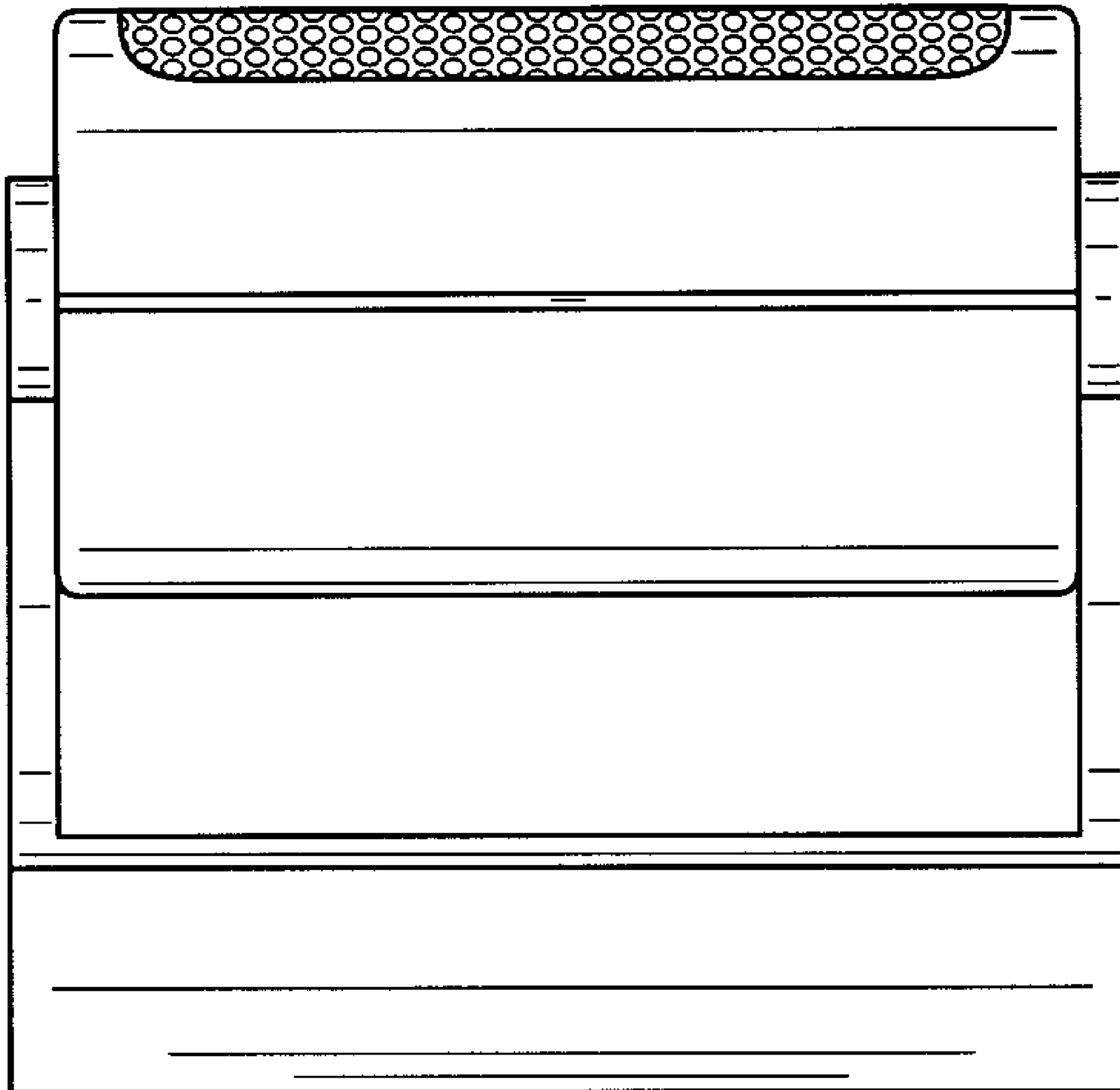

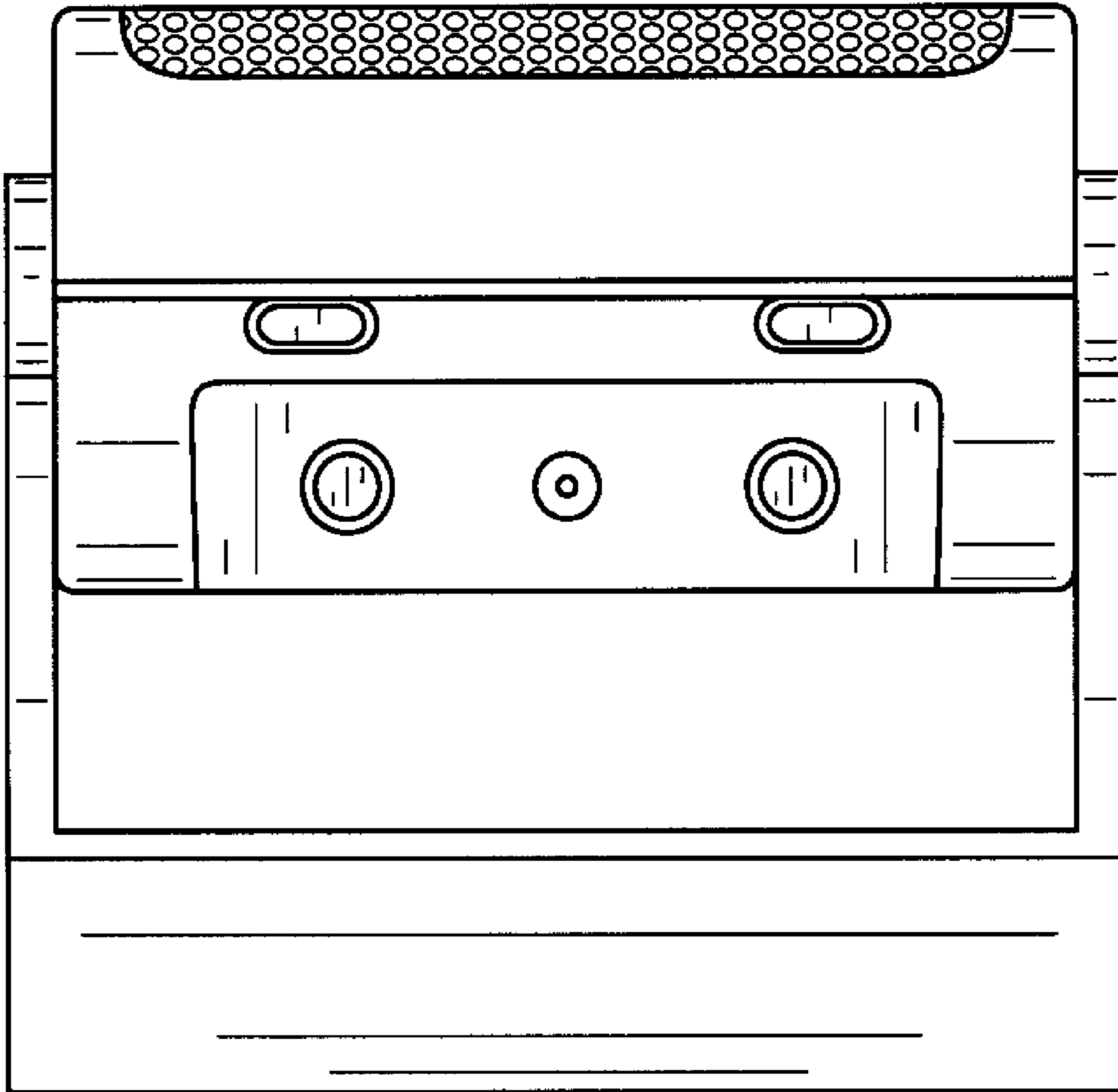

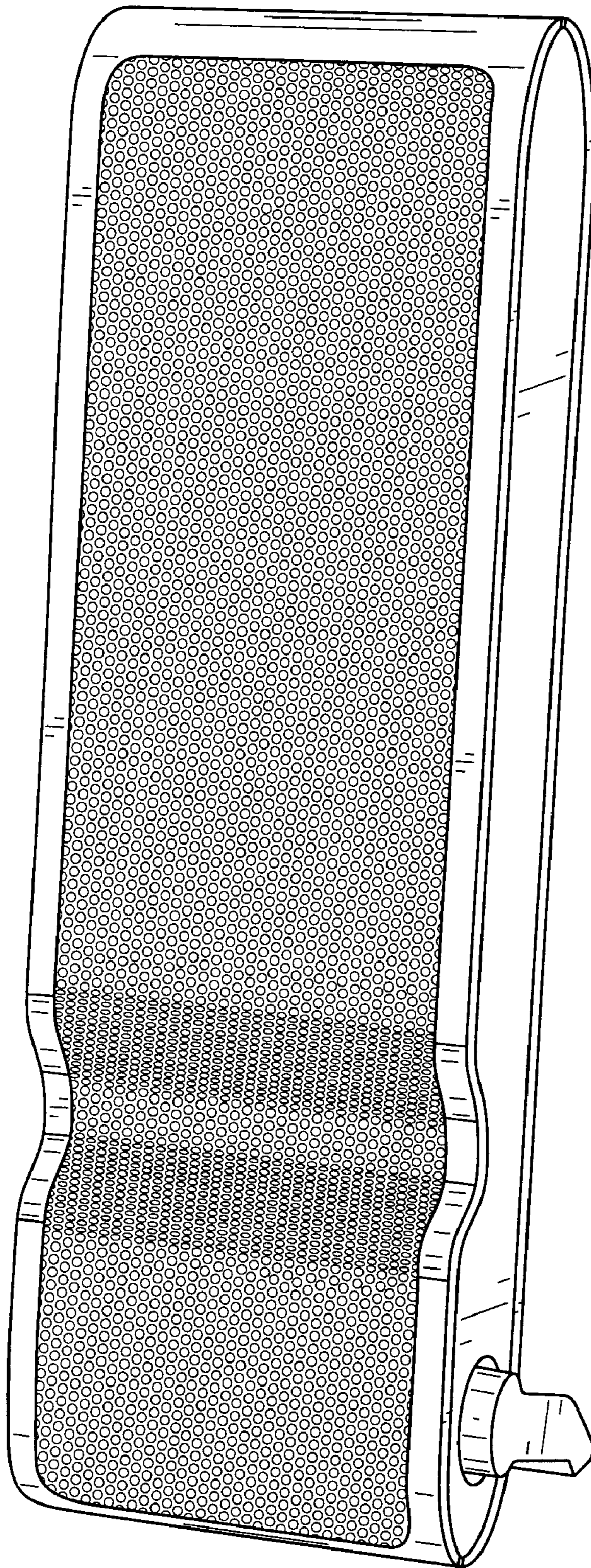

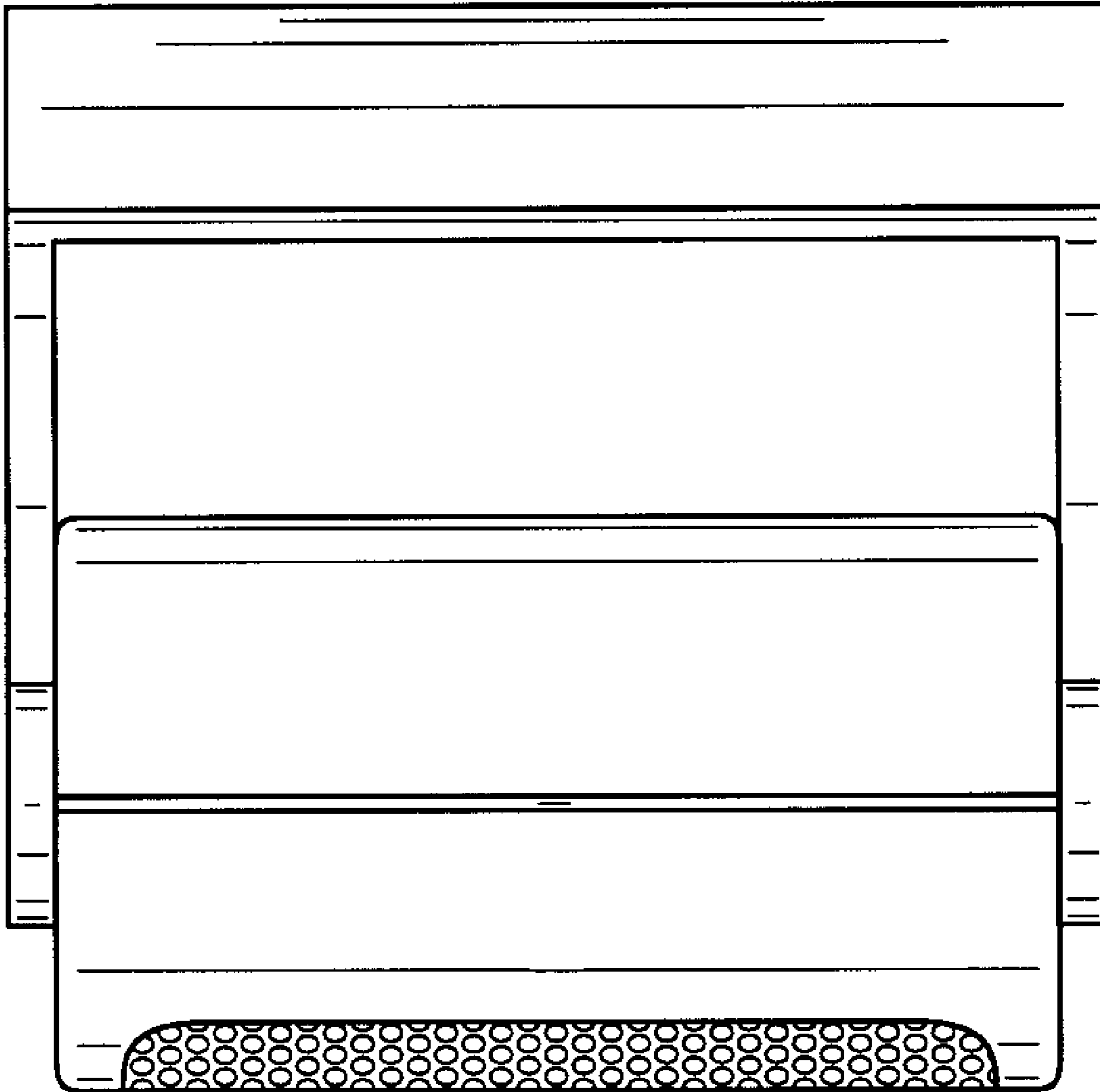

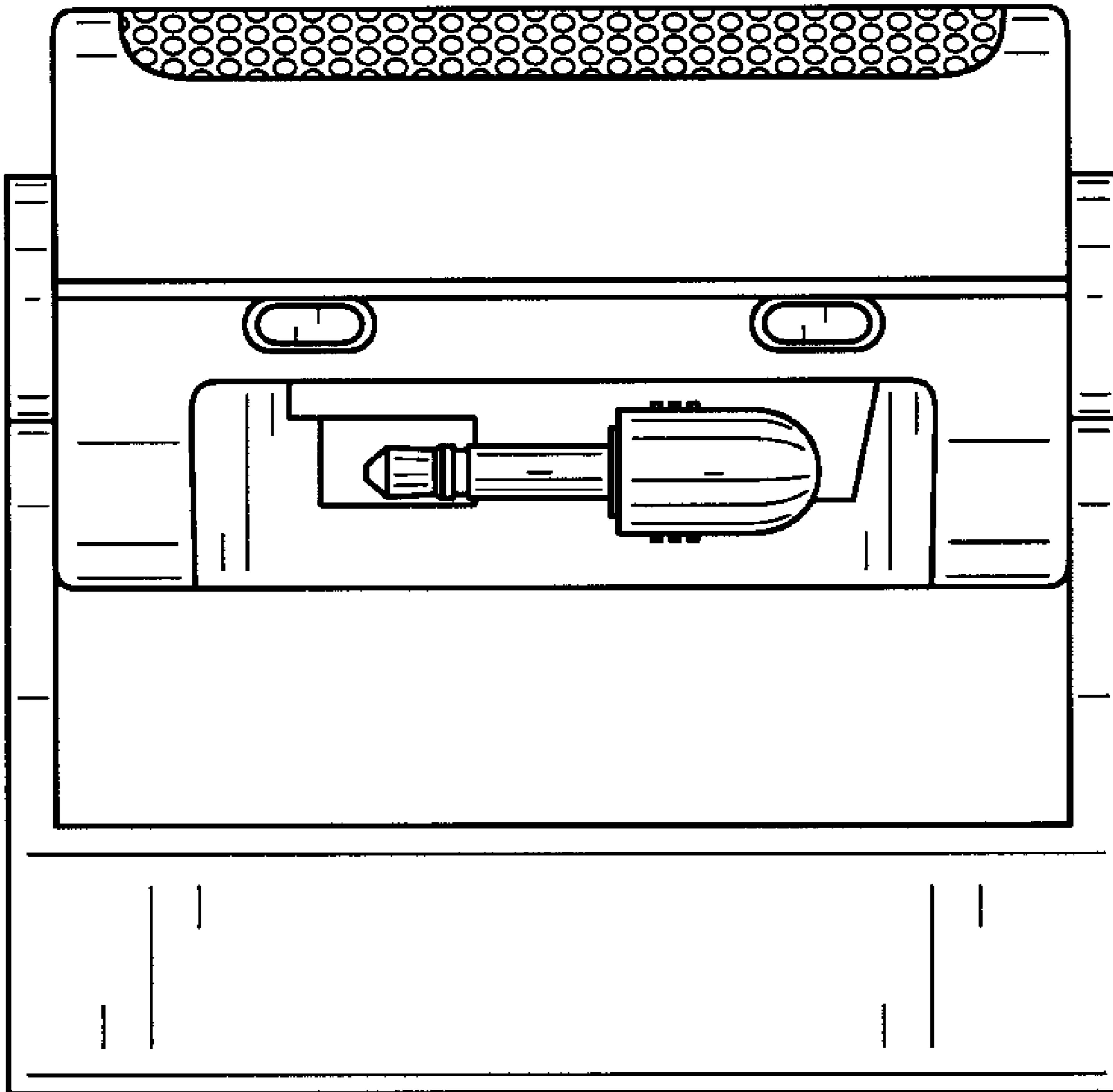

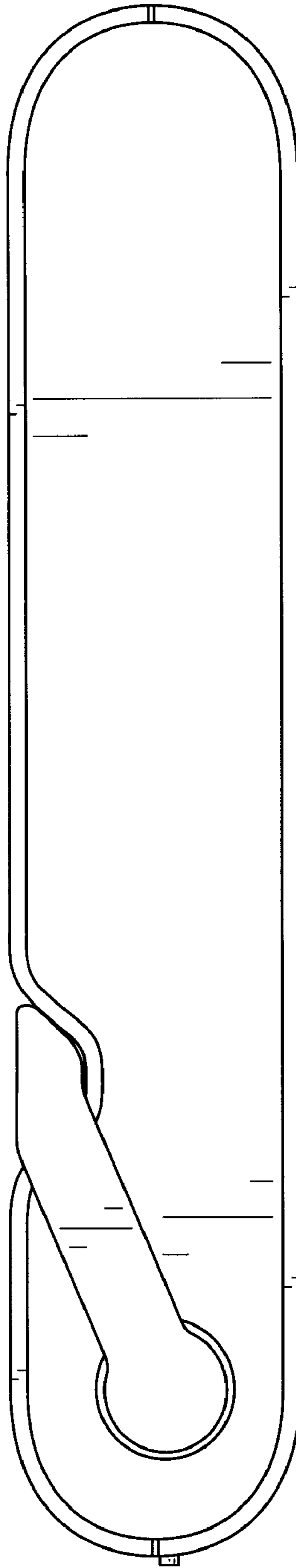
