(57) **CLAIM**

The ornamental design for a drain cover, as shown and
described.

DESCRIPTION

In a preferred embodiment, the nature of this product is a
cover for a drain opening in a plumbing fixture such a
lavatory or a bathtub.

FIG. 1 is a top, front perspective view of a drain cover
according to my new design;

FIG. 2 is a top plan view thereof;

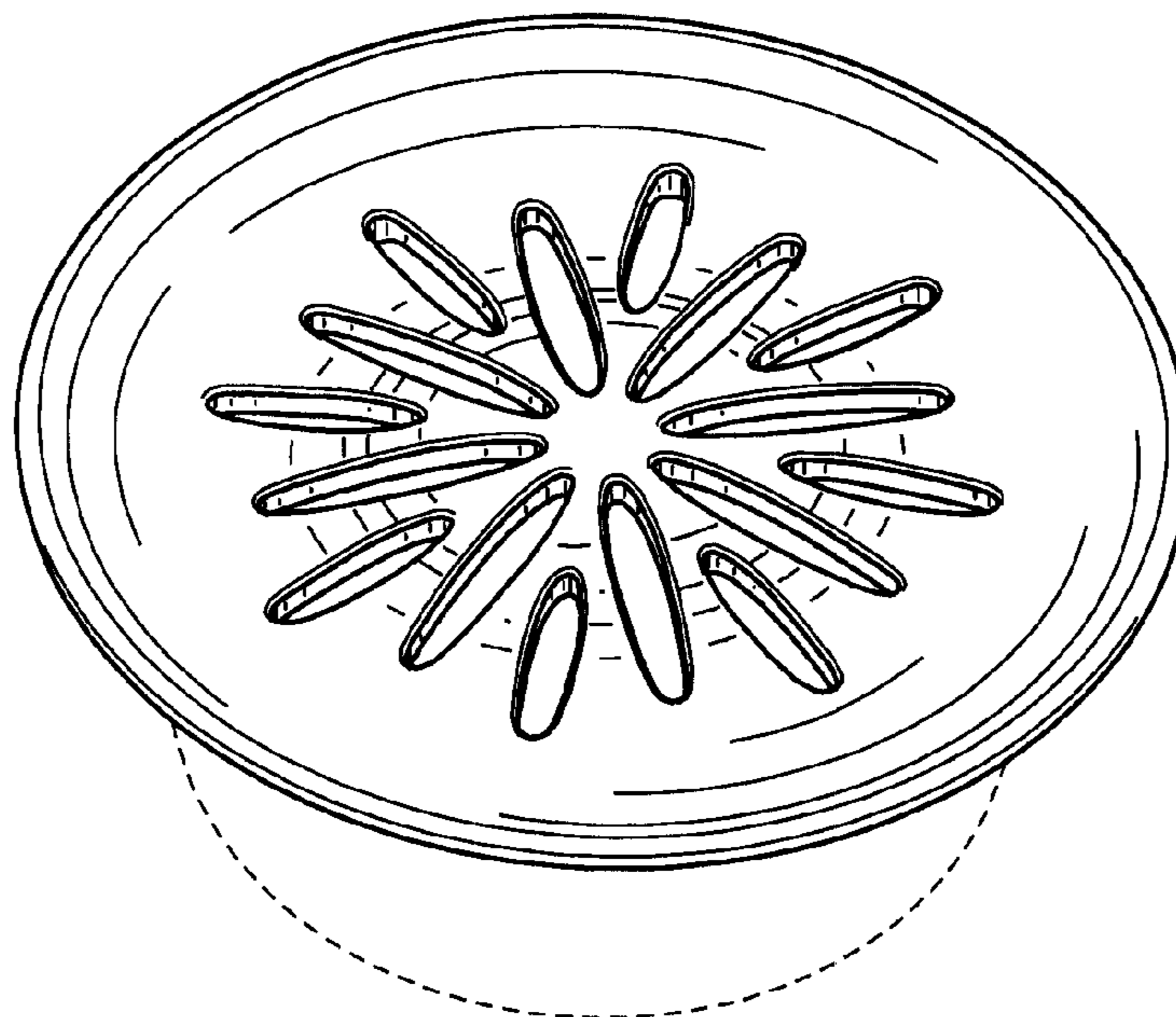
FIG. 3 is a front elevational view thereof;

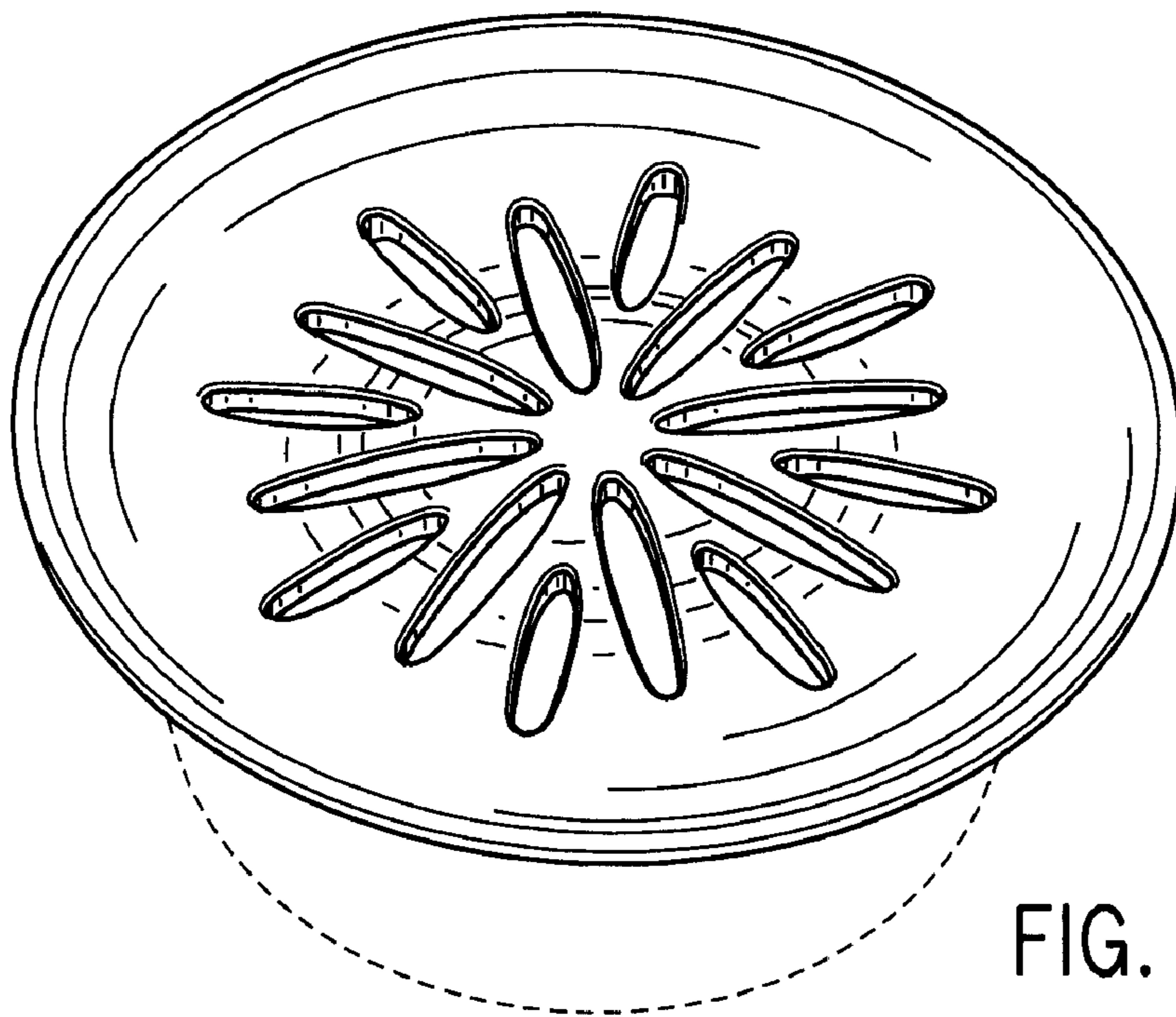

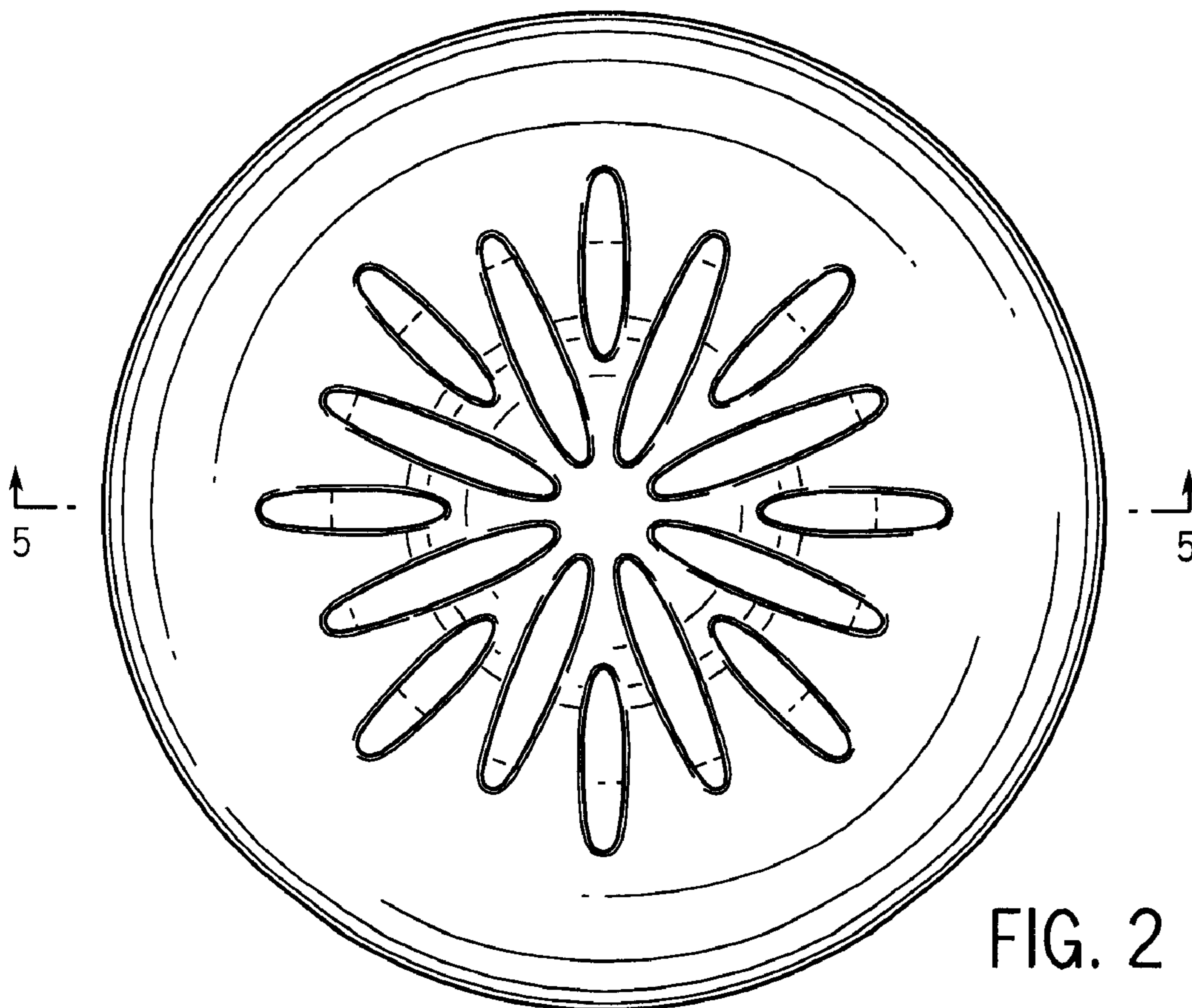

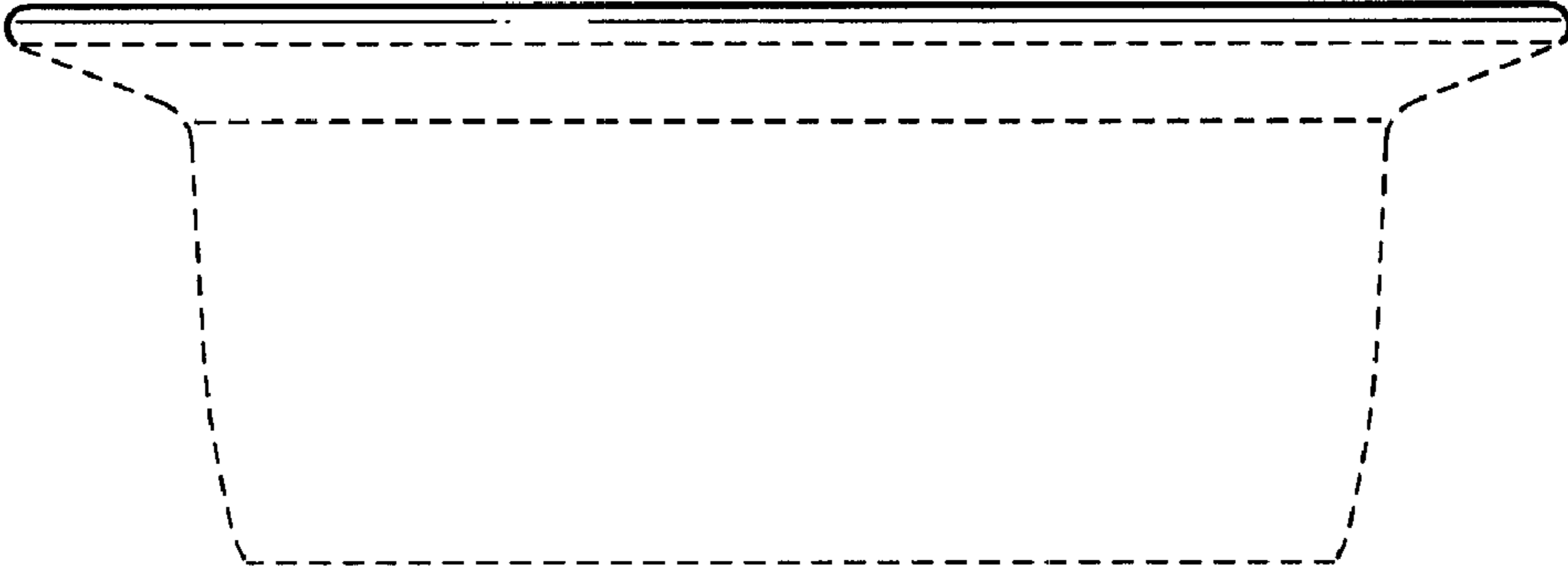

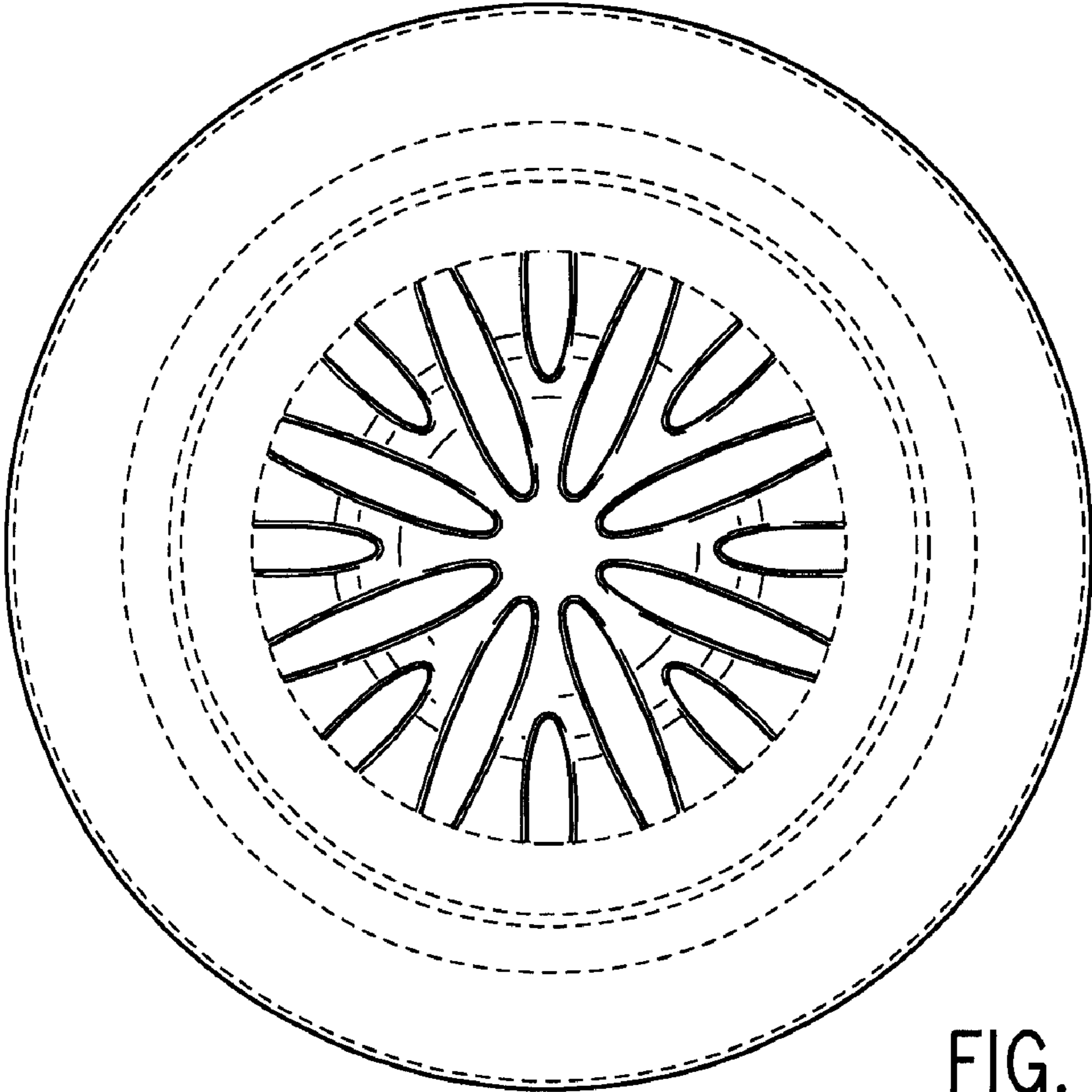

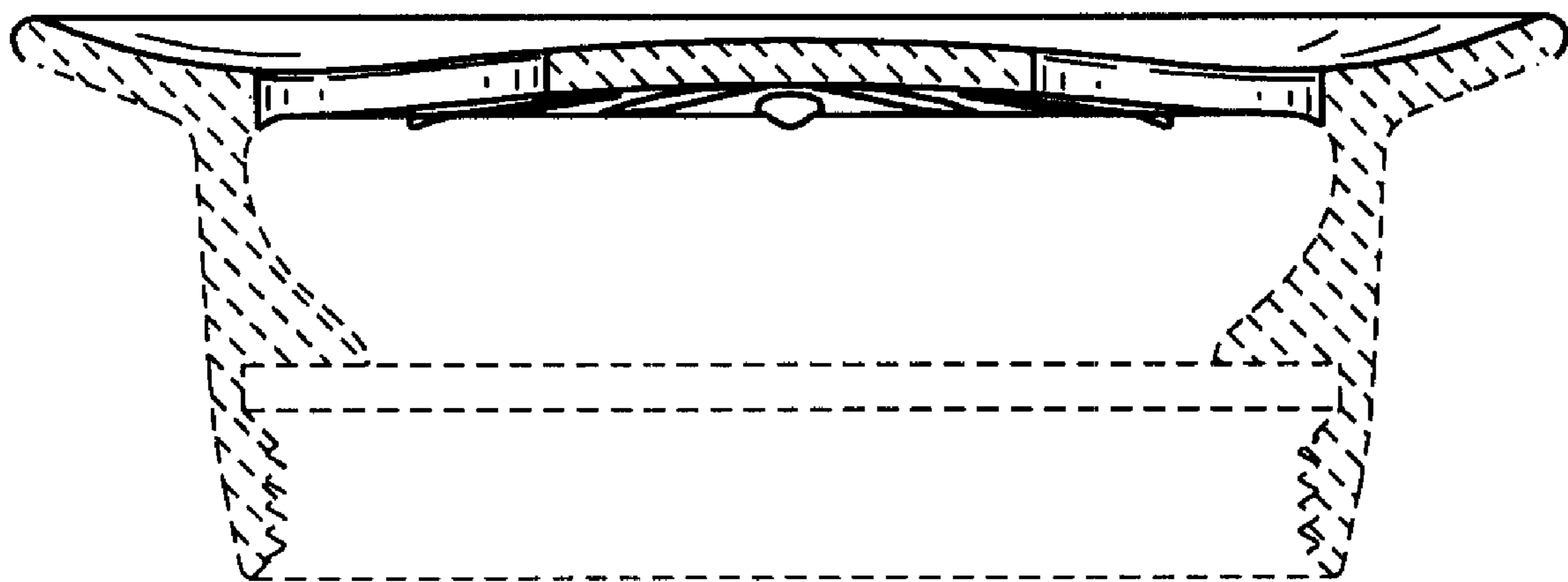
