FIG. 3 is a right side view of the design shown in FIG. 1.

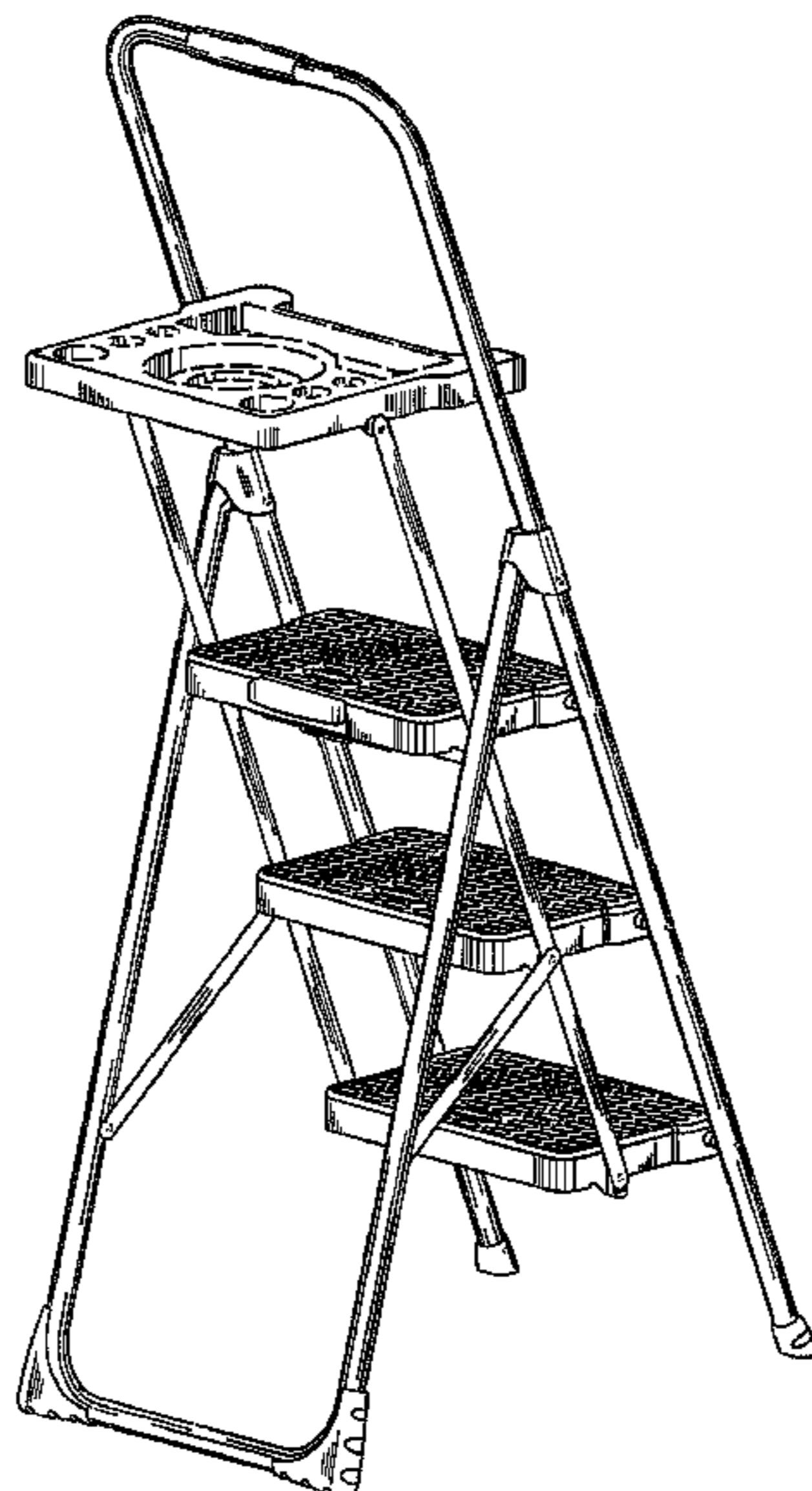
FIG. 4 is a front view of the design shown in FIG. 1.

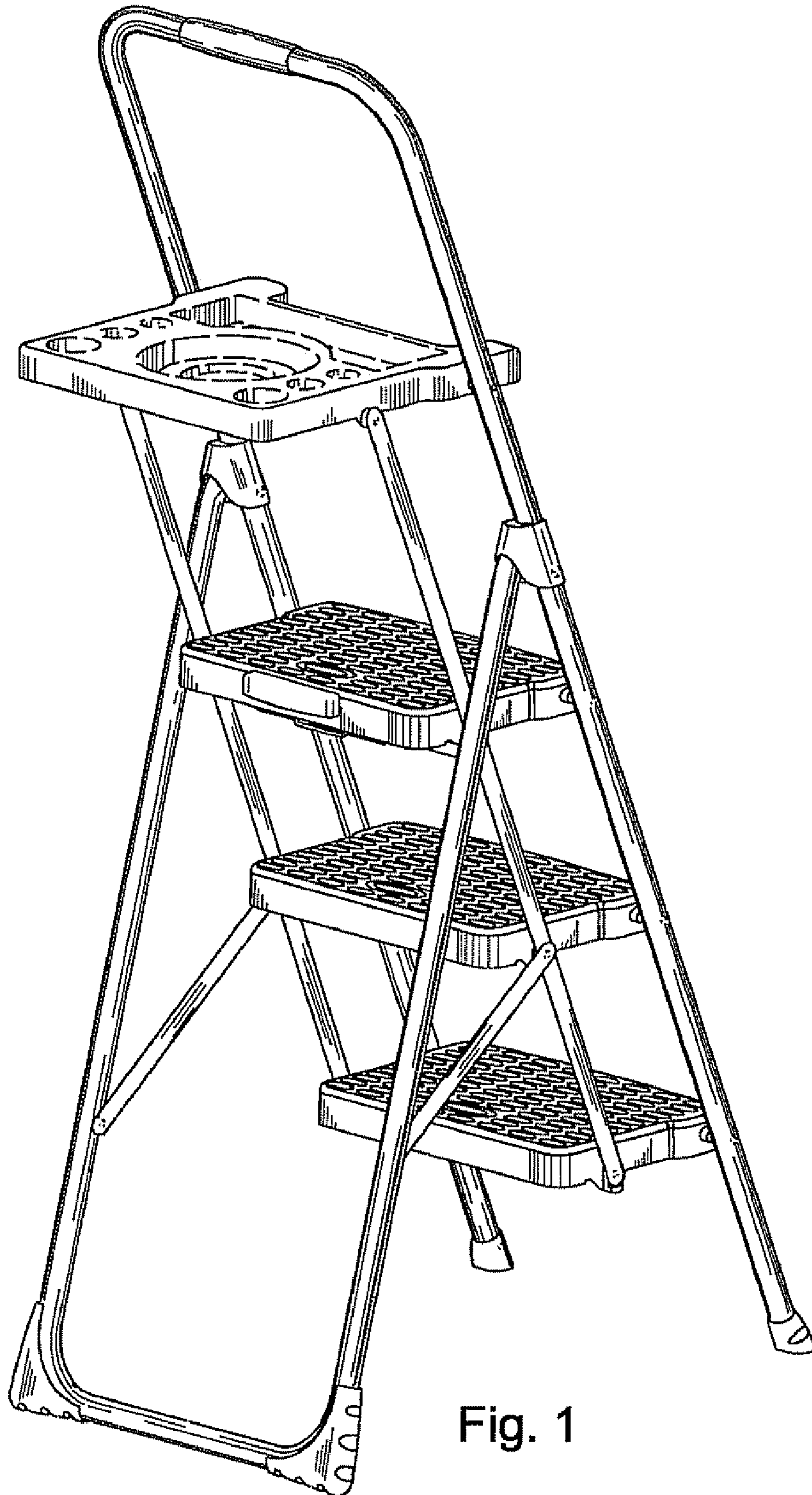

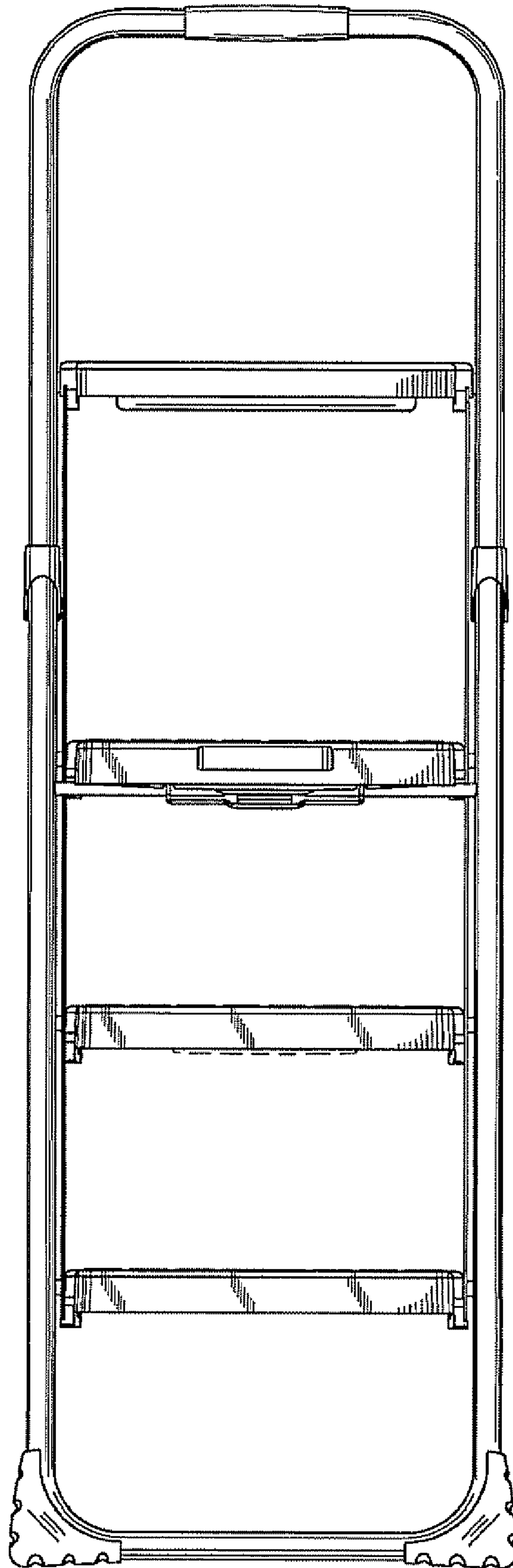

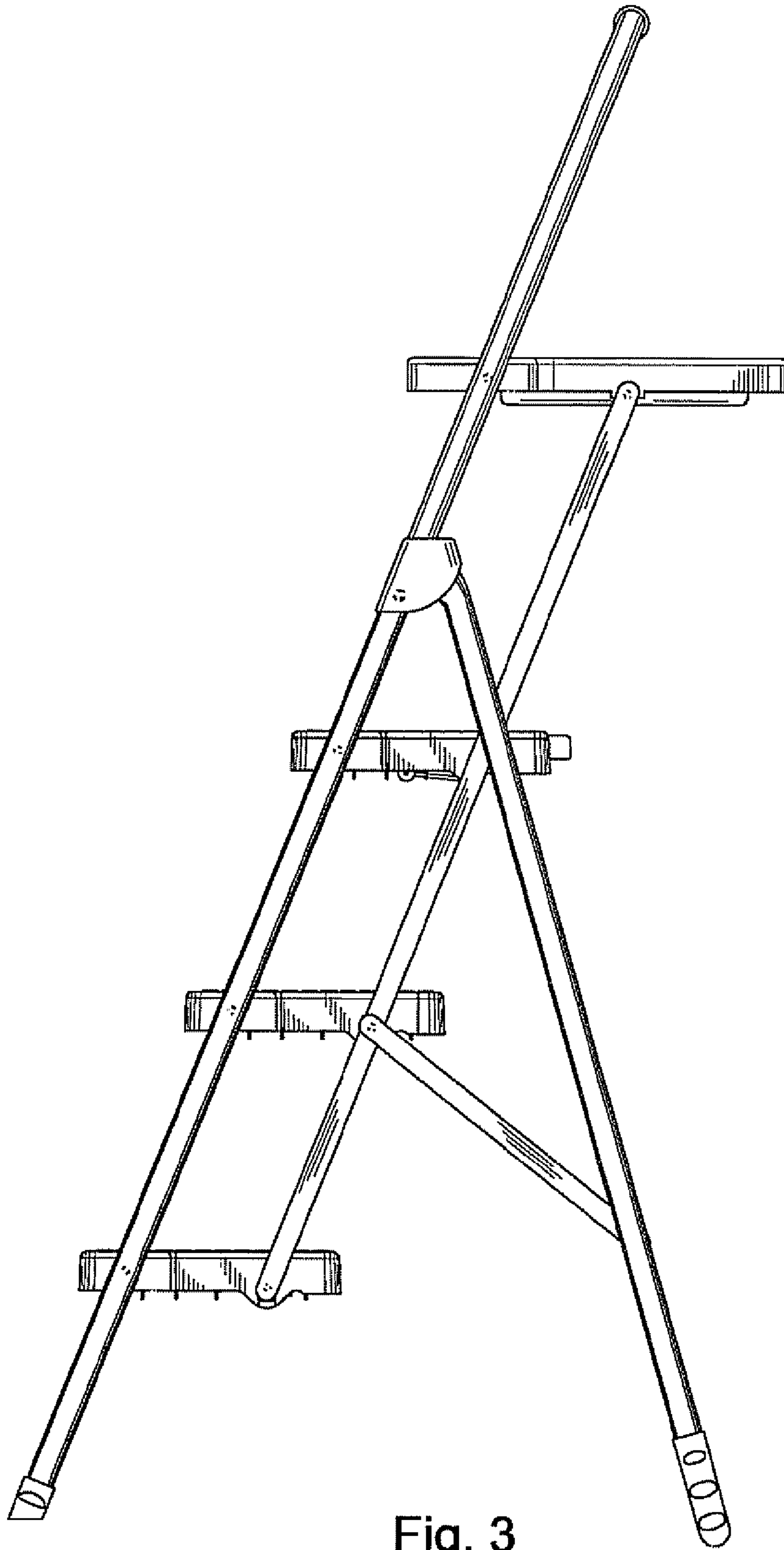

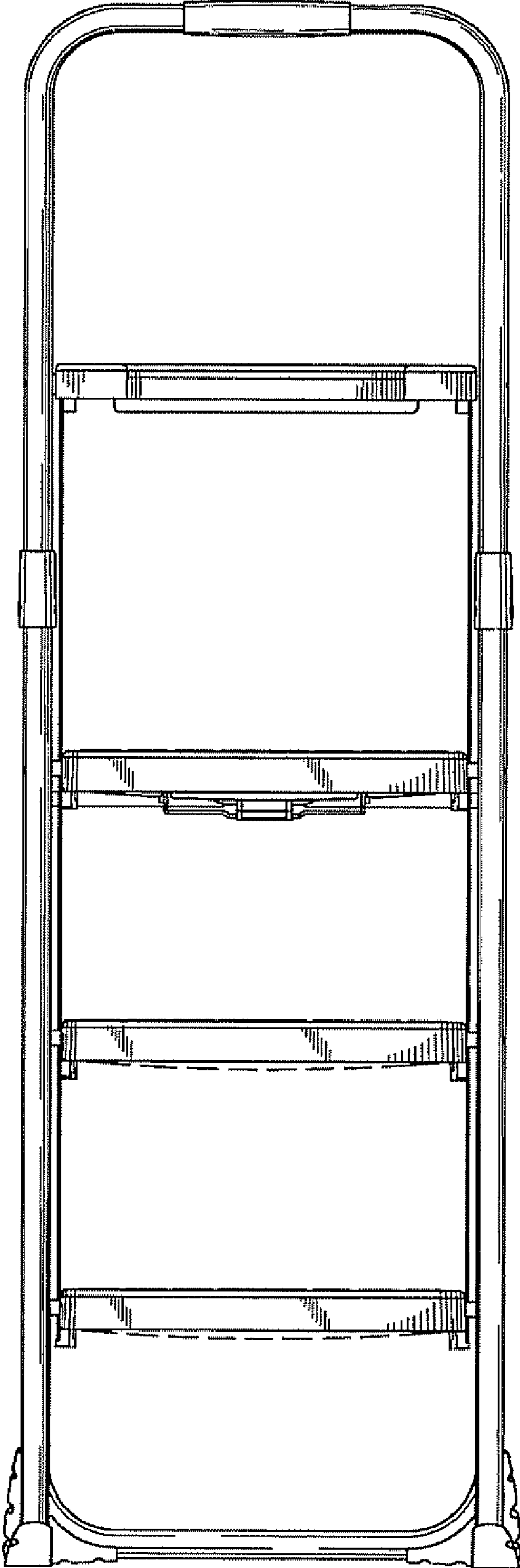

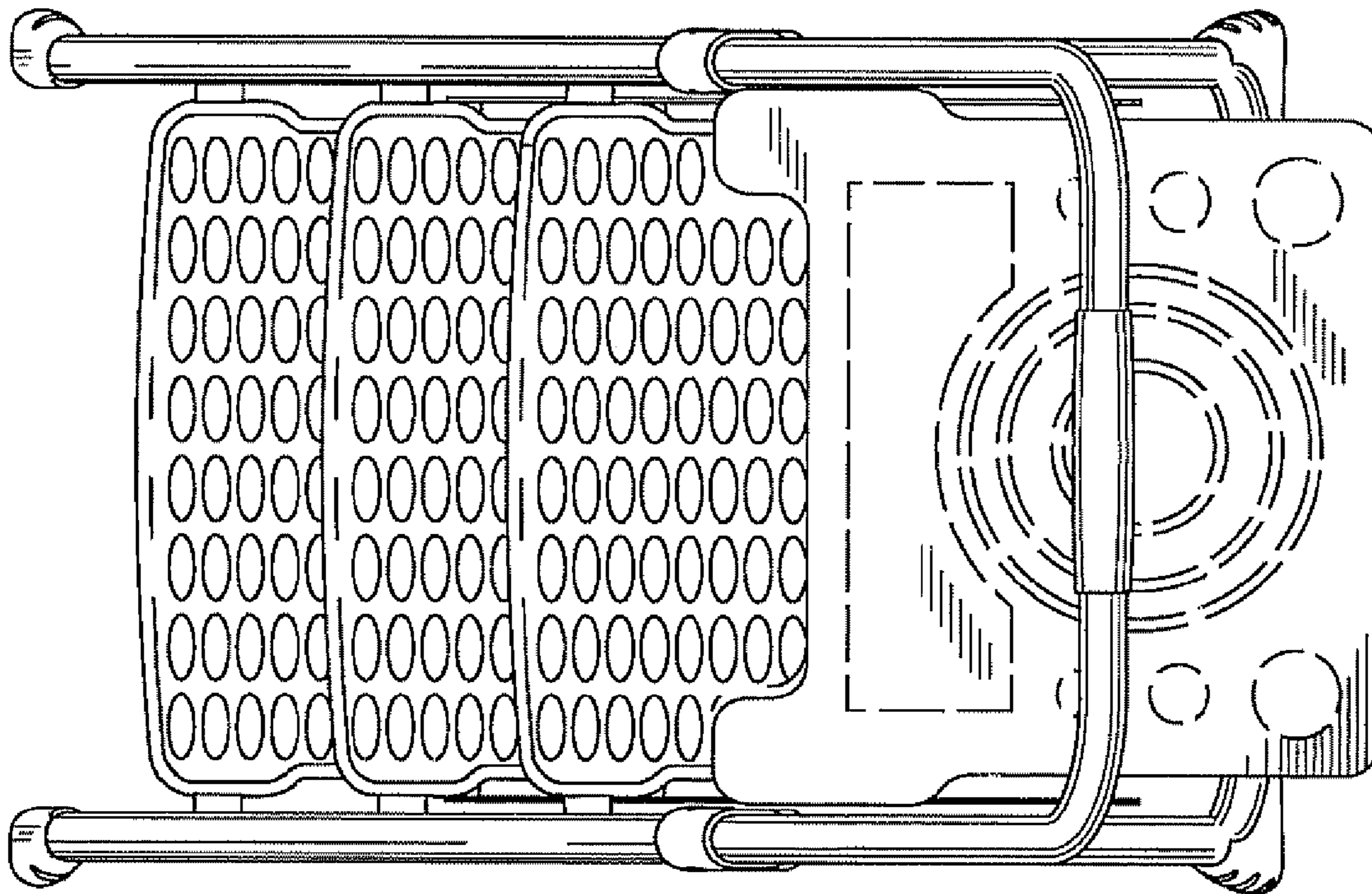

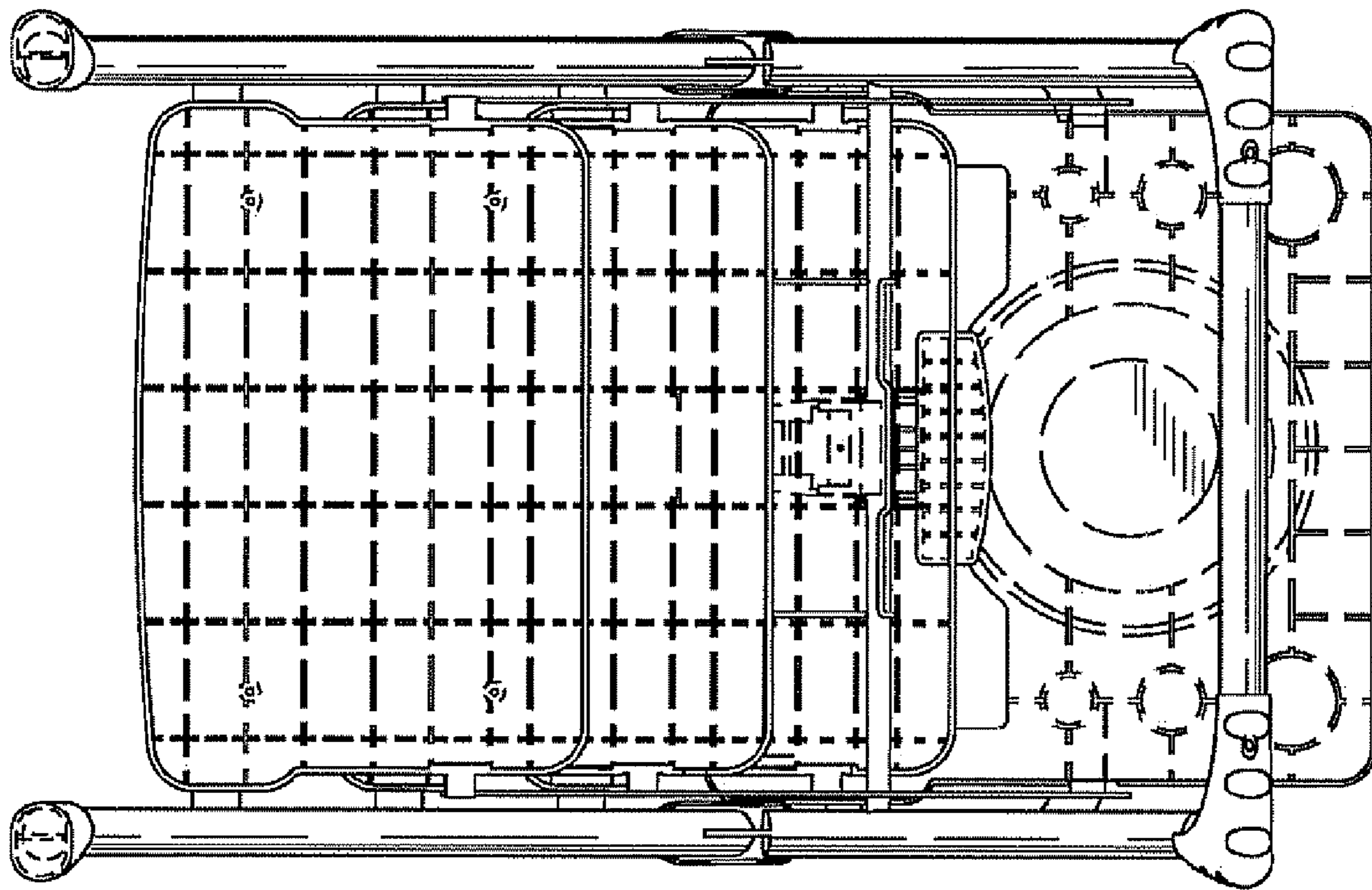
