DESCRIPTION

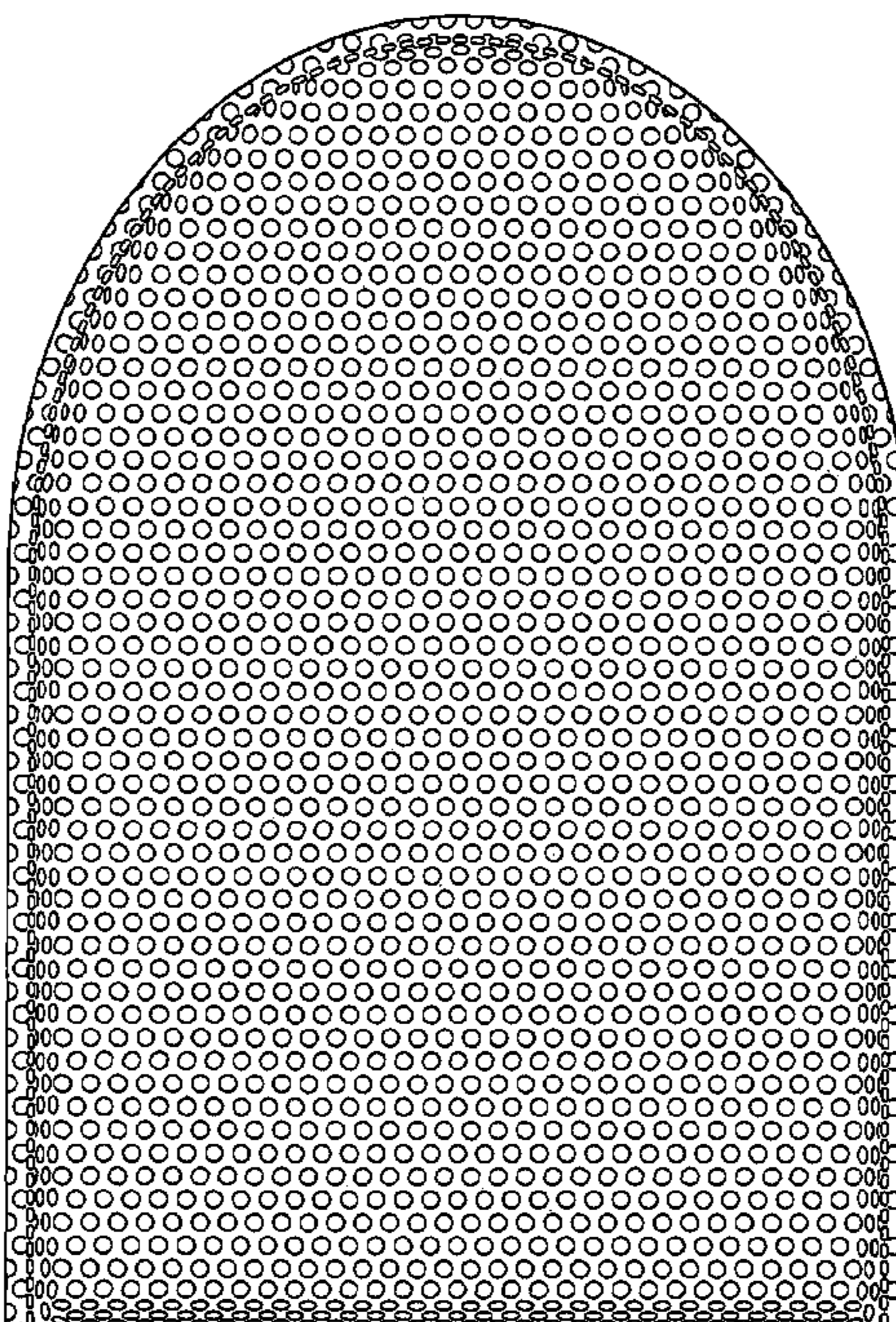
FIG. 1 is a front view of a cleaning article, embodying our new design;

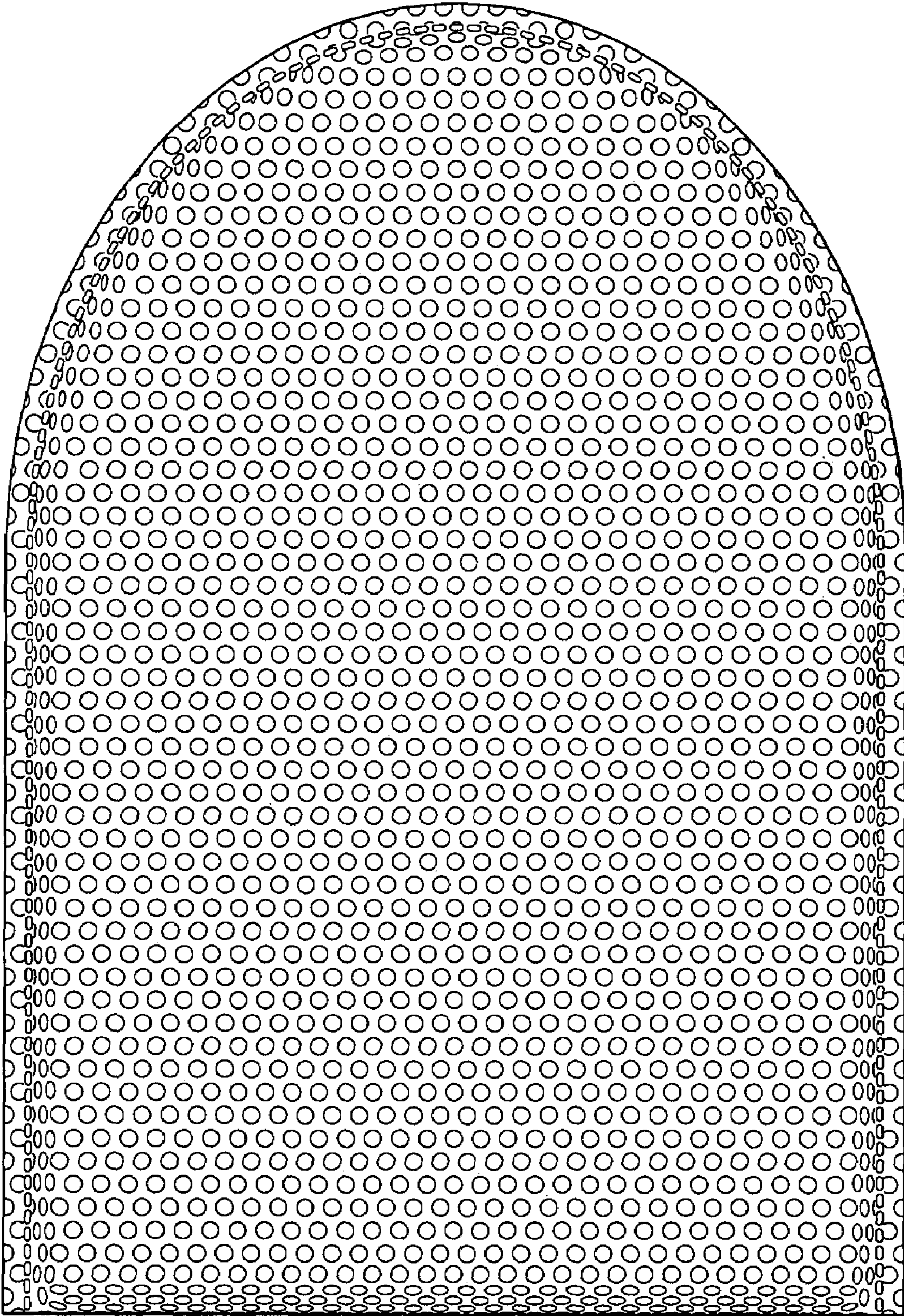

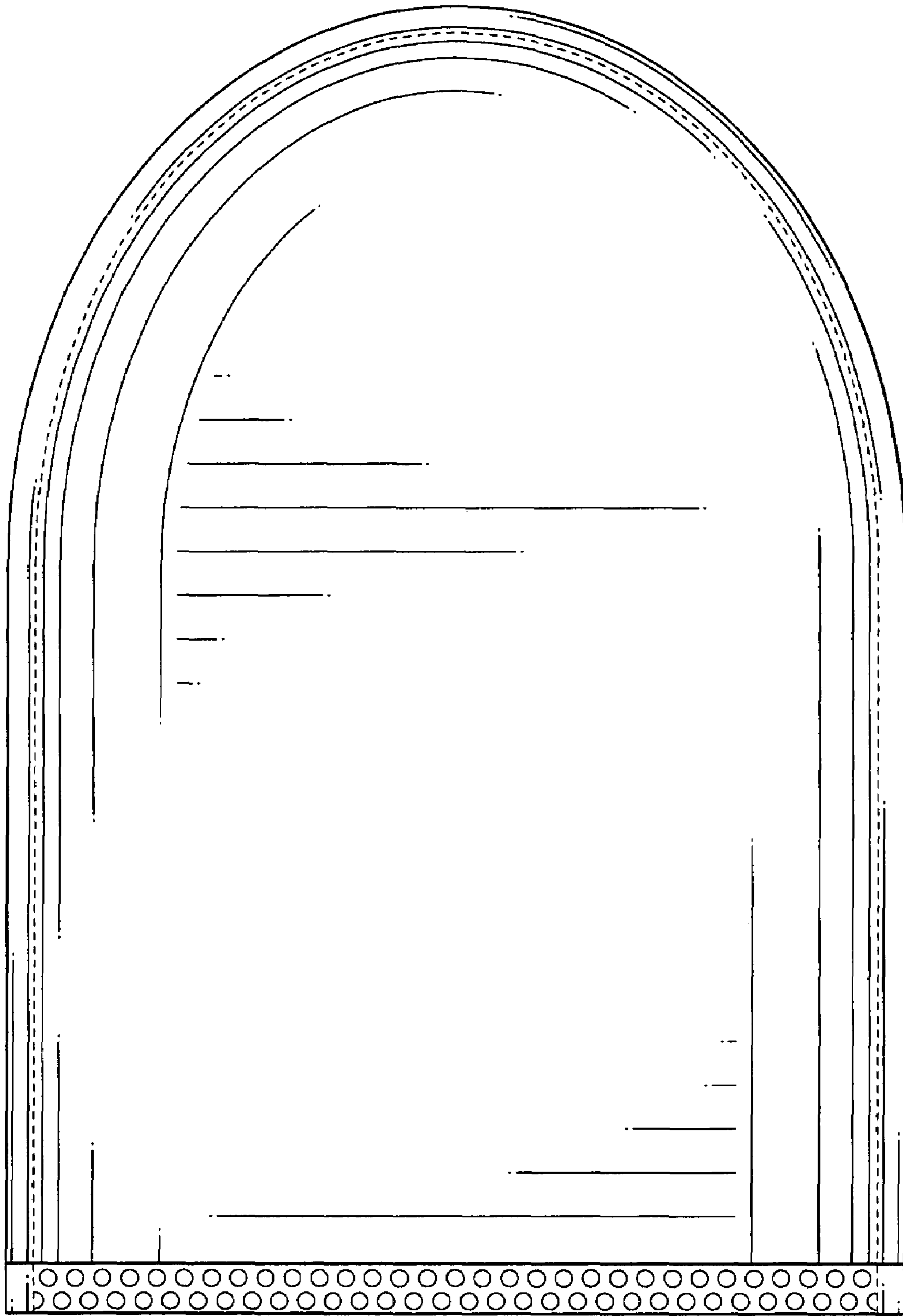

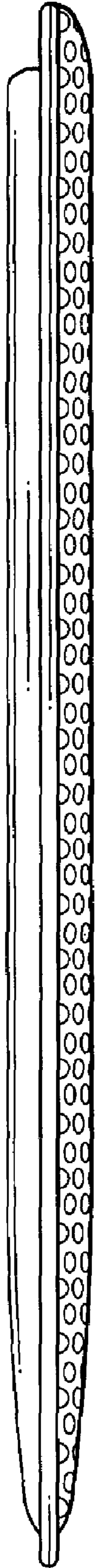

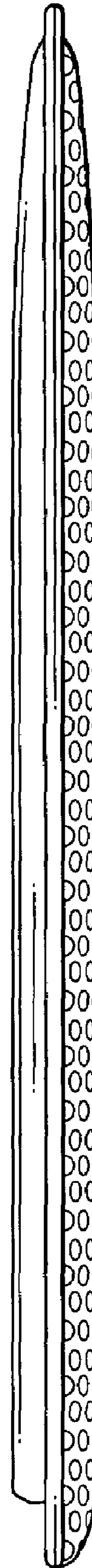

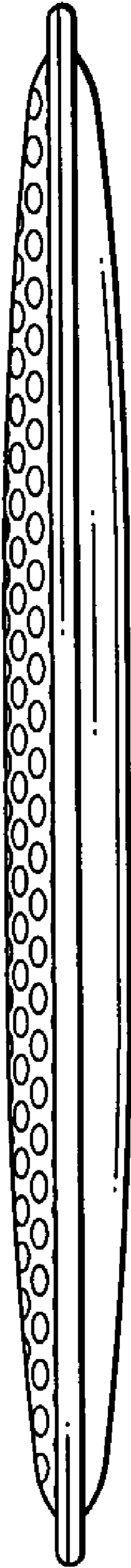

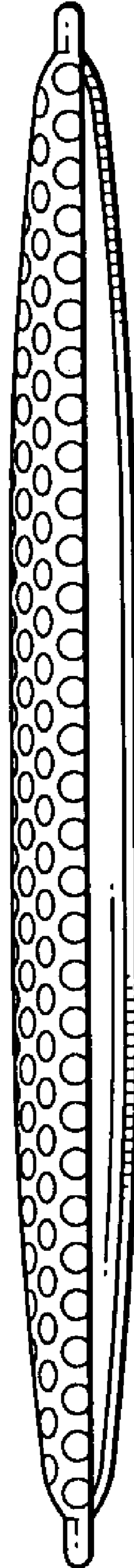
