(57) **CLAIM**

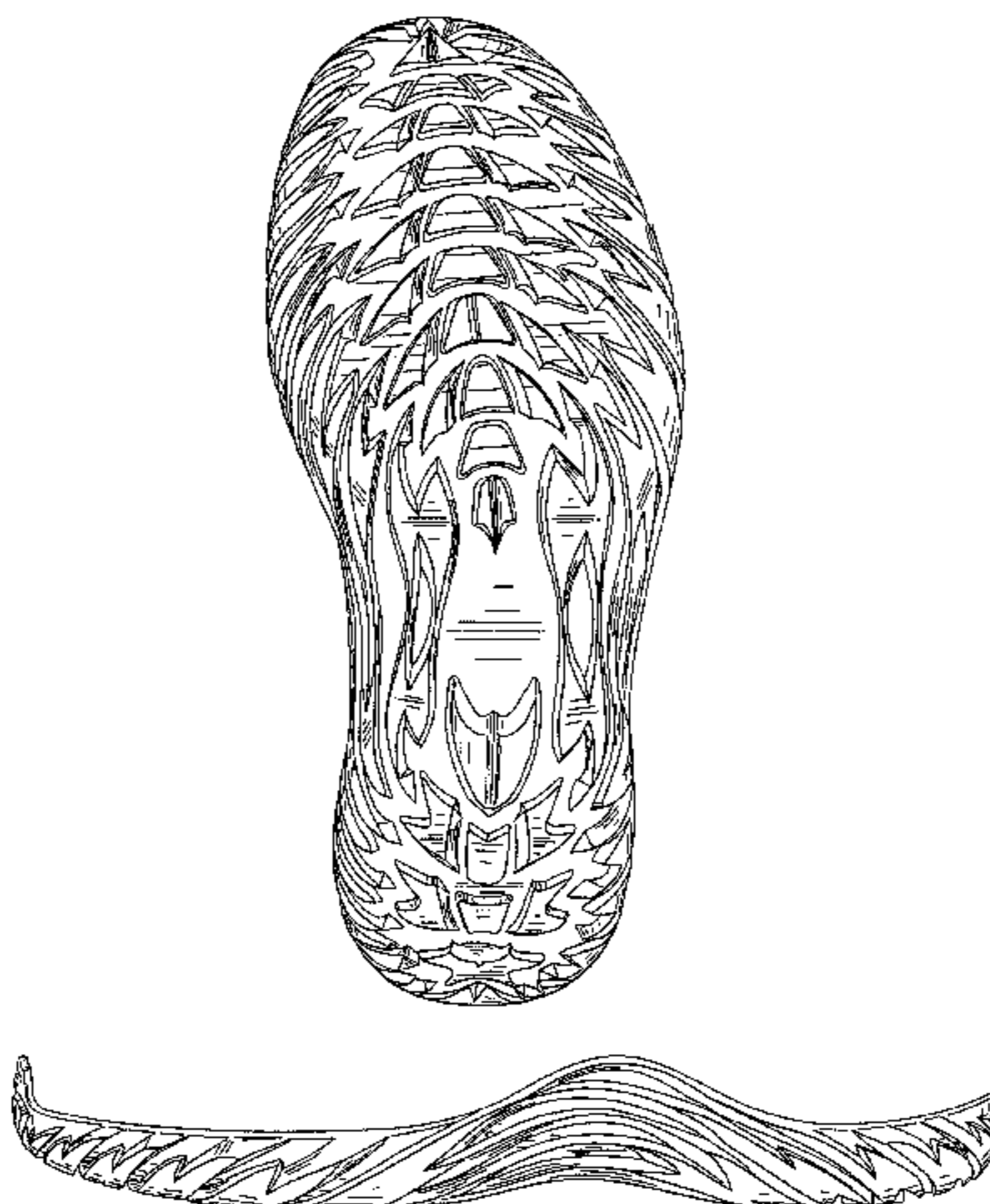
I claim the ornamental design for an outsole for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of an outsole for a shoe showing my new design;  
 FIG. 2 is a bottom view thereof;  
 FIG. 3 is a right side view thereof;  
 FIG. 4 is a left side view thereof;  
 FIG. 5 is a front view thereof; and,  
 FIG. 6 is a rear view thereof.

The broken line showing a strip across the front of FIGS. 1, 3, 4, & 5 represents the boundary of the design; with neither the lines themselves, nor the area within them forming any part of the claim.

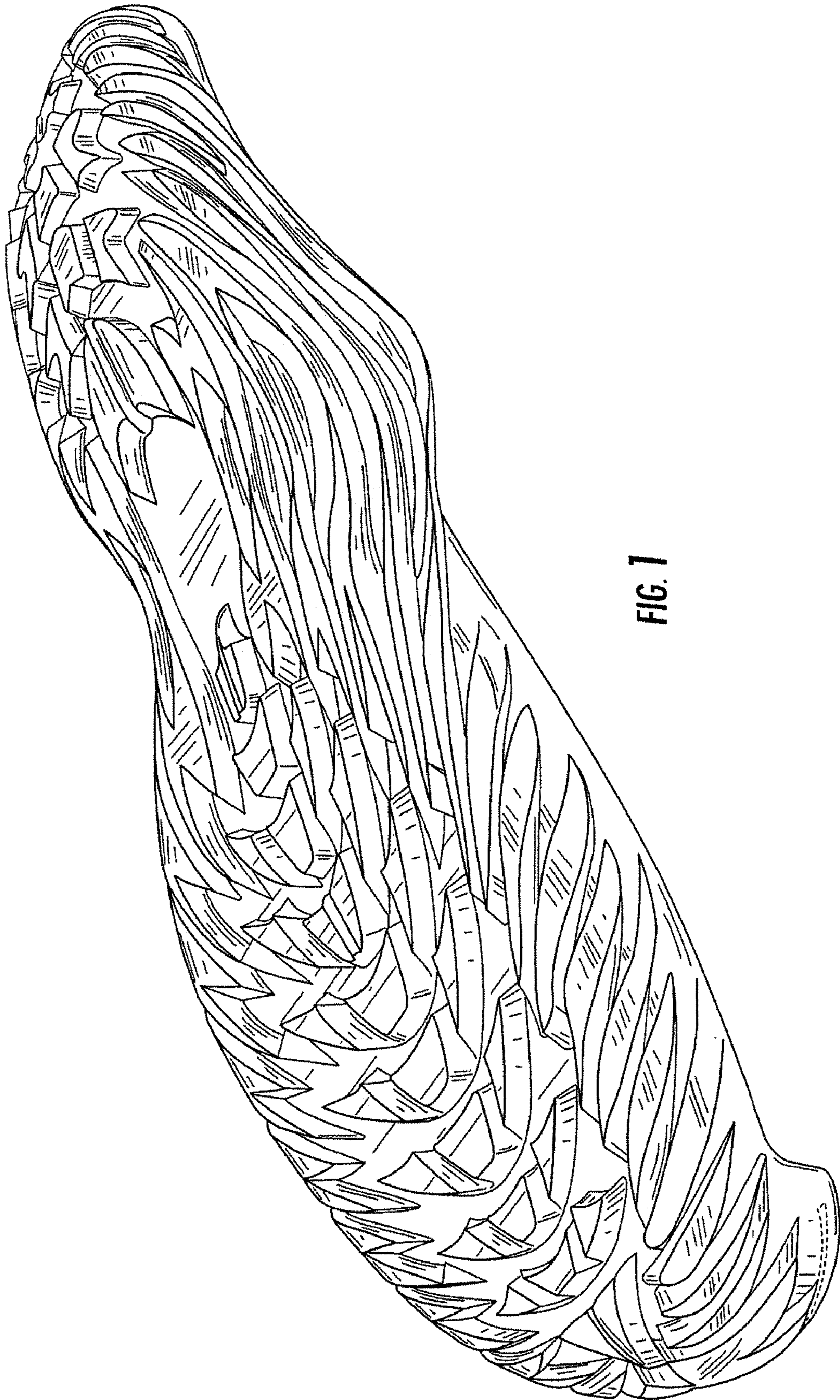

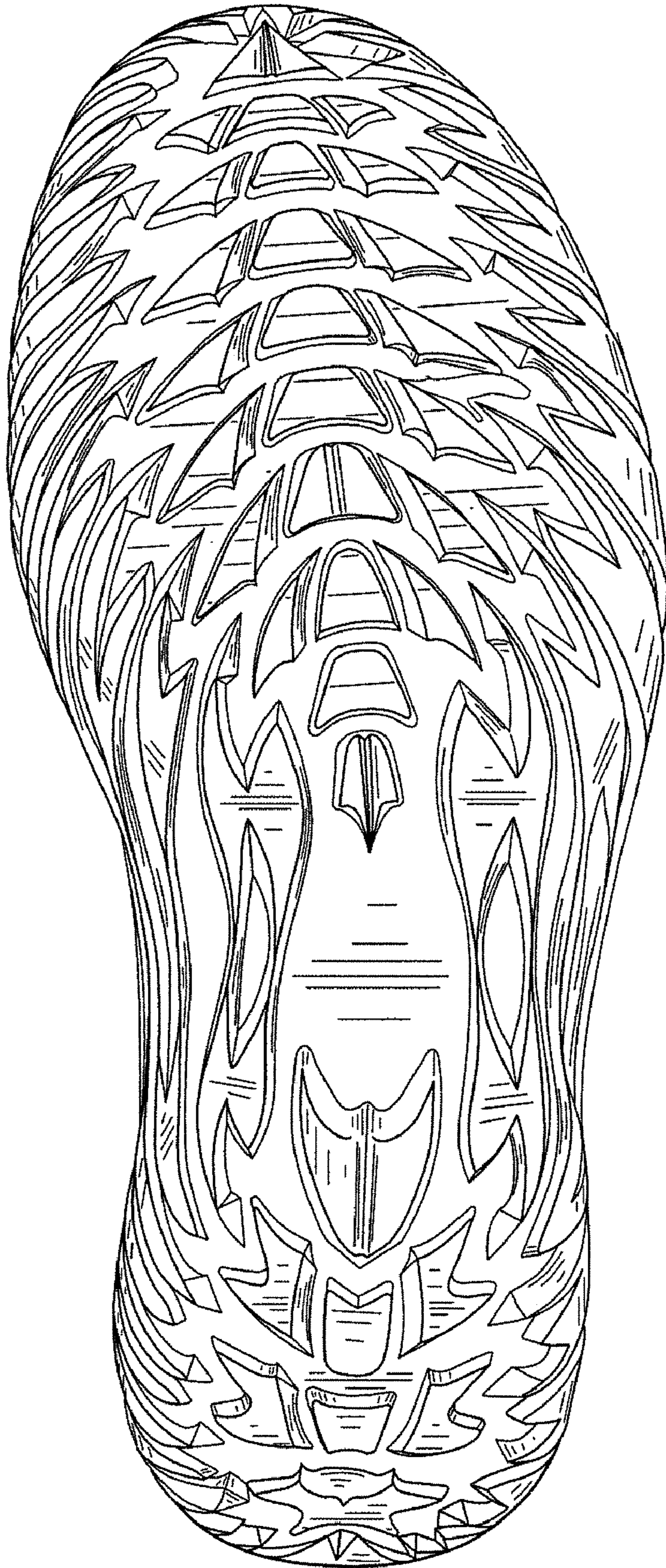

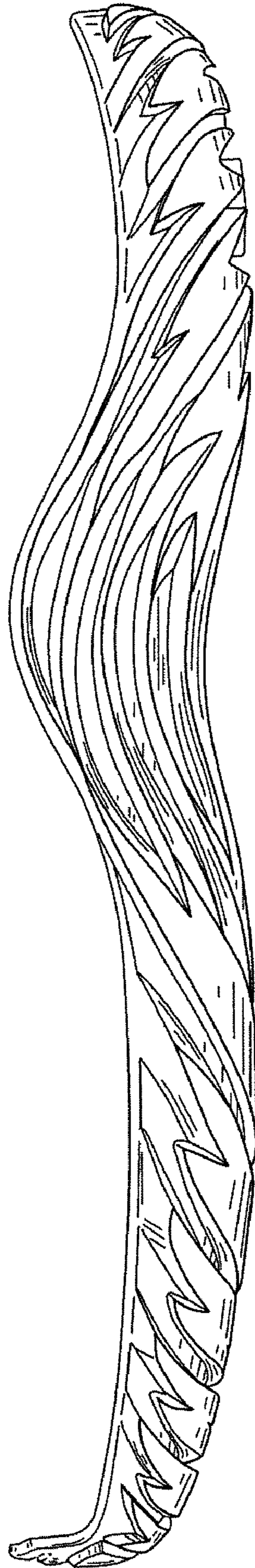

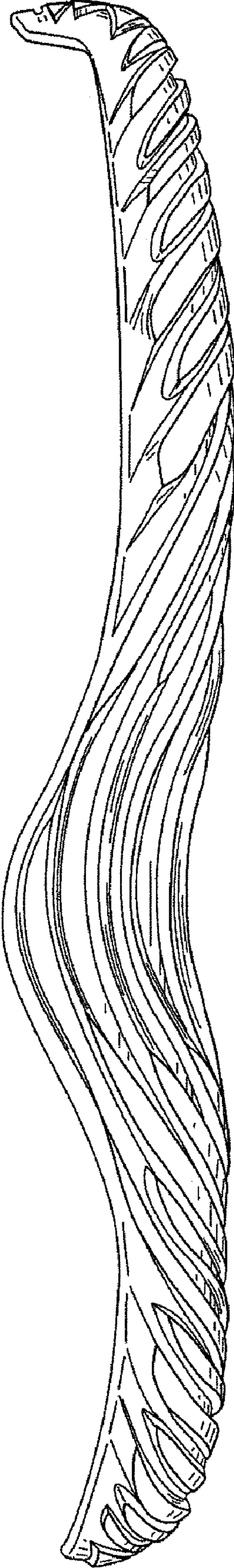
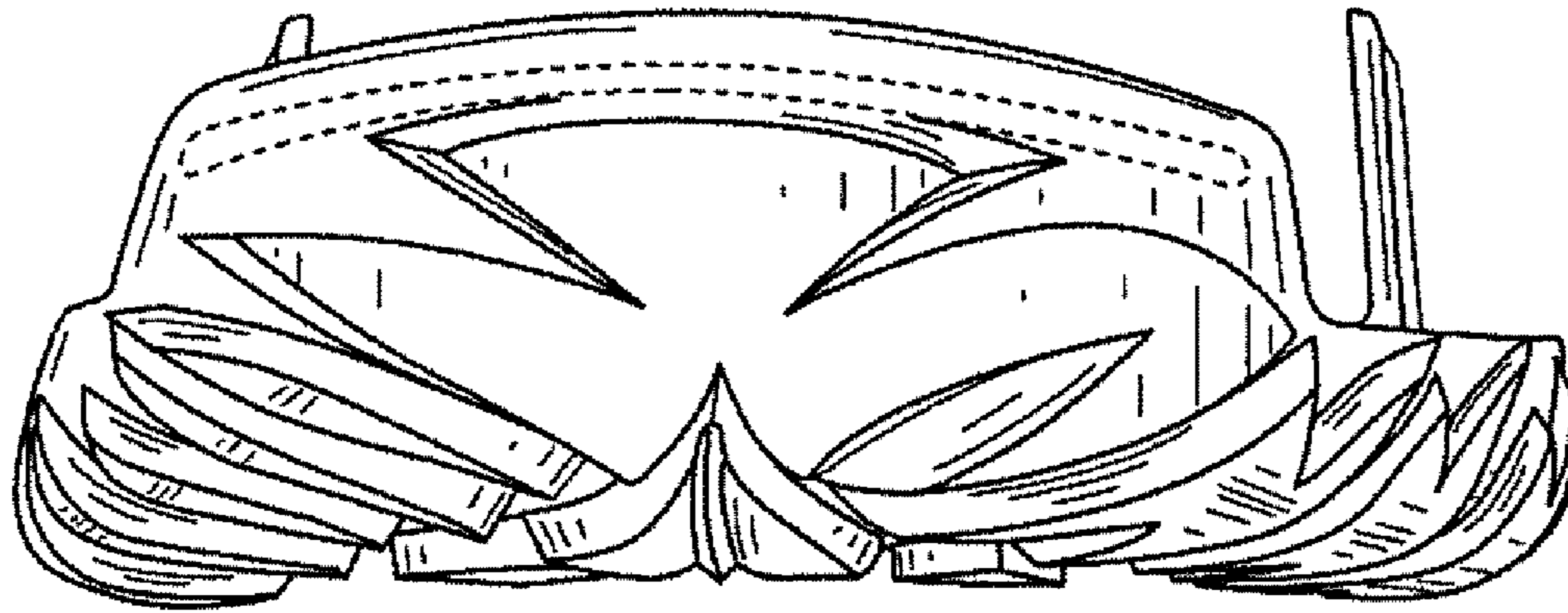
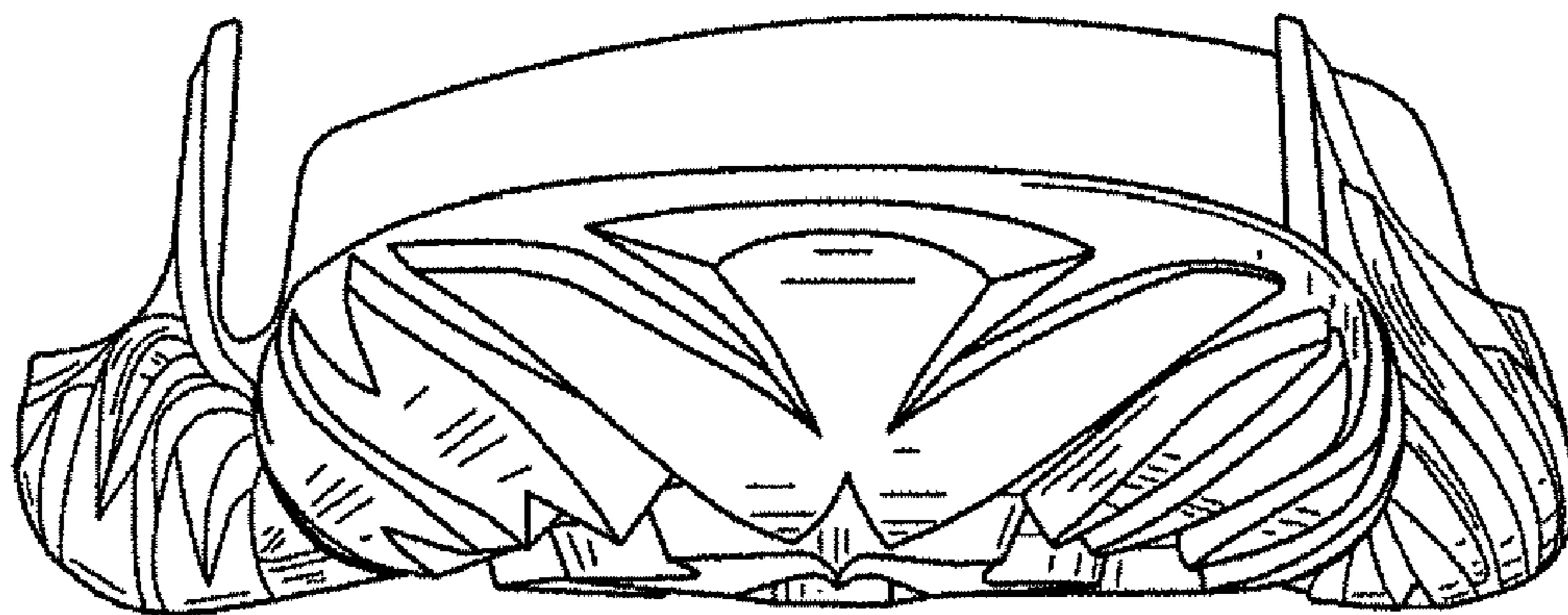
