cell phone or other personal electronic device.

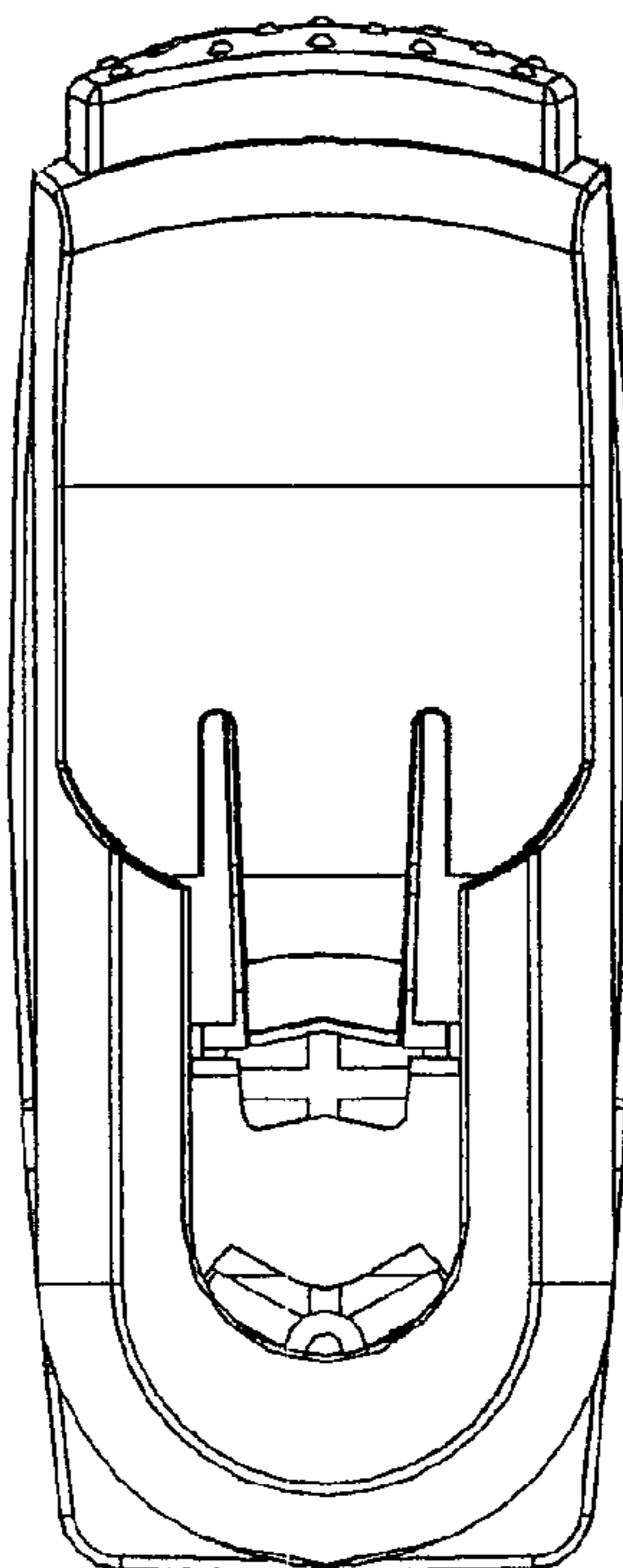
FIG. 2 is right side view of a belt or strap clip for cell phone

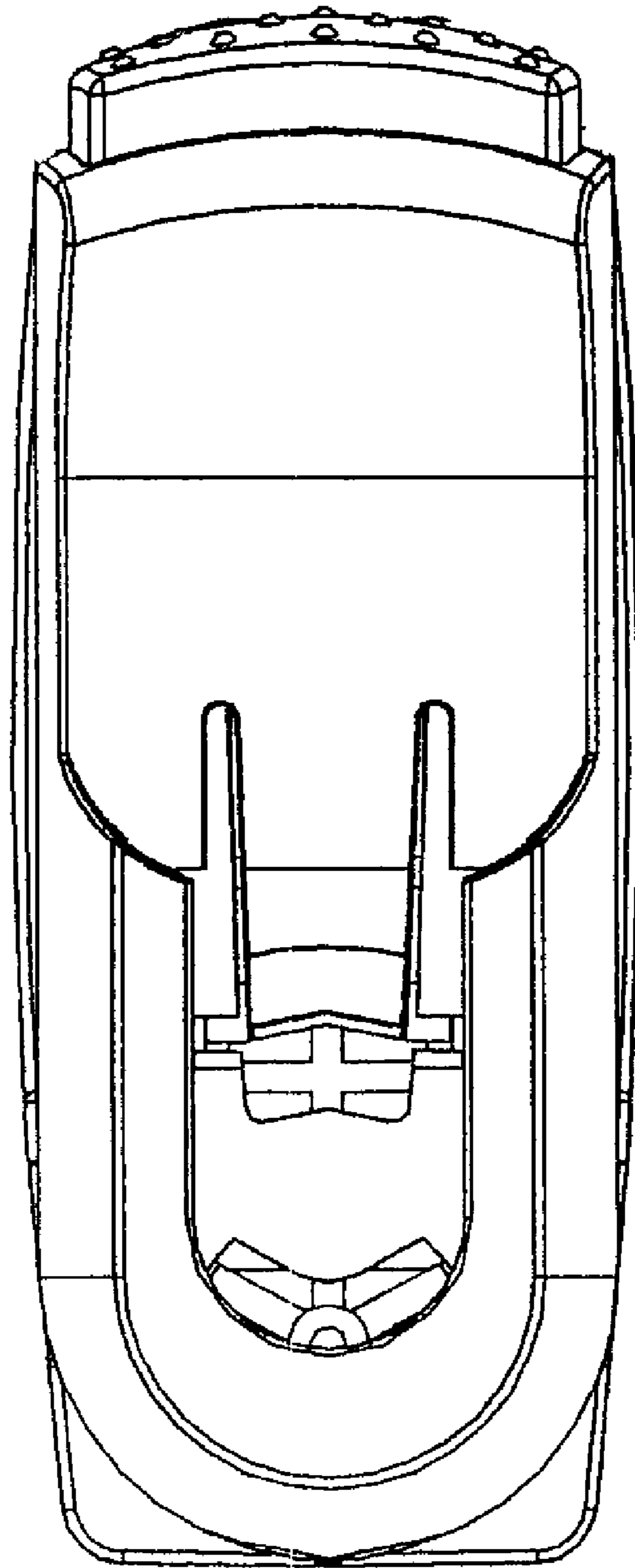

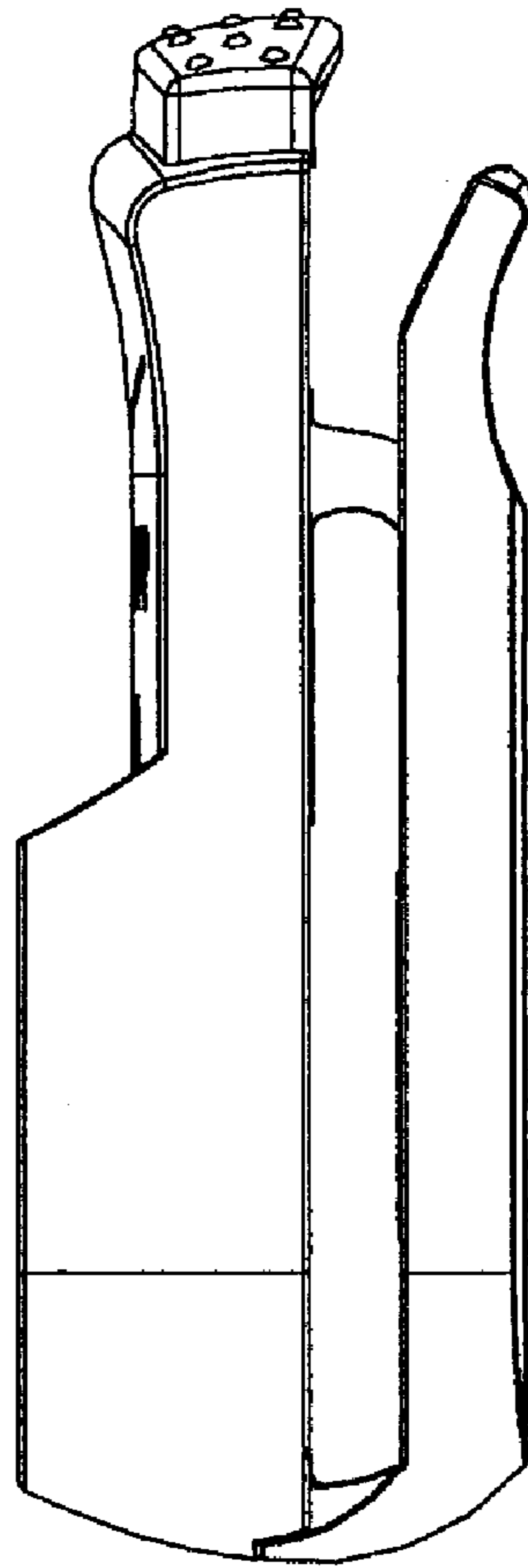

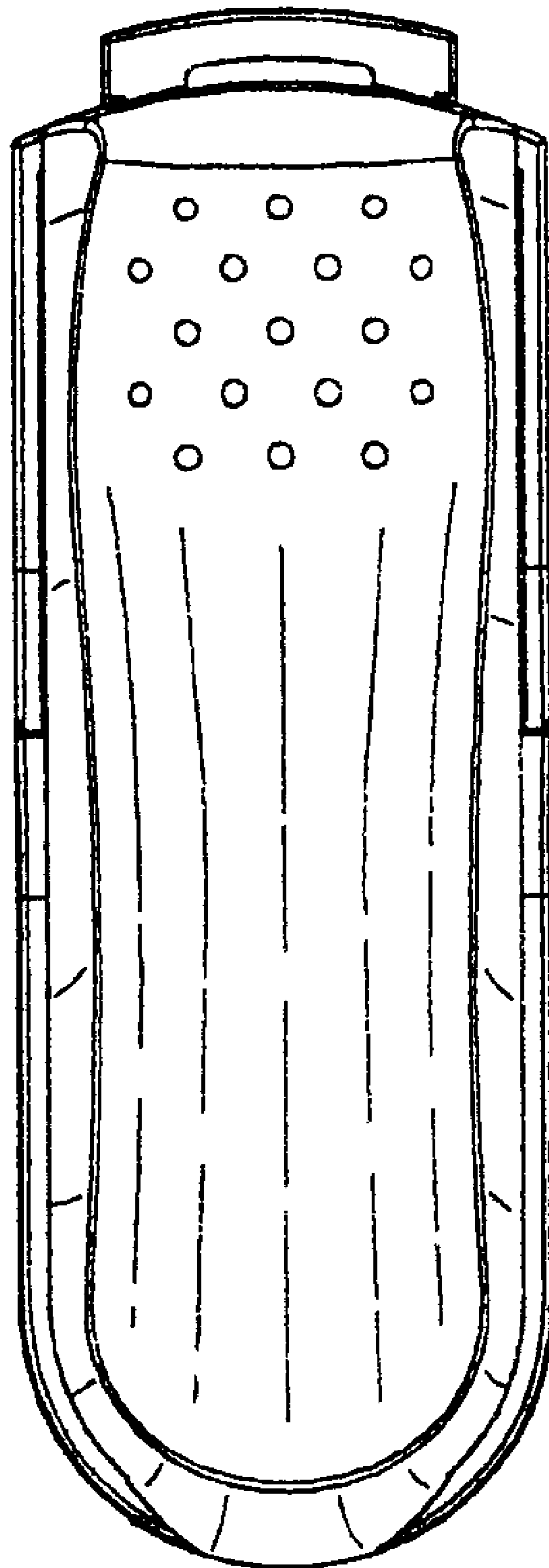

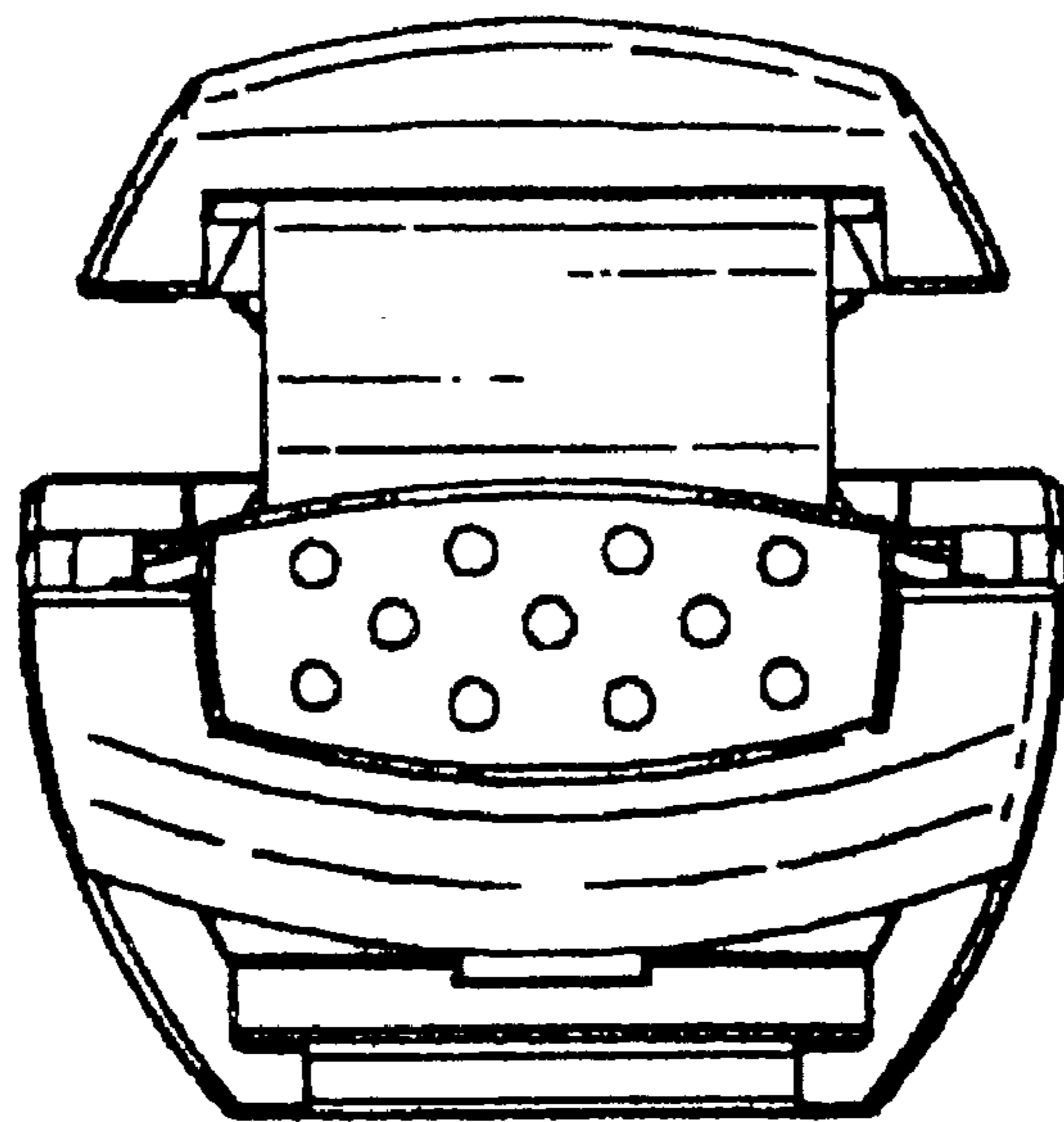

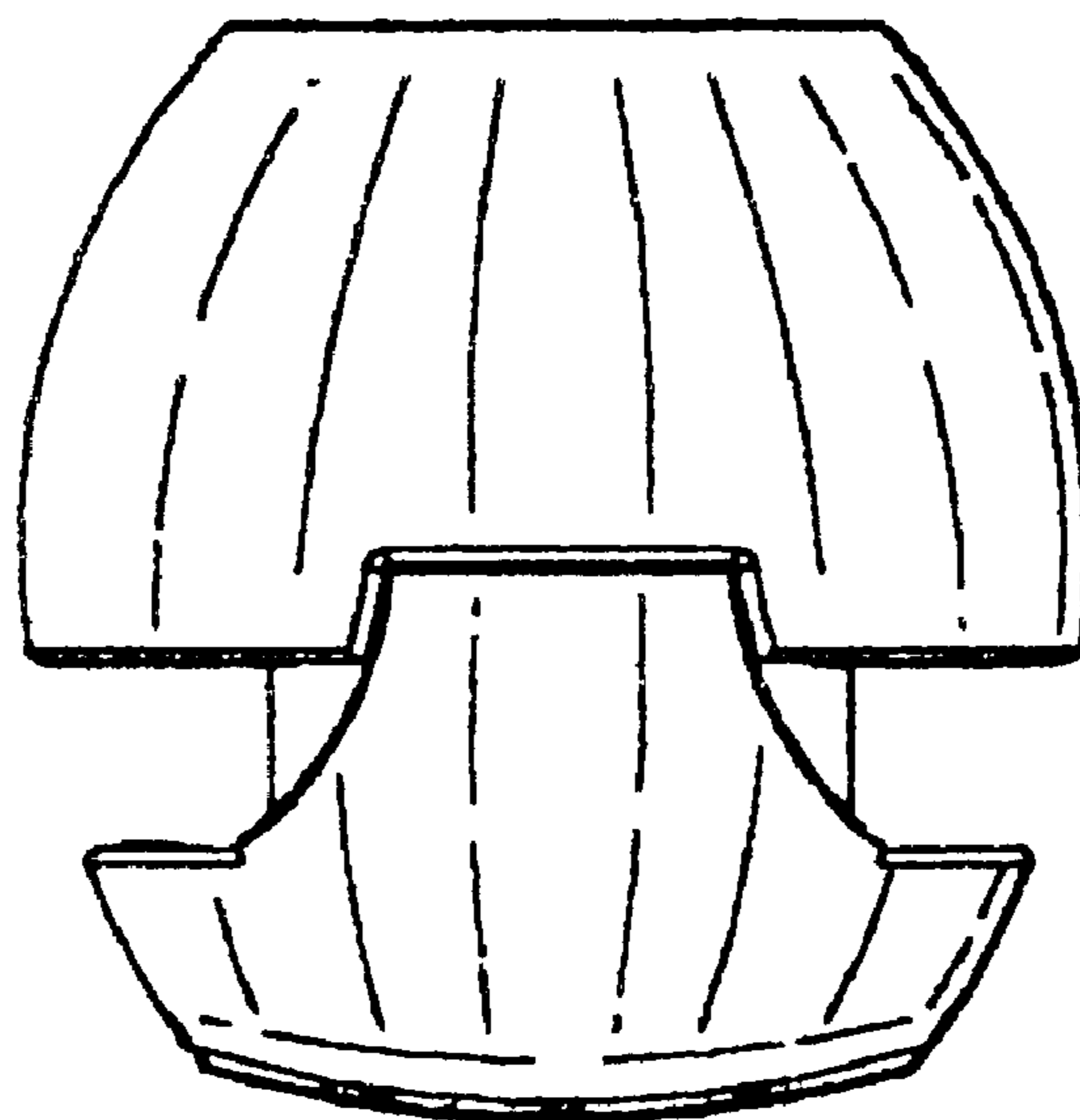
