illustration.

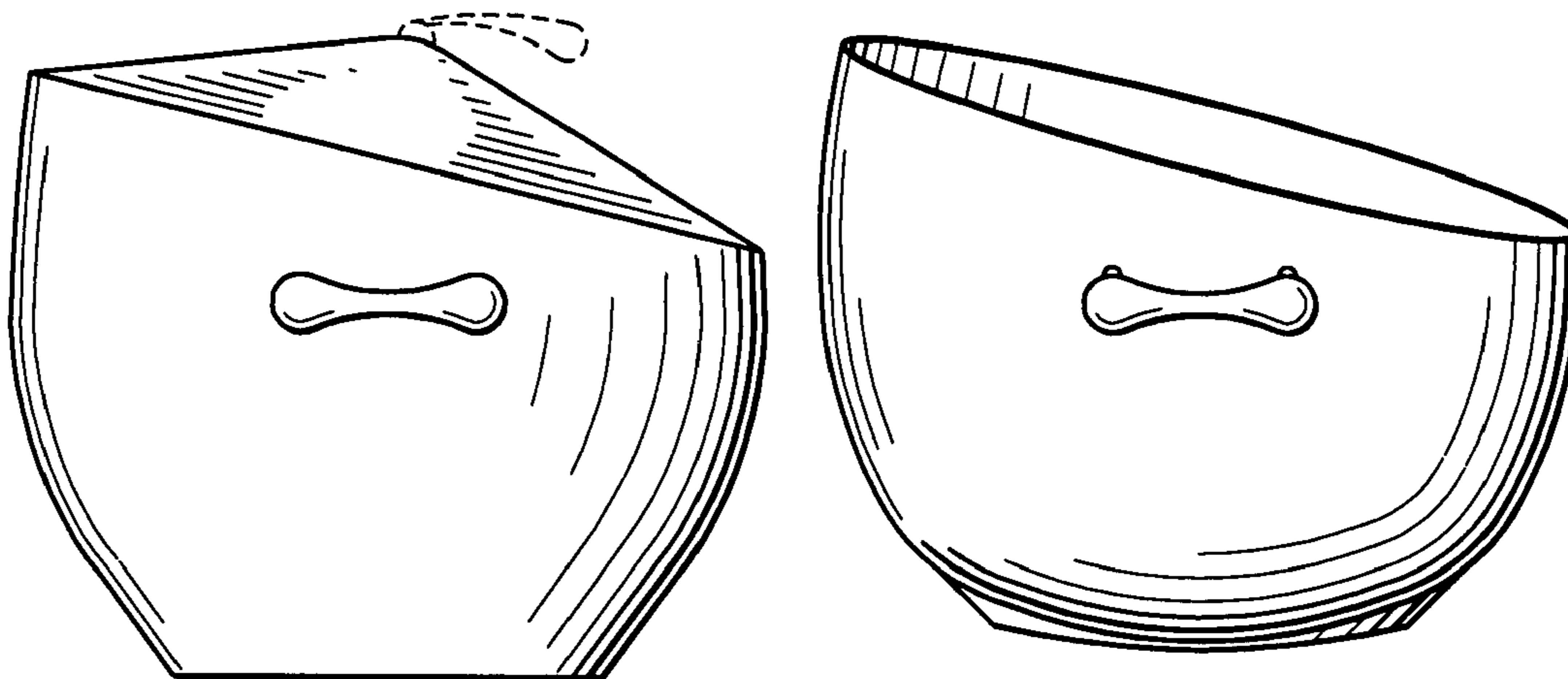

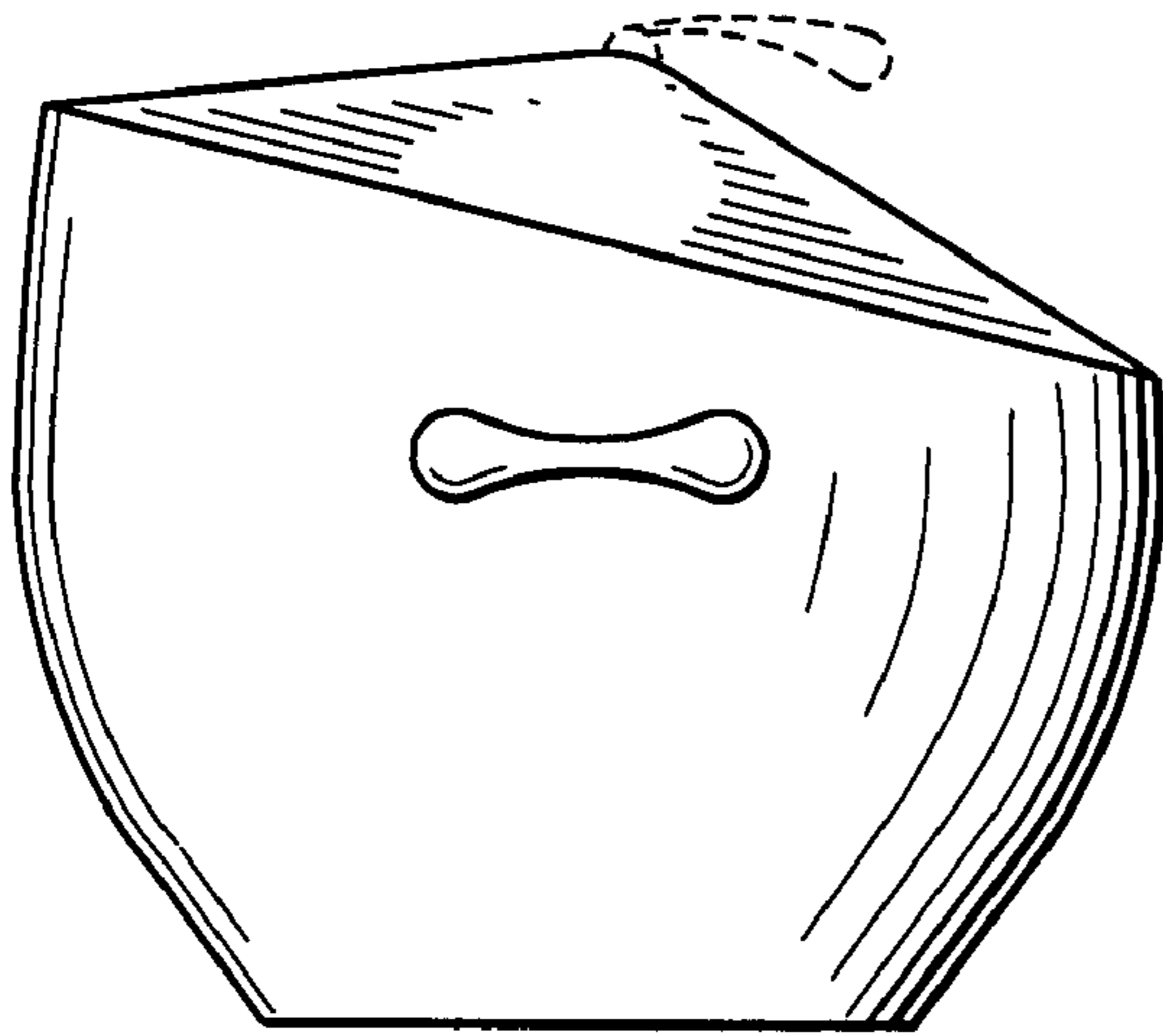

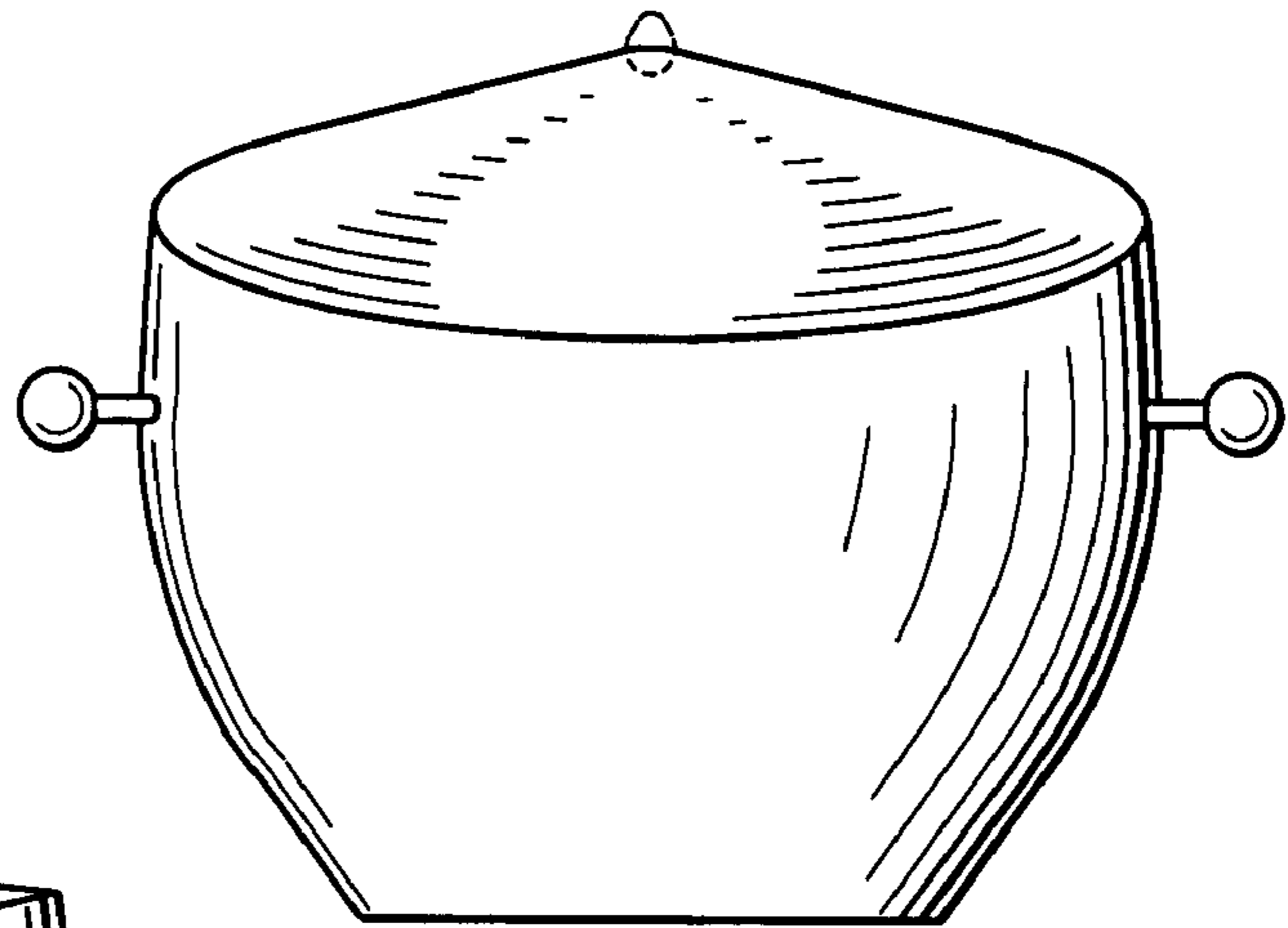

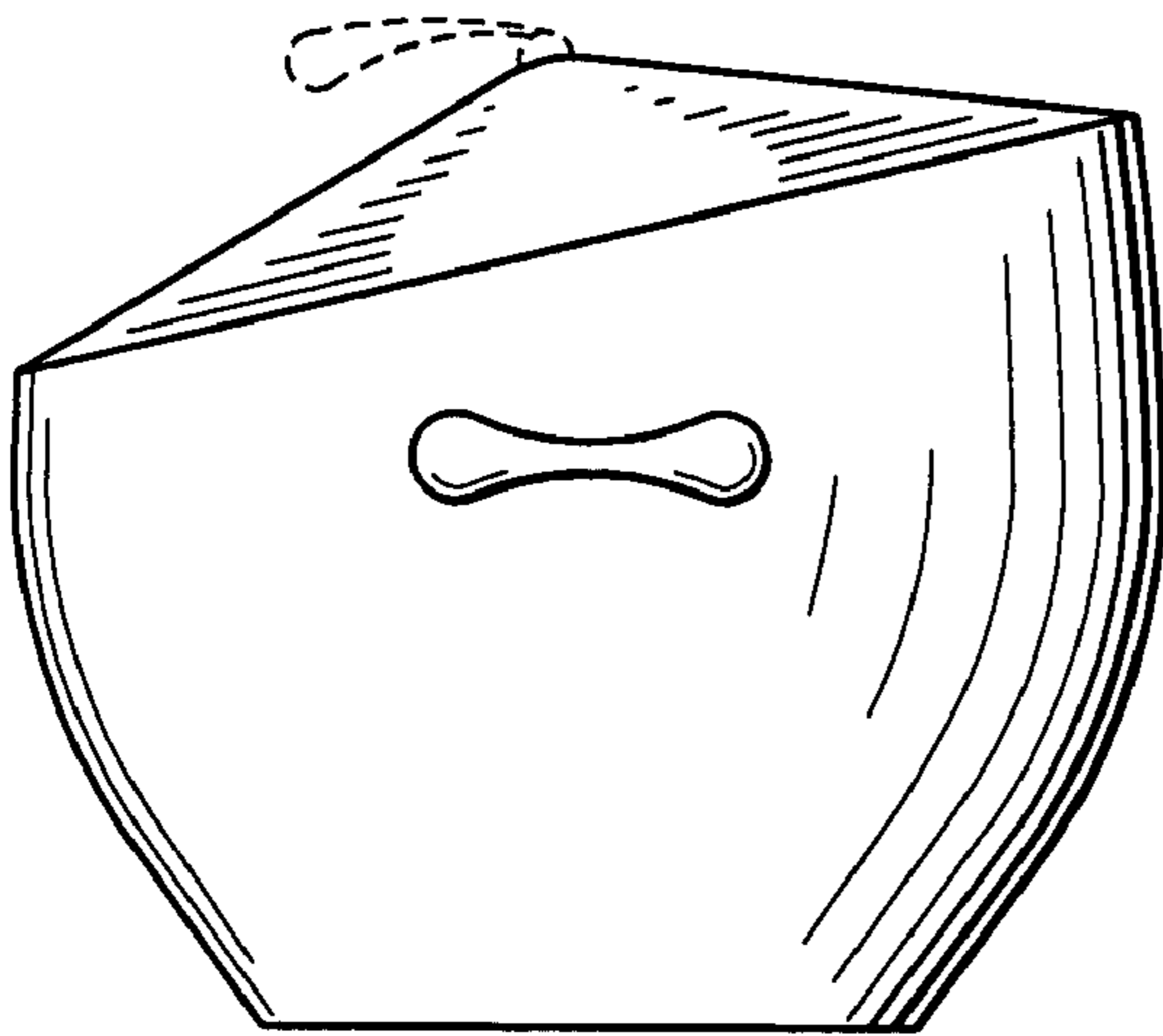

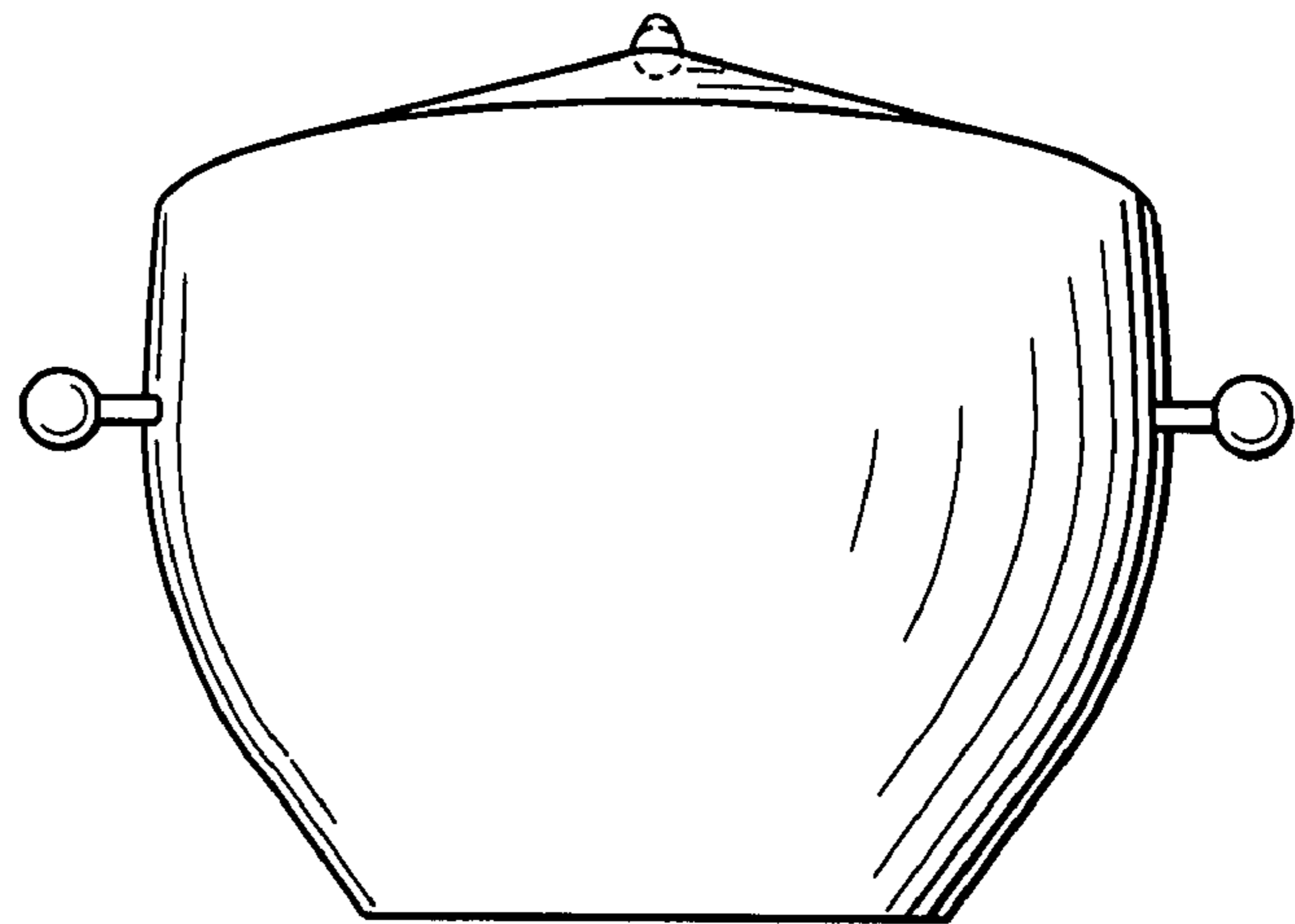

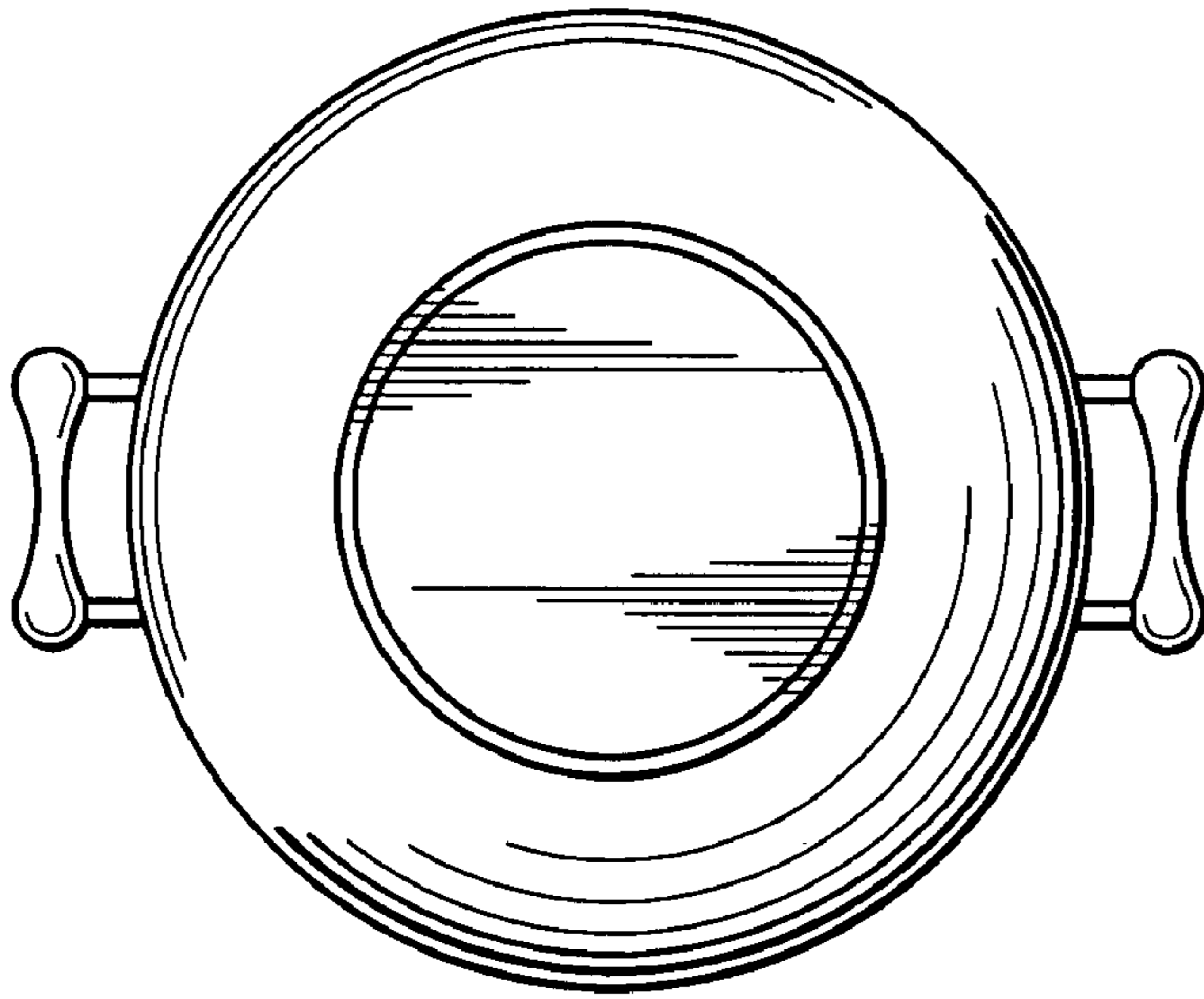

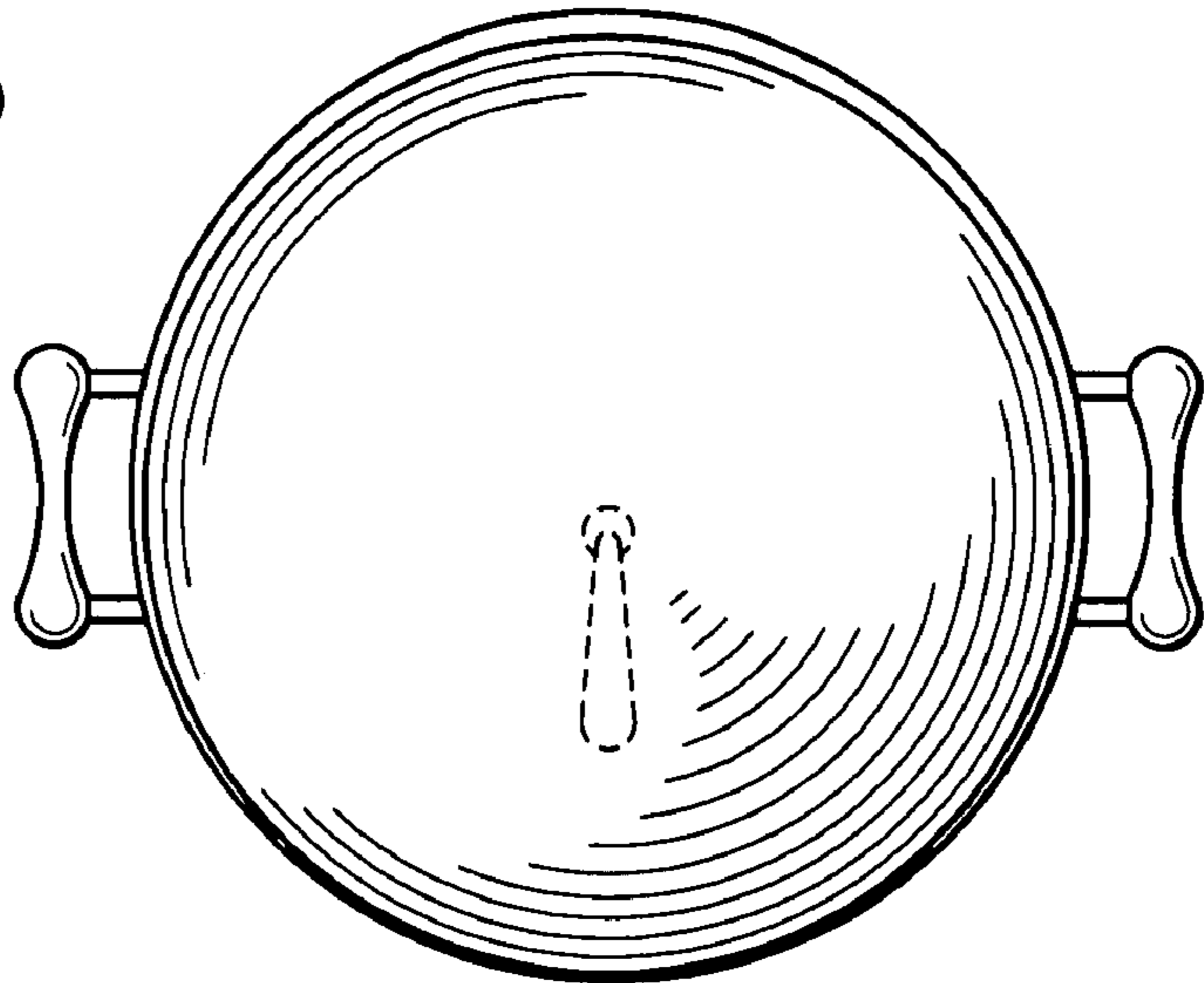

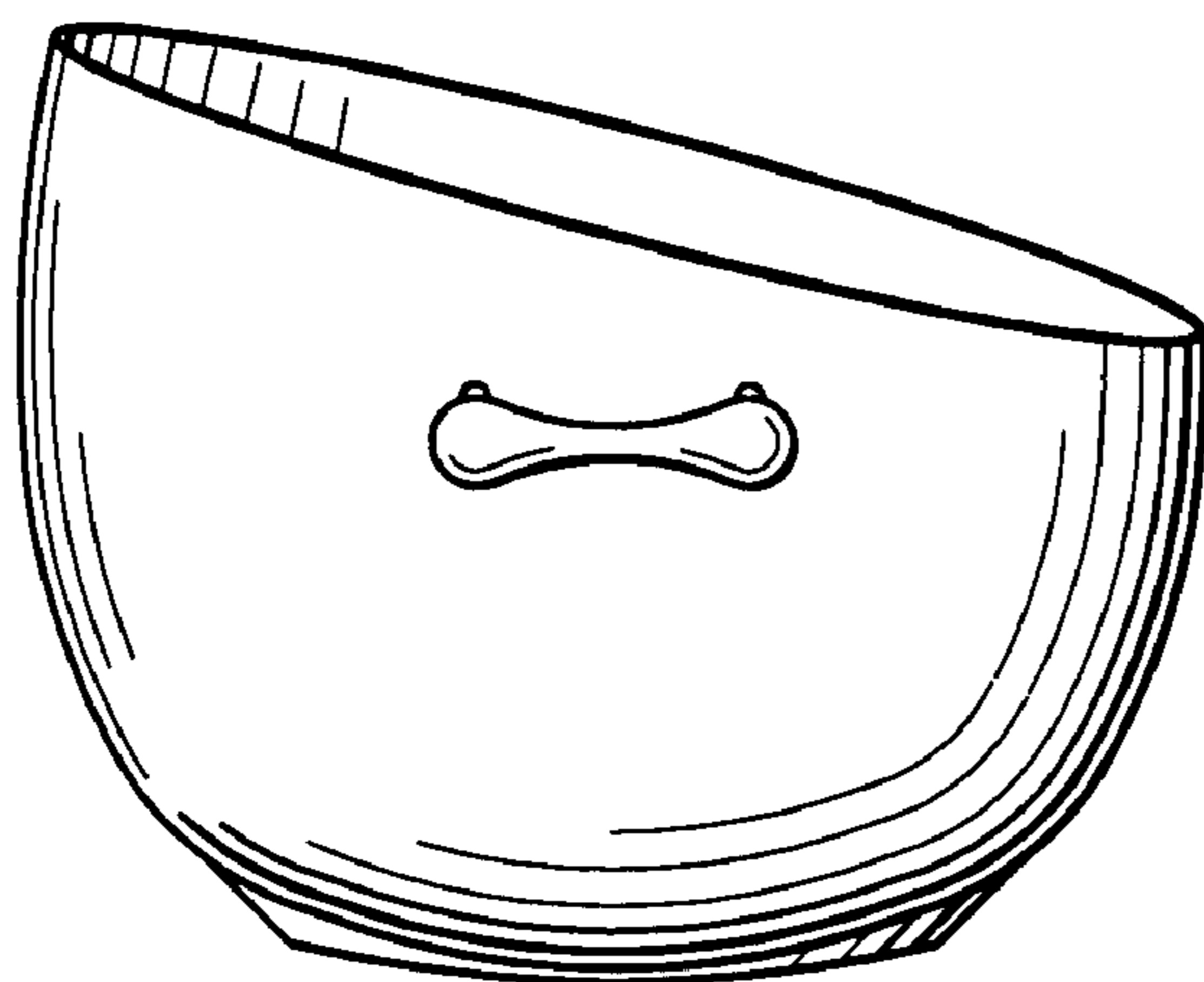
