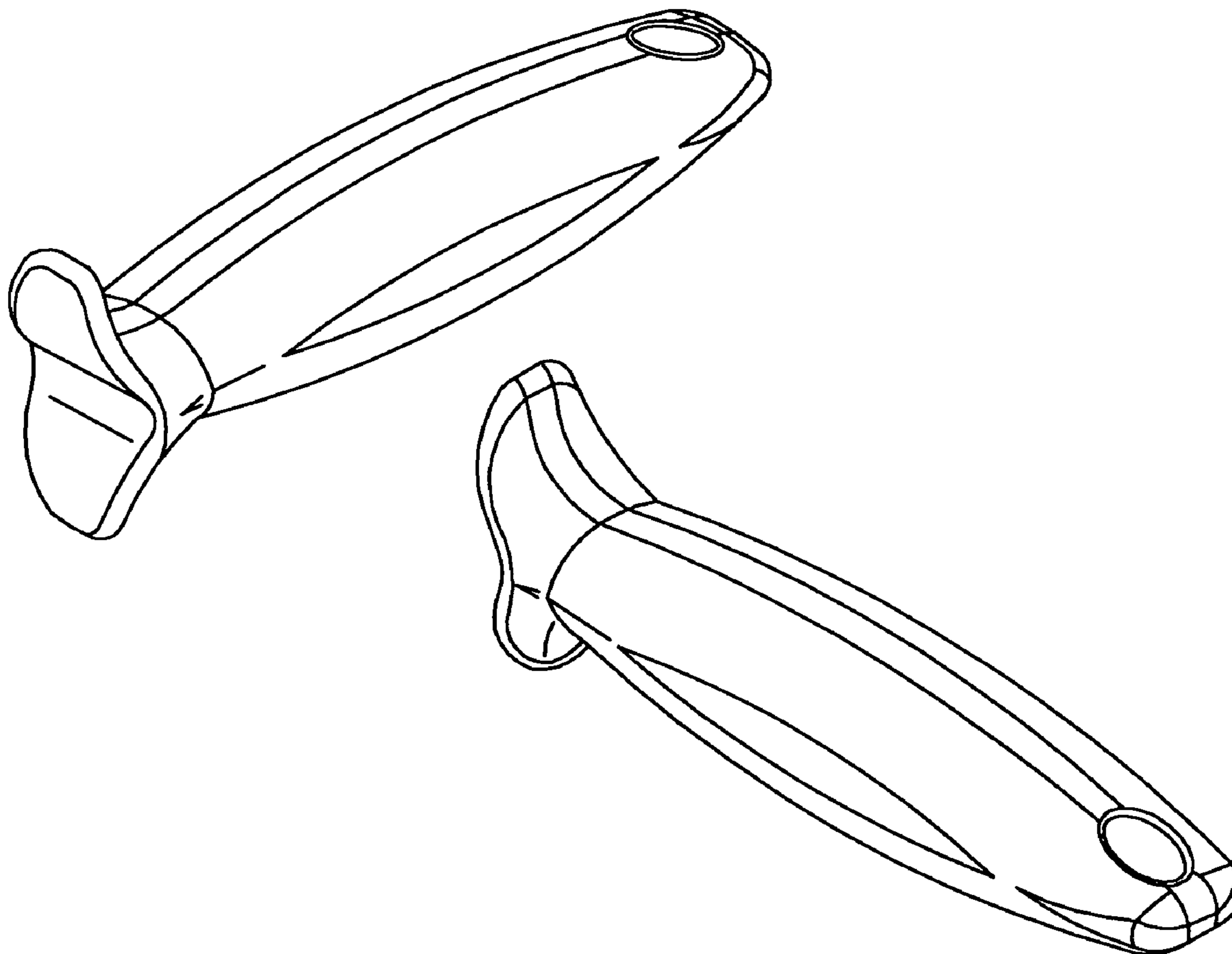
FIG. 1 is a side view of the handle showing our new design,

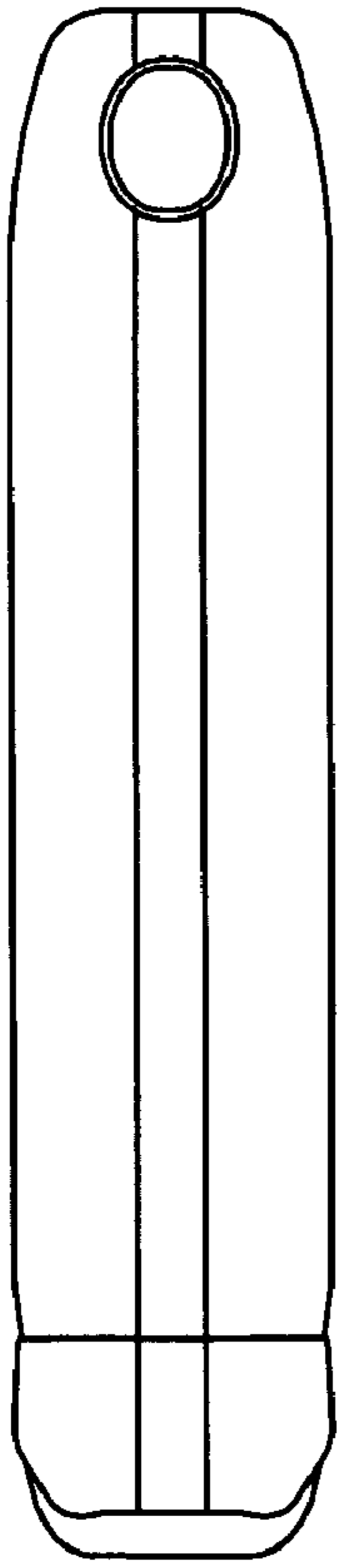

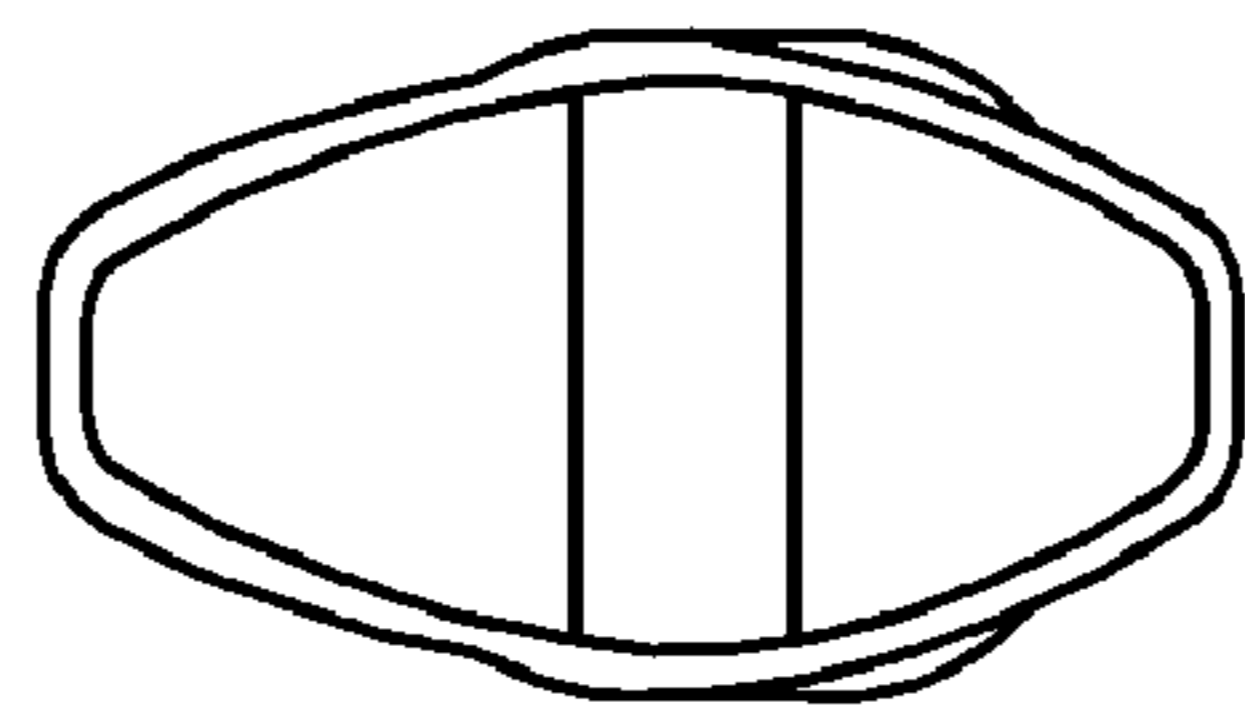

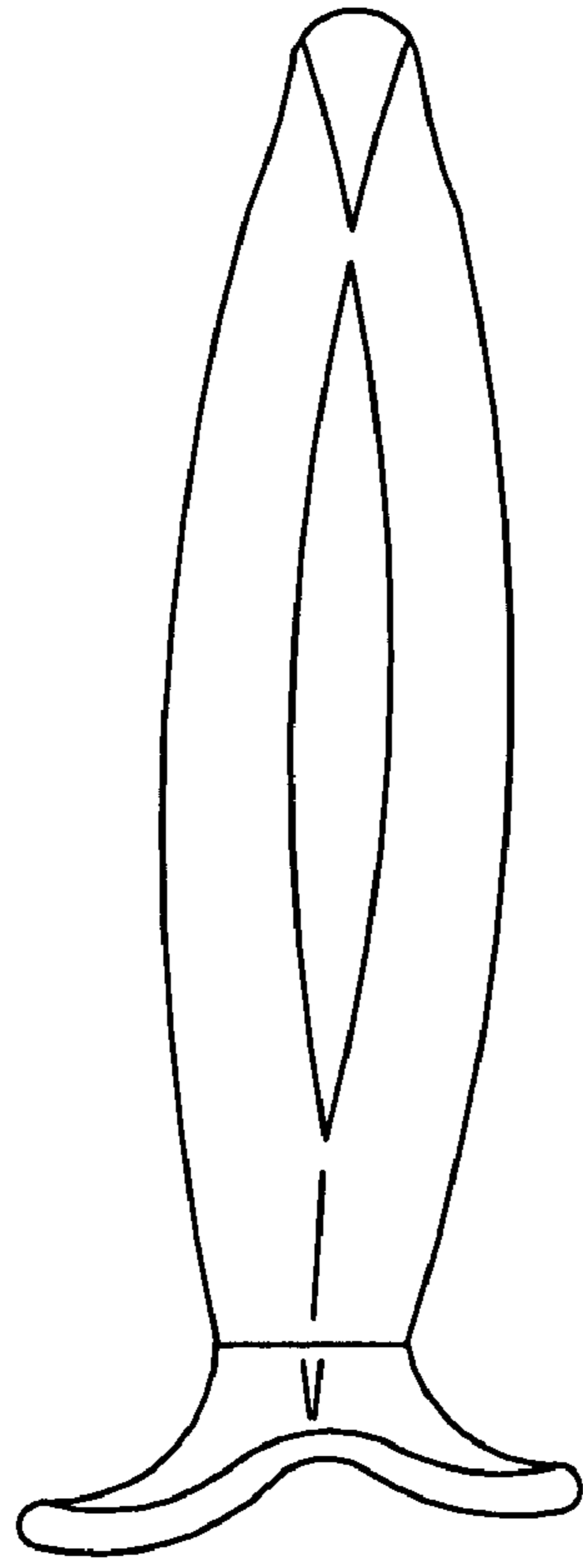

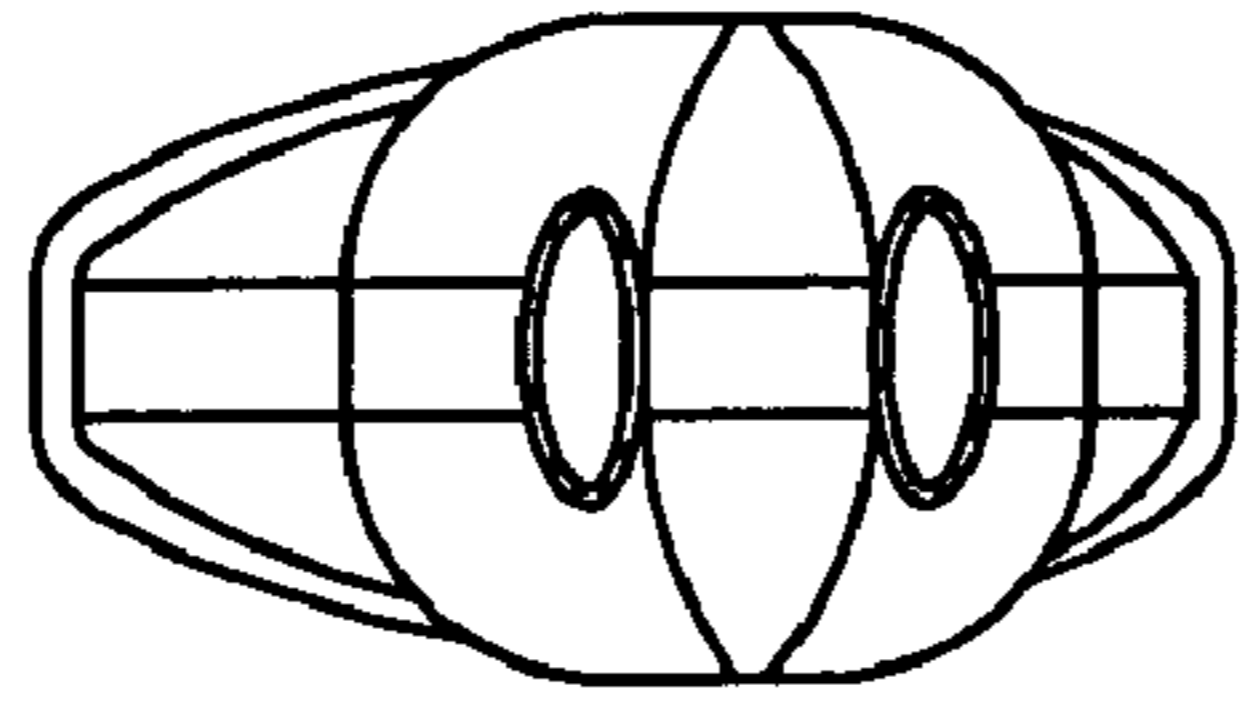

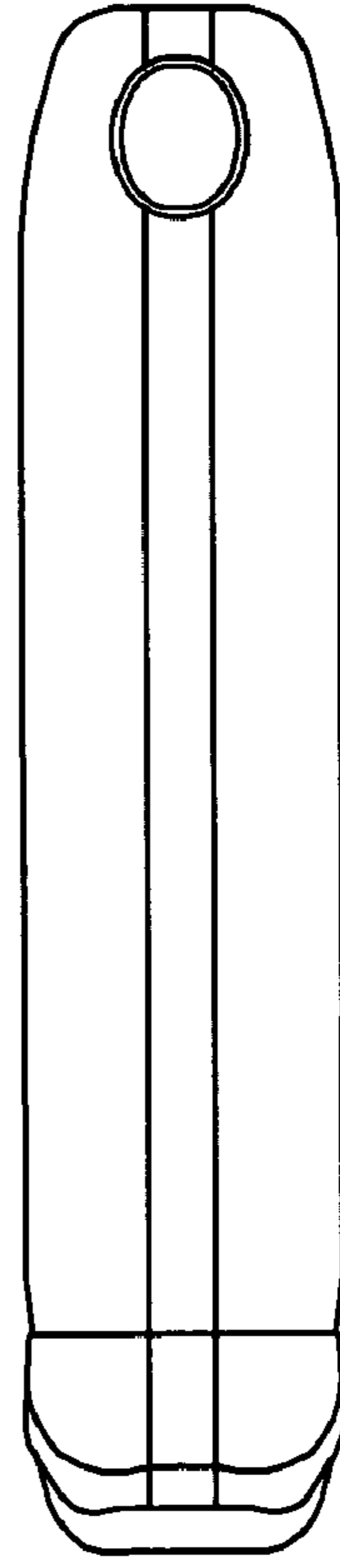

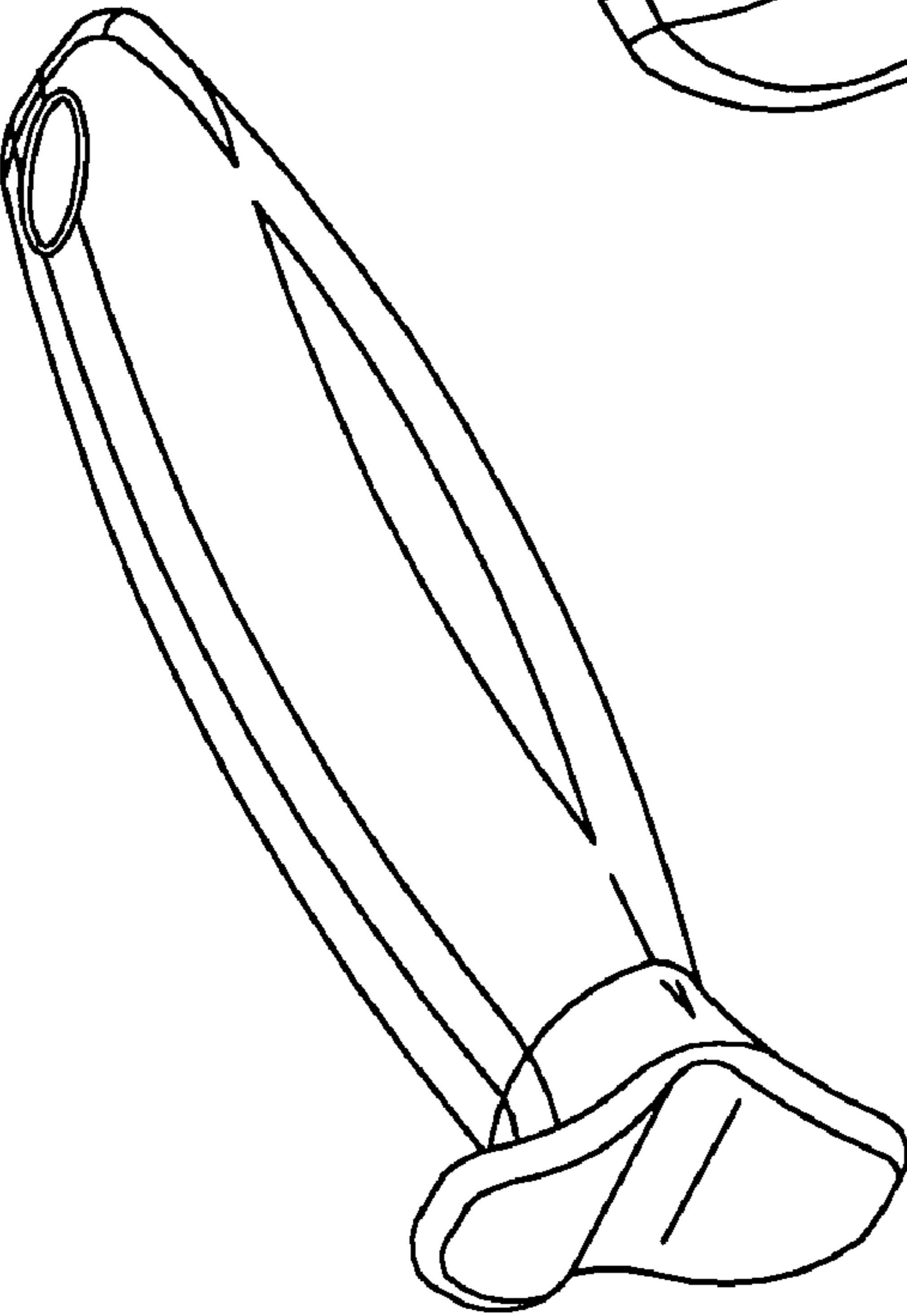

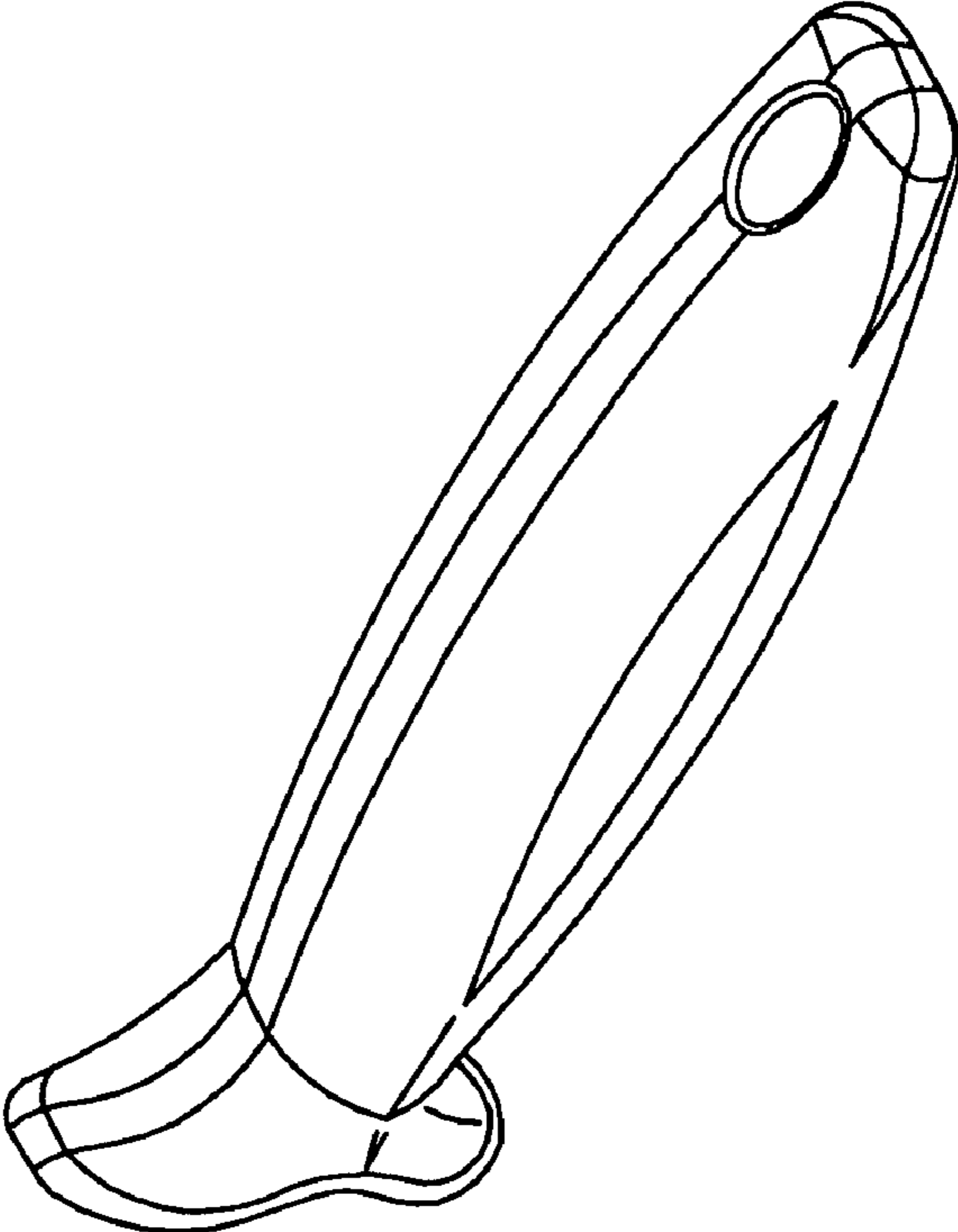
