(57) **CLAIM**

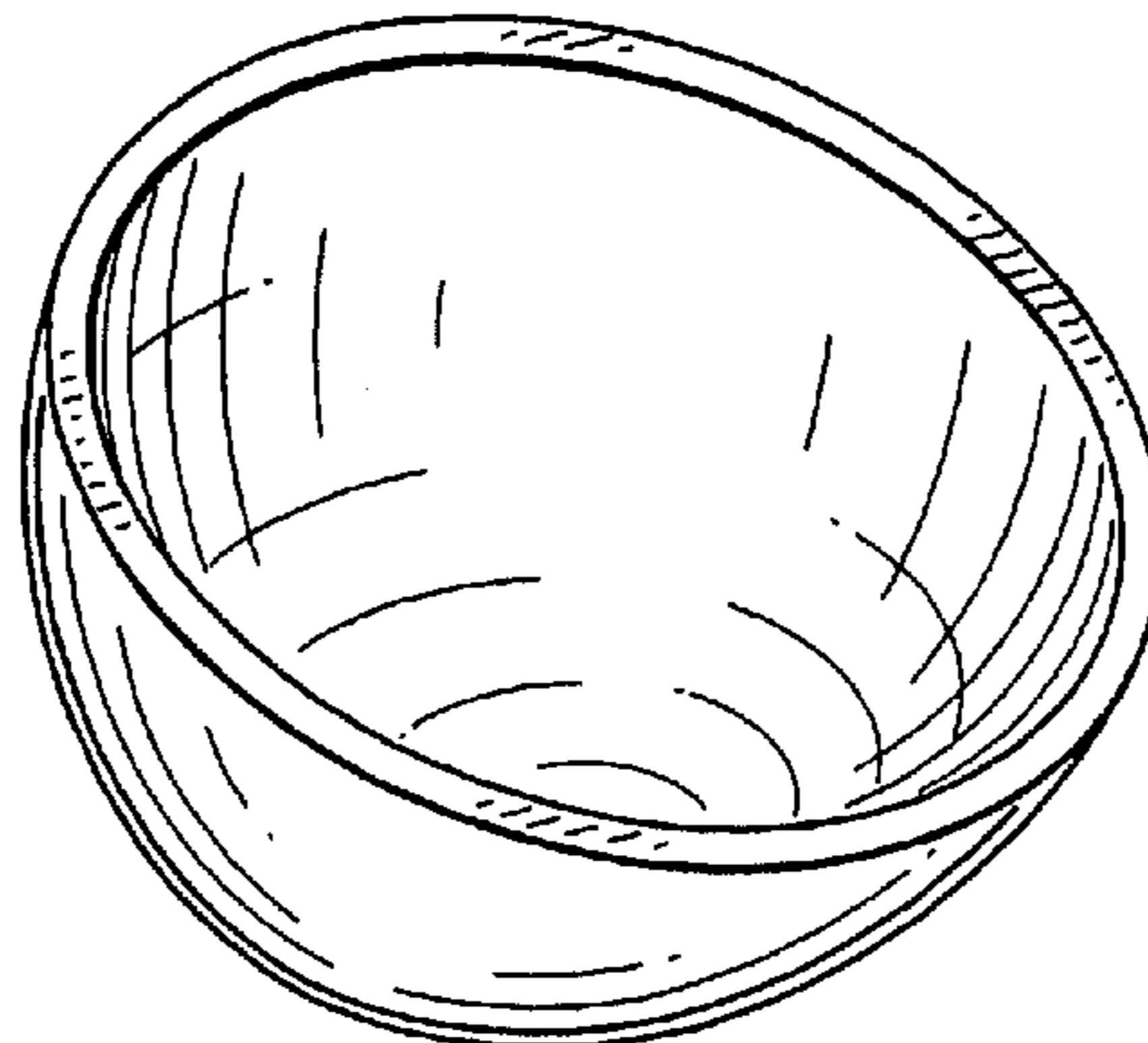
We claim the ornamental design for a bowl, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a bowl showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a left elevational view, the right side being a mirror image;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a sectional view thereof.

The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

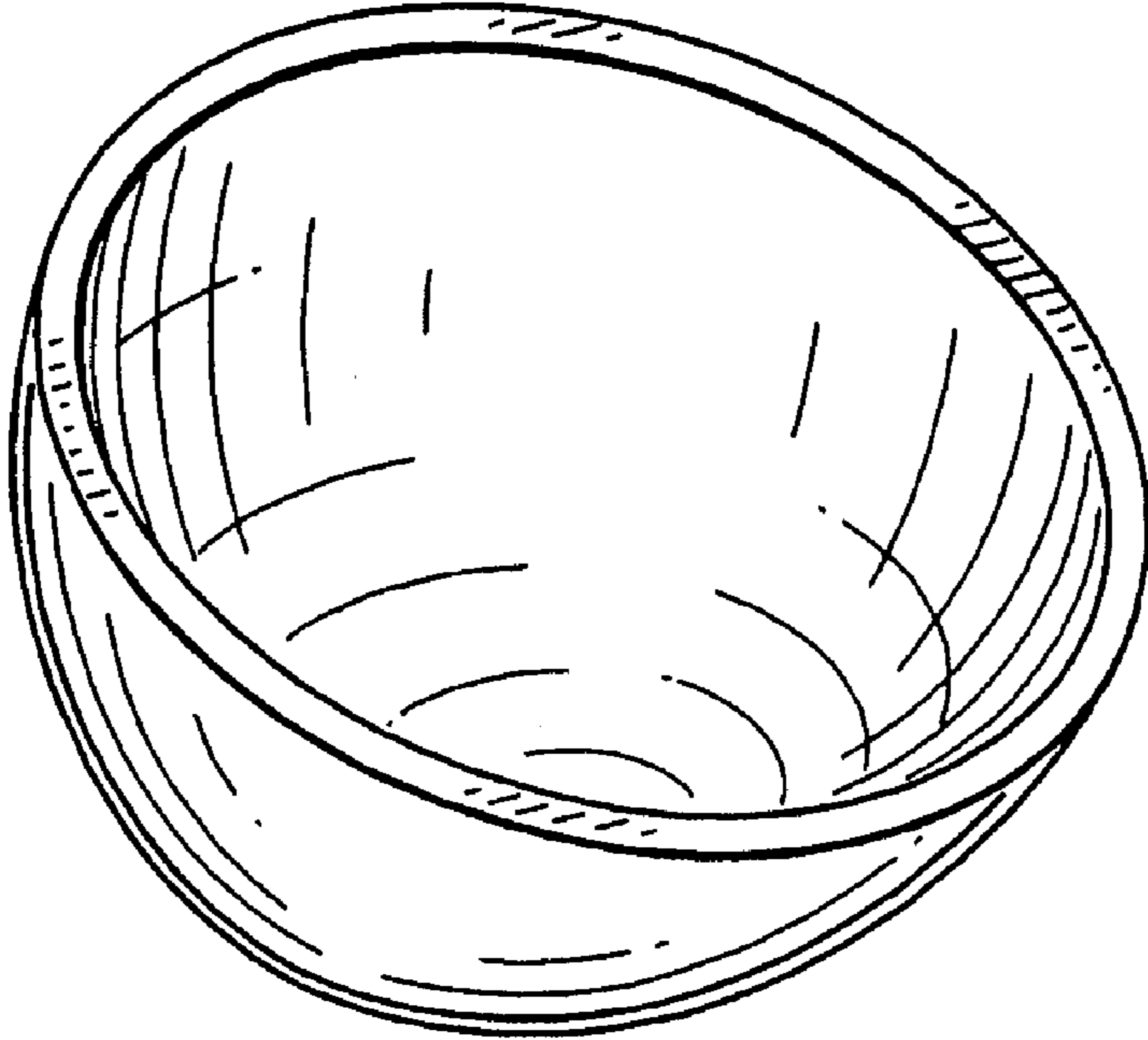

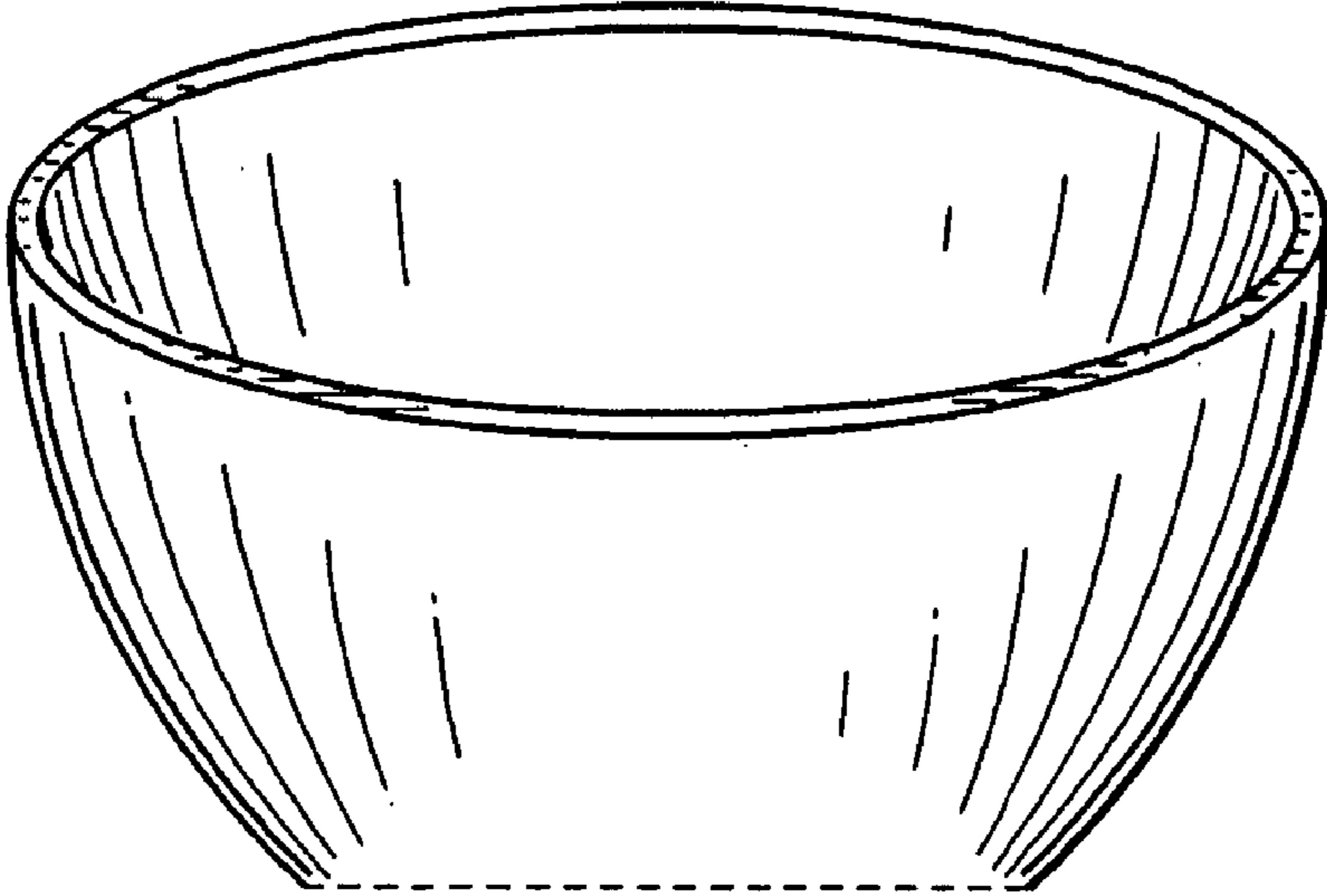

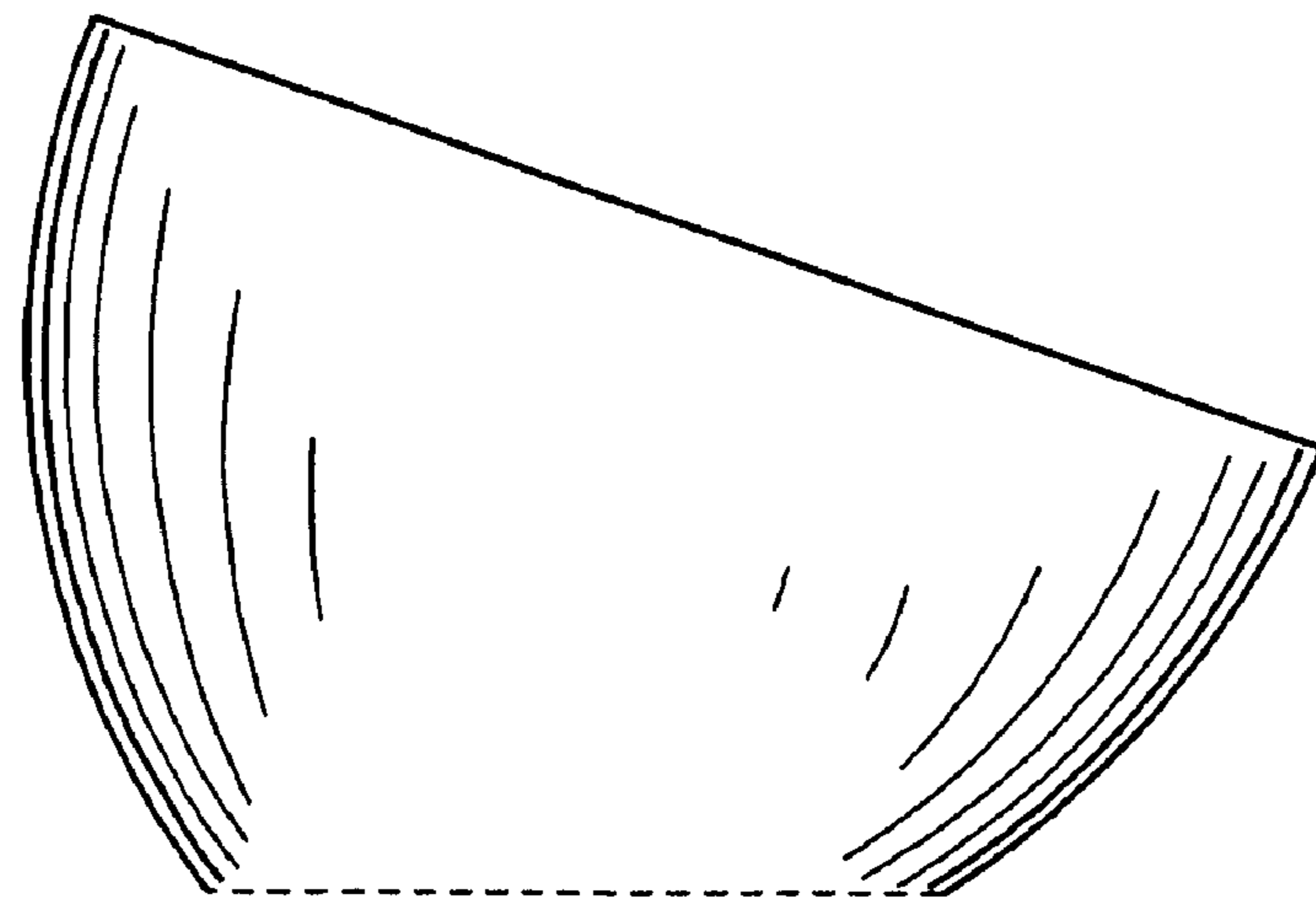
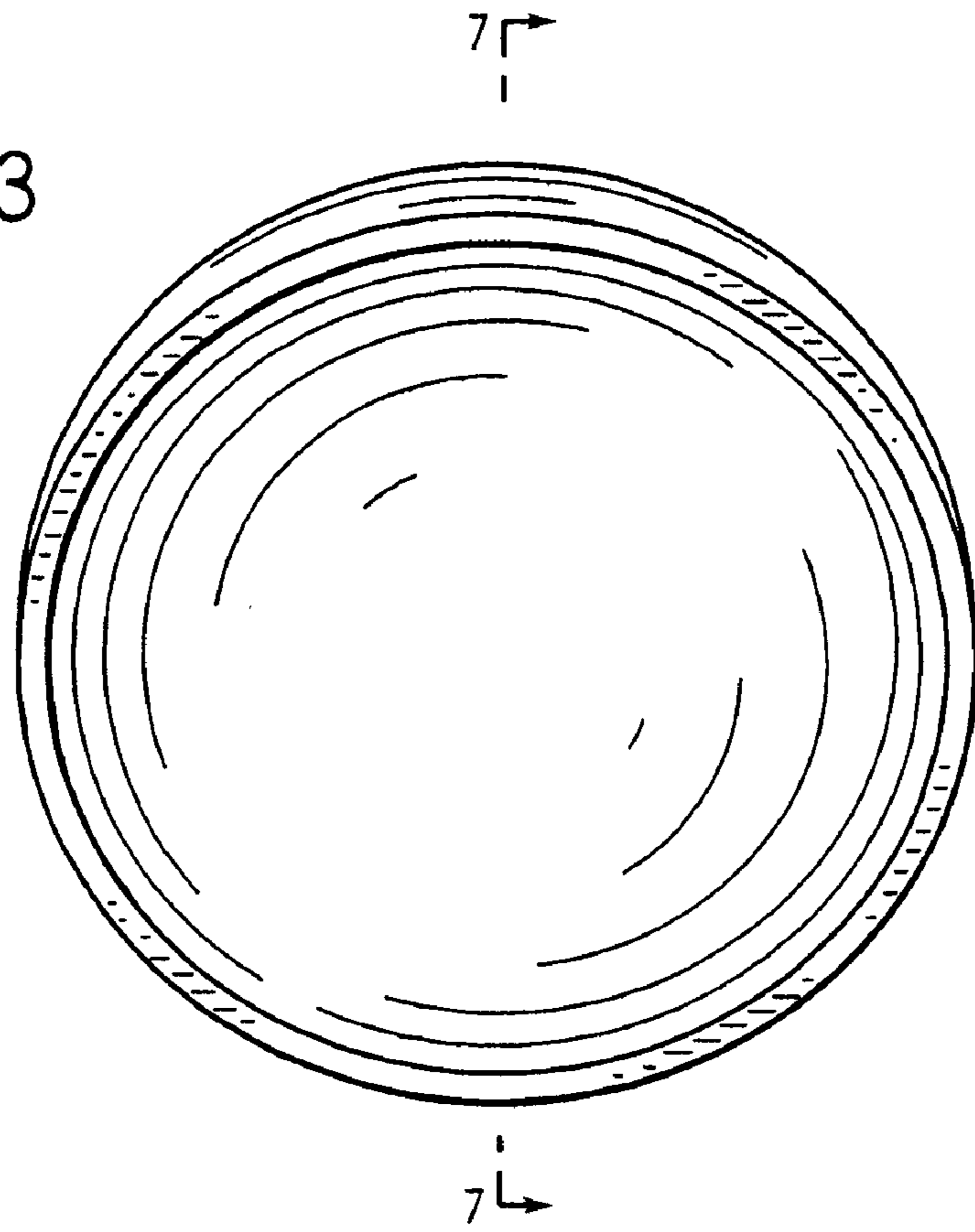

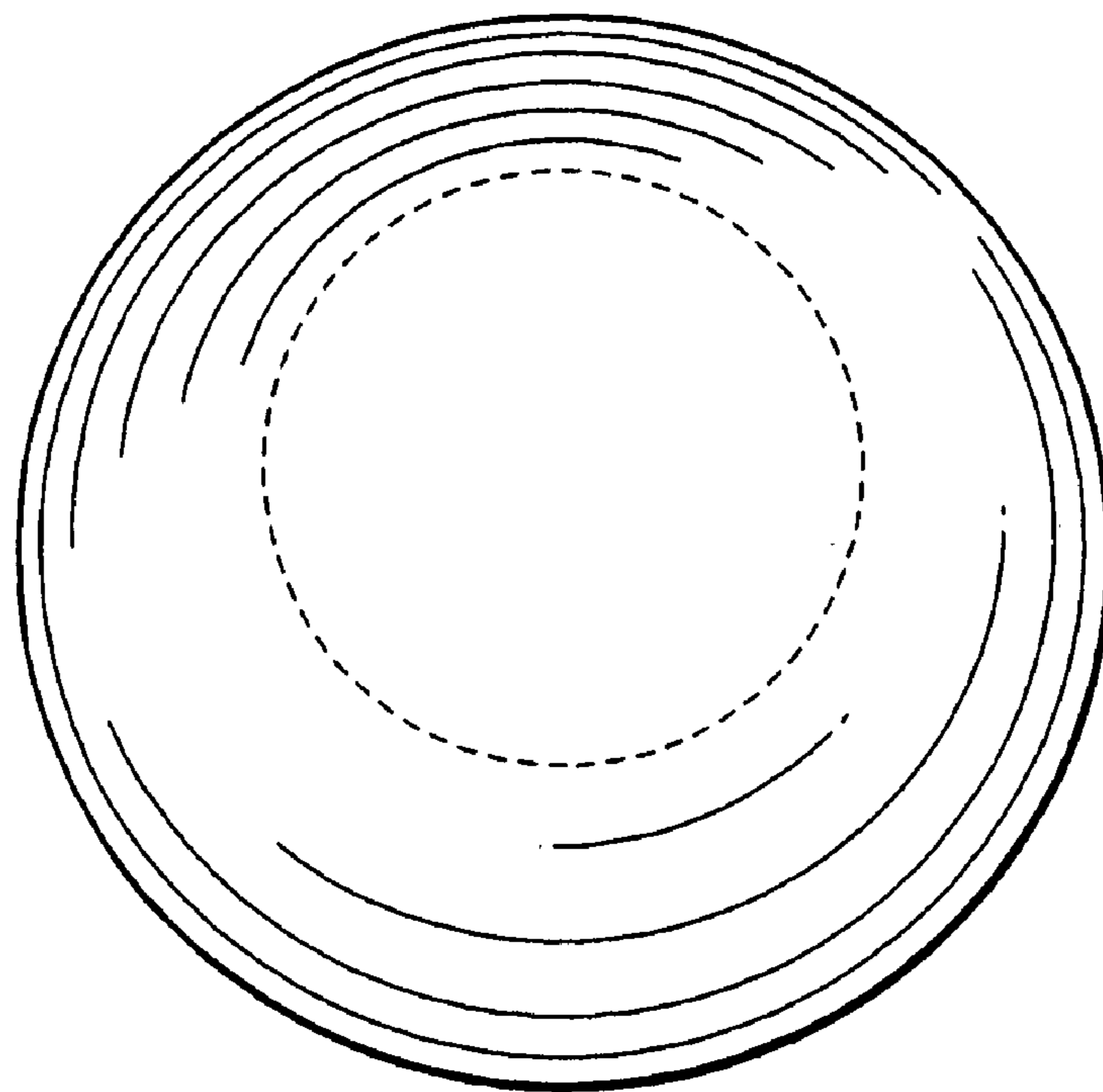
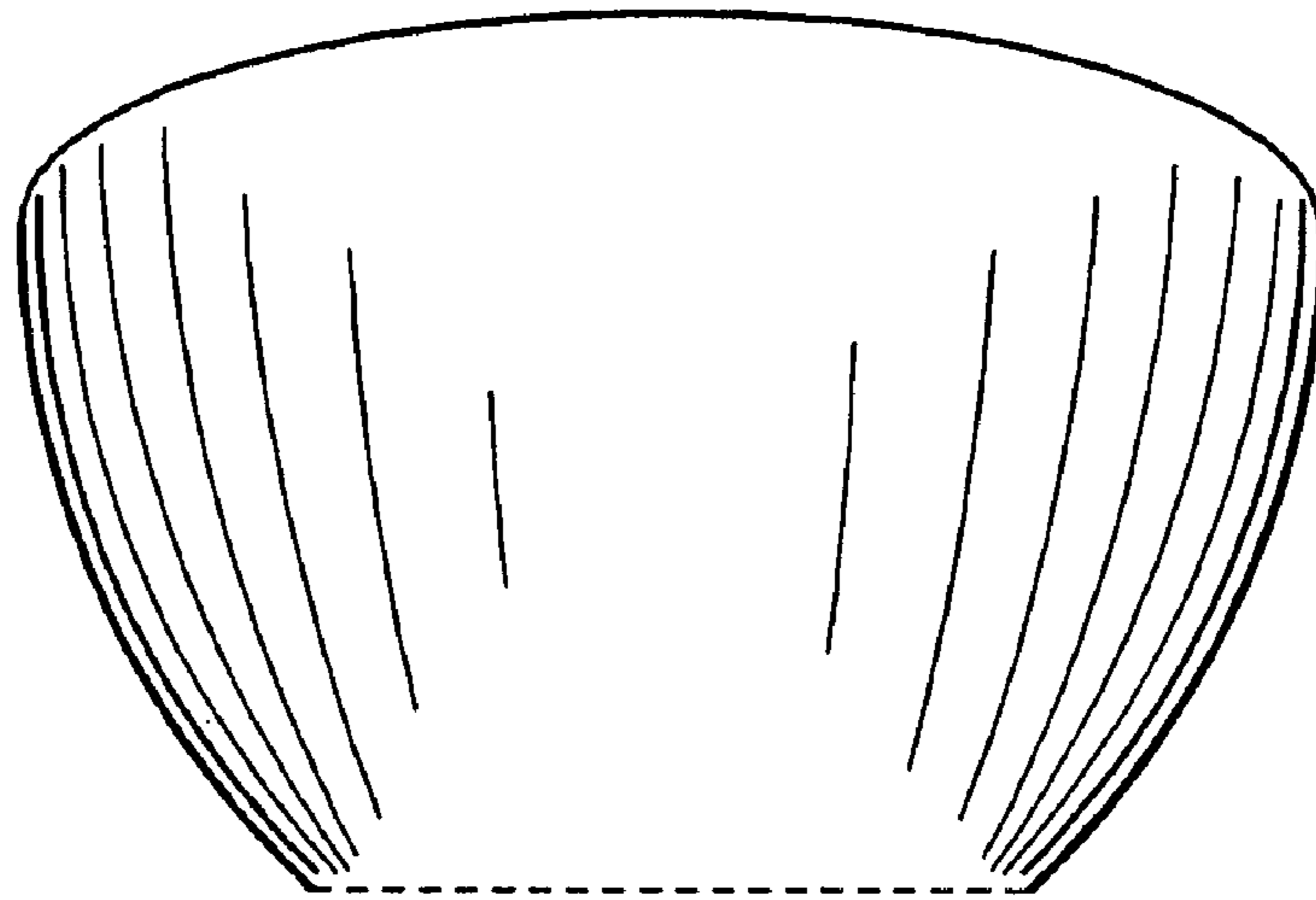

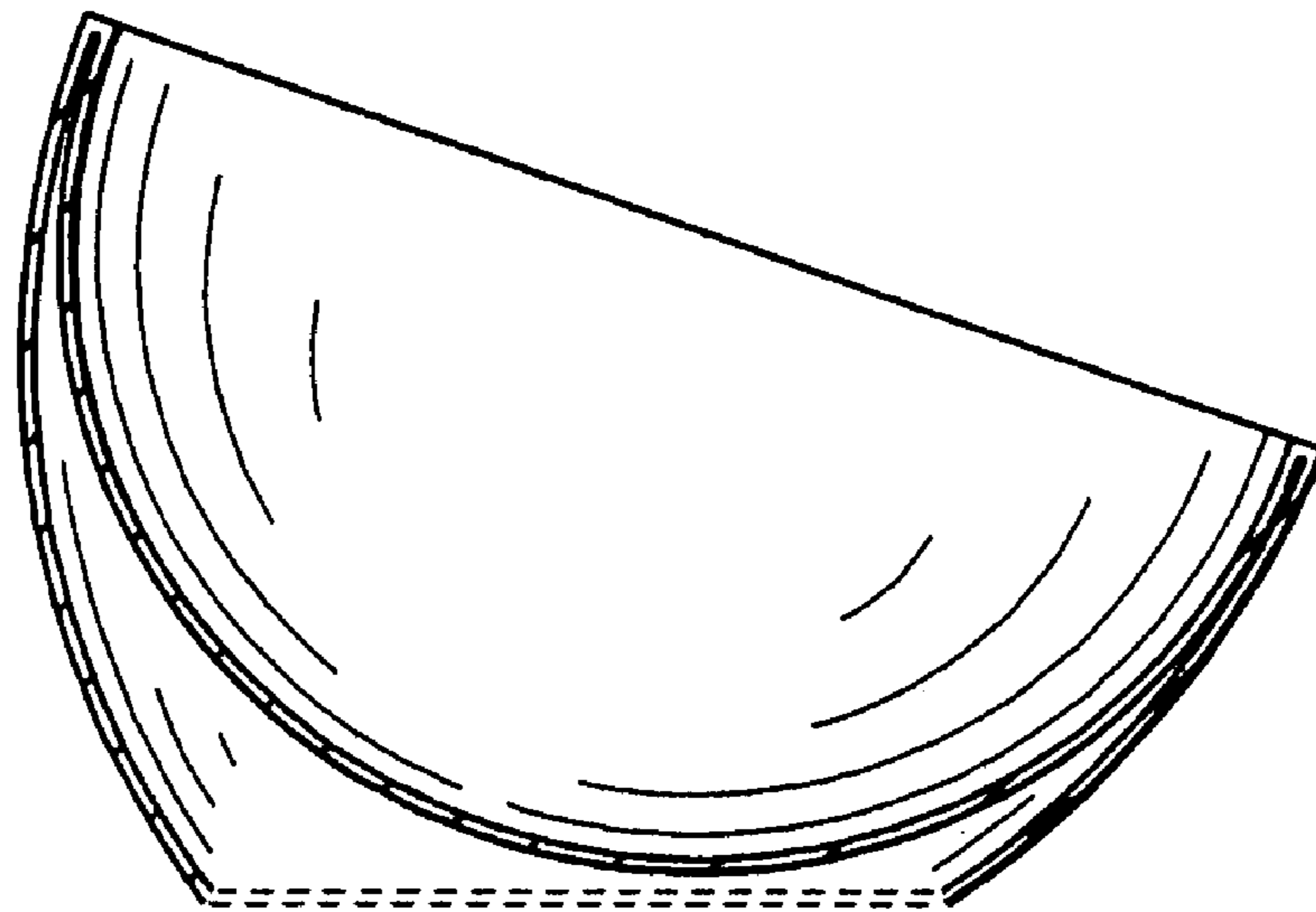
