**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a bottle embodying my new design;

FIG. 3 is a front elevational view thereof;

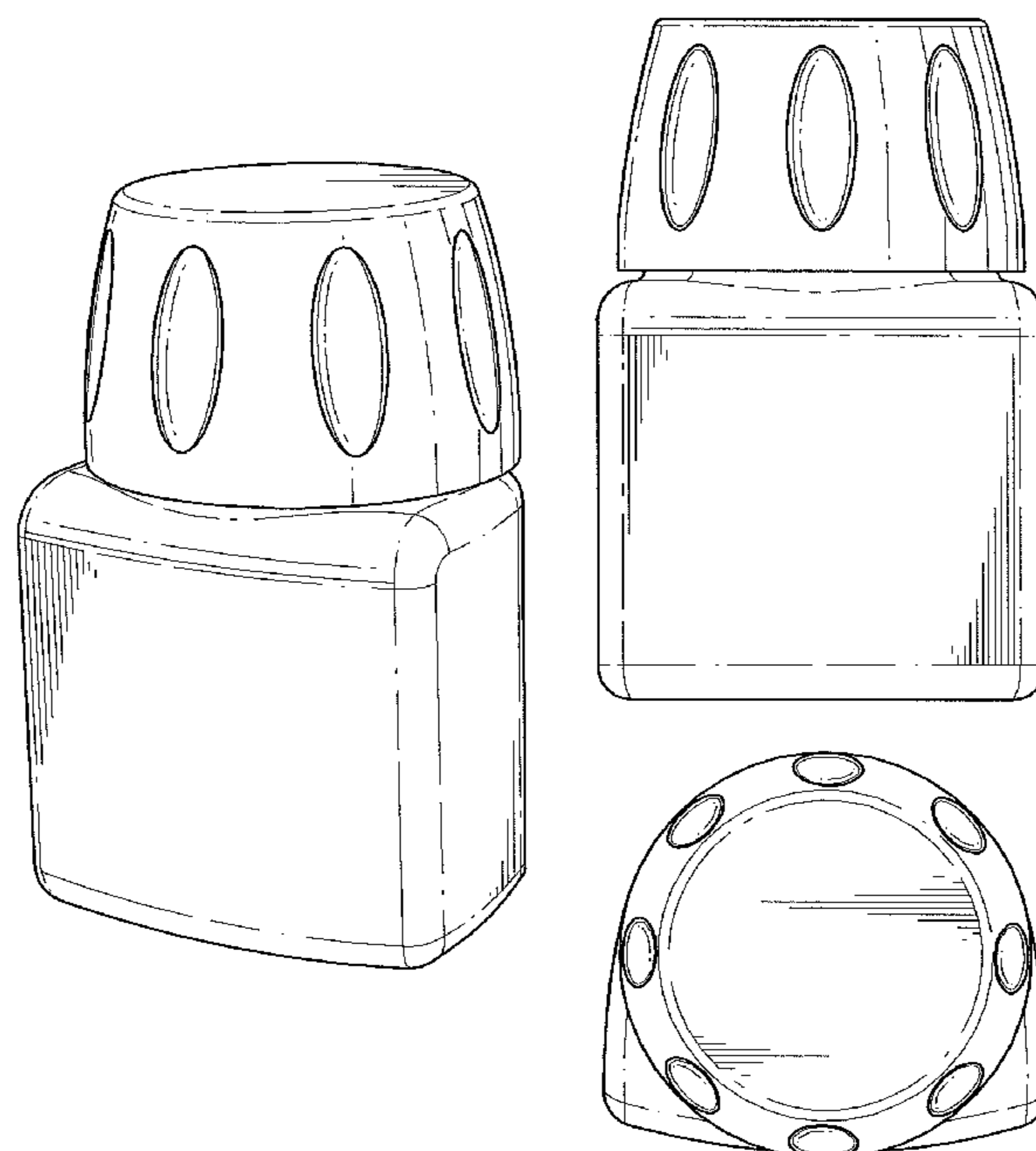
FIG. 4 is a right side elevational view, the left side elevational view being a mirror image thereof;

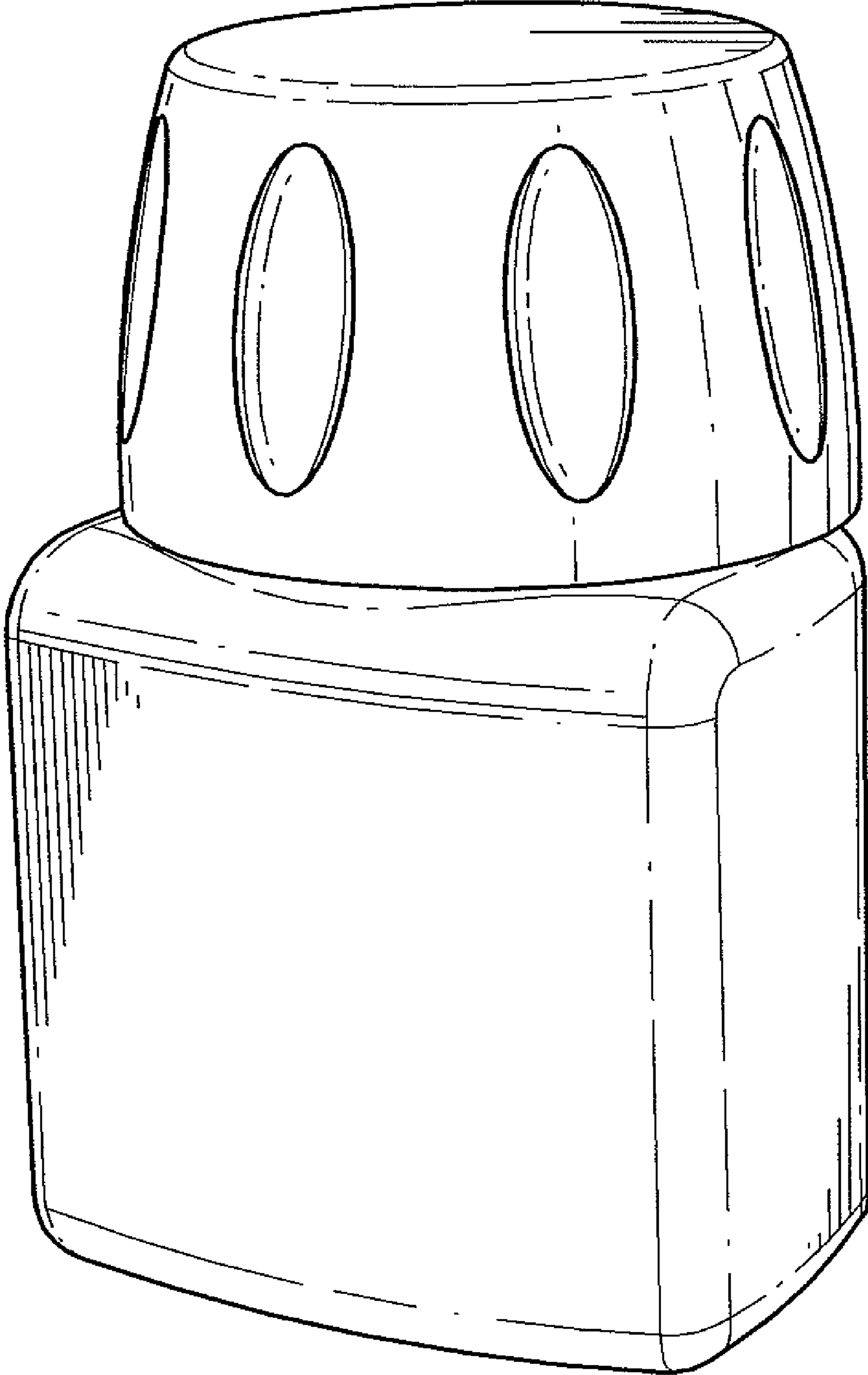
FIG. 5 is a top plan view thereof; and,

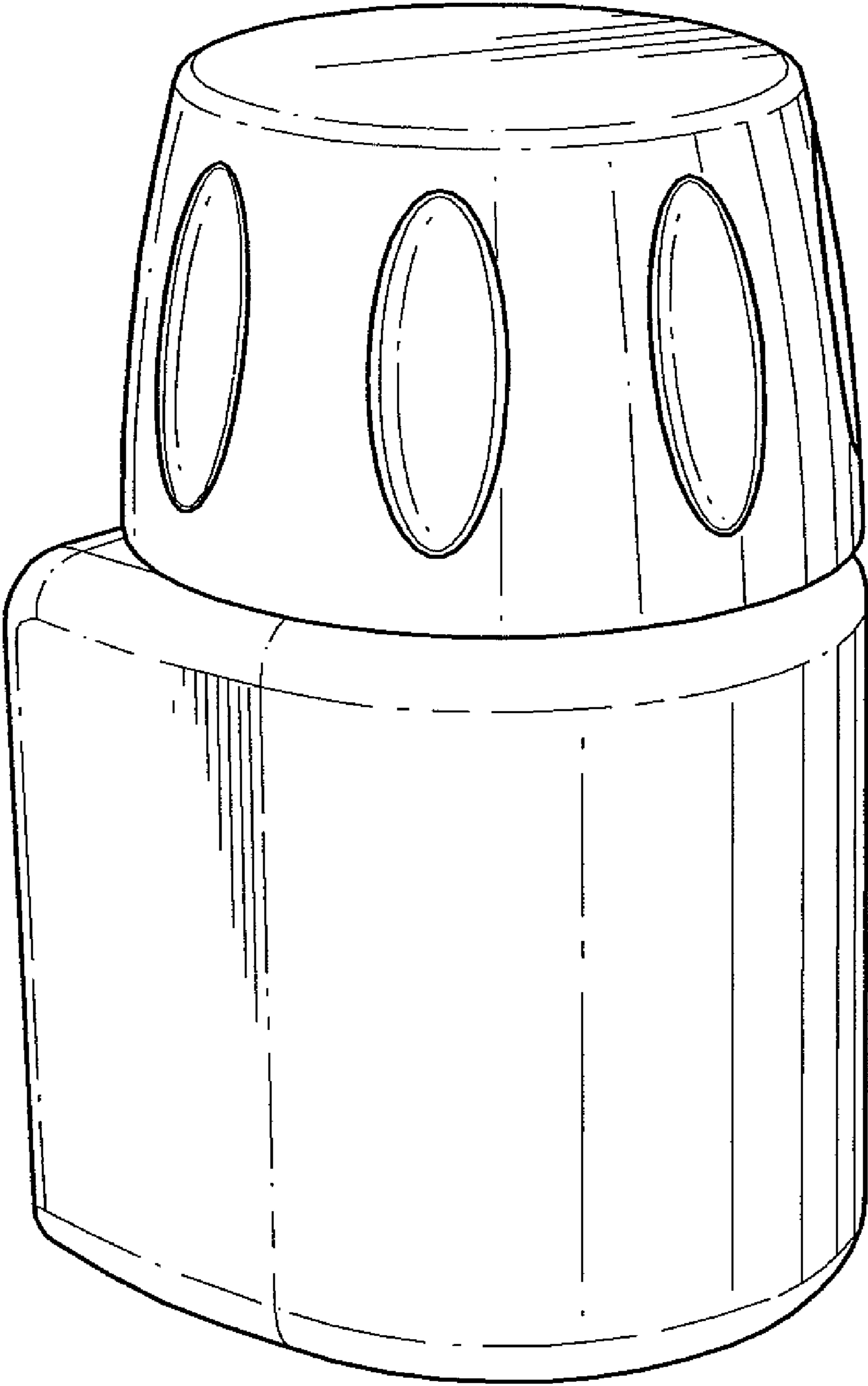
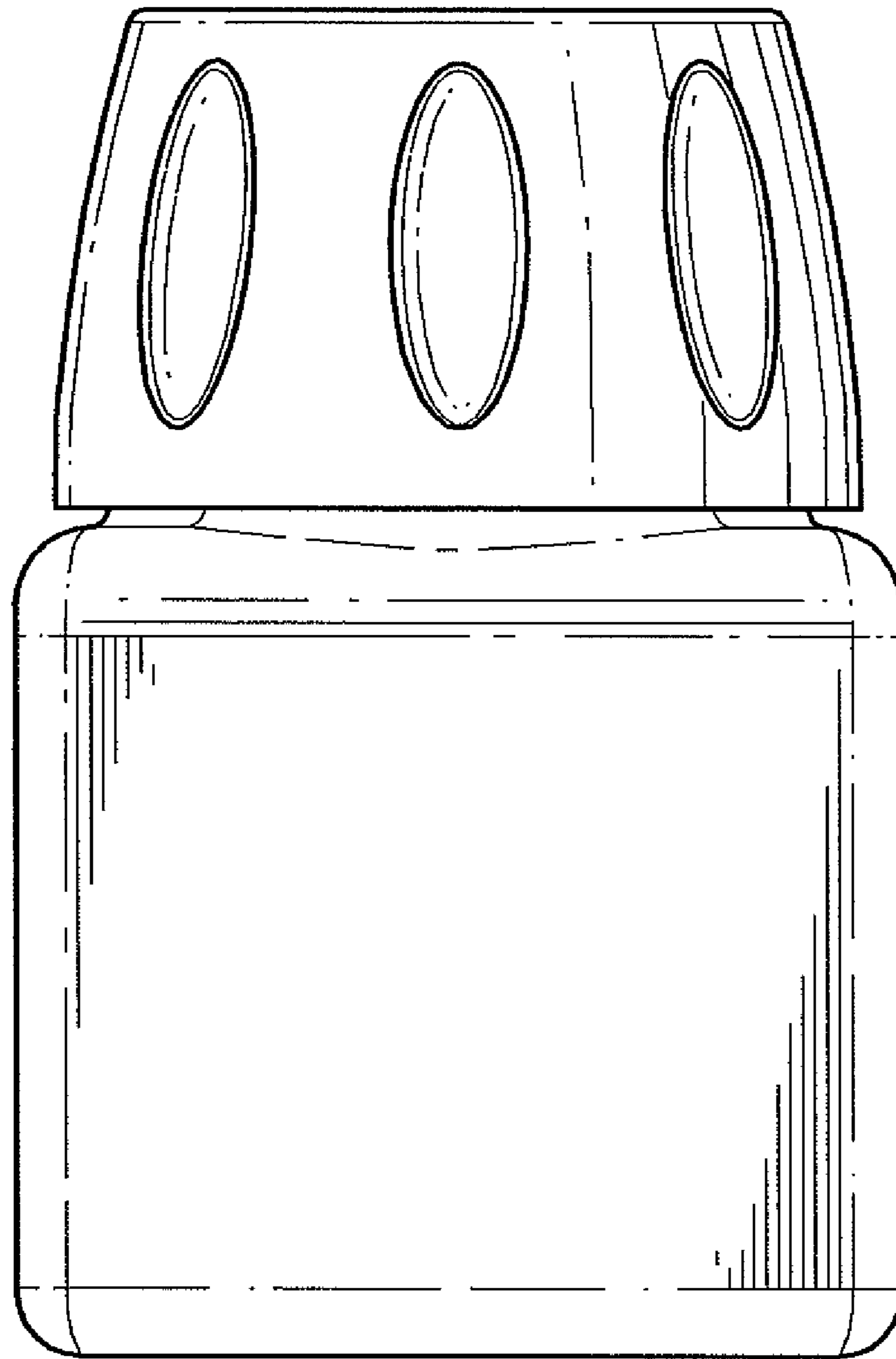

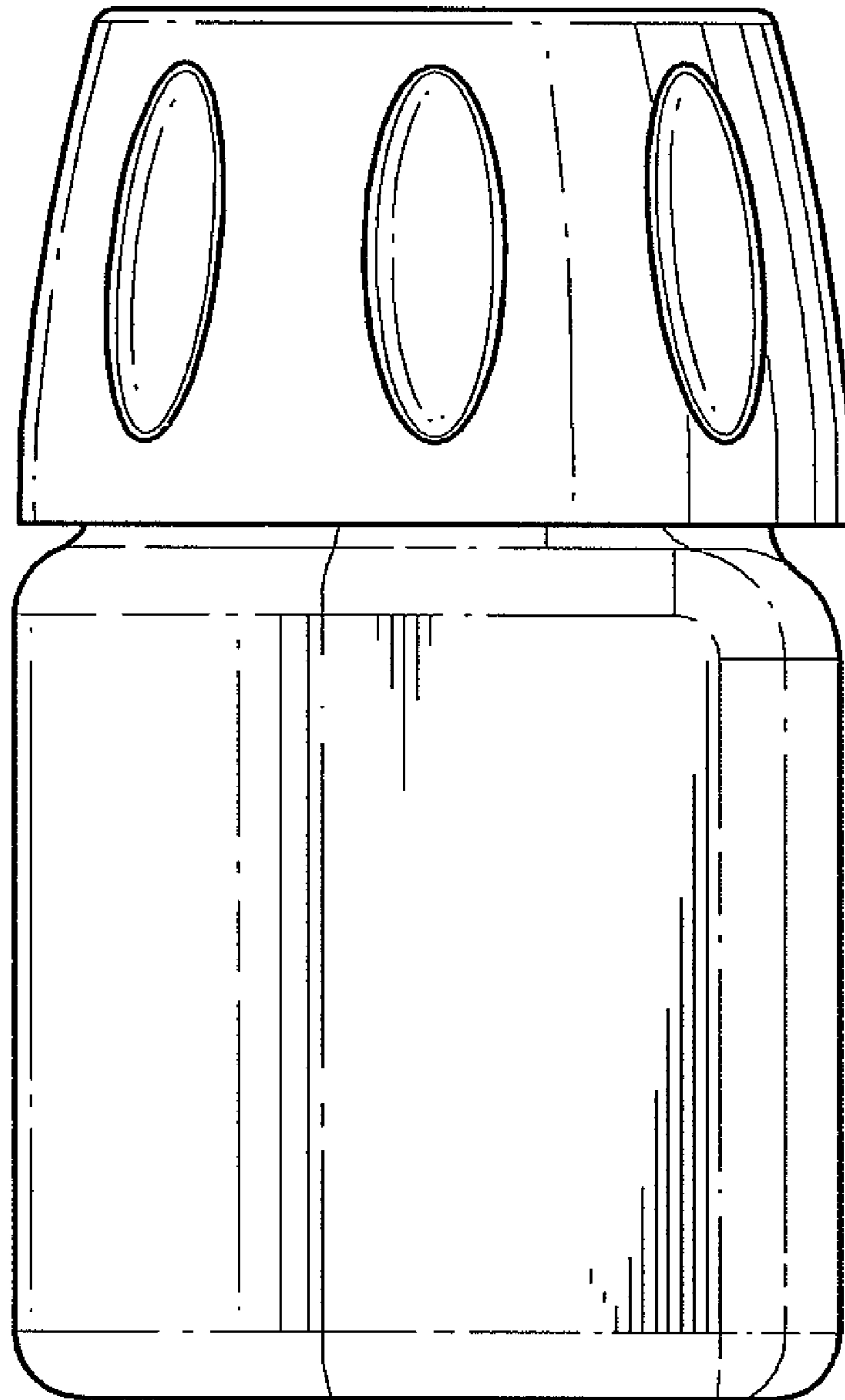
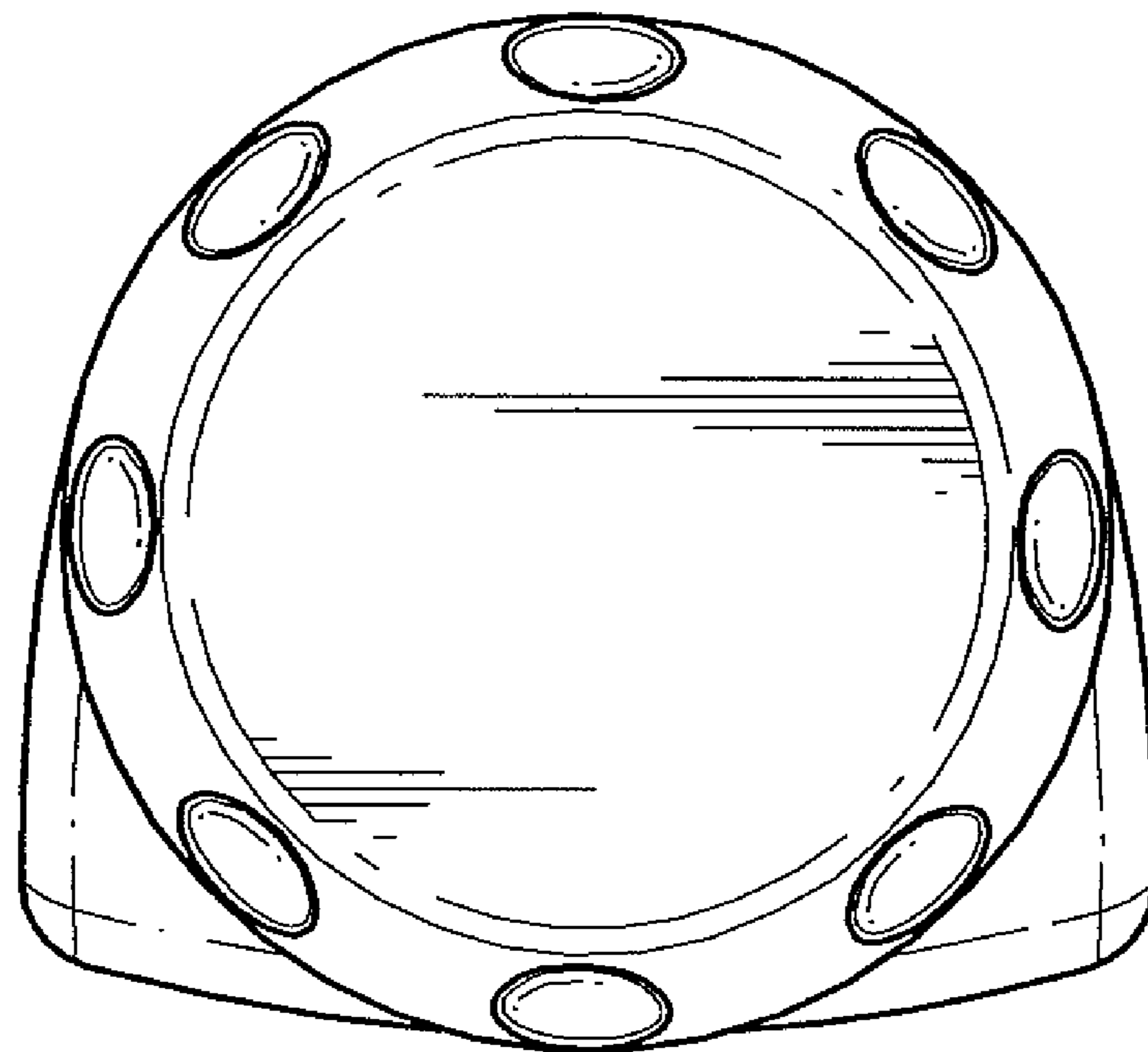
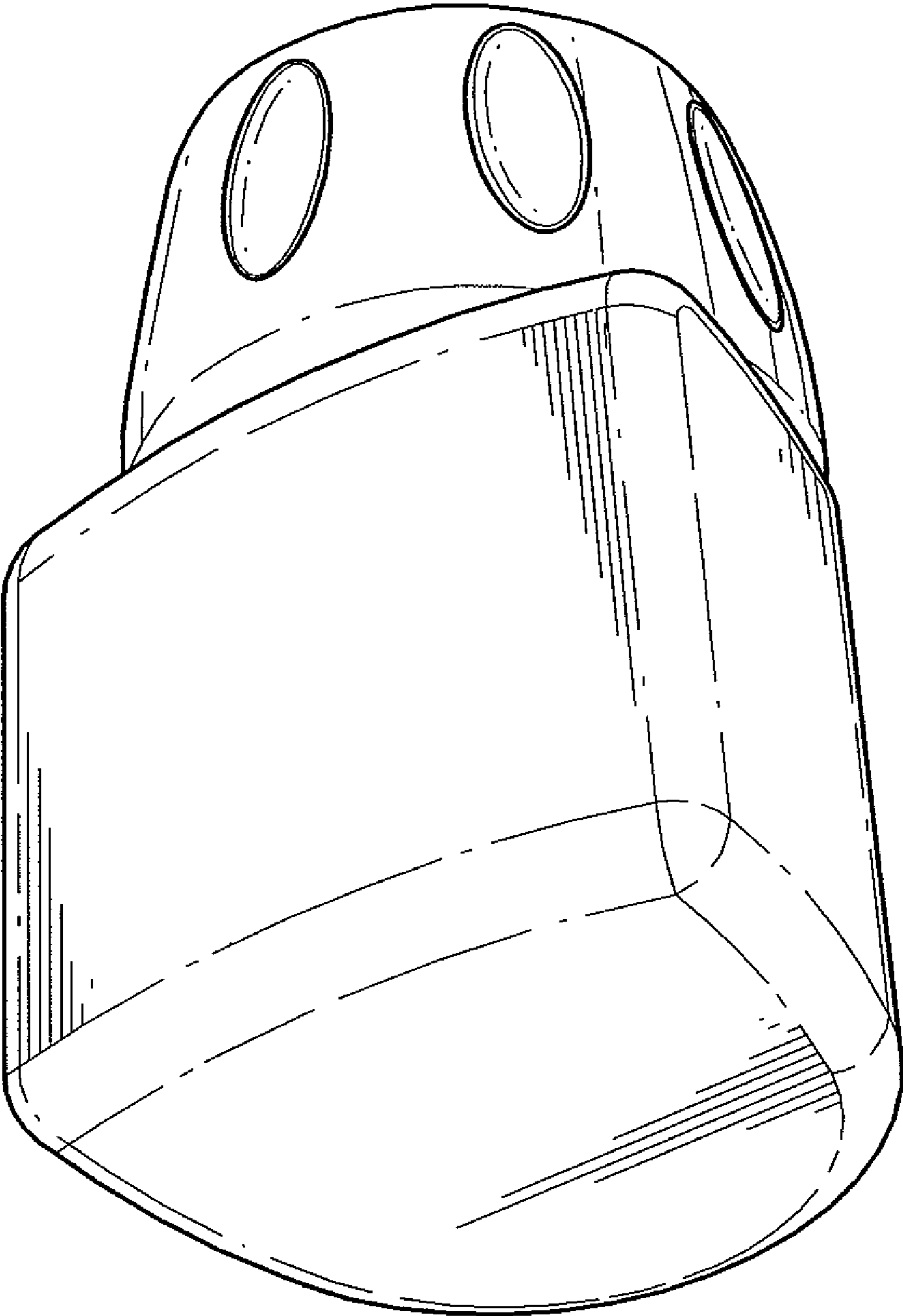
