The ornamental design for a bottle and portion thereof, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bottle showing our new design;

FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image;

FIG. 3 is a right side elevation view thereof, the left side elevation view being a mirror image;

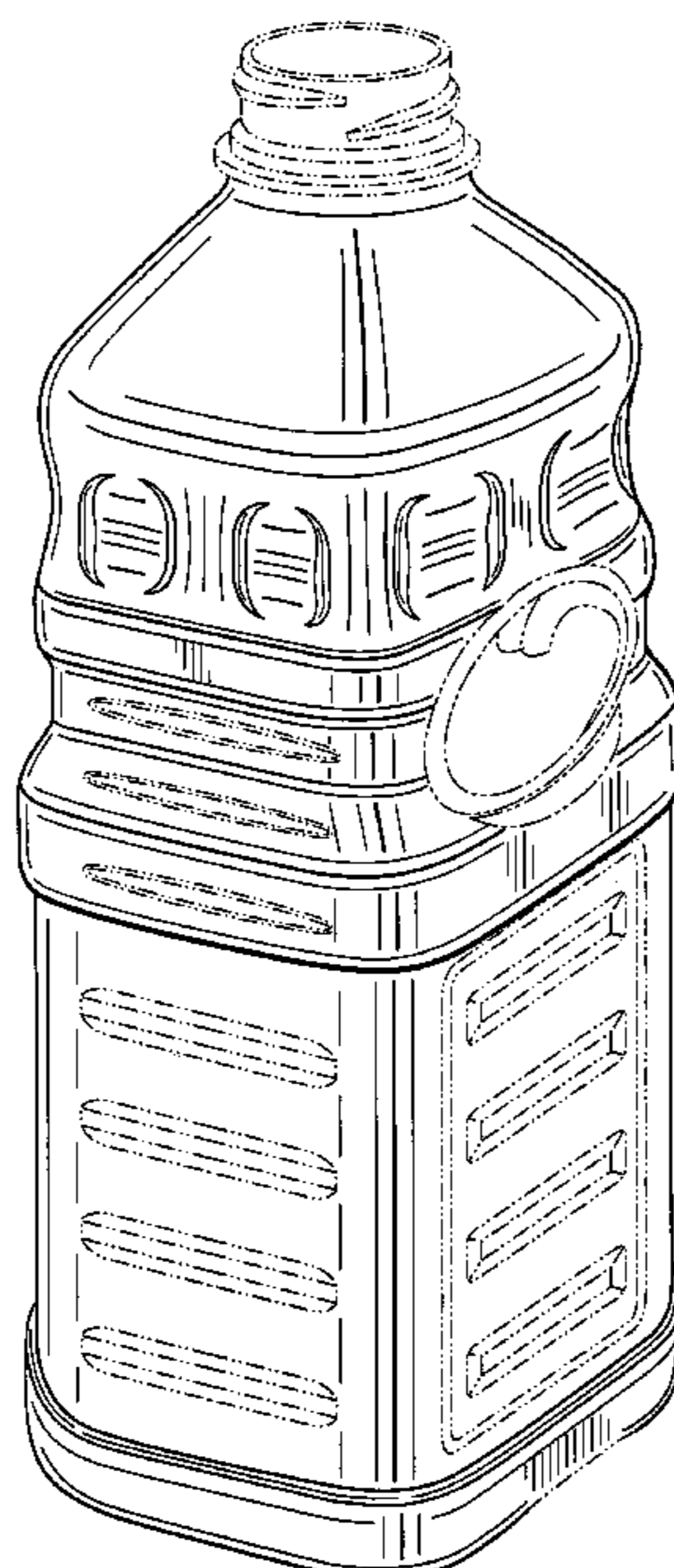
FIG. 4 is a top plan view thereof; and,

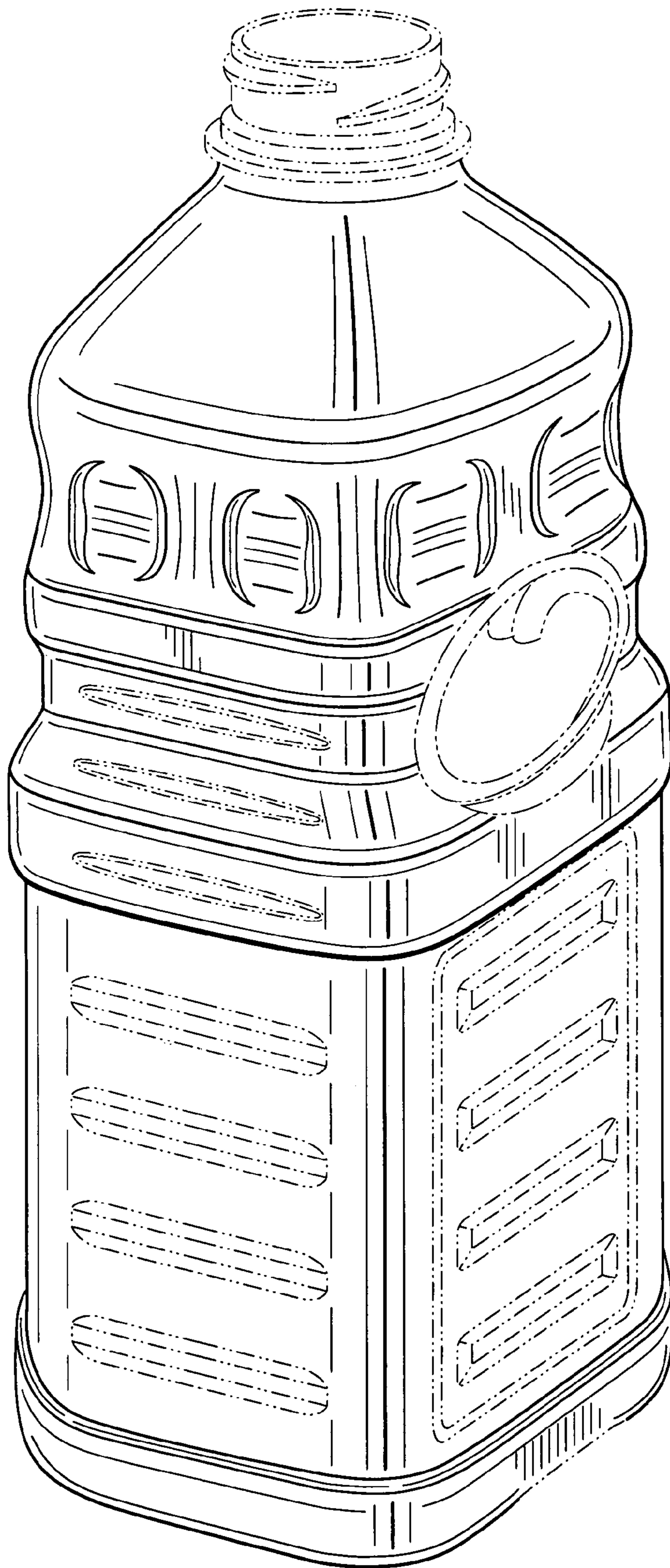

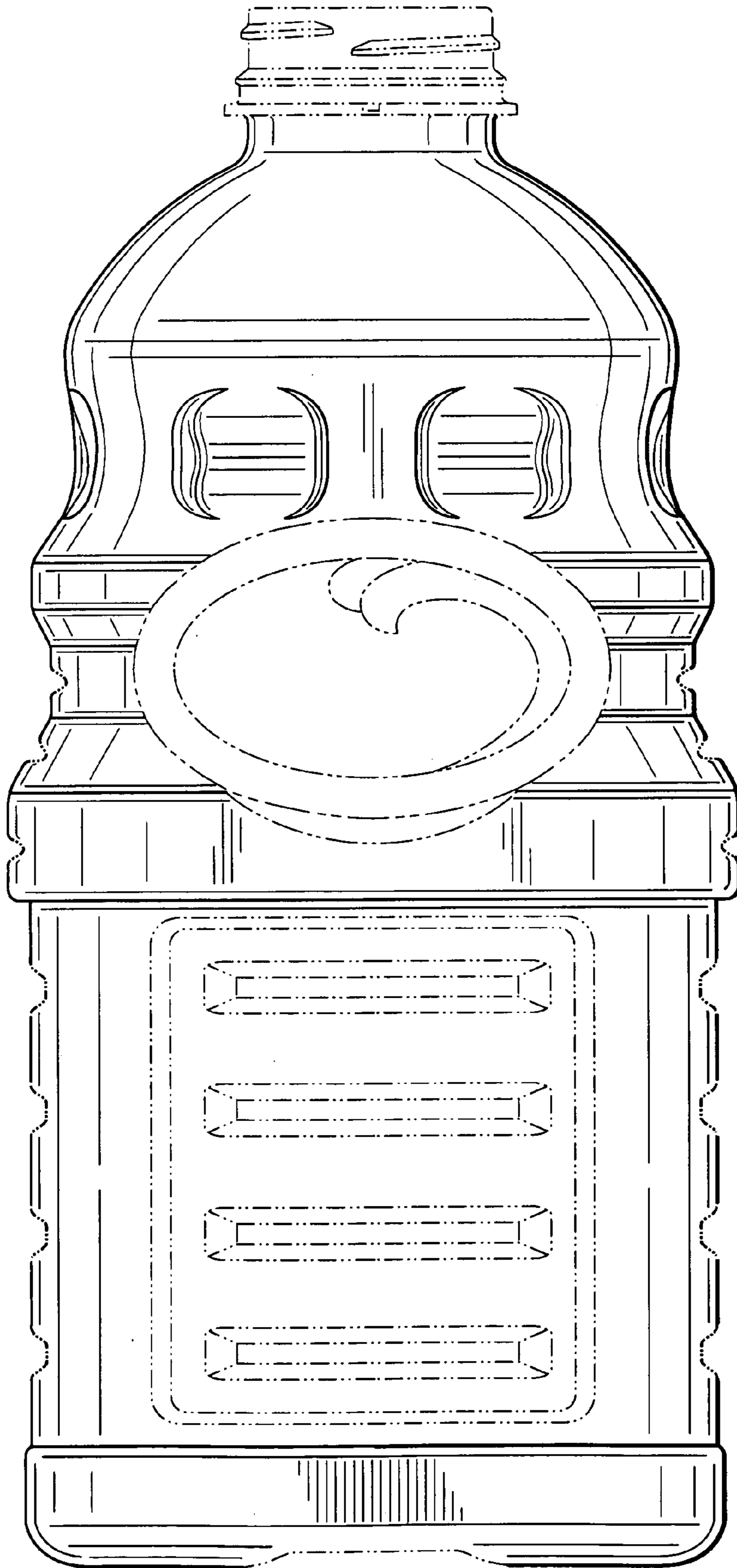

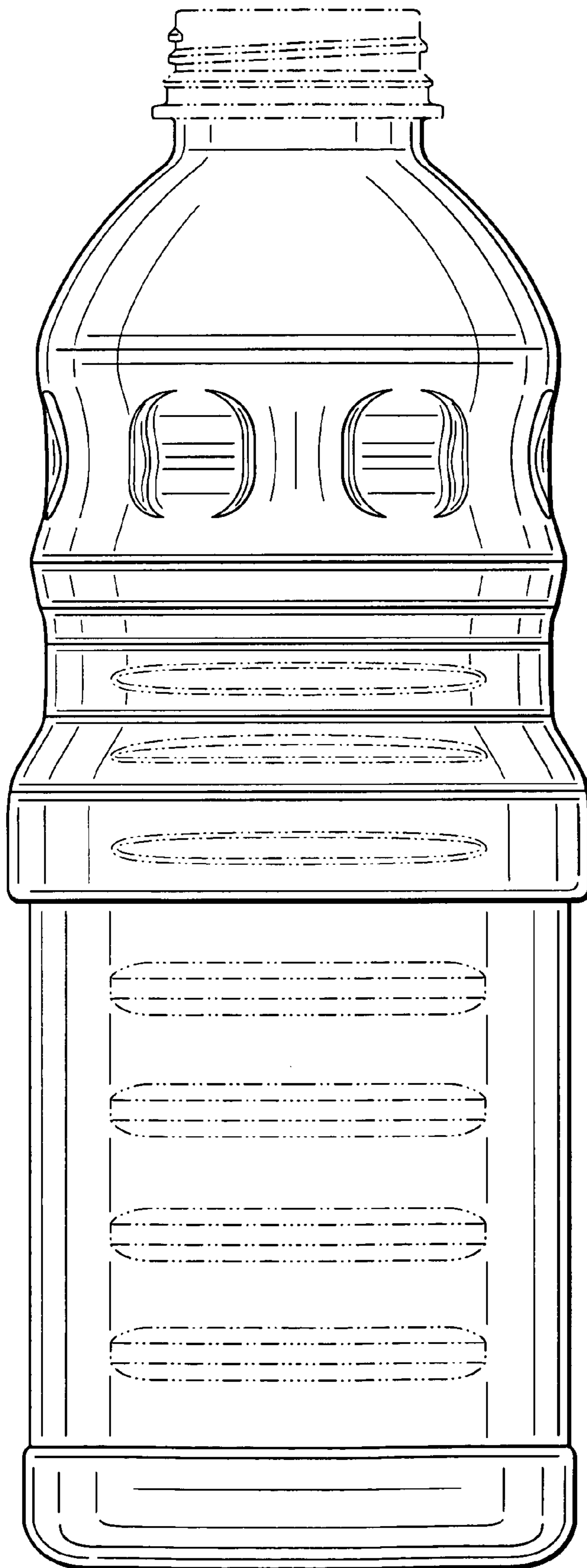

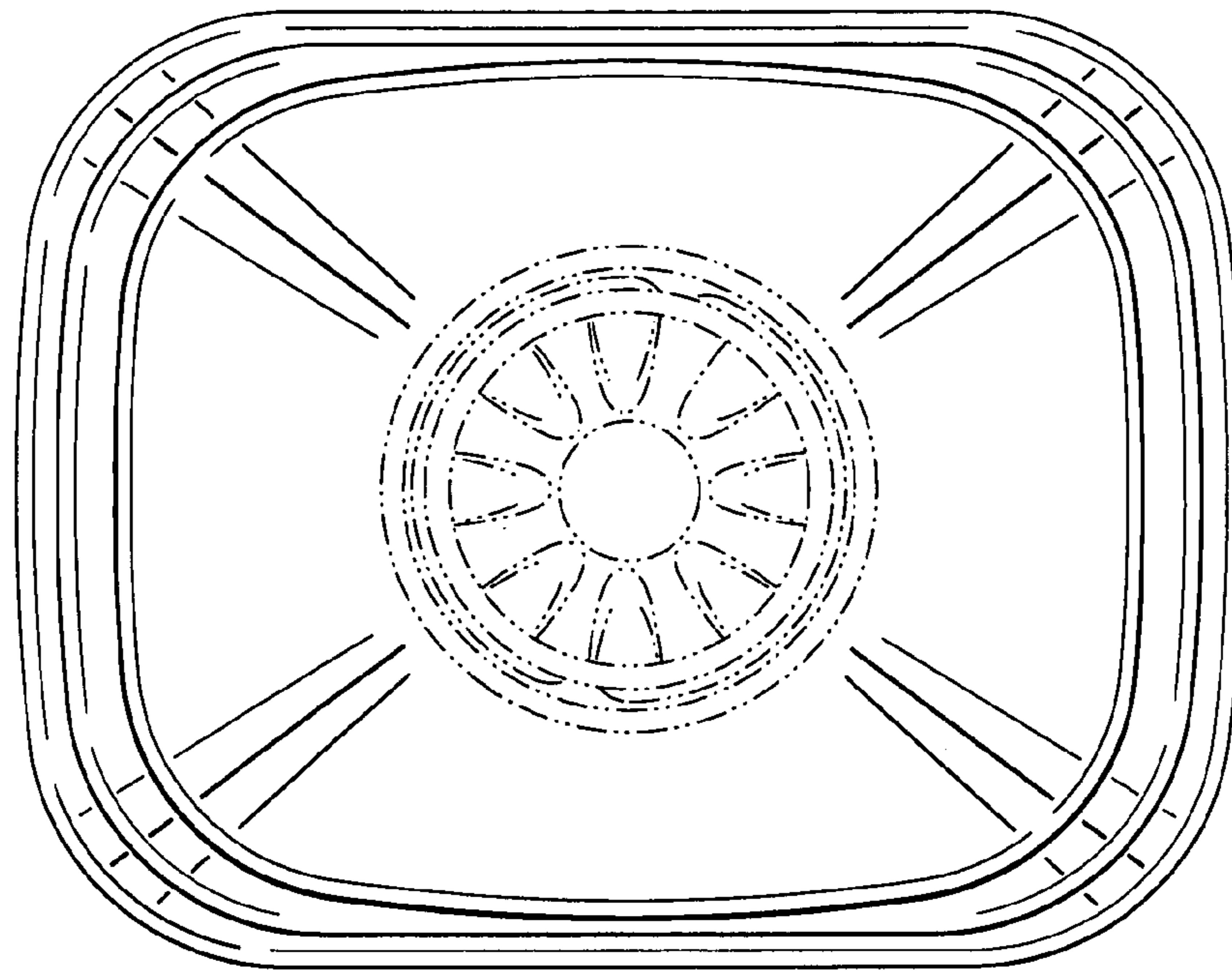

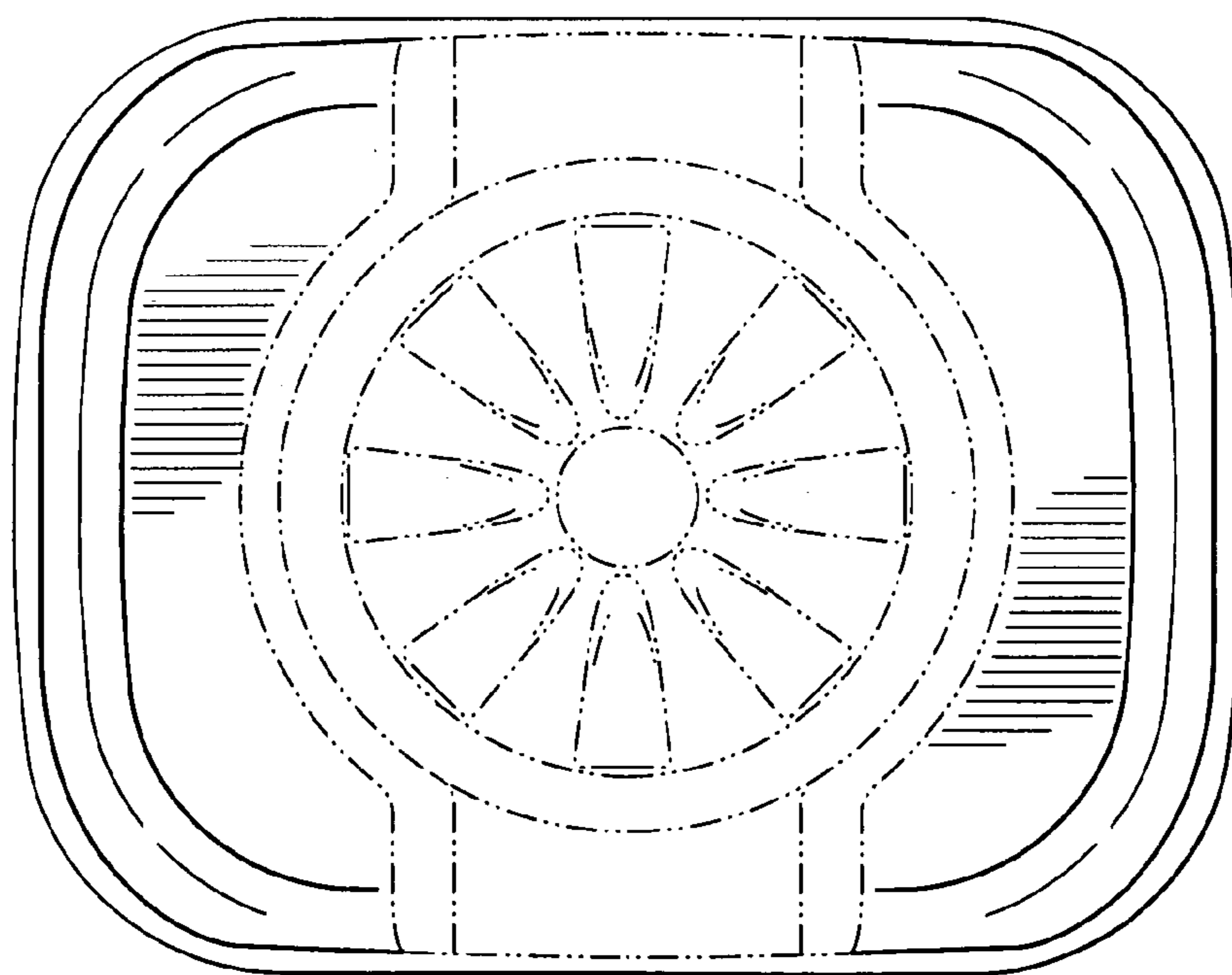
