FIG. 4 is front side view thereof;

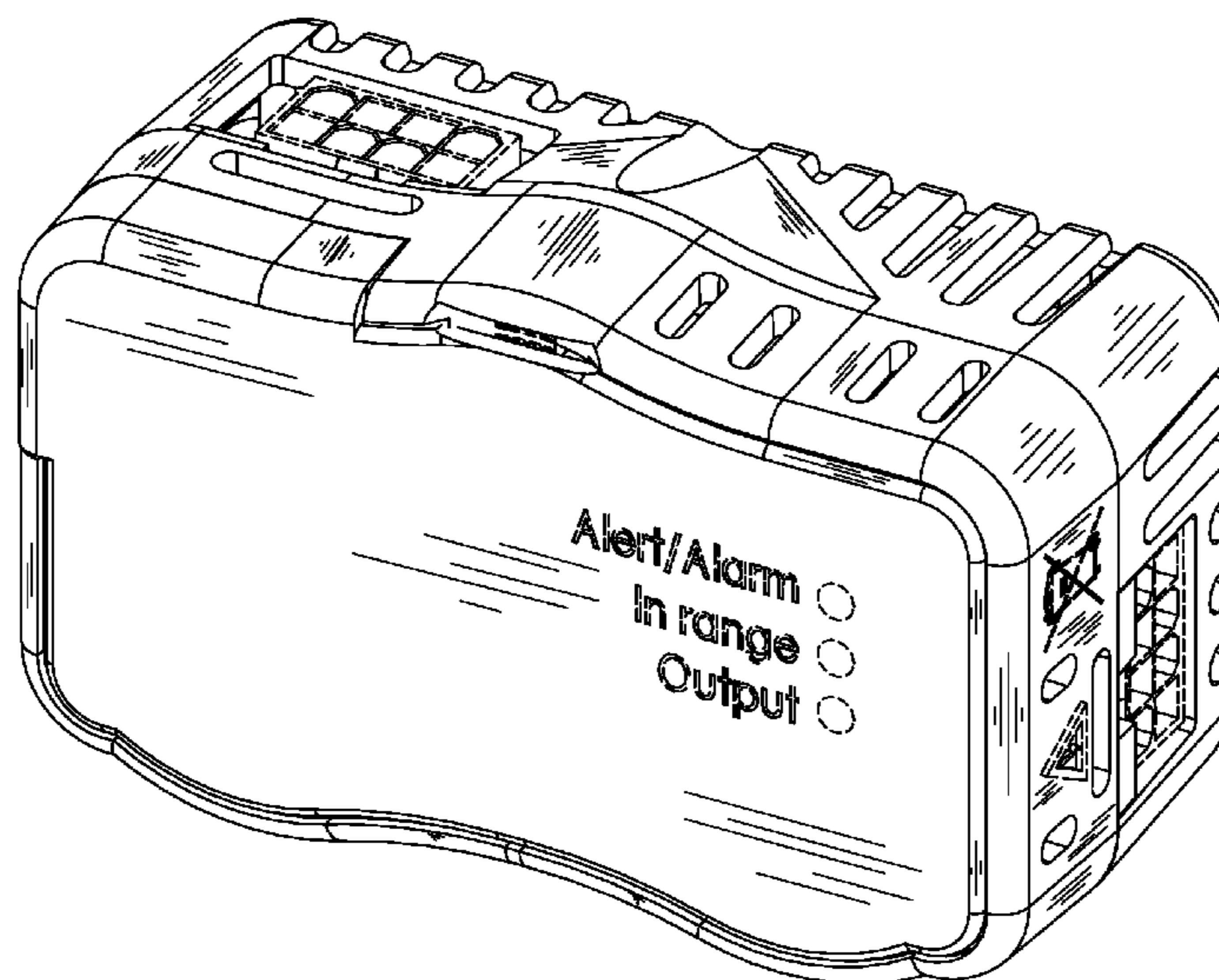
FIG. 5 is back side view thereof;

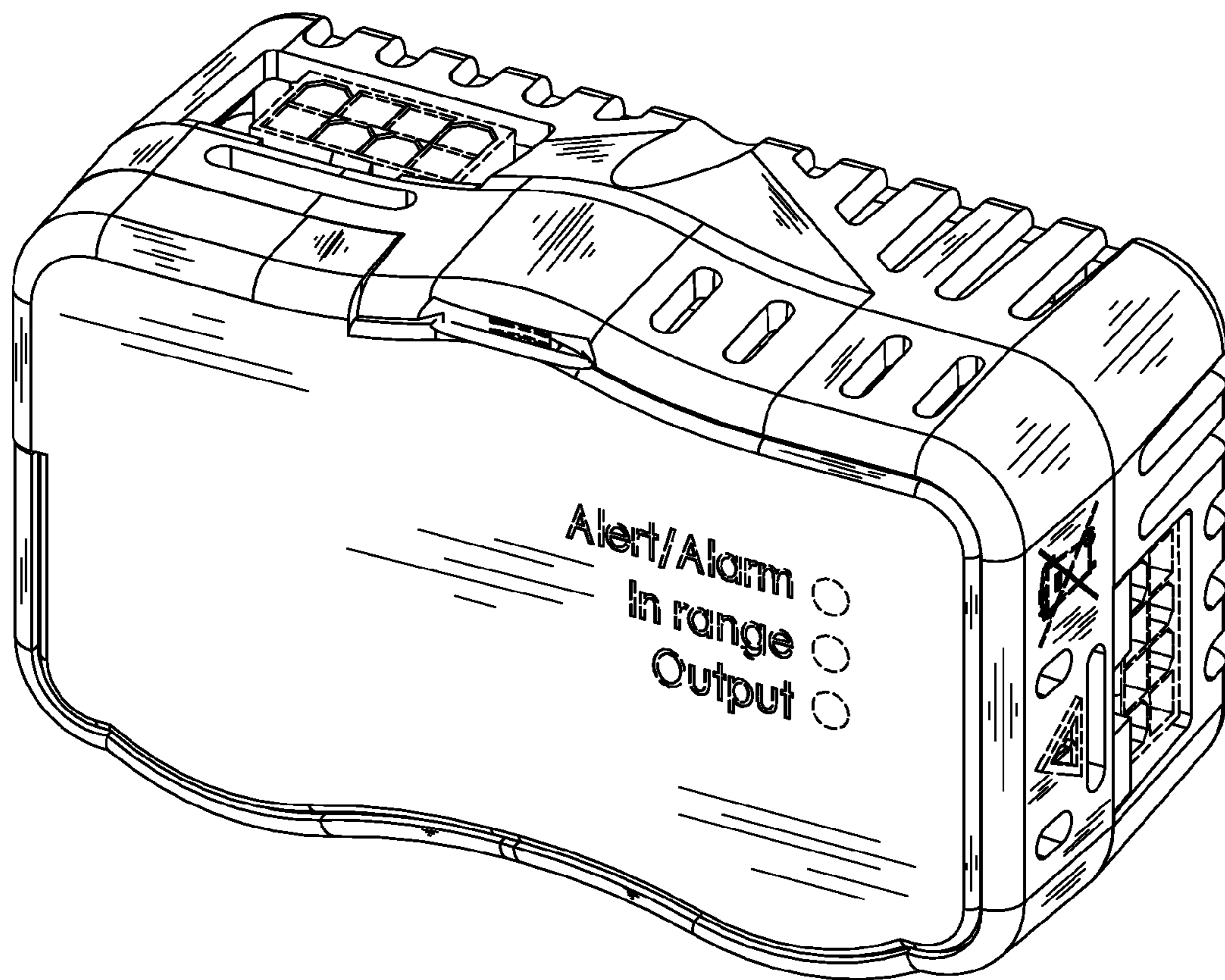

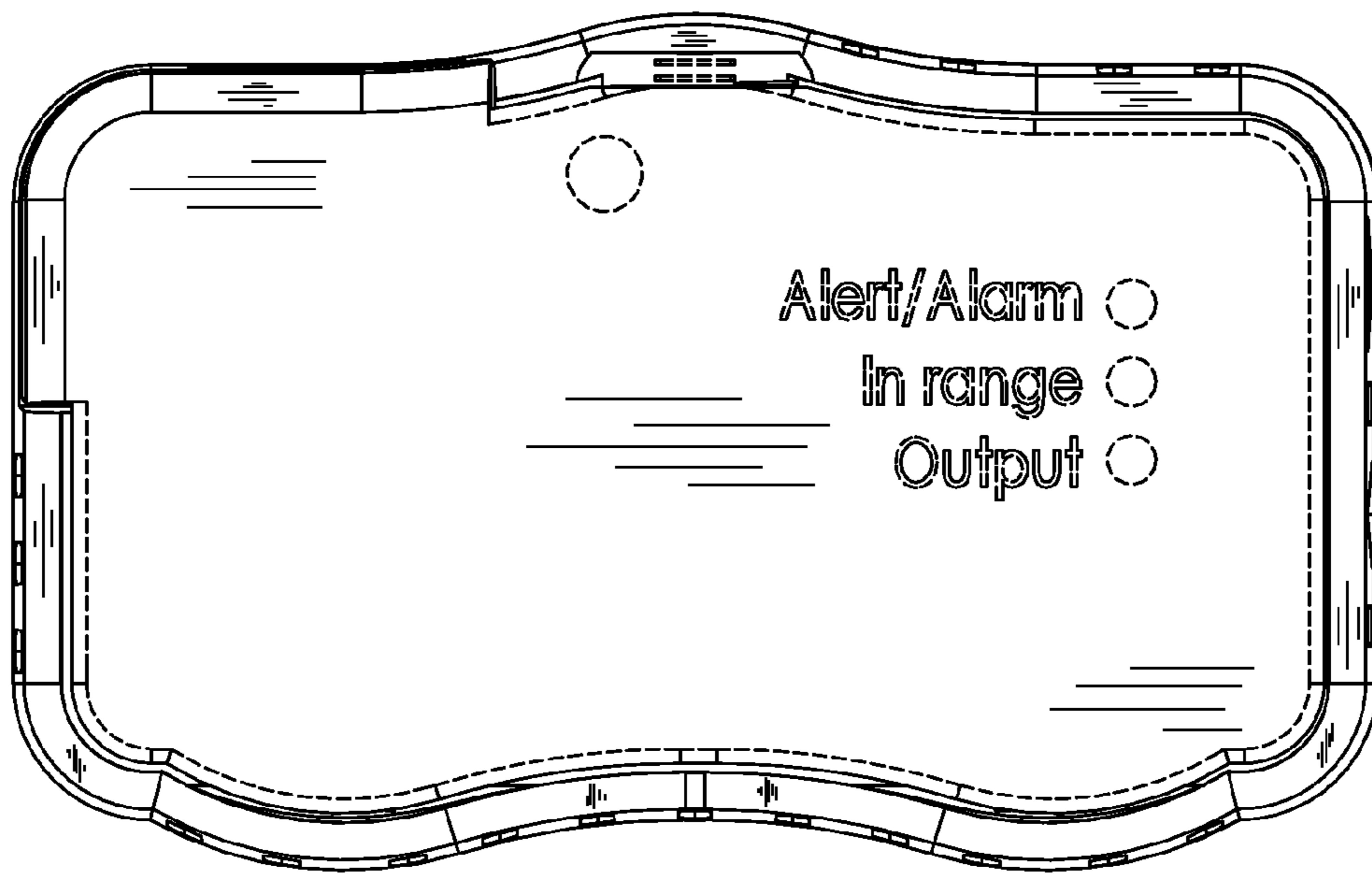

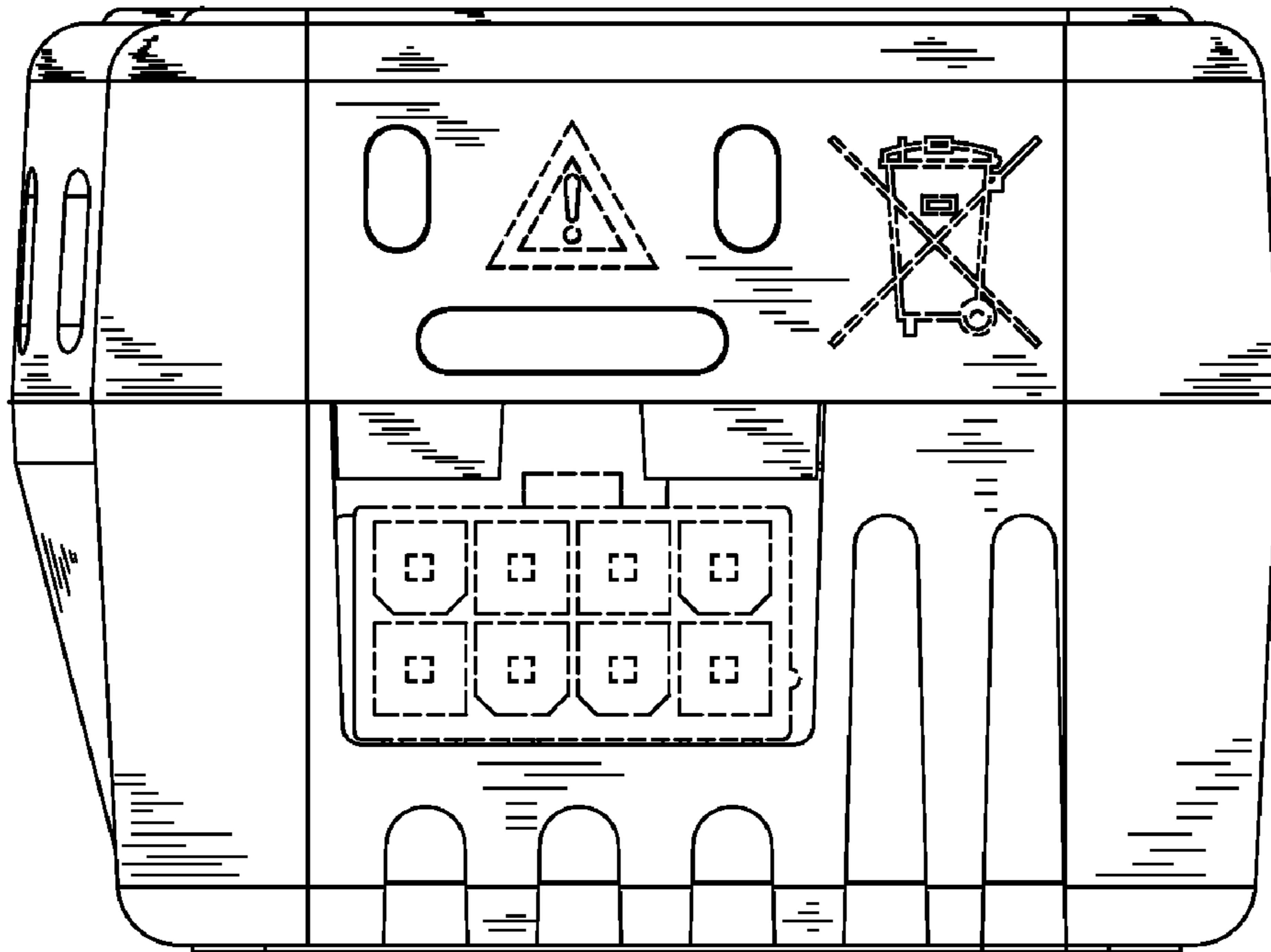

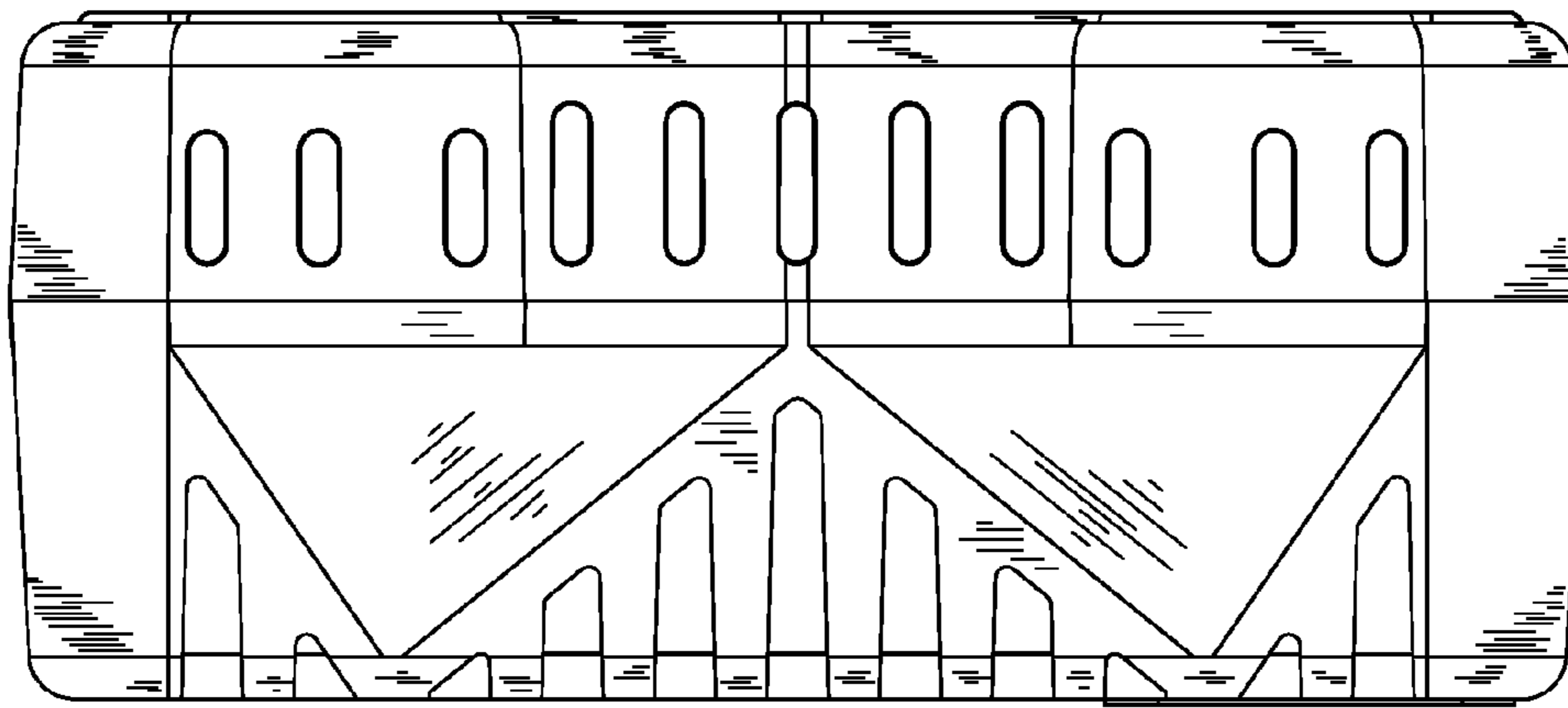

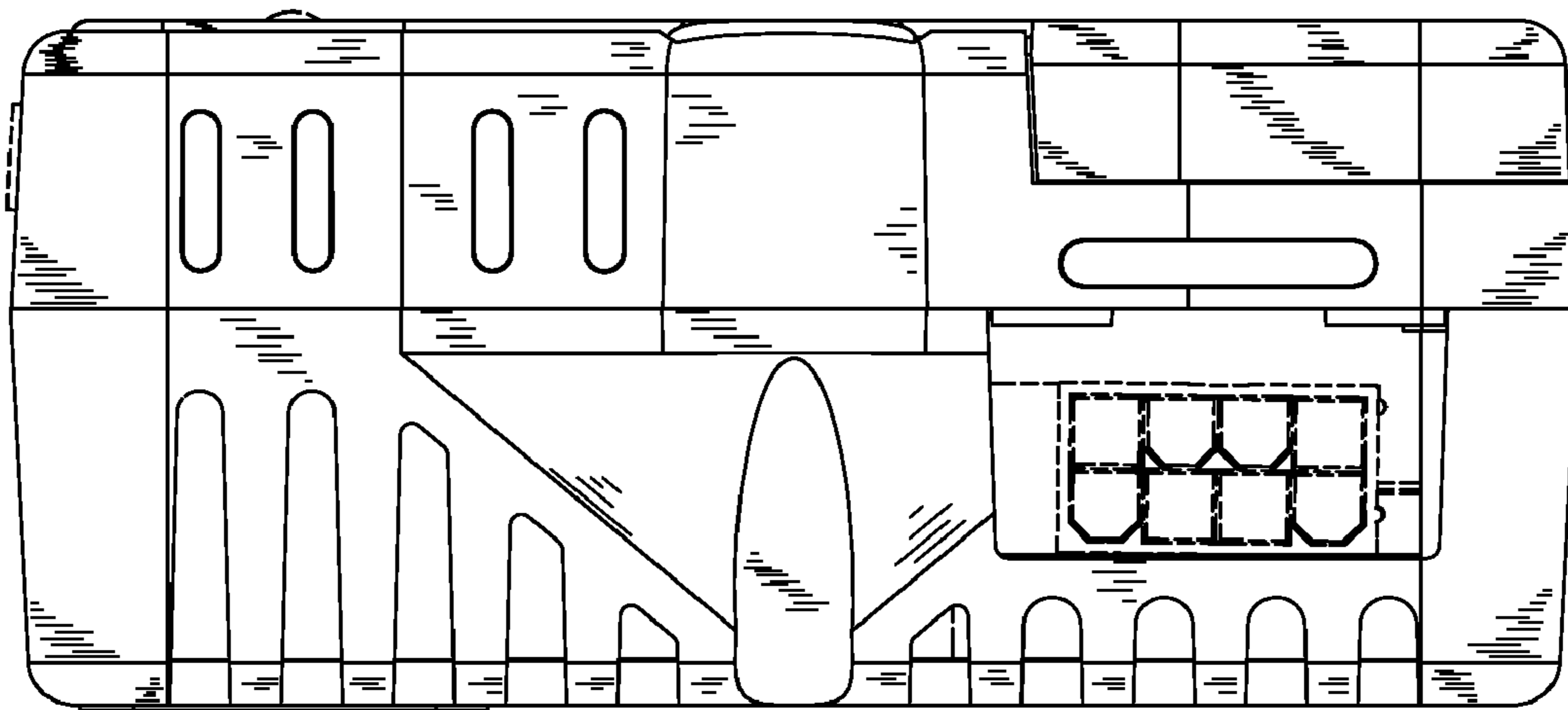

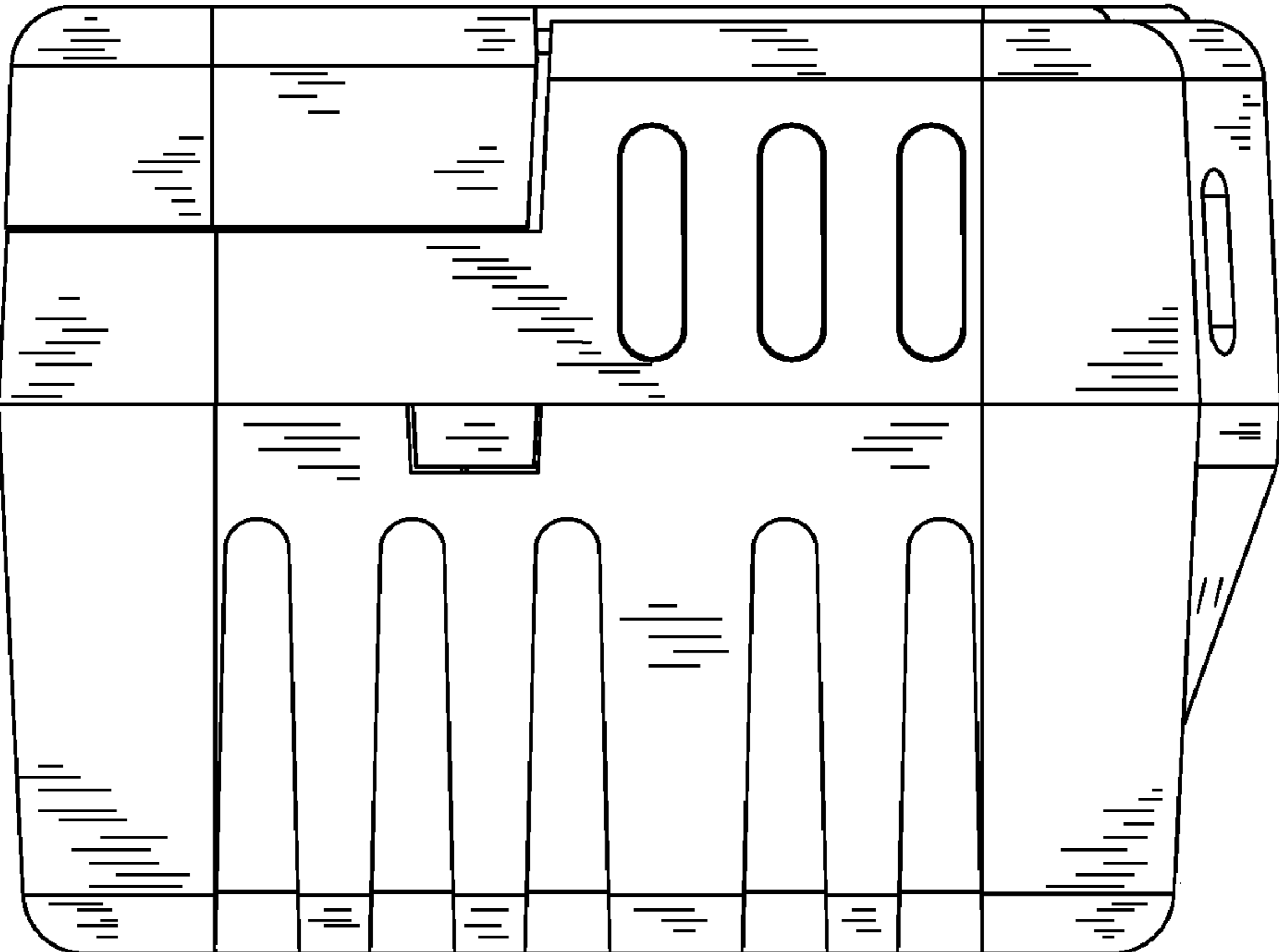

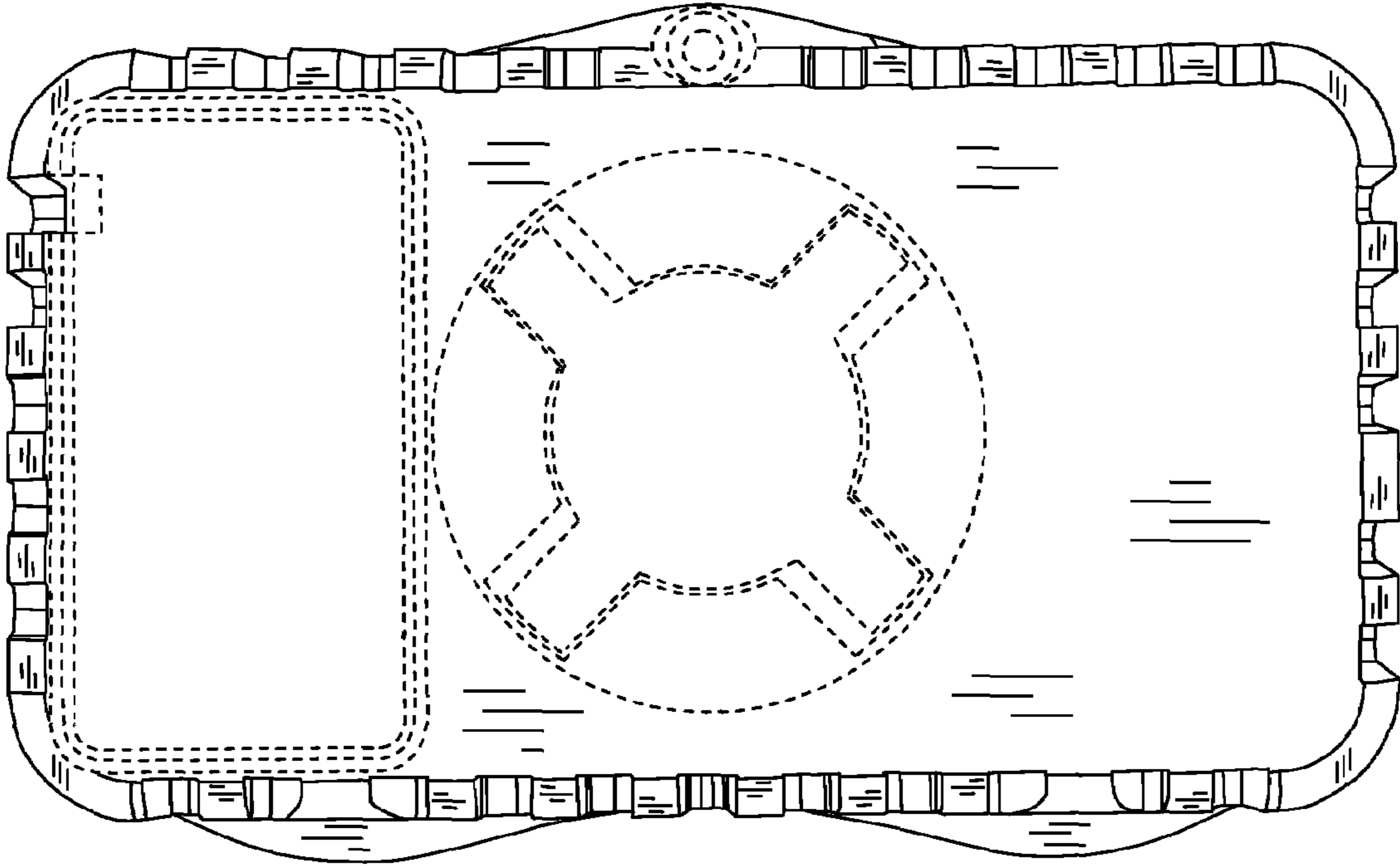
