DESCRIPTION

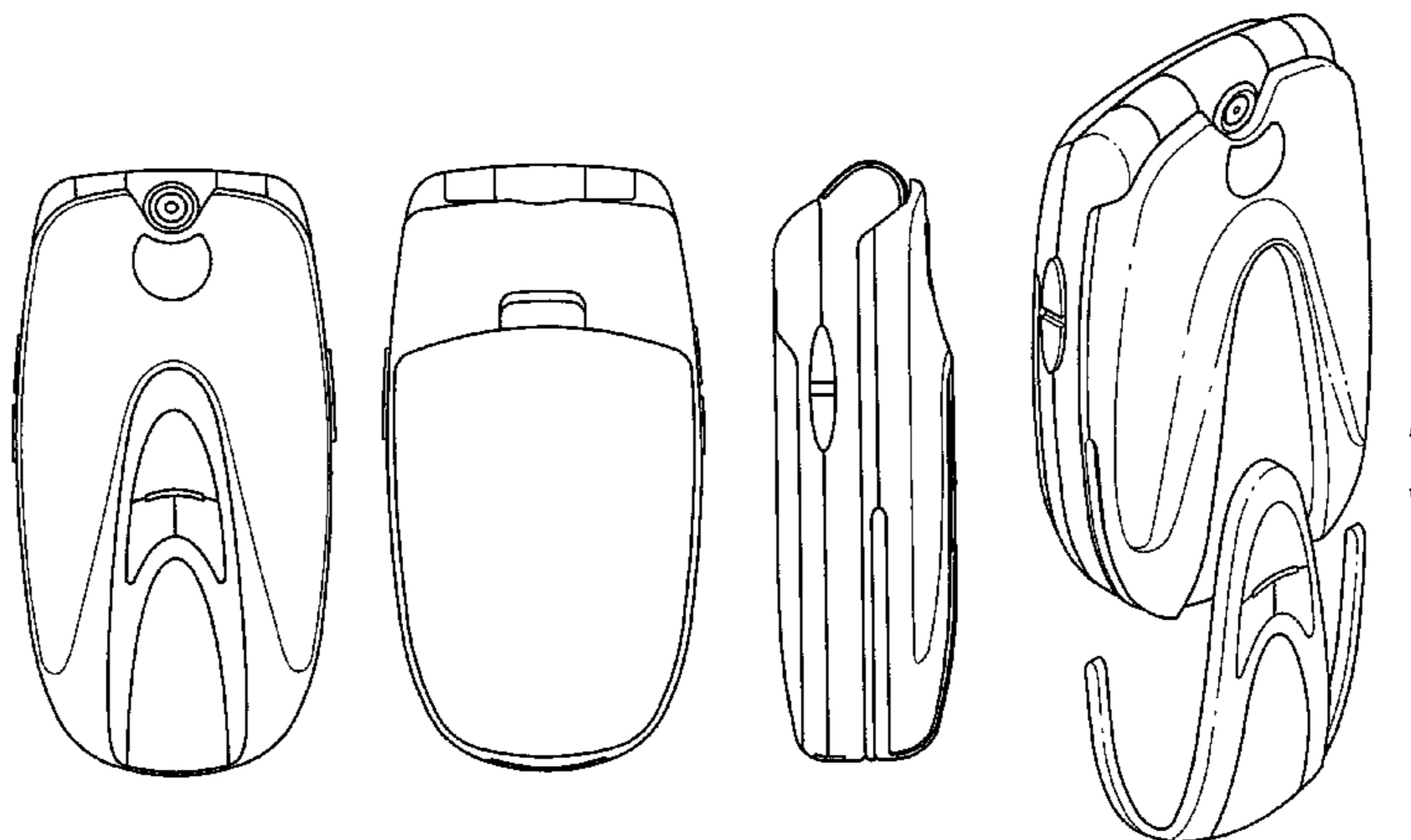

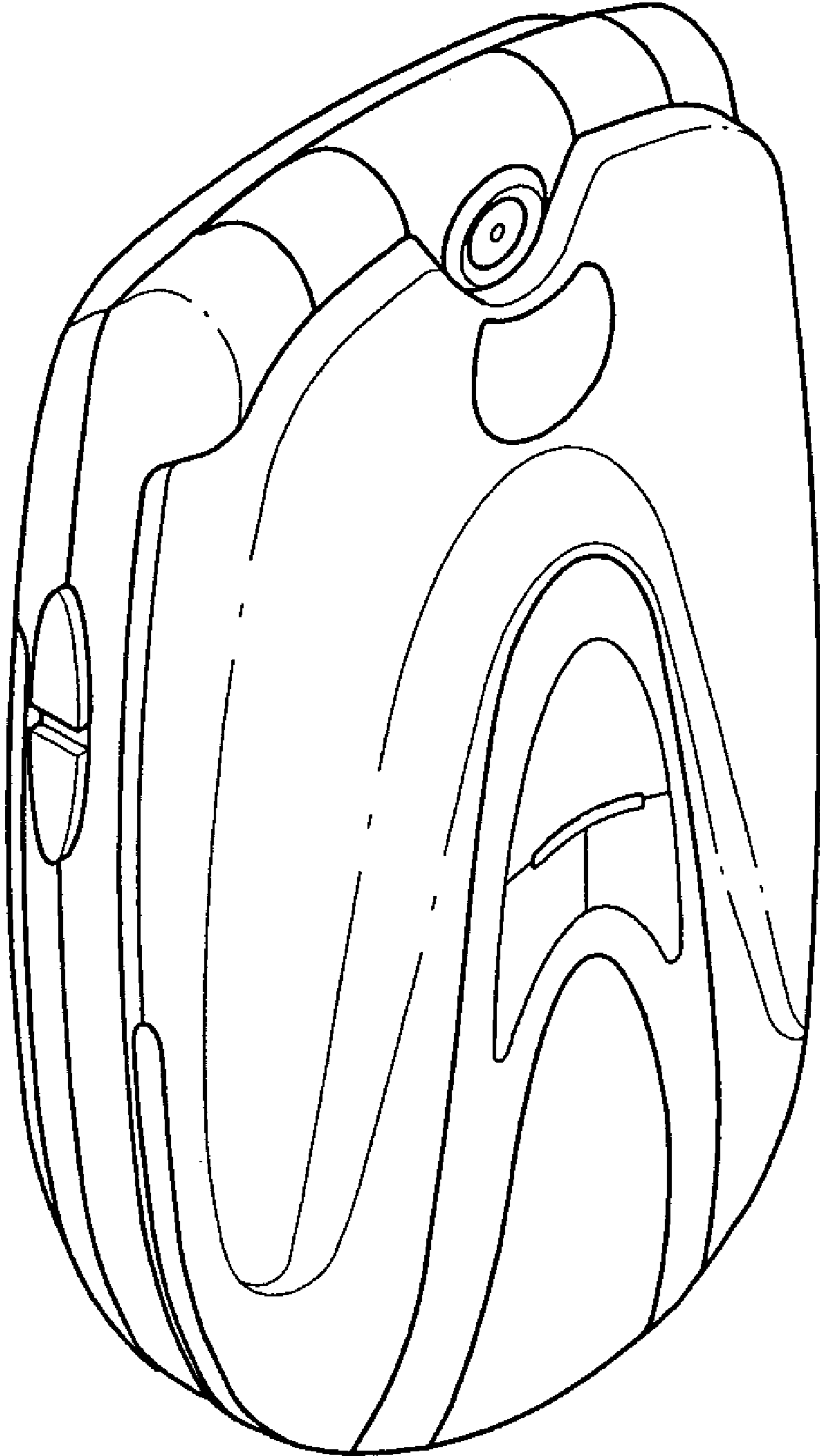

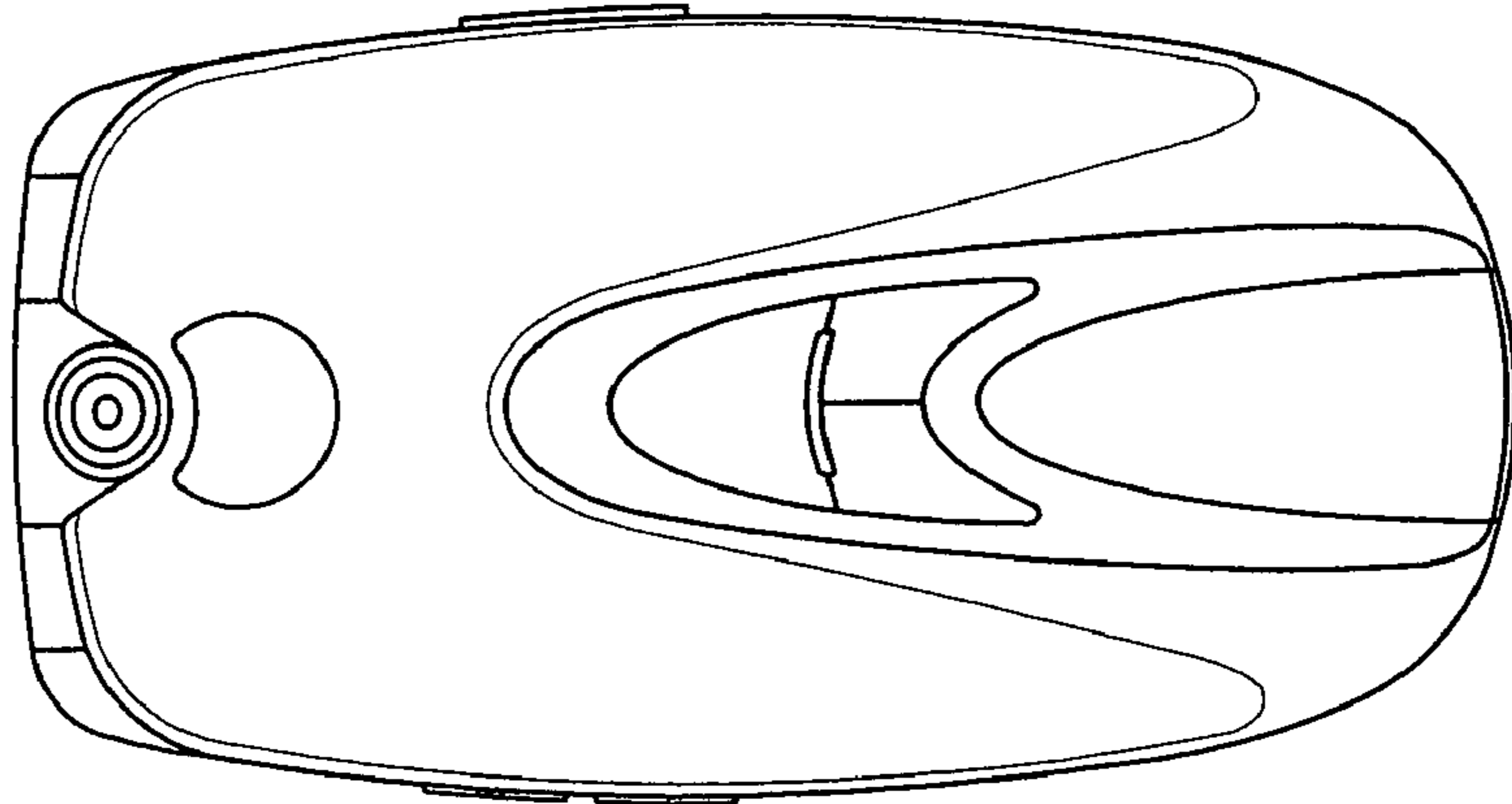

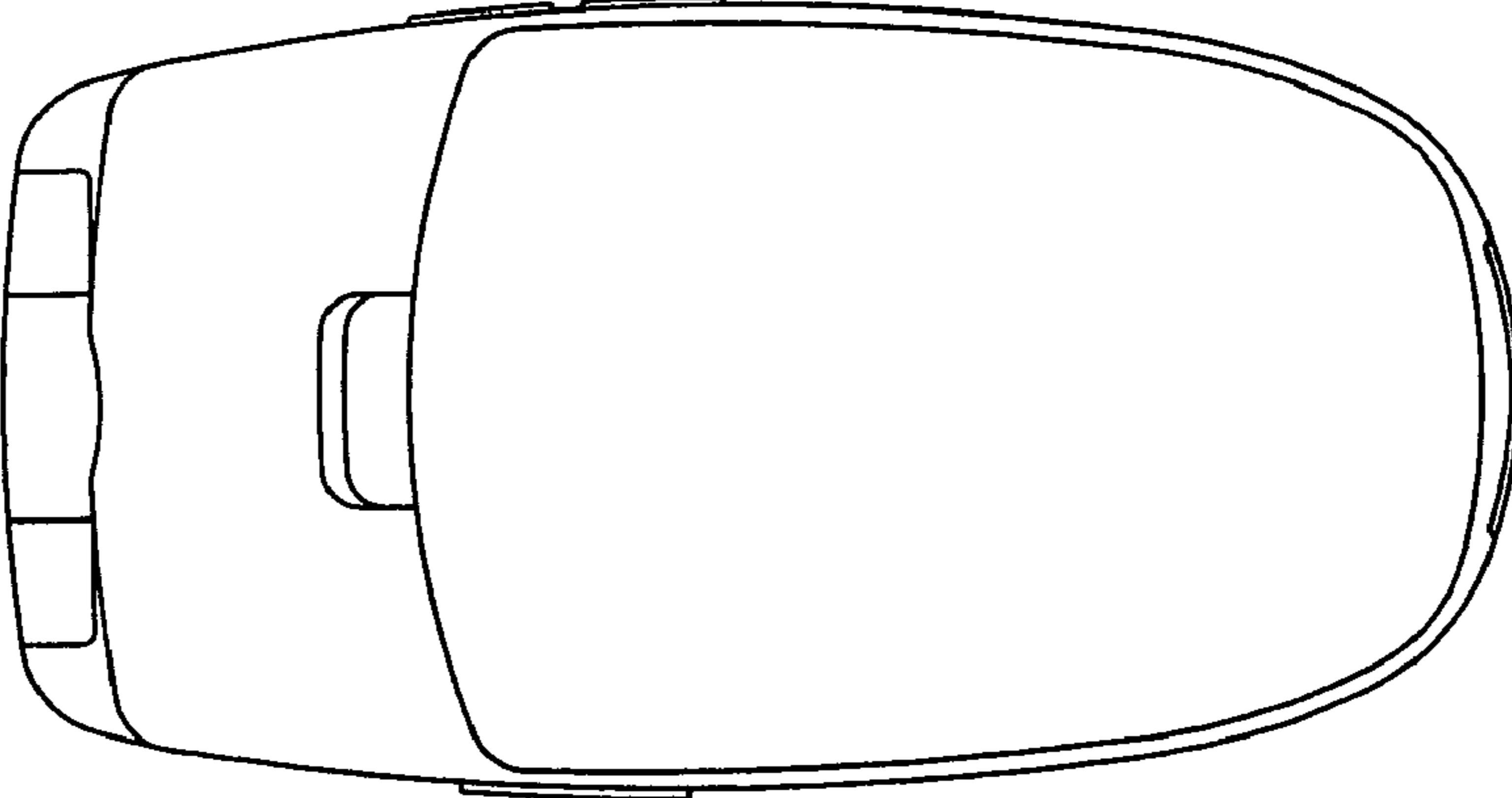

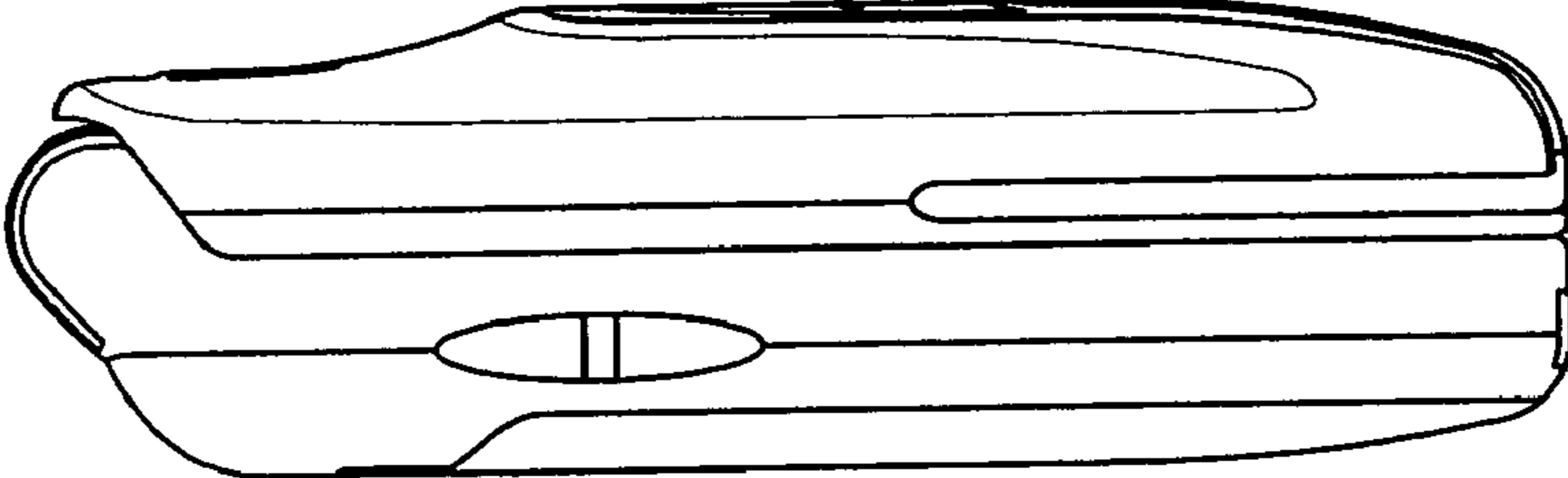

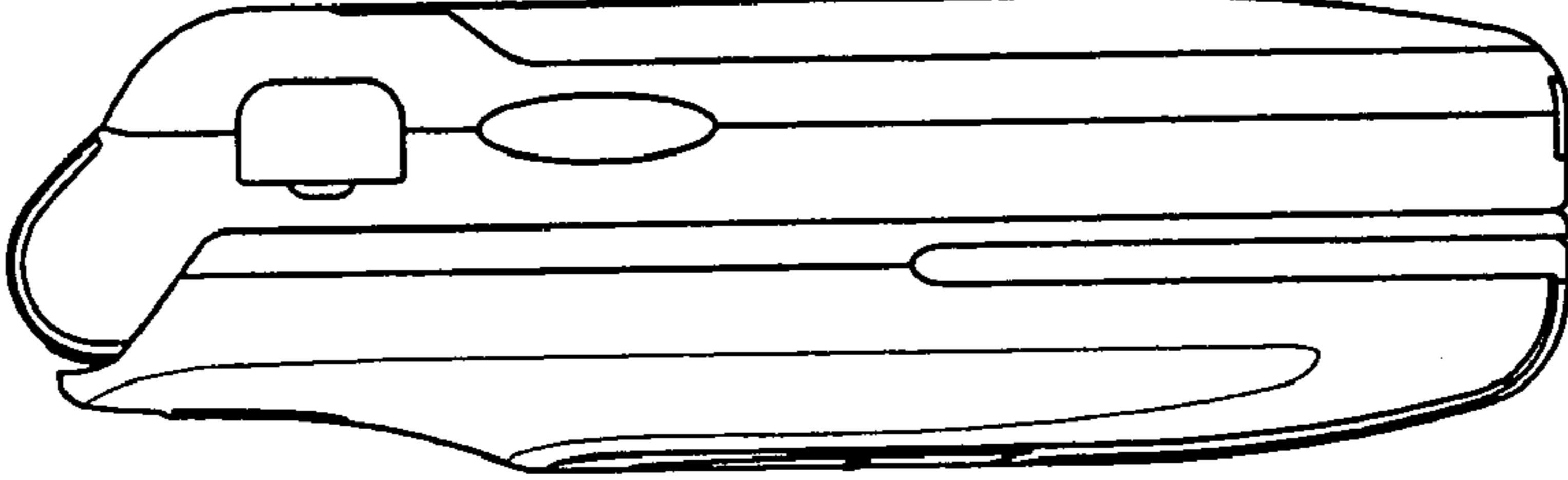

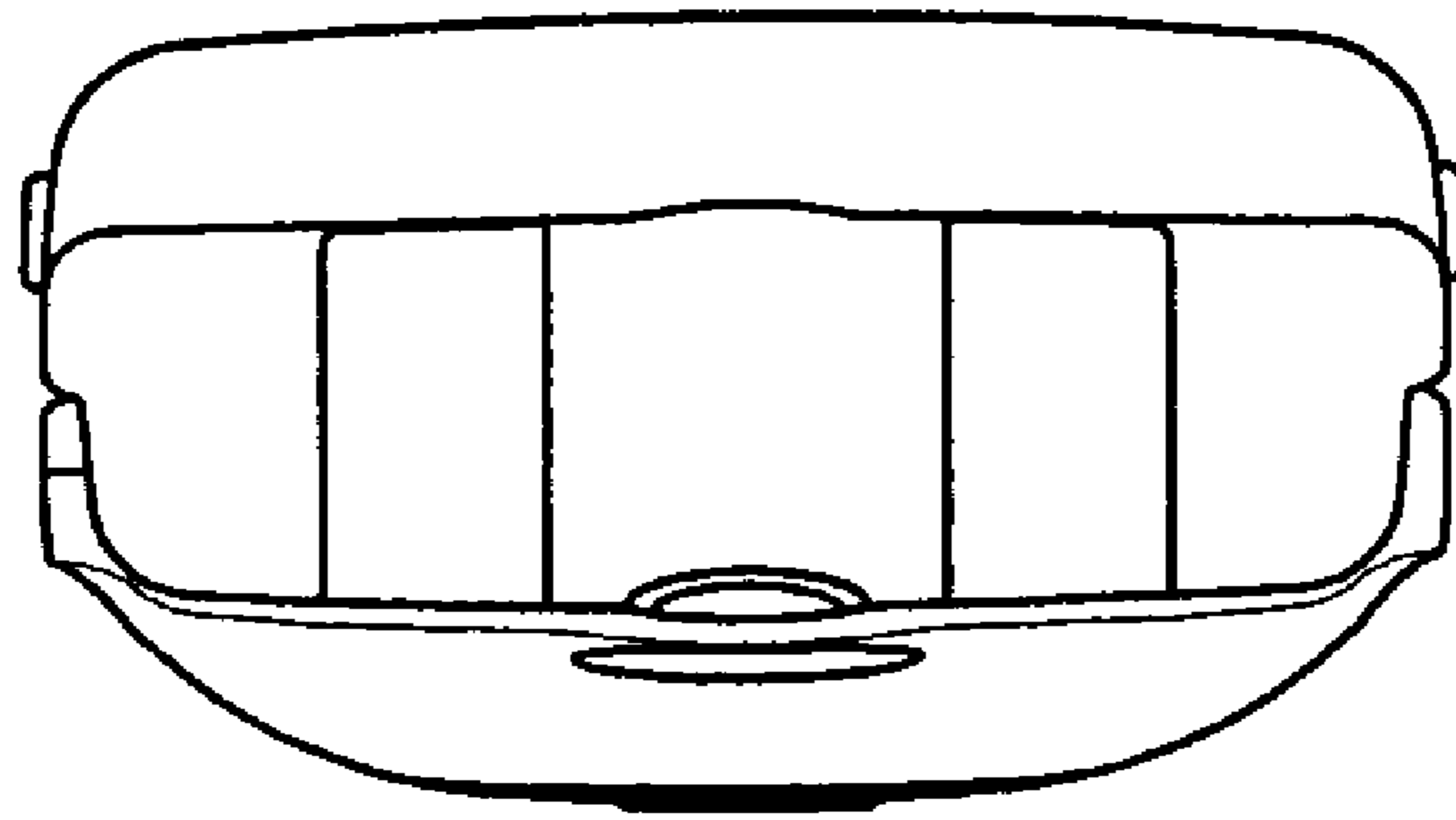

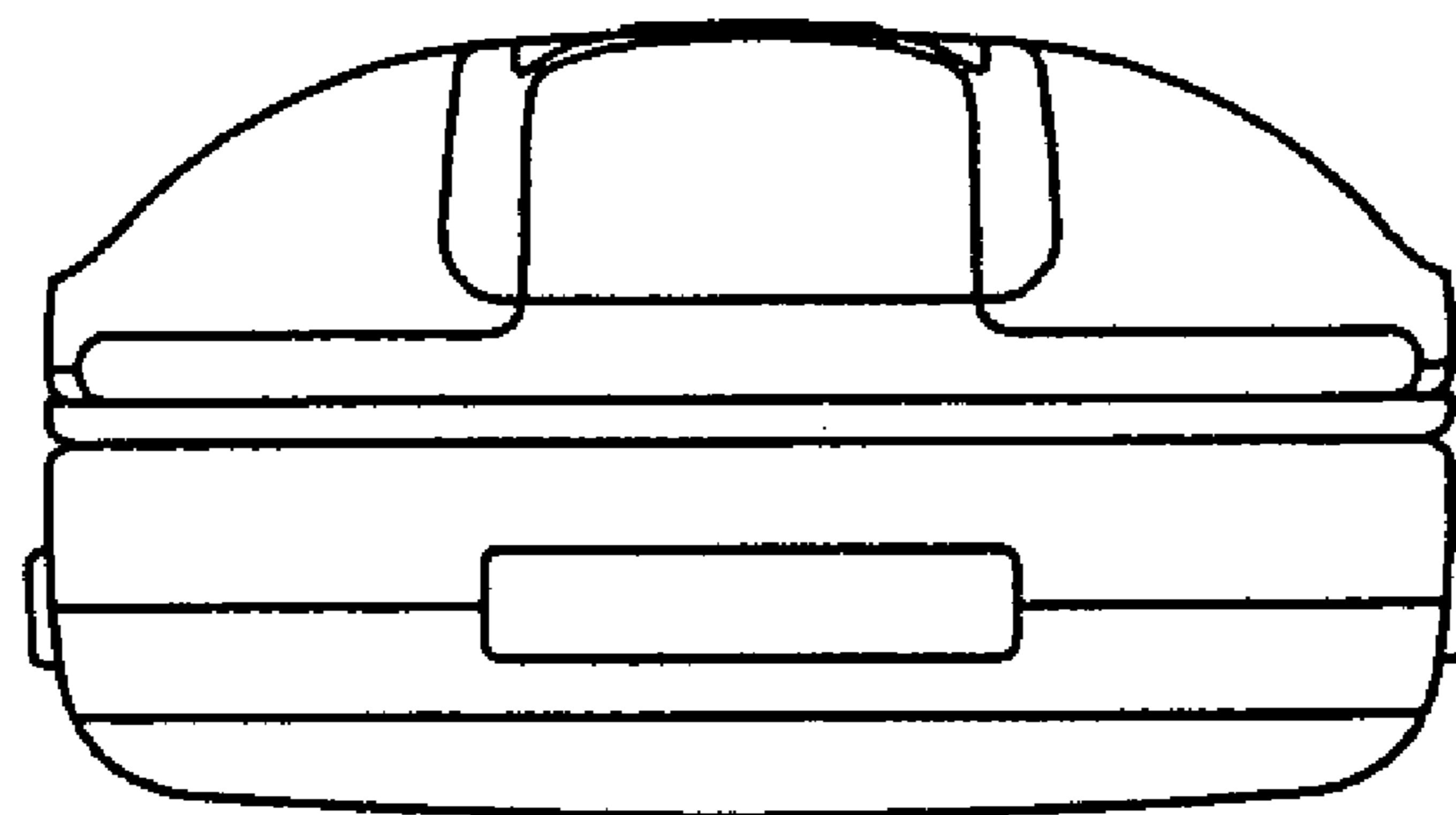
