(57) **CLAIM**

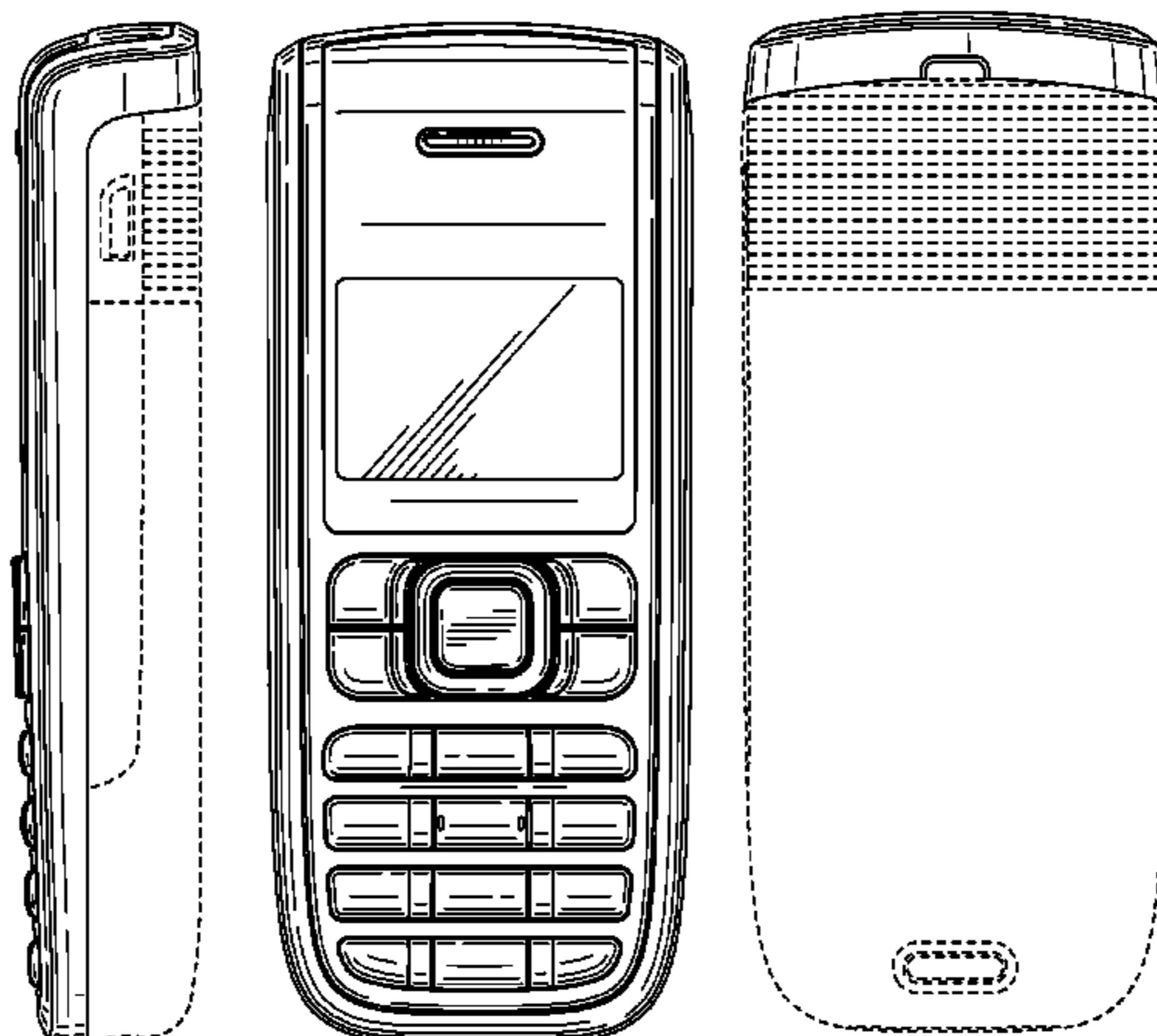
The ornamental design for a front cover for a handset, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom plan view of a front cover for a handset showing our new design in isolation;  
FIG. 2 is a right side view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a front perspective view thereof;

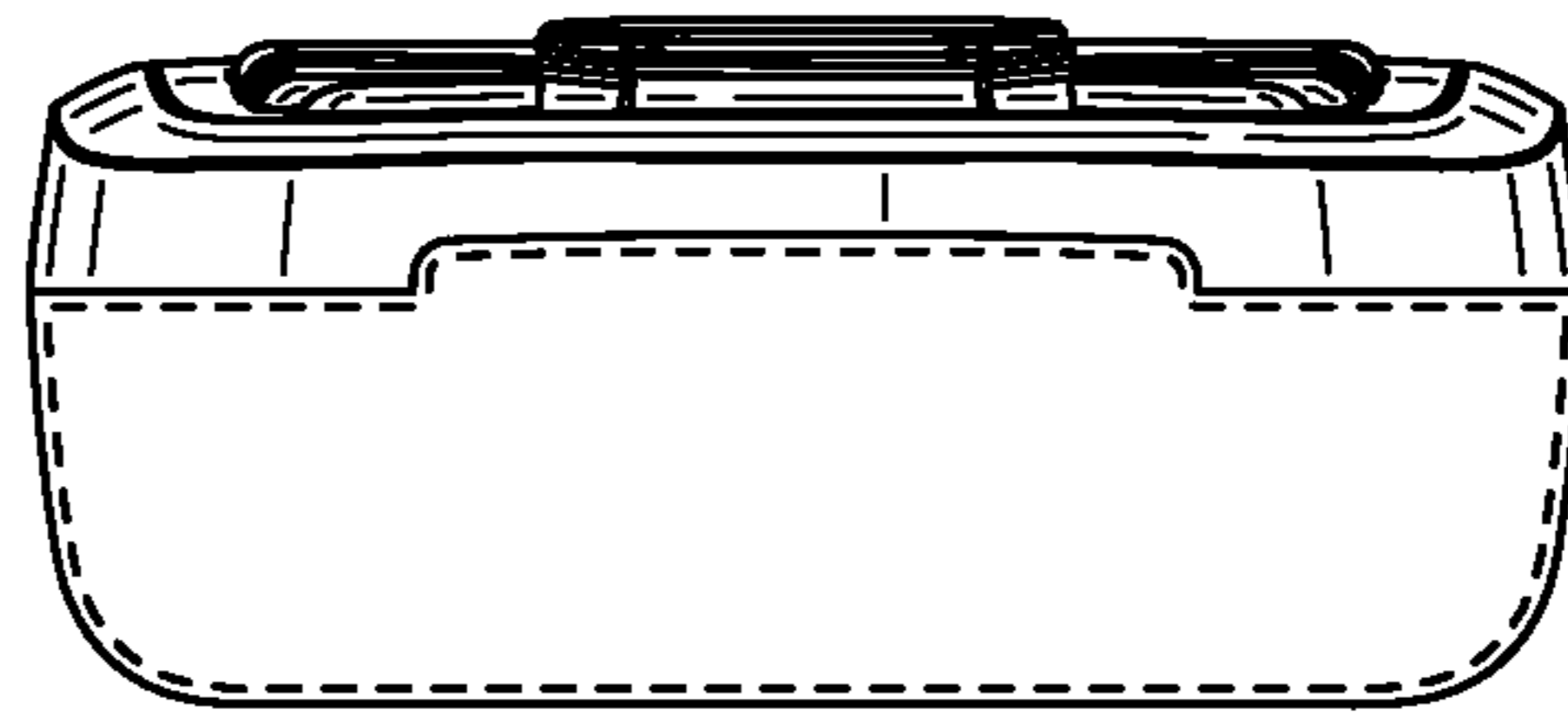

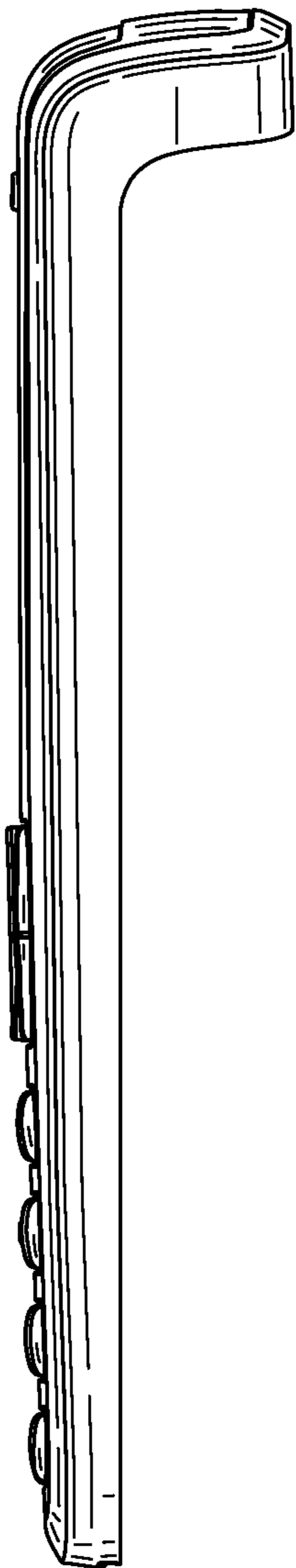

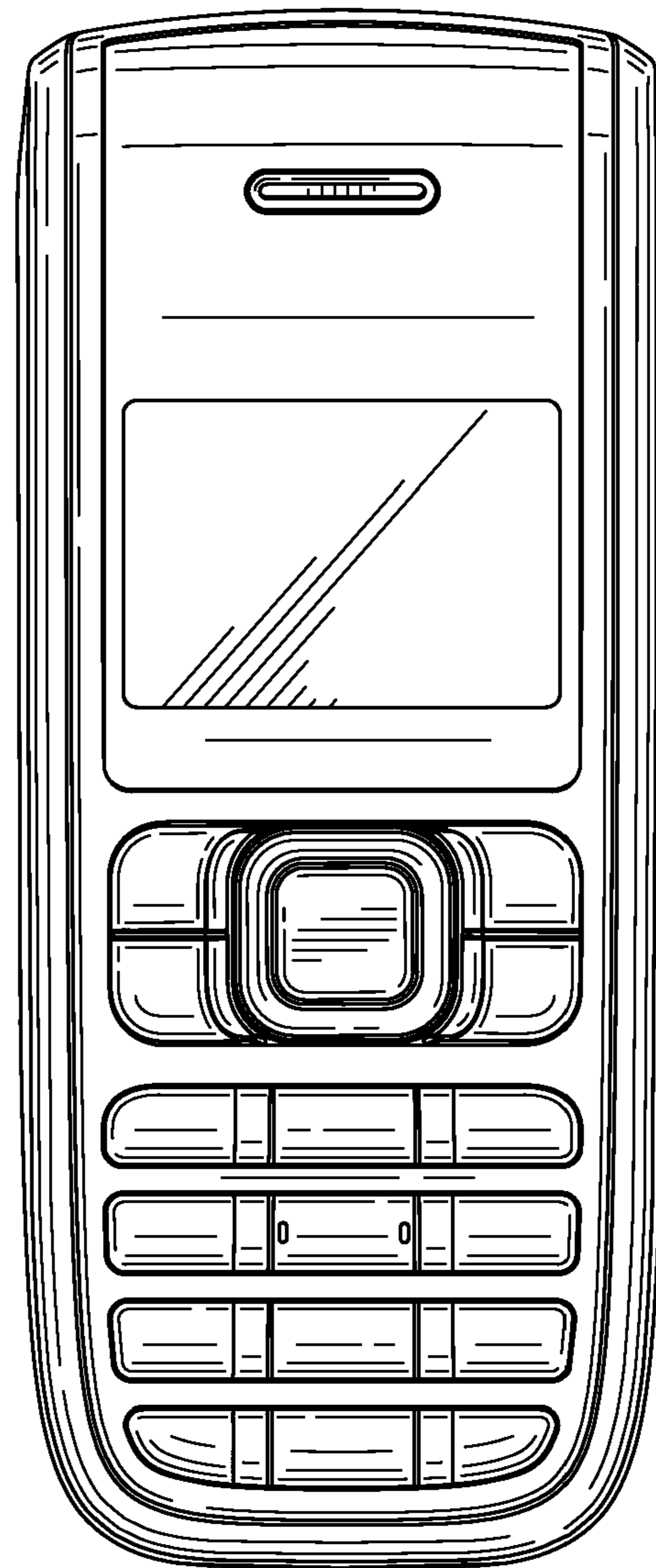

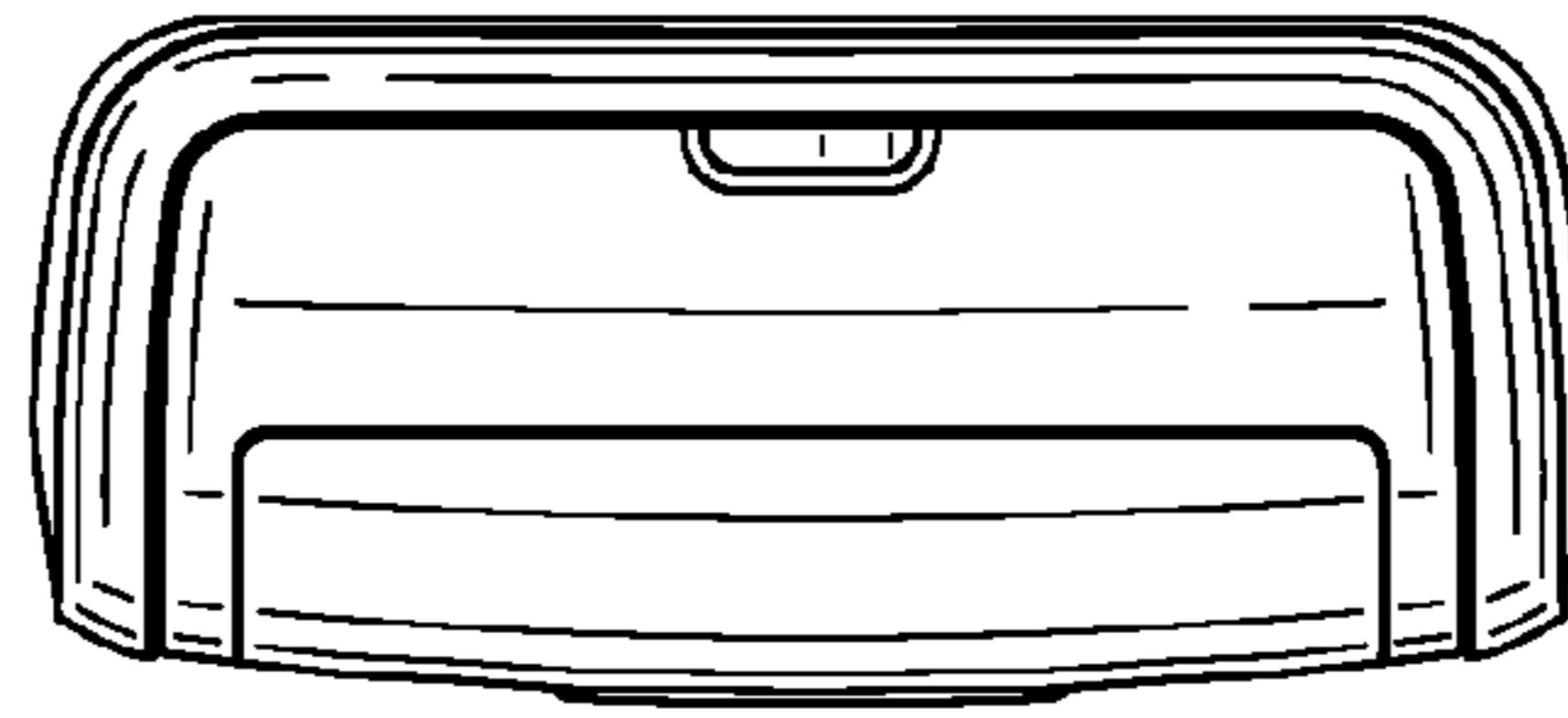

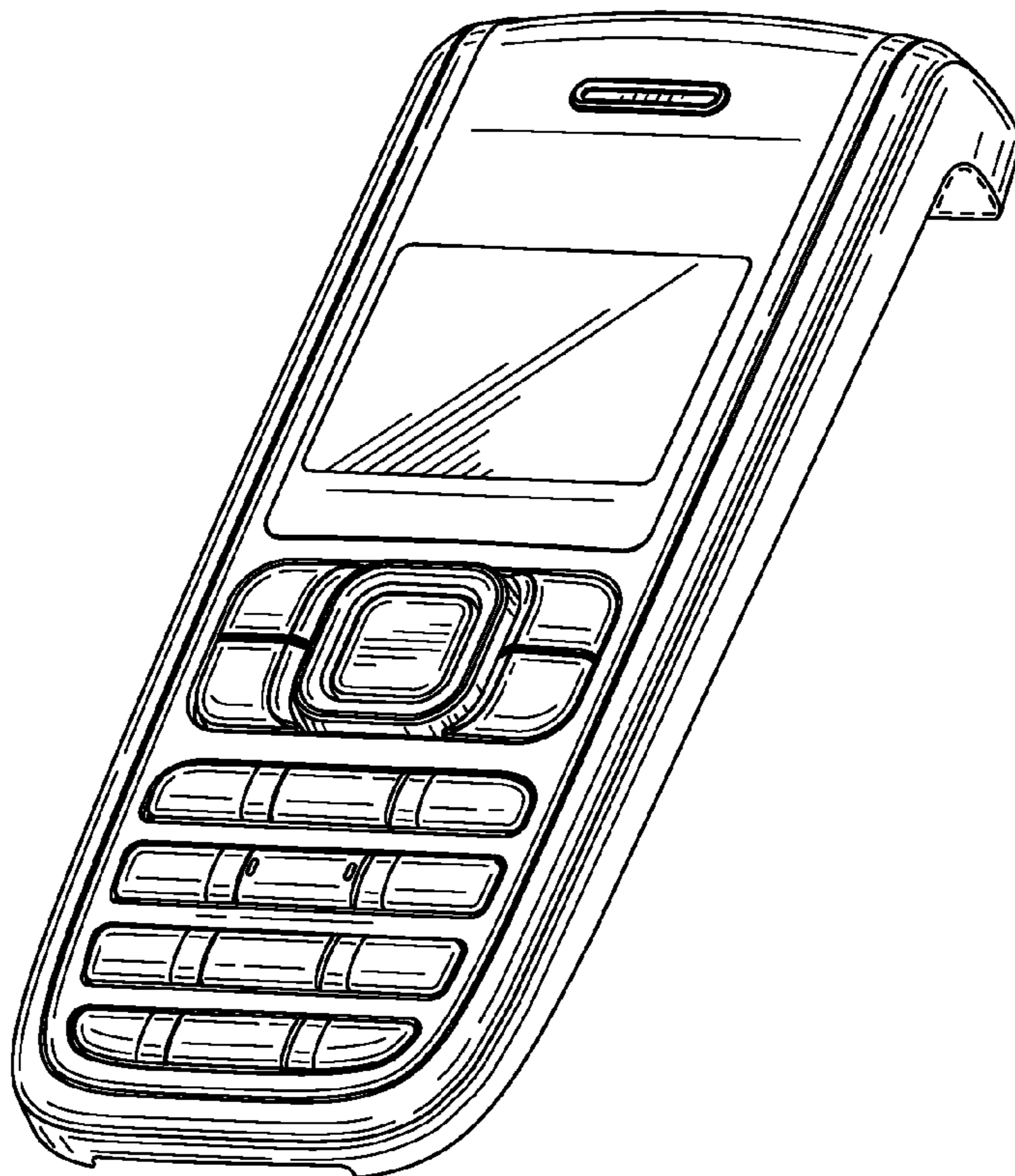

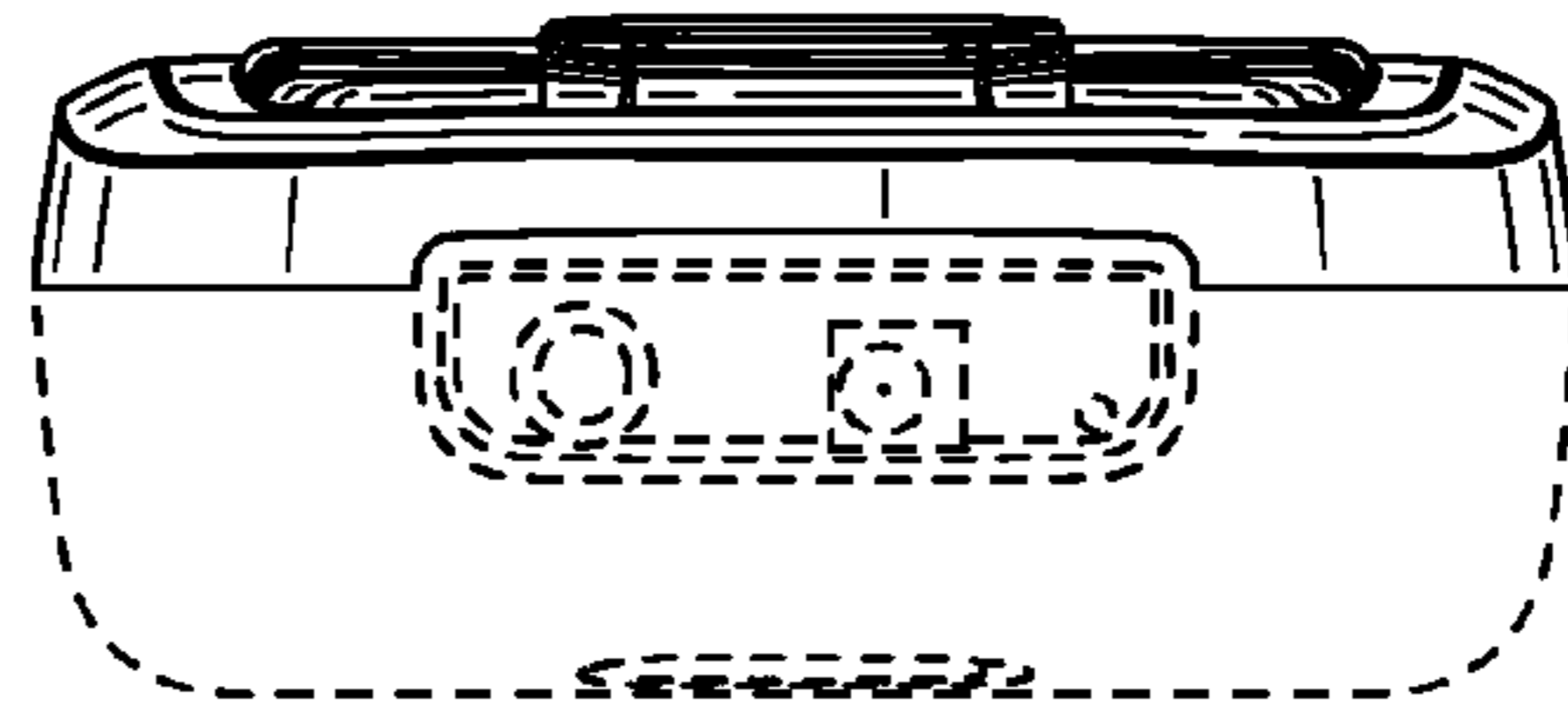

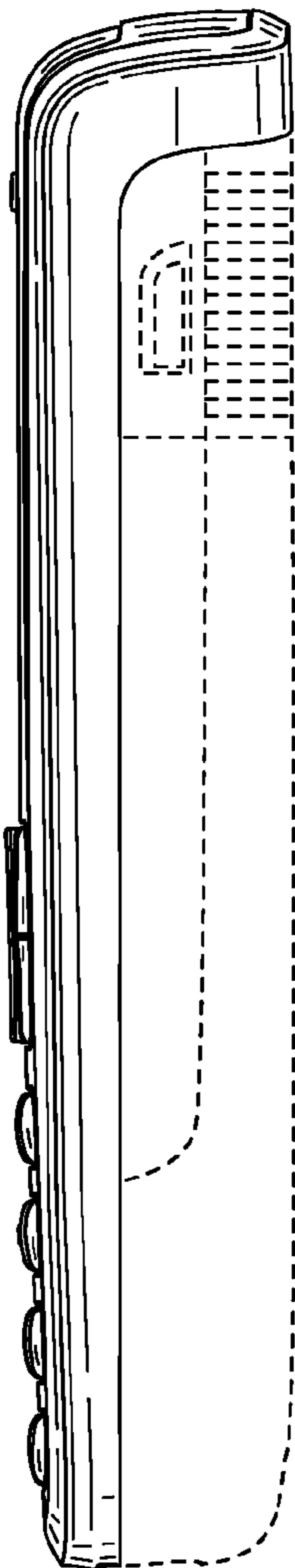

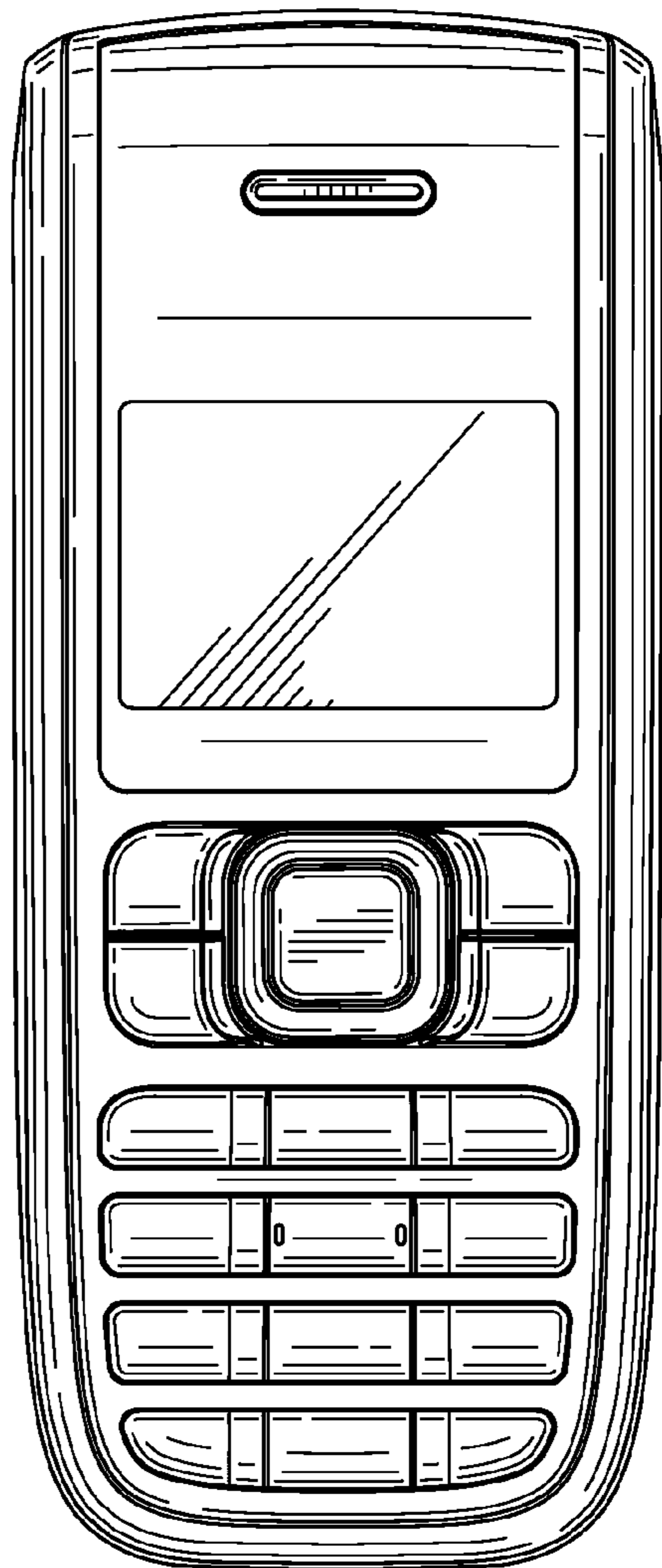

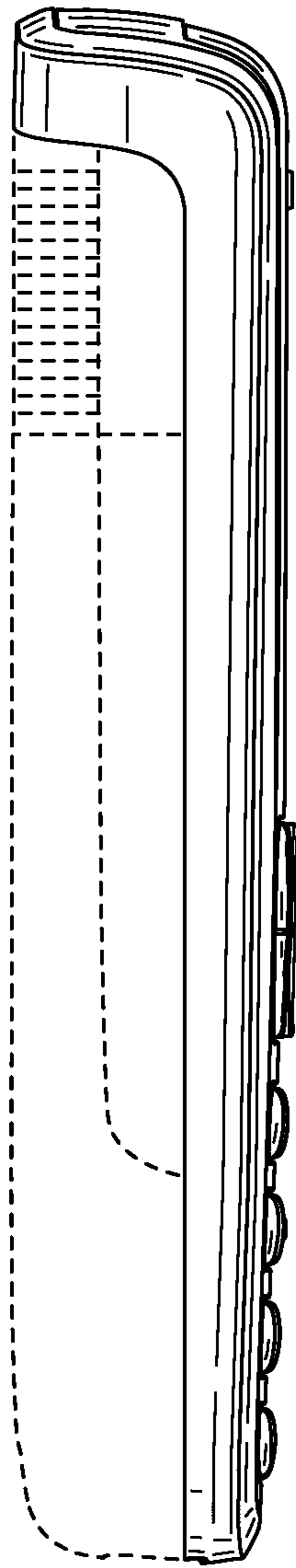

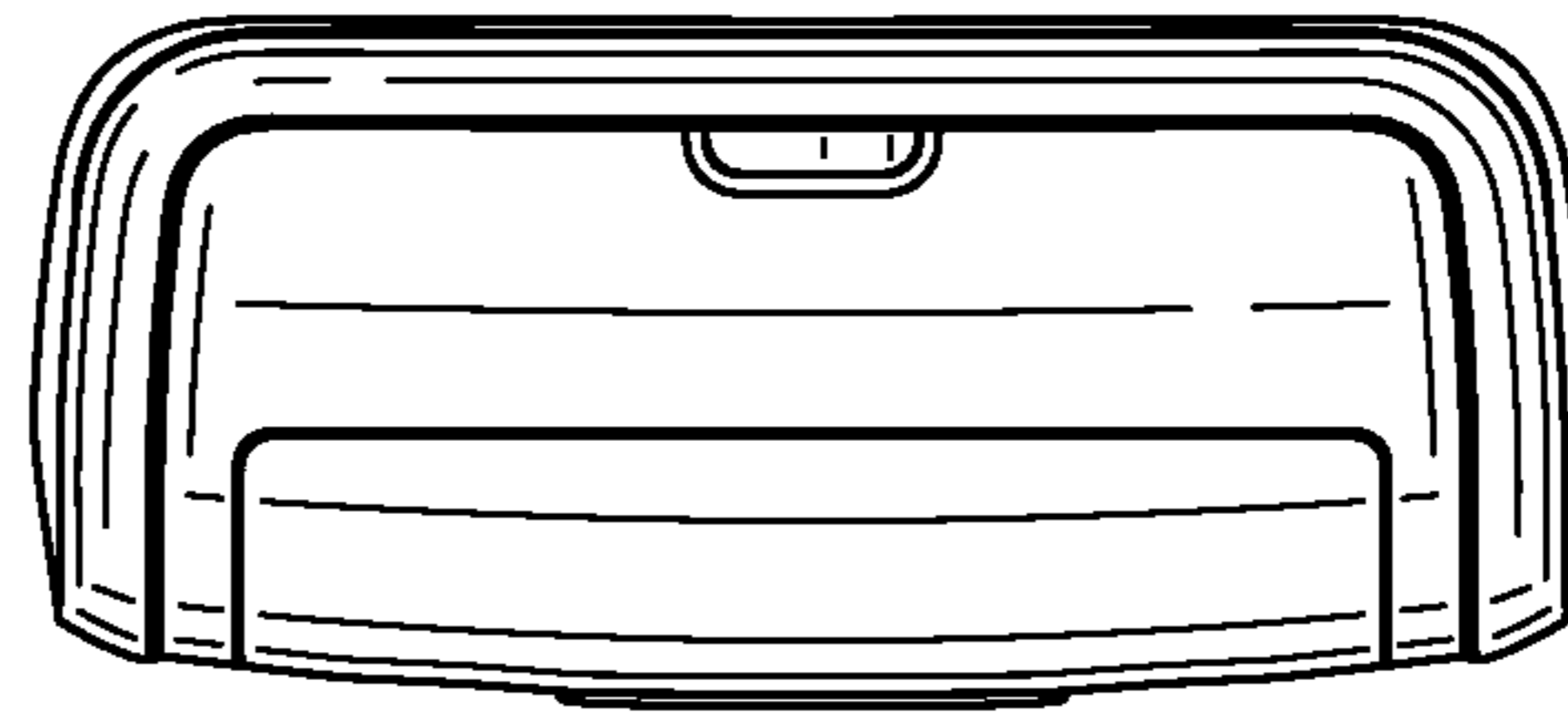

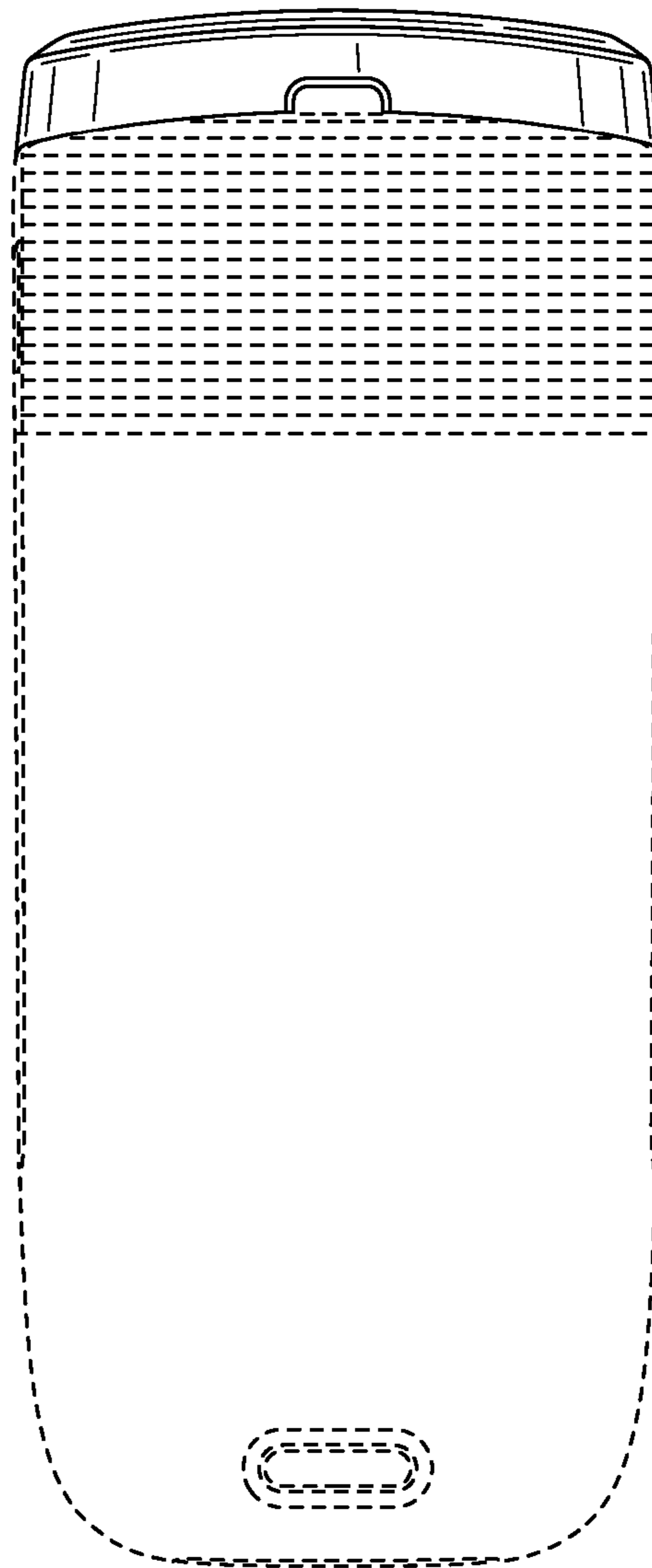

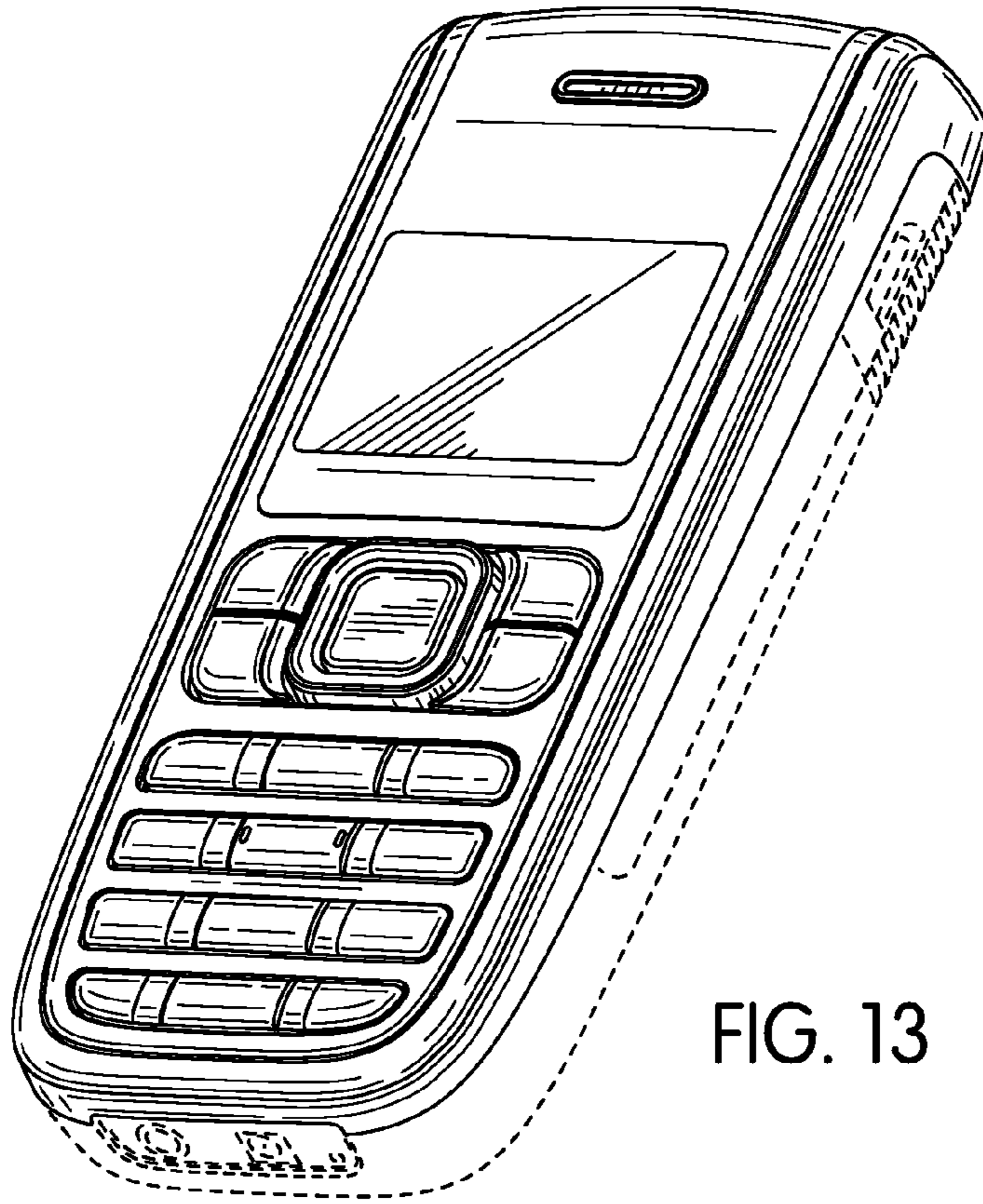

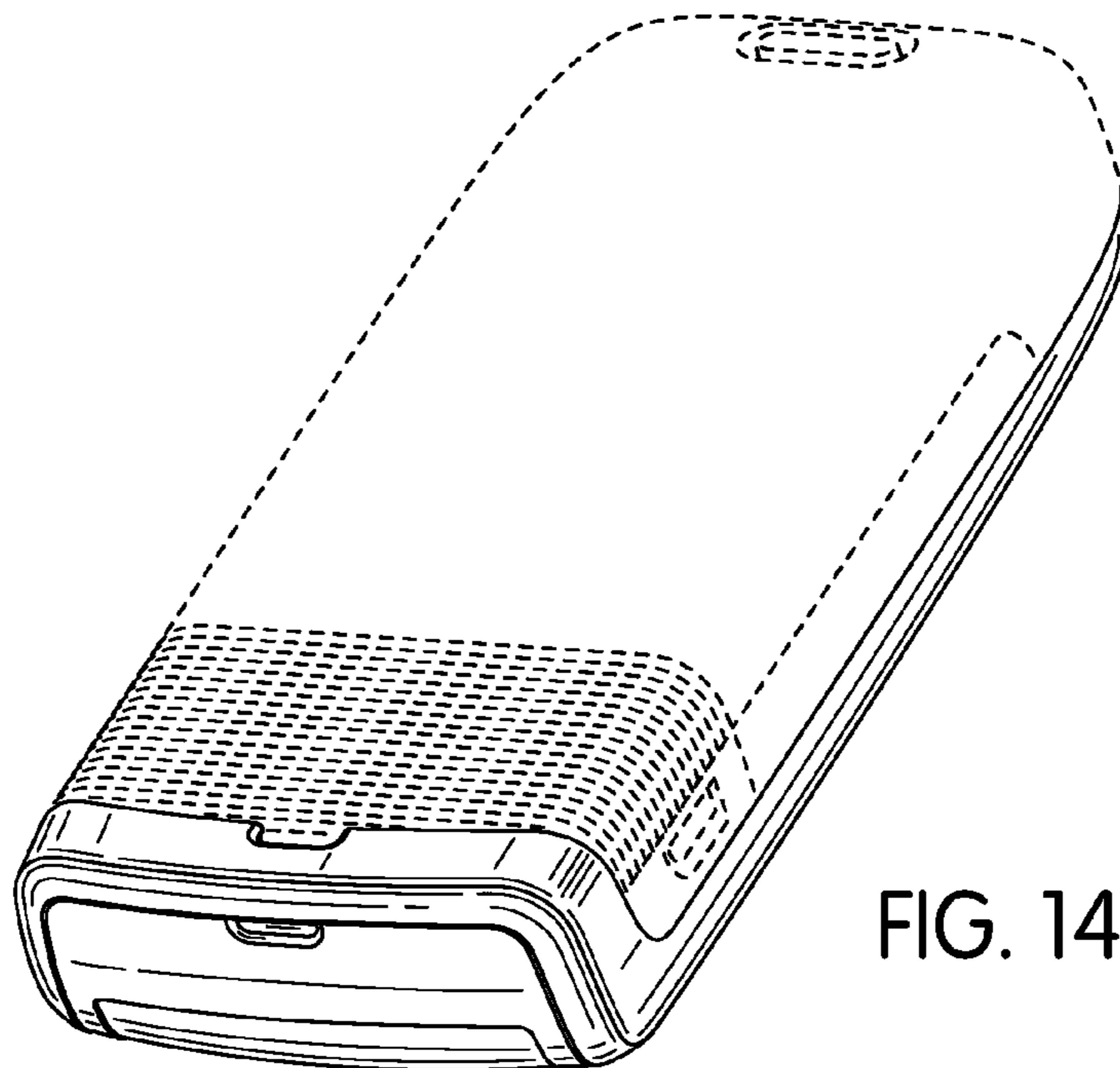
